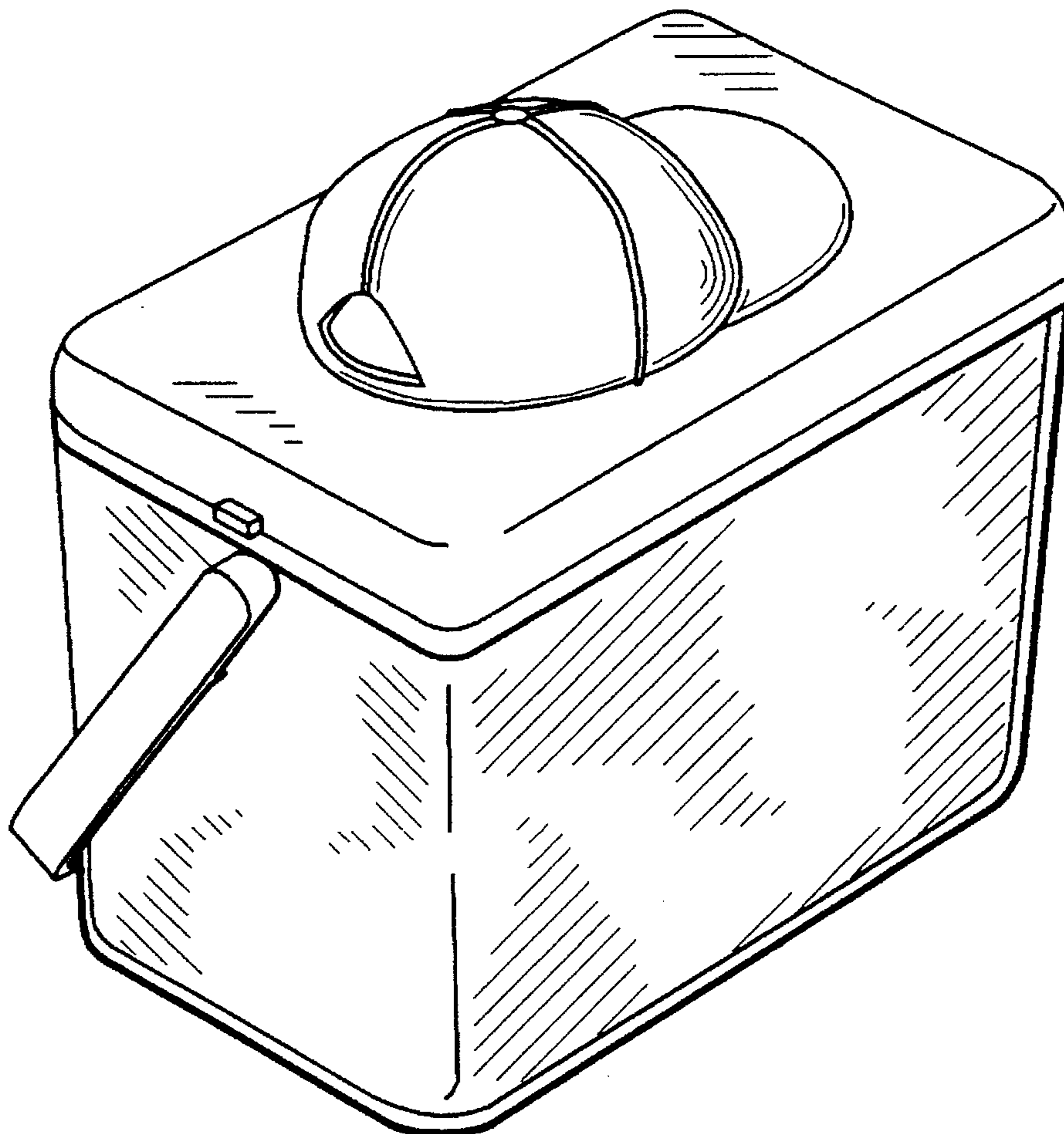
[57] **CLAIM**

The ornamental design for a baseball hat cooler, as shown and described.

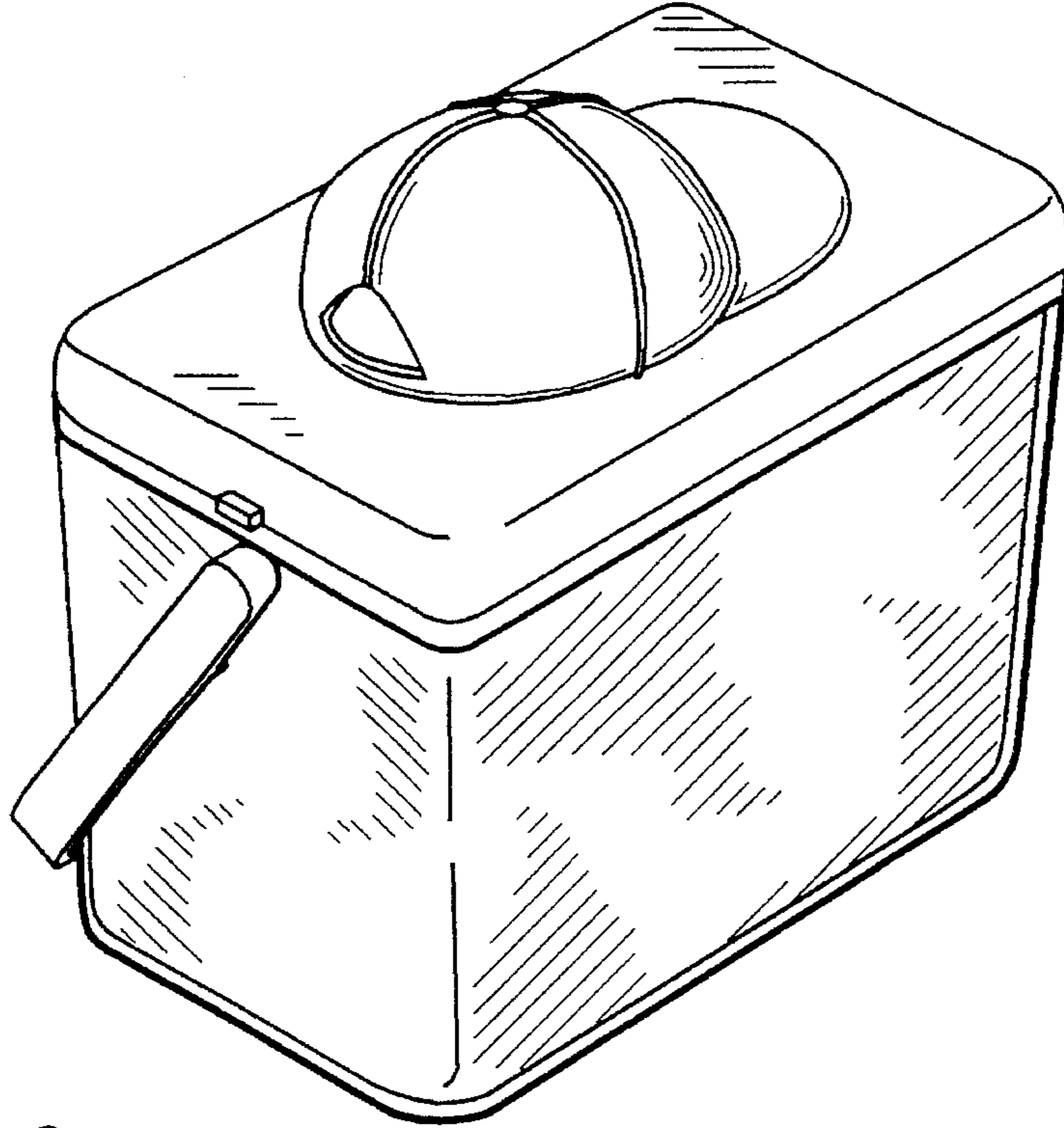
**DESCRIPTION**

The bottom view is planar and unornamented.

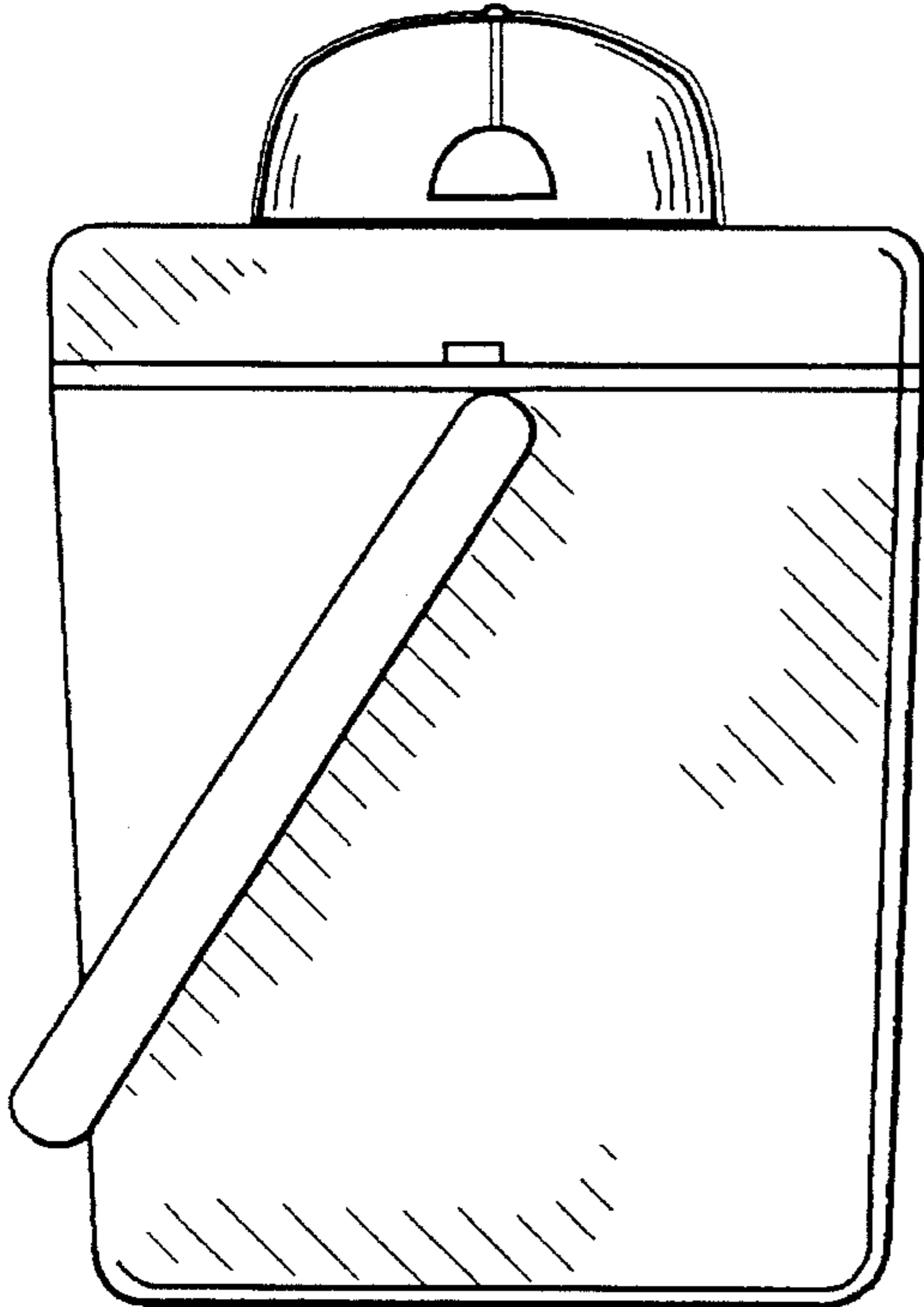
