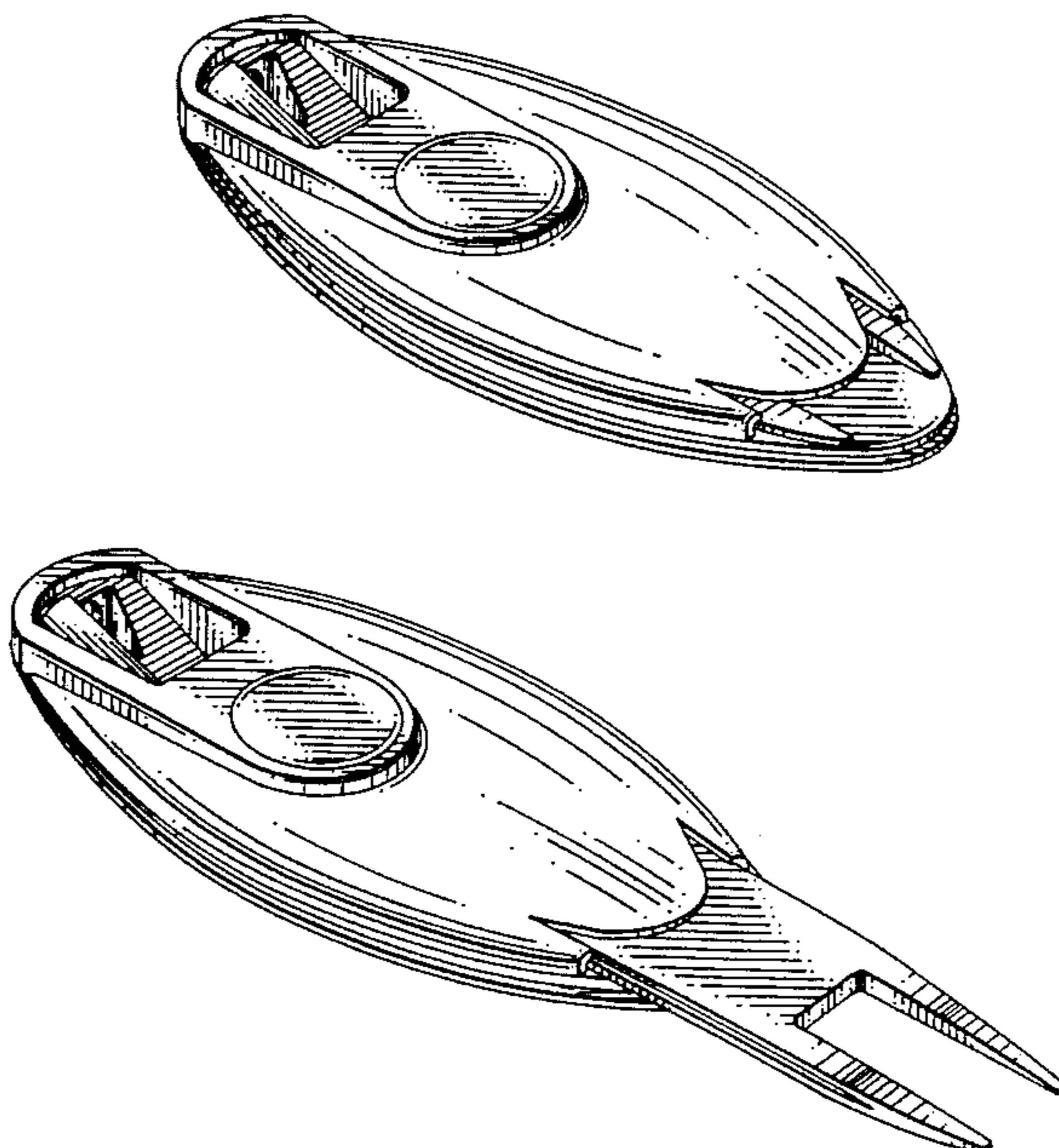
[57] CLAIM

The ornamental design for a multi-purpose golfer's tool, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a multi-purpose golfer's tool showing our new design;
FIG. 2 is a side view of the multi-purpose golfer's tool;
FIG. 3 is a top view of the multi-purpose golfer's tool;
FIG. 4 is a bottom view of the multi-purpose golfer's tool;
FIG. 5 is a rear view of the multi-purpose golfer's tool;
FIG. 6 is a front view of the multi-purpose golfer's tool; and,
FIG. 7 is a perspective view of the multi-purpose golfer's tool with prongs extended.

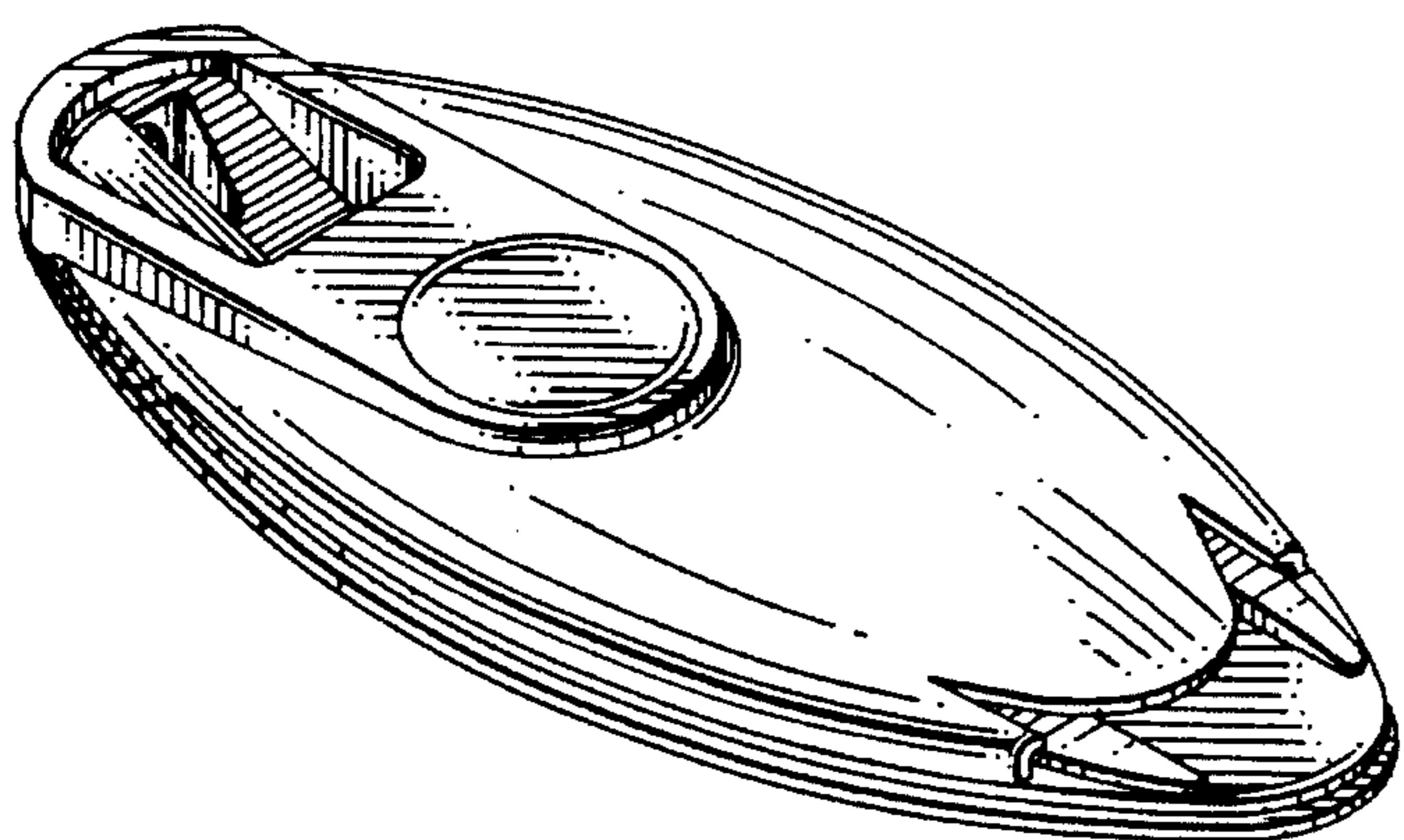

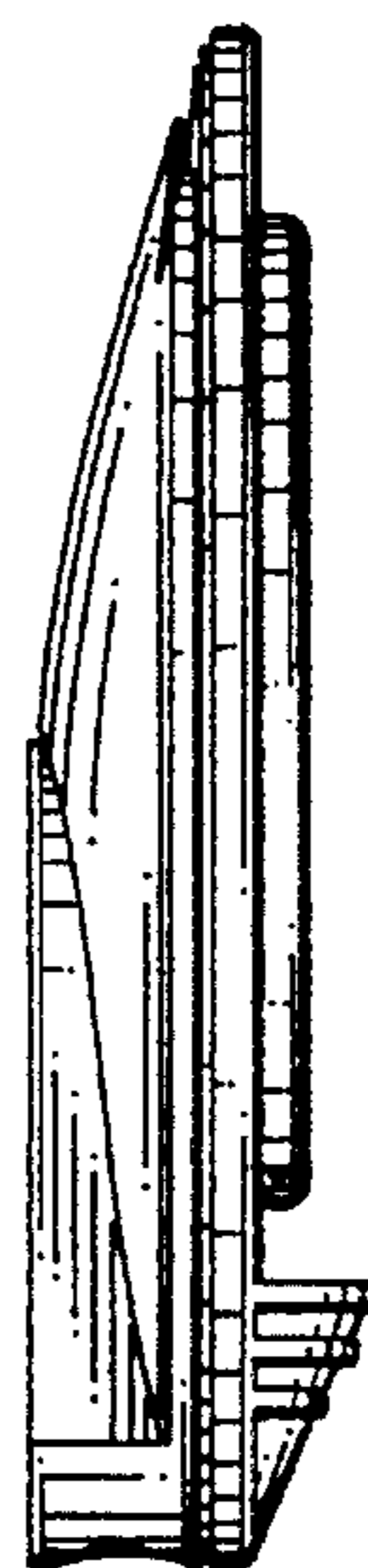

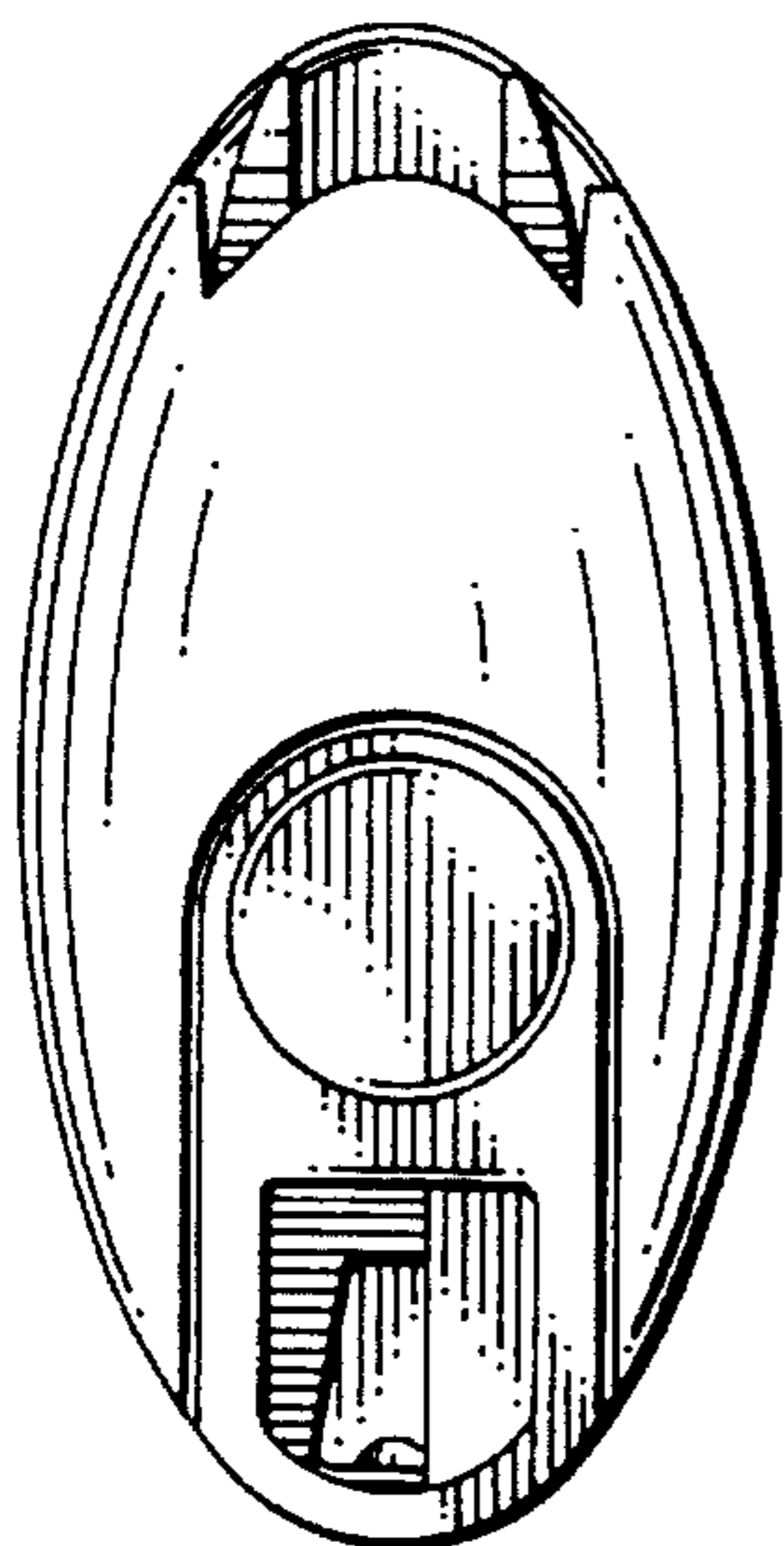

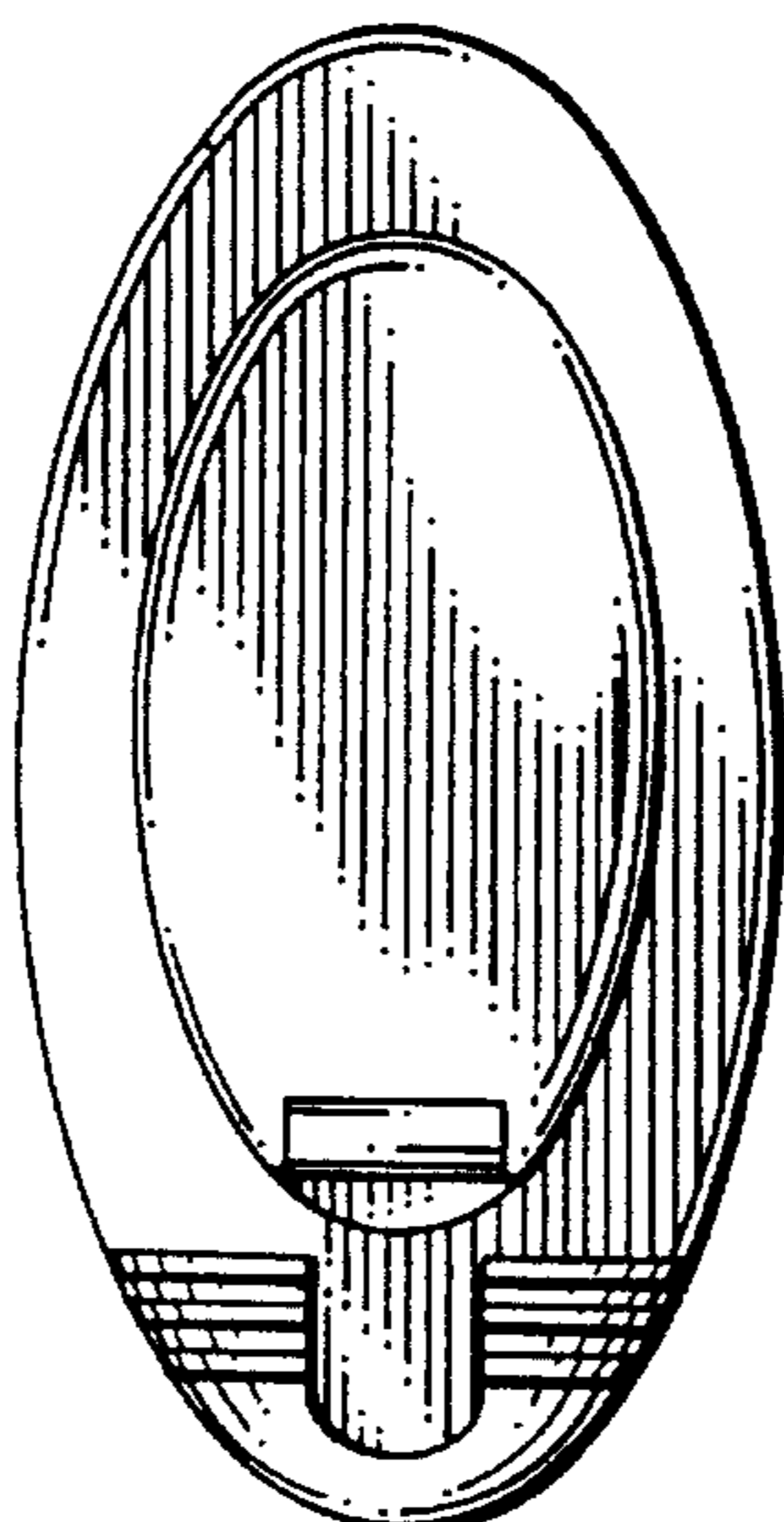

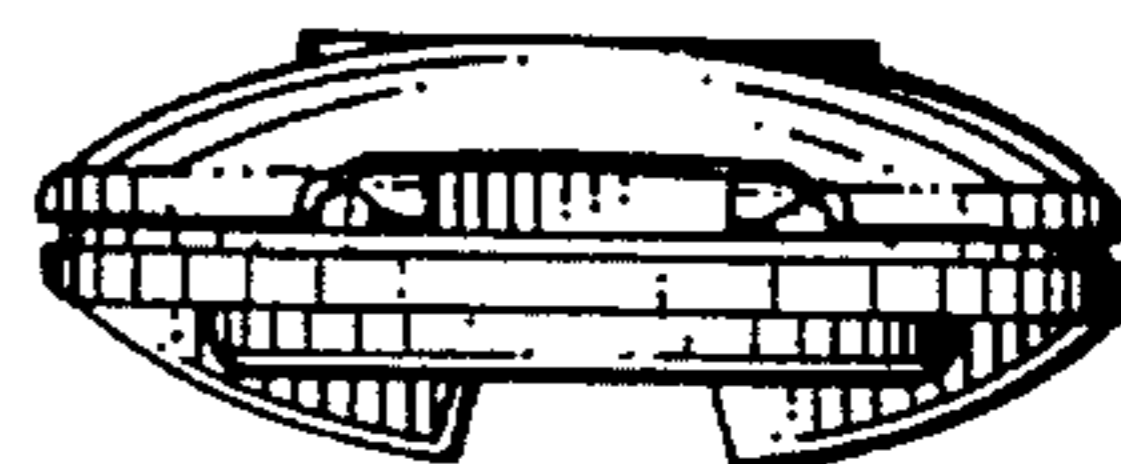

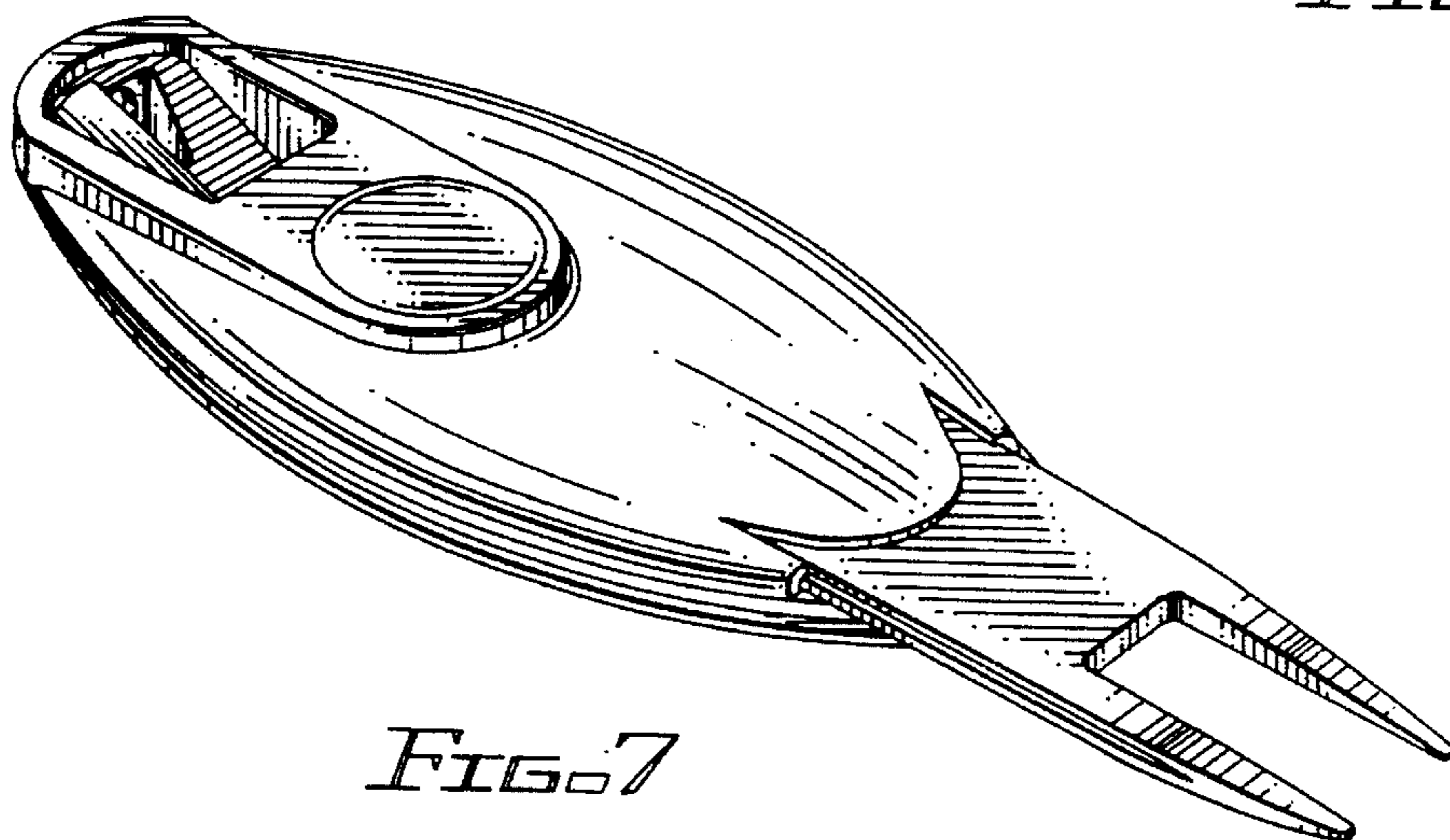
