[57] **CLAIM**

The ornamental design for a bottle with dispensing pump, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a bottle with dispensing pump showing our new design;  
FIG. 2 is a right side elevation view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a front elevation view thereof, the rear view being a mirror image;  
FIG. 5 is a left side elevation view thereof;  
FIG. 6 is a bottom plan view thereof; and,  
FIG. 7 is a perspective view thereof, with the dispensing pump in an open position.

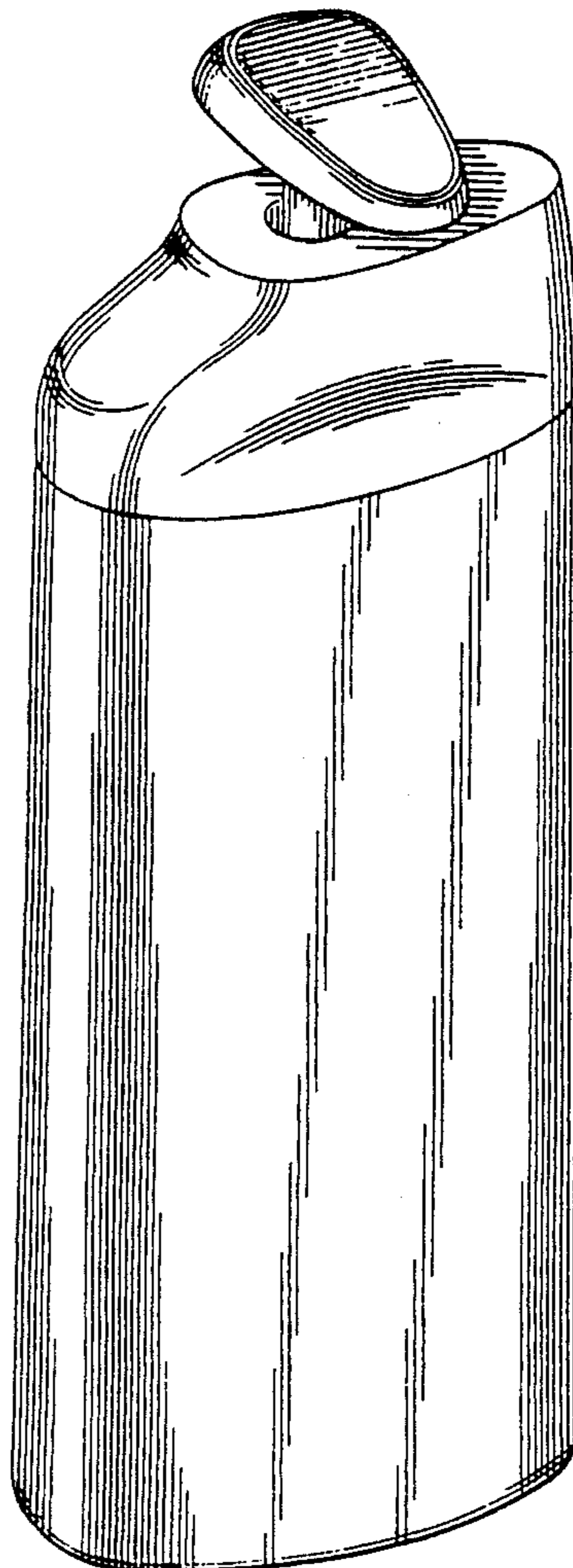

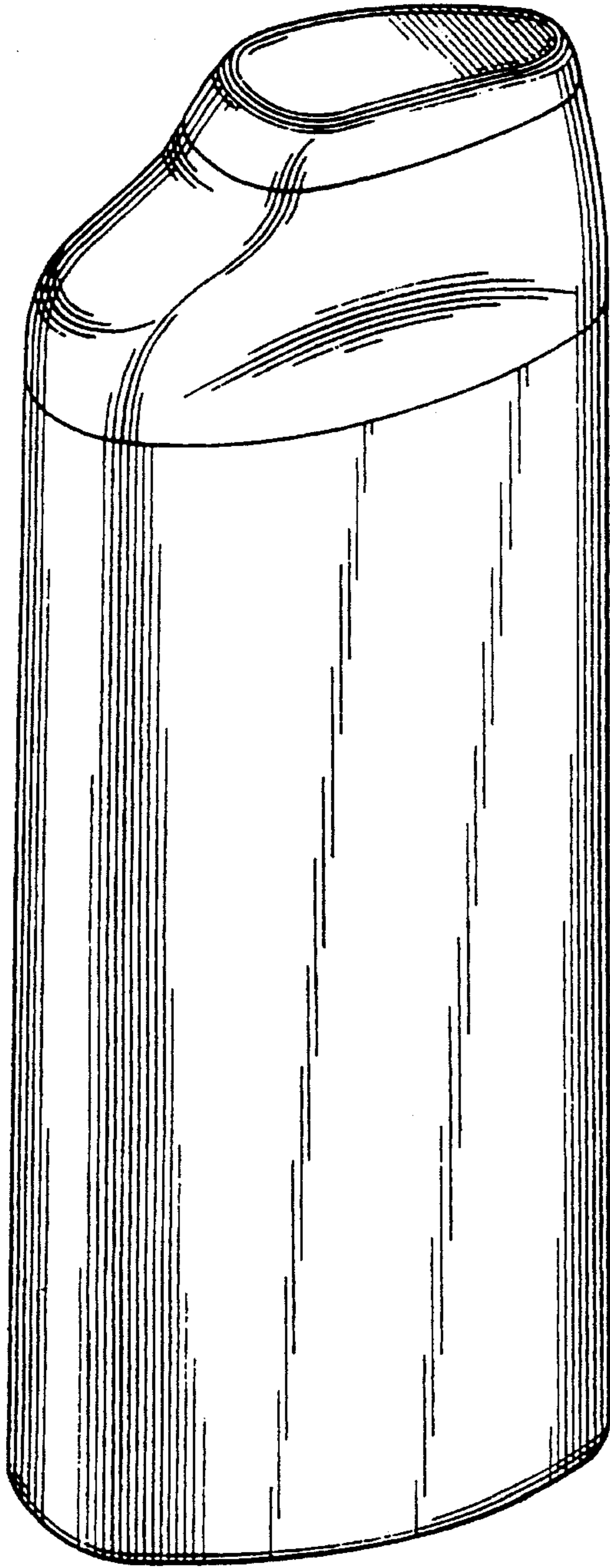

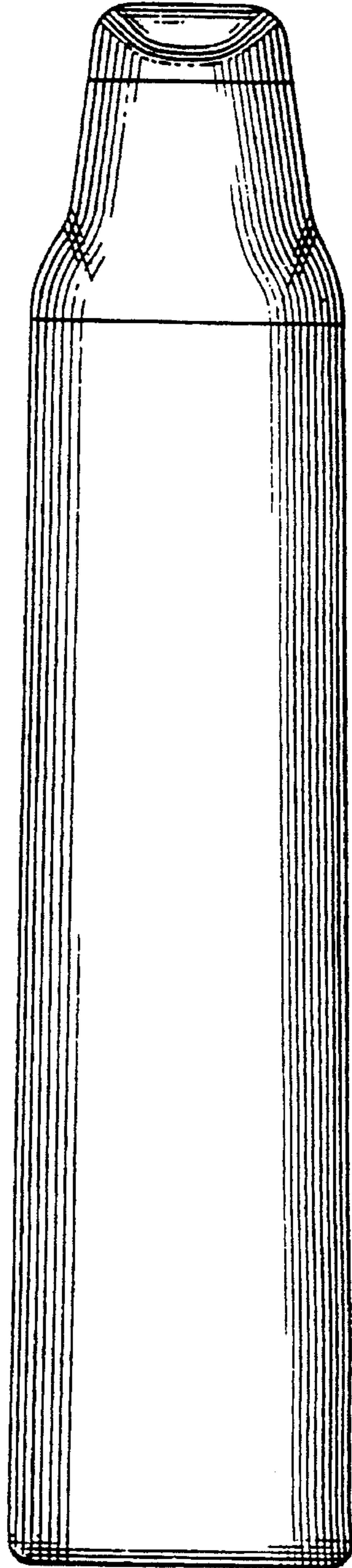

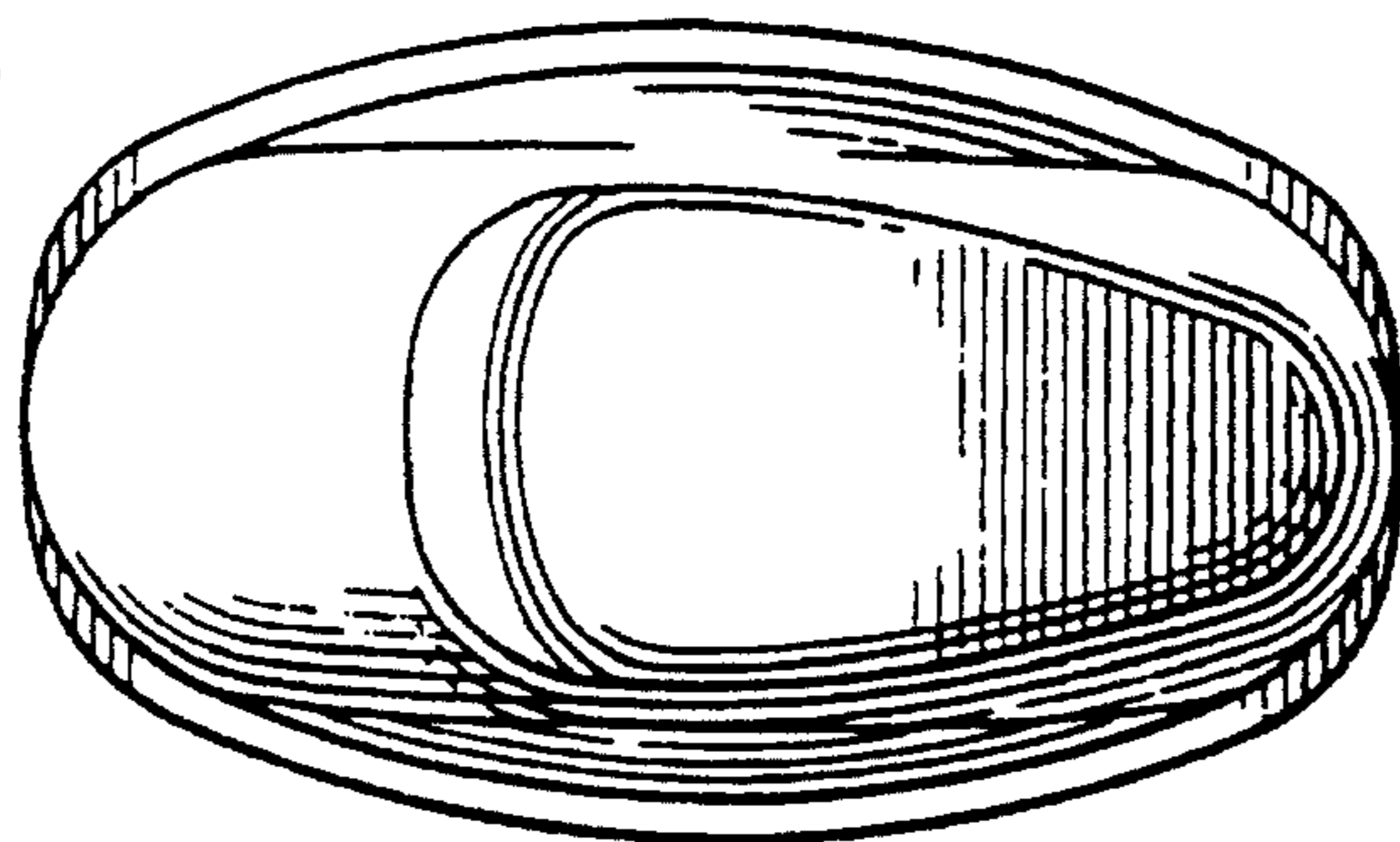

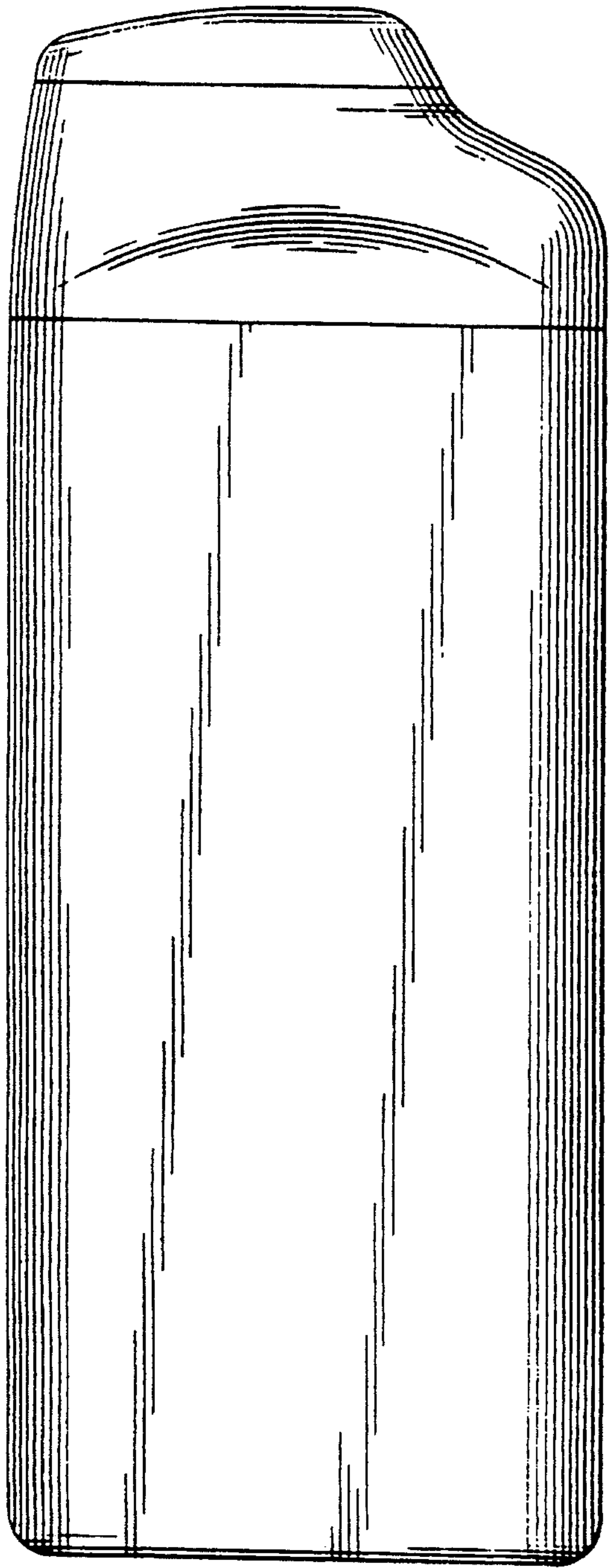

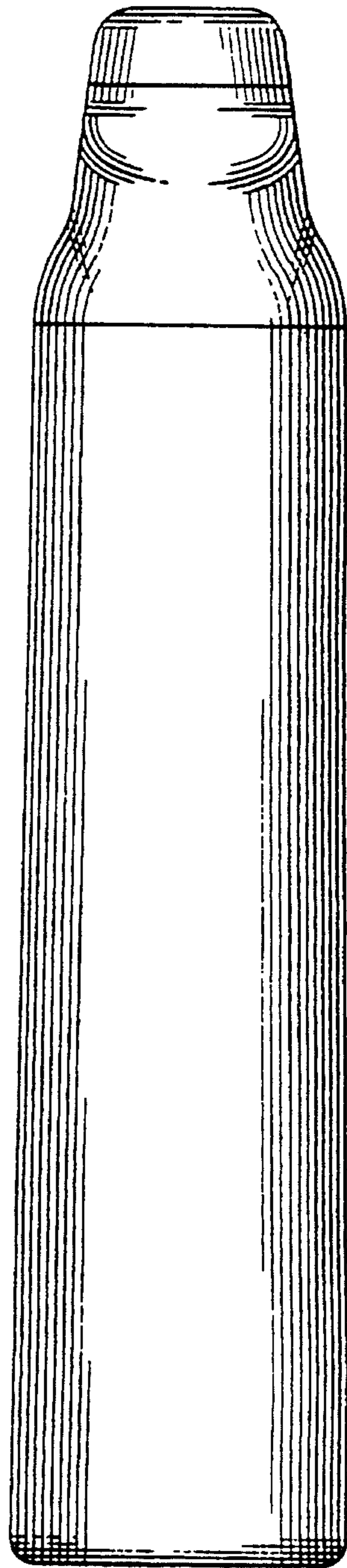

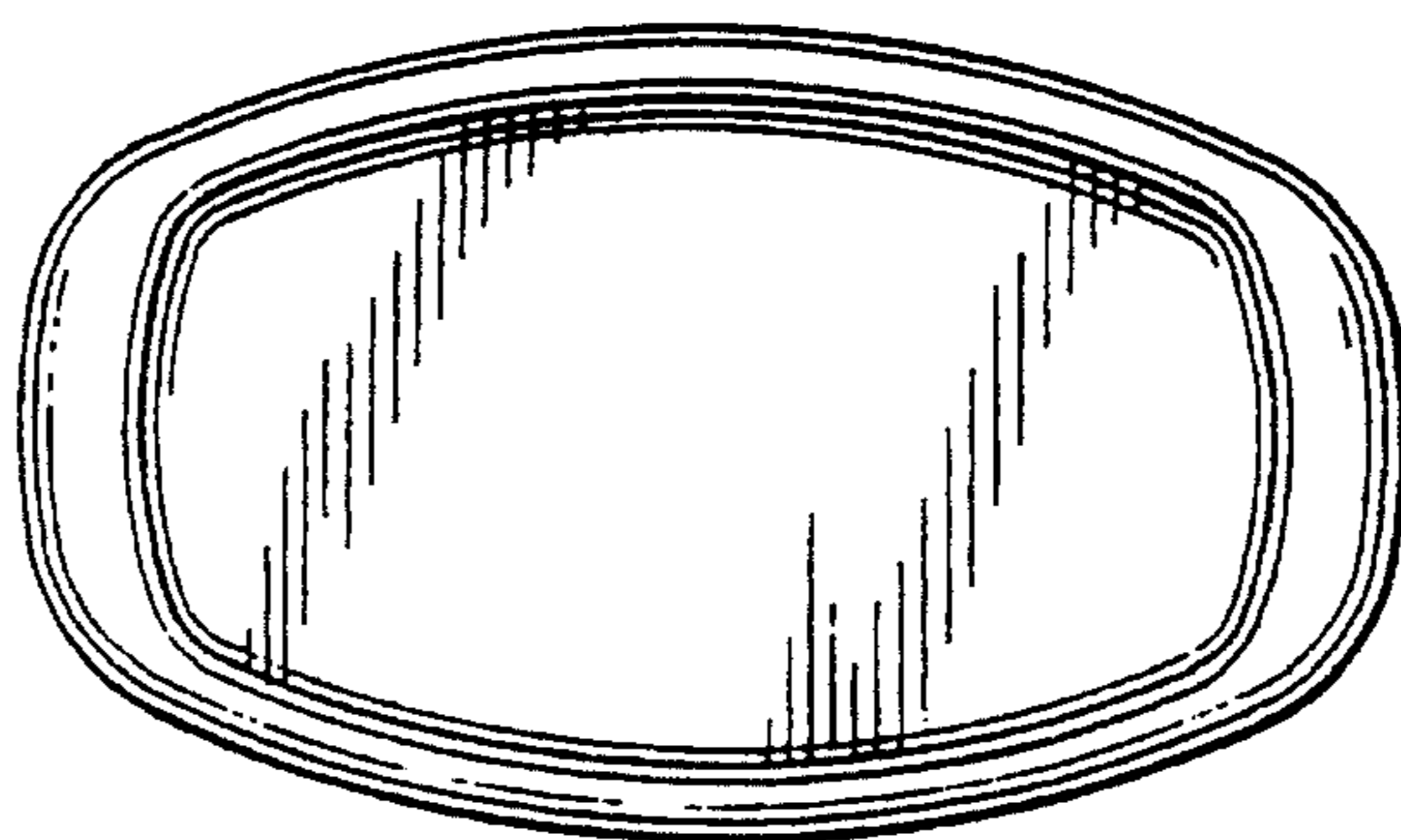
