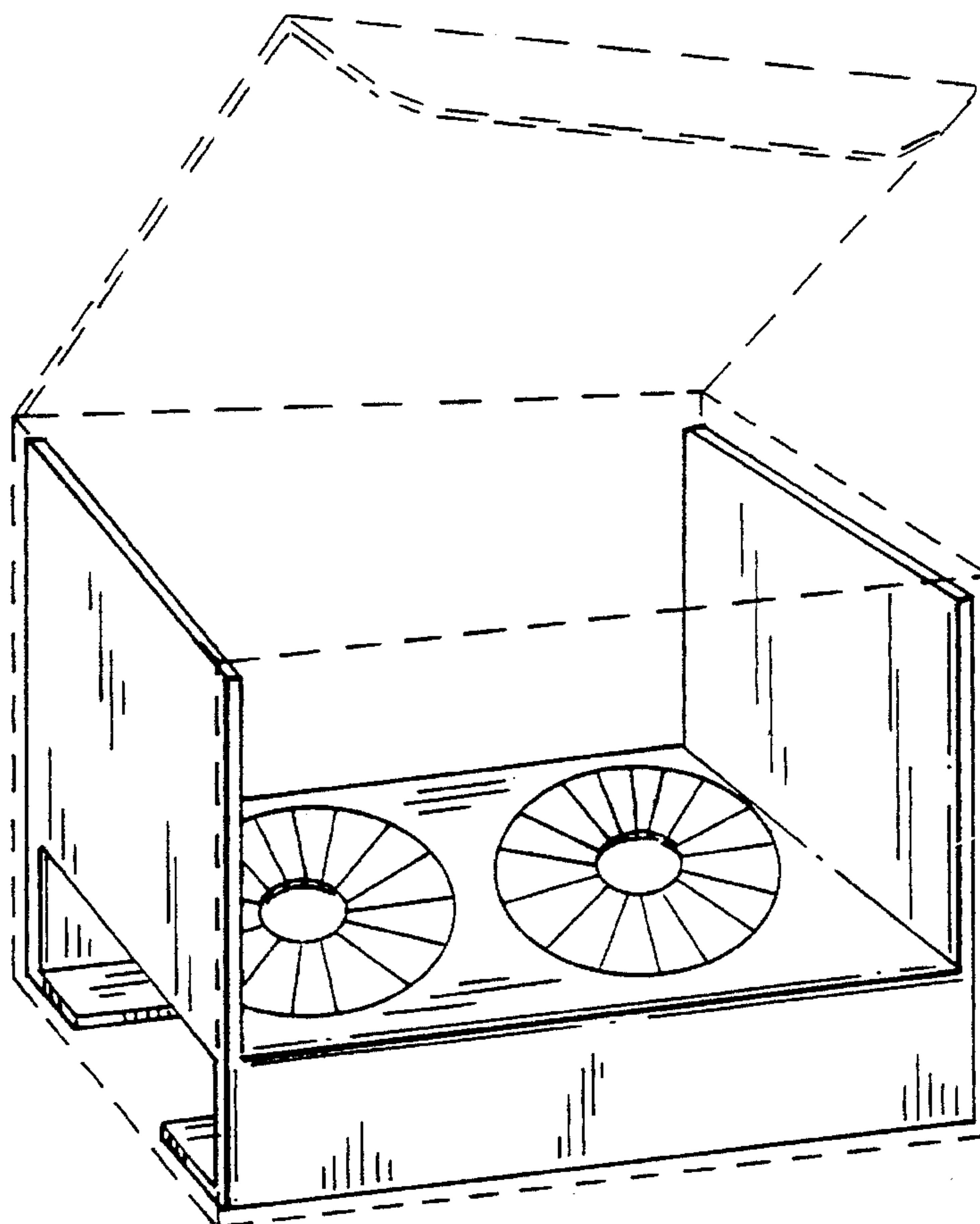
[57] **CLAIM**

The ornamental design for the box blank insert for containers, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the box blank insert for containers inside a shipping container shown in dotted lines; FIG. 2 is a front perspective view of the box blank insert for containers showing my new design; FIG. 3 is a front elevational view of the box blank insert for containers thereof; FIG. 4 is a right side elevational view of the box blank insert for containers thereof; FIG. 5 is a rear elevational view of the box blank insert for containers thereof; FIG. 6 is a left side elevational view of the box blank insert for containers thereof; FIG. 7 is a top plan view of the box blank insert for containers thereof; FIG. 8 is a bottom plan view of the box blank insert for containers thereof; and, FIG. 9 is a top view of the blank in extended flat position. The broken line showing of a shipping container is for illustrative purposes only and forms no part of the claimed design.

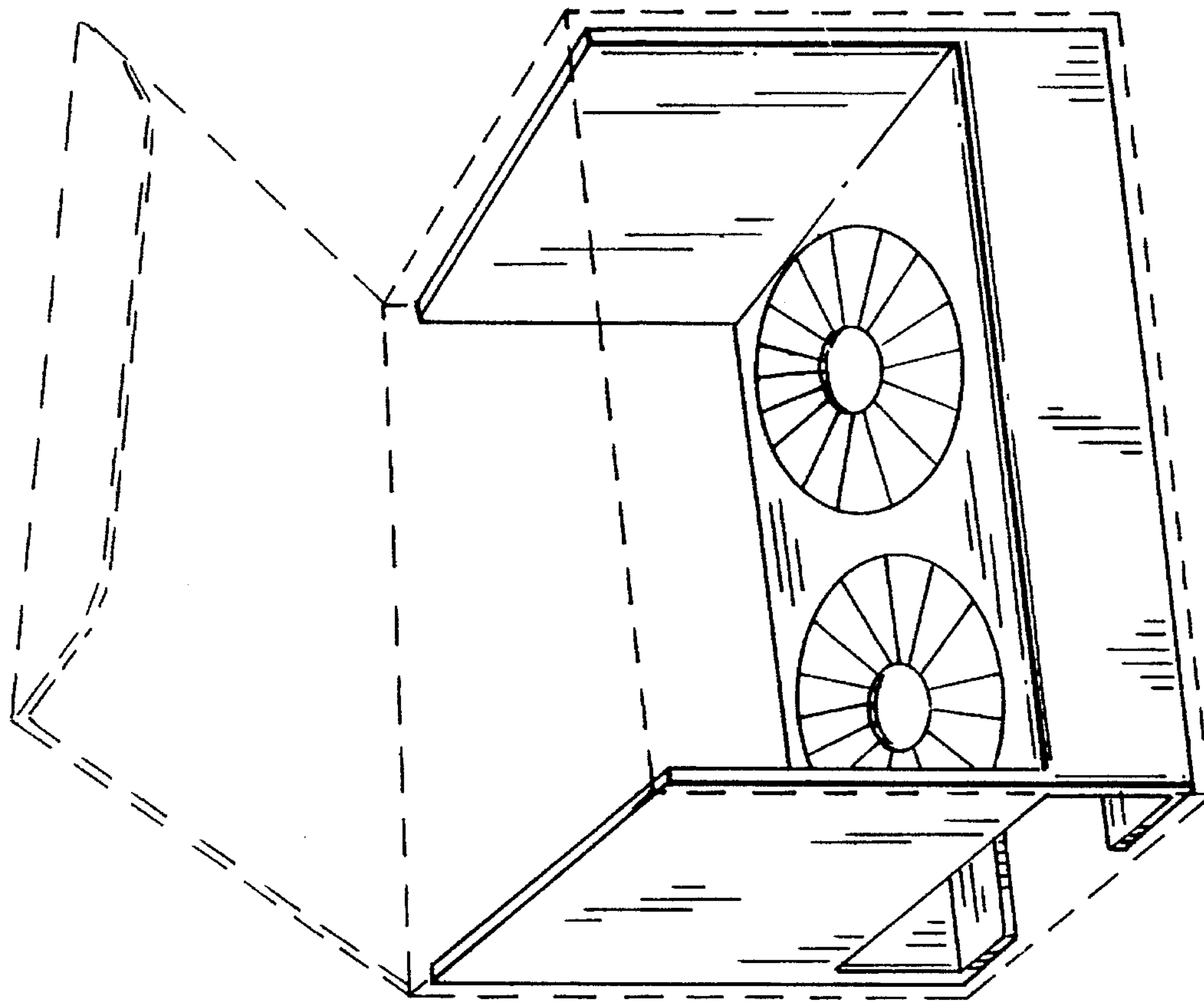

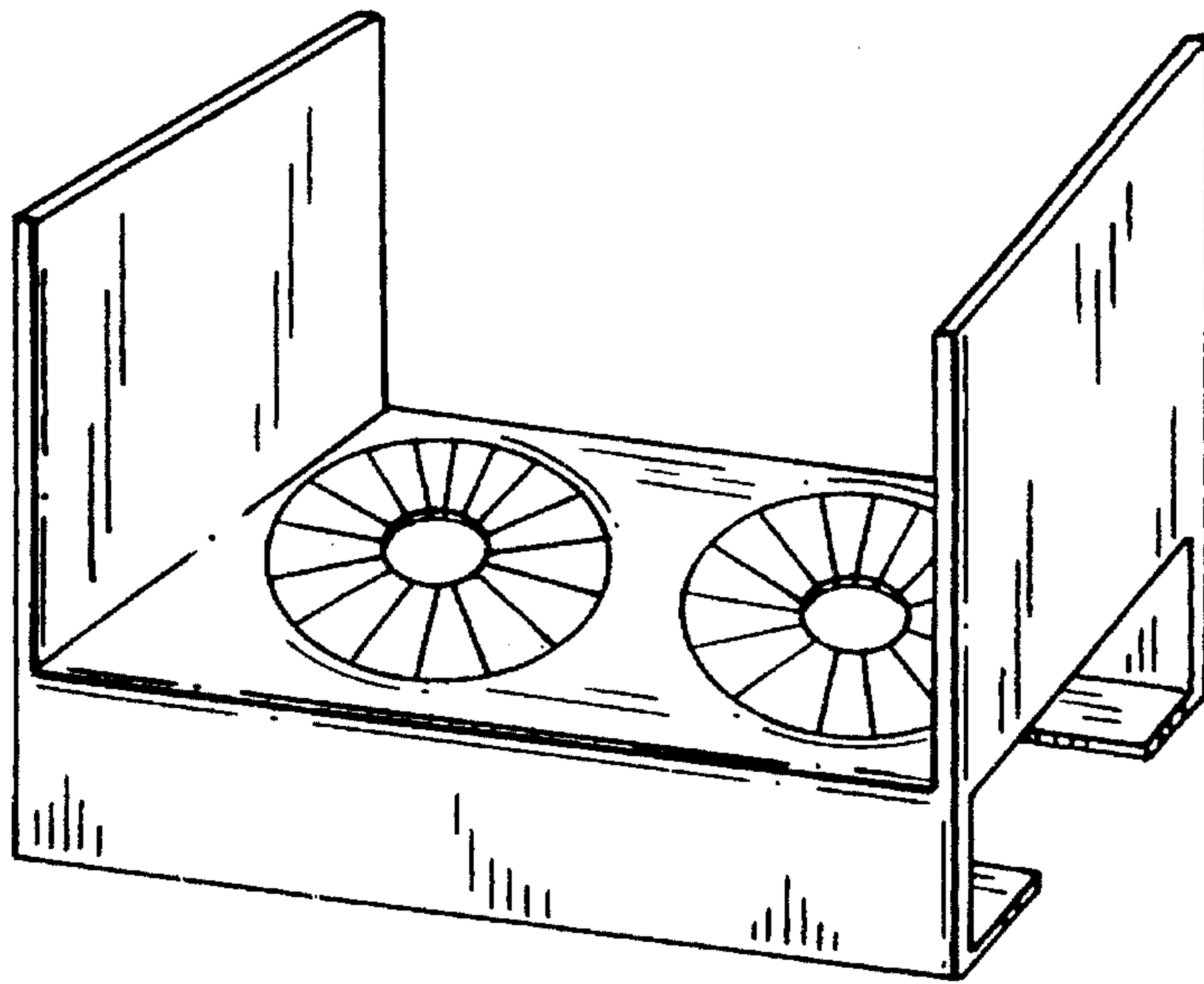

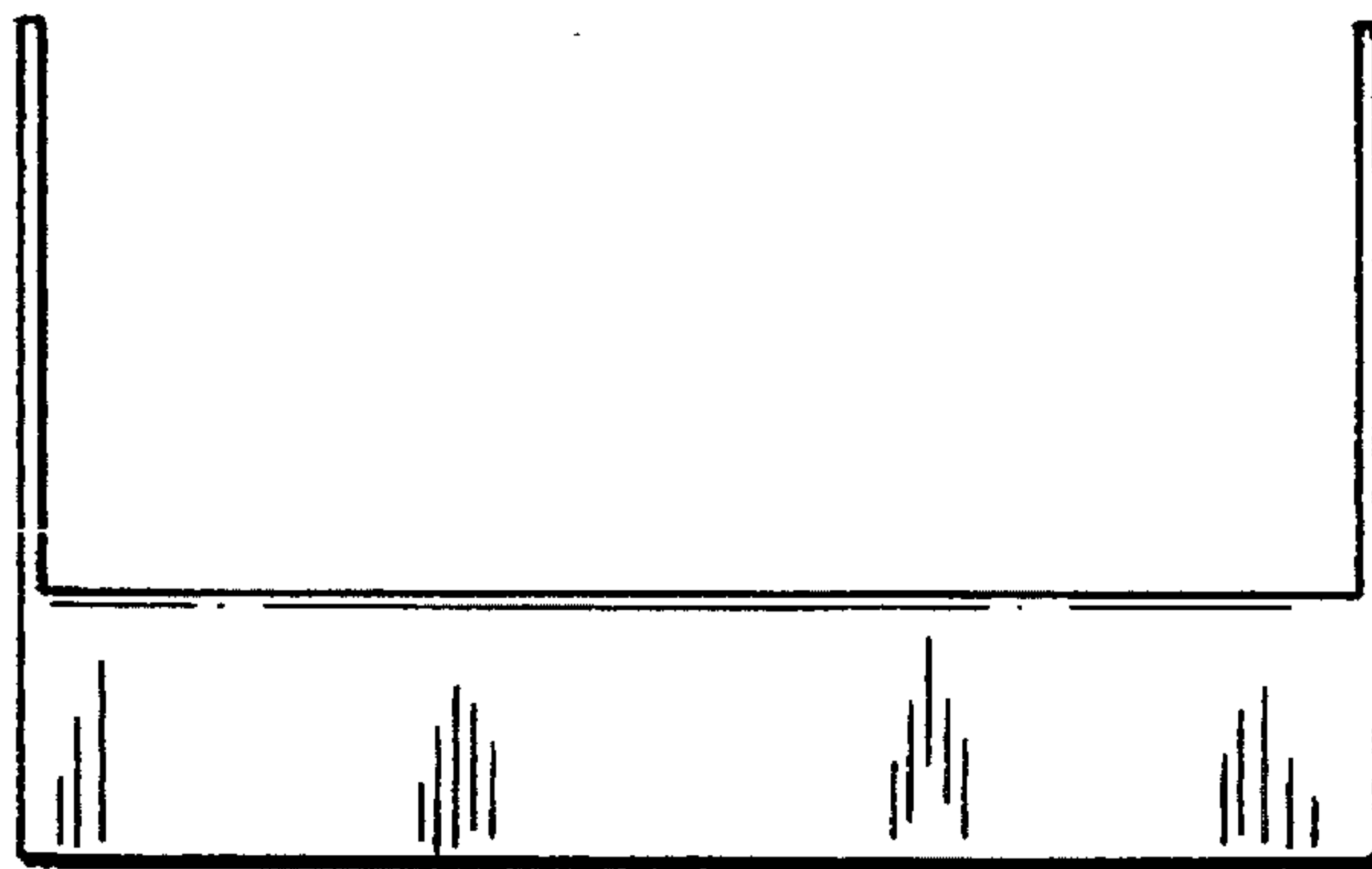

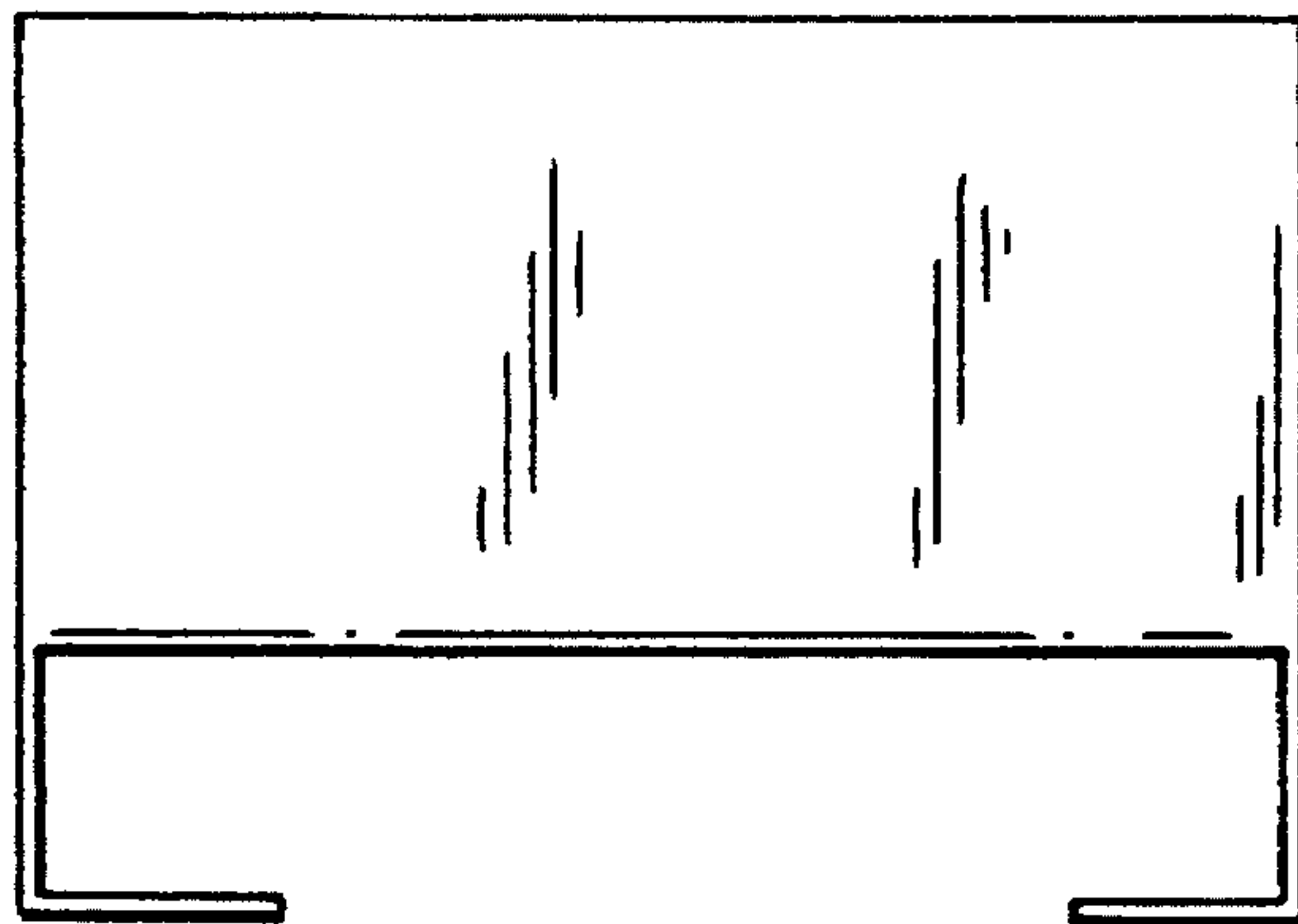

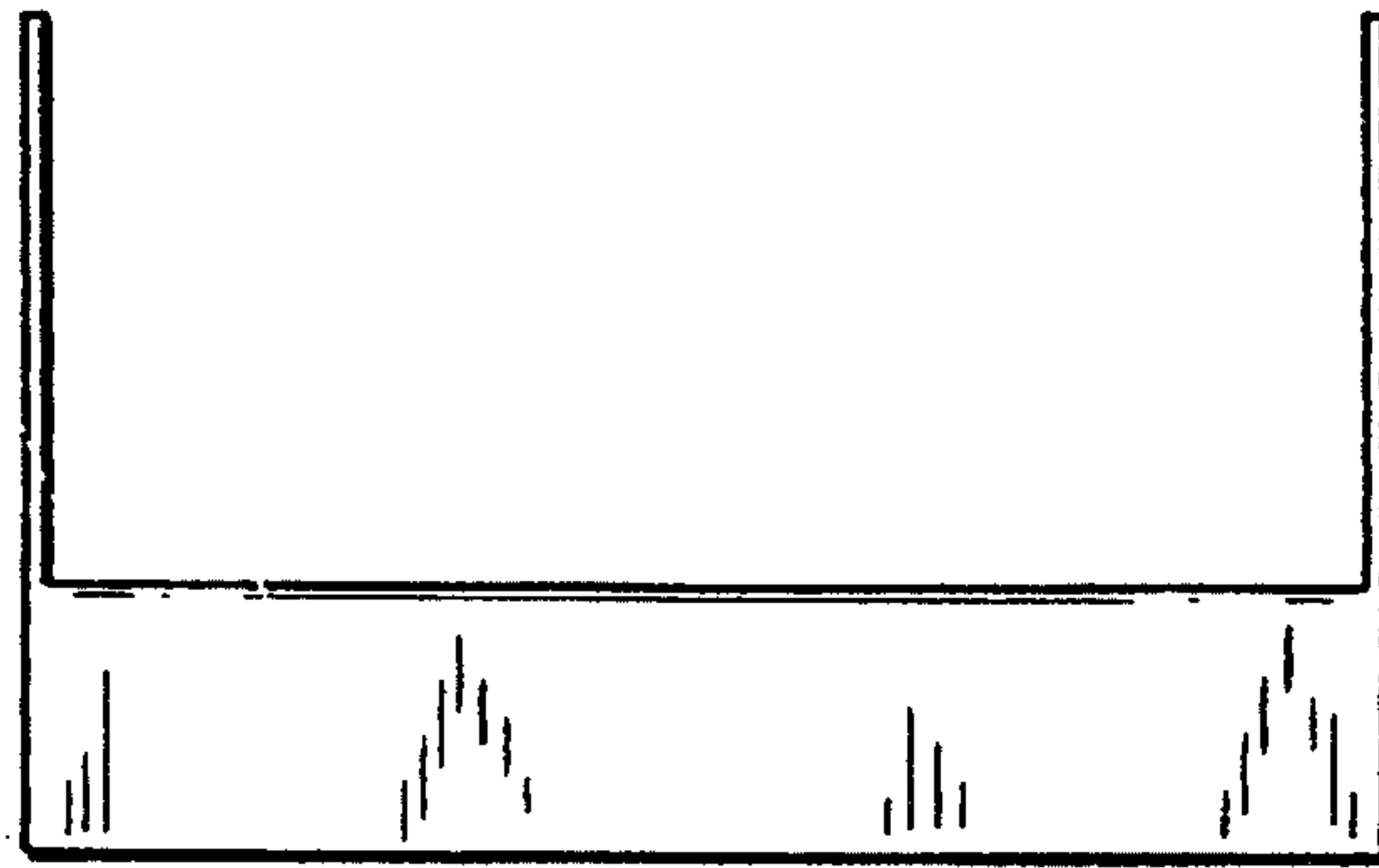

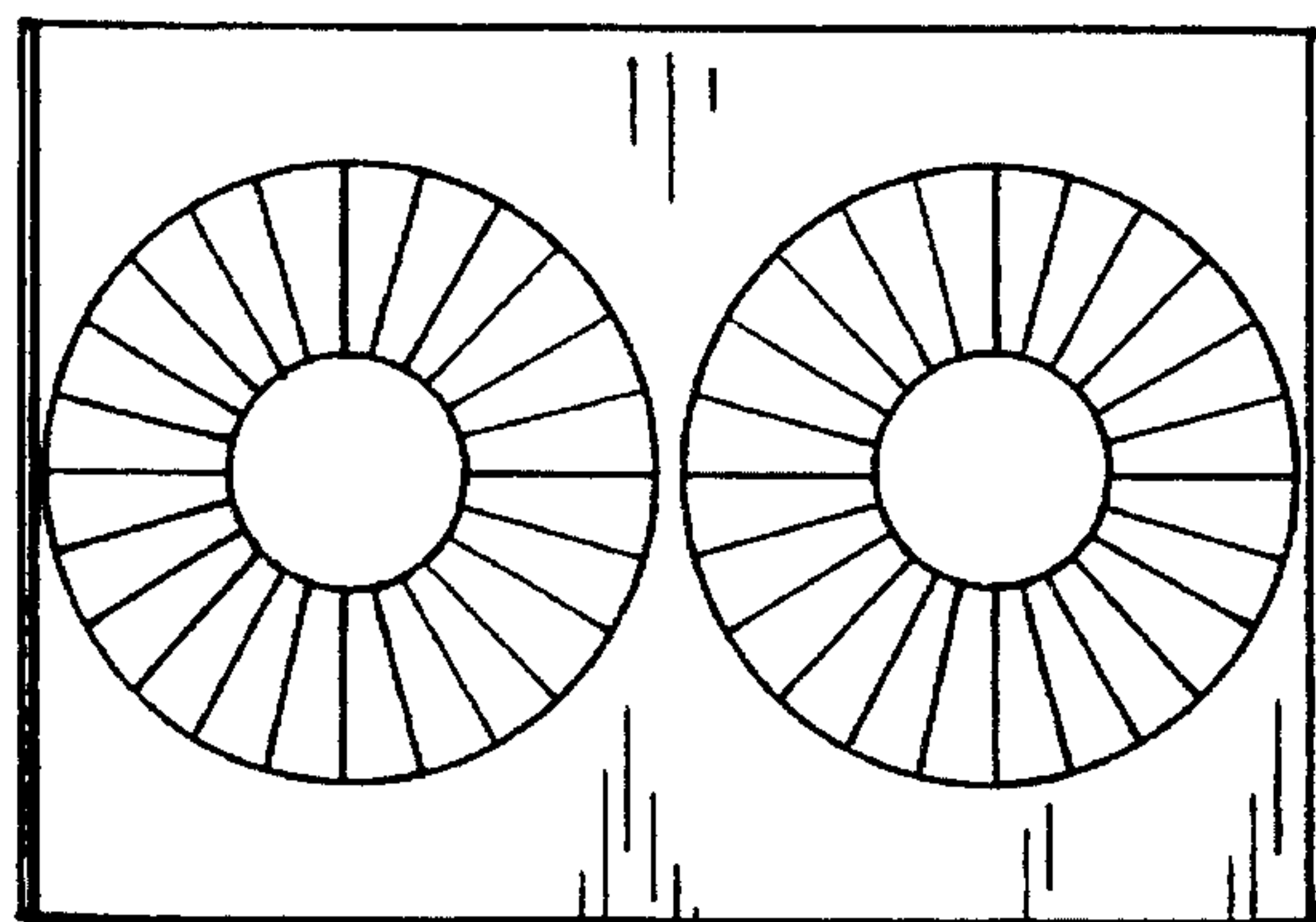
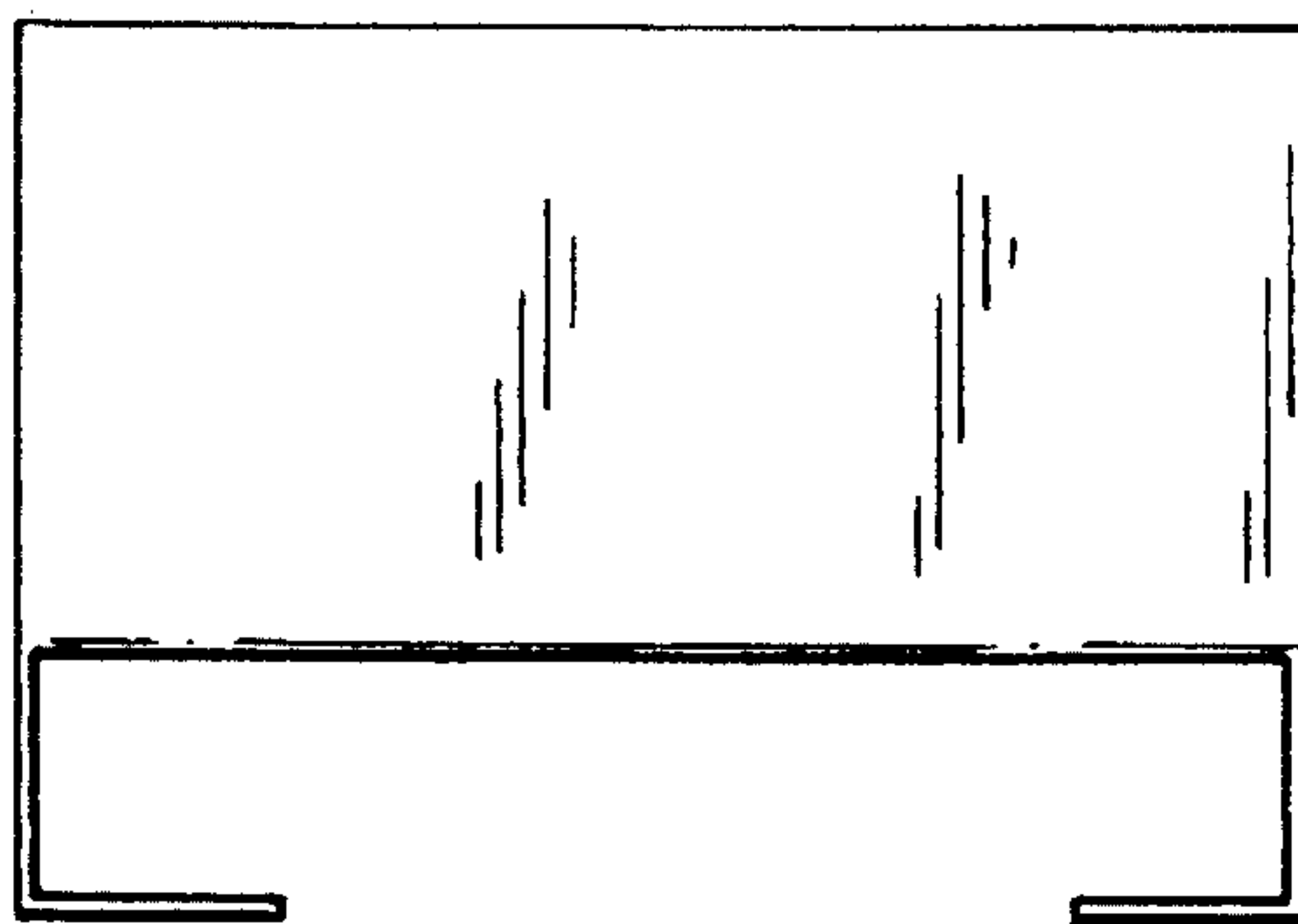

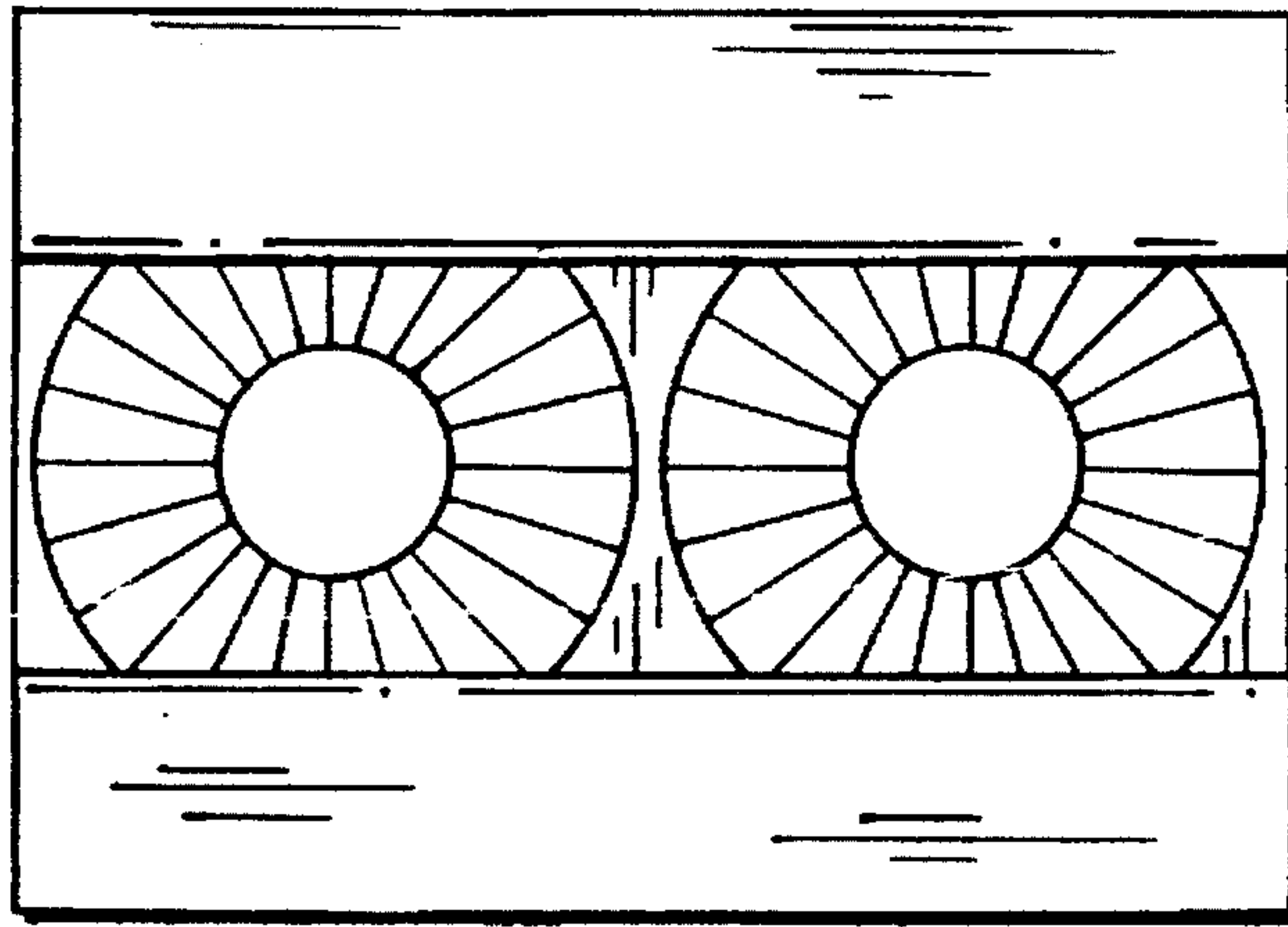

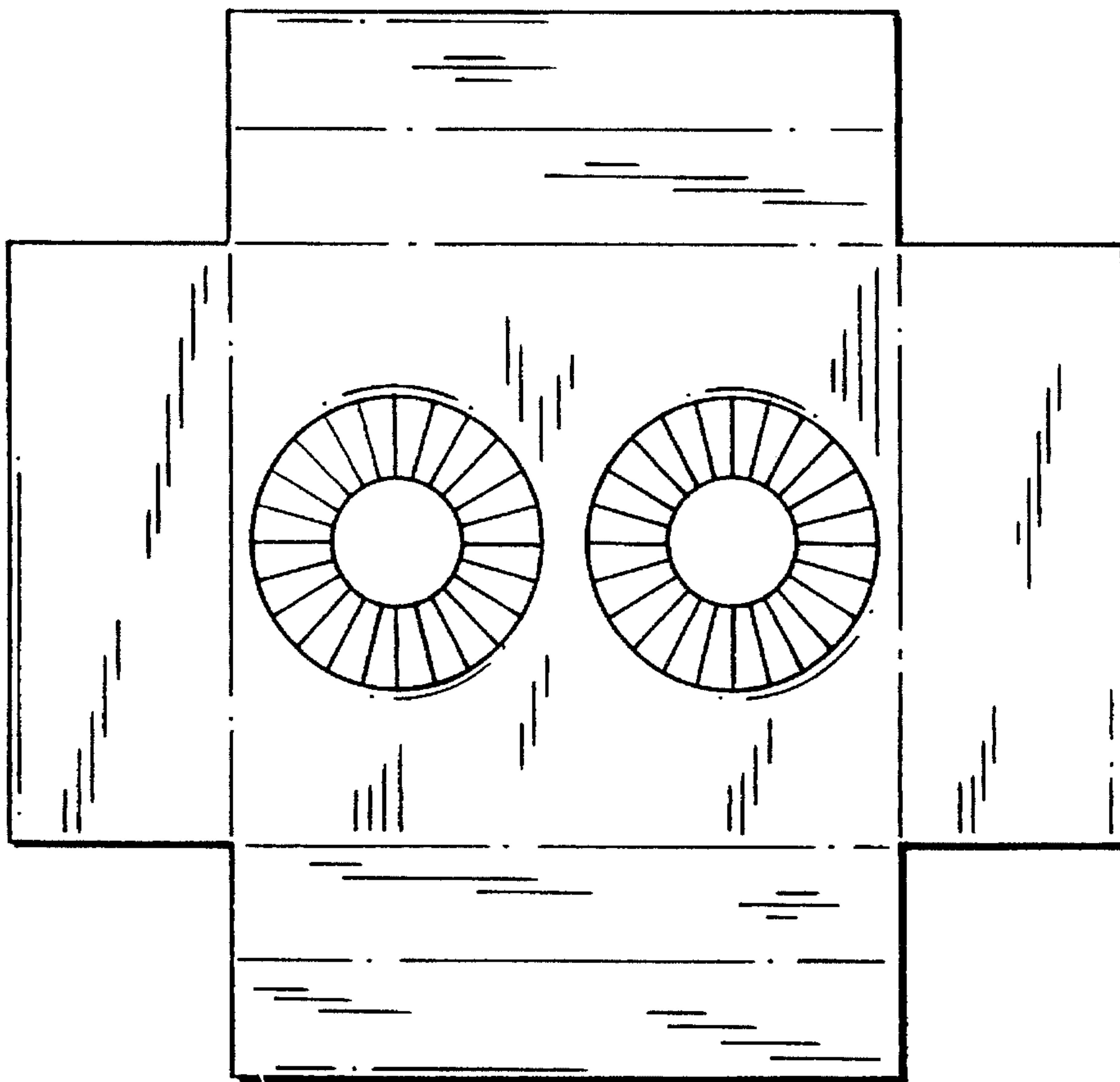
