[57] **CLAIM**

The ornamental design for a portable data terminal with rotatable head, as shown and described.

DESCRIPTION

FIG. 1 is a front and left side perspective view of a portable data terminal with rotatable head showing my new design; FIG. 2 is a left side view of the portable data terminal of FIG. 1;

FIG. 3 is a right side view of the portable data terminal of FIG. 1;

FIG. 4 is a front view of the portable data terminal of FIG. 1;

FIG. 5 is a back view of the portable data terminal of FIG. 1;

FIG. 6 is a top view of the portable data terminal of FIG. 1;

FIG. 7 is a bottom view of the portable data terminal of FIG. 1;

FIG. 8 is a front and left side perspective view of a second embodiment of a portable data terminal with rotatable head it being understood that the undisclosed bottom view is identical to that of the first embodiment;

FIG. 9 is a left side view of the portable data terminal of FIG. 8;

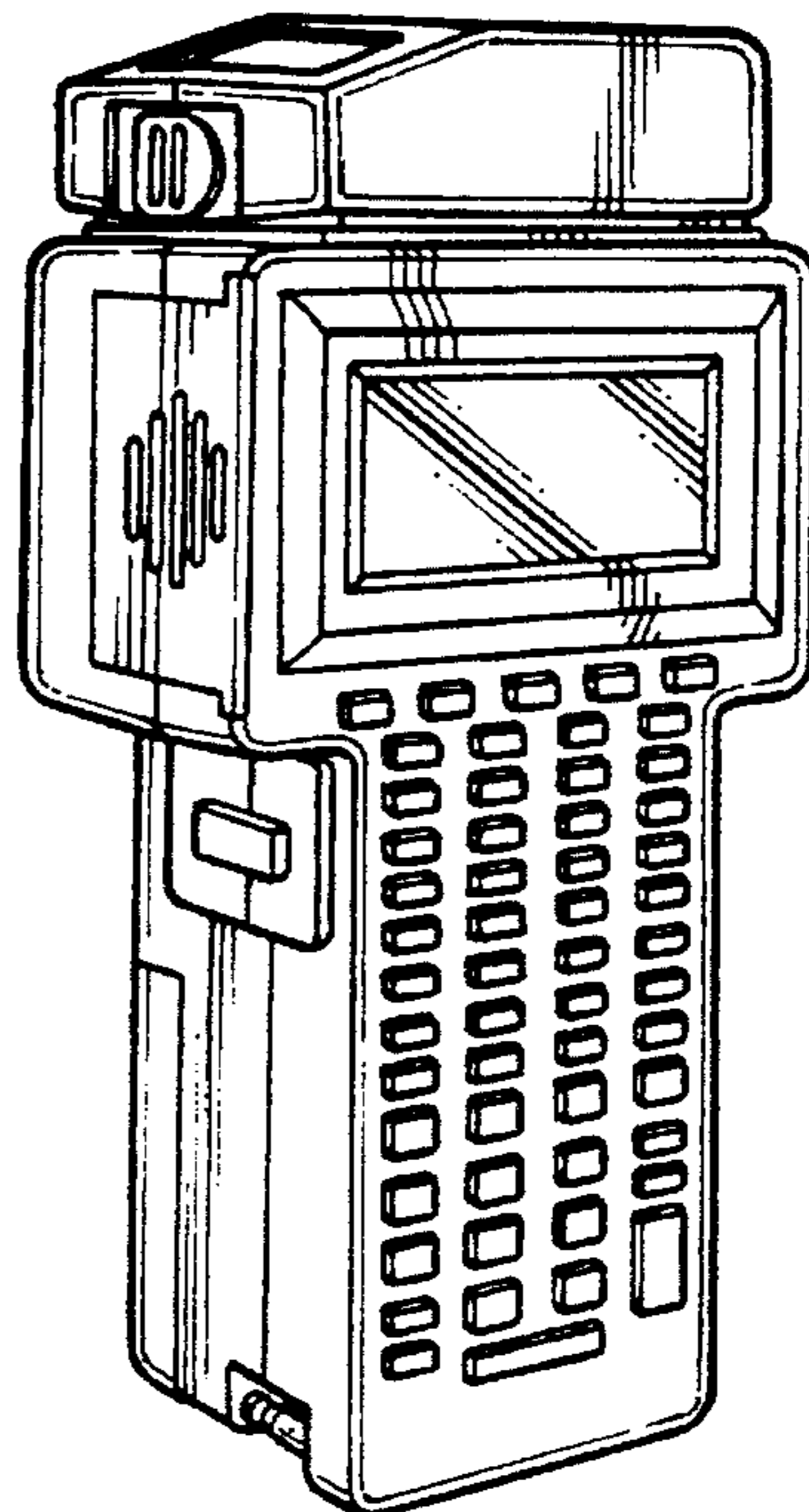
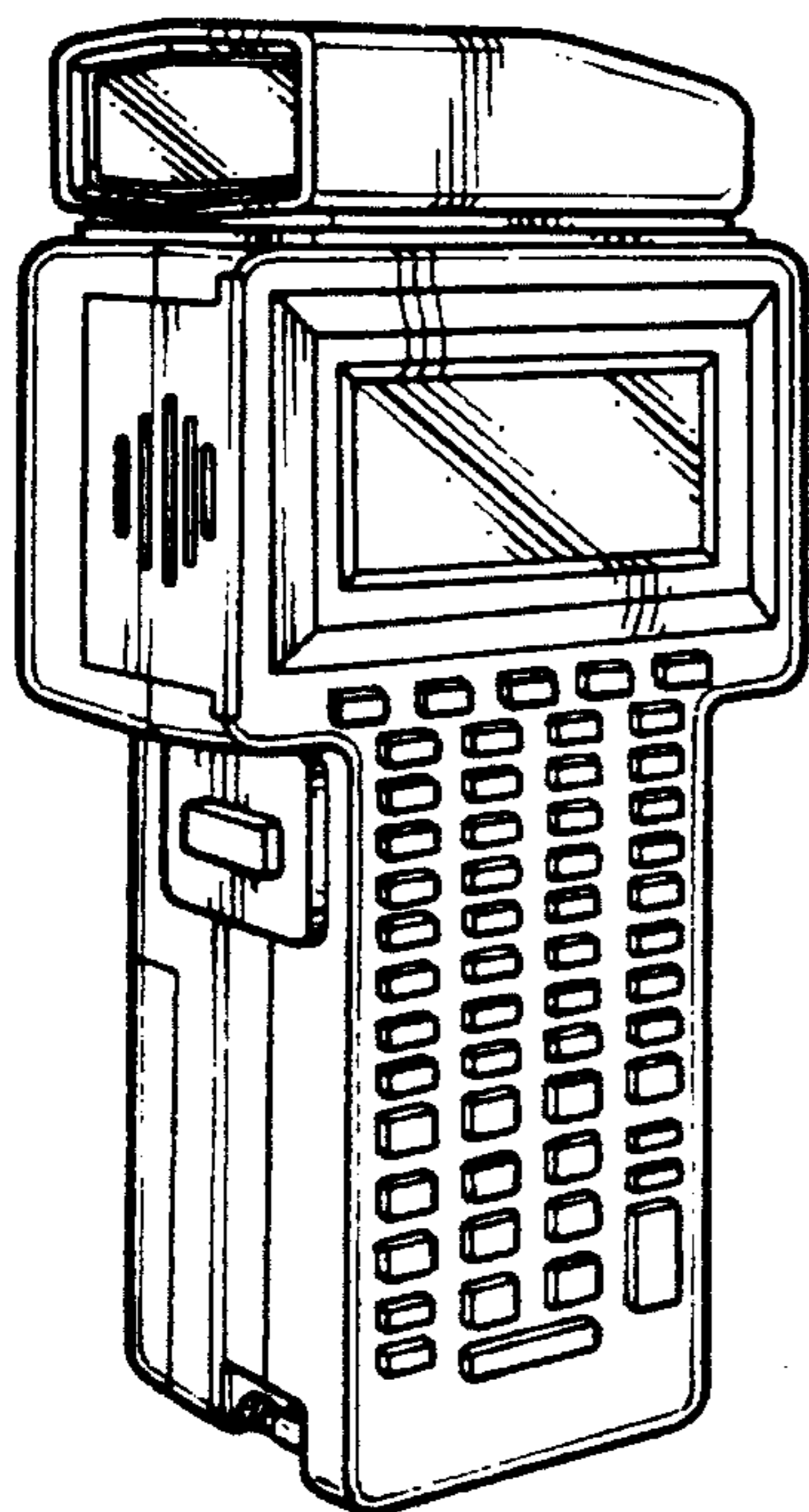
FIG. 10 is a right side view of the portable data terminal of FIG. 8;

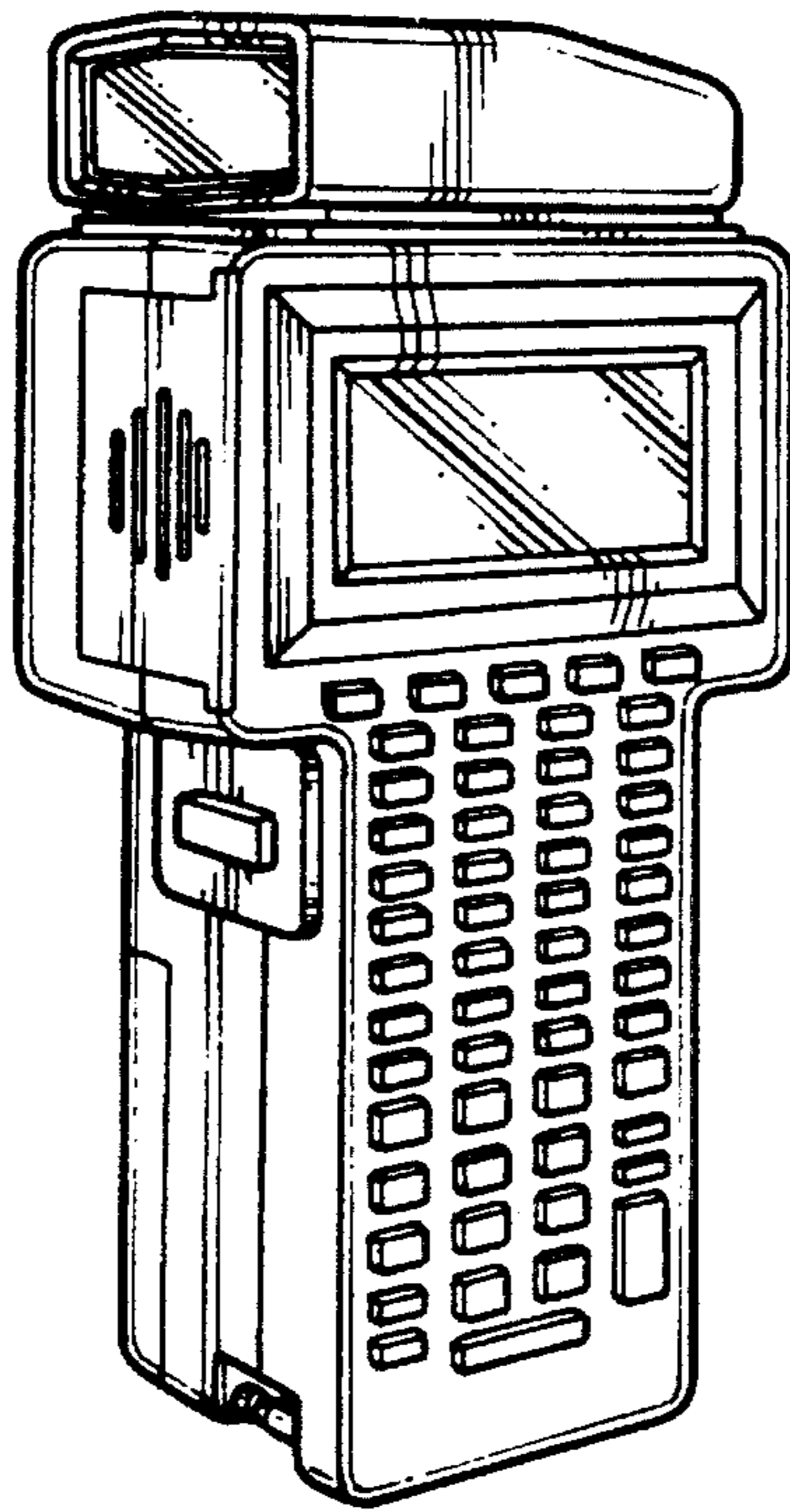

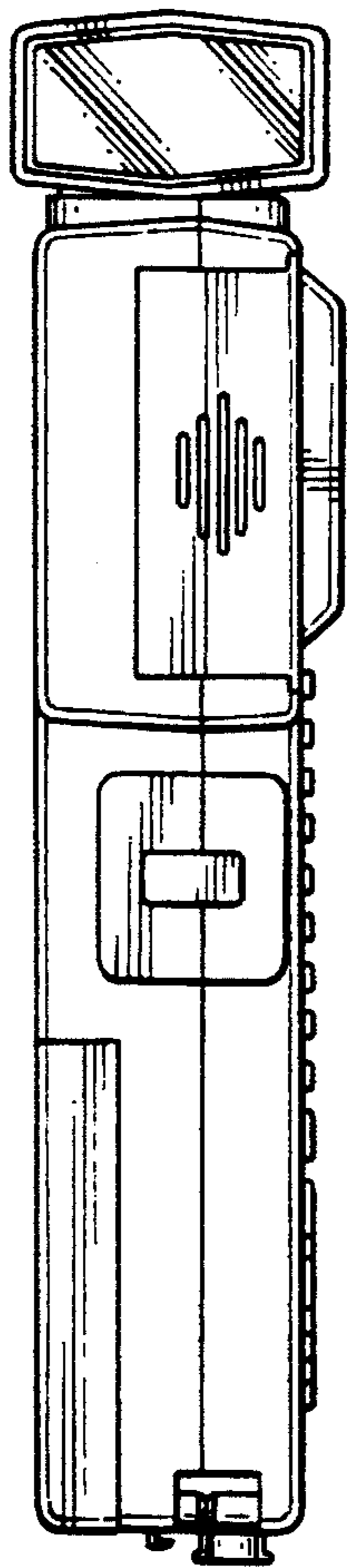

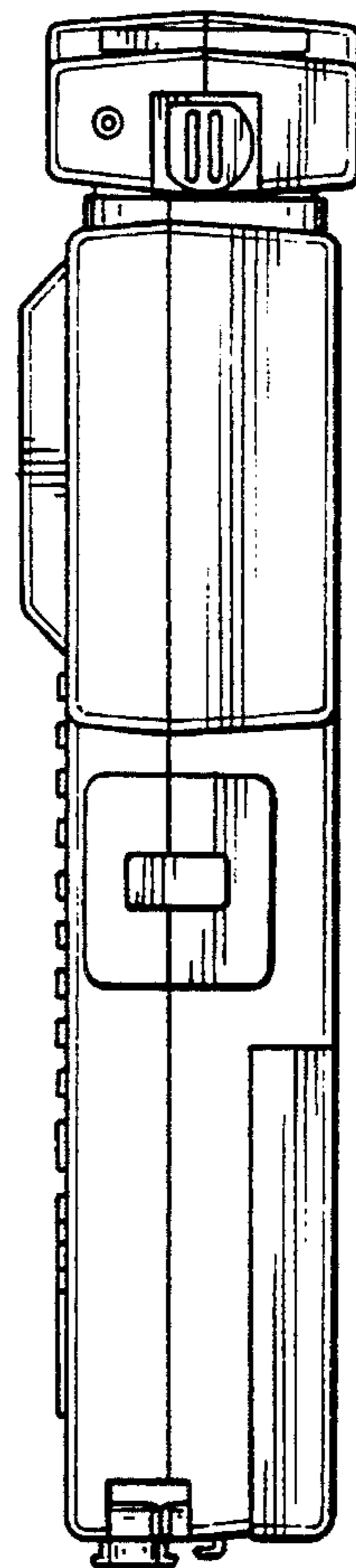

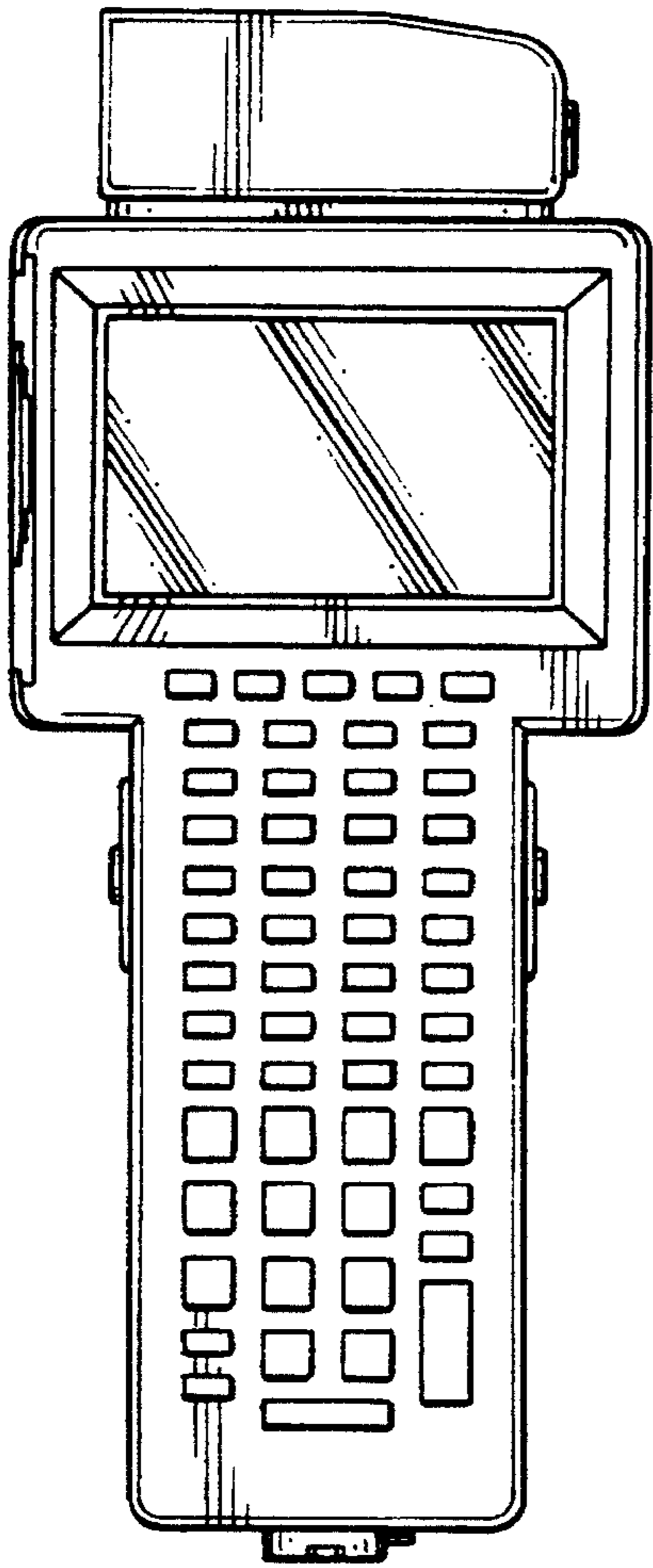

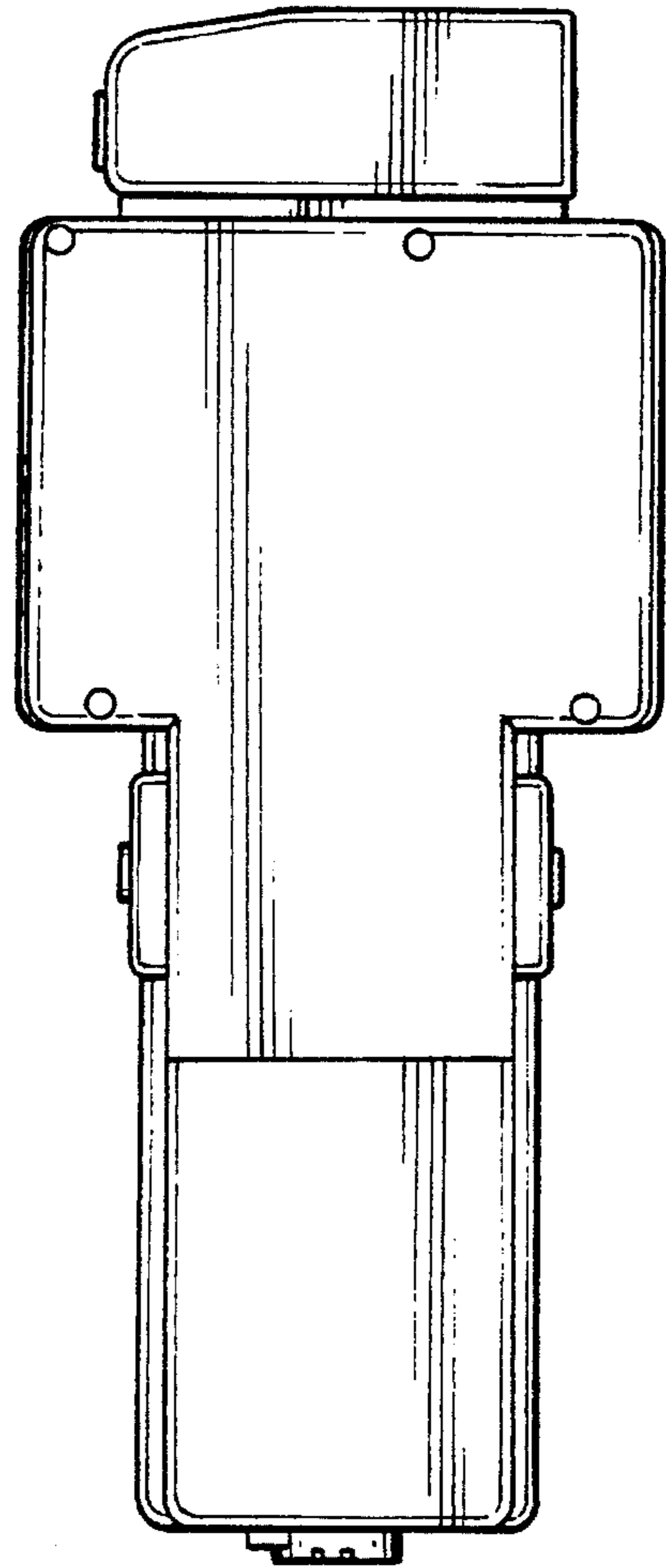

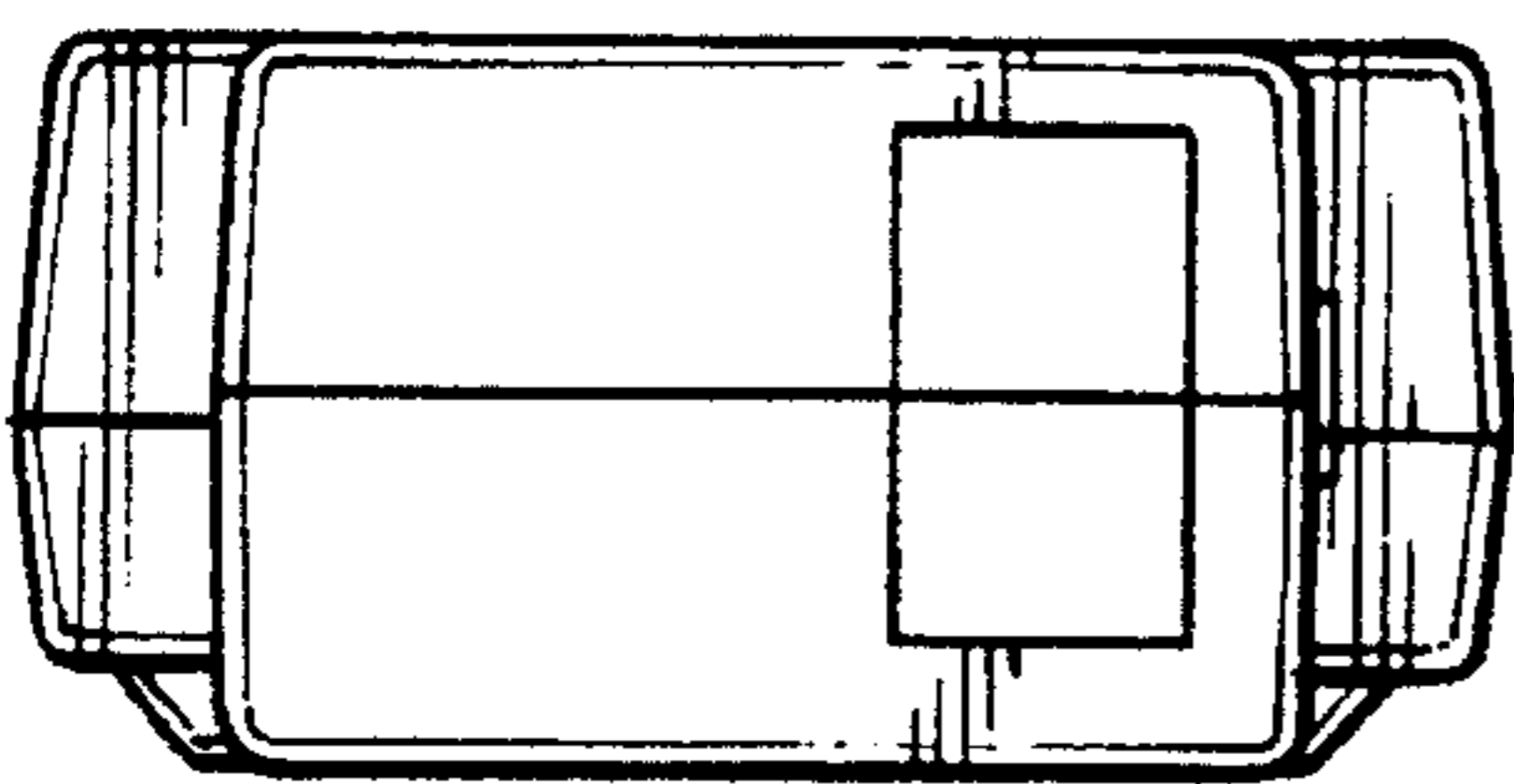

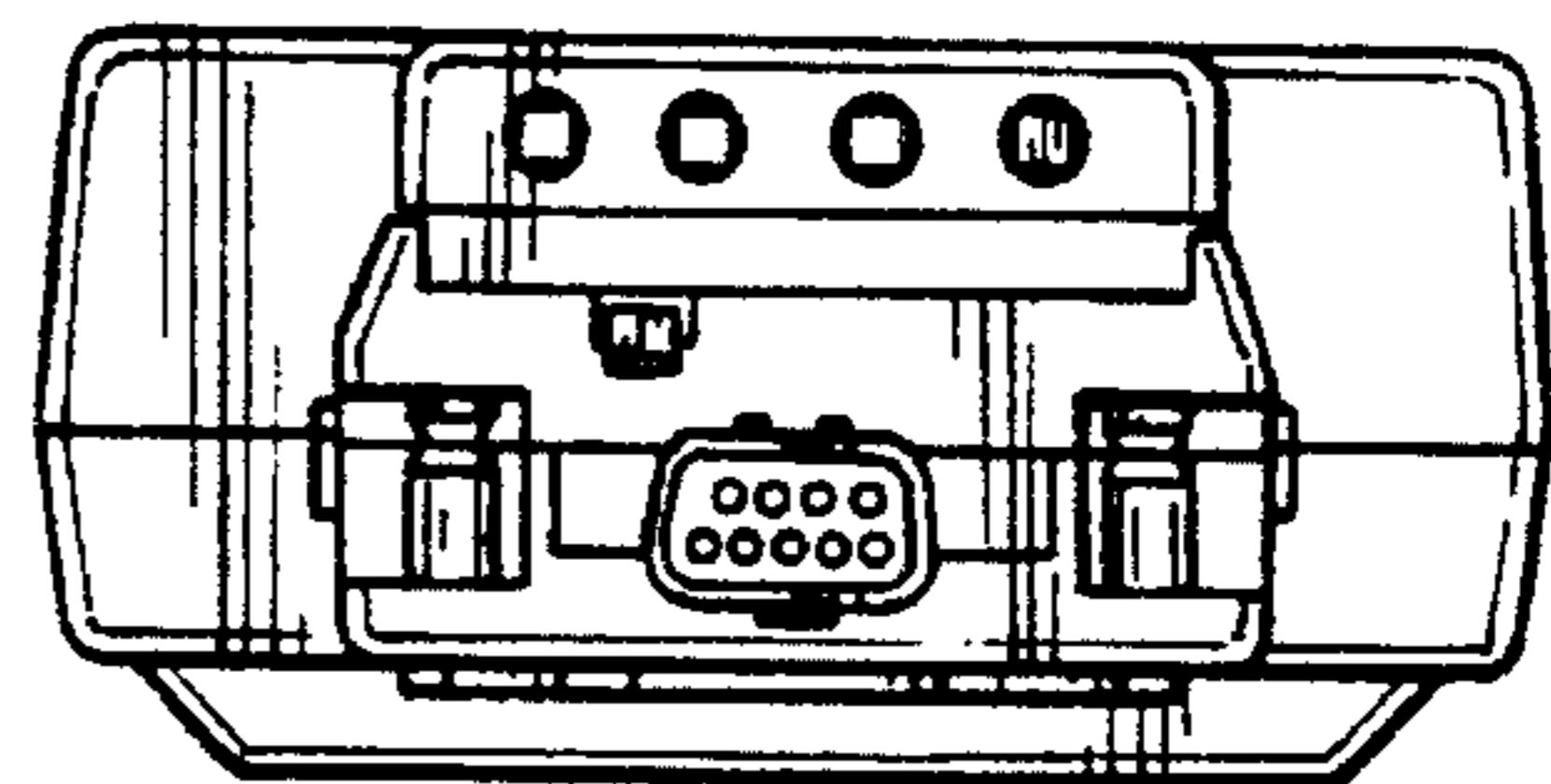

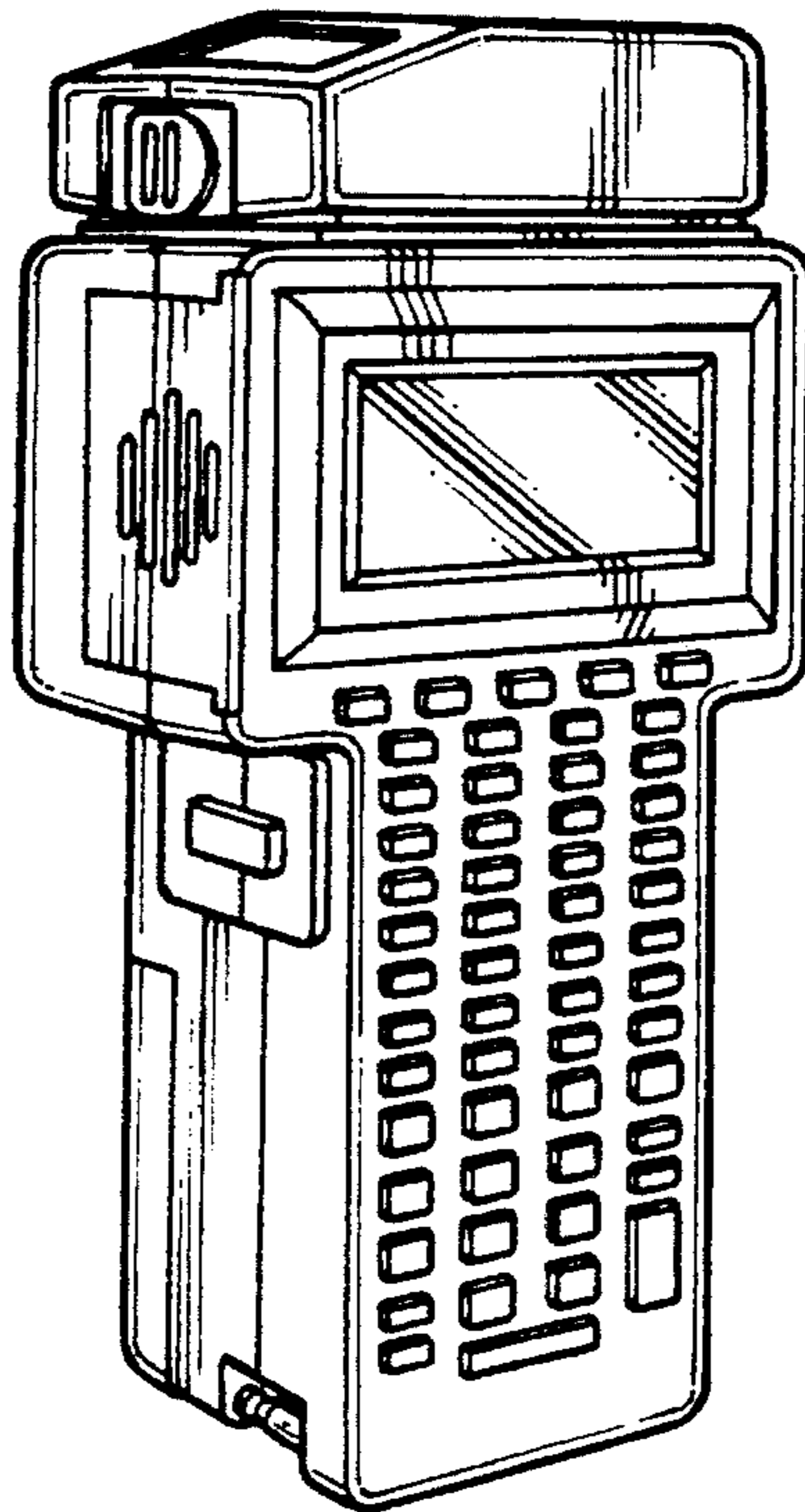

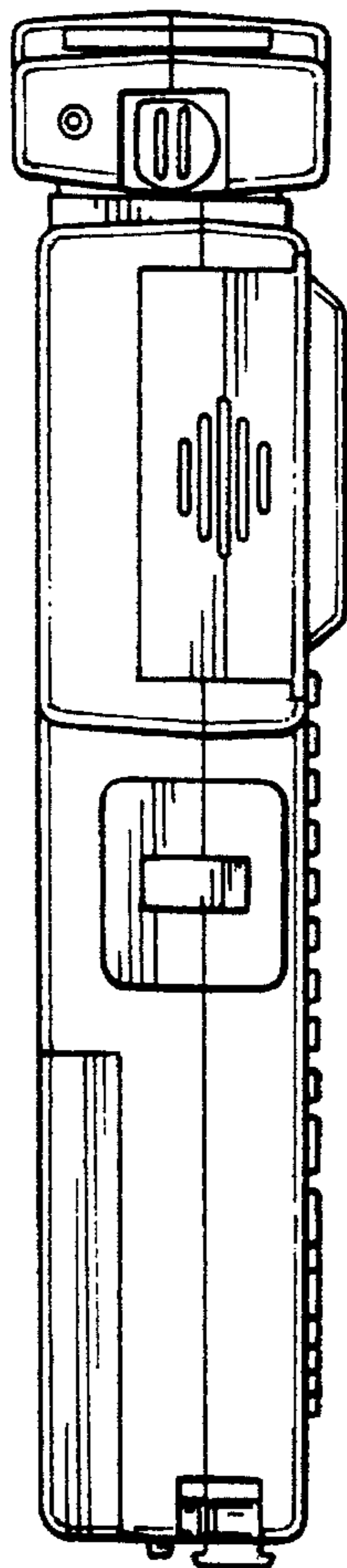
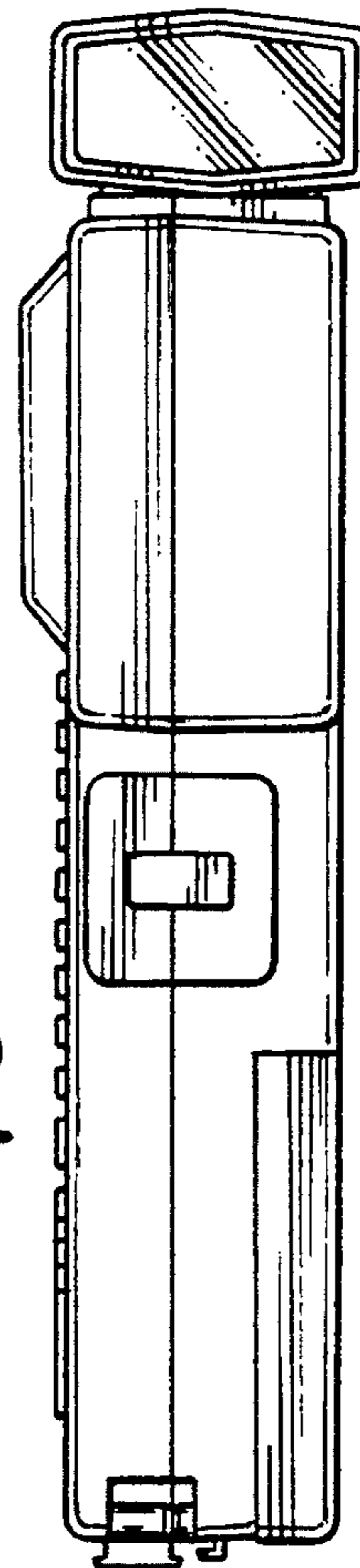

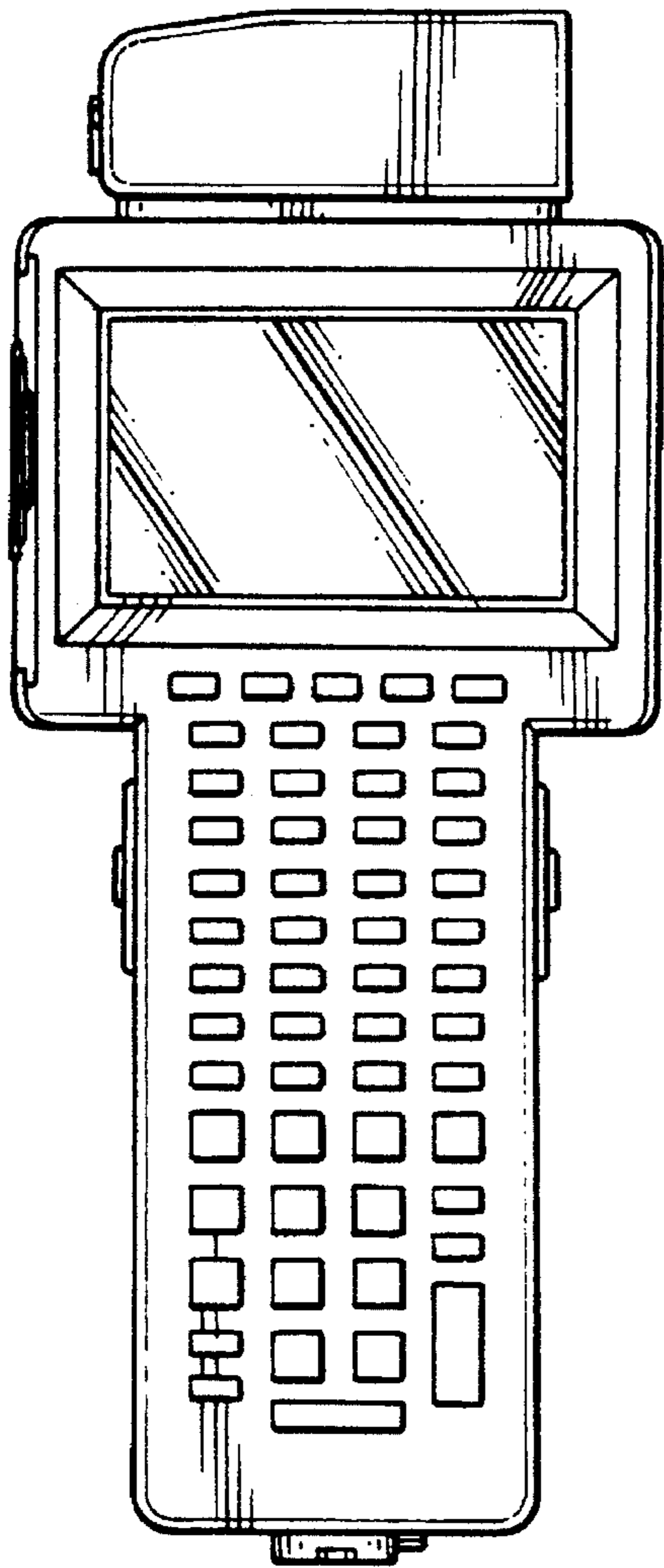

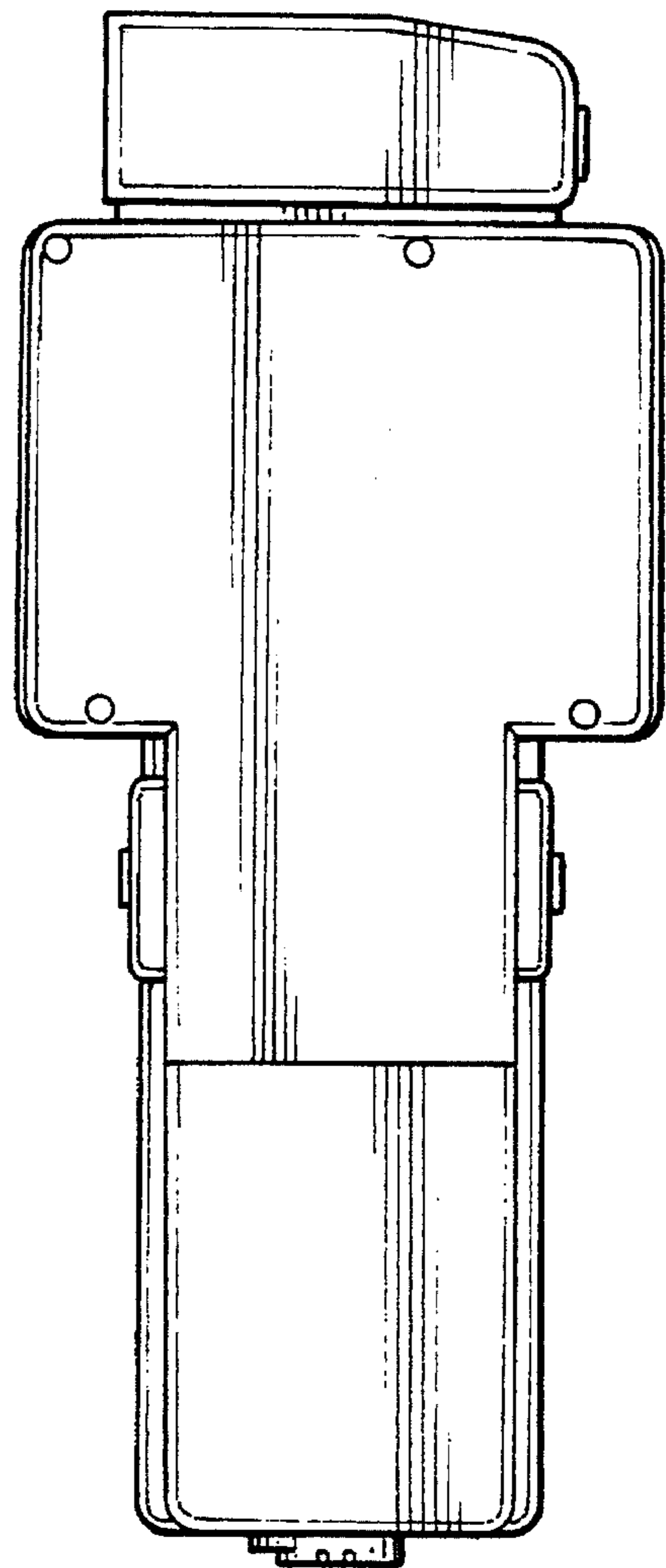

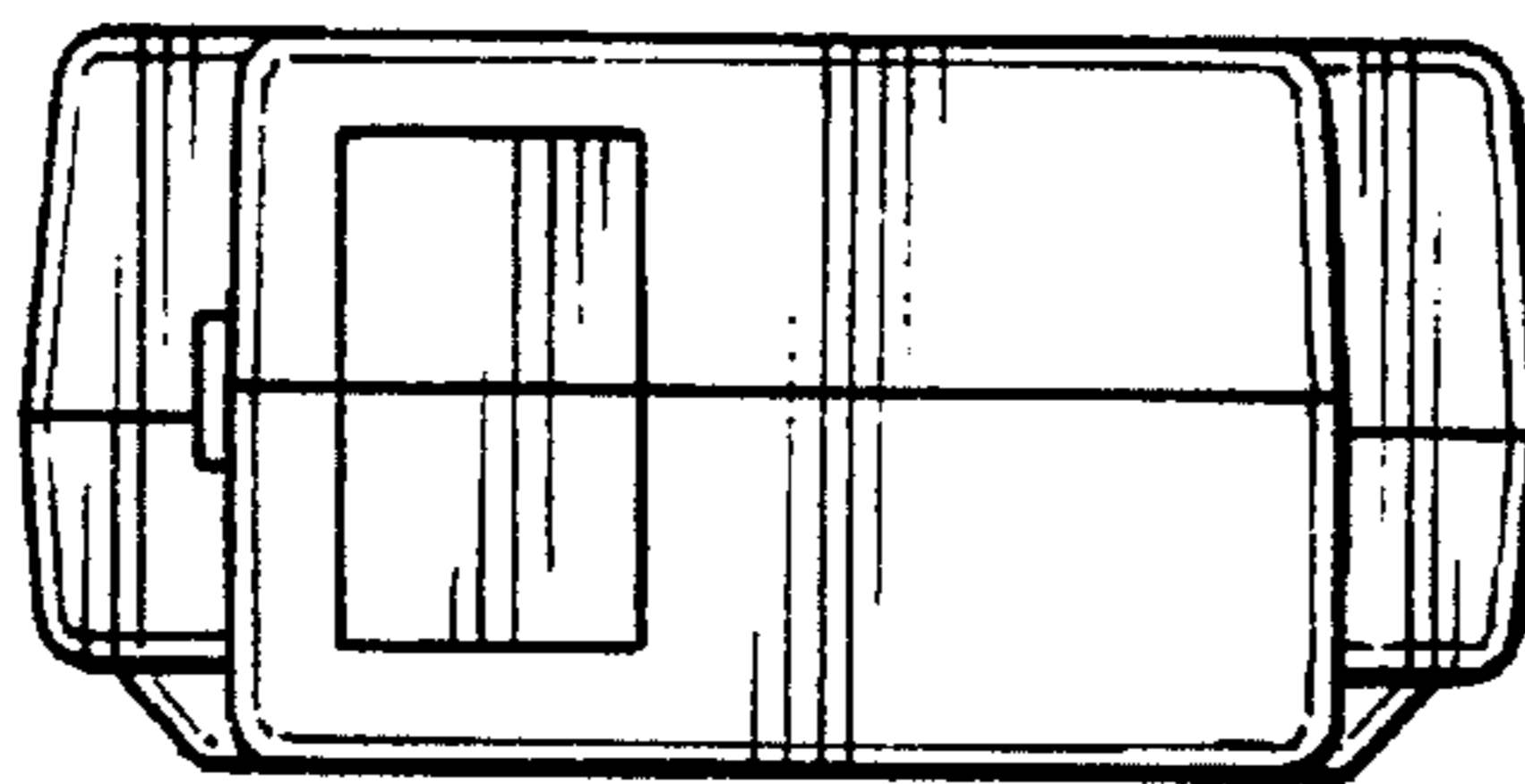
