### DESCRIPTION

FIG. 1 is a top plan view of an abrasive pin for a sanding machine head embodying the new design;  
FIG. 2 is a front elevational view of the abrasive pin for a sanding machine head of FIG. 1, which is a mirror image of the rear elevational view thereof;  
FIG. 3 is a right side elevational view of the abrasive pin for a sanding machine head of FIG. 1;  
FIG. 4 is a left side elevational view of an abrasive pin for a sanding machine head for FIG. 1;  
FIG. 5 is a bottom plan view of the abrasive pin for a sanding machine head of FIG. 4; and,  
FIG. 6 is a exploded perspective view of the abrasive pin for a sanding machine head of FIG. 1.

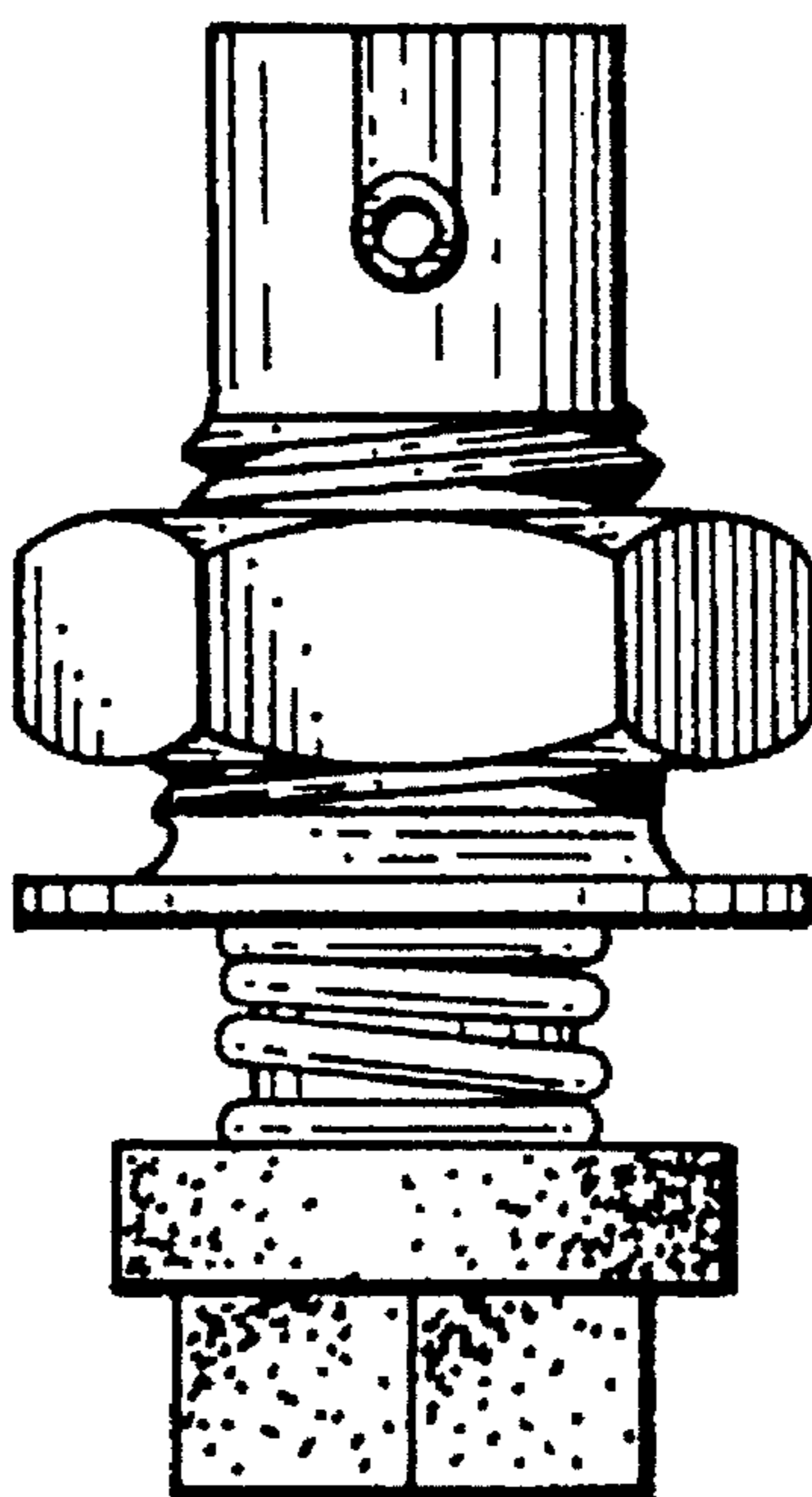

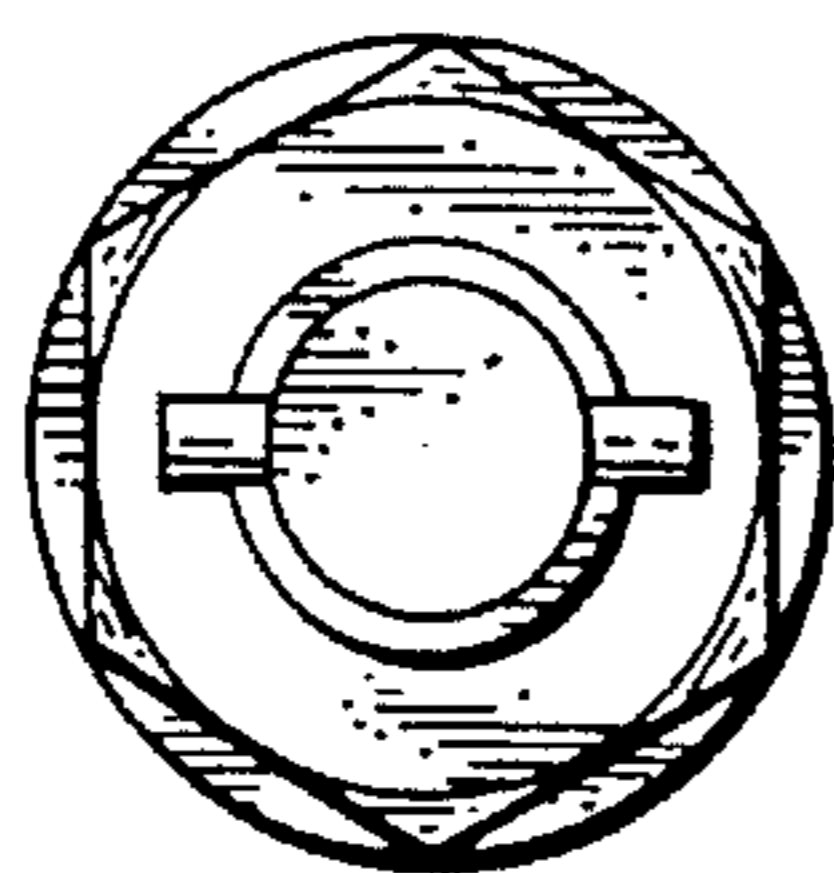

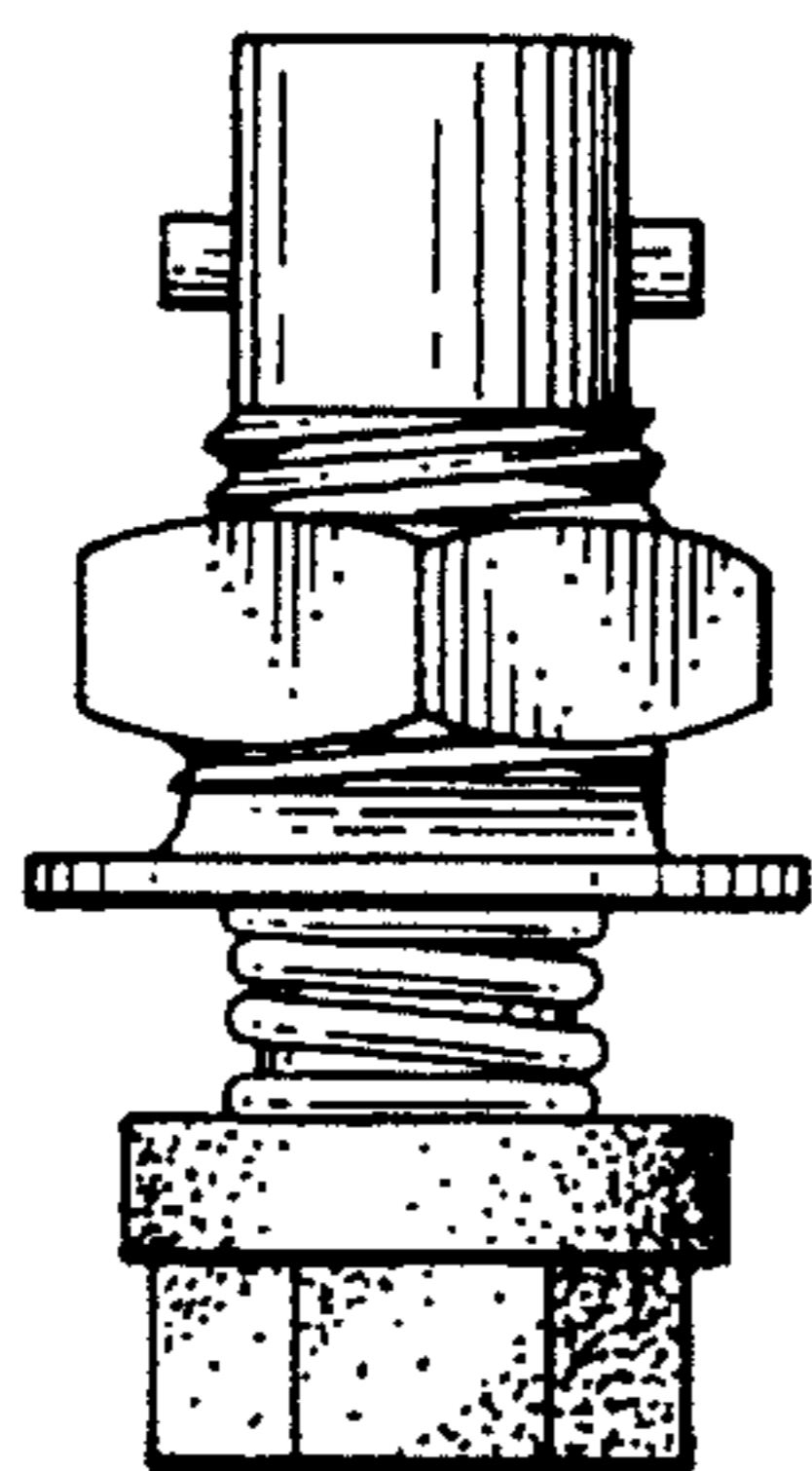

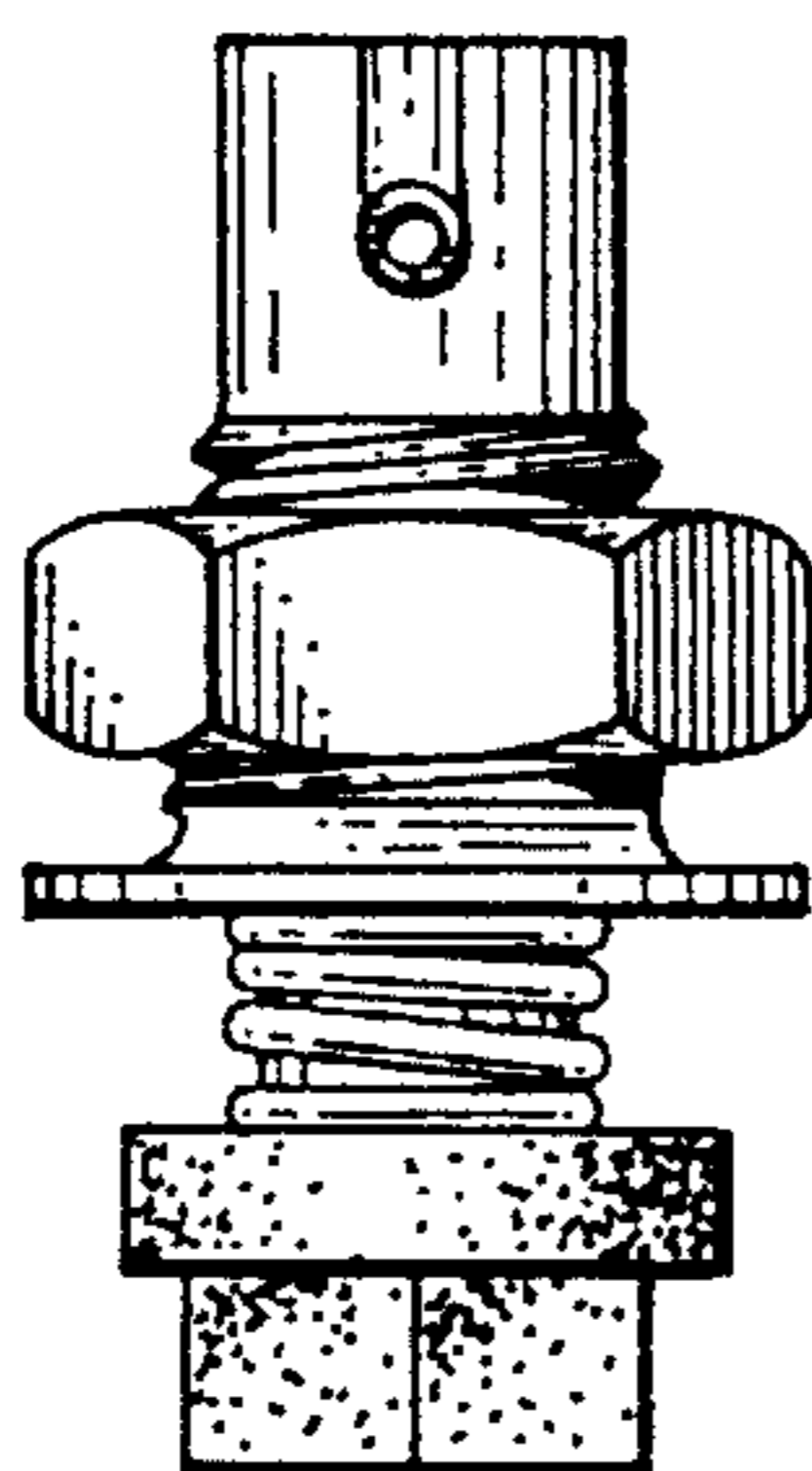

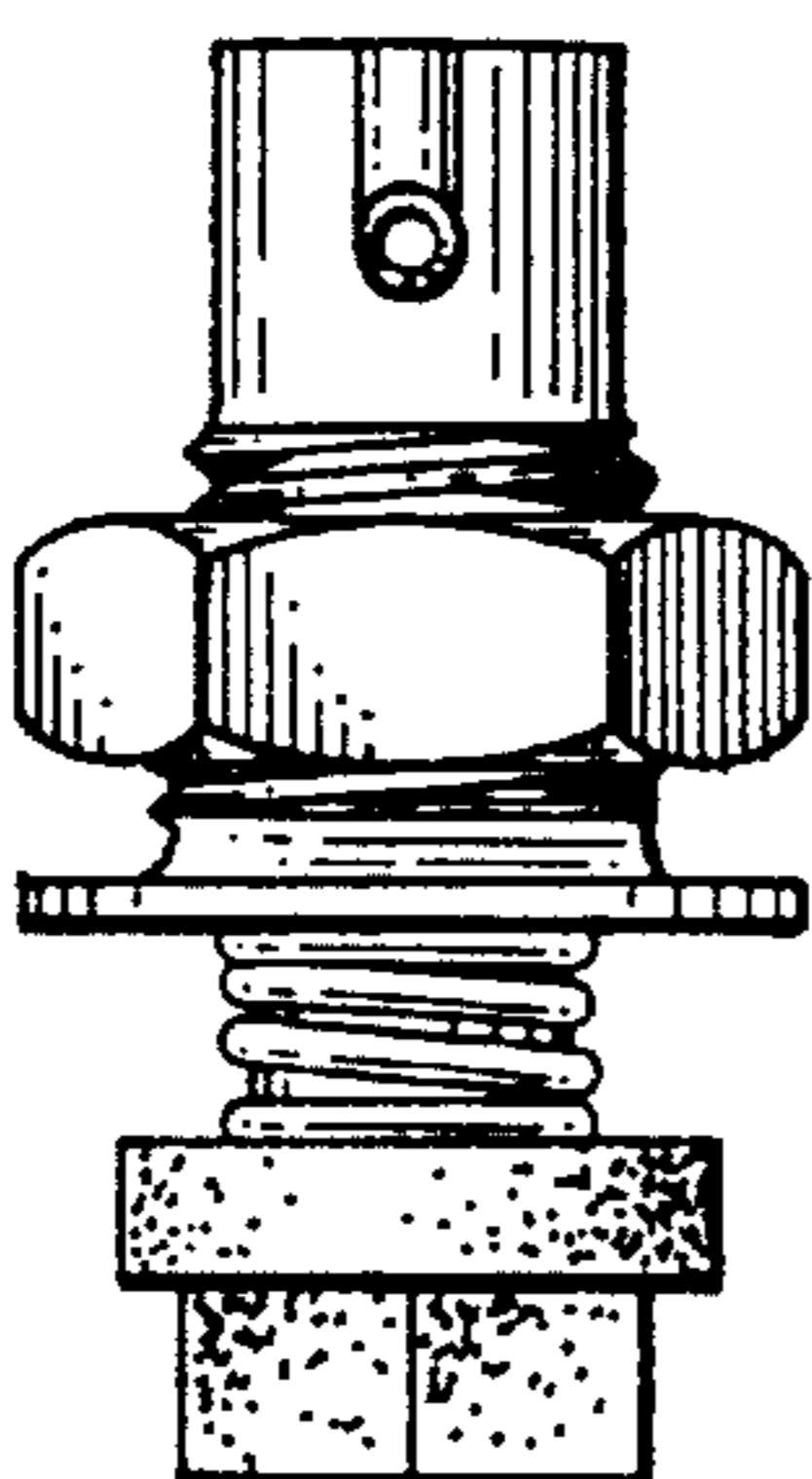

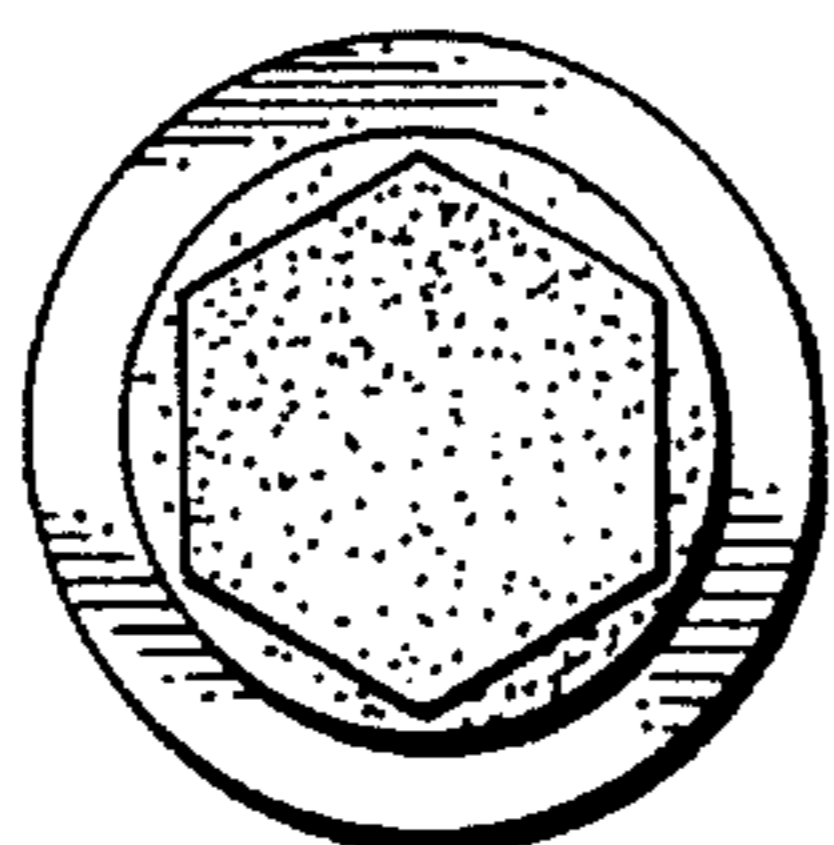
