FIG. 4 is a perspective view thereof;

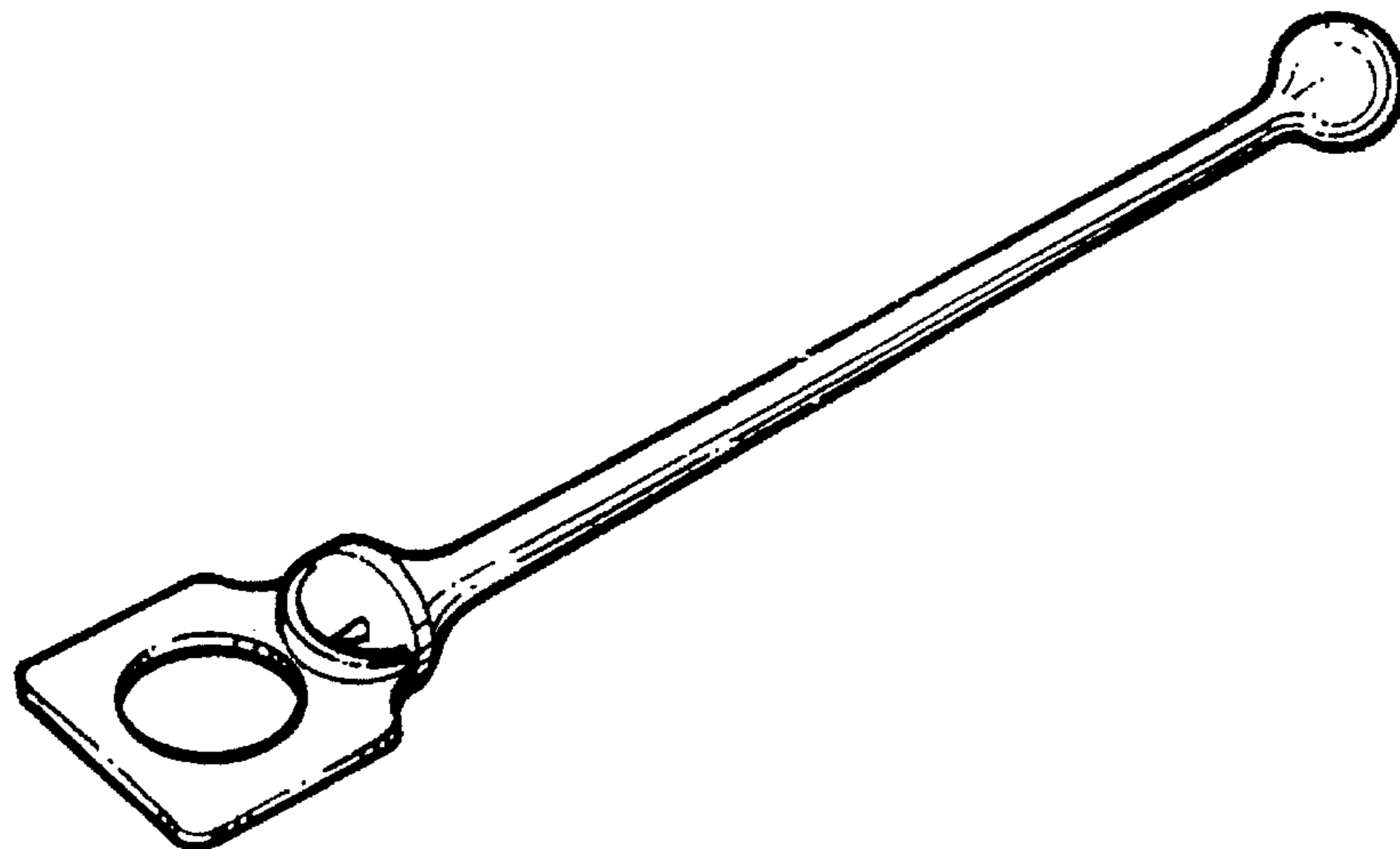
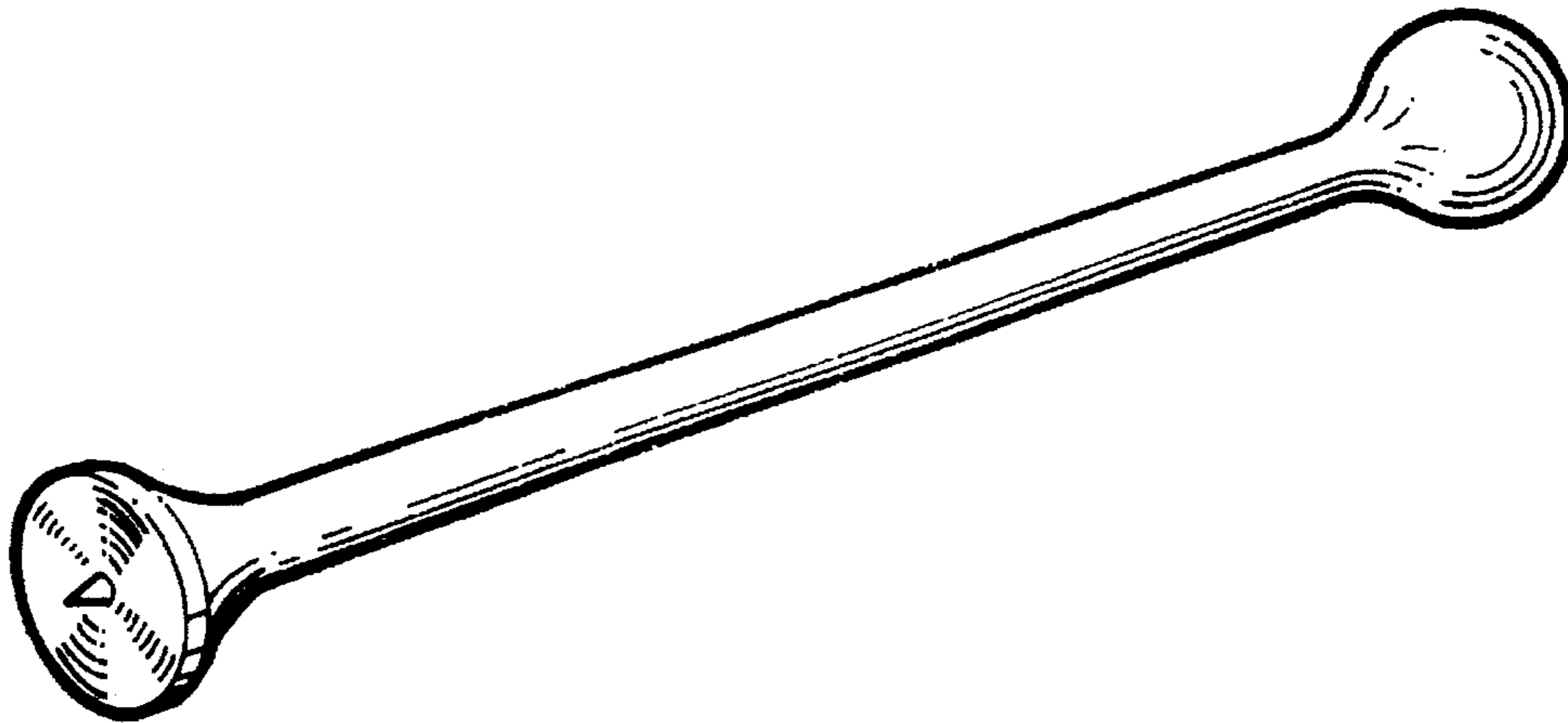
FIG. 5 is a side elevational view of a combined neurological pin showing a second embodiment including protective cap, my new design, the opposite side elevational view being identical;

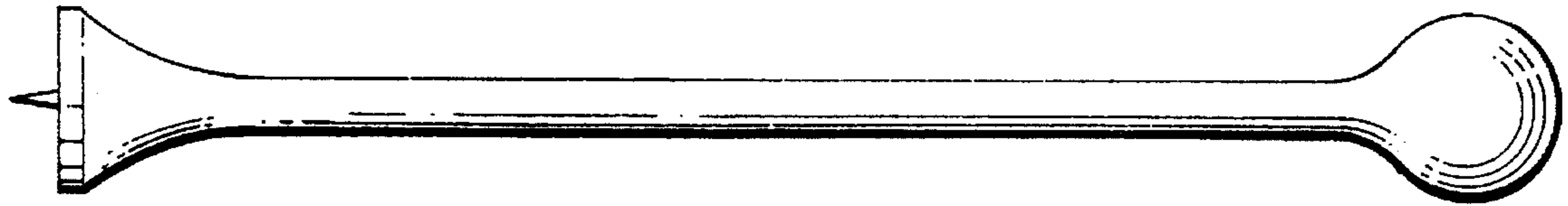

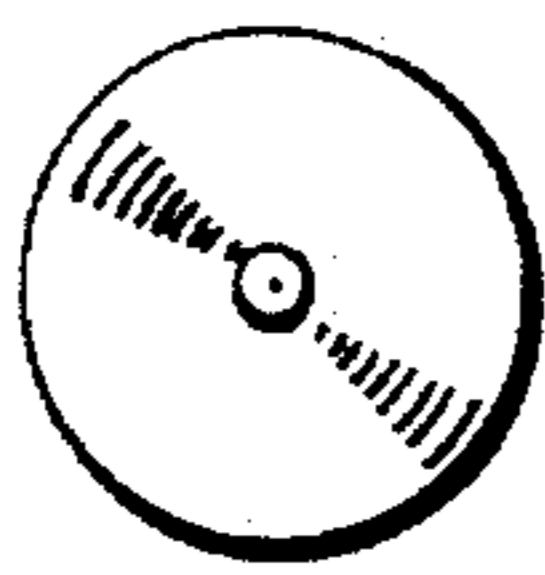

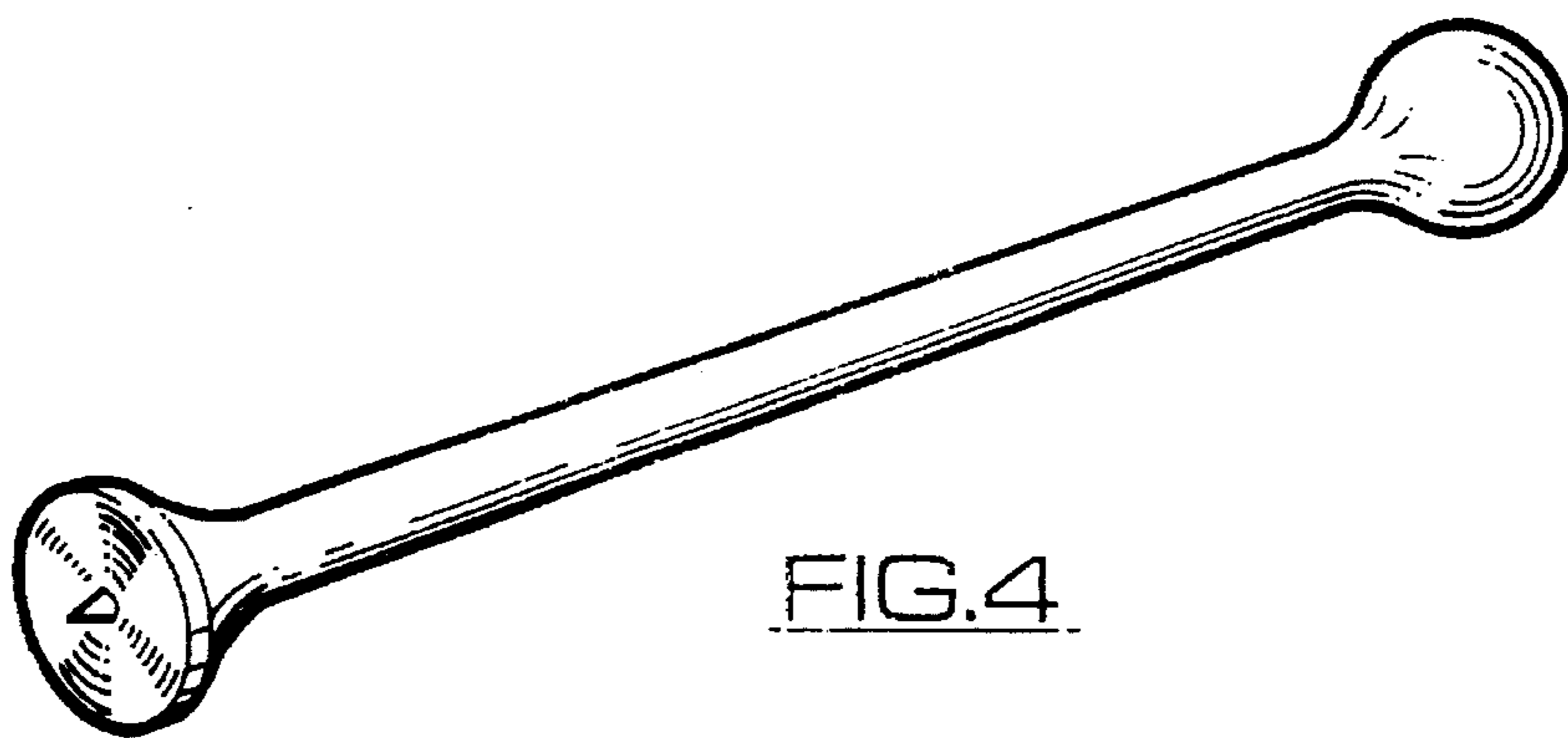

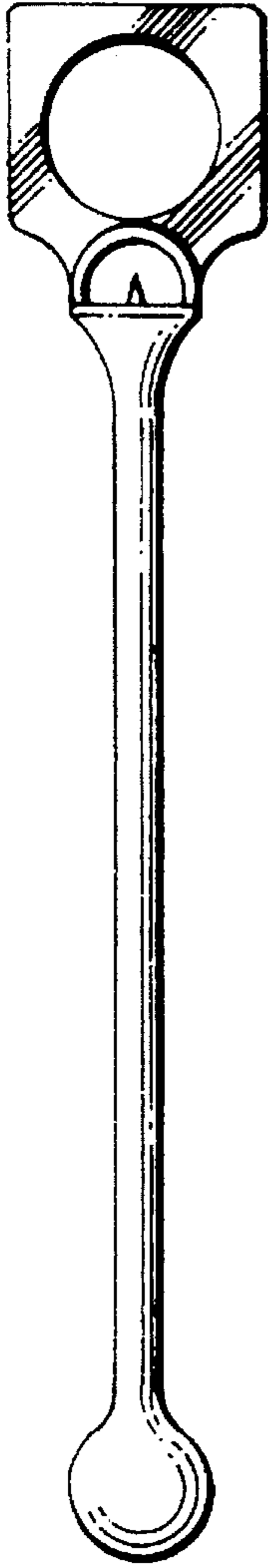

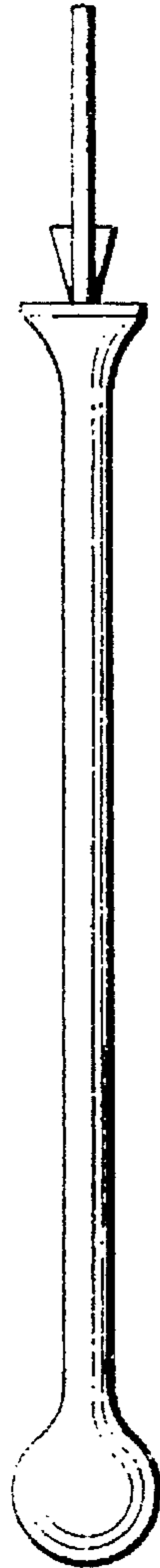

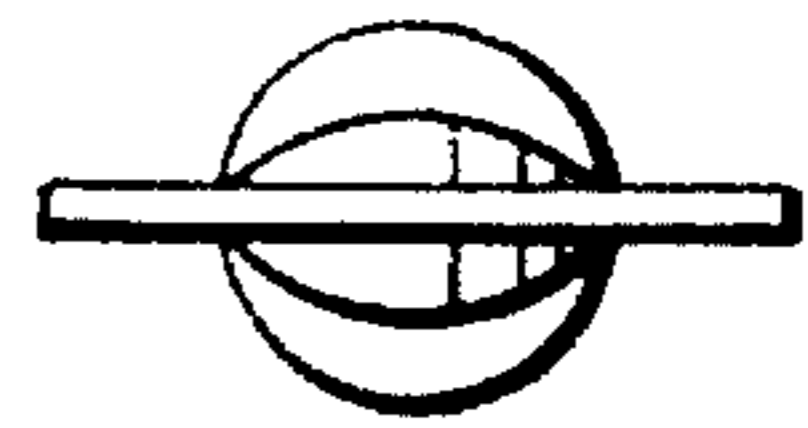

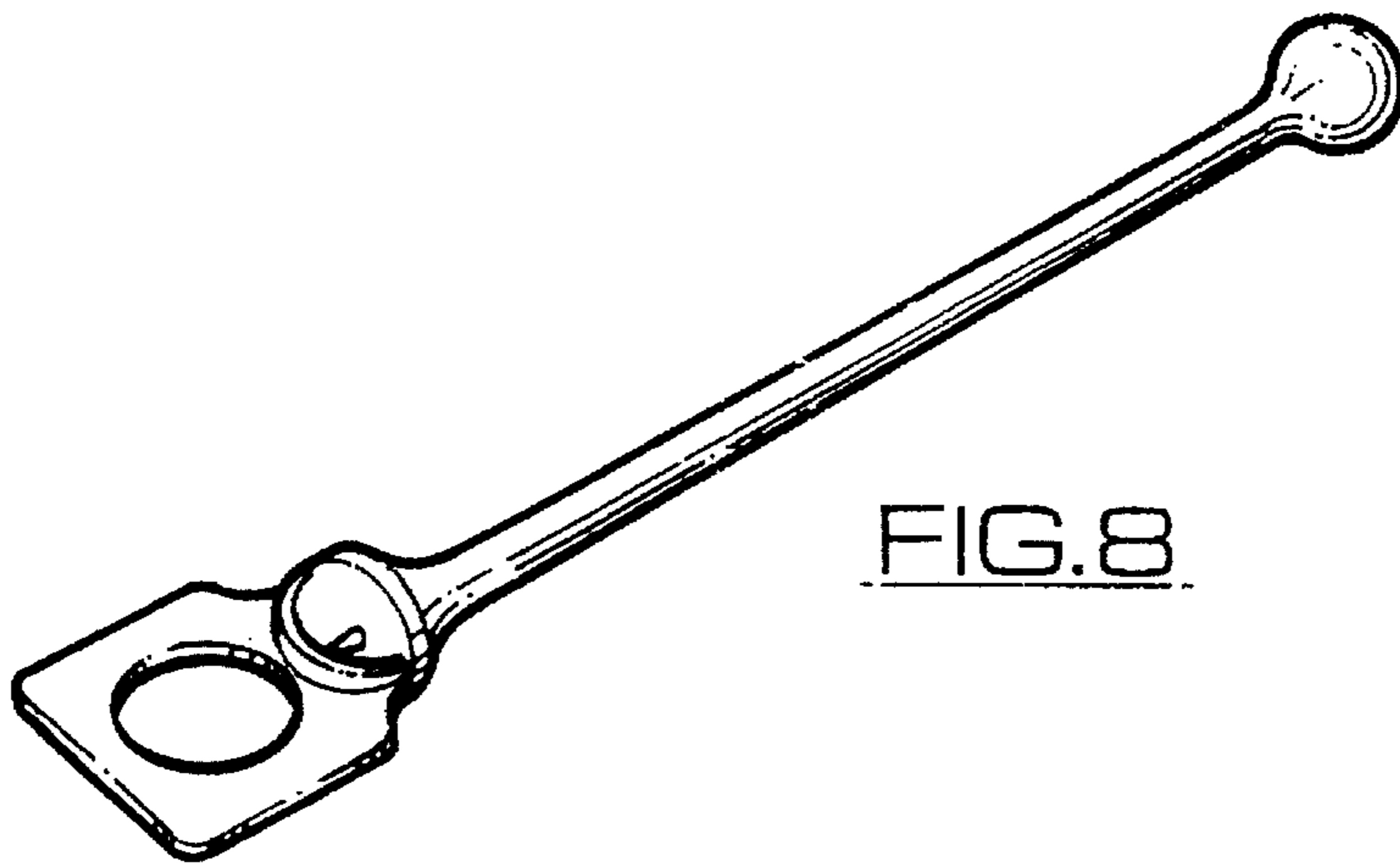
