[57] CLAIM

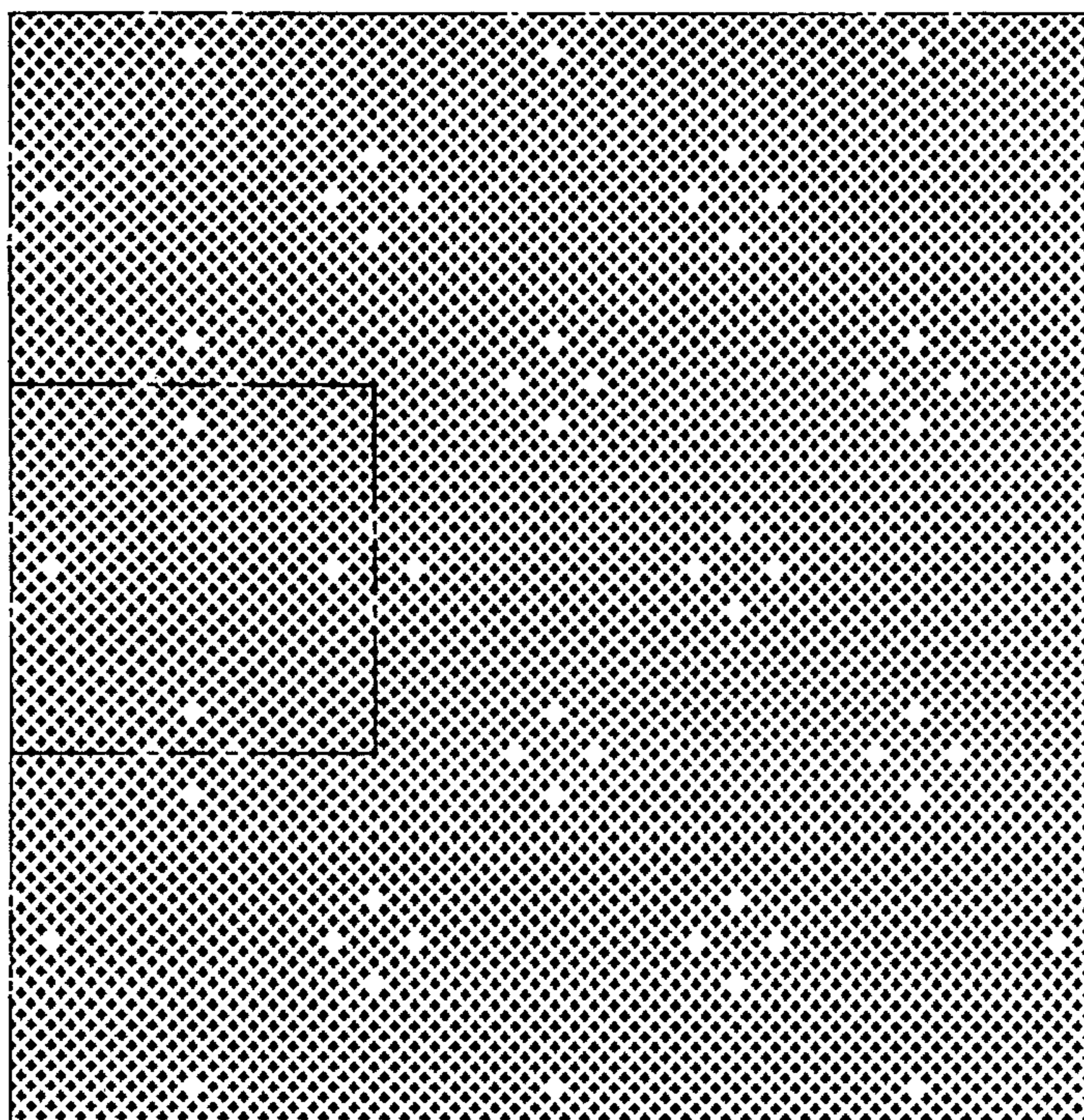
The ornamental design for a pattern bonded nonwoven fabric web, as shown and described.

DESCRIPTION

FIG. 1 is a plan view of a pattern bonded nonwoven fabric web showing our new design. The broken lines at the perimeter of the Figure denote the boundaries of the repeat unit of the claimed design; and,

FIG. 2 is an enlarged view of the portion FIG. 1 enclosed by the smaller broken line square within FIG. 1.

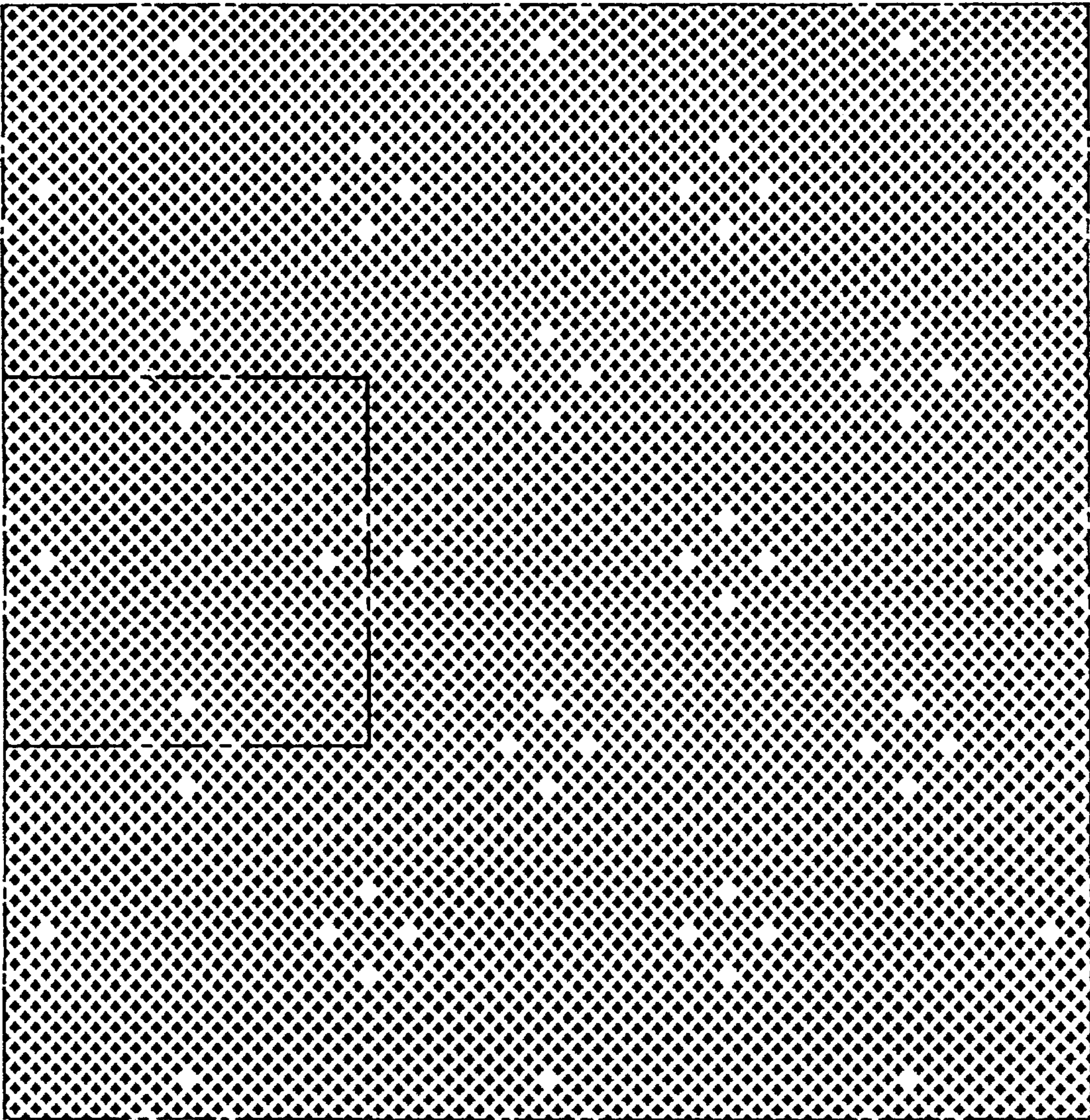

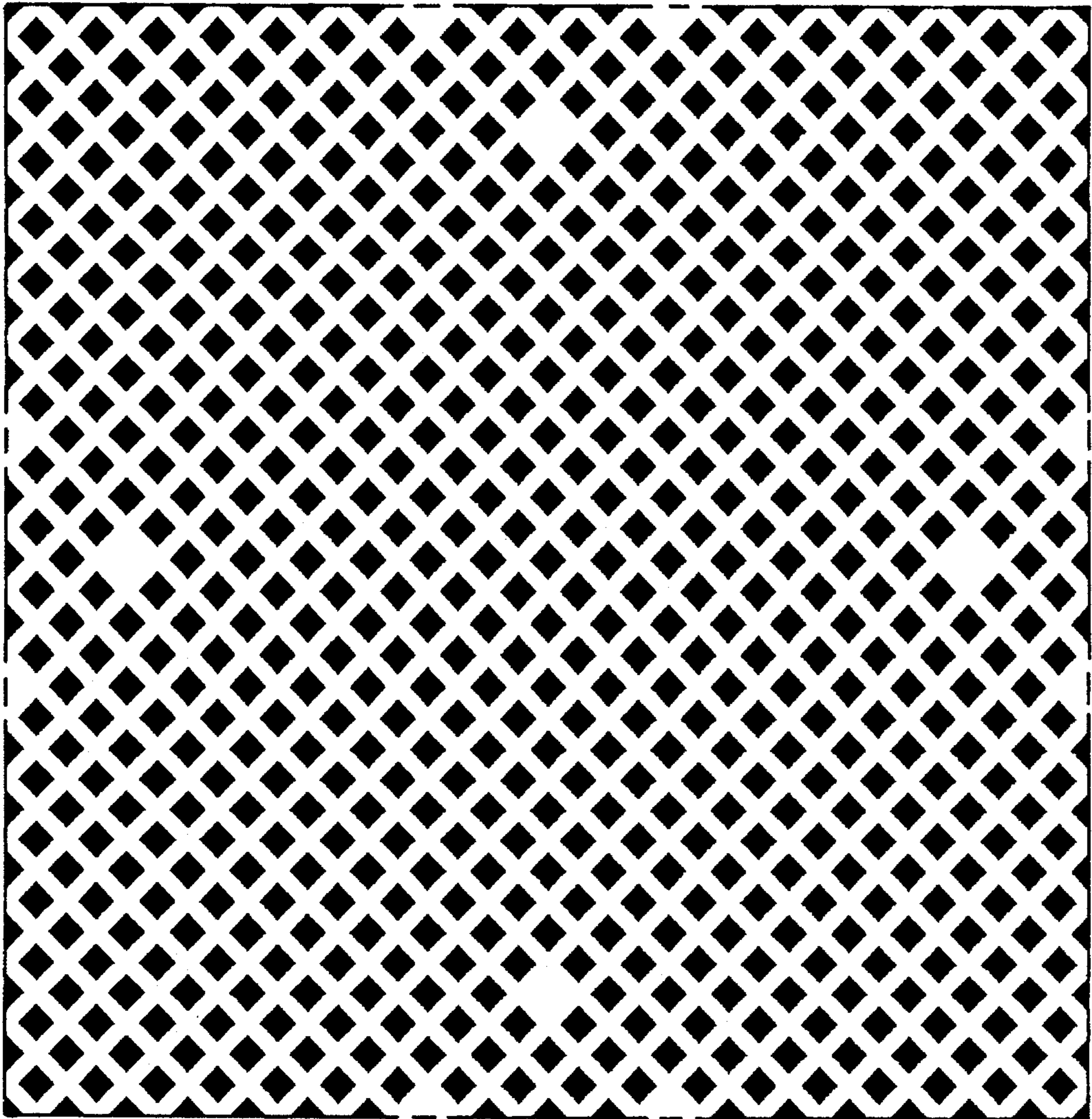
