FIG. 4 is a side elevational view of the opposite side thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.

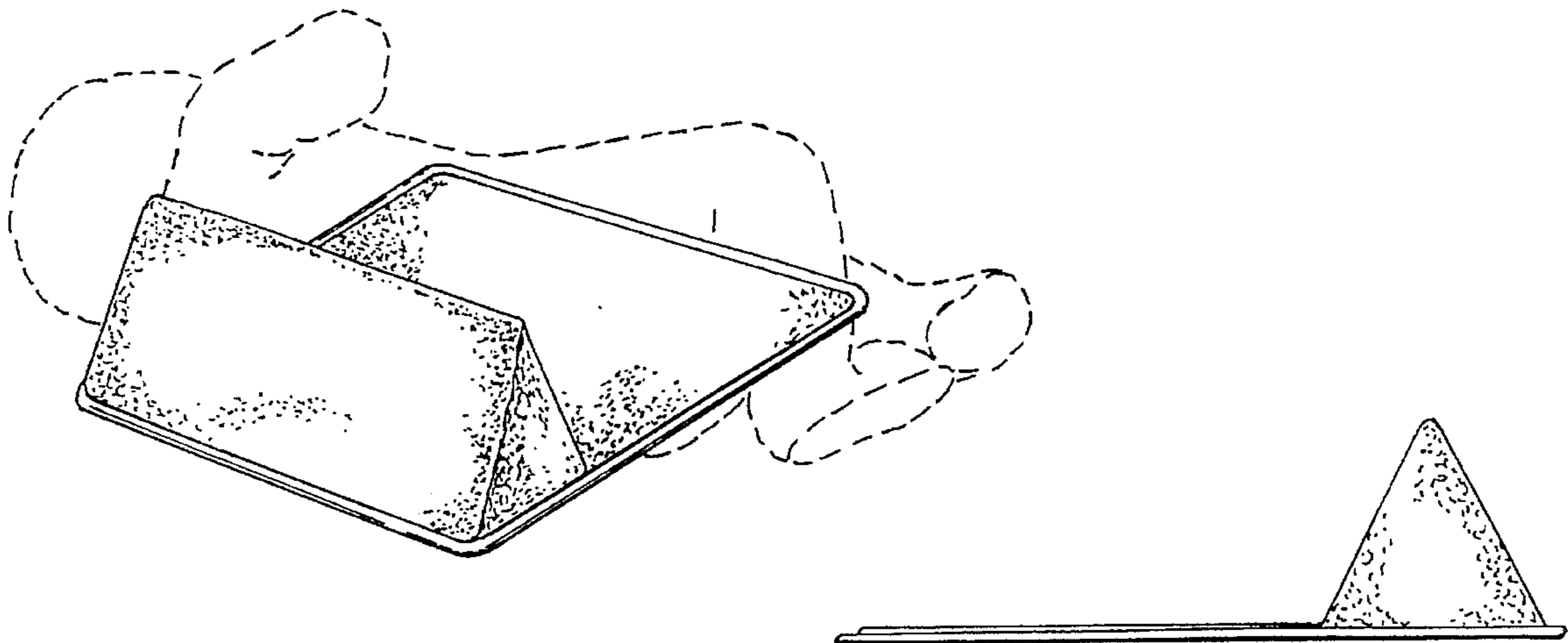

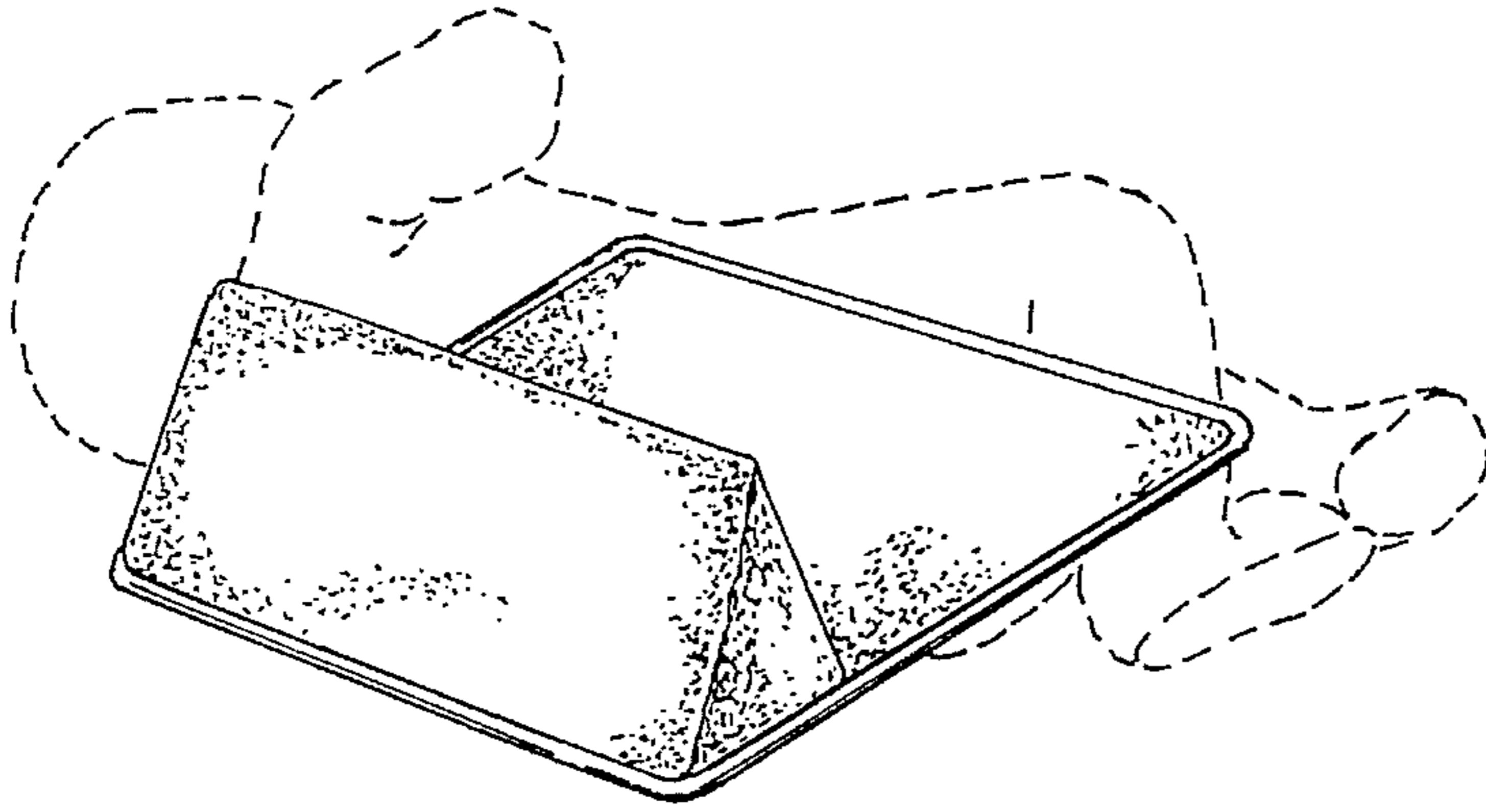

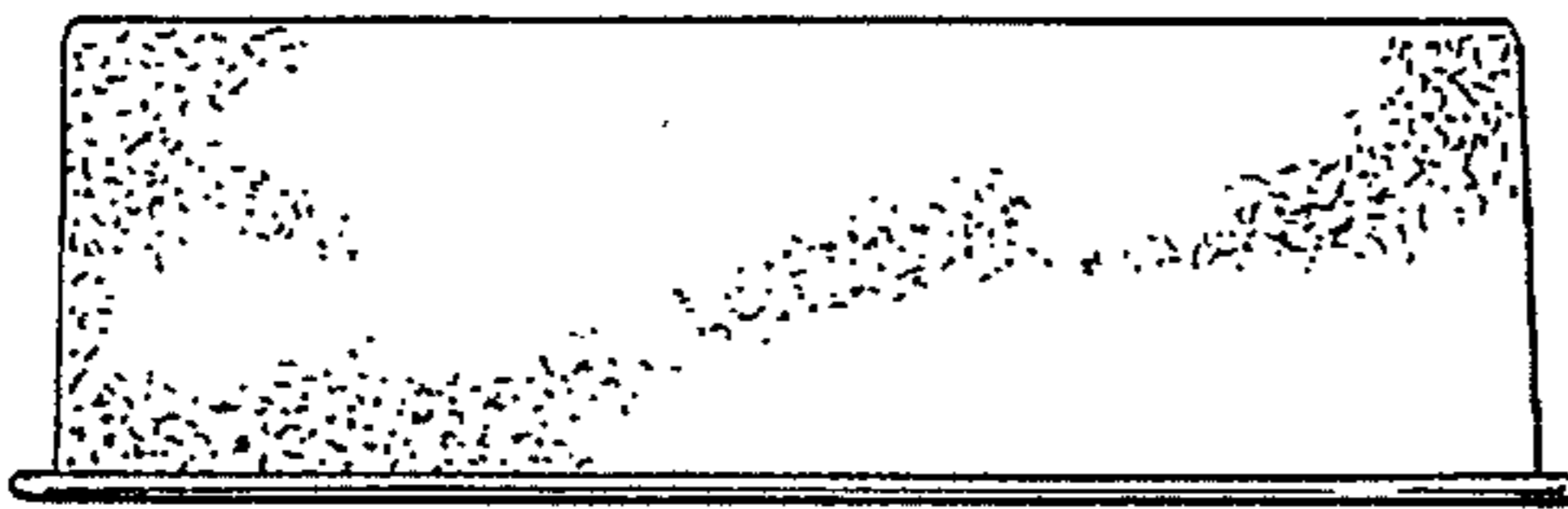

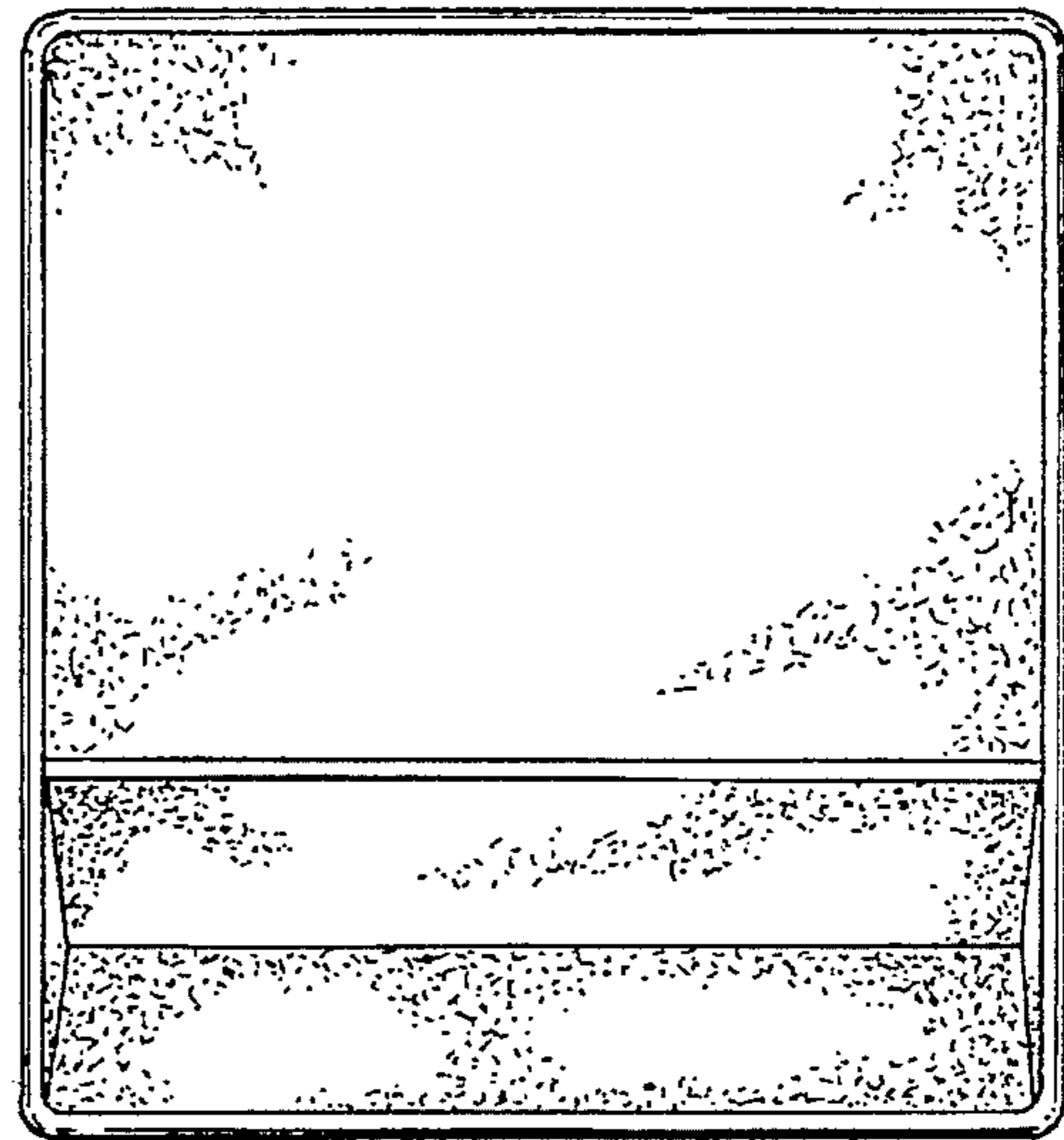

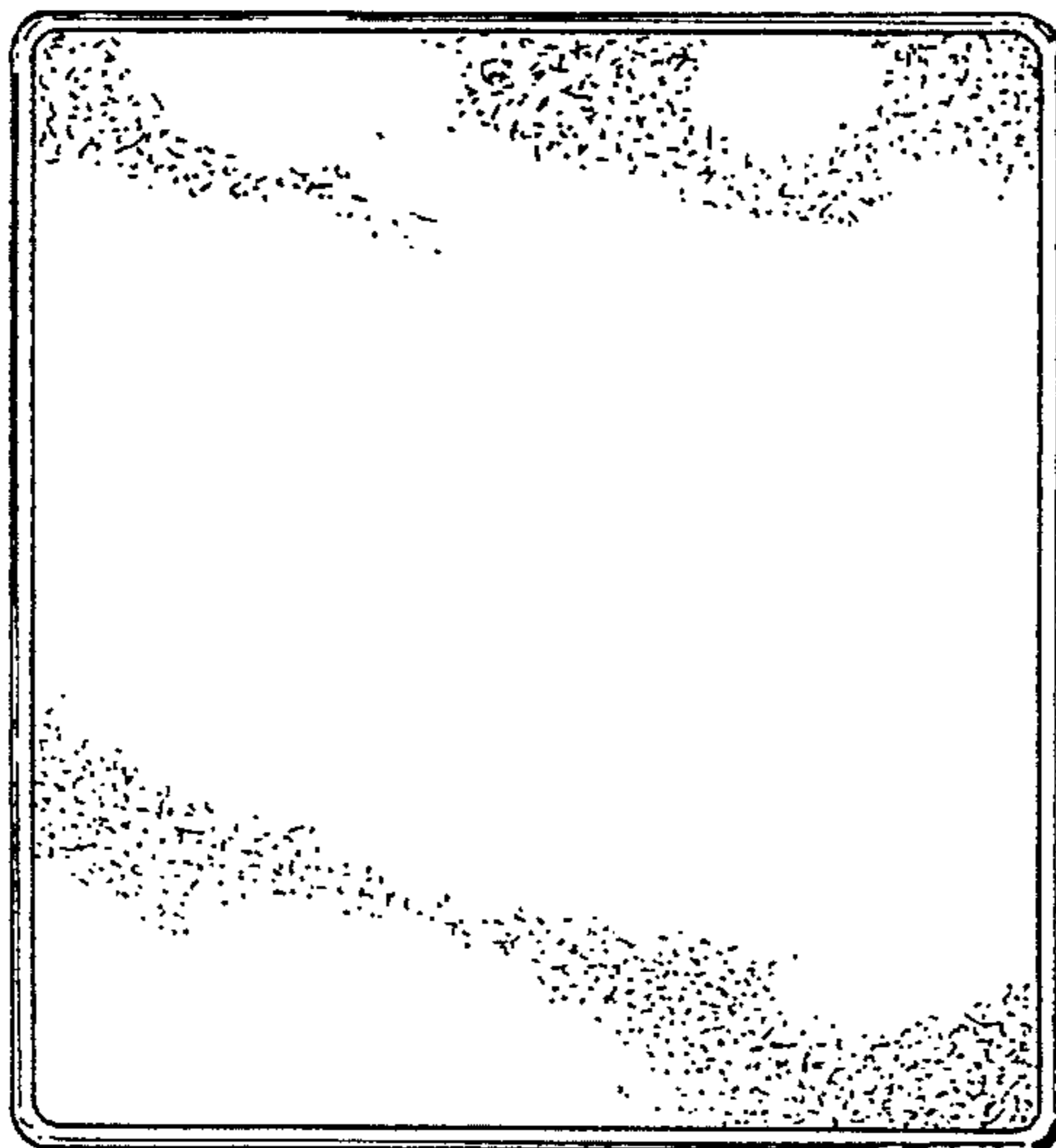
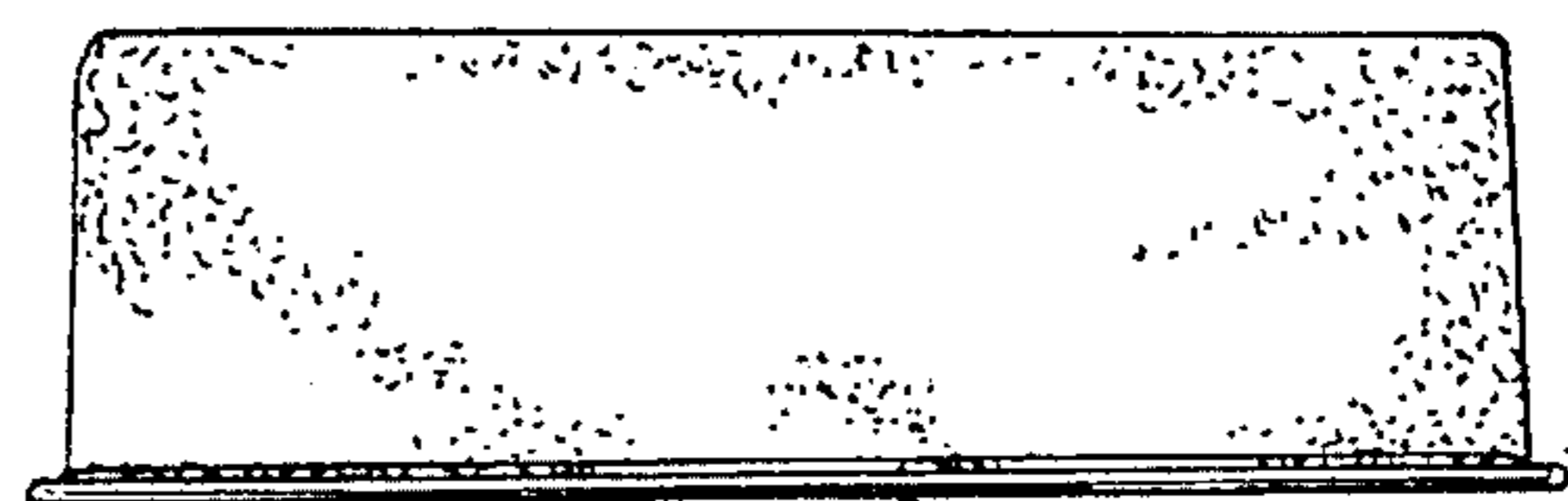
