### [57] CLAIM

The ornamental design for a quilted reflective automobile window shade, as shown and described.

### DESCRIPTION

FIG. 1 is a front elevational view of a quilted reflective automobile window shade showing my new design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; and, FIG. 5 is a side elevational view thereof.

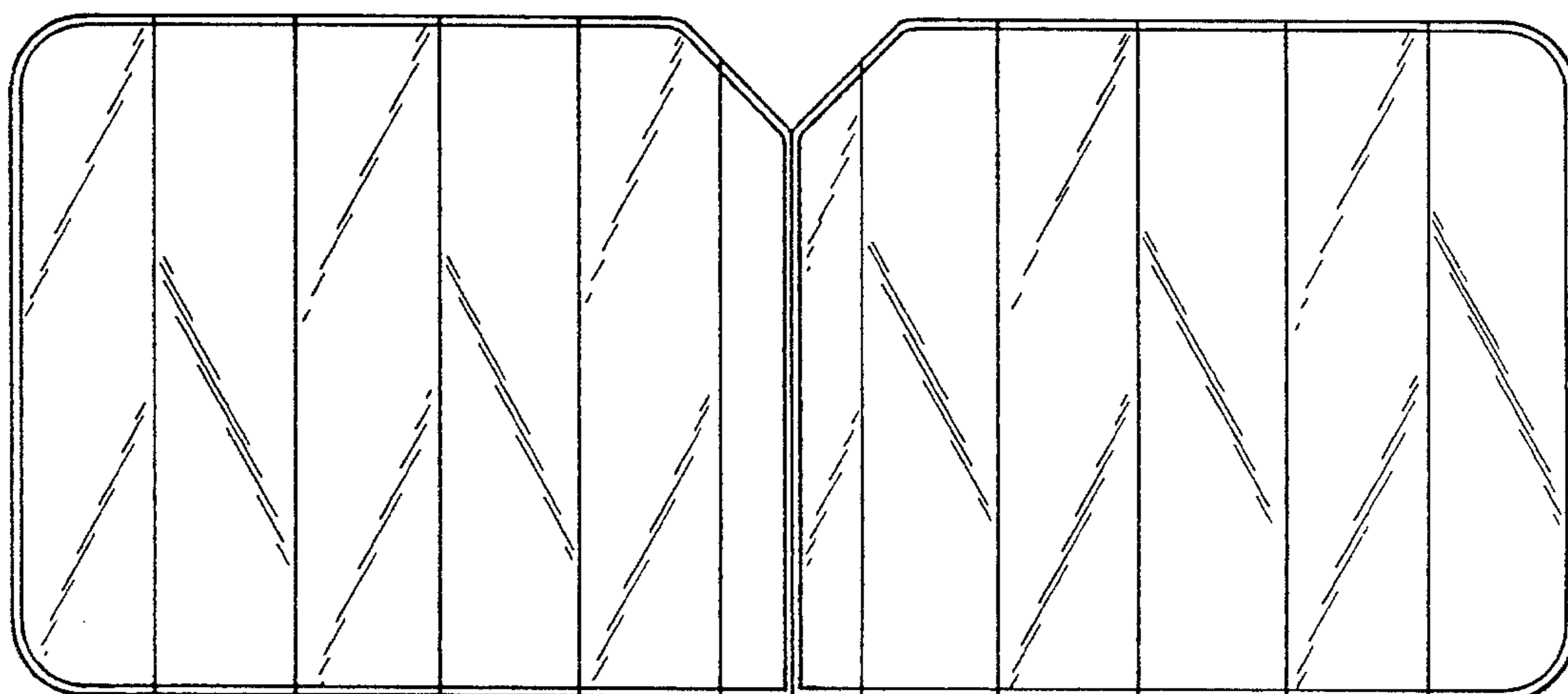

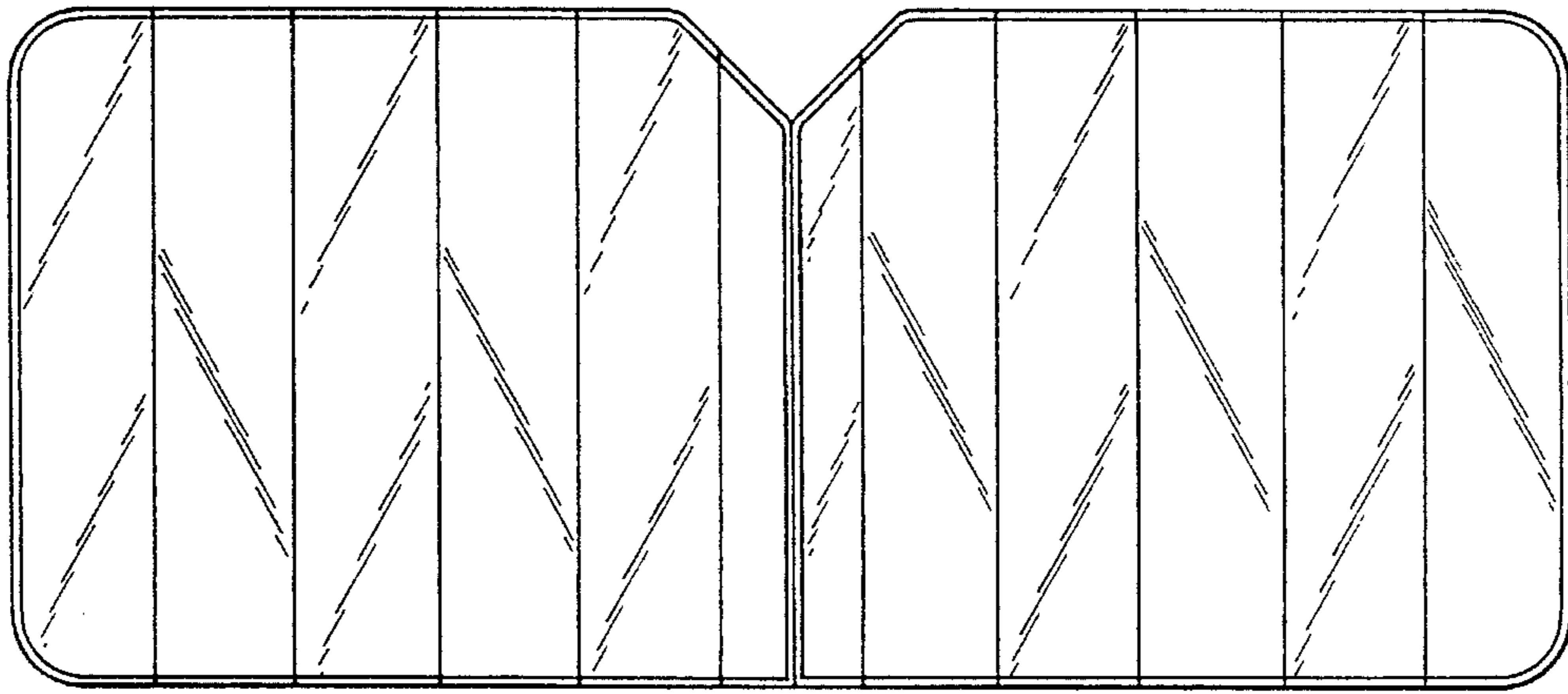

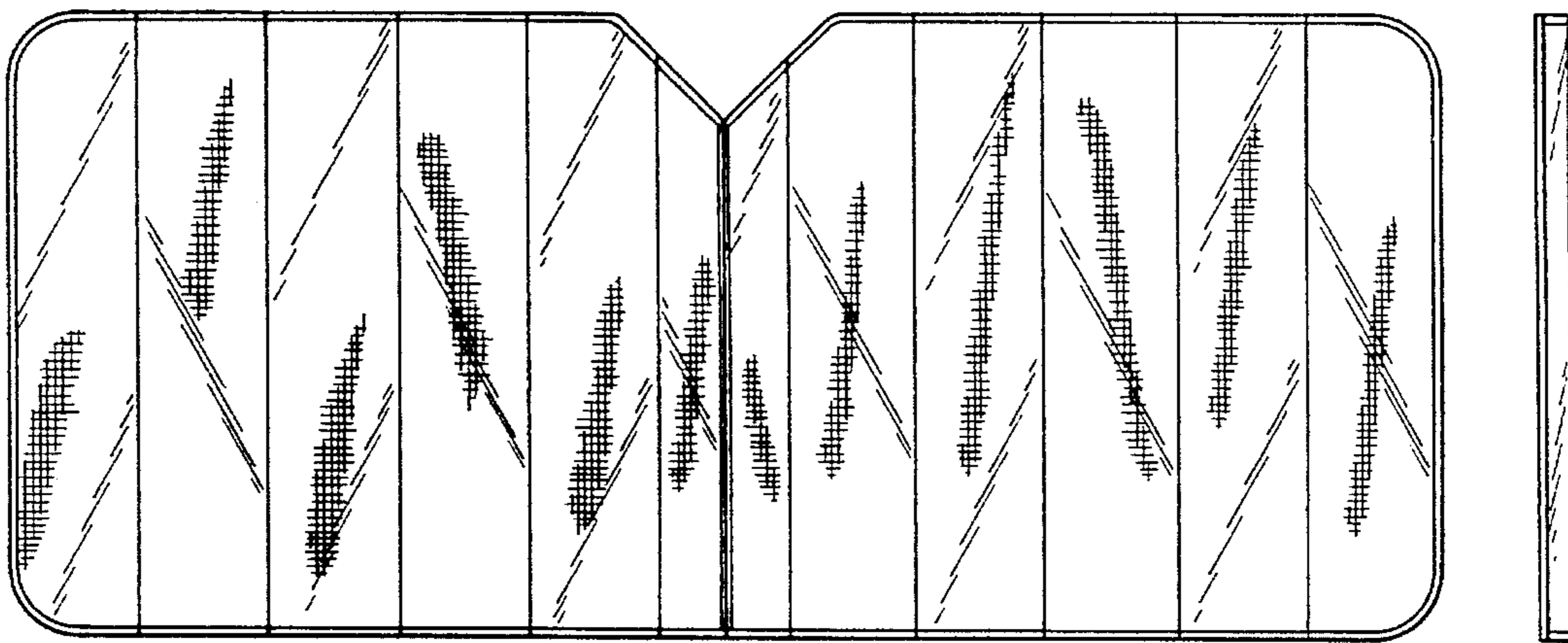
