[57] **CLAIM**

The ornamental design for a pet carrier bag, as shown and described.

DESCRIPTION

FIG. 1 is an environmental, perspective view of a pet carrier bag showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a left side elevational view with the right side being a mirror image thereof;

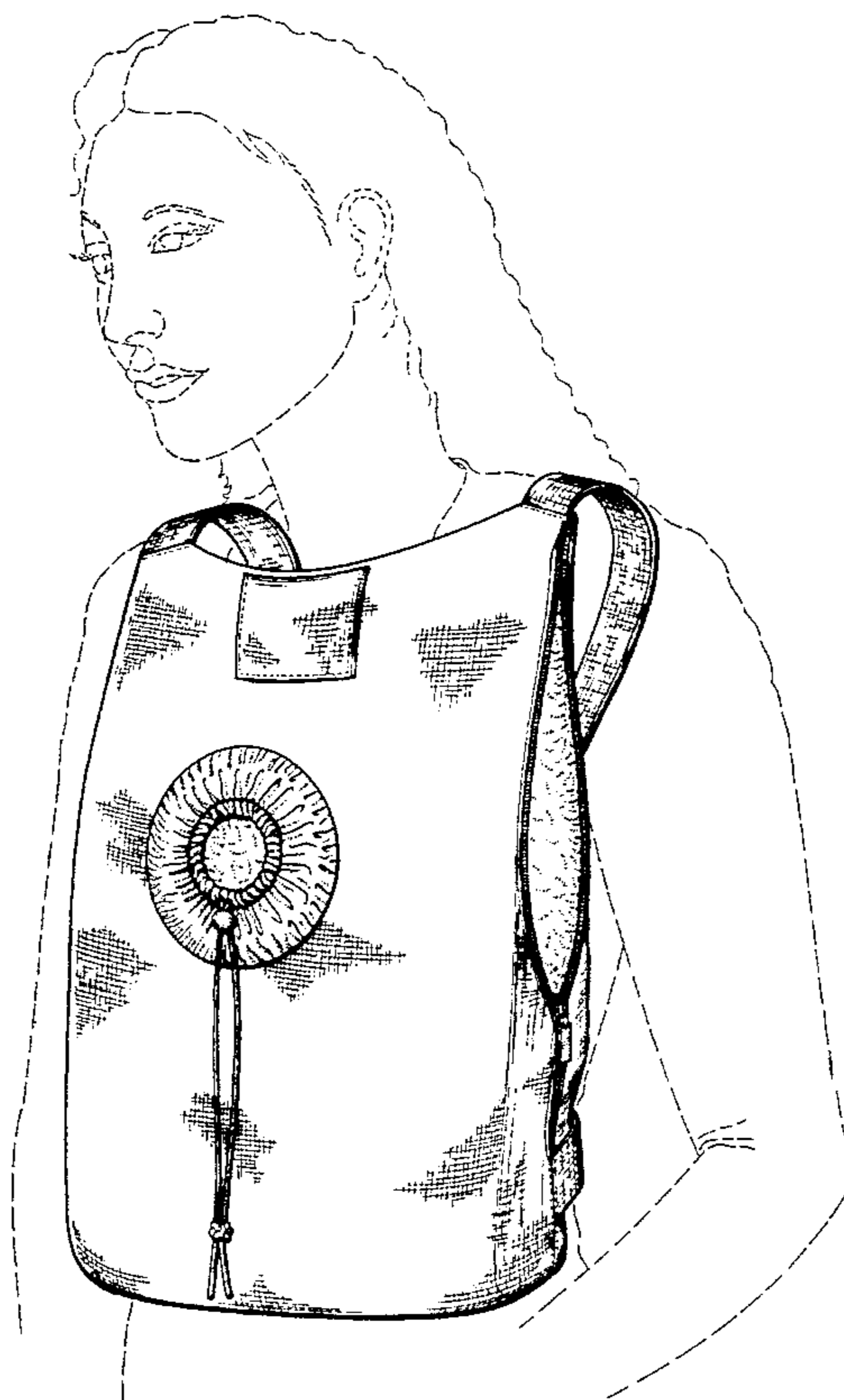
FIG. 4 is a top view thereof;

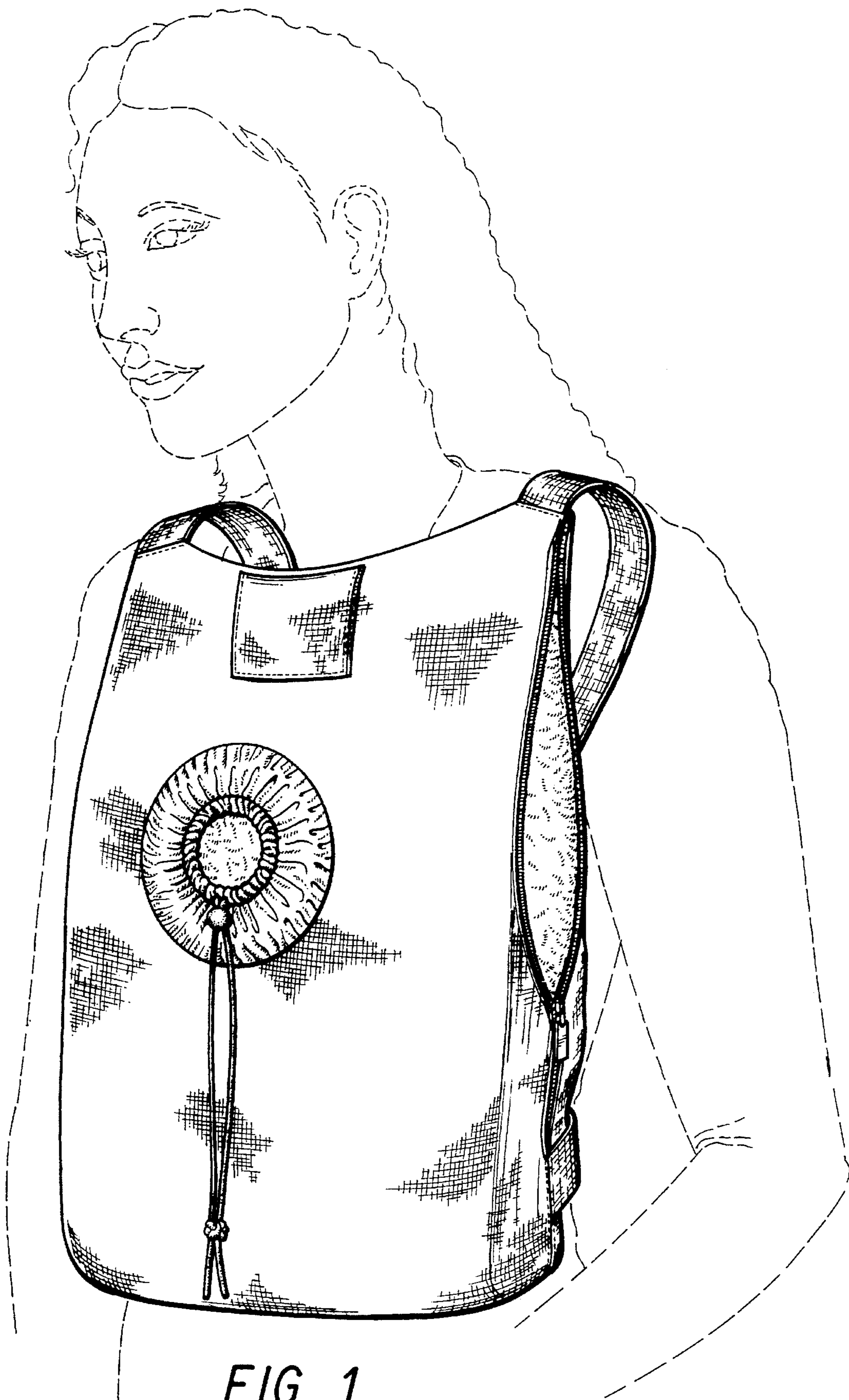

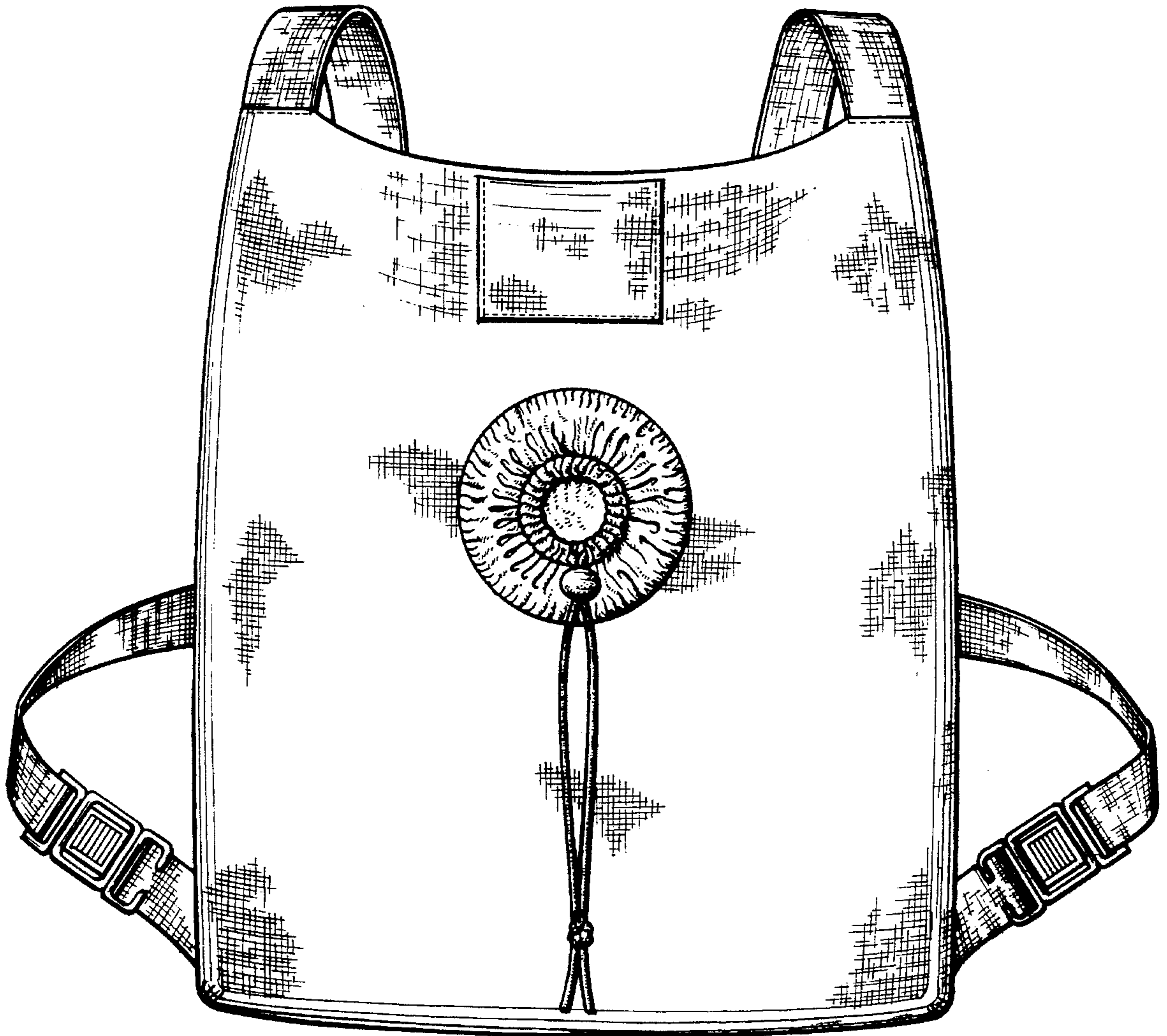

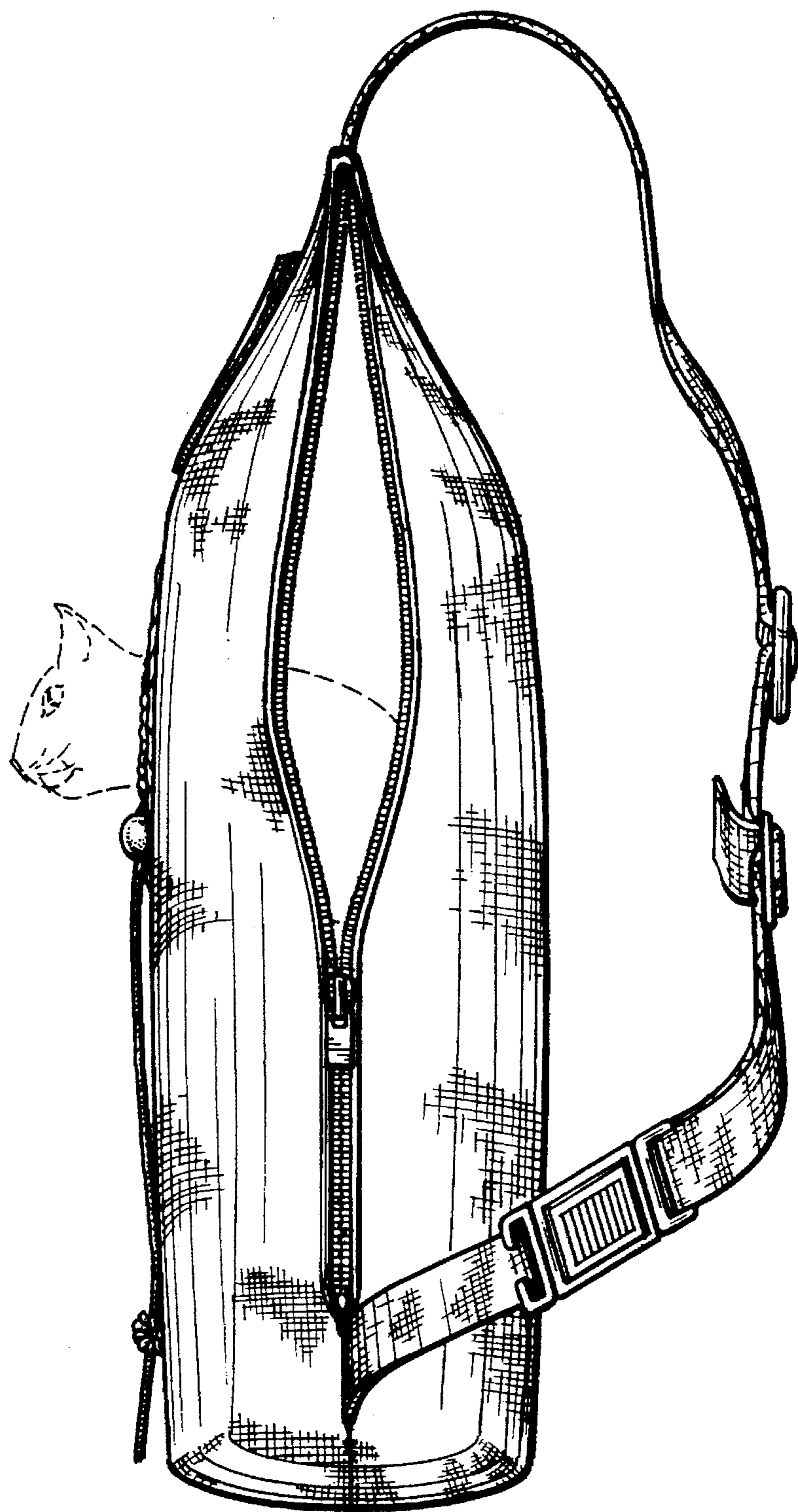

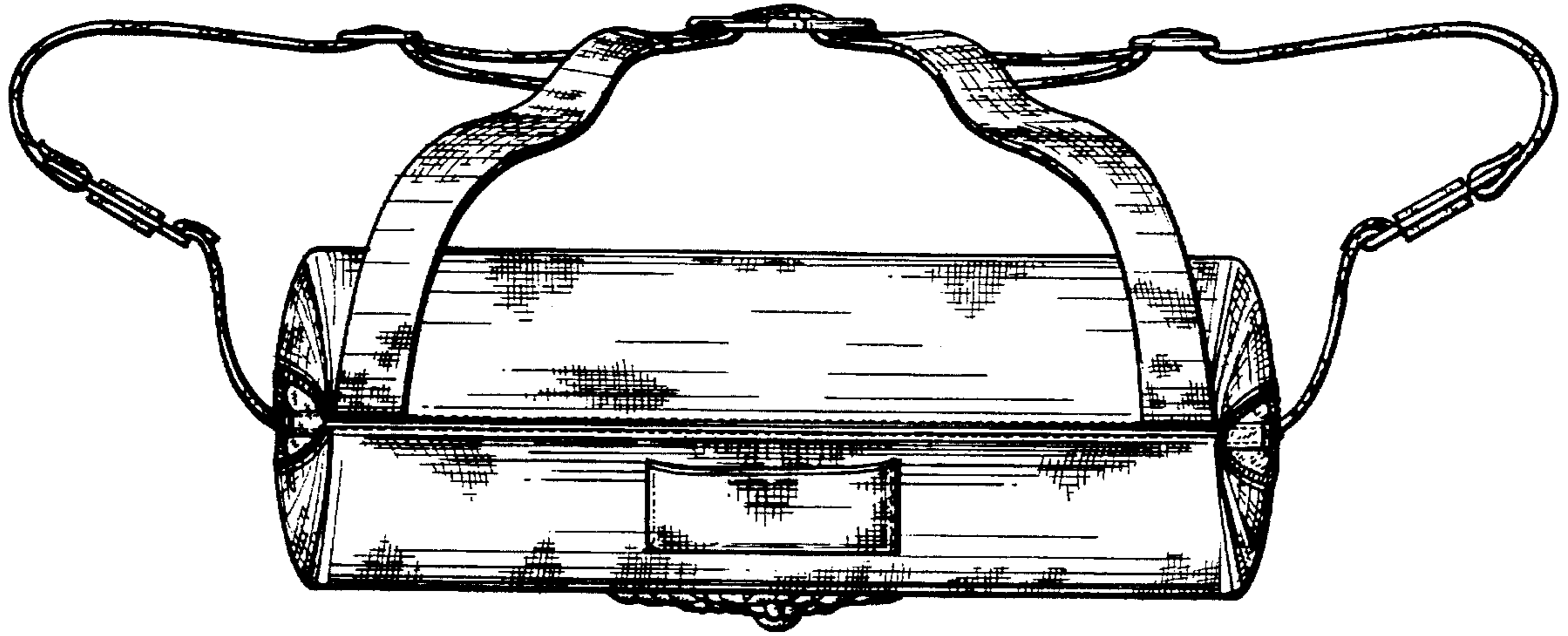

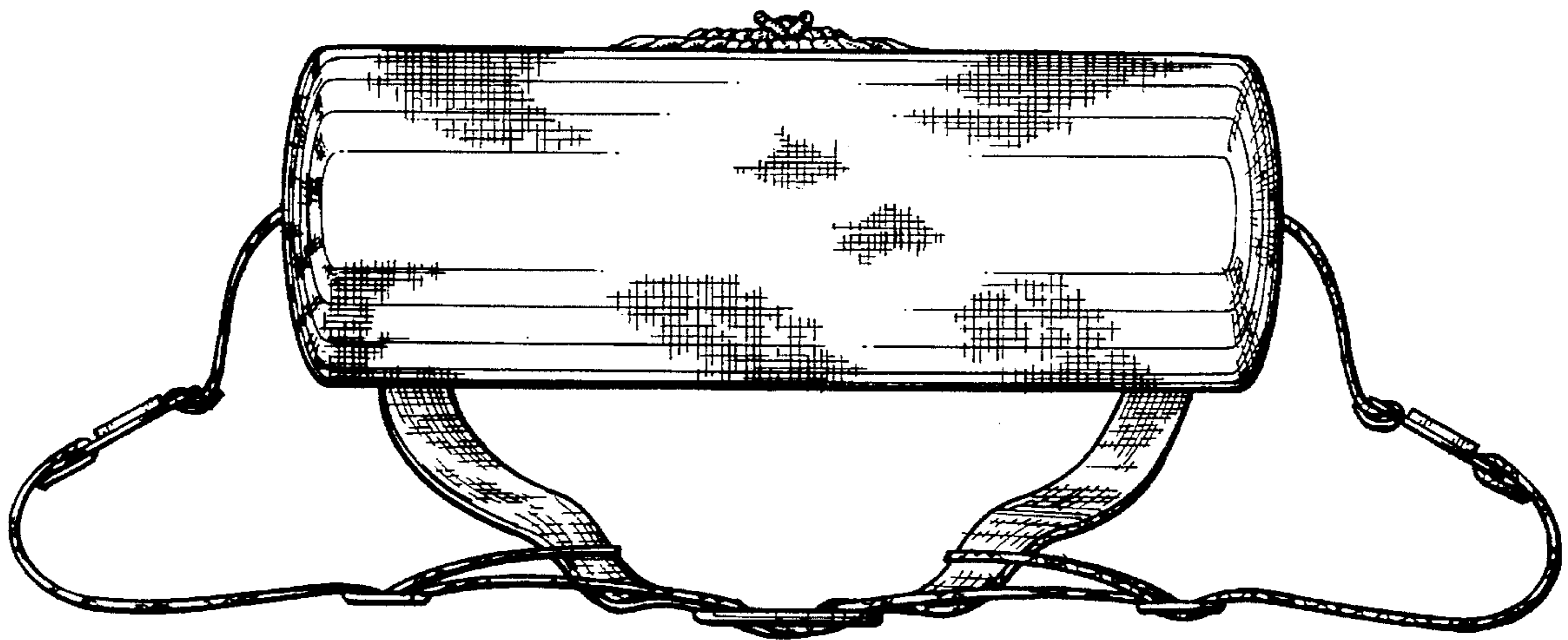

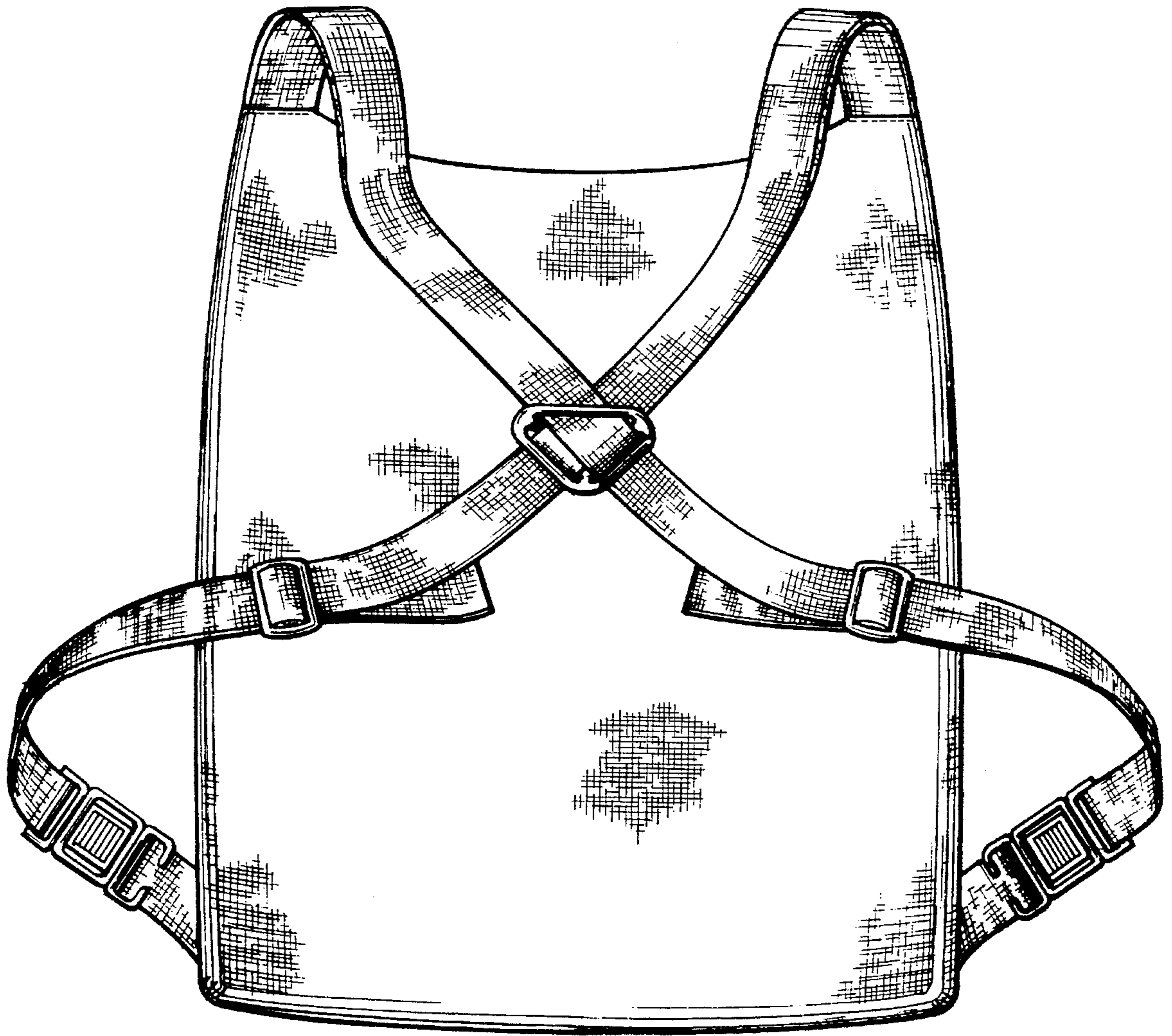
