DESCRIPTION

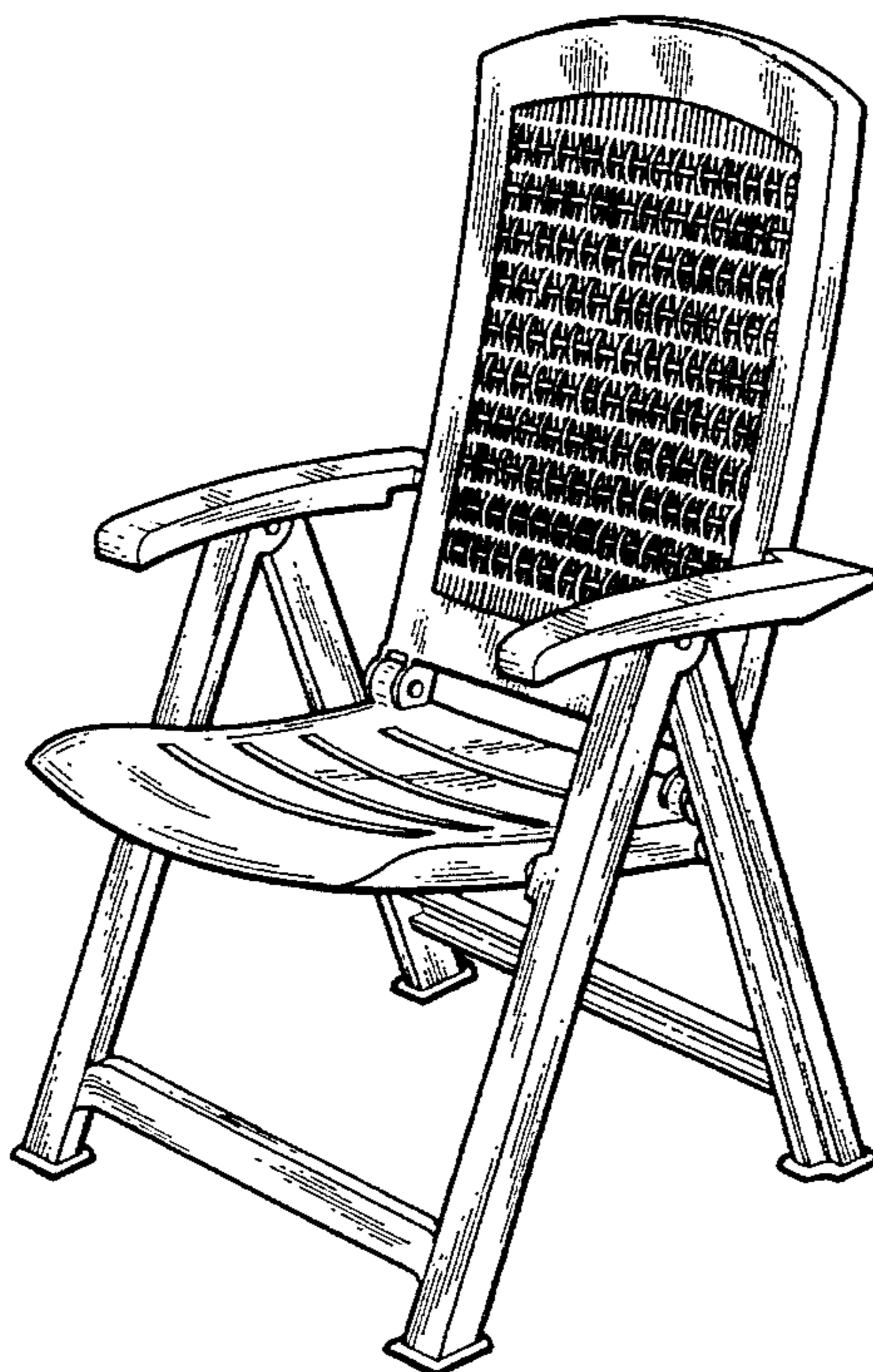

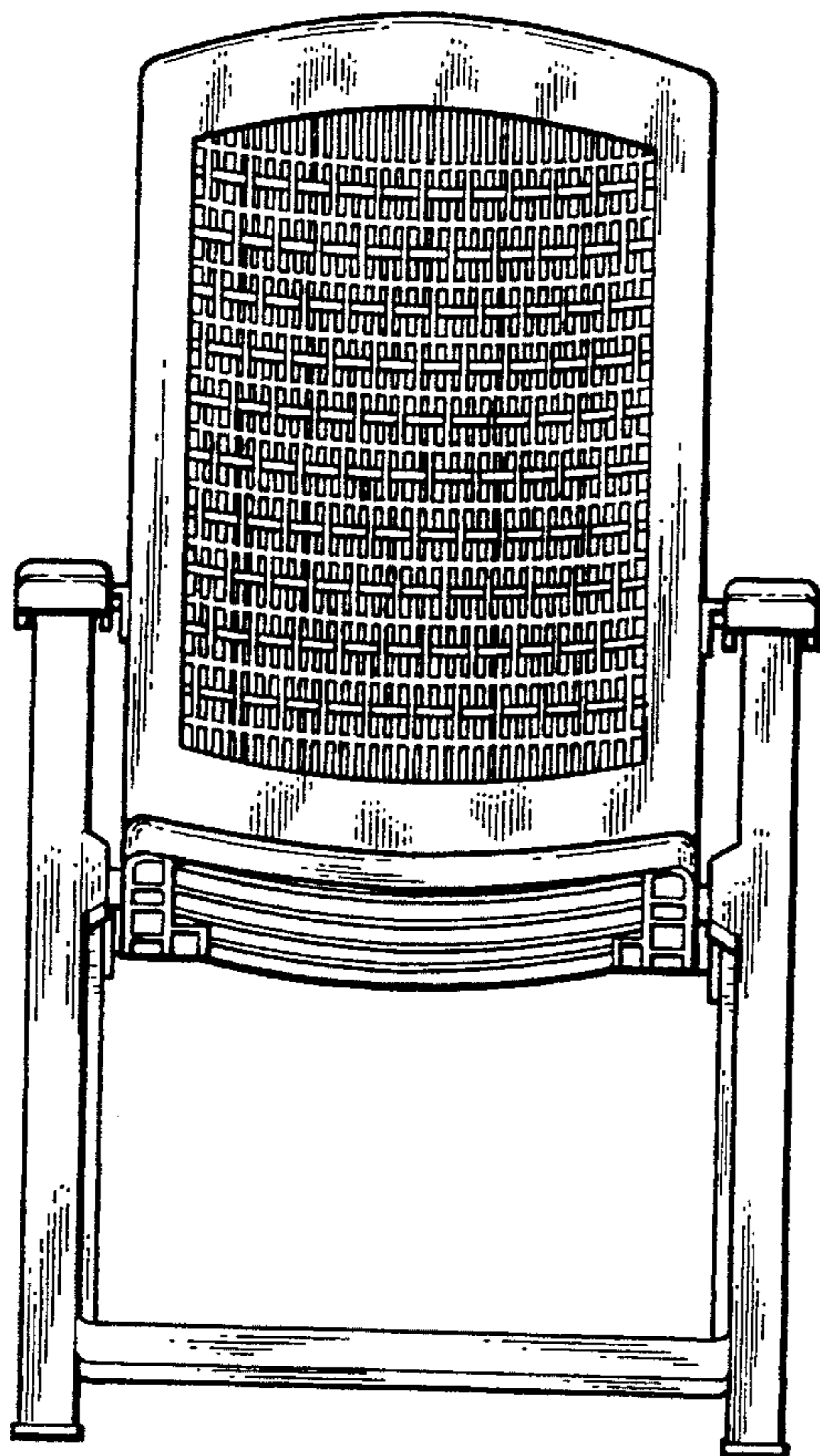
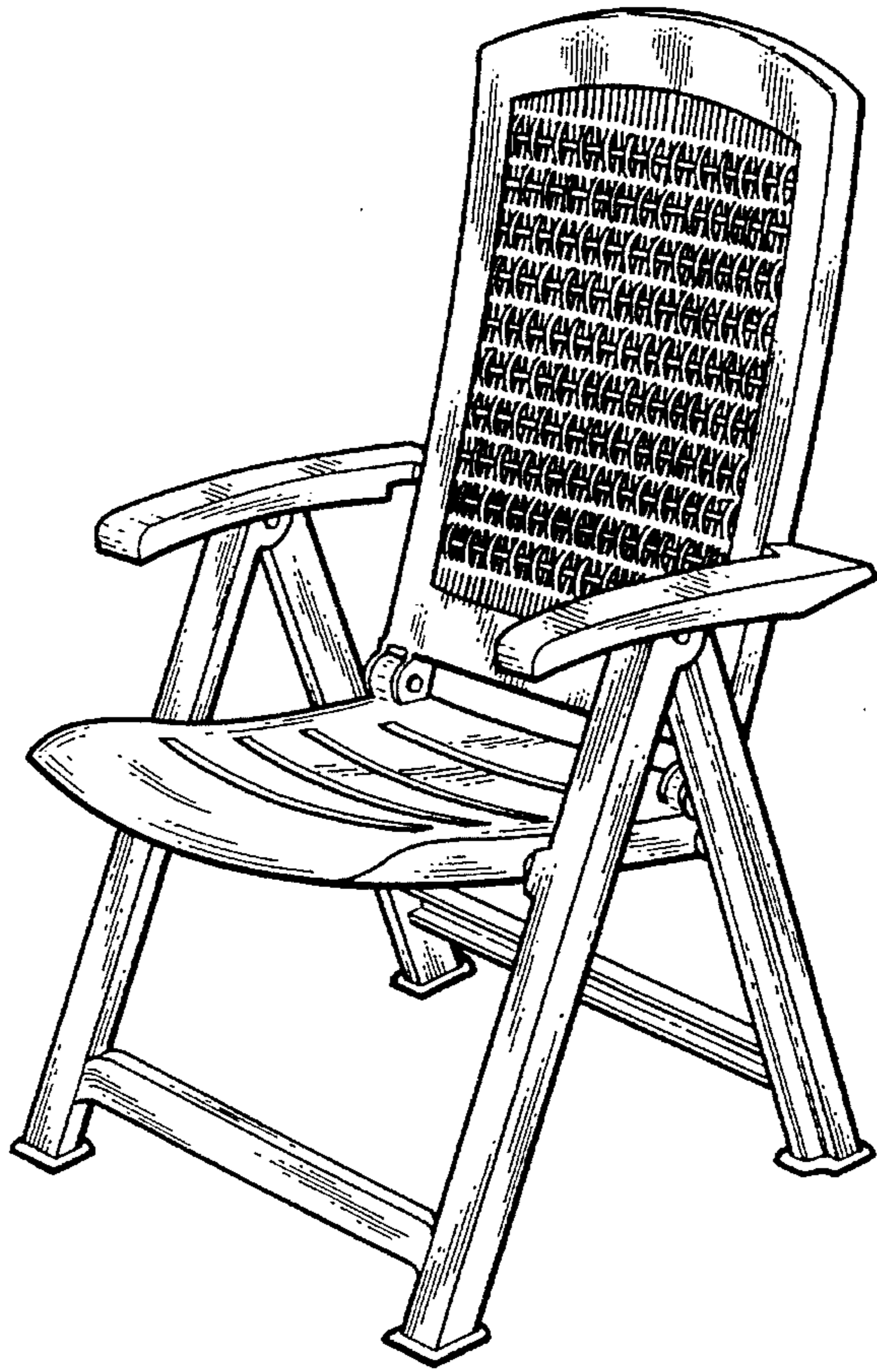

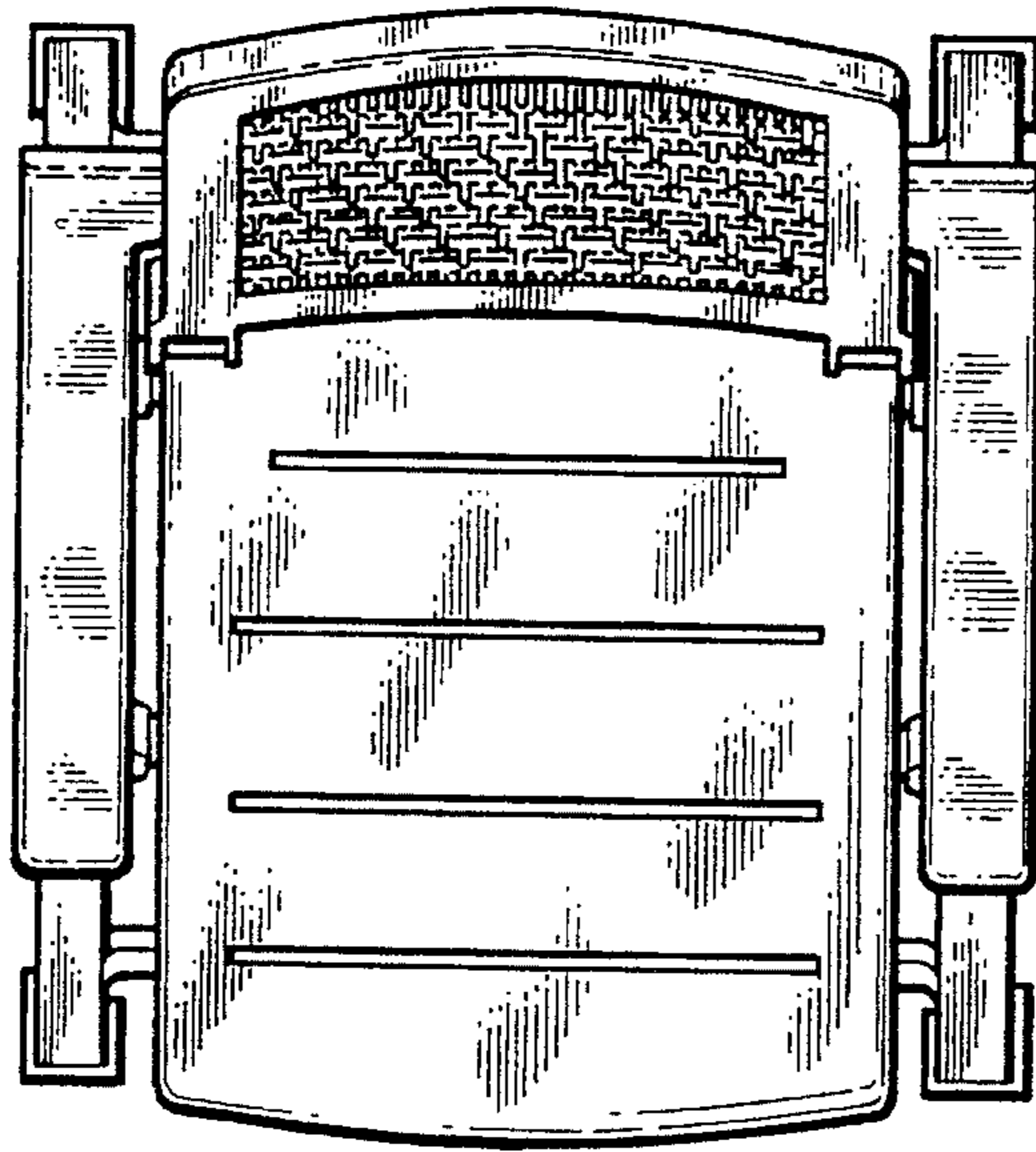

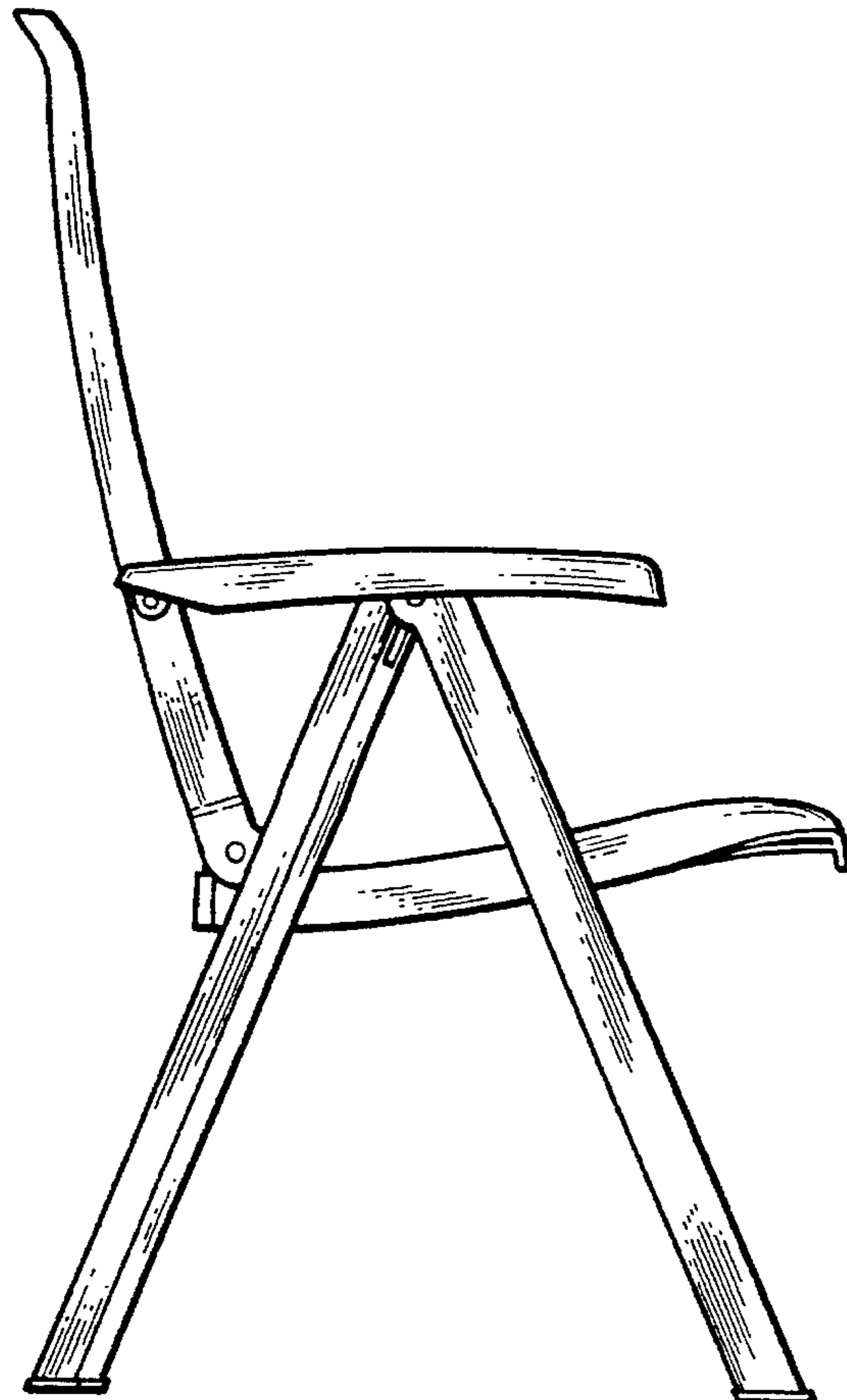

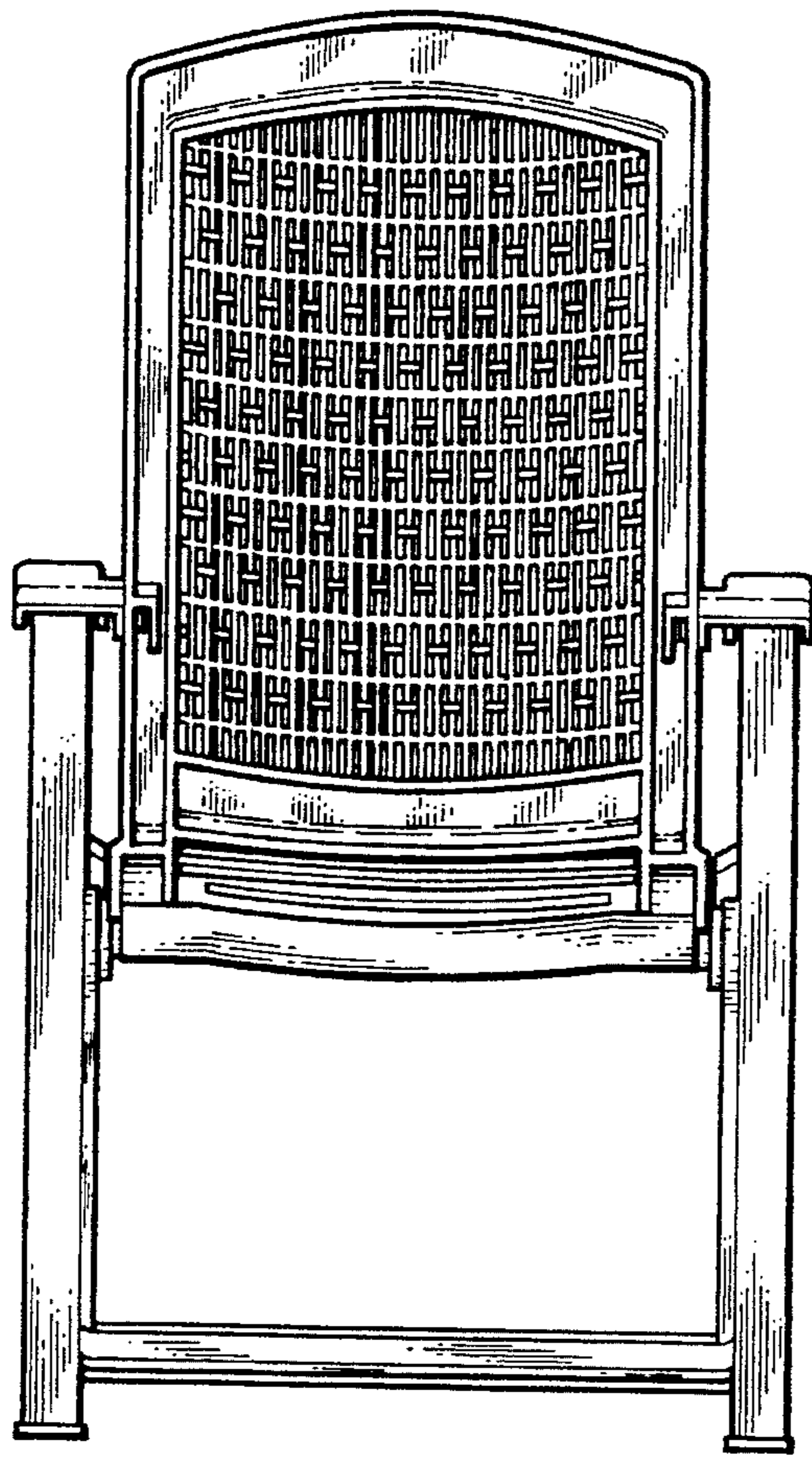

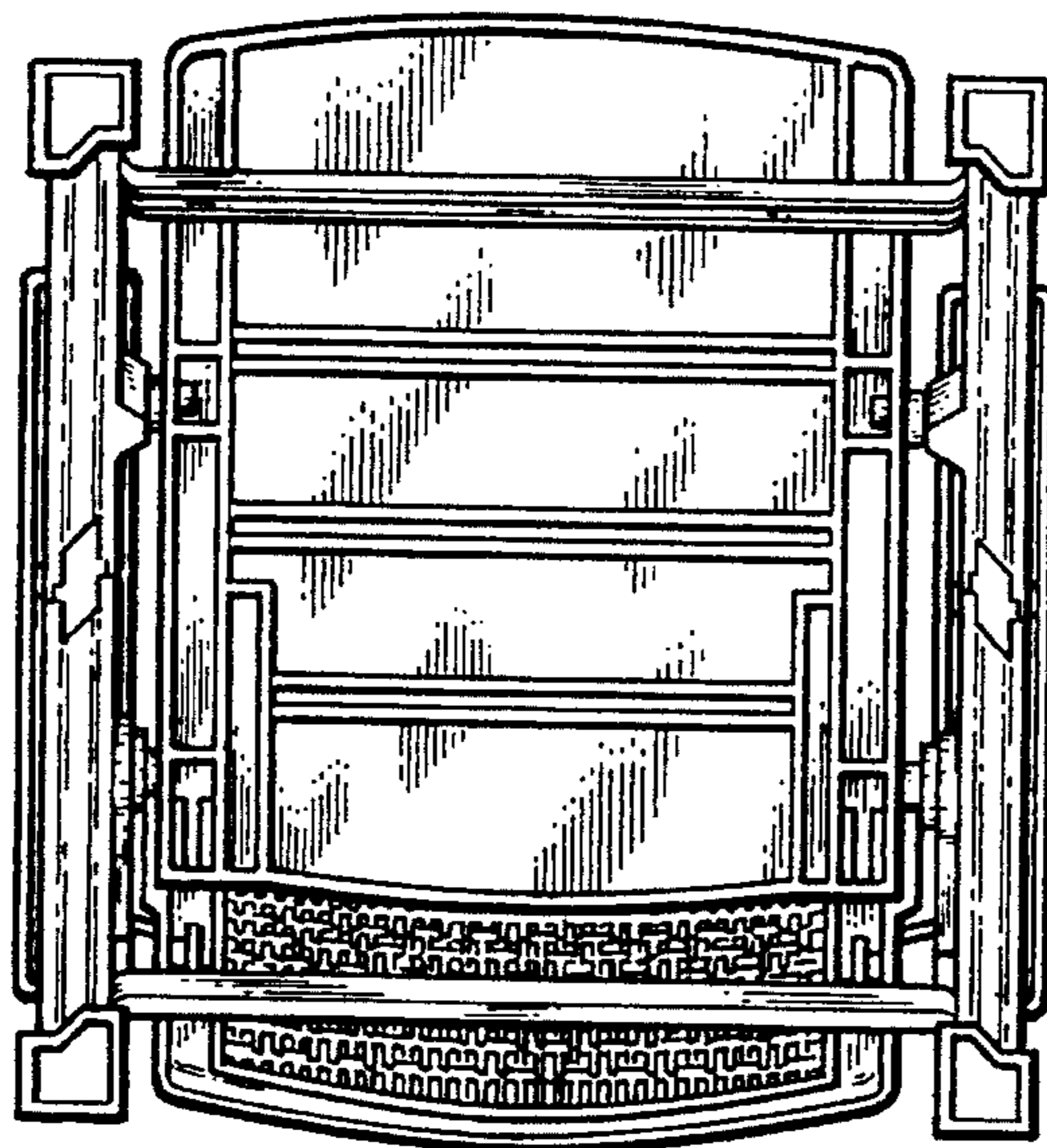

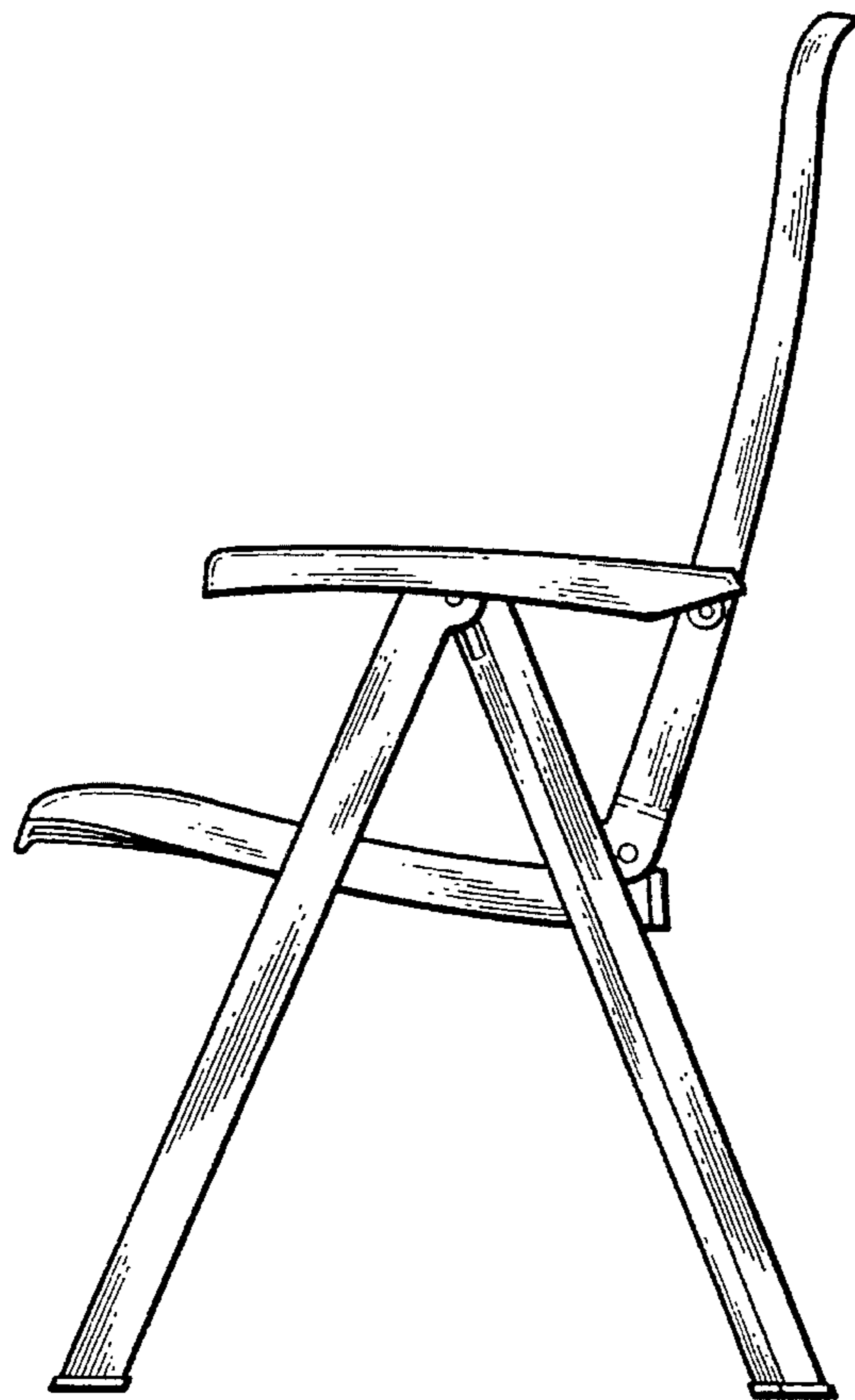

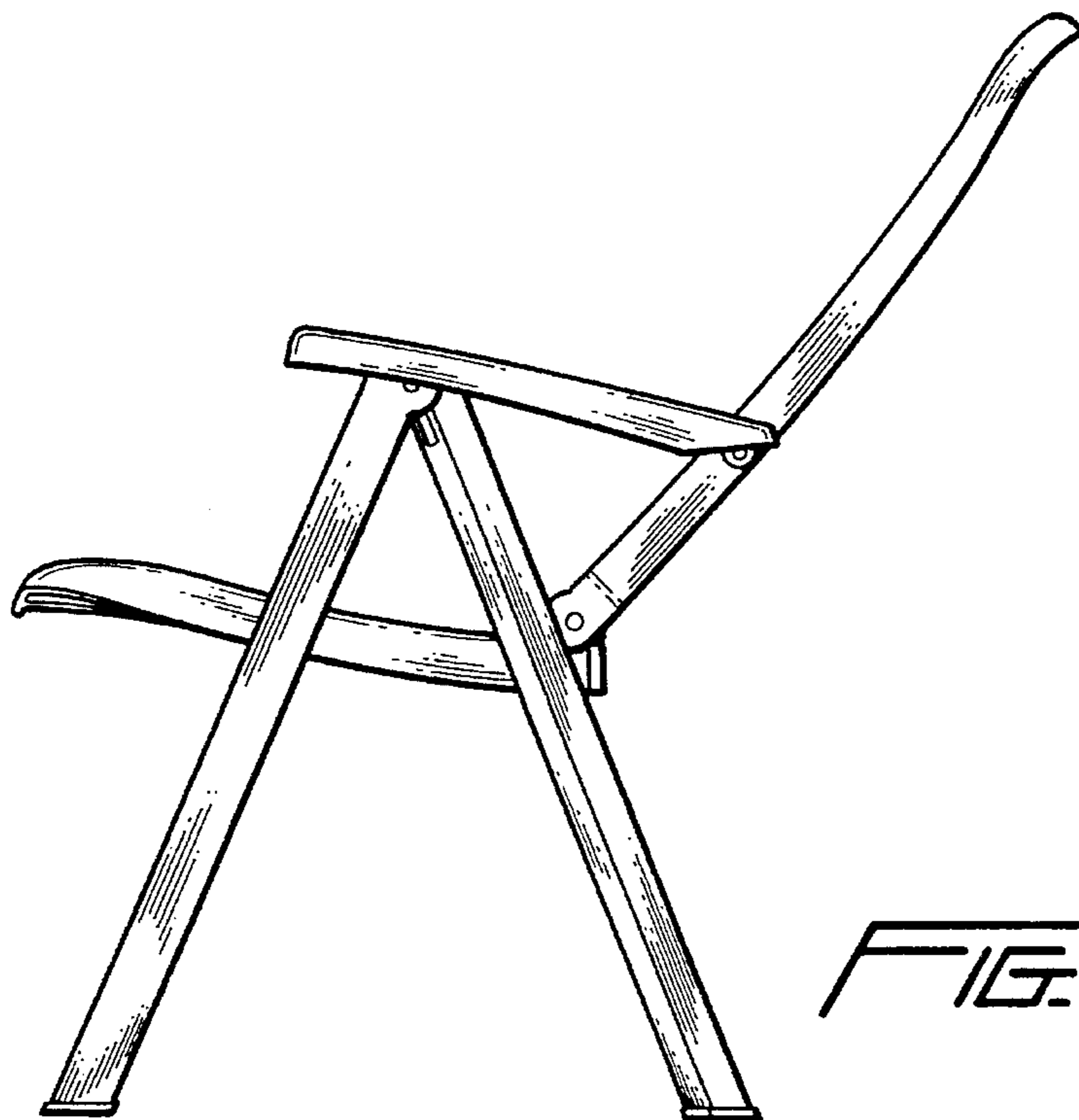
