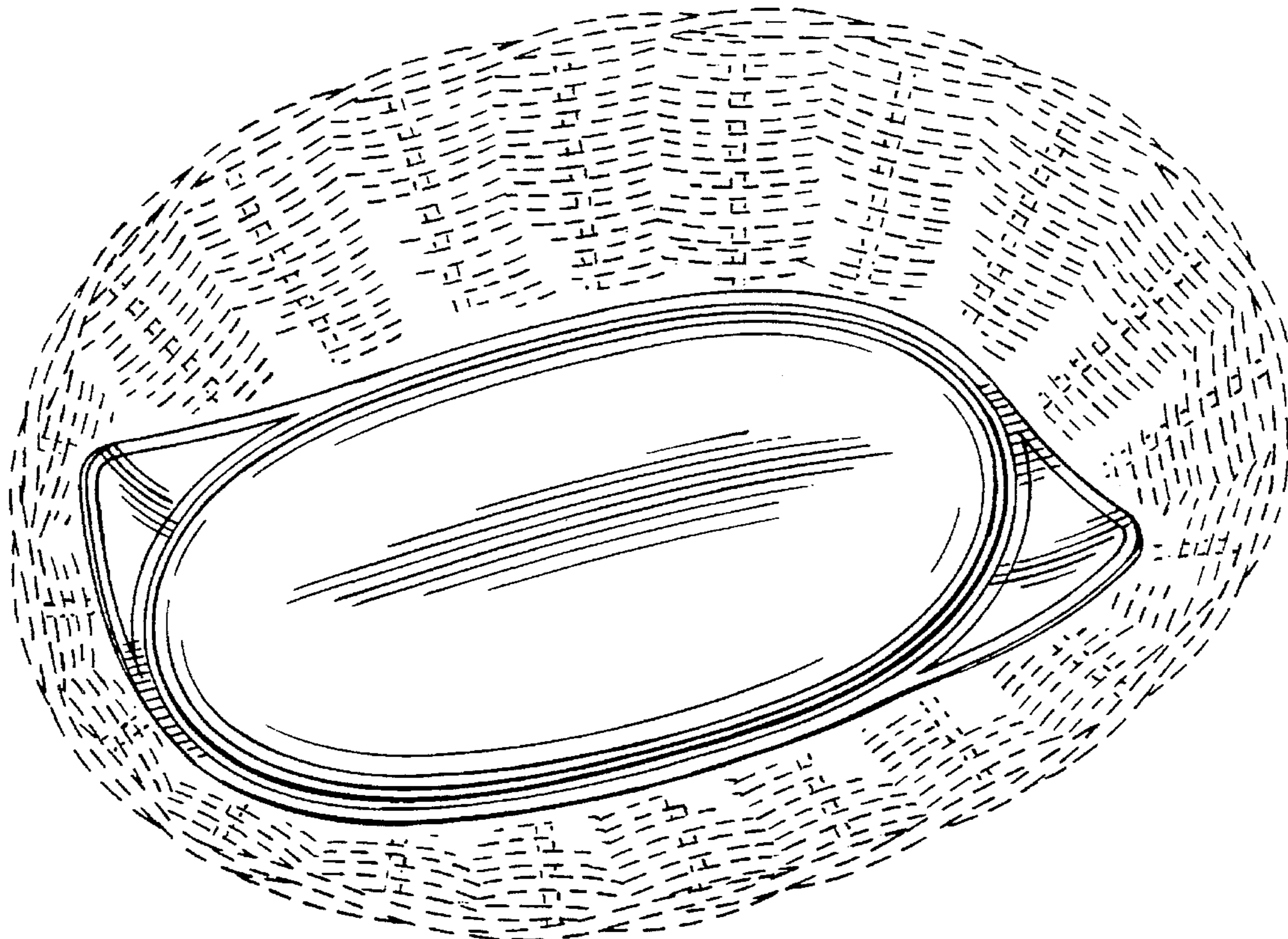
[57] **CLAIM**

The ornamental design for a microwaveable breadwarmer, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a microwavable breadwarmer, showing my new design;
 FIG. 2 is a bottom view thereof;
 FIG. 3 is a front elevational view thereof, with the opposite view being a mirror image thereof;
 FIG. 4 is a side elevational view thereof, with the opposite view being a mirror image thereof;
 FIG. 5 is a top perspective view of a microwavable breadwarmer, showing a second embodiment of my new design;
 FIG. 6 is a bottom view thereof;
 FIG. 7 is a front elevational view thereof, with the opposite view being a mirror image thereof, and,
 FIG. 8 is a side elevational view thereof, with the opposite view being a mirror image thereof.
 The broken line showing of a basket in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.

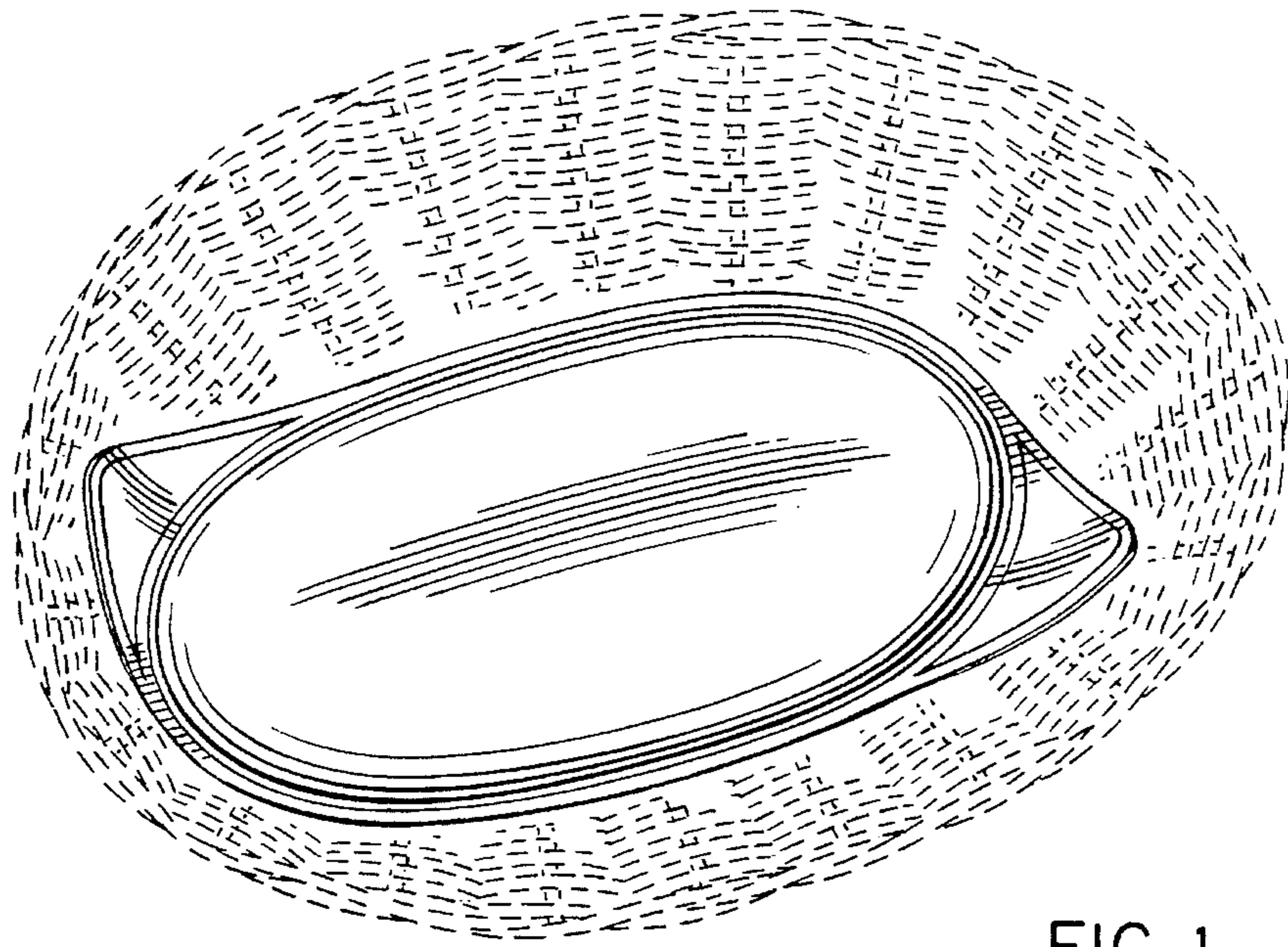

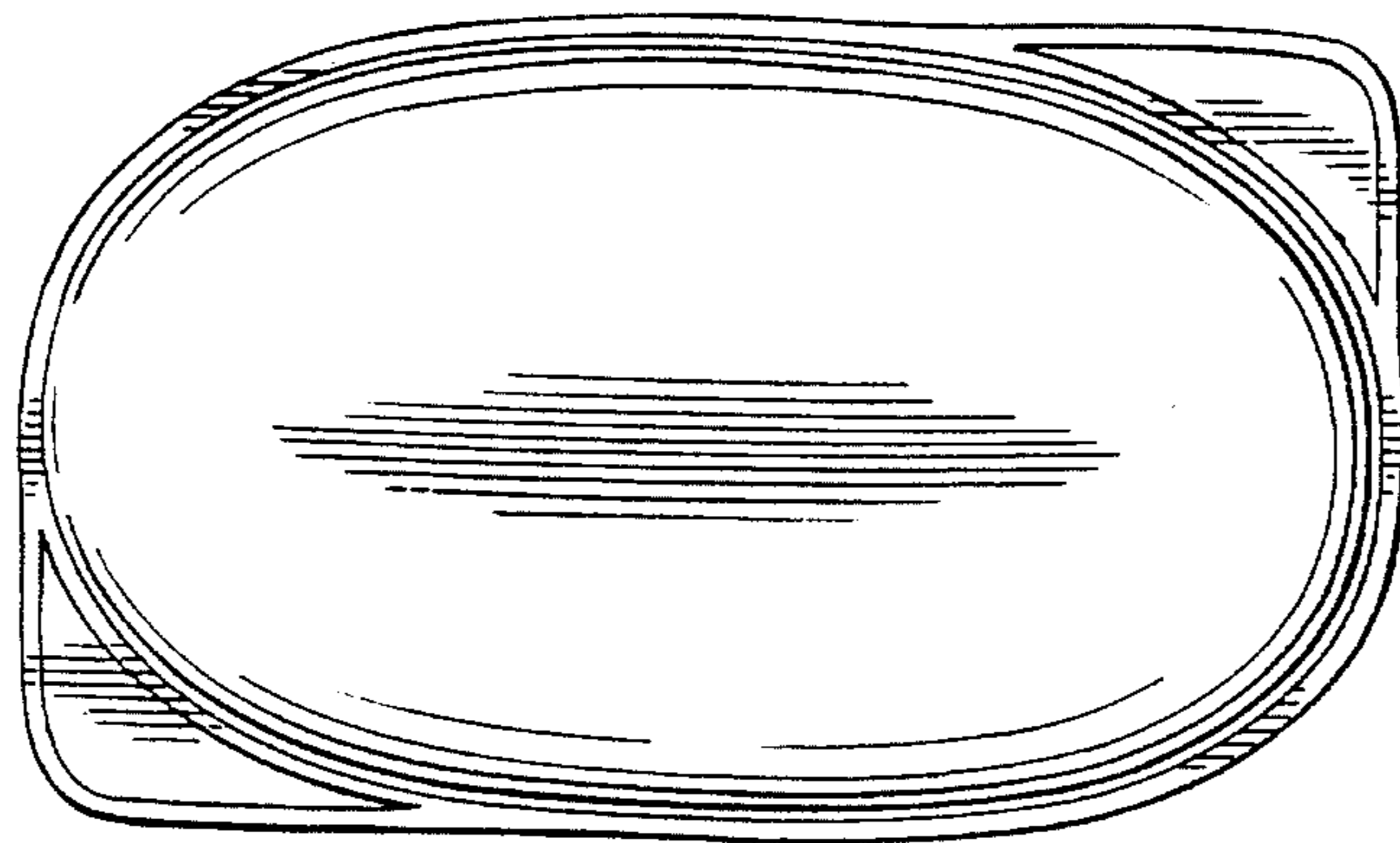

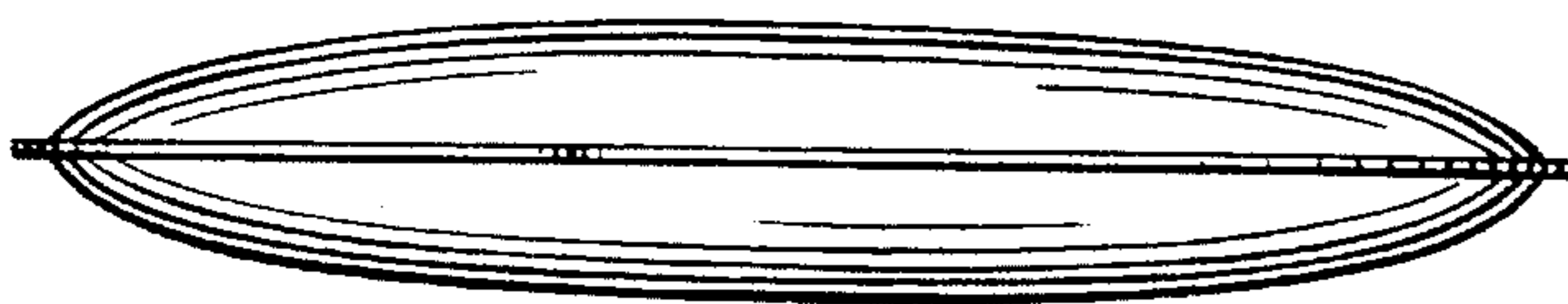

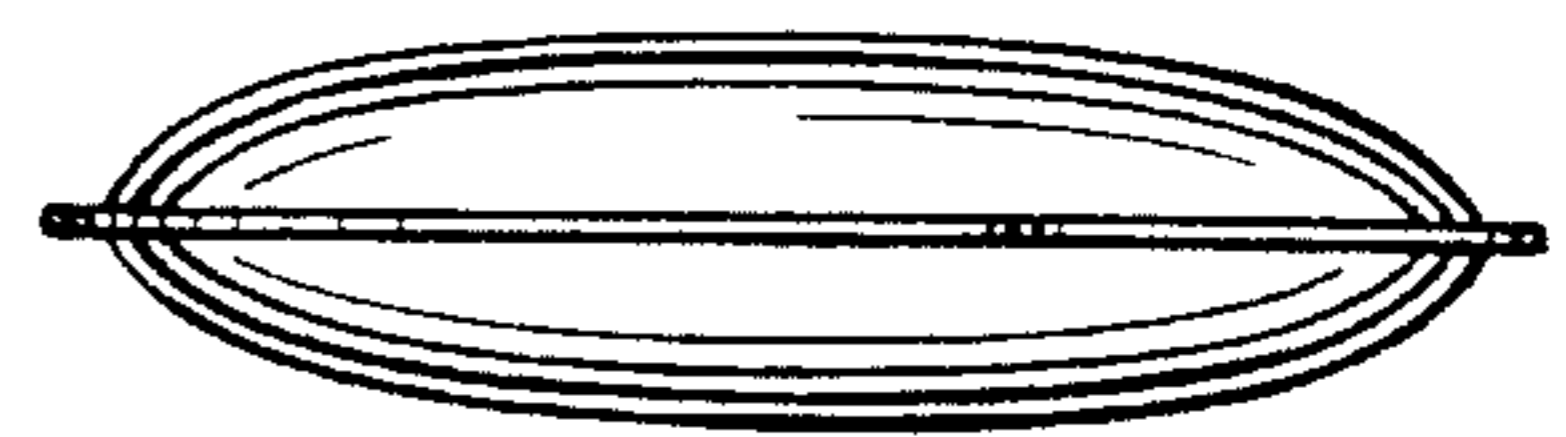

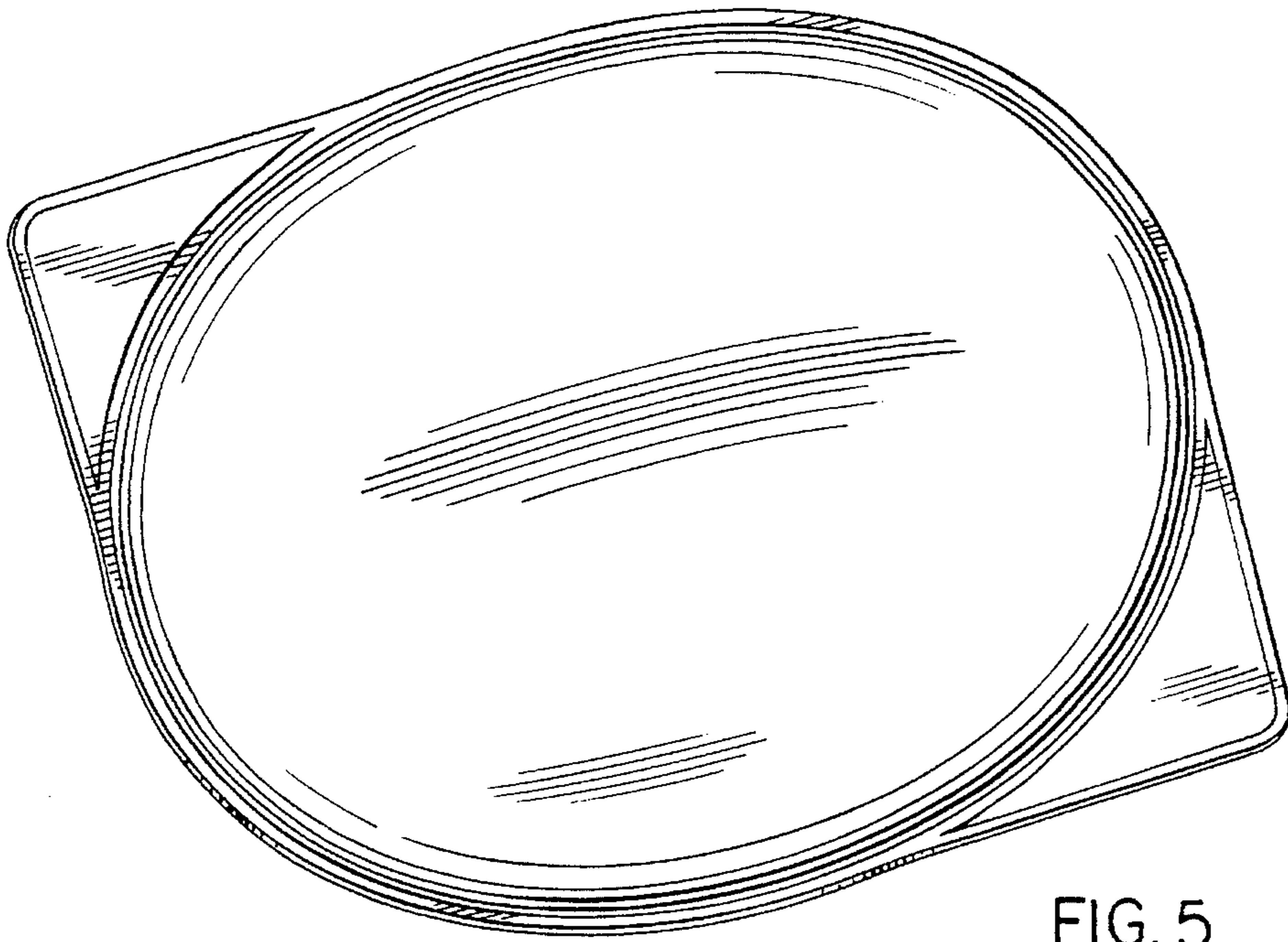

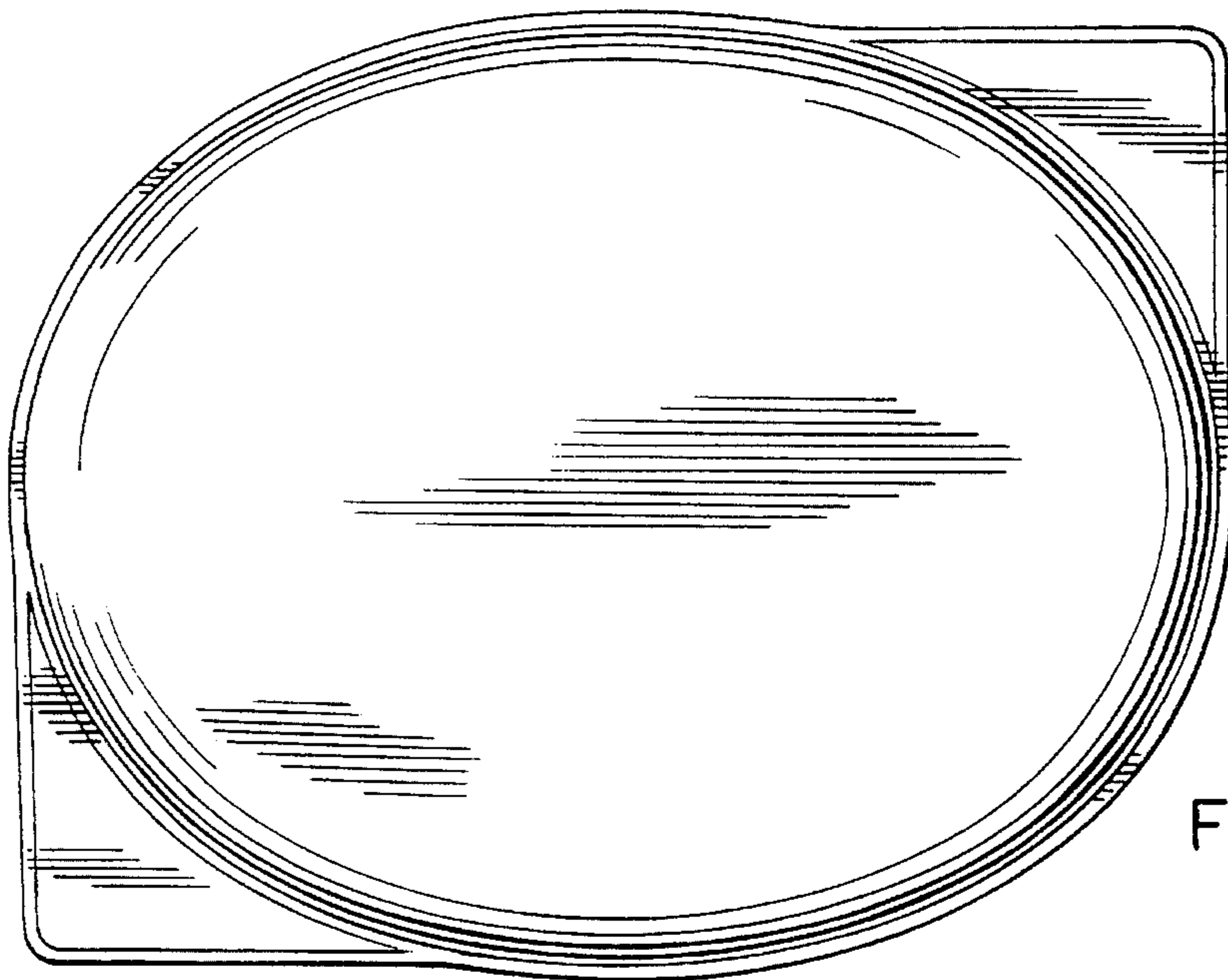

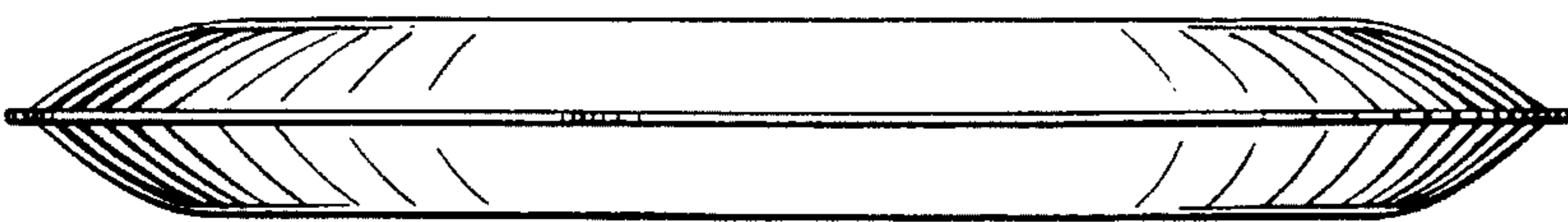

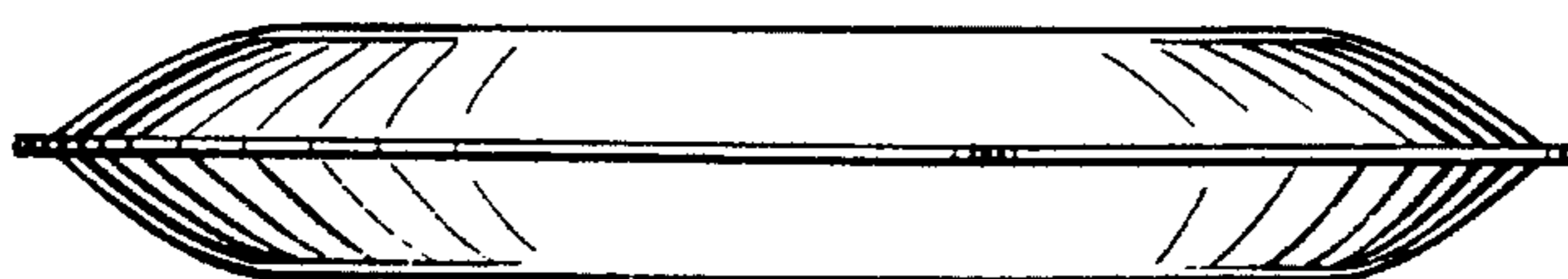
