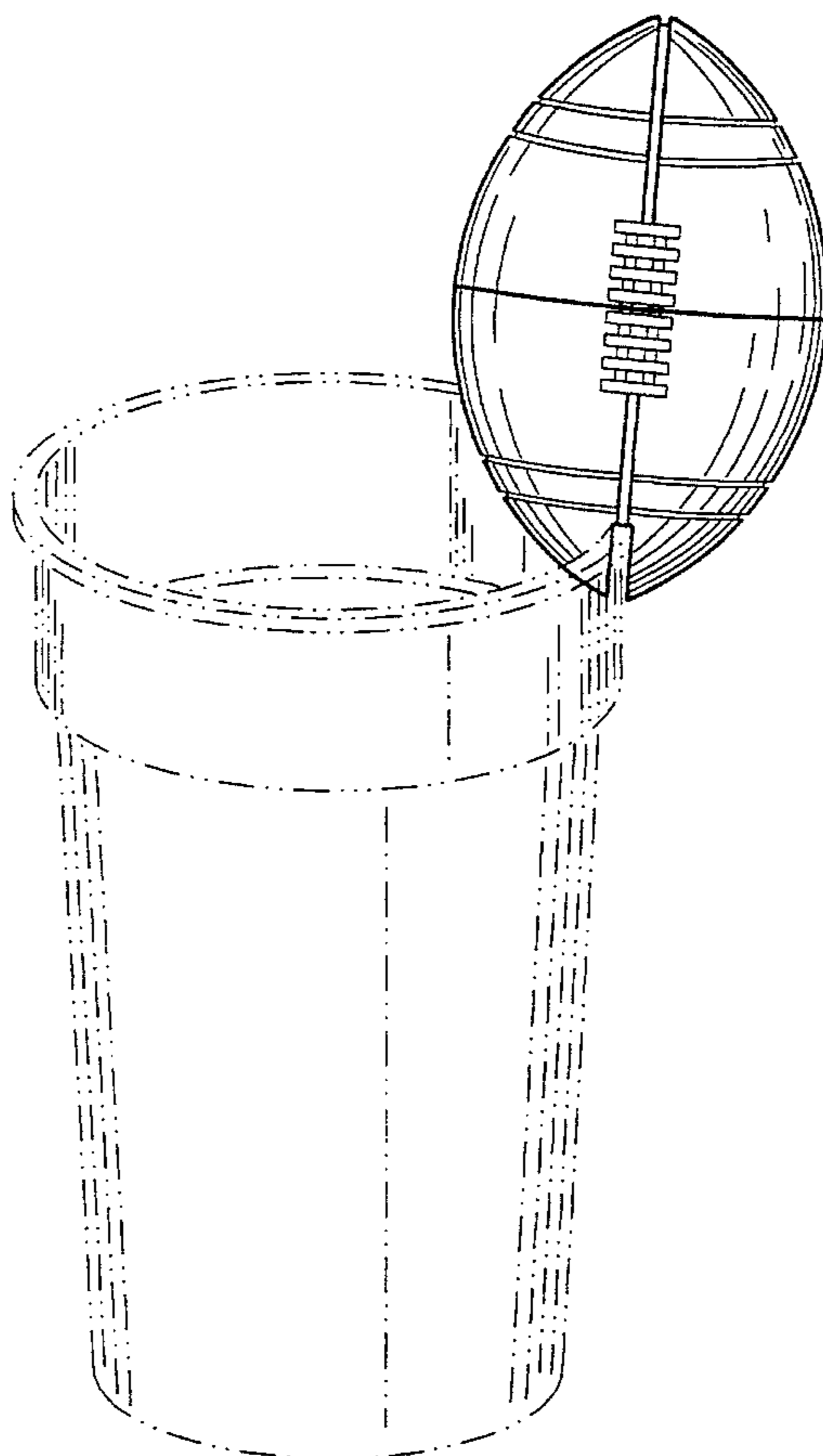
[57] **CLAIM**

The ornamental design for a football drink container, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a football drink container showing my new design;  
FIG. 2 is a left front perspective view of a football drink container thereof;  
FIG. 3 is a bottom view of the football drink container of the instant invention;  
FIG. 4 is a top view of the football drink container of the instant invention;  
FIG. 5 is a front view of the football drink container of the instant invention;  
FIG. 6 is a rear view of the football drink container of the instant invention;  
FIG. 7 is a top view of the bottom portion of the football drink container, the top portion removed for ease of illustration;  
FIG. 8 is a bottom view of the top portion of the football drink container, the bottom portion removed for ease of illustration; and,  
FIG. 9 is a left side view of the football drink container.  
The broken line showing of a drinking cup in FIG. 1 and a support stand in FIG. 2 is for illustrative purposes only and forms no part of the claimed design.

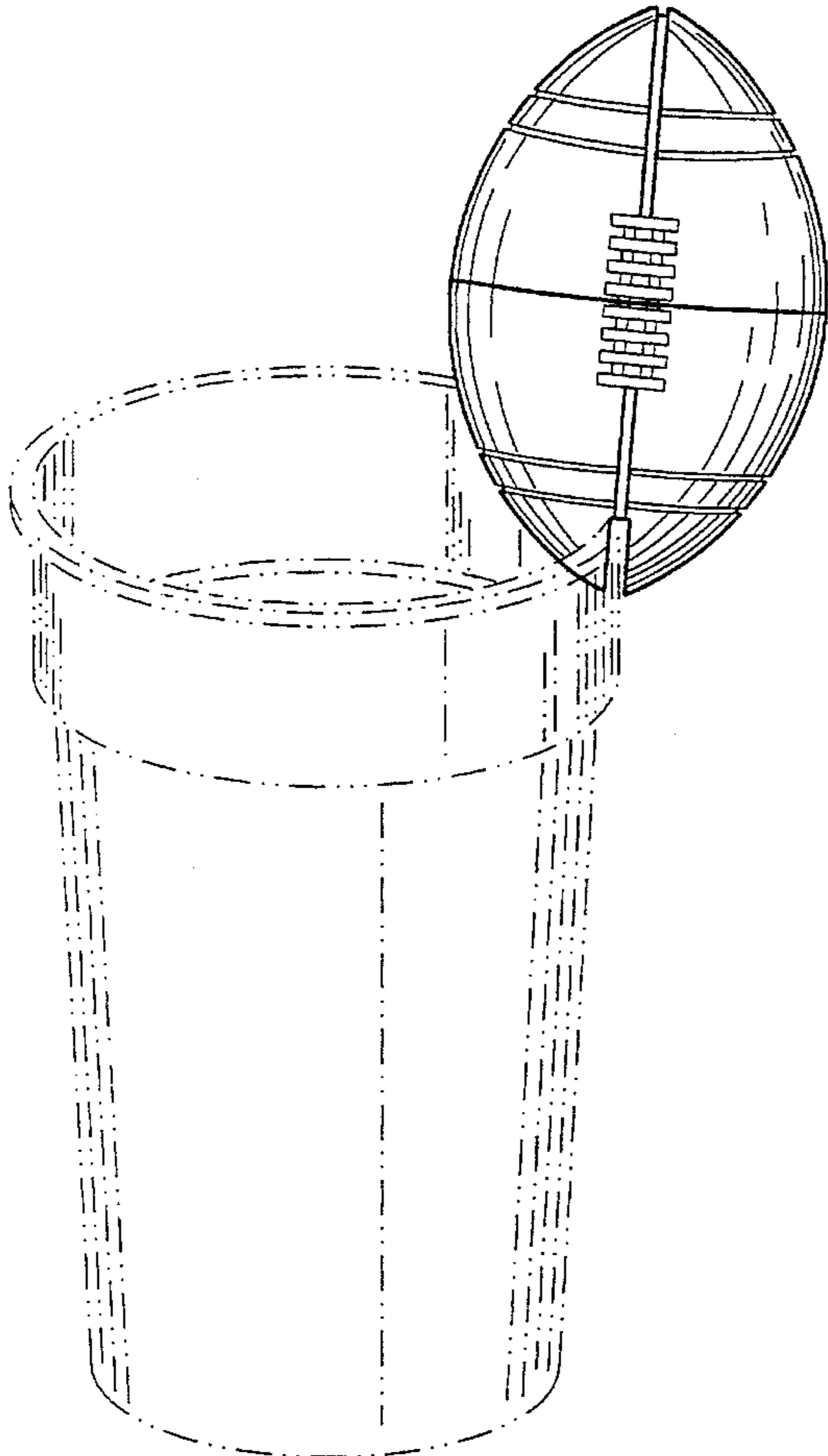

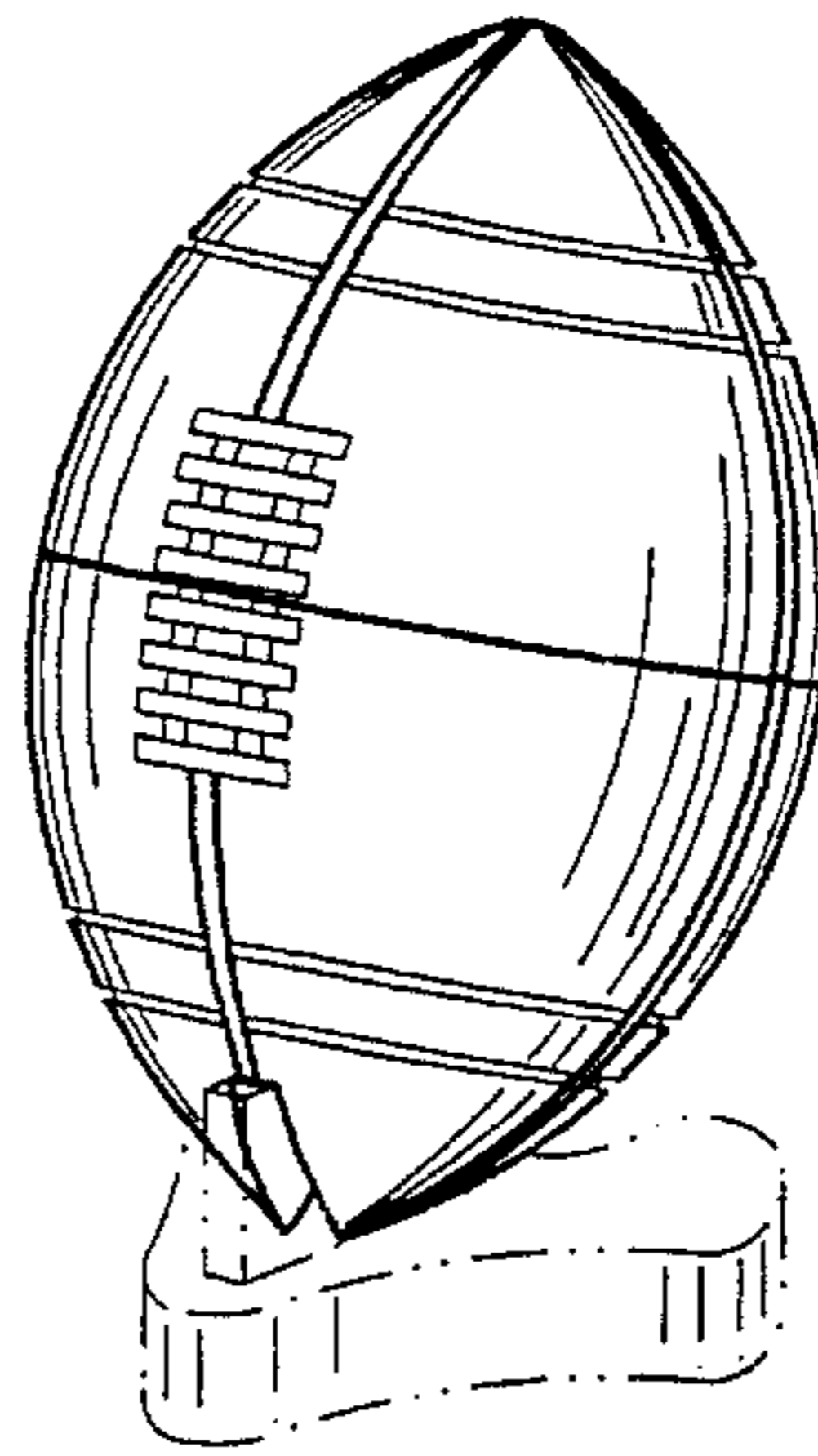

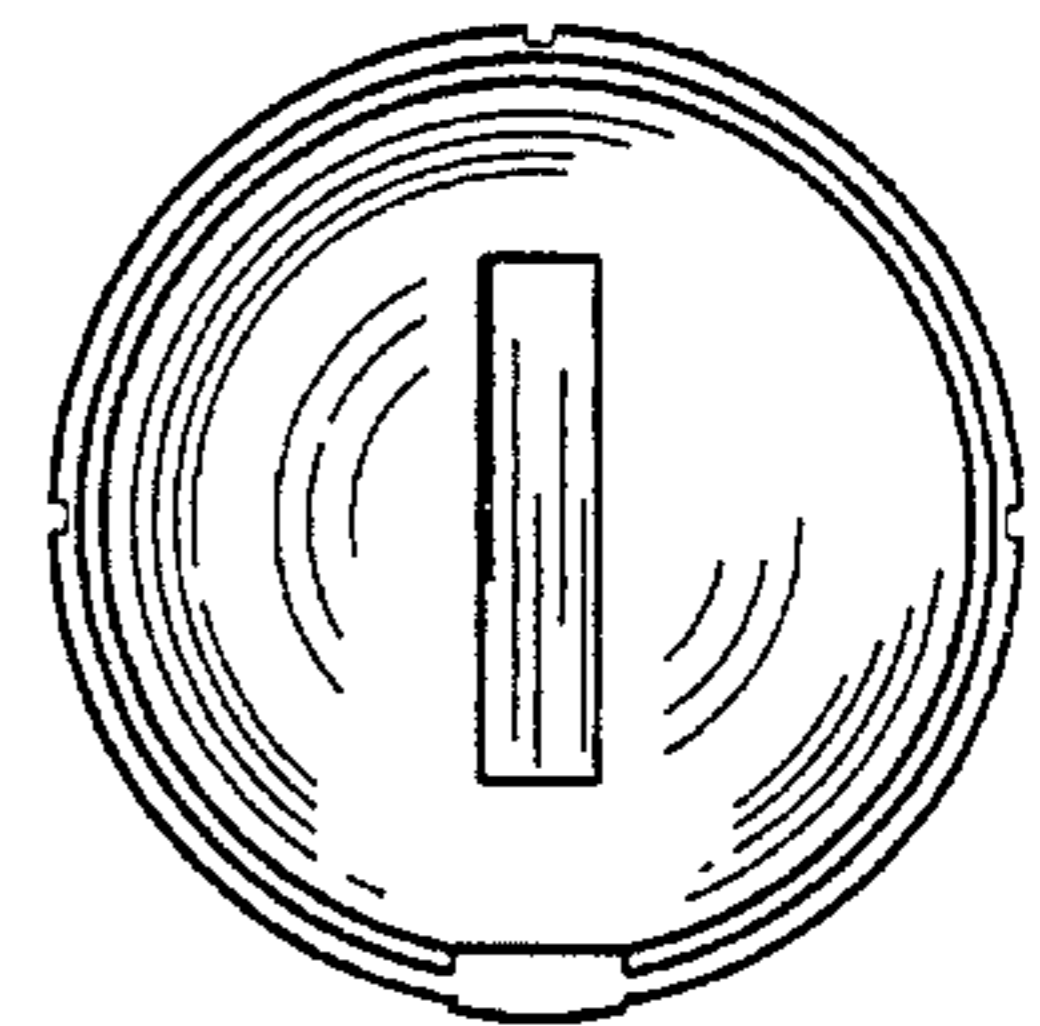

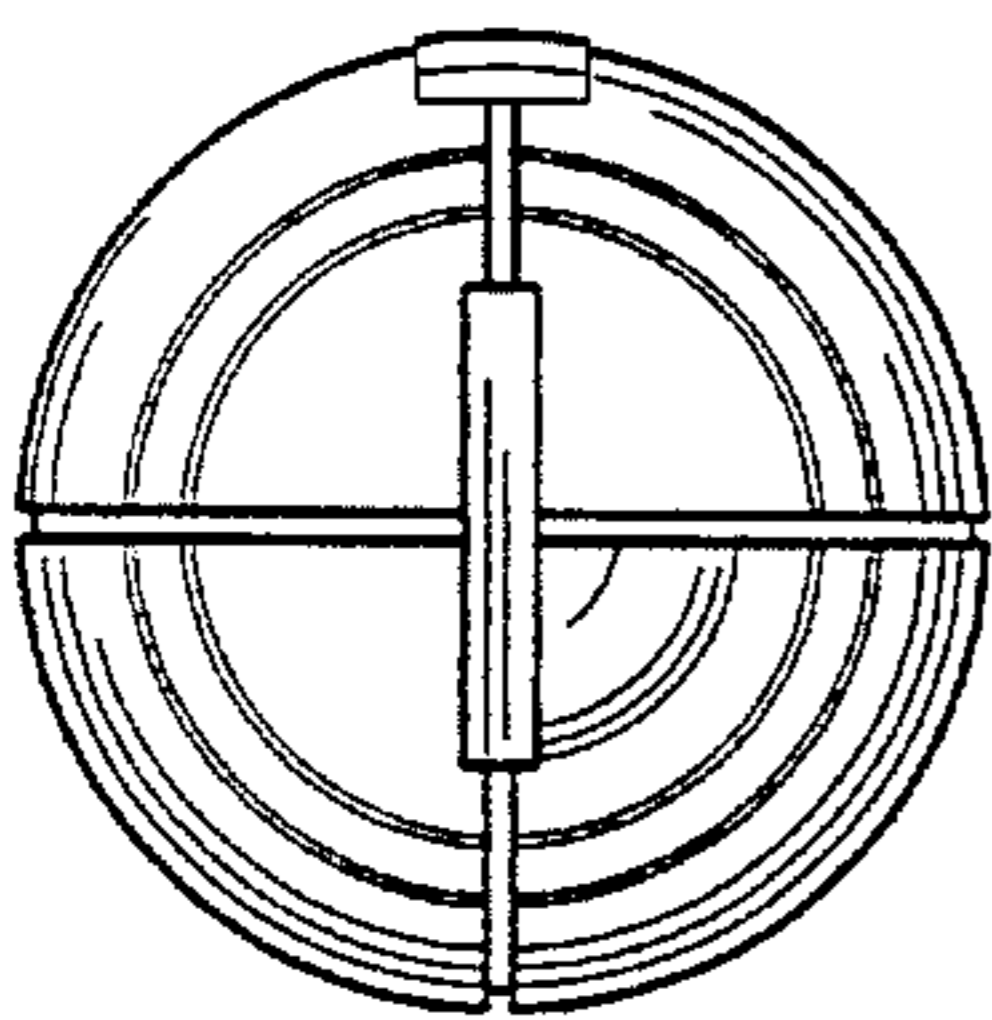

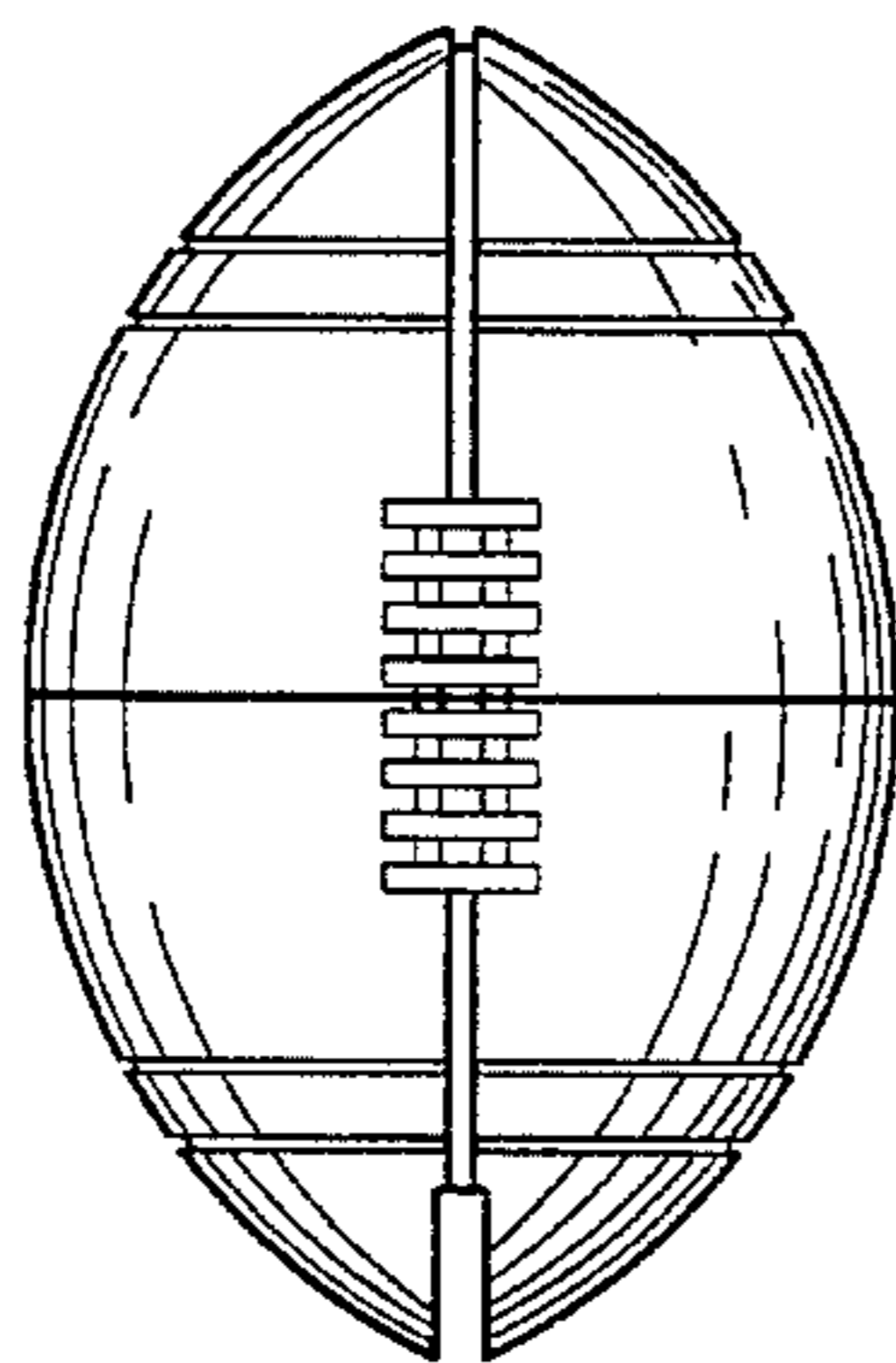

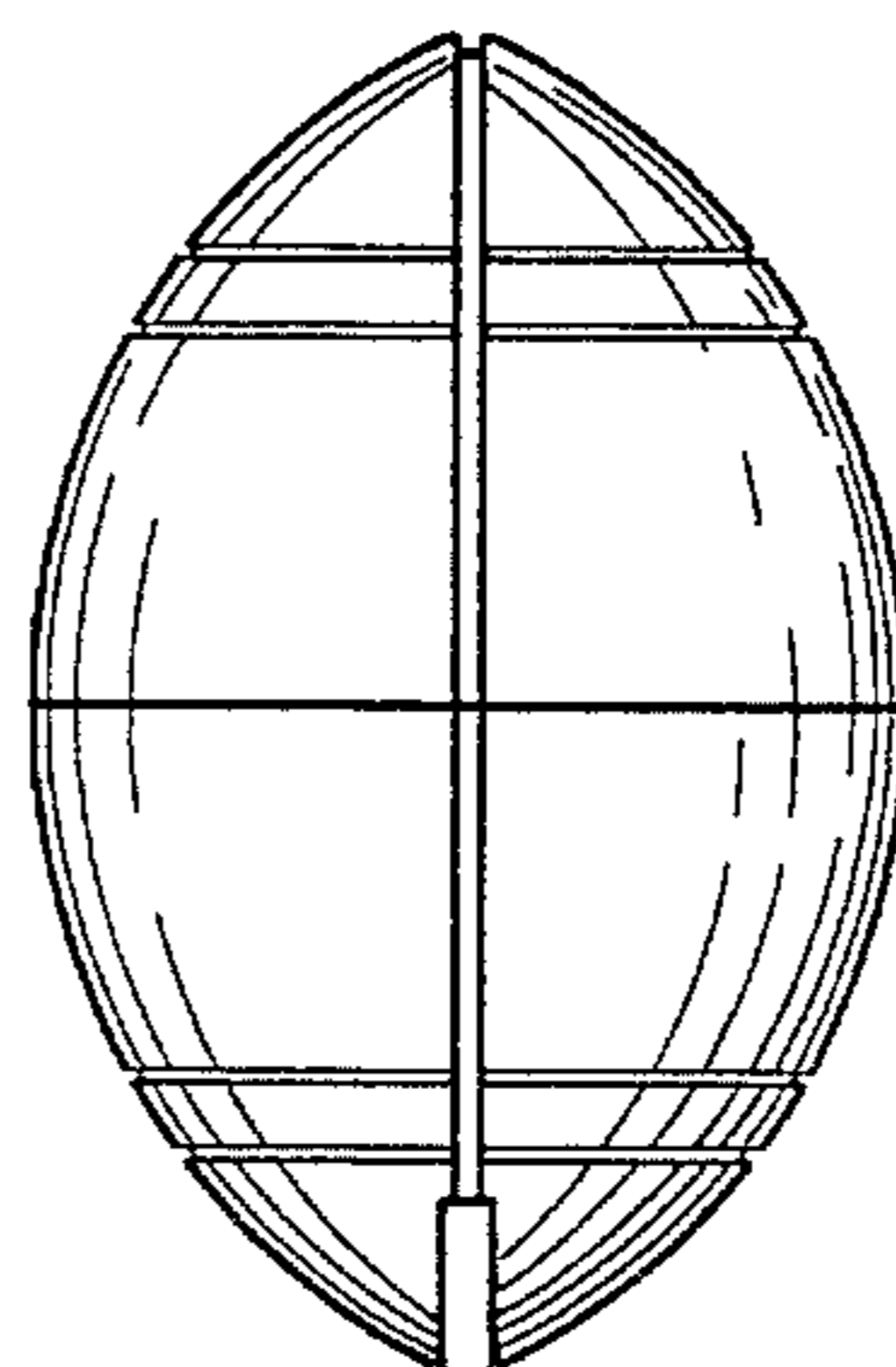

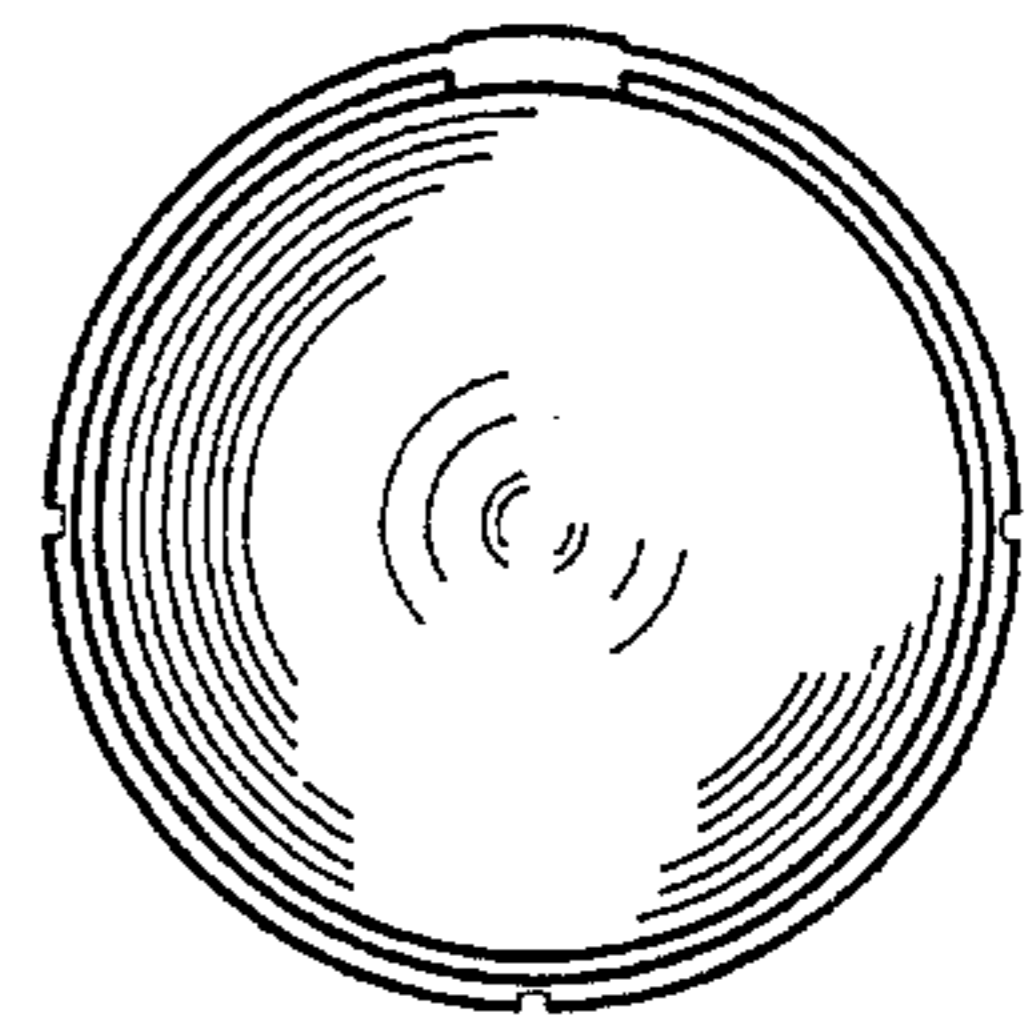

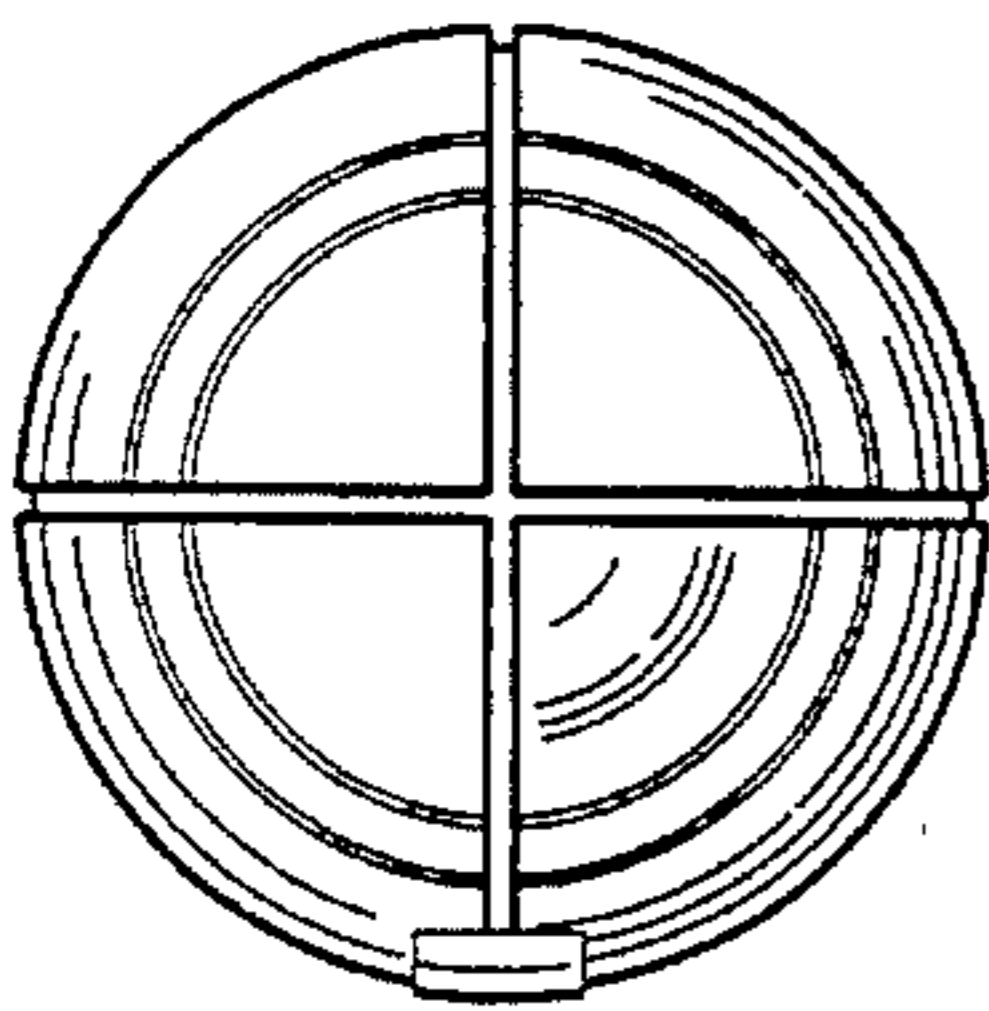

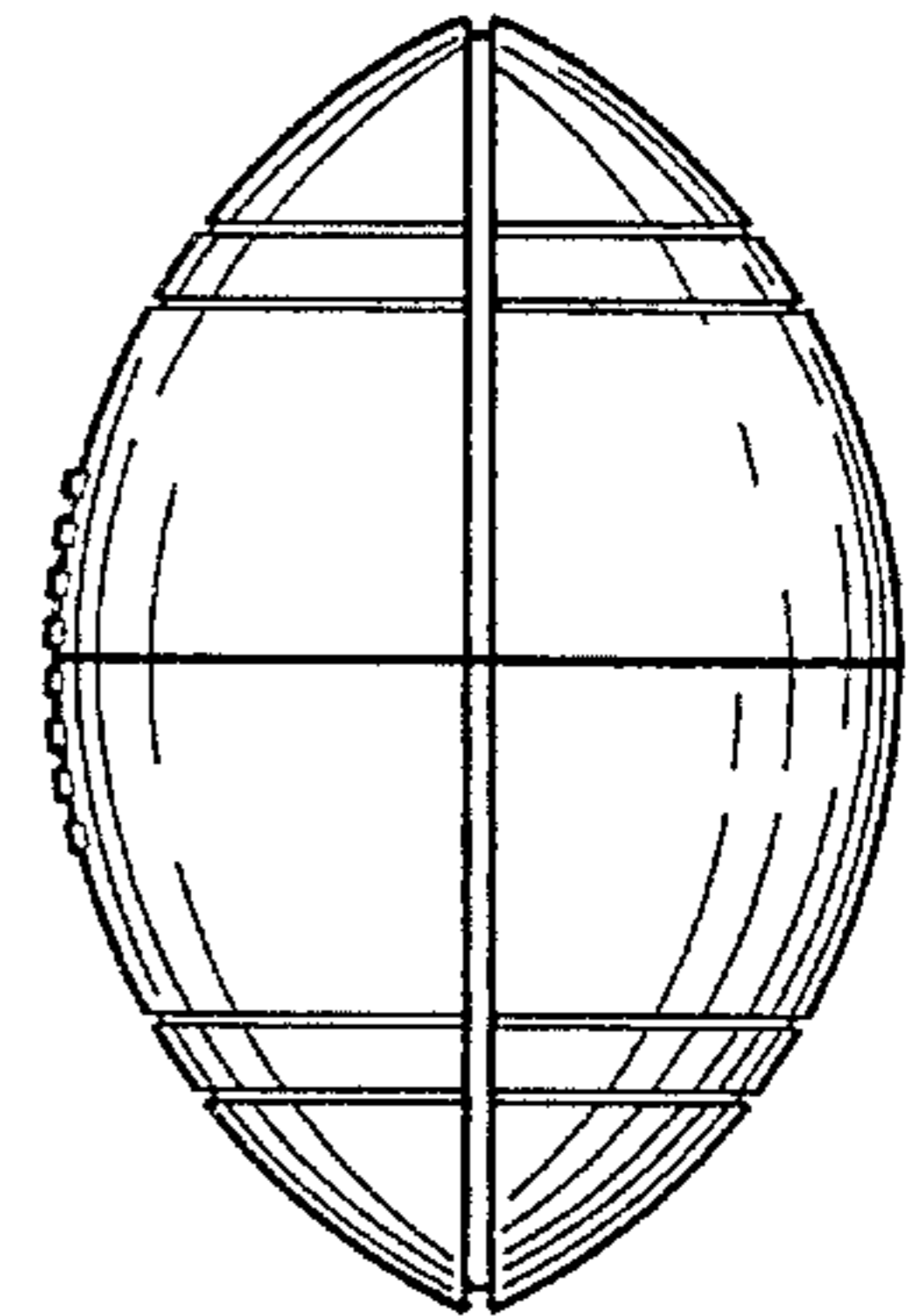
