[57] **CLAIM**

The ornamental design for a trailer hitch bracket, as shown
and described.

DESCRIPTION

FIG. 1 is a perspective view showing the trailer hitch bracket
of my new design;

FIG. 2 is an end elevational view thereof, the opposite end
being a mirror image thereof;

FIG. 3 is a side elevational view thereof, the opposite side
being a mirror image thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a perspective view of a first modification of the
trailer hitch bracket of my new design;

FIG. 7 is an end elevational view of FIG. 6, the opposite end
being a mirror image thereof;

FIG. 8 is a side elevational view of FIG. 6, the opposite side
being a mirror image thereof;

FIG. 9 is a top plan view of FIG. 6;

trailer hitch bracket showing my new design;

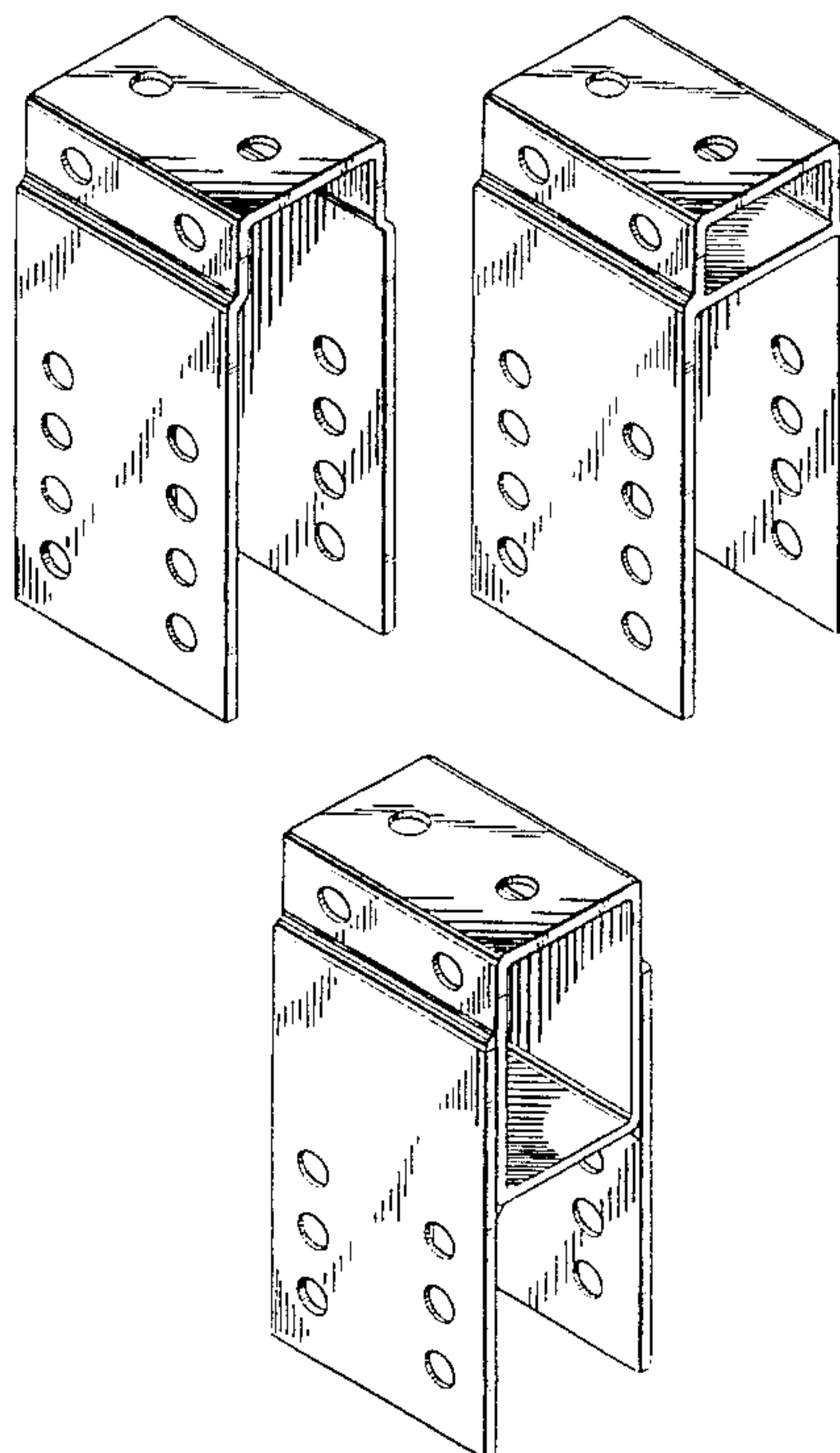
FIG. 12 is an end elevational view of FIG. 11, the opposite

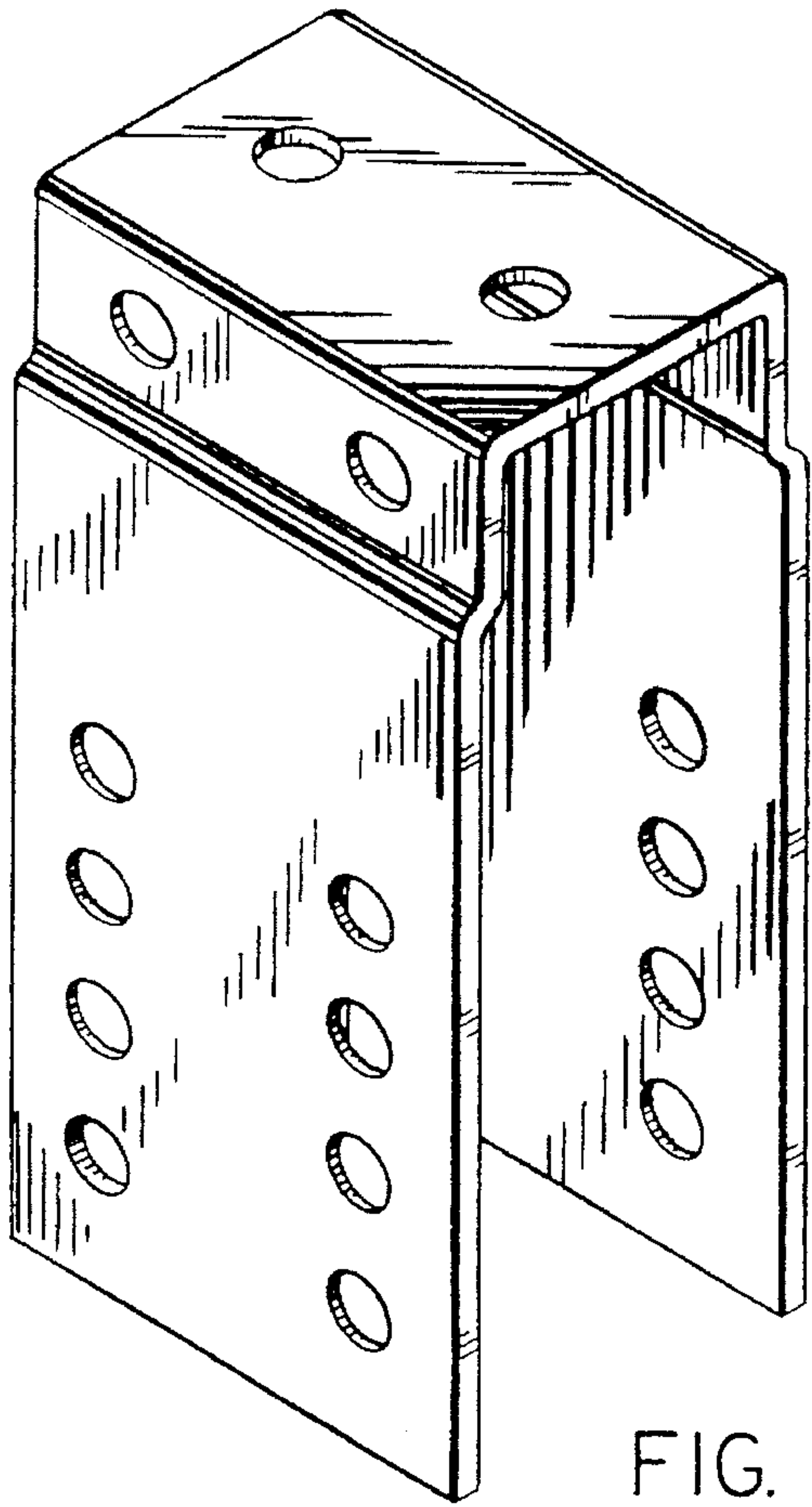

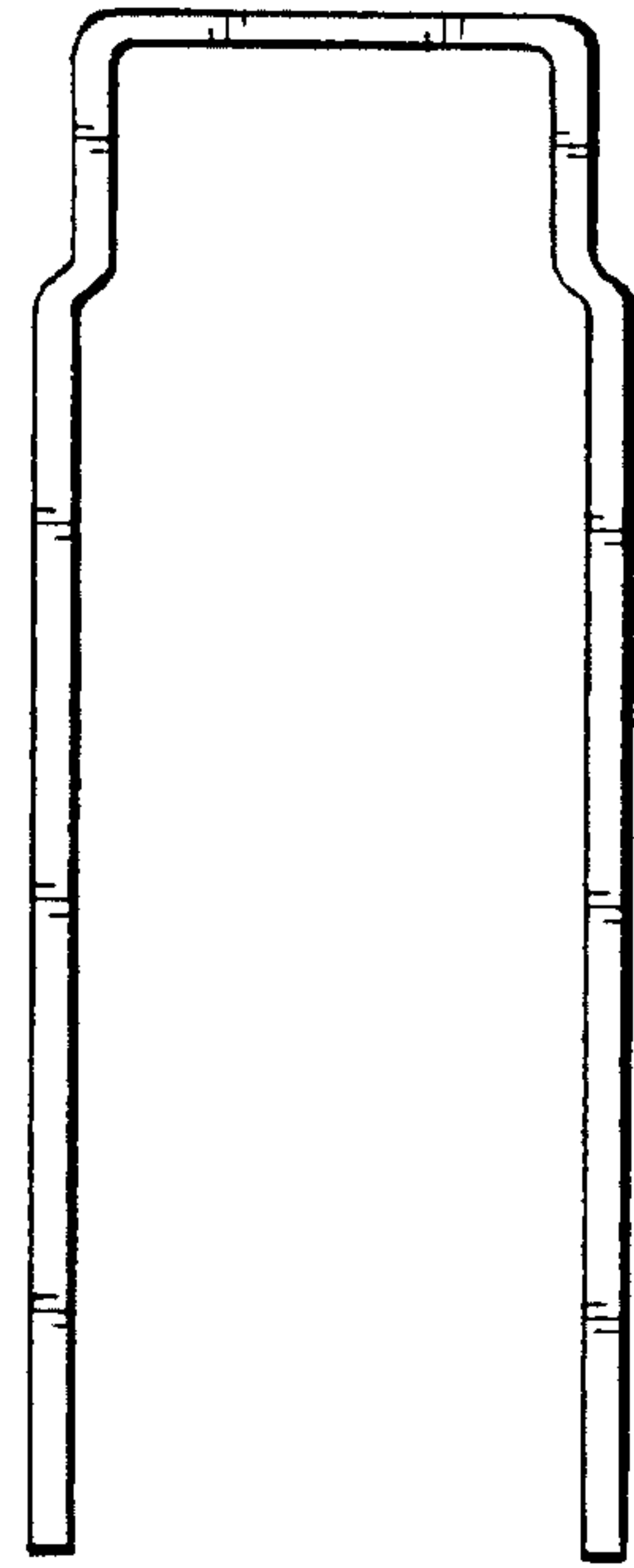

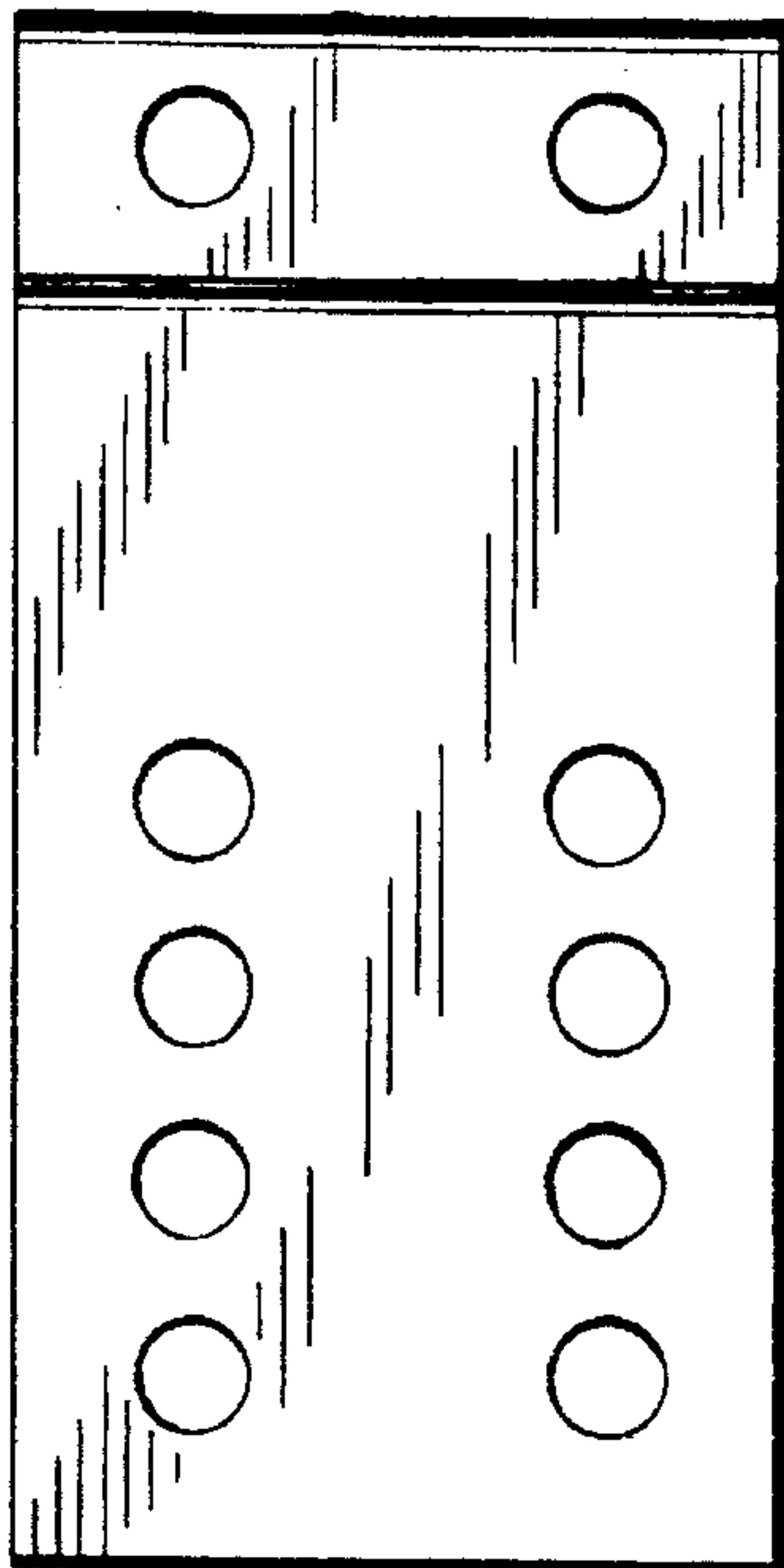

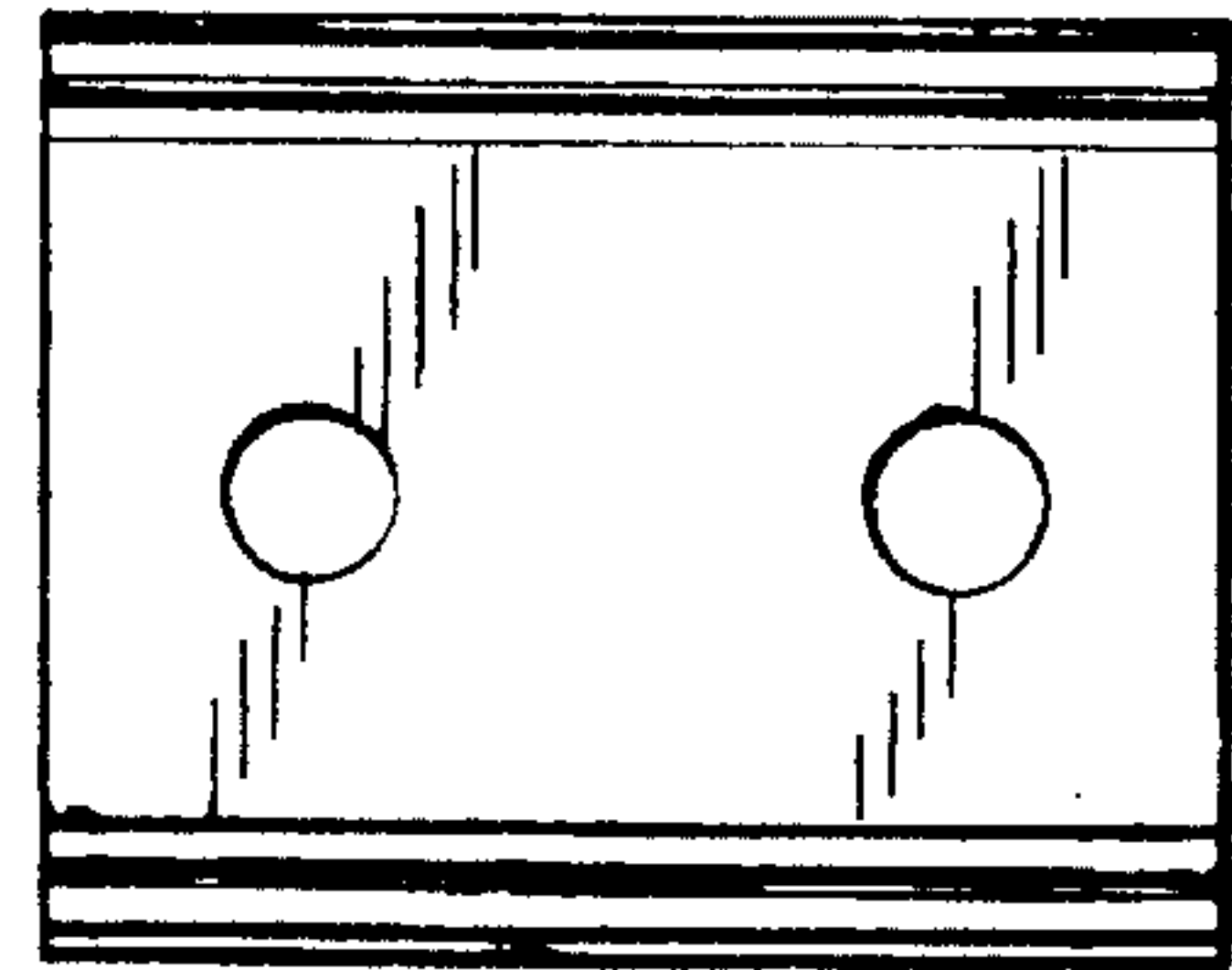

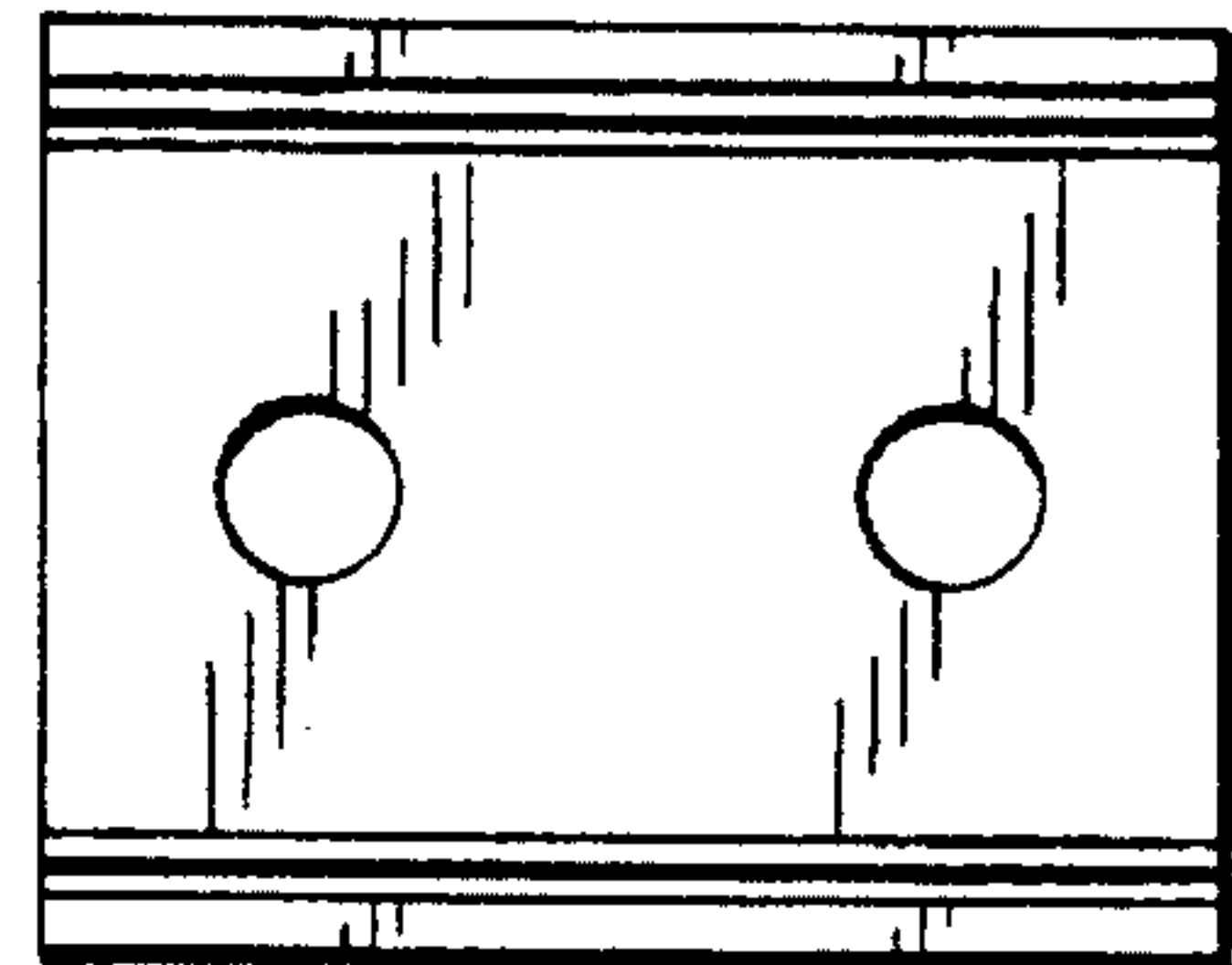

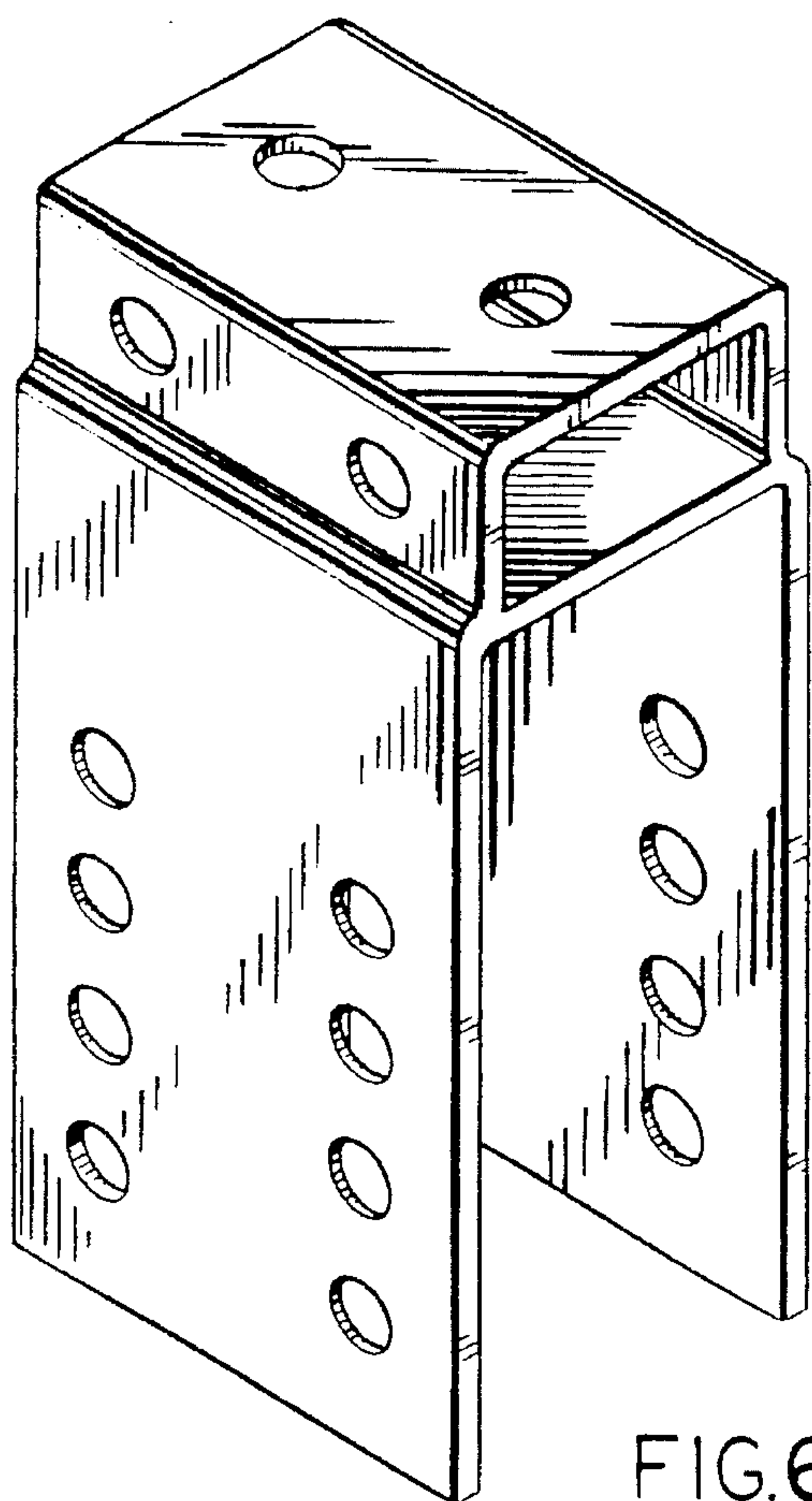

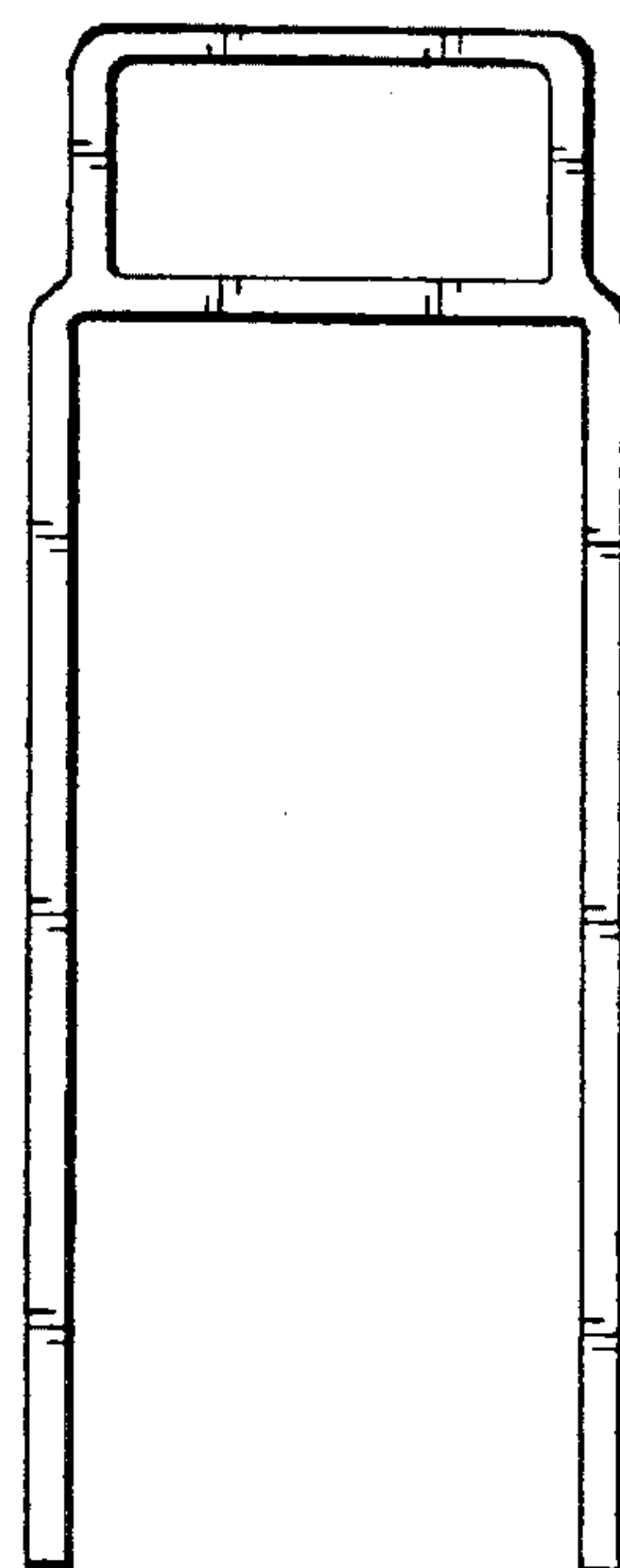

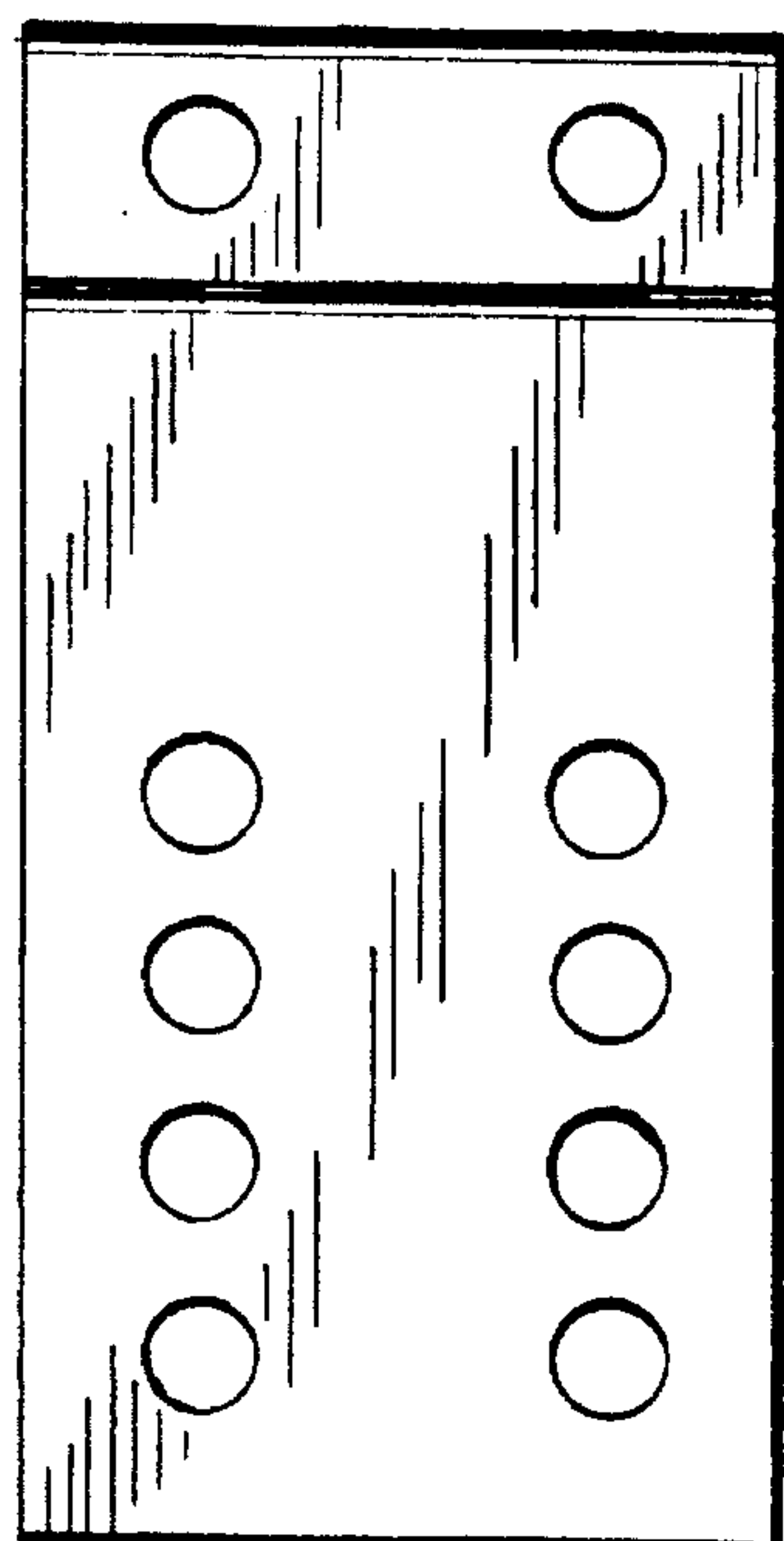

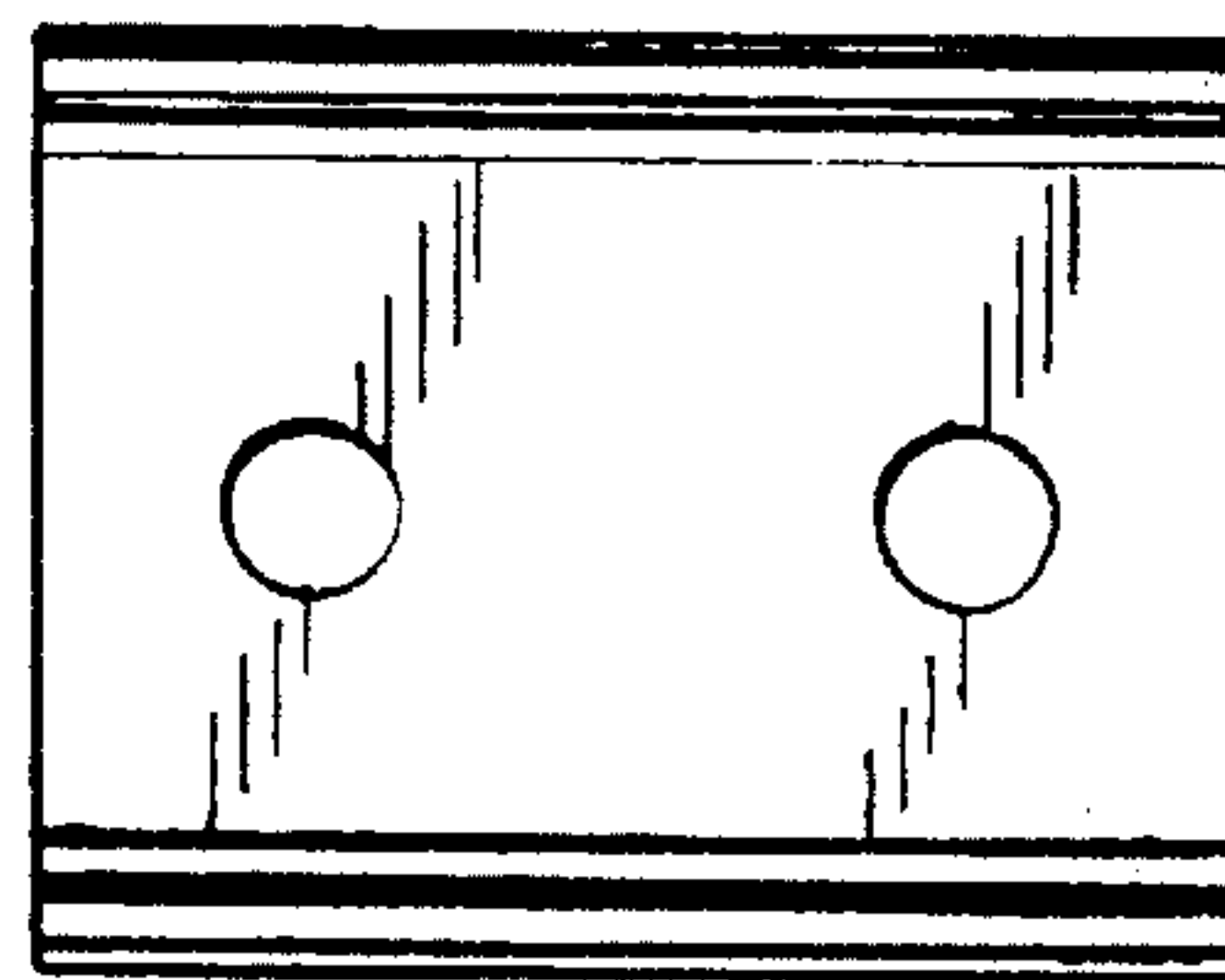

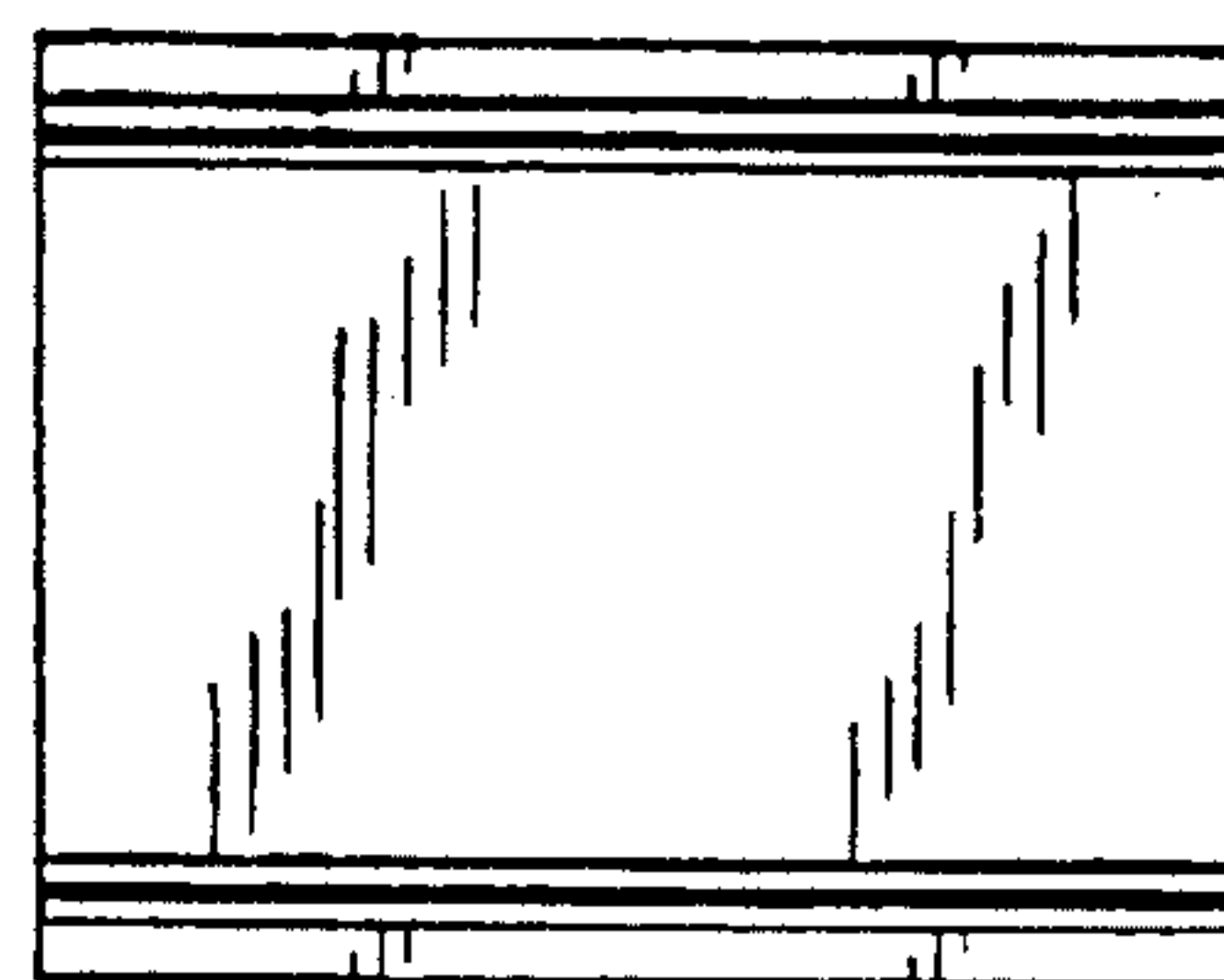

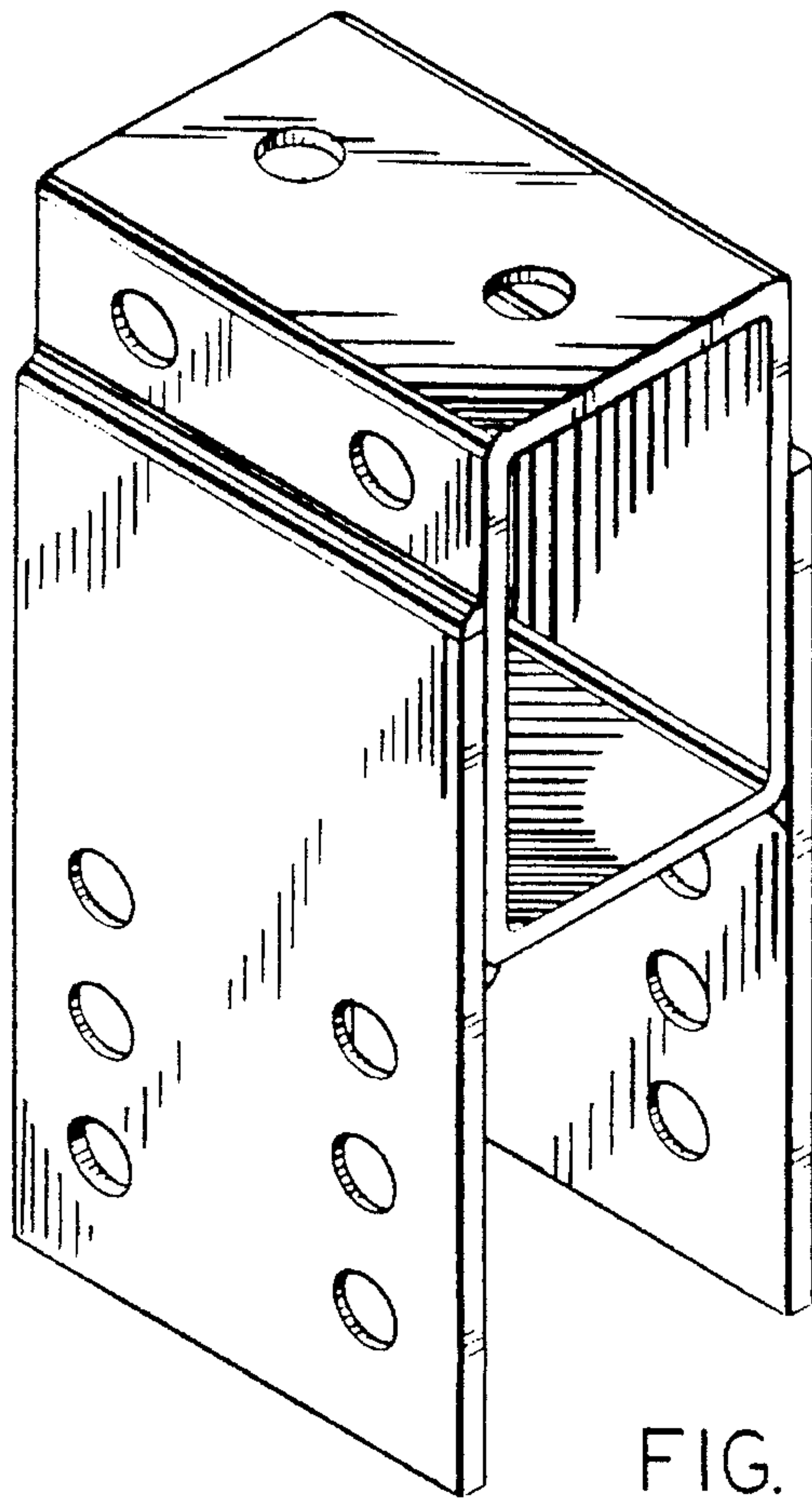

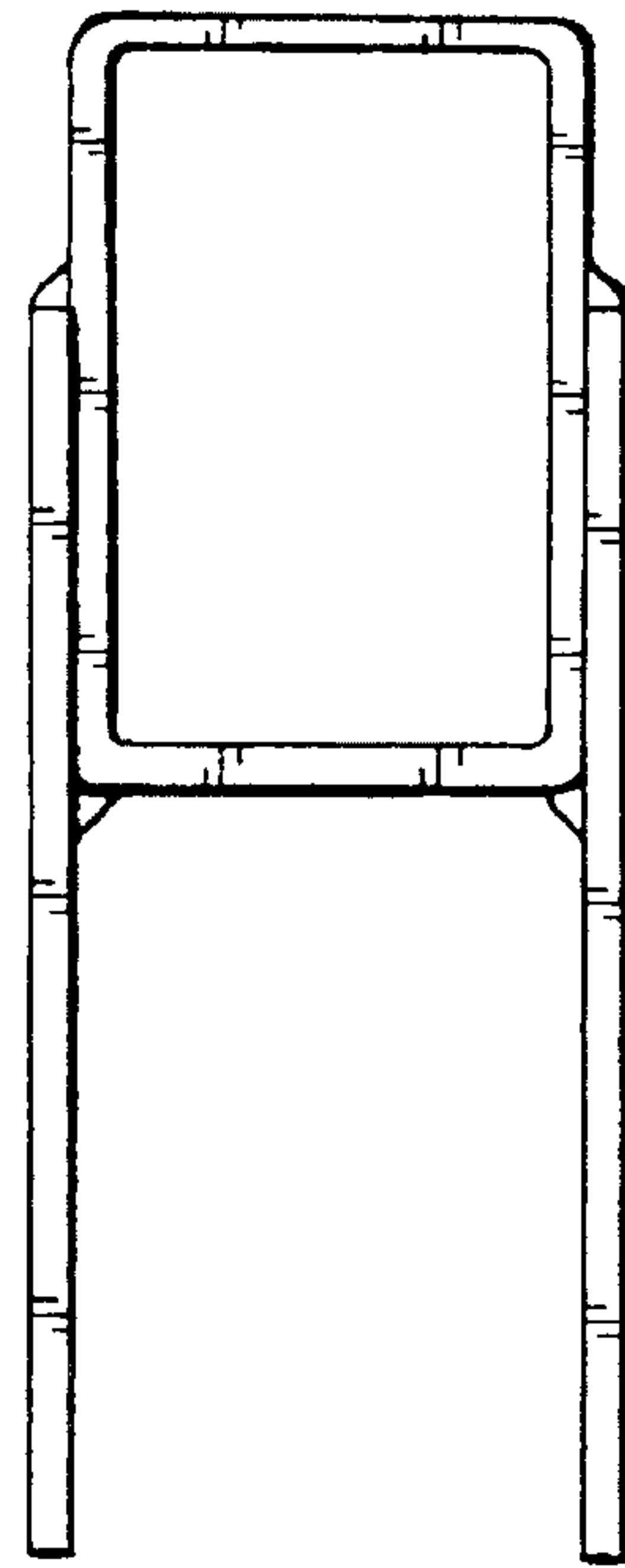

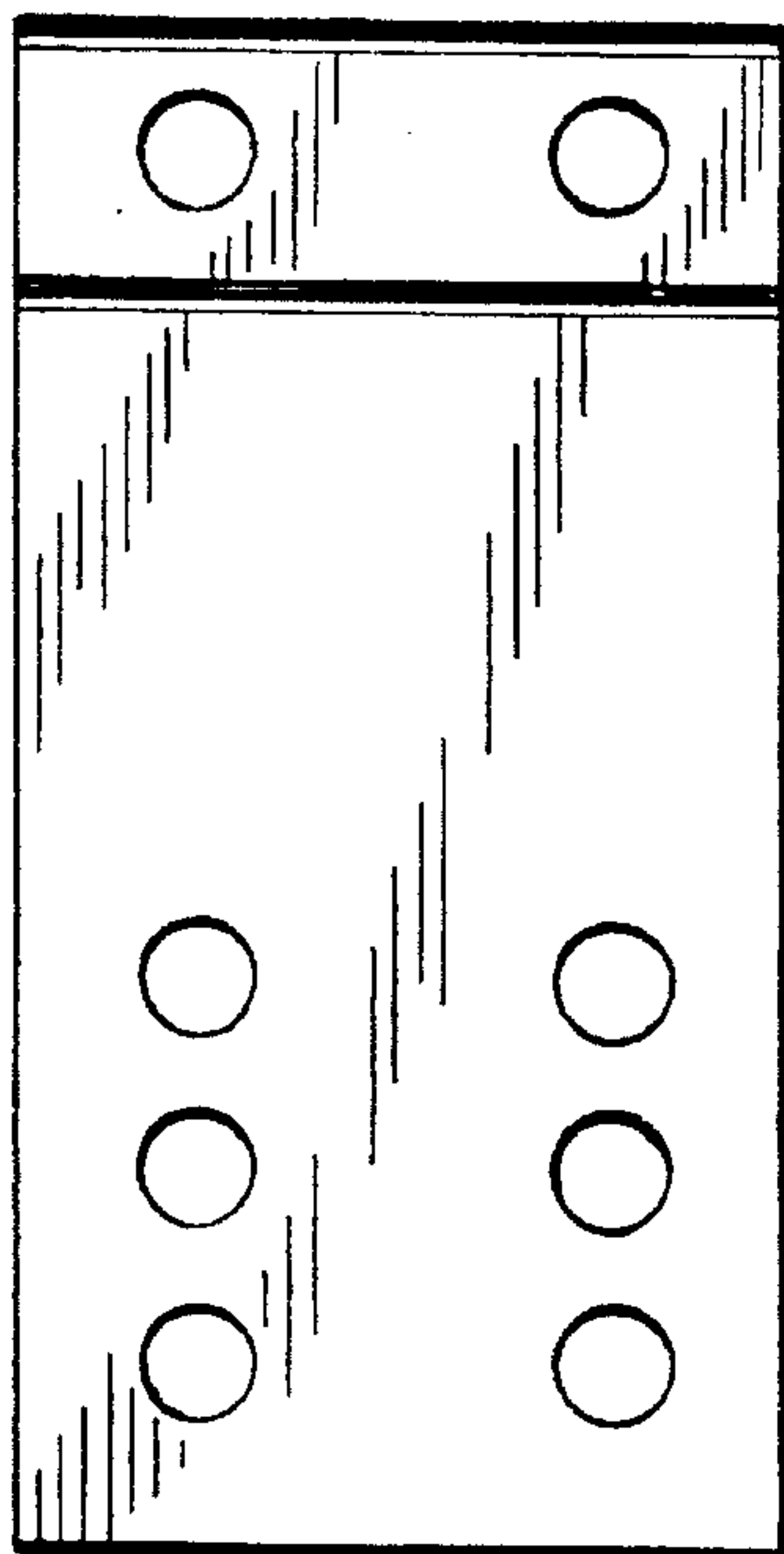

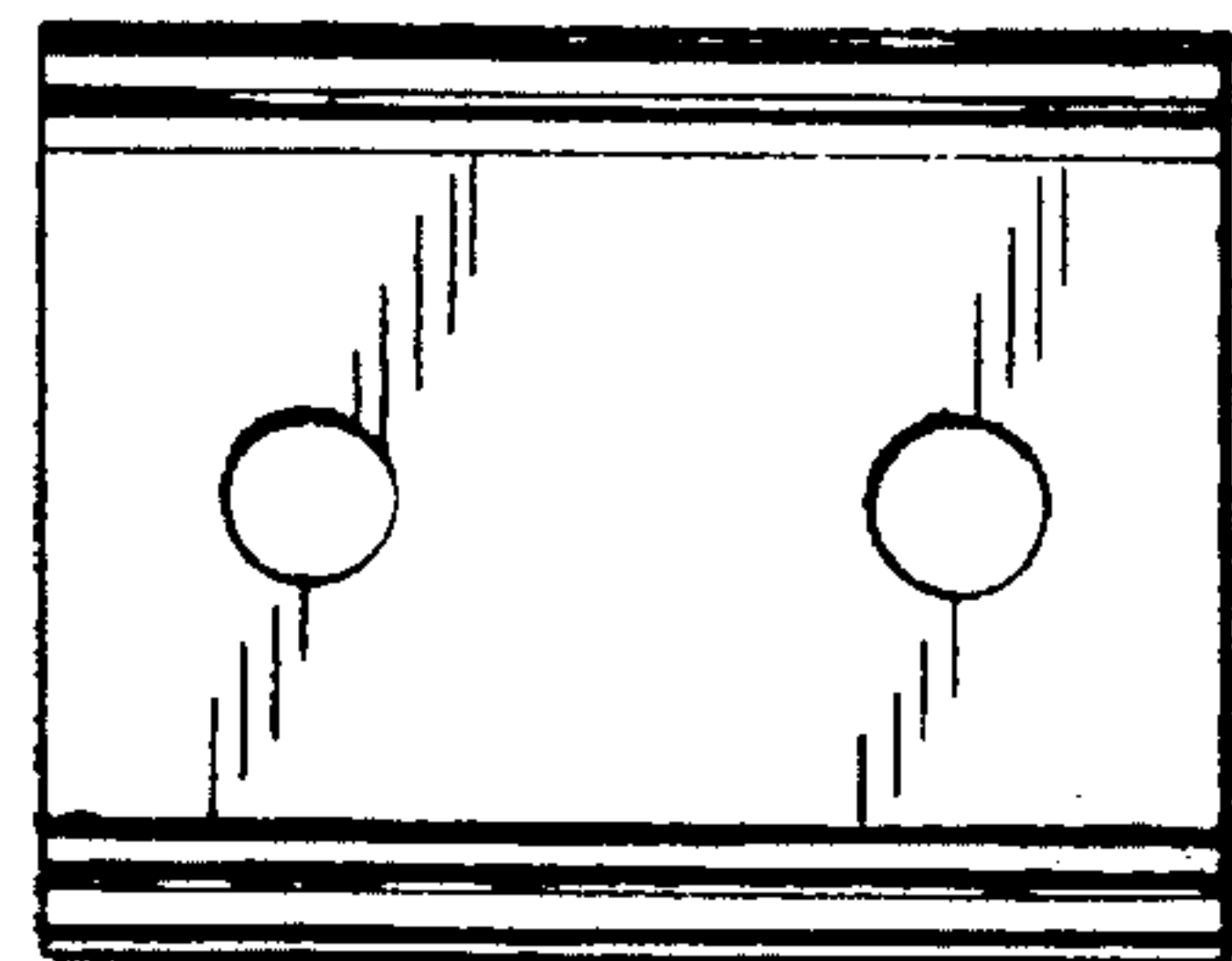

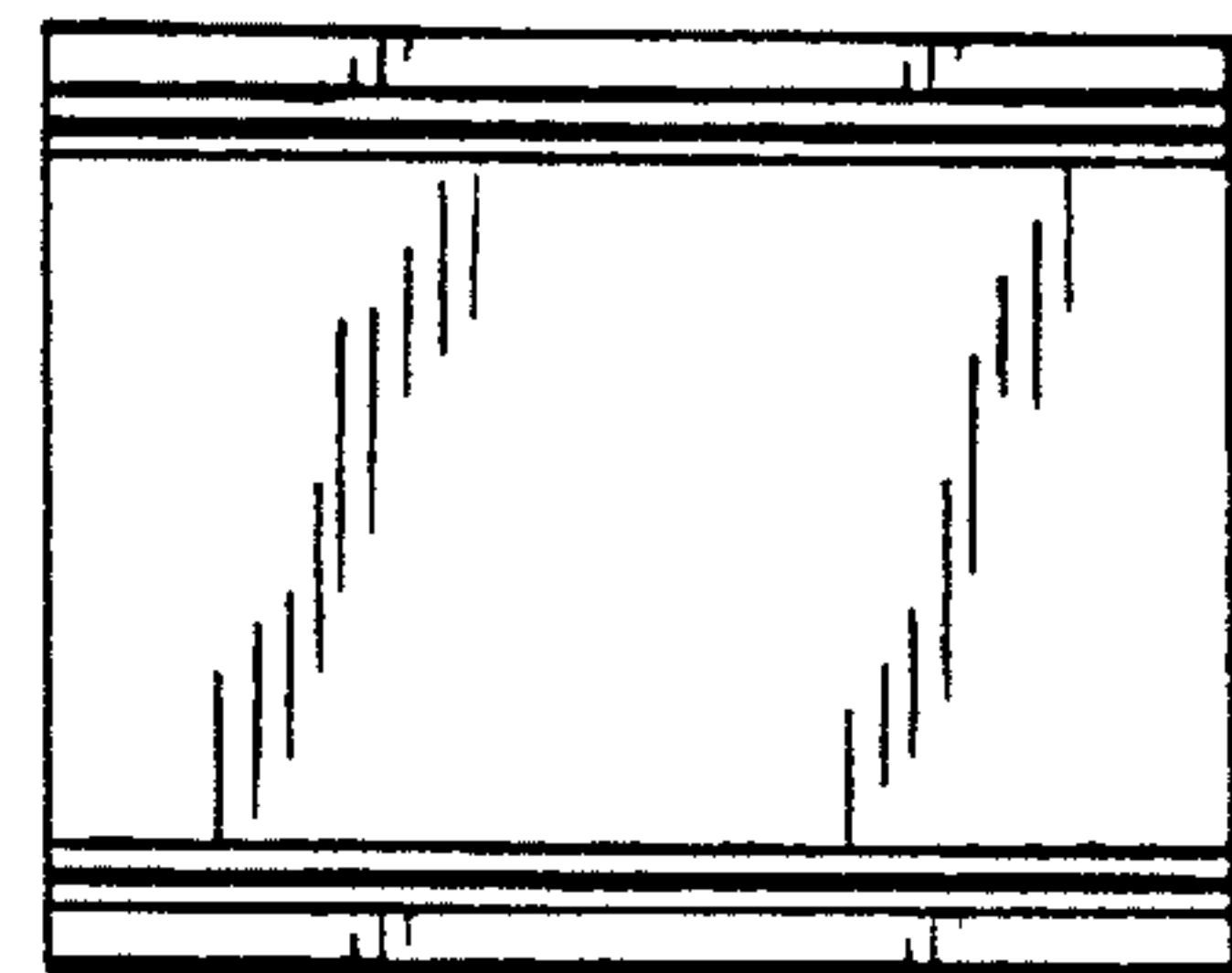
