### [57] CLAIM

The ornamental design for a portable radio telephone, as shown and described.

### DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a portable radio telephone with the antenna extended, showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a left side elevational view thereof;

FIG. 7 is a rear elevational view thereof; and,

FIG. 8 is an enlarged cross sectional view, taken along the line 8—8 in FIG. 2 with its internal mechanisms omitted.

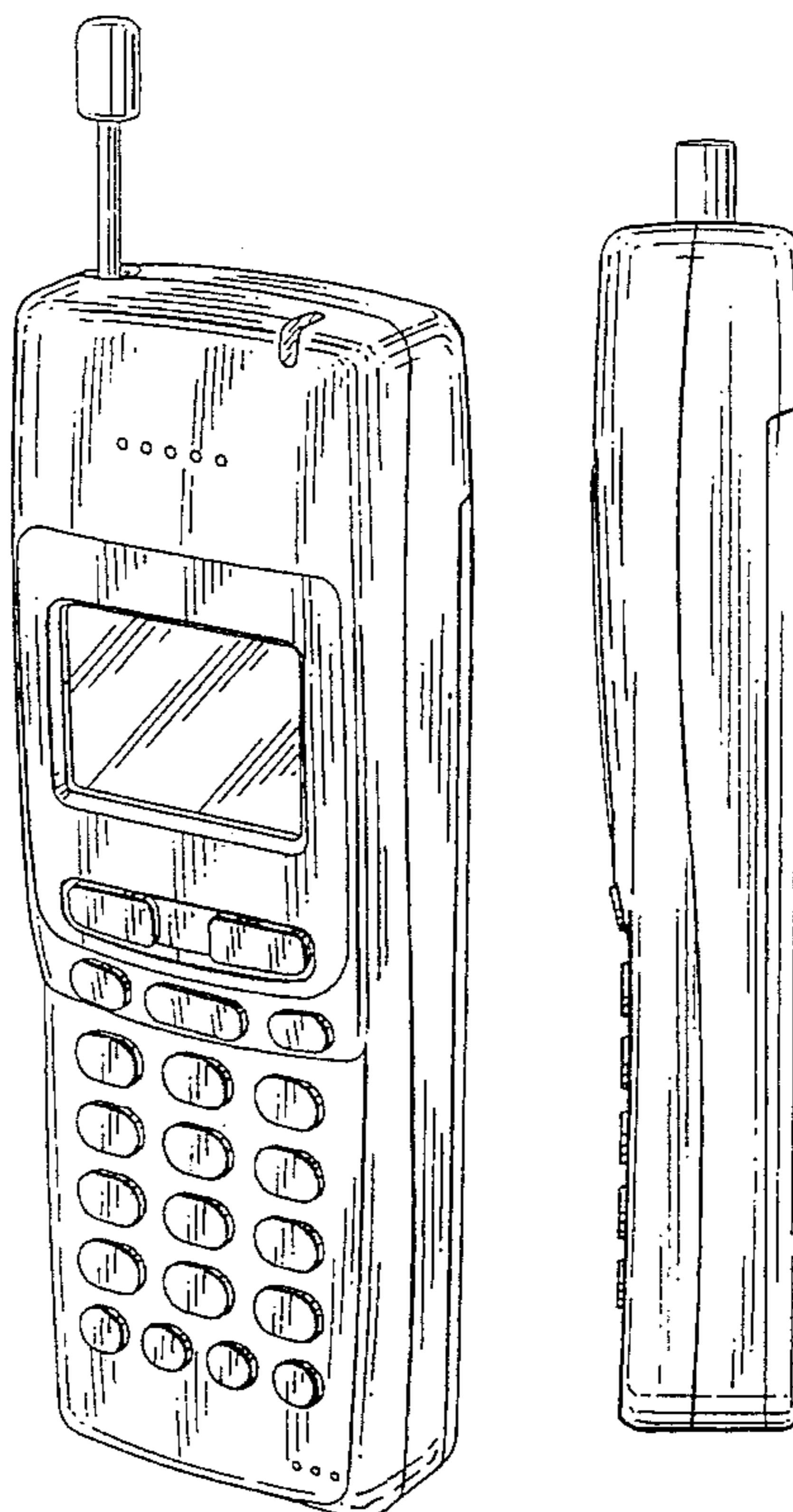

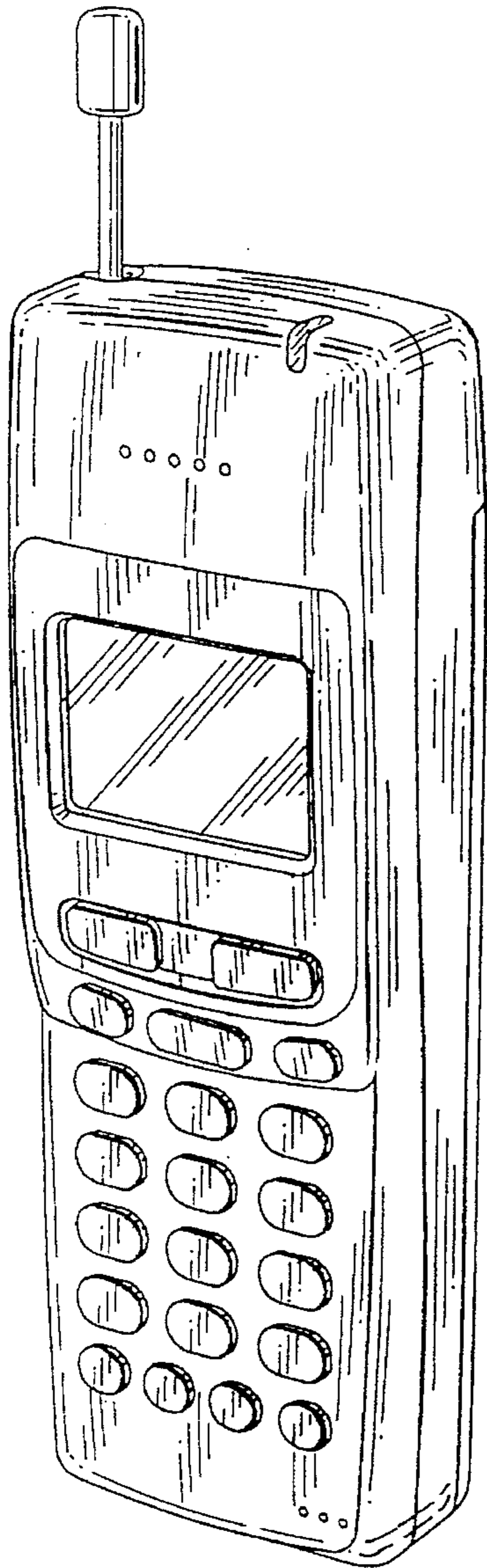

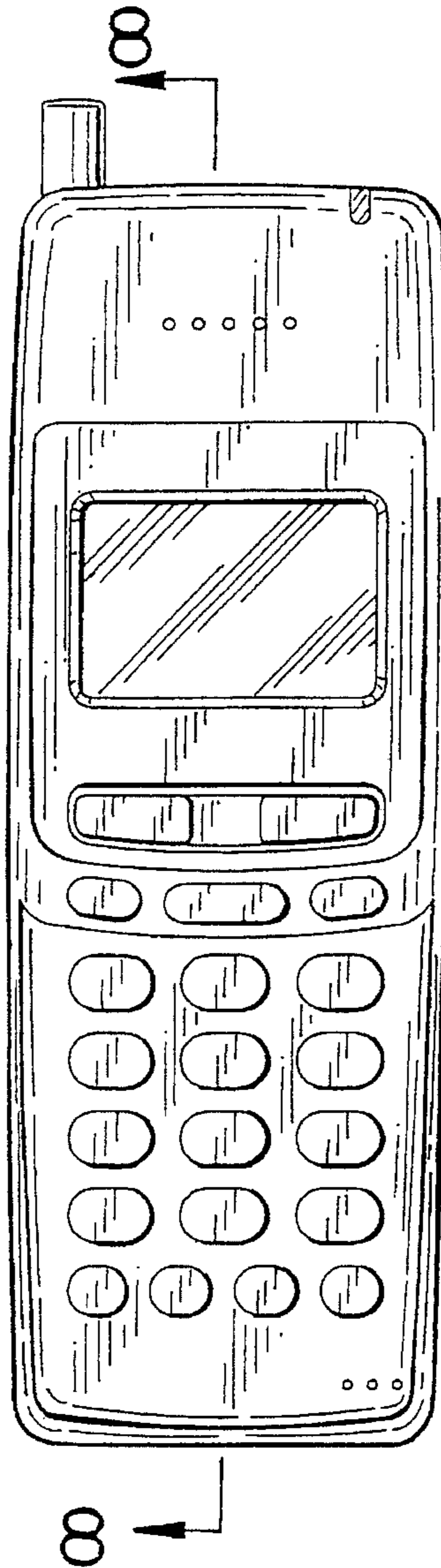

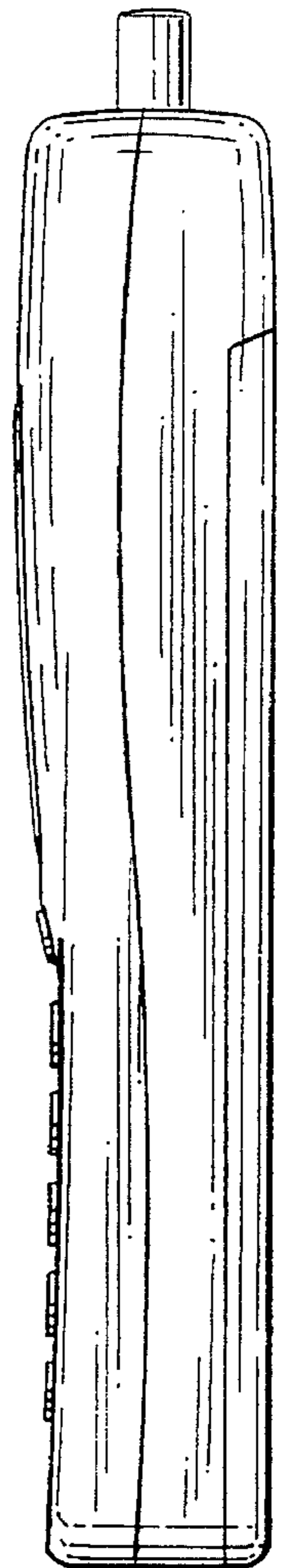

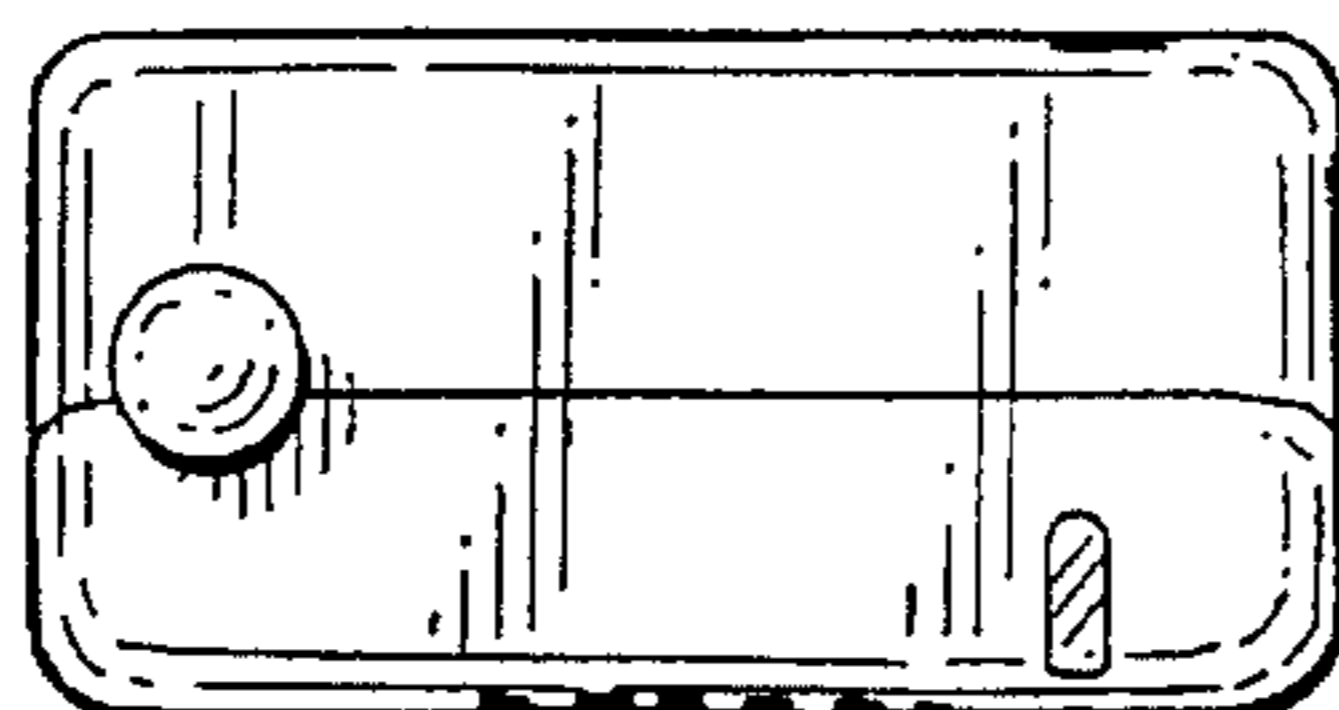

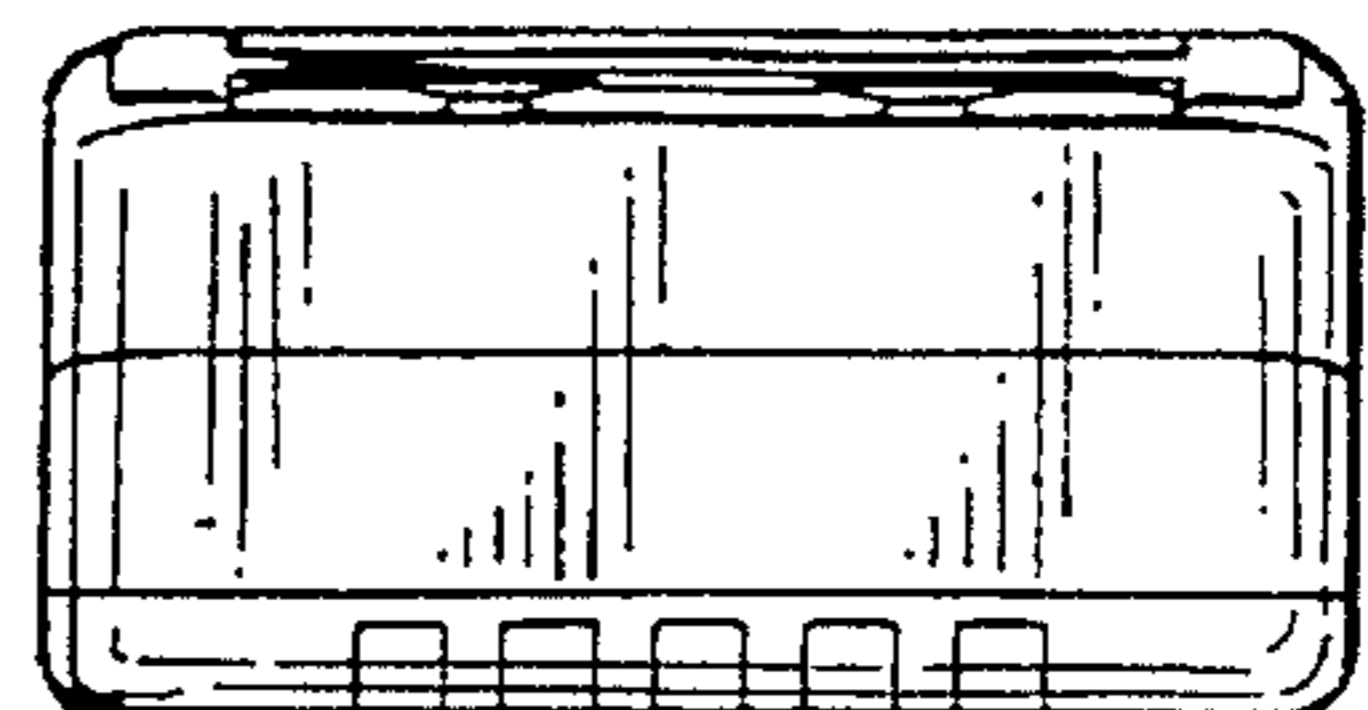

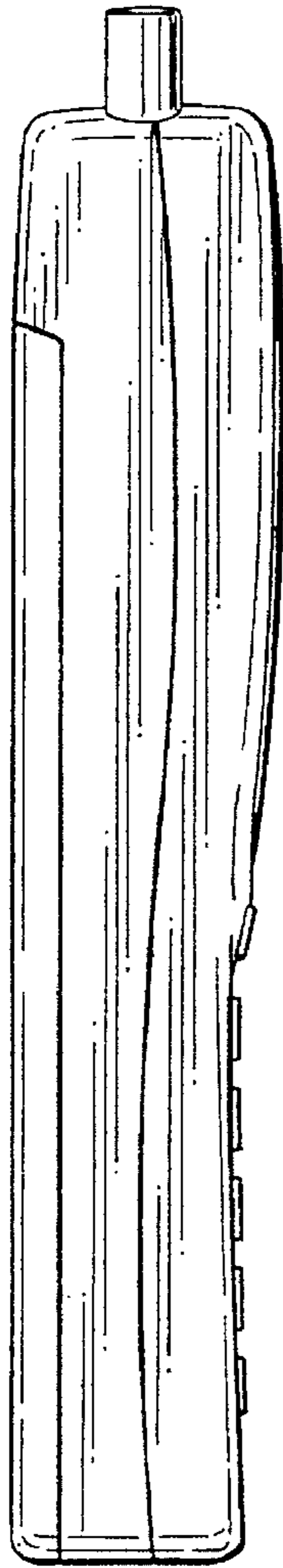

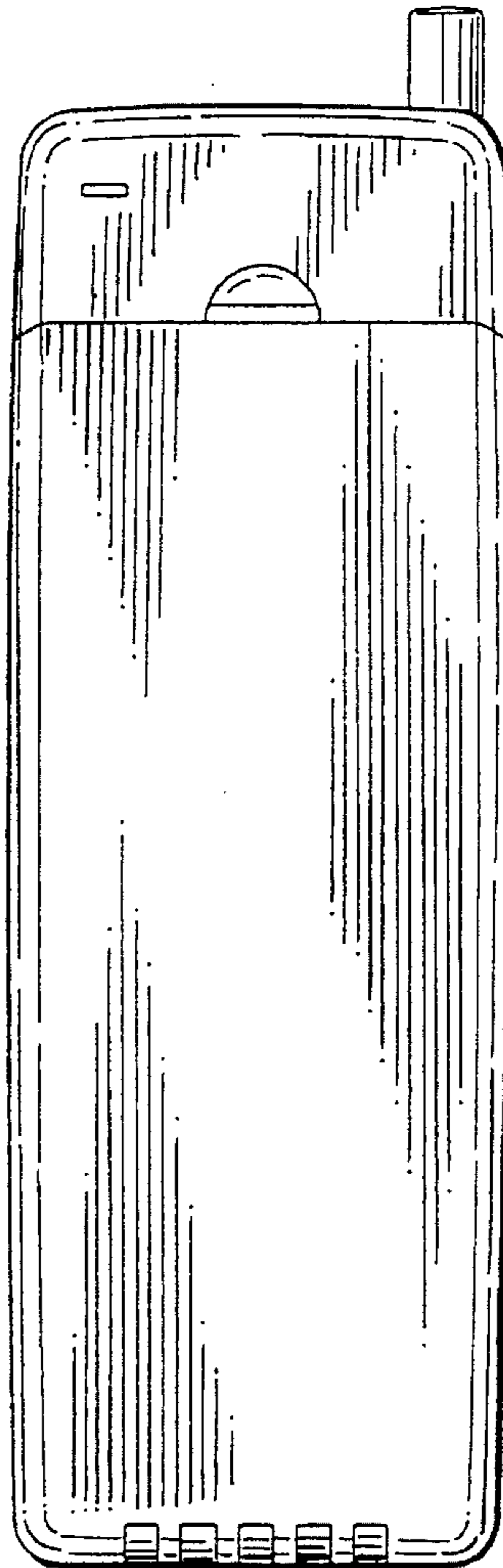
