The ornamental design for a razor handle, as shown and described.

DESCRIPTION

FIG. 1 is a rear elevational view of a razor handle showing my new design;
FIG. 2 is a right side elevational view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a bottom plan view thereof; and
FIG. 6 is a top plan view thereof.

The broken line showing the head and neck portion of a razor is for illustrative purposes only and forms no part of the claimed design.

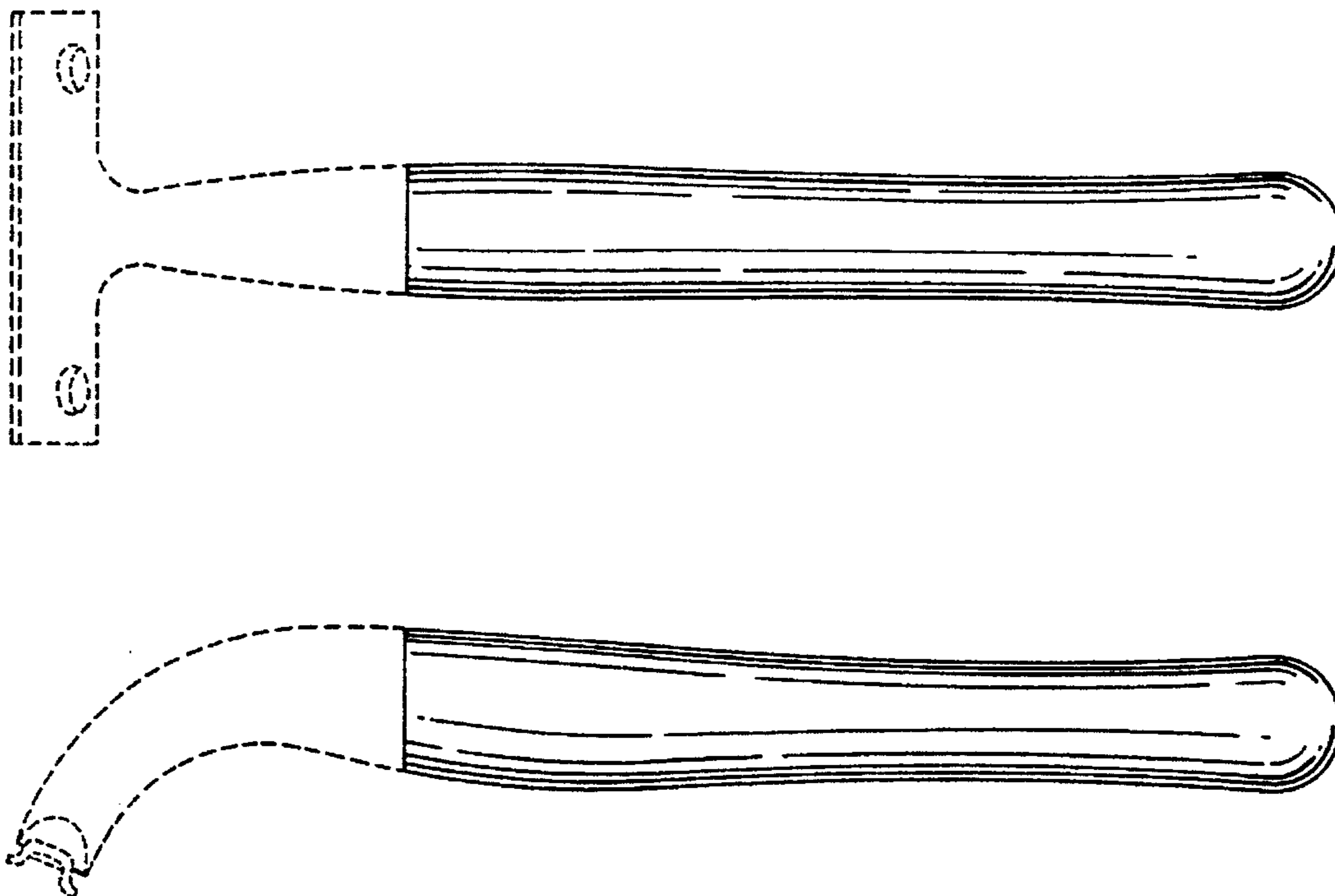

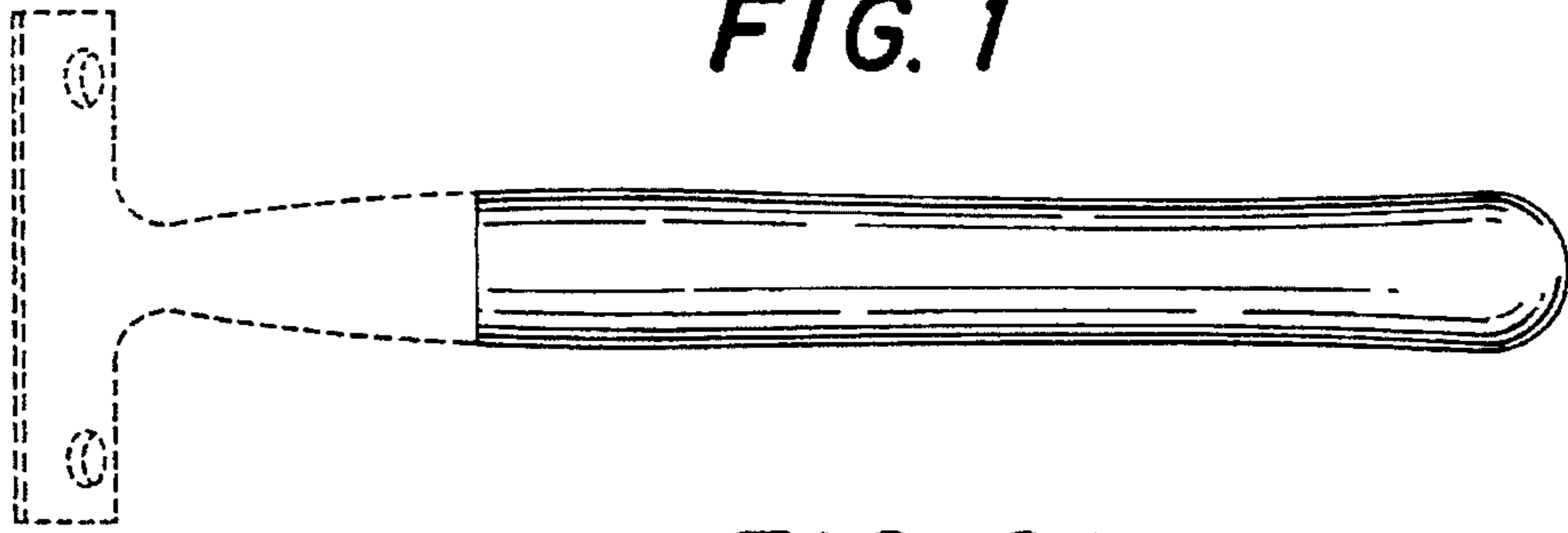

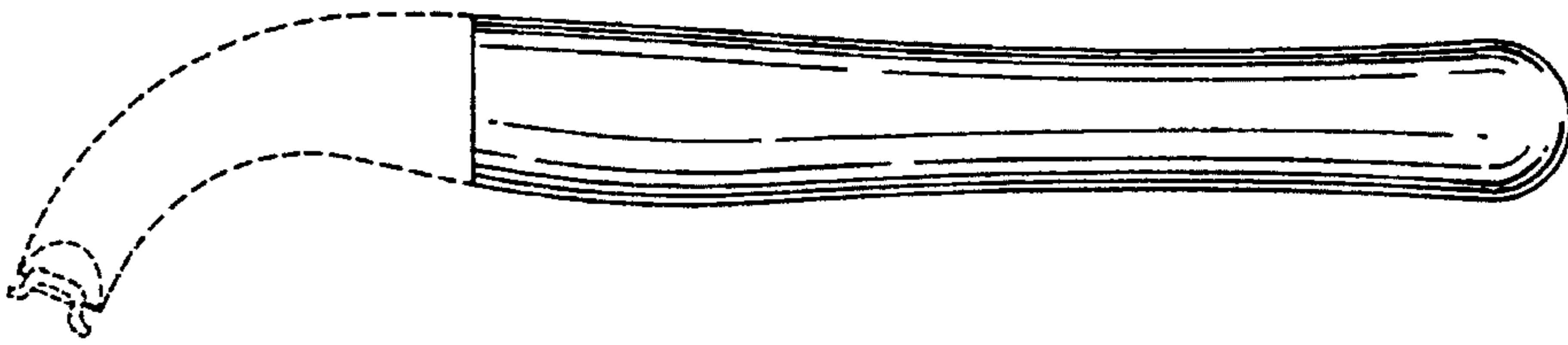

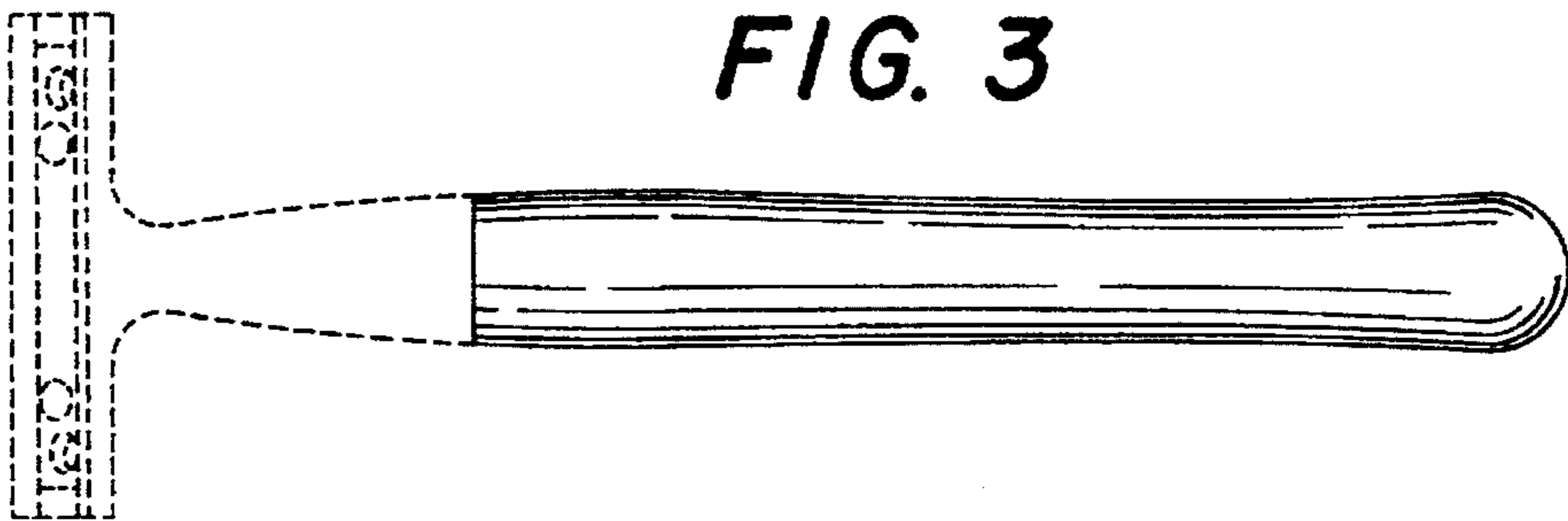

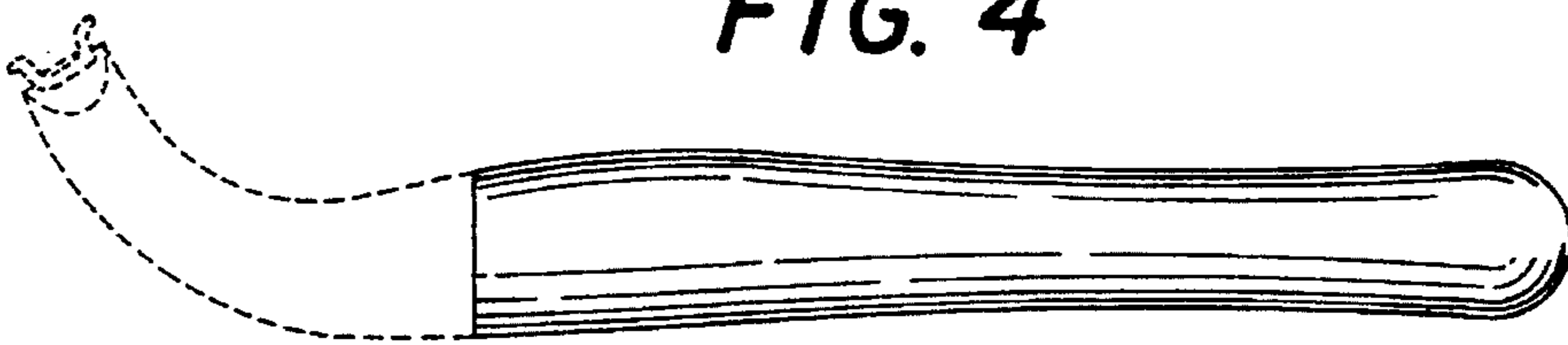

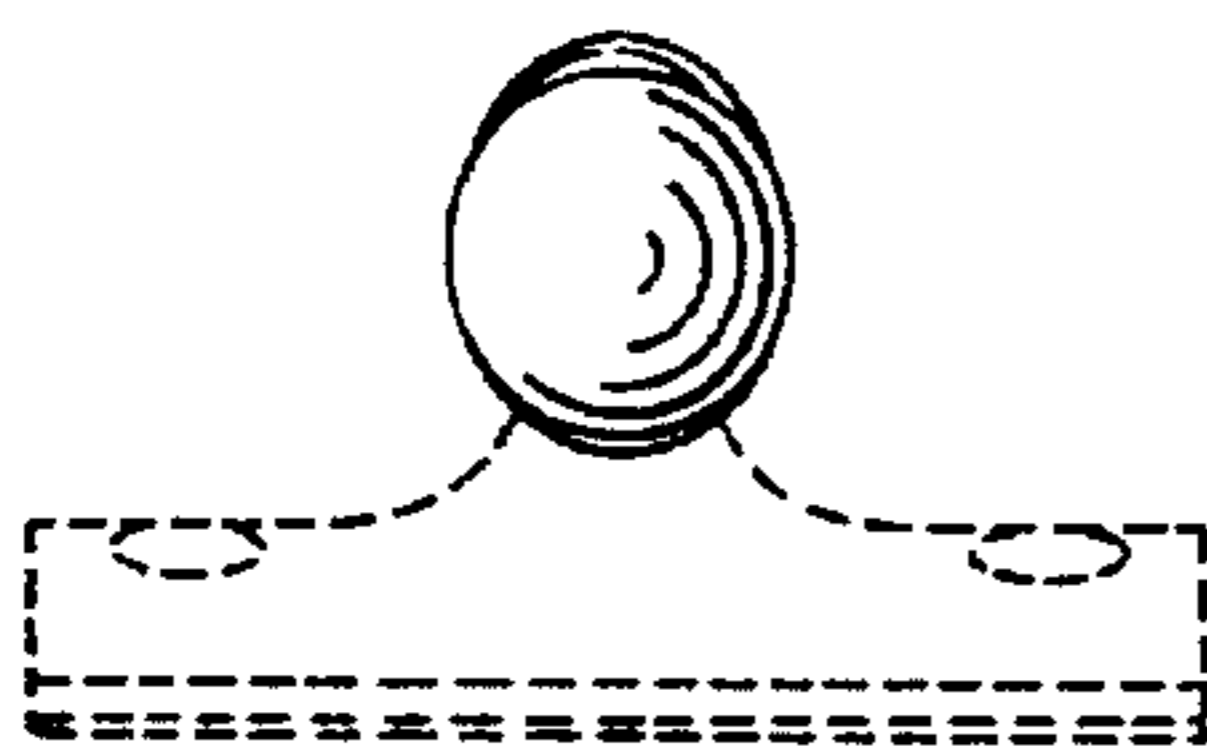
