The ornamental design for a lawn cart, as shown and described.

### **DESCRIPTION**

FIG. 1 is a top right front perspective view of a lawn cart showing our new design. The broken lines are for illustrative purposes only and form no part of the claimed design;

FIG. 2 is a front elevational view thereof; the rear elevational view being a mirror image;

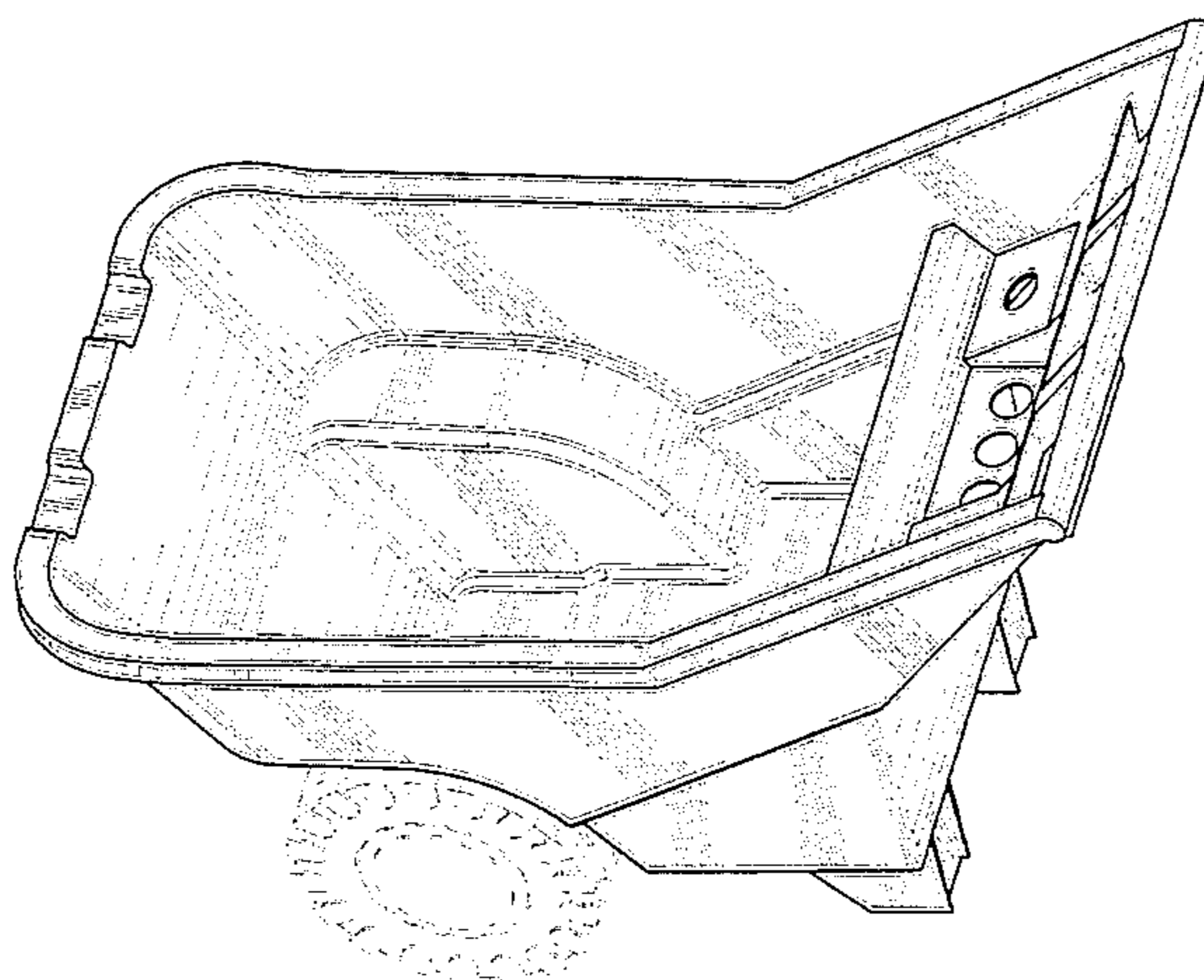
FIG. 3 is a top plan view thereof;

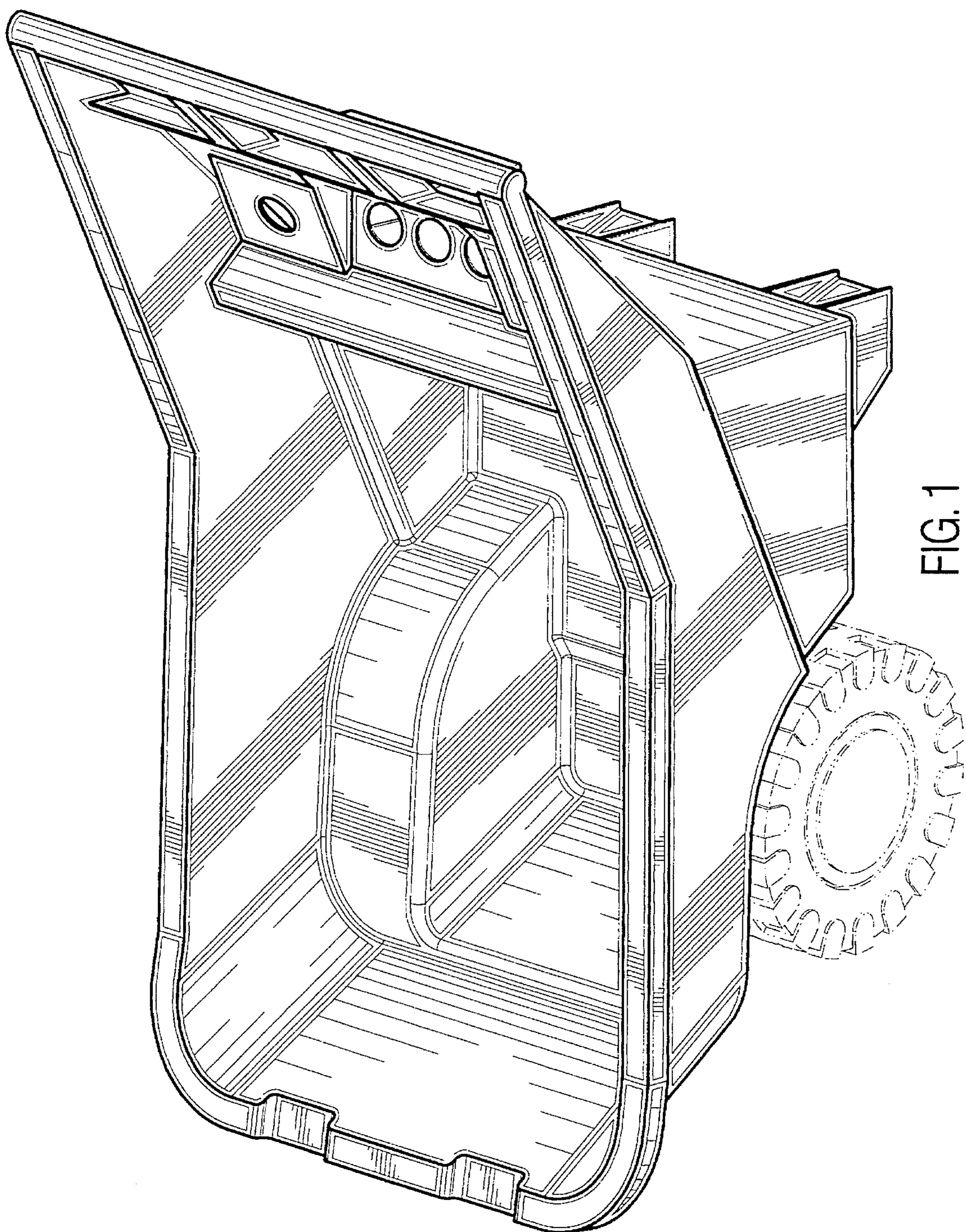

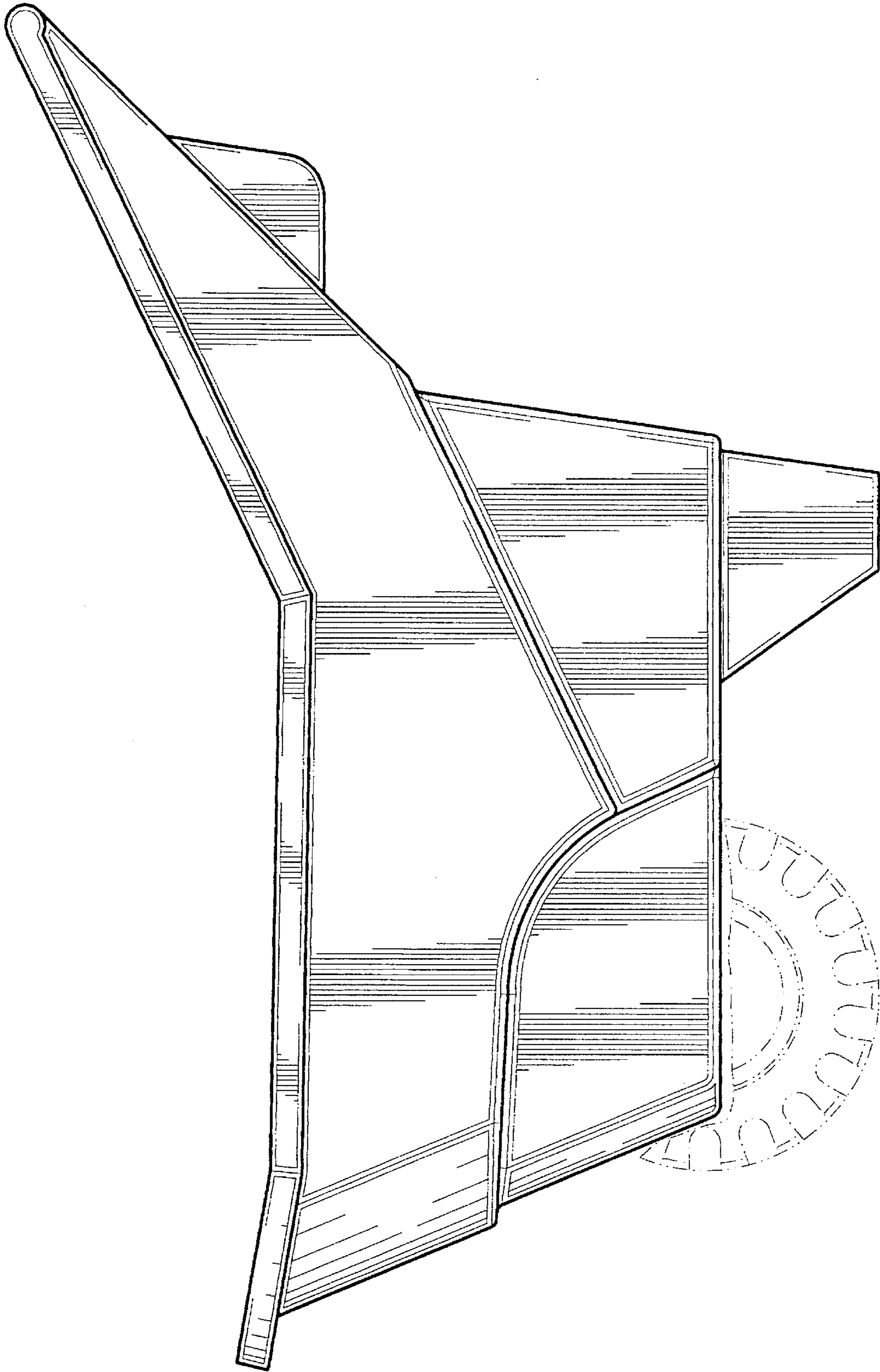

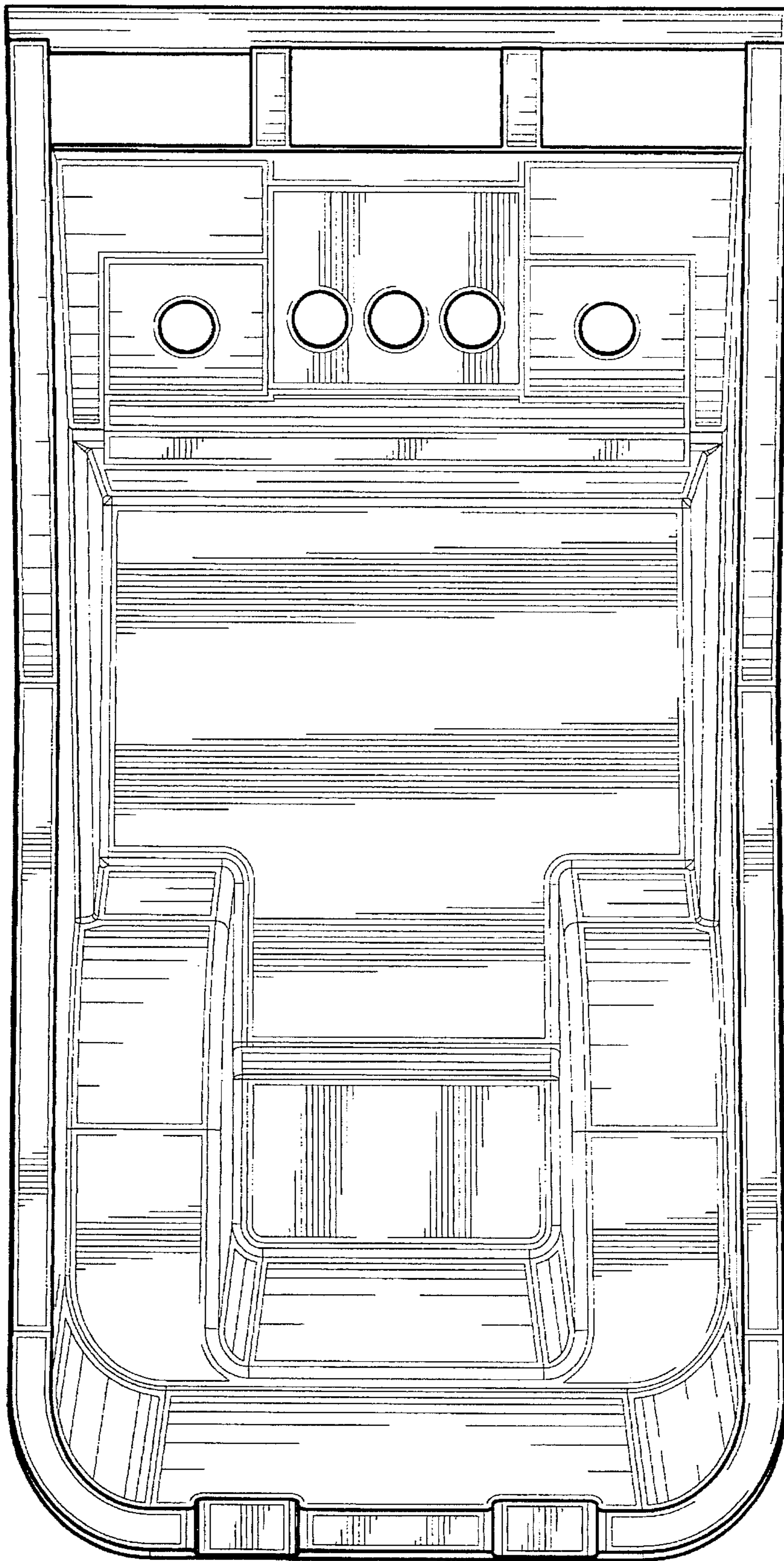

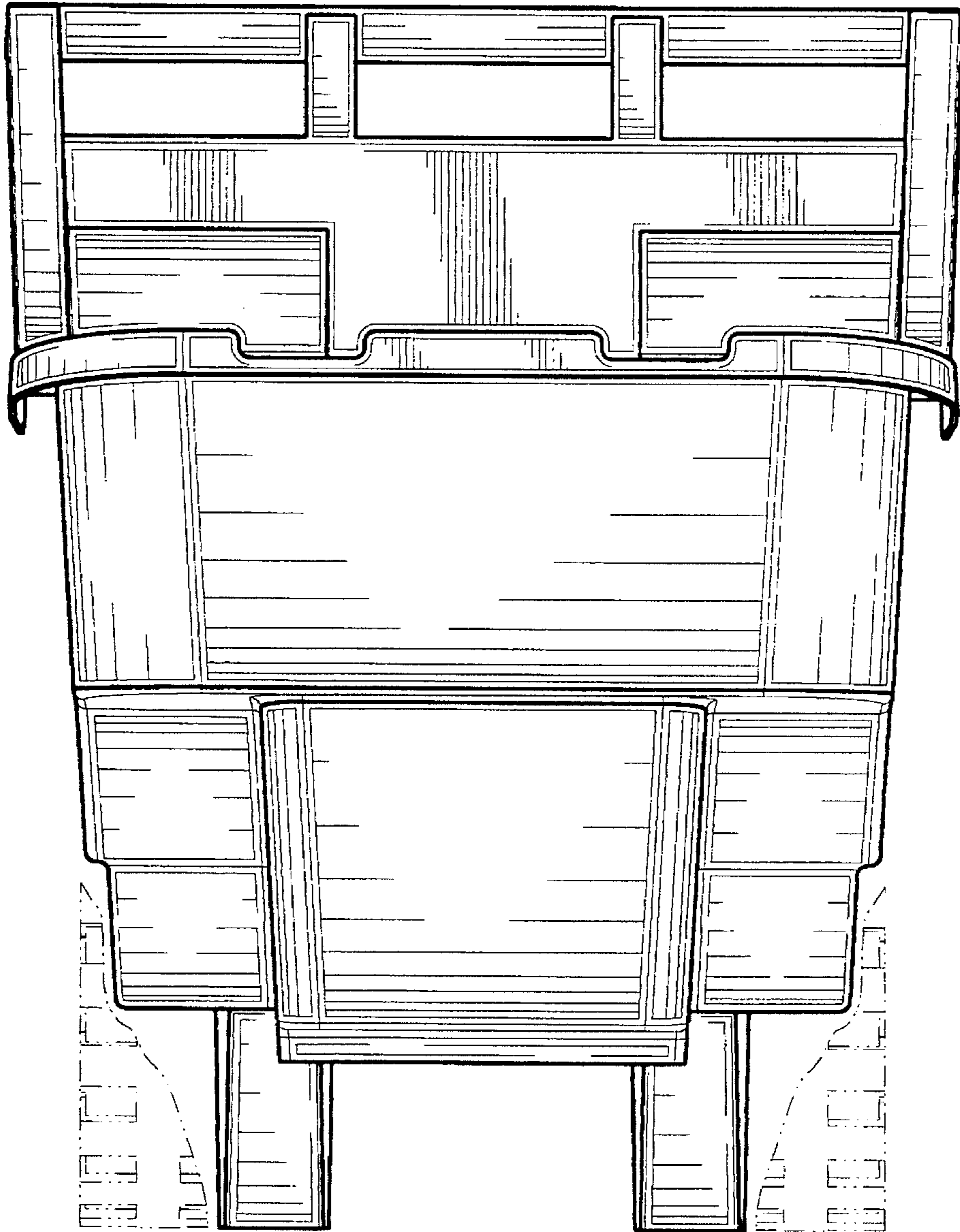

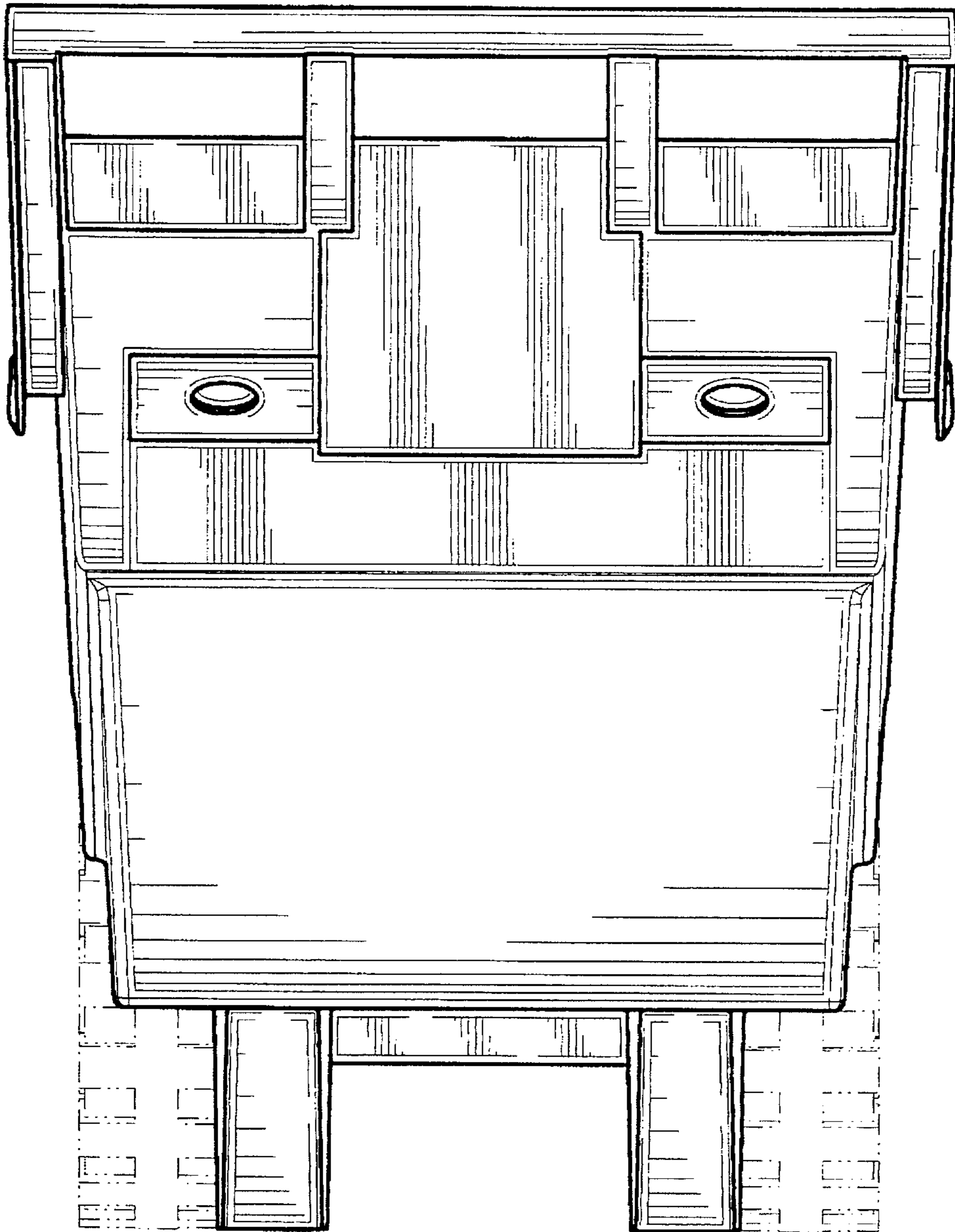

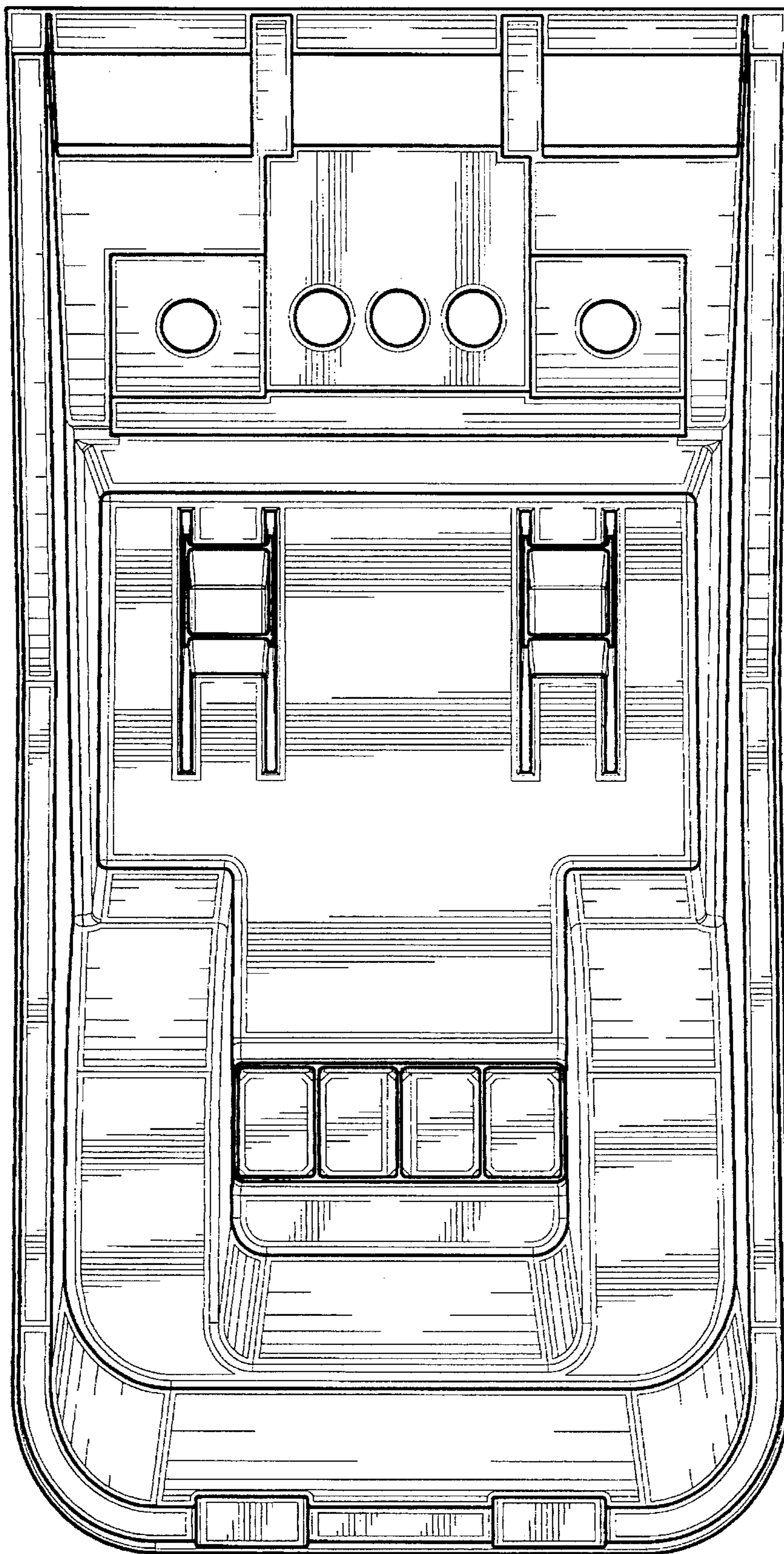
