FIG. 5 left side elevational view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a top plan view thereof;

FIG. 8 is a bottom plan view thereof, the broken line showing of the closure for the top opening of the crown is for illustrative purposes and forms no part of the claimed design; and,

FIG. 9 is a right side elevational view thereof.

The characteristic feature of our design resides in the specific ornamentation of the opening on the top of the hat in combination with interior pocket as best illustrated in FIG. 1 of the drawing.

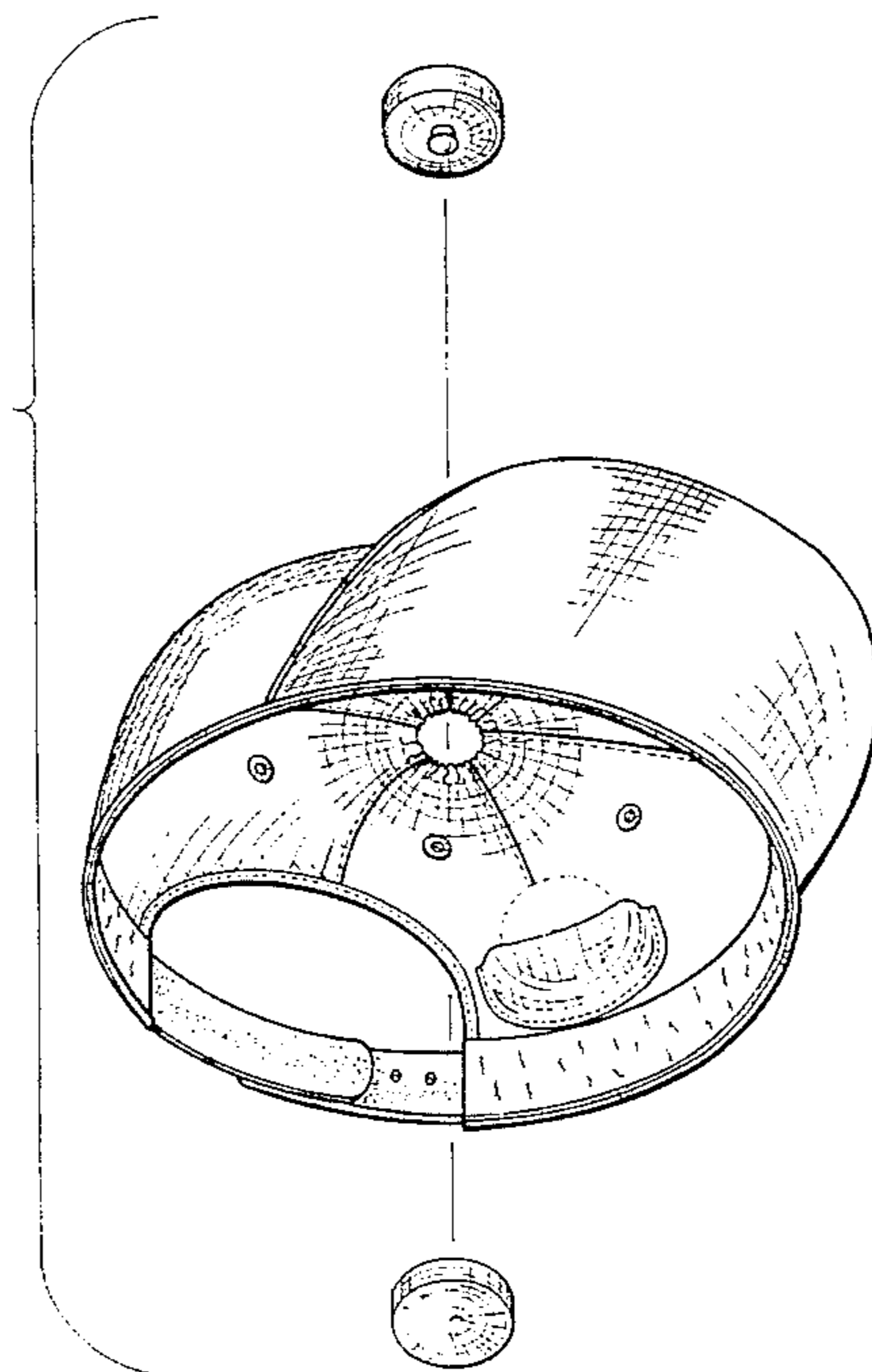

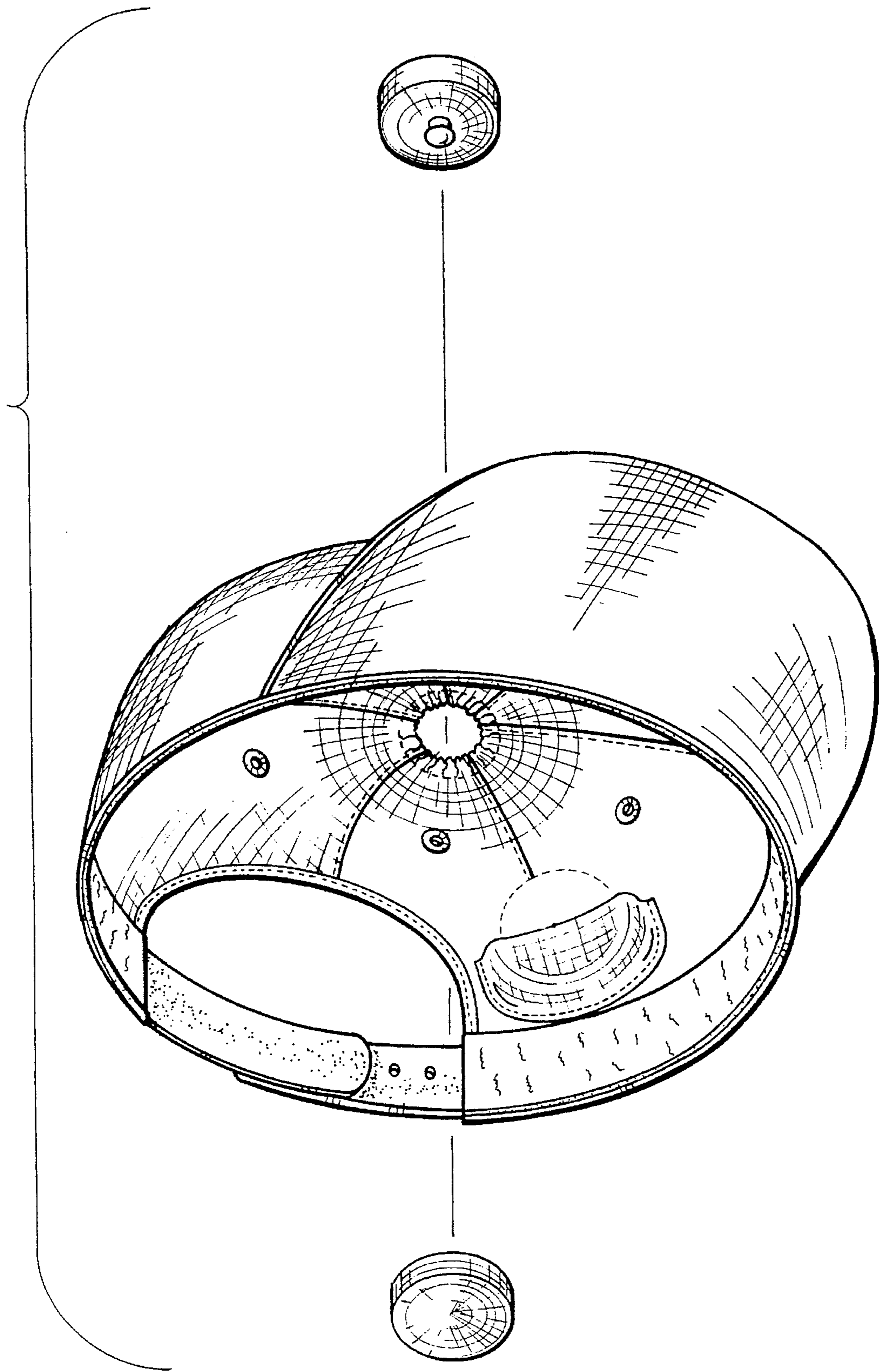

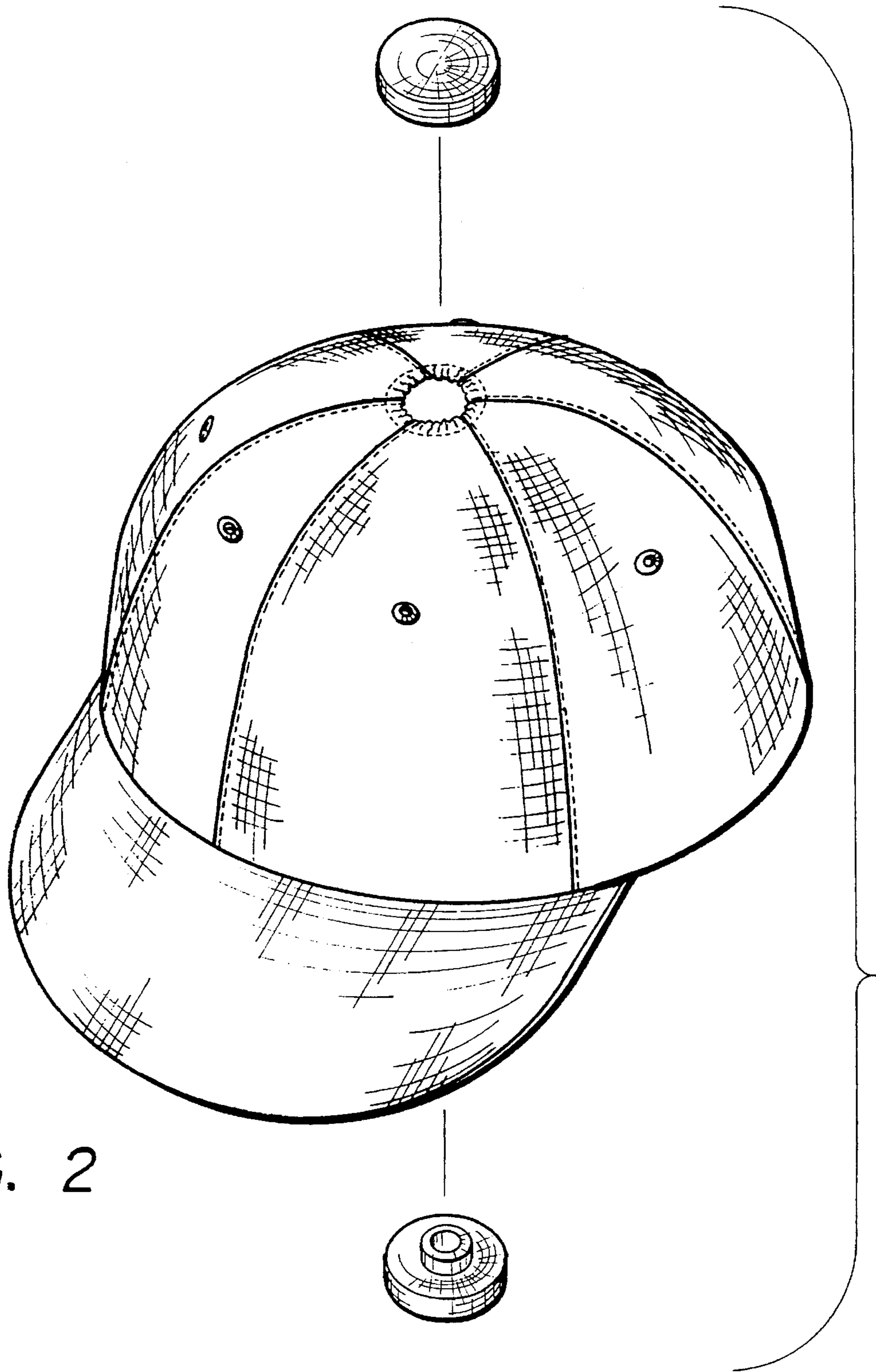

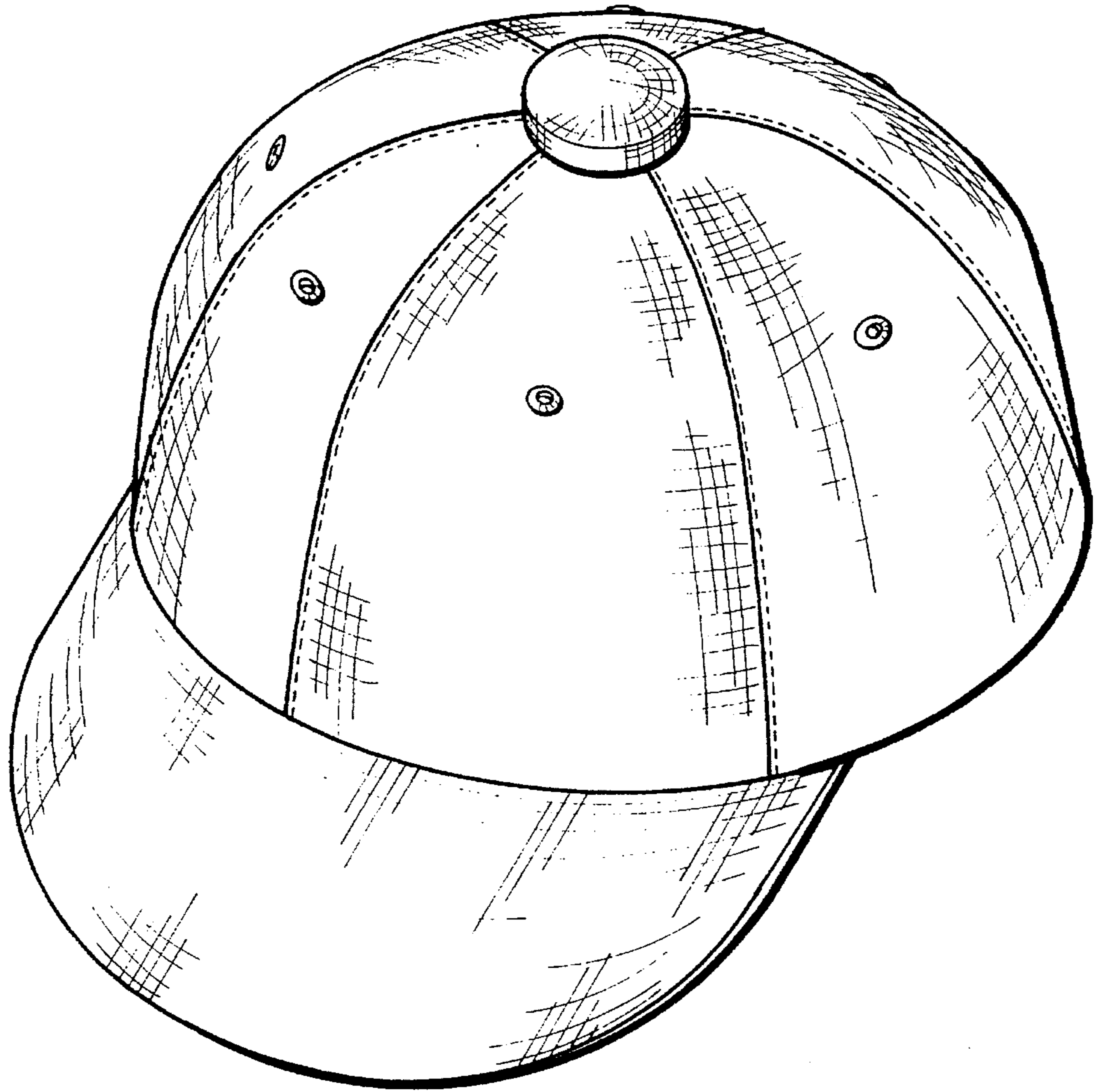

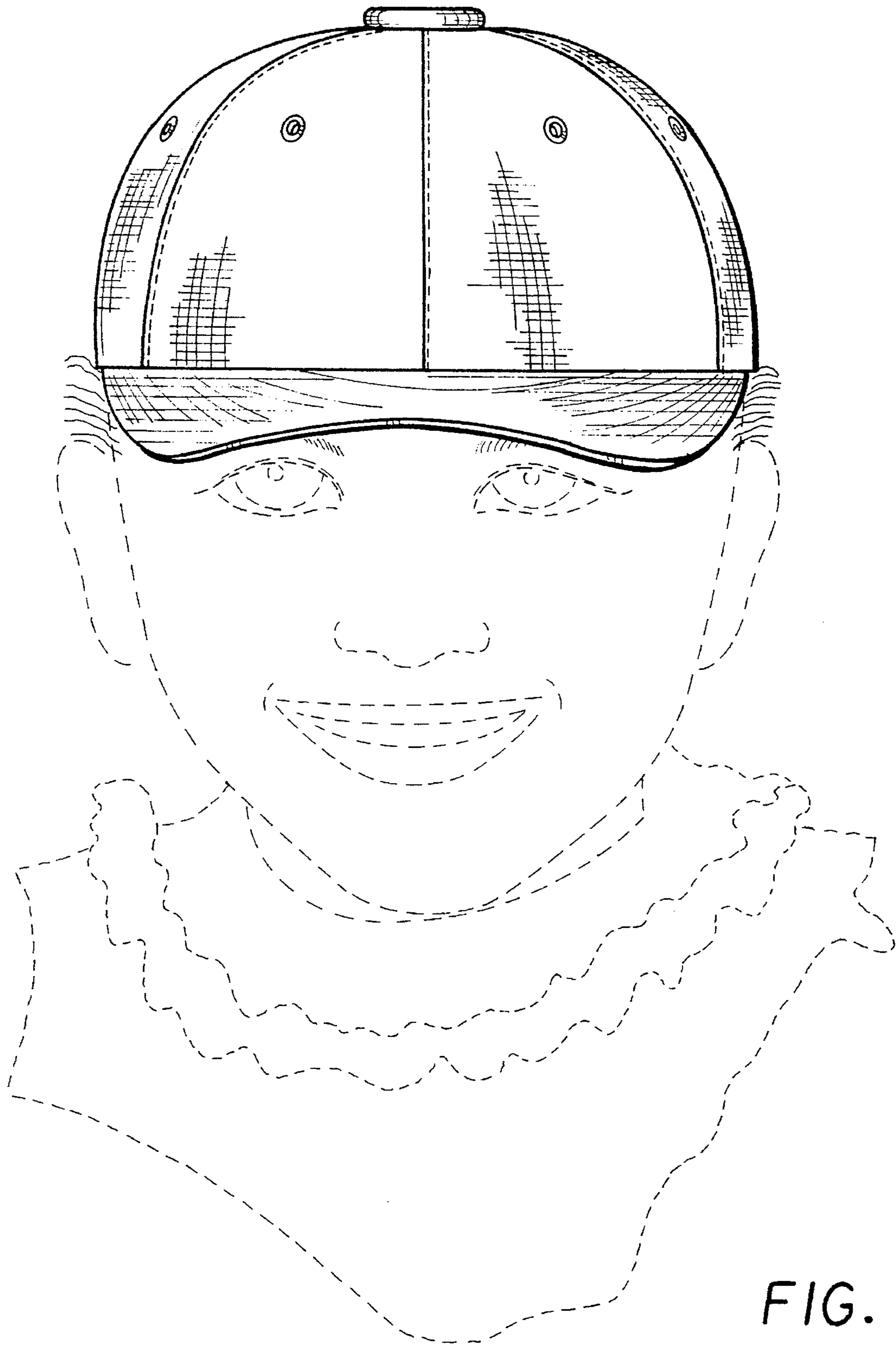

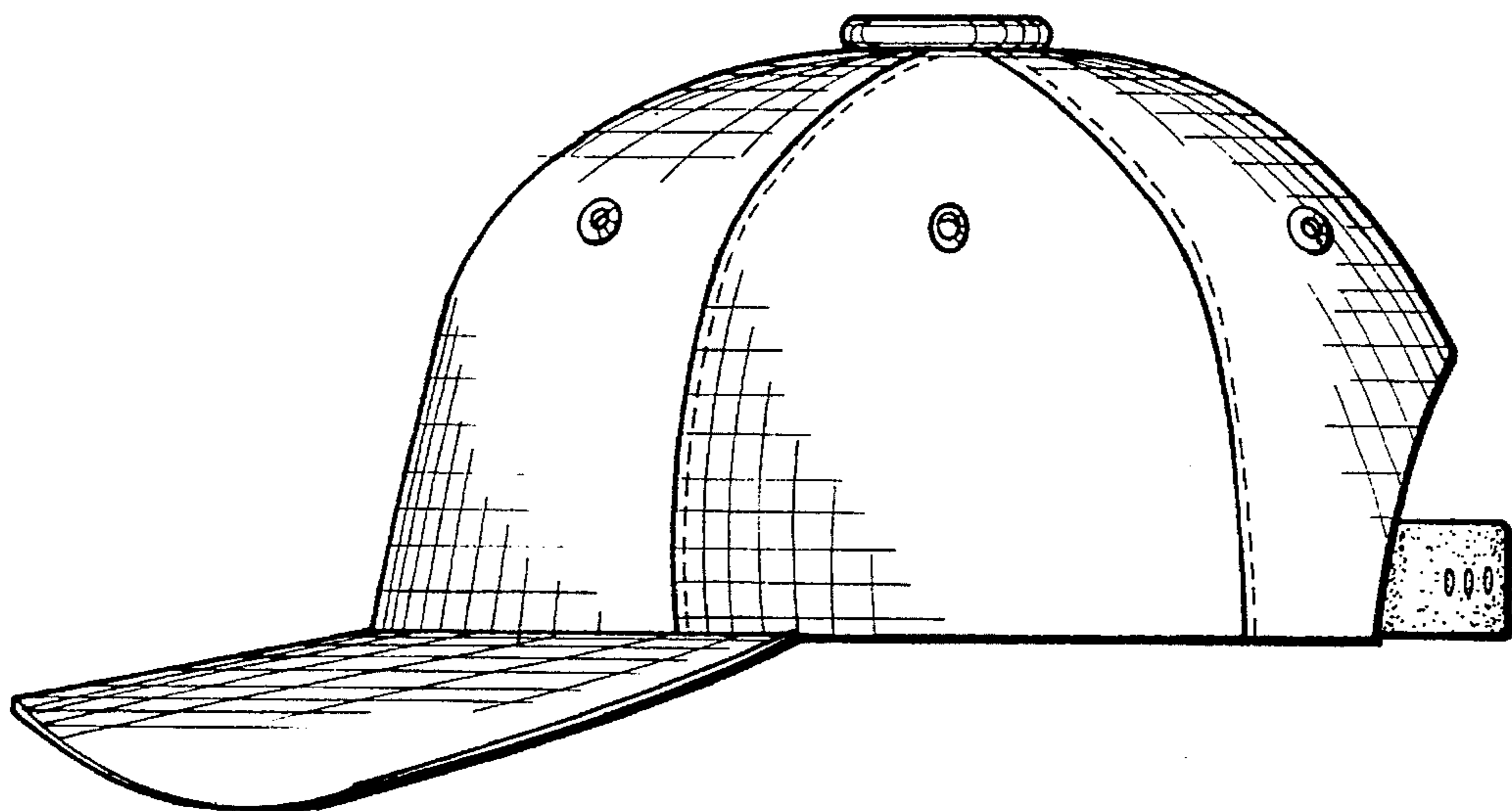

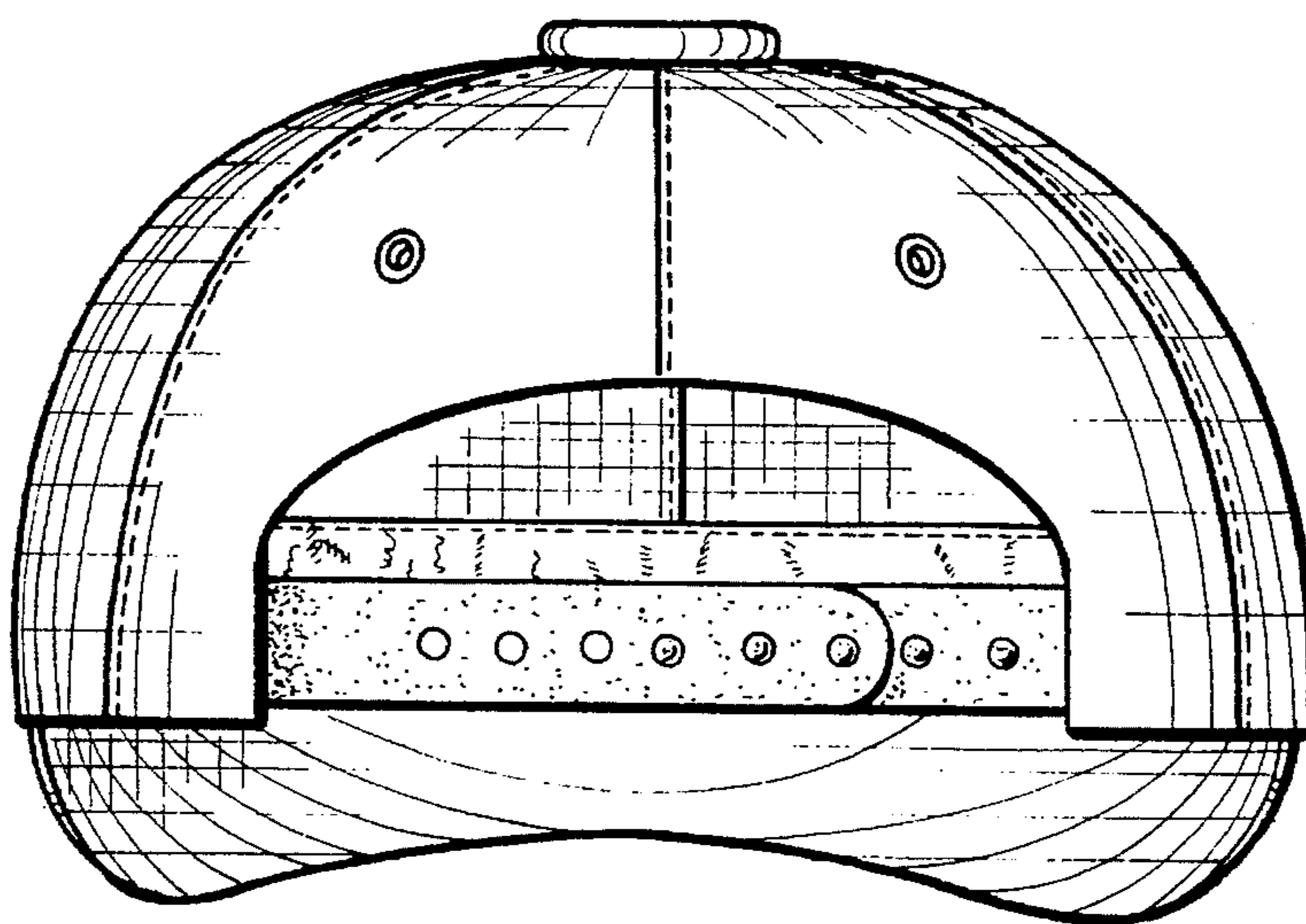

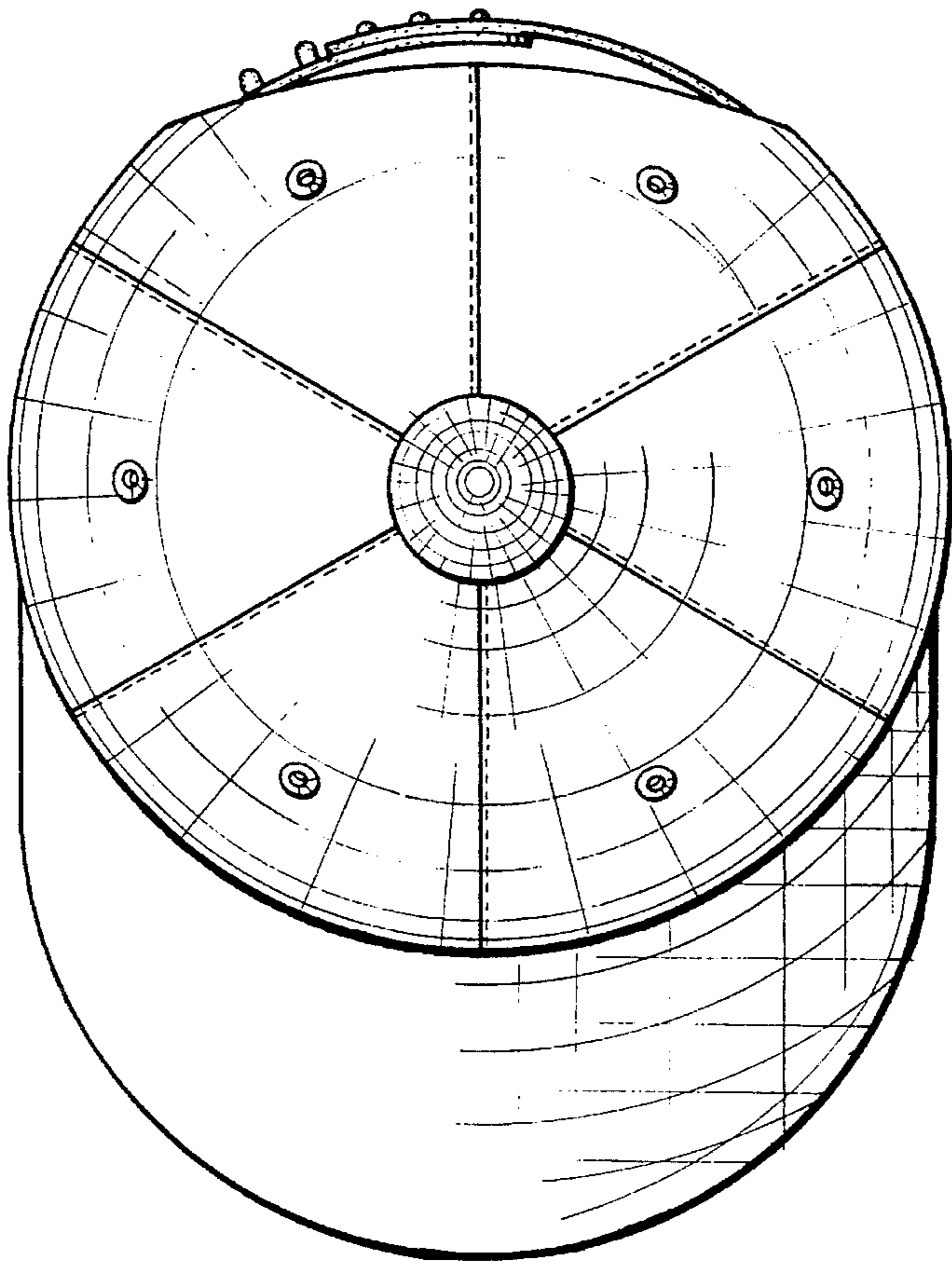

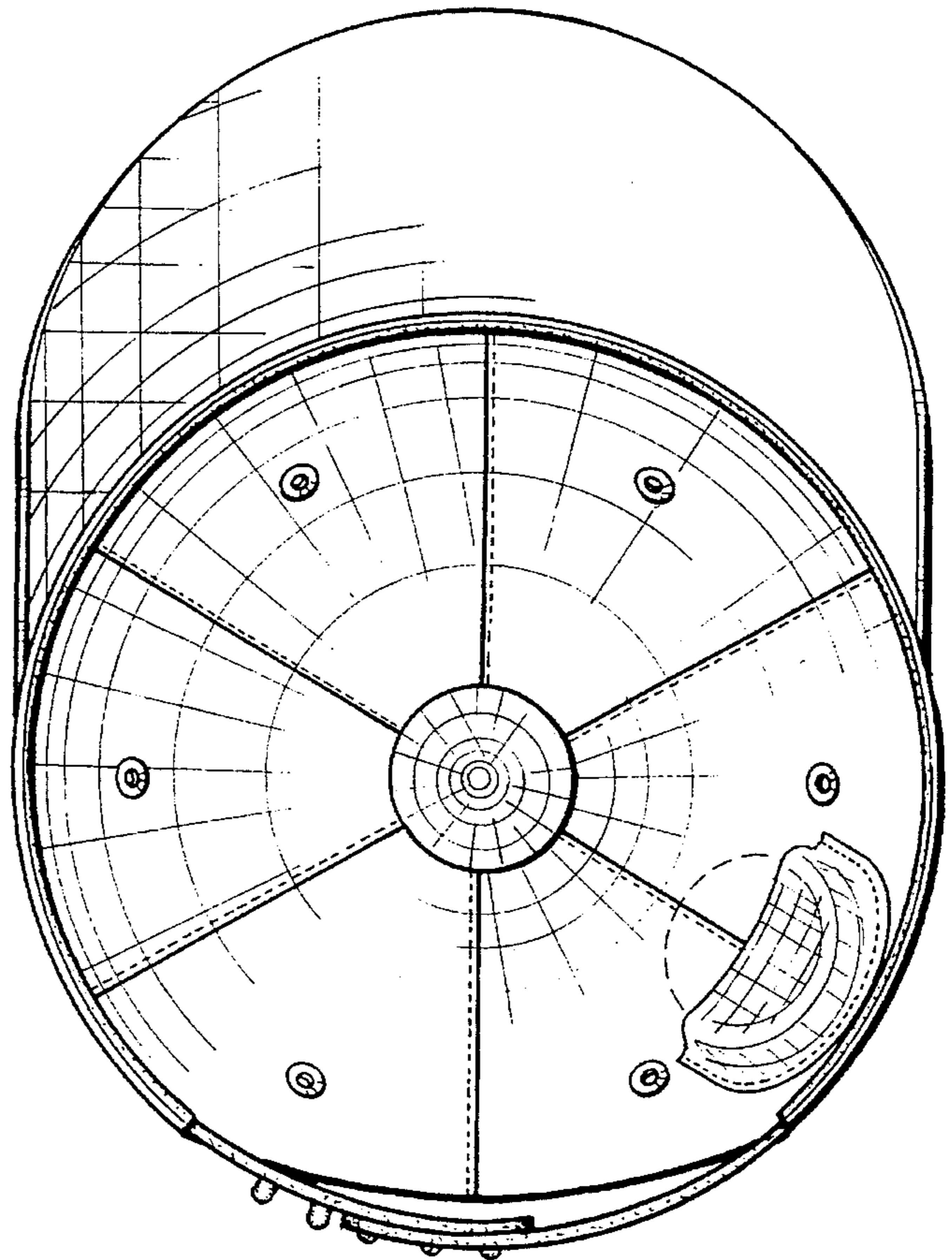

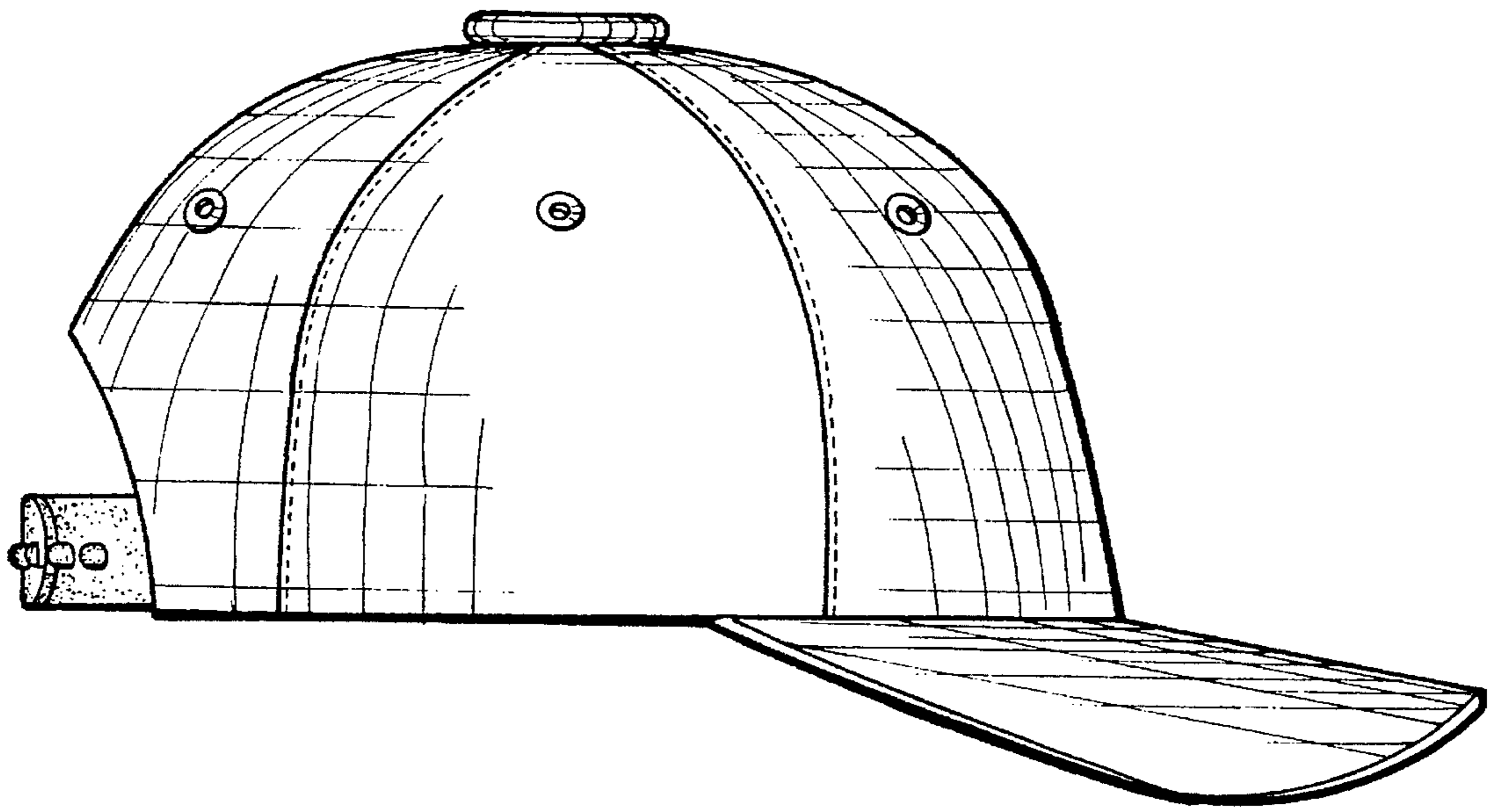
