DESCRIPTION

FIG. 1 is a front elevational view of a bed frame holster clip showing my new design the broken line showing of the bed frame and holstered gun is for illustrative purposes only and forms no part of the claimed design;

FIG. 2 is a left side elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a front elevational view of a second embodiment of bed frame holster clip showing my new design, the only difference being the rotation of the facing clip member, broken line showing of the bed frame and holstered gun is for illustrative purposes only and forms no part of the claimed design;

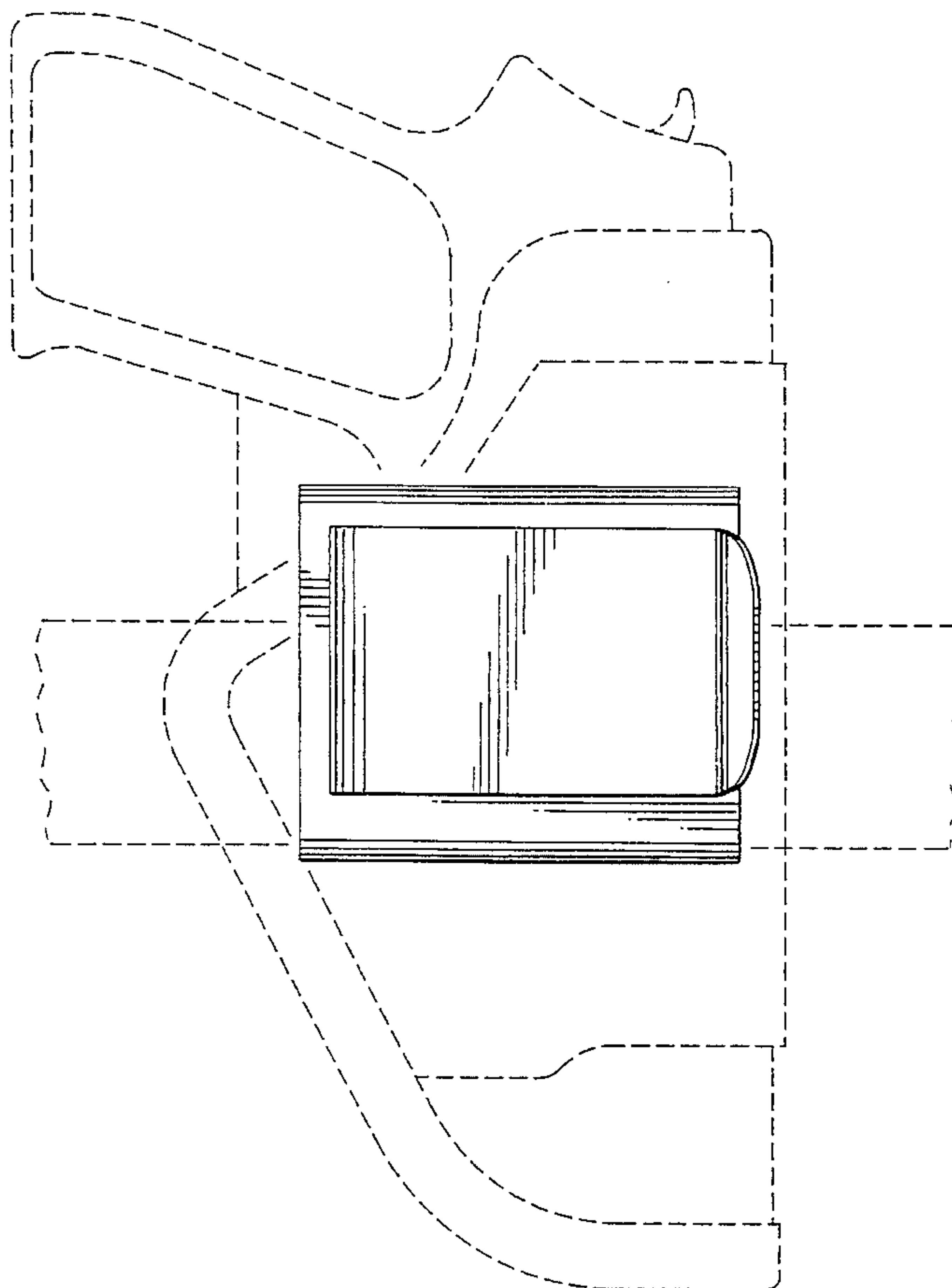
FIG. 8 is a left side elevational view thereof;

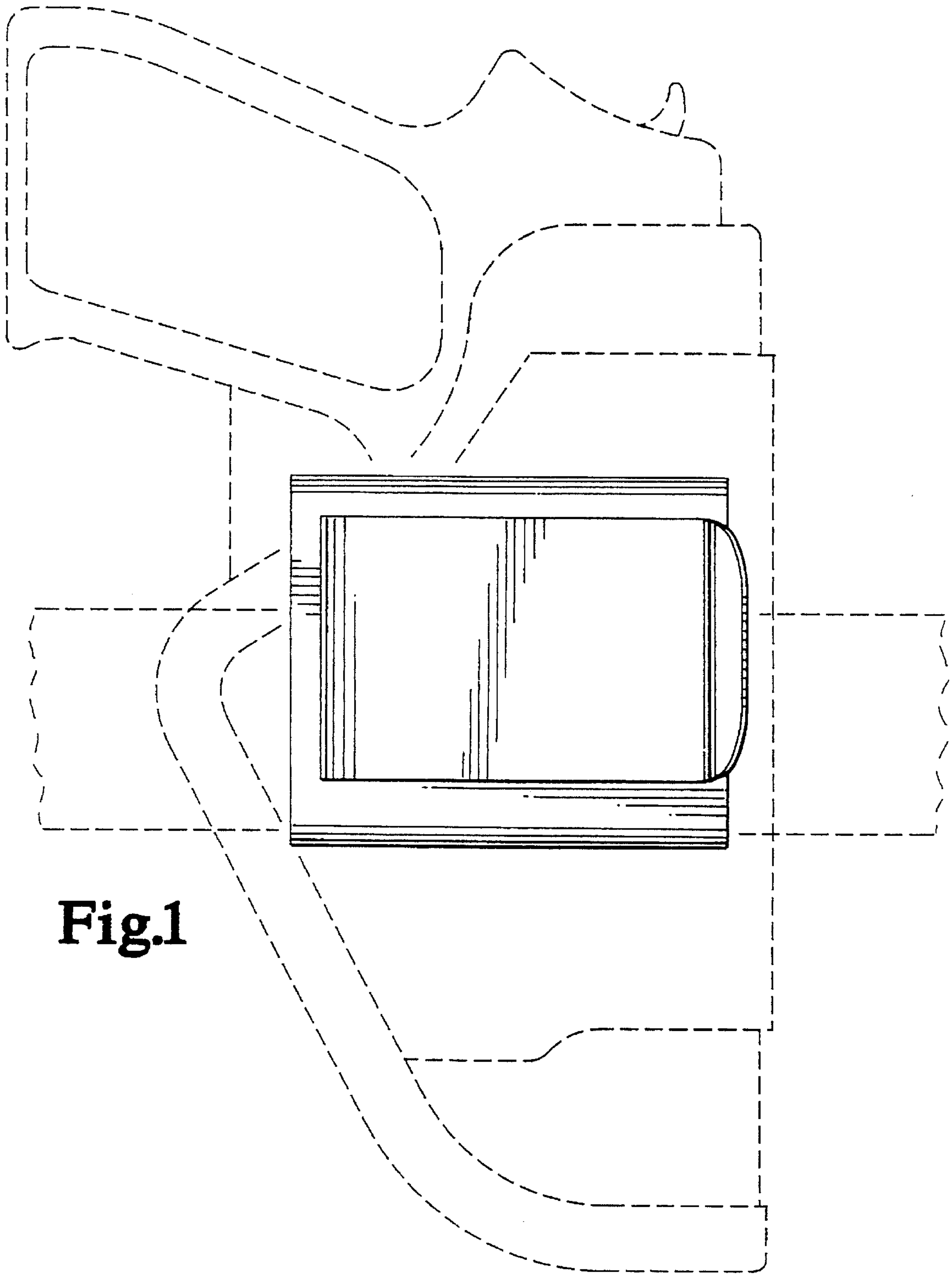

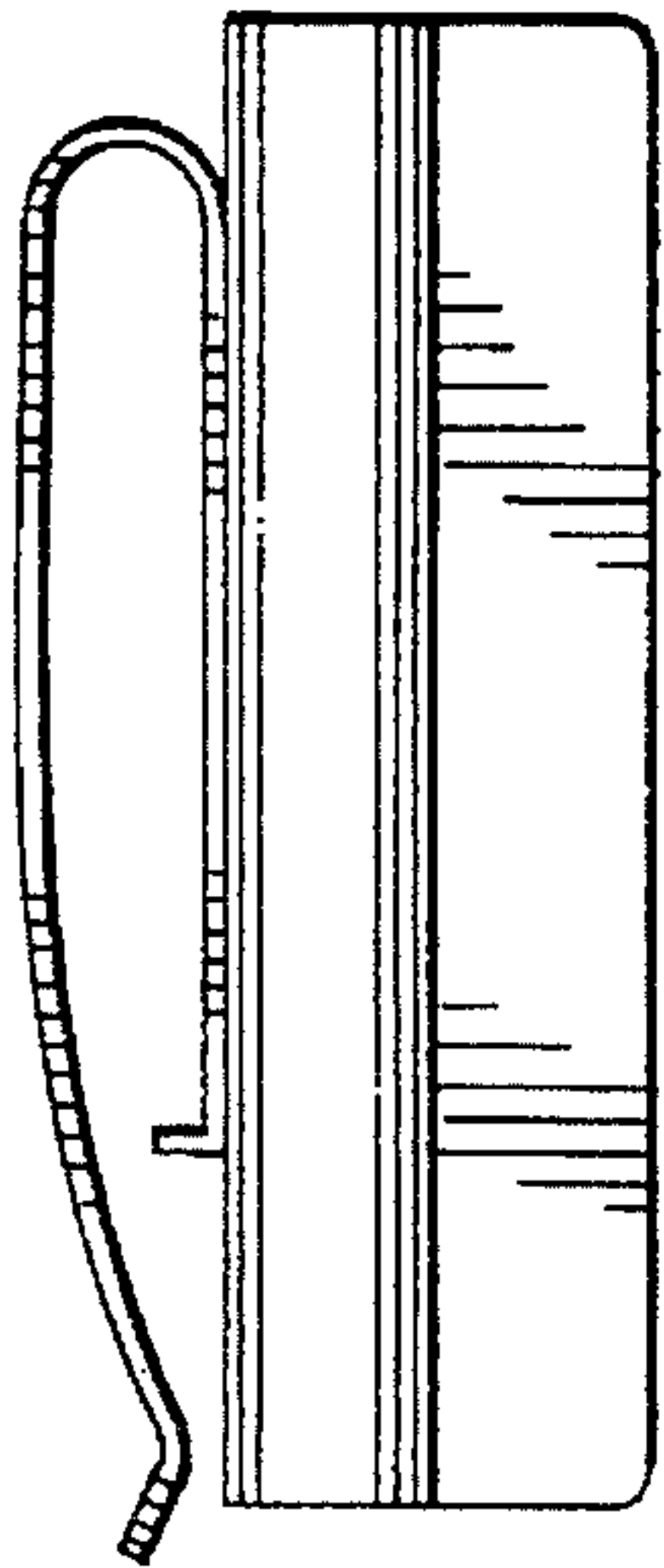

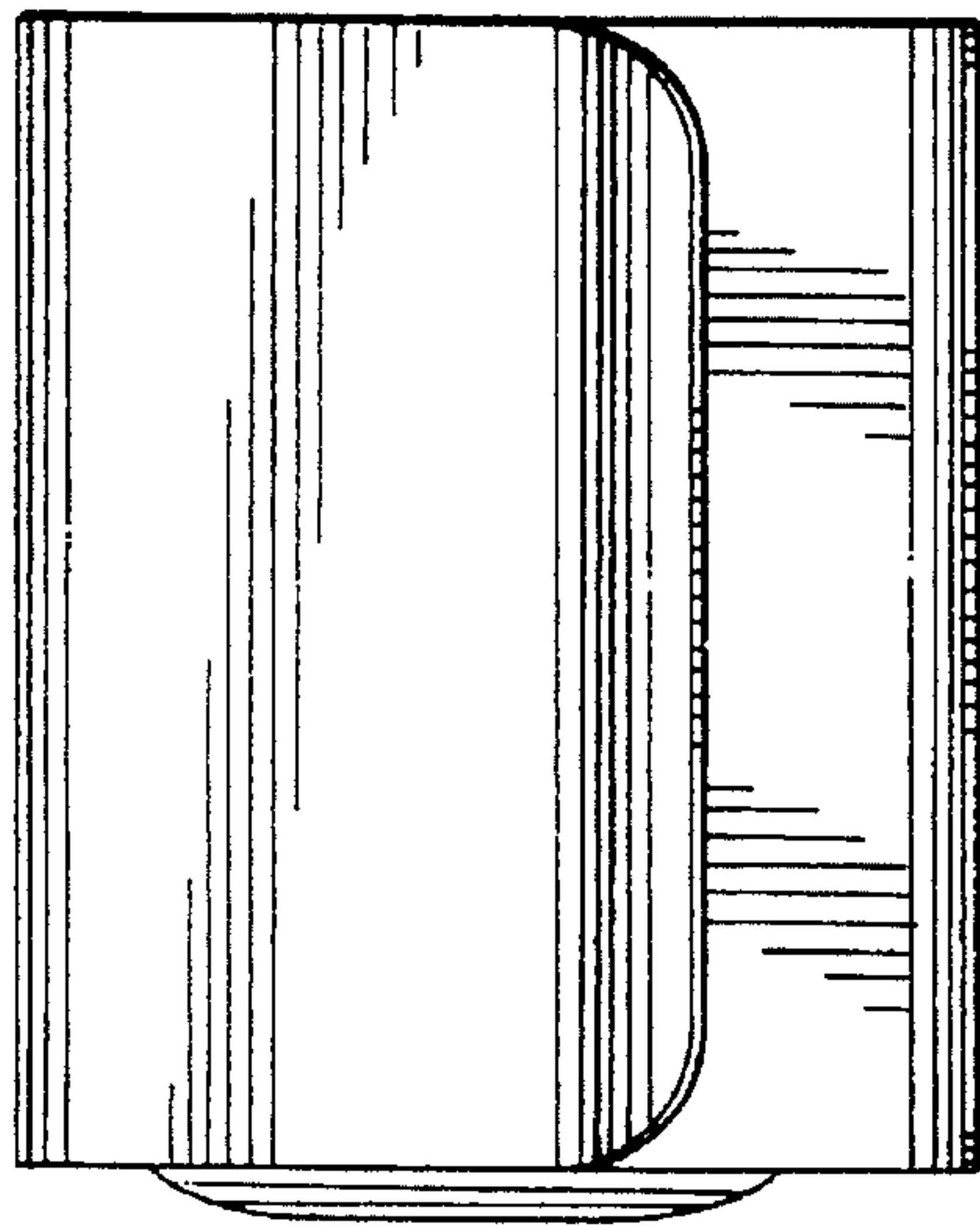

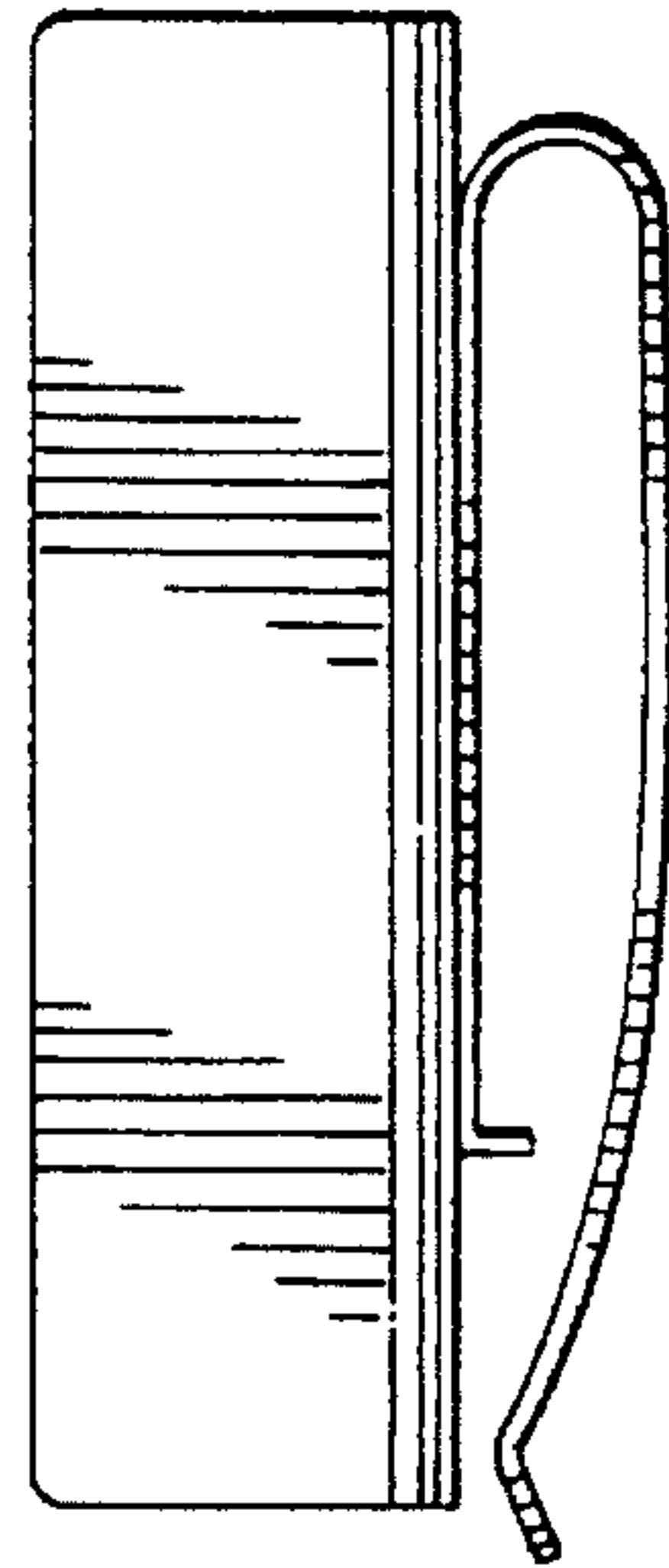

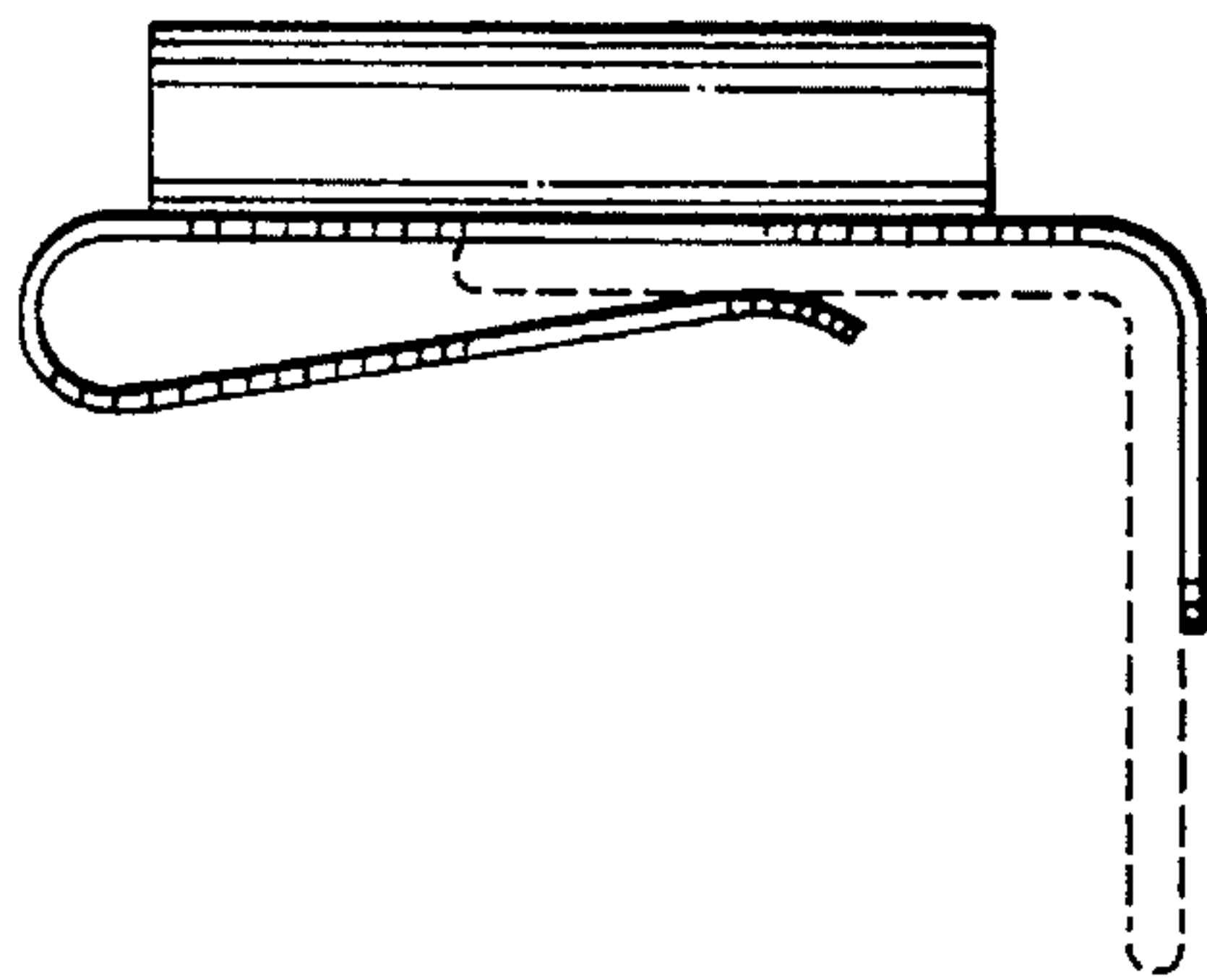

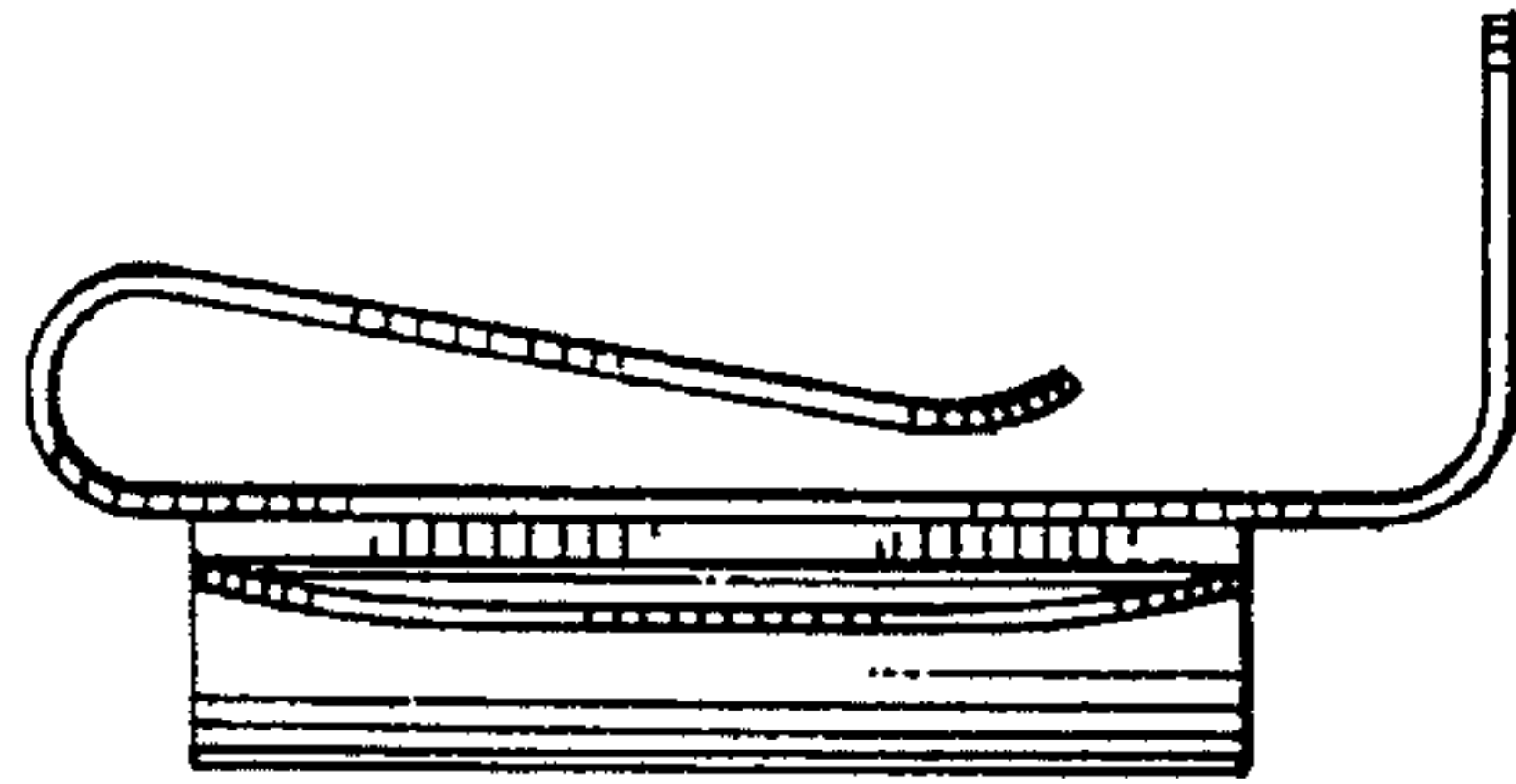

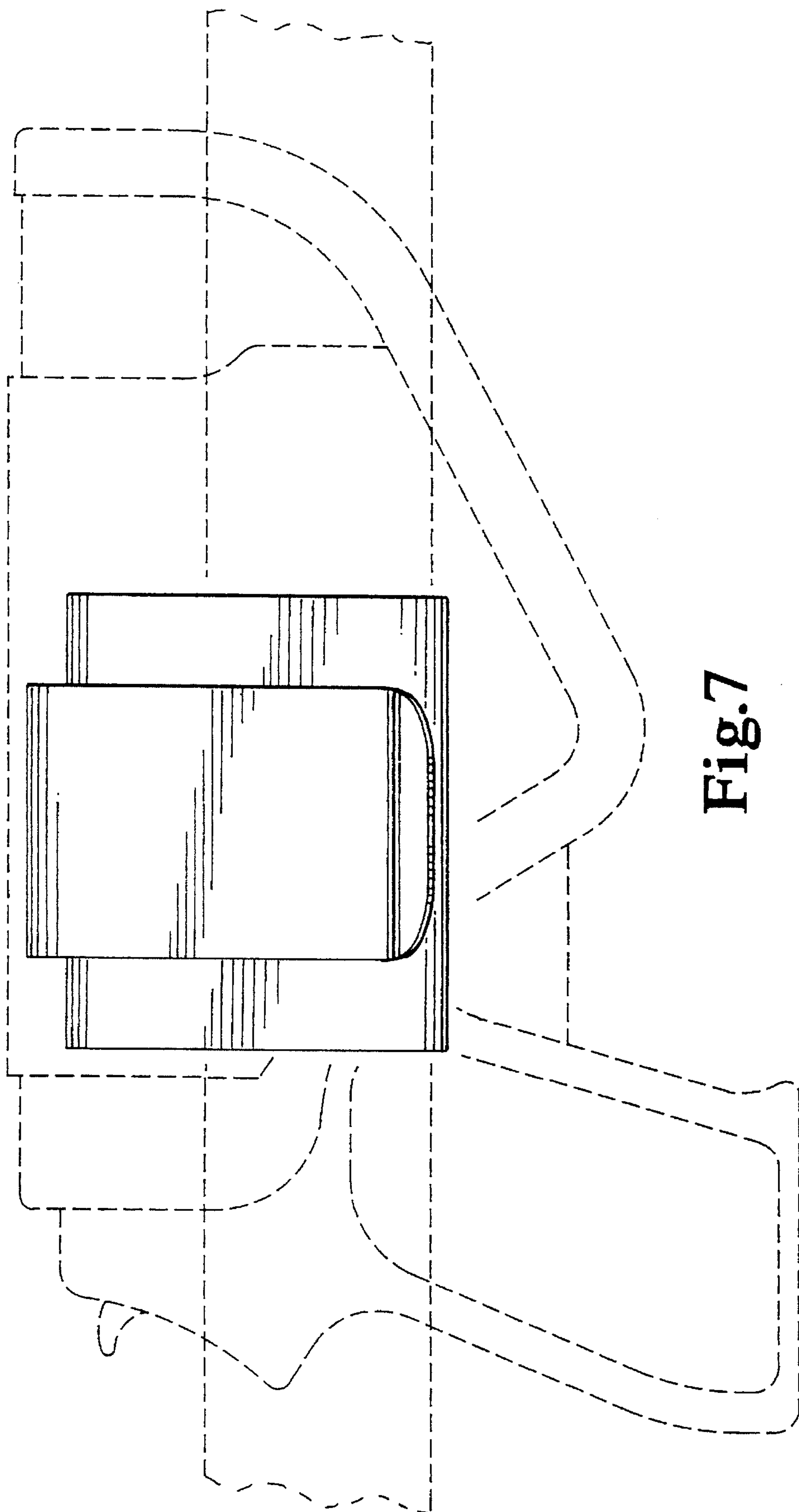

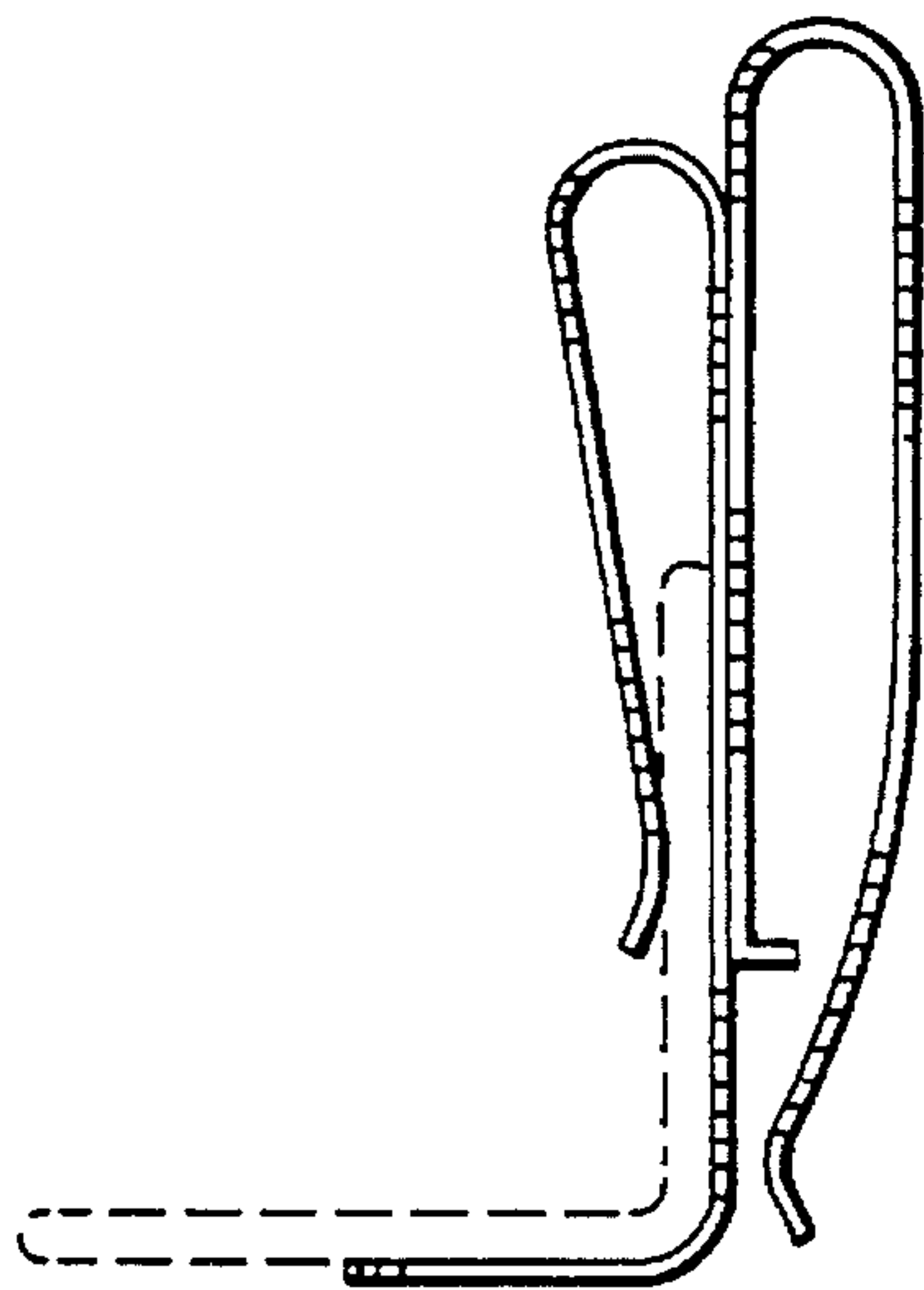

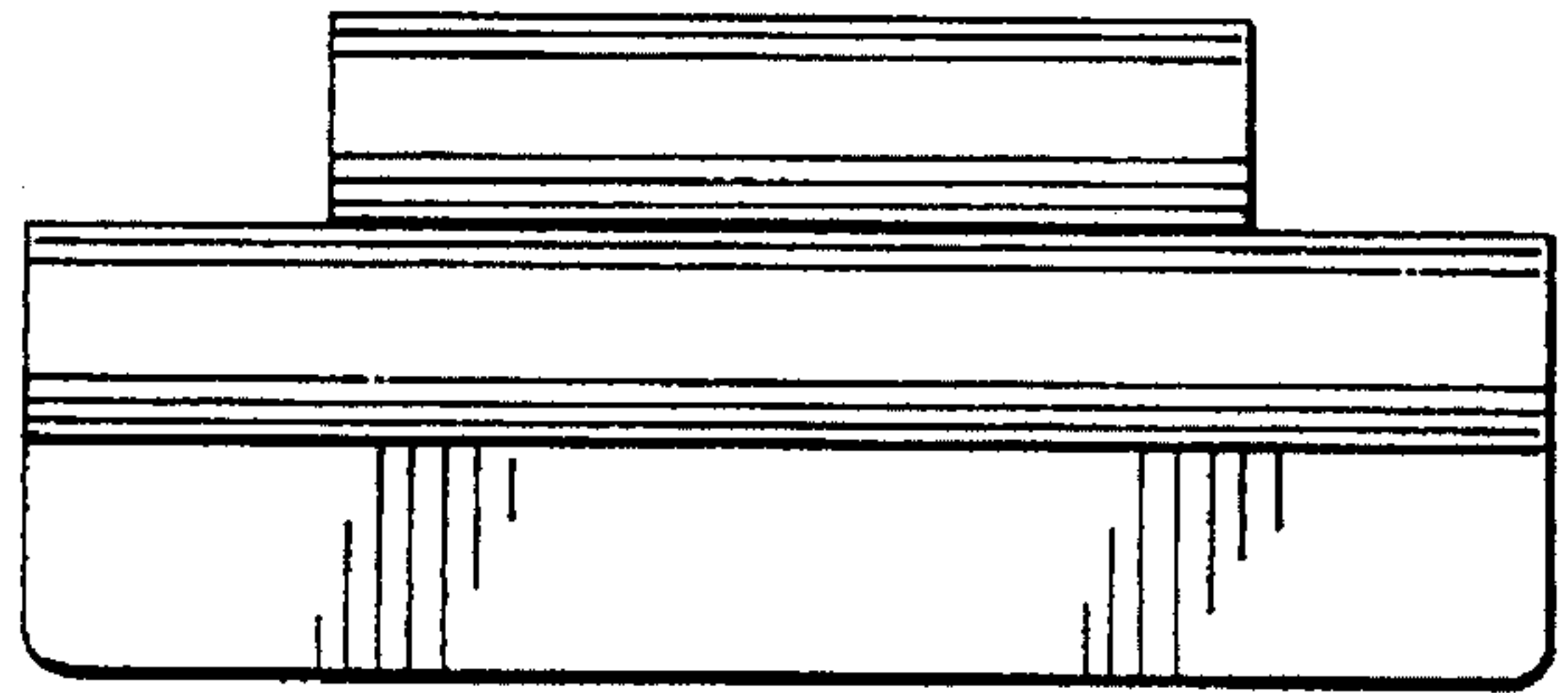

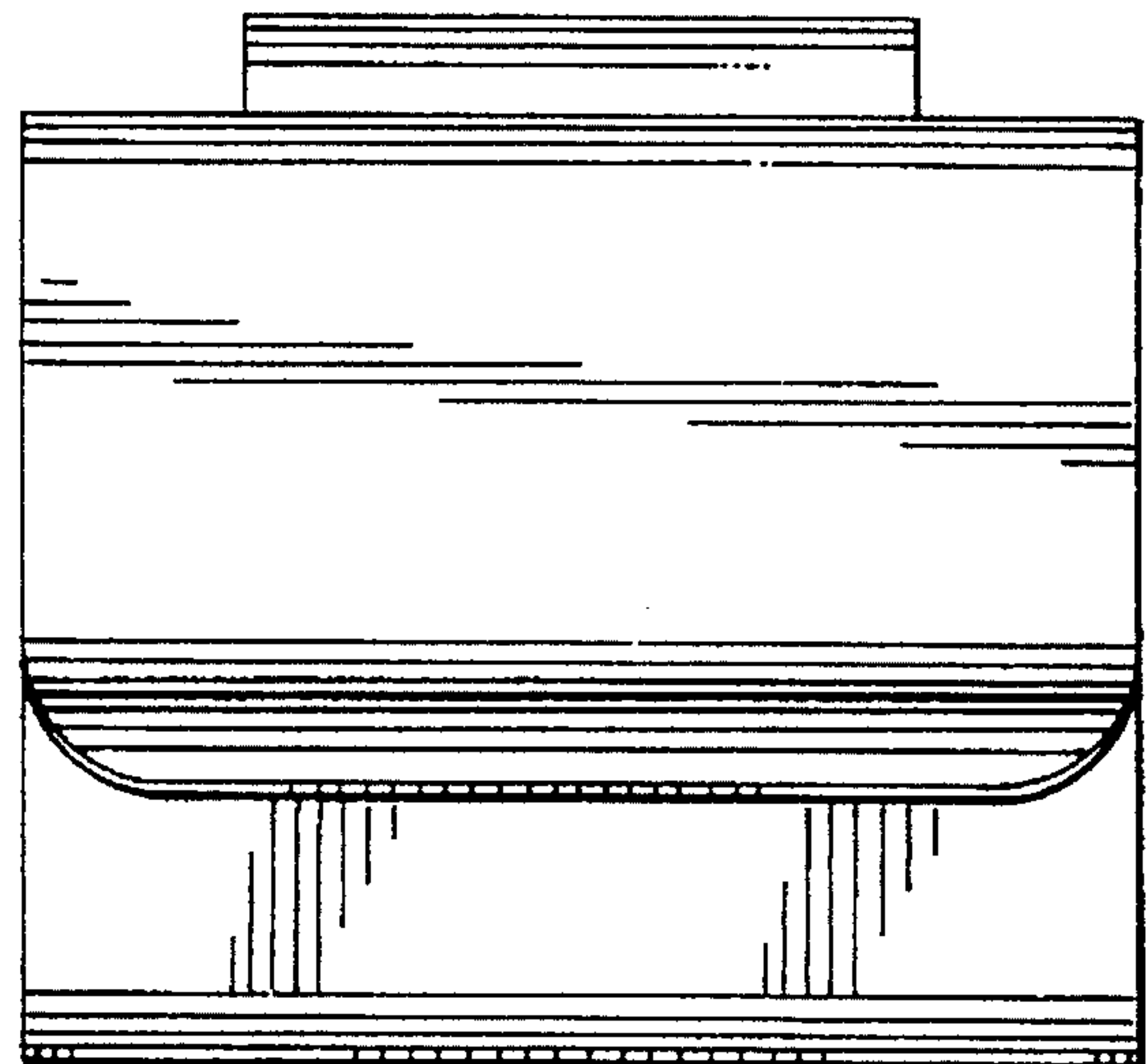

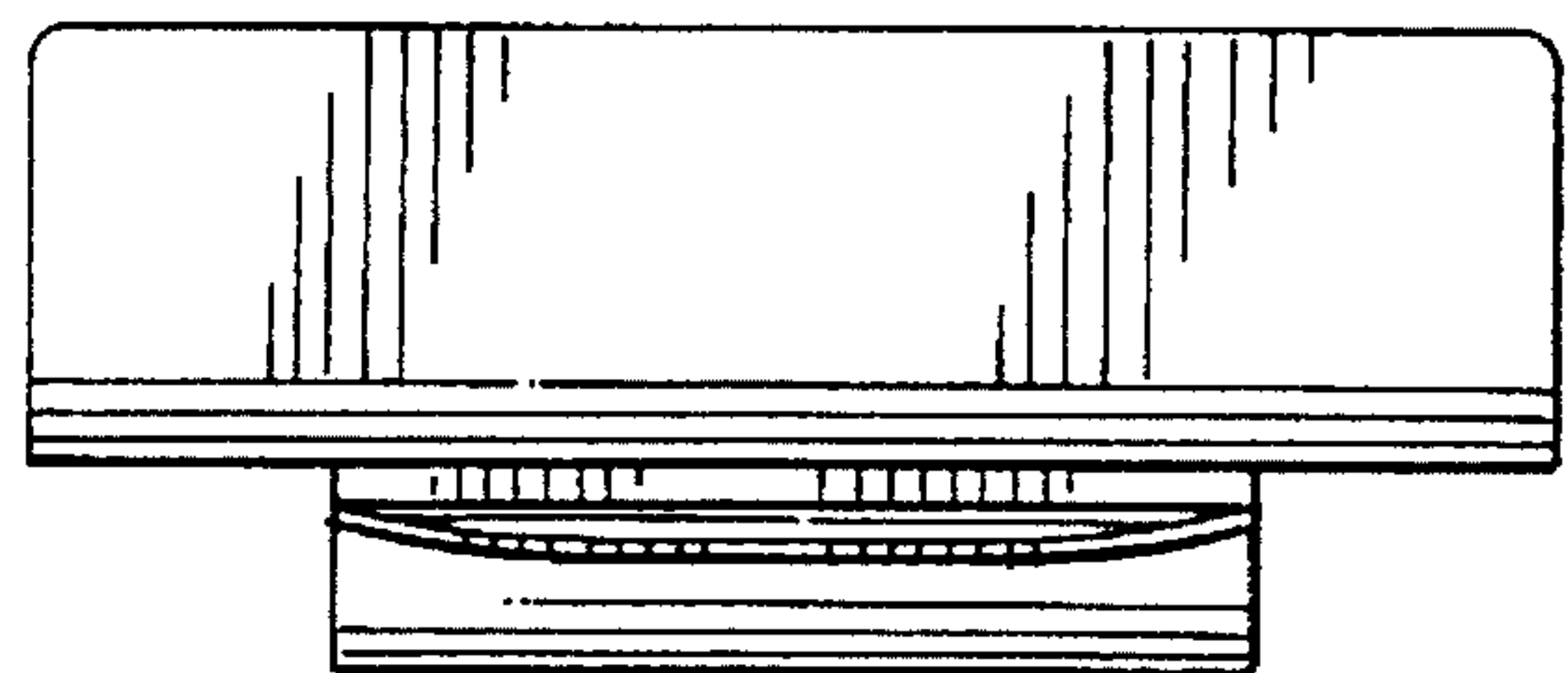
