The ornamental design for stemware, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a first embodiment of the present design; the rear elevational view being a mirror image thereof;

FIG. 2 is a side elevational view thereof;

FIG. 3 is a top view of the first embodiment of the present design;

FIG. 4 is a bottom view of the first embodiment of the present design;

FIG. 8 is a bottom view of the second embodiment of the present design;

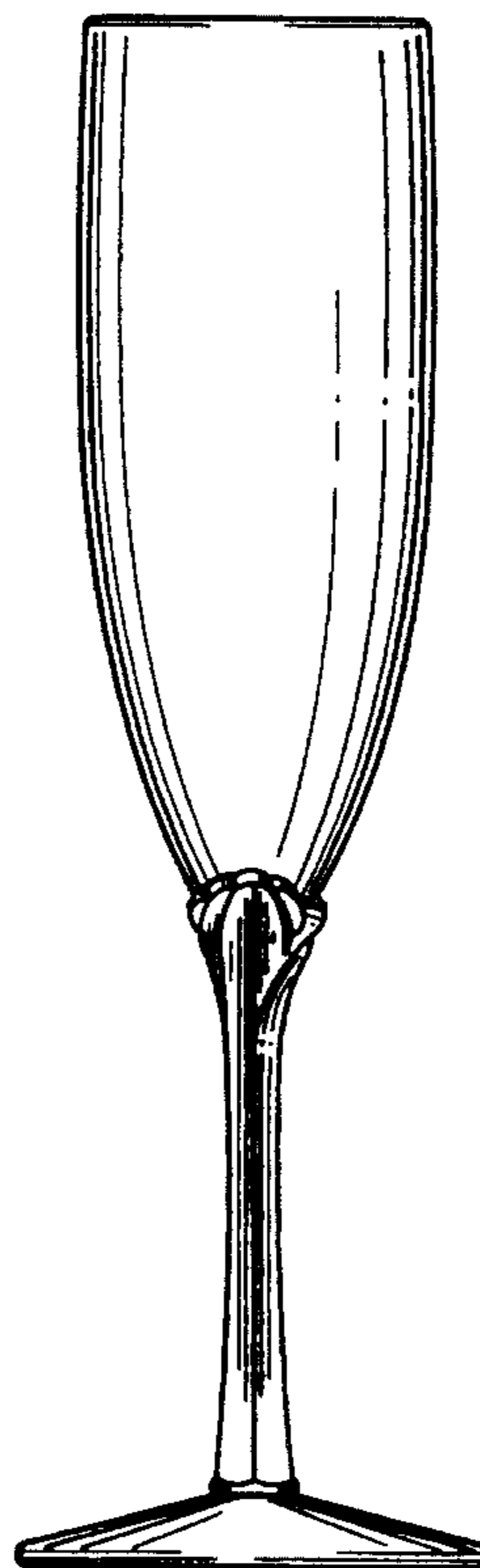
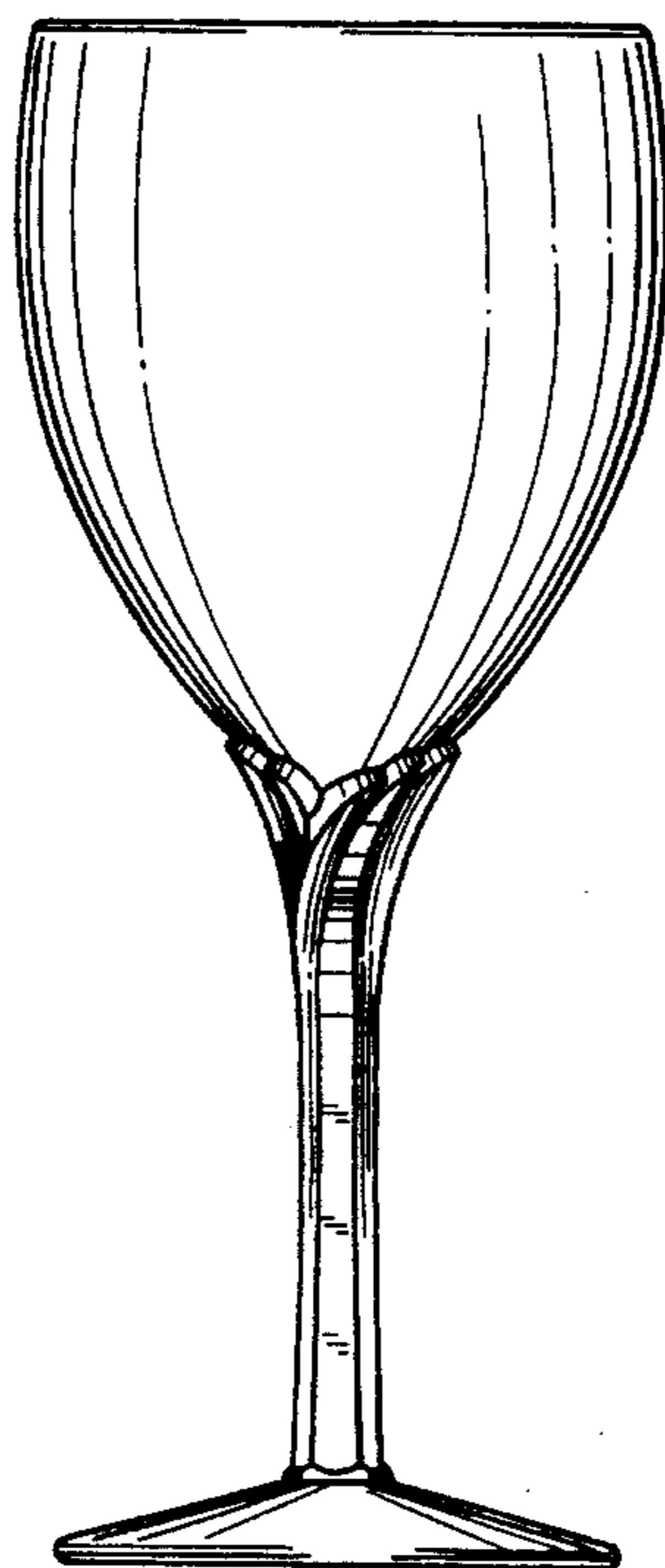
FIG. 9 is a front elevational view of a third embodiment of the present design; the rear elevational view being a mirror image thereof;

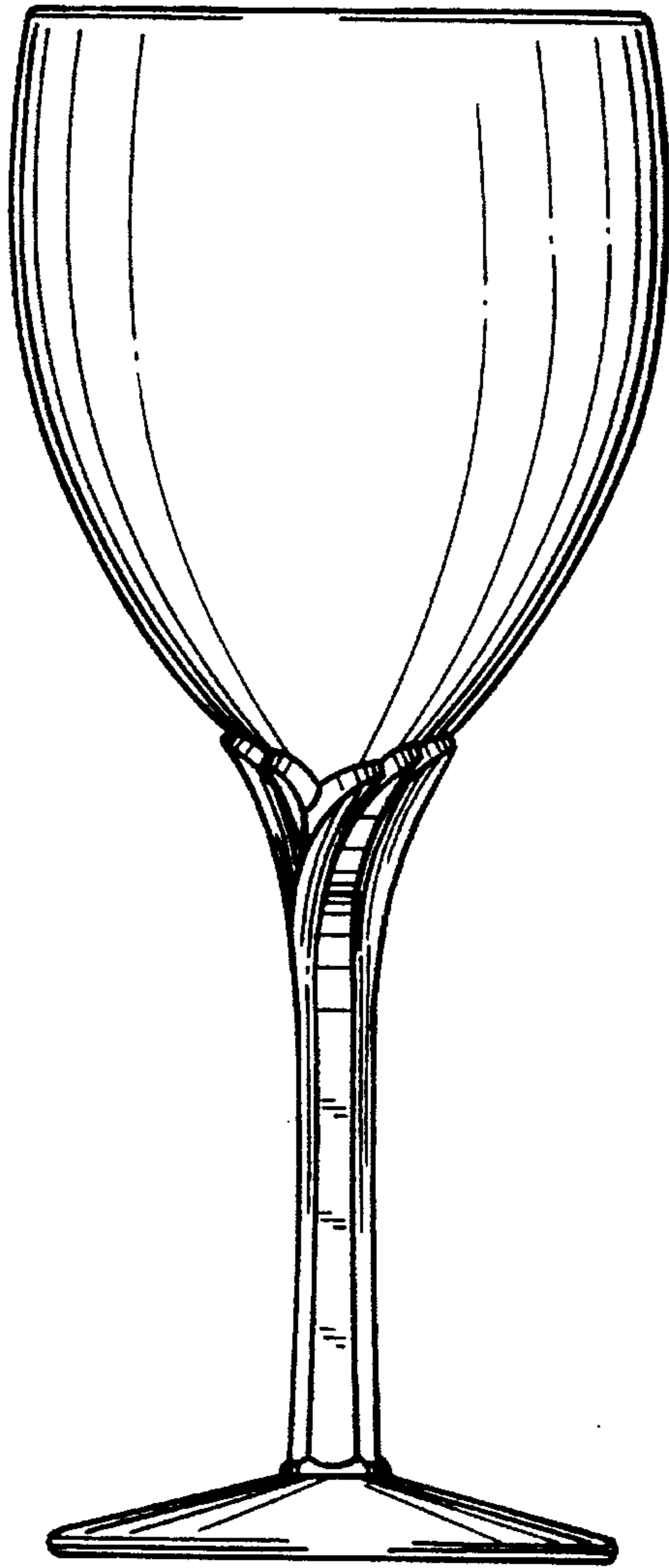

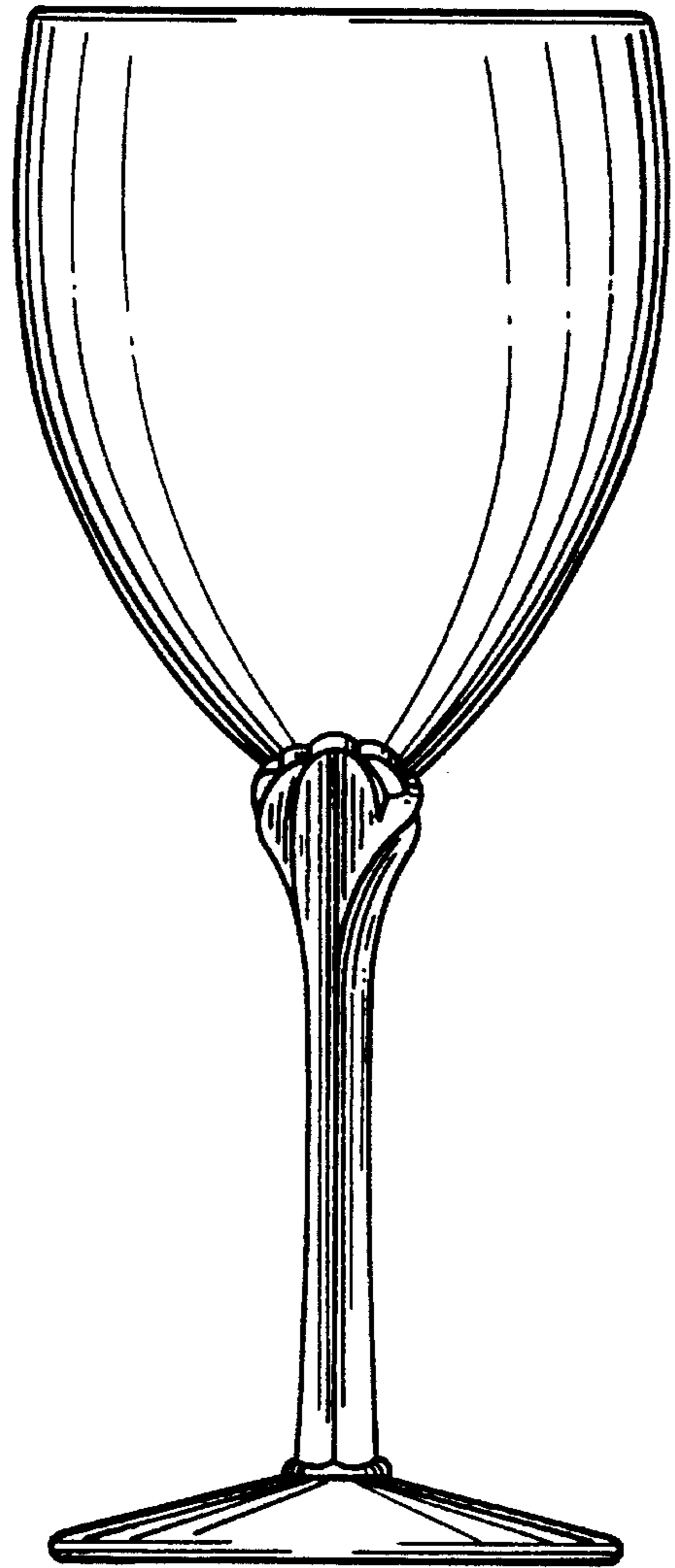

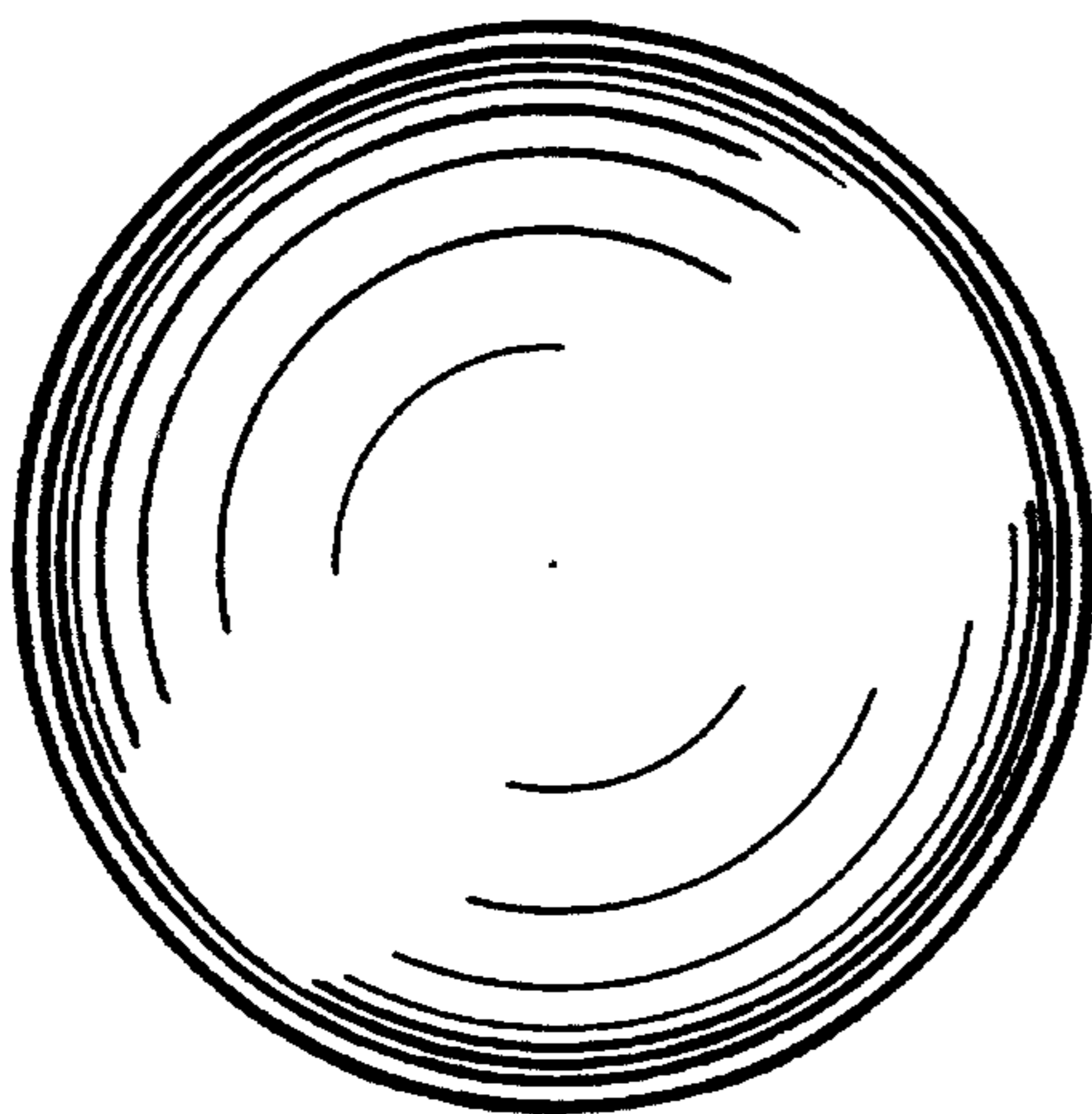

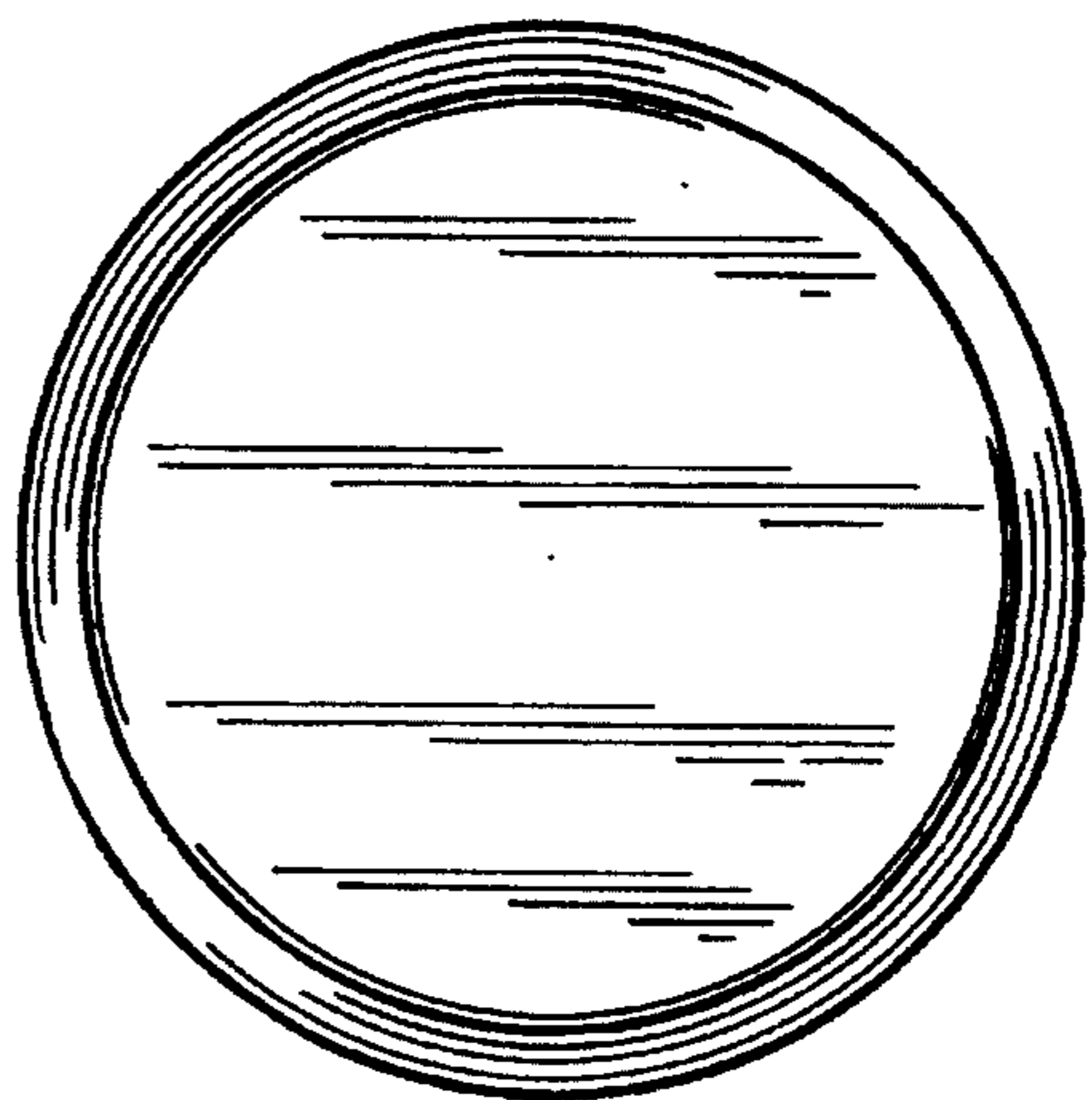

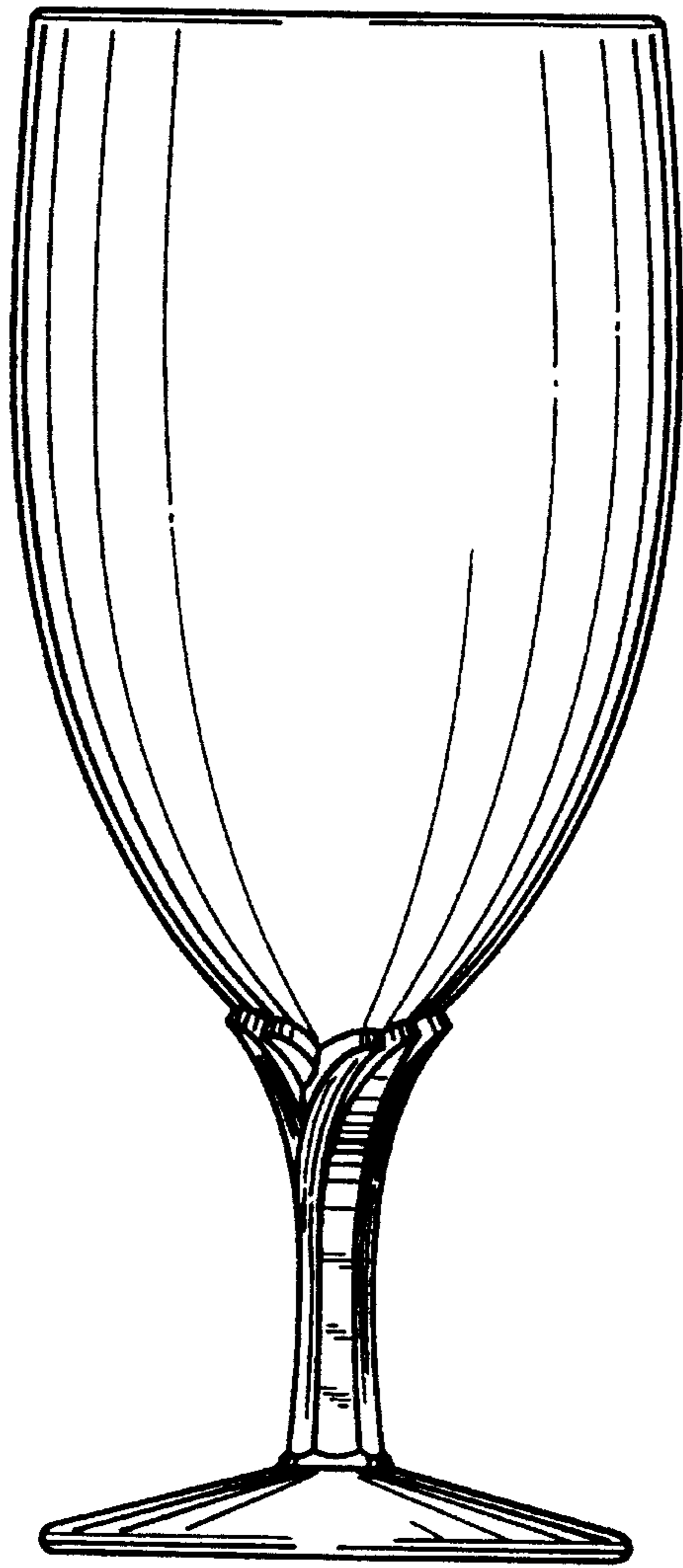

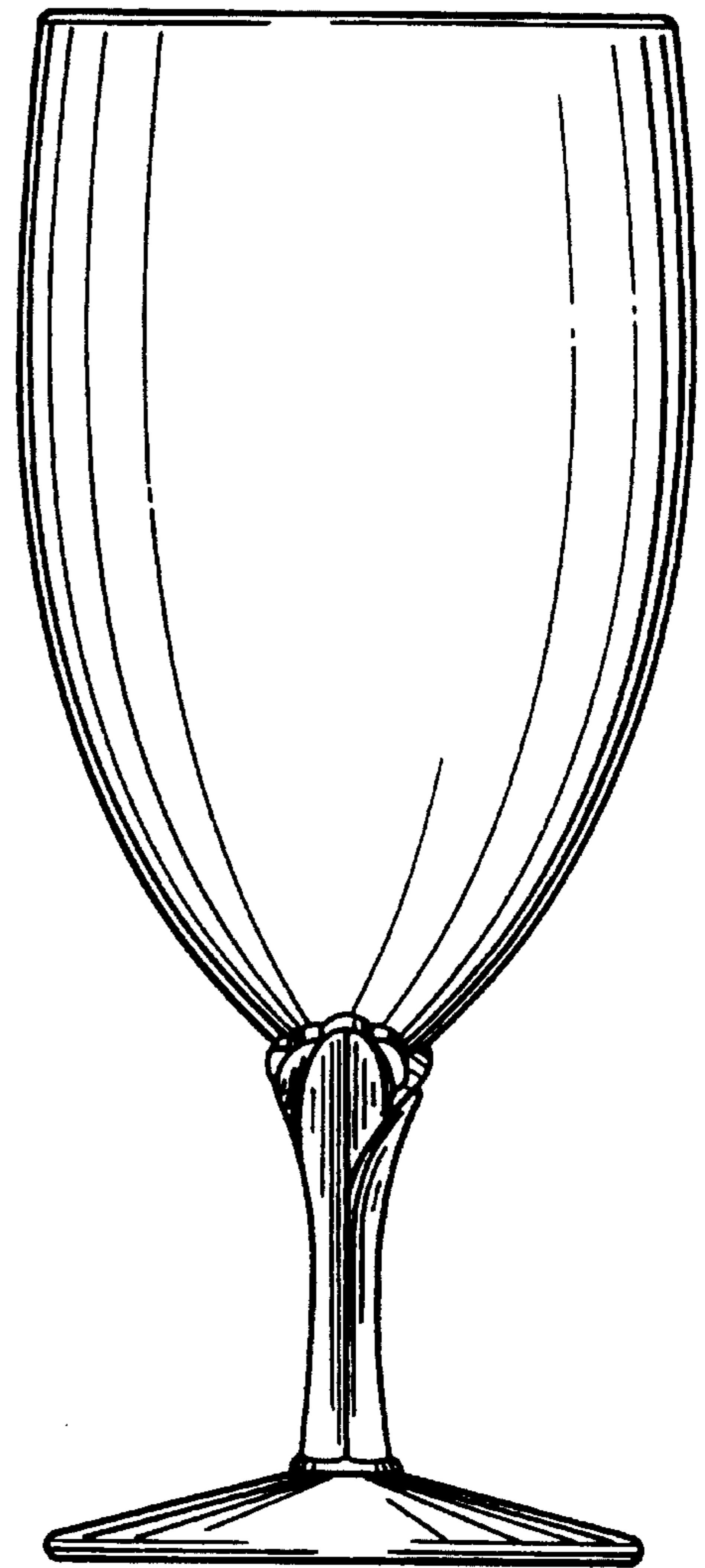

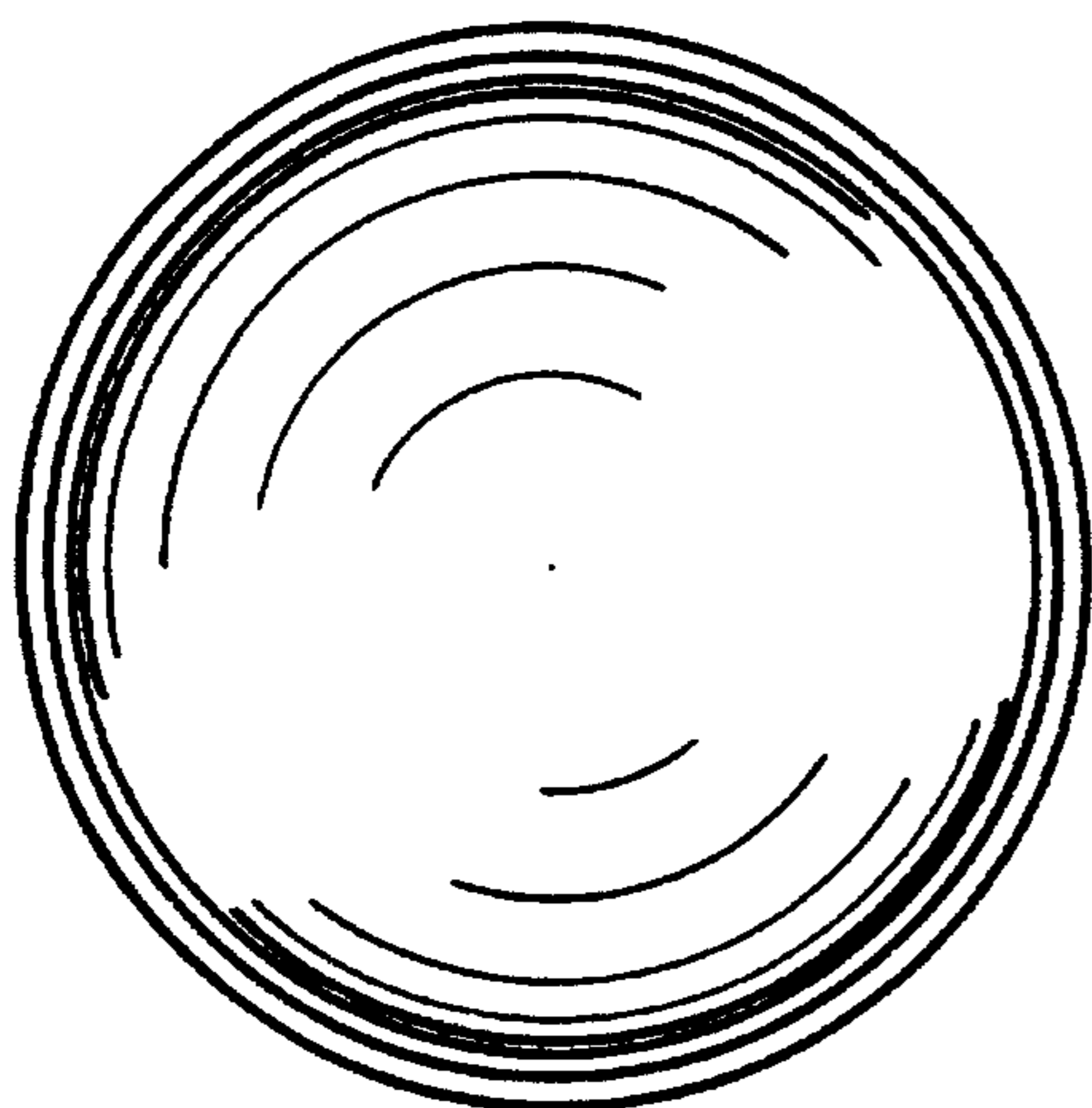

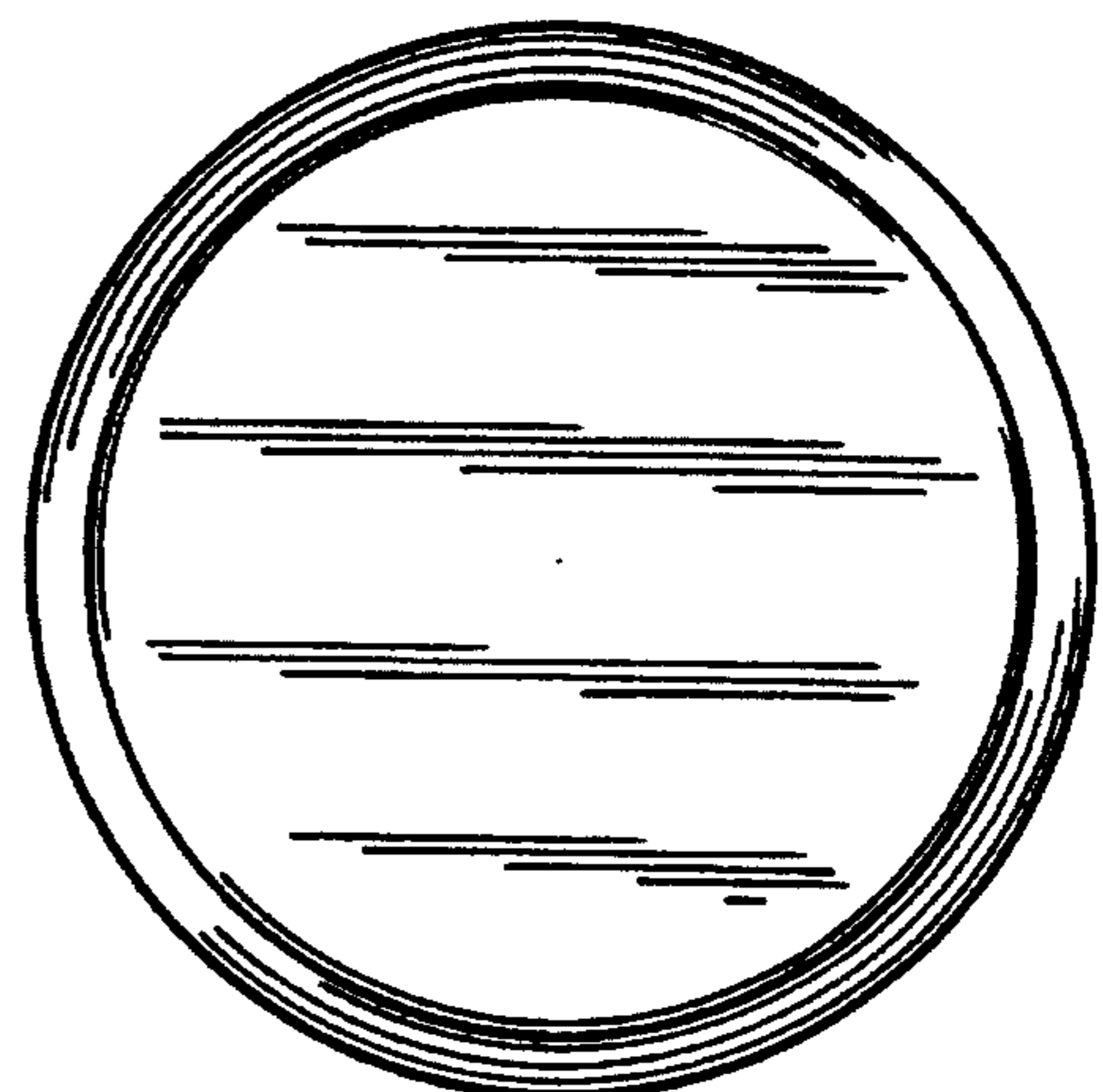

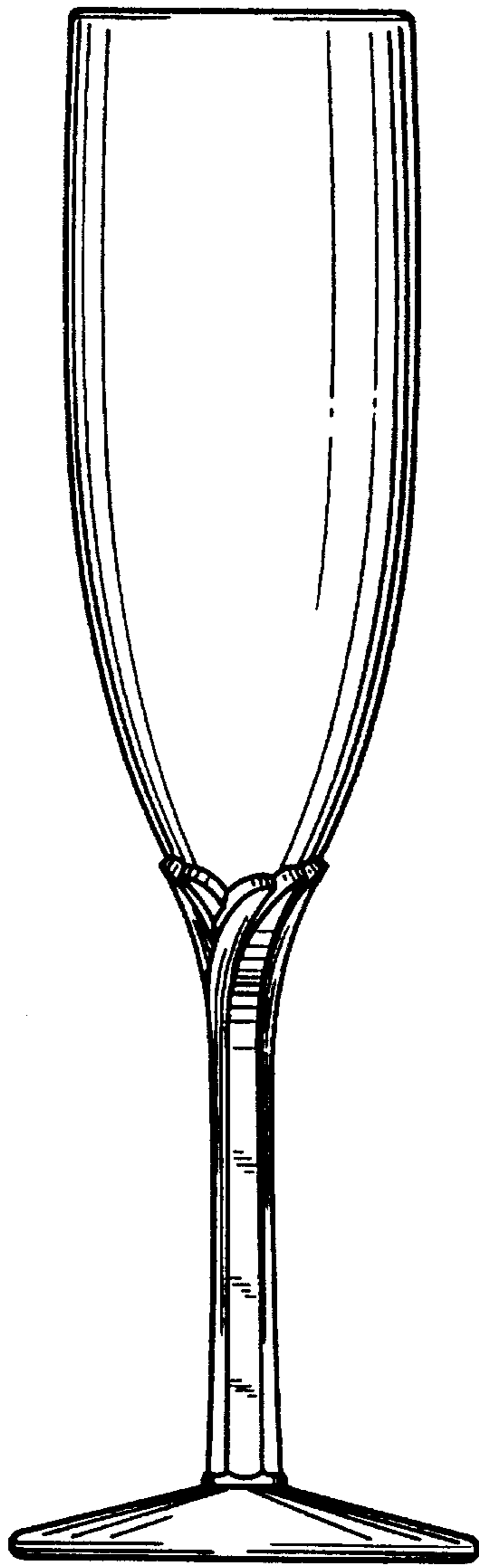

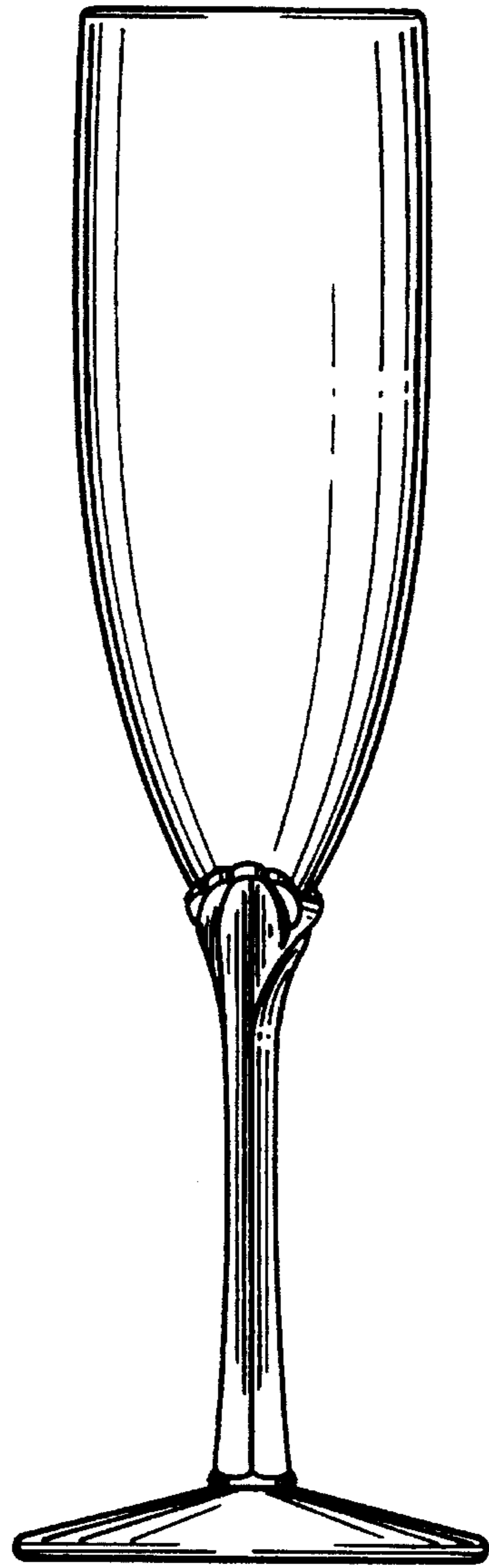

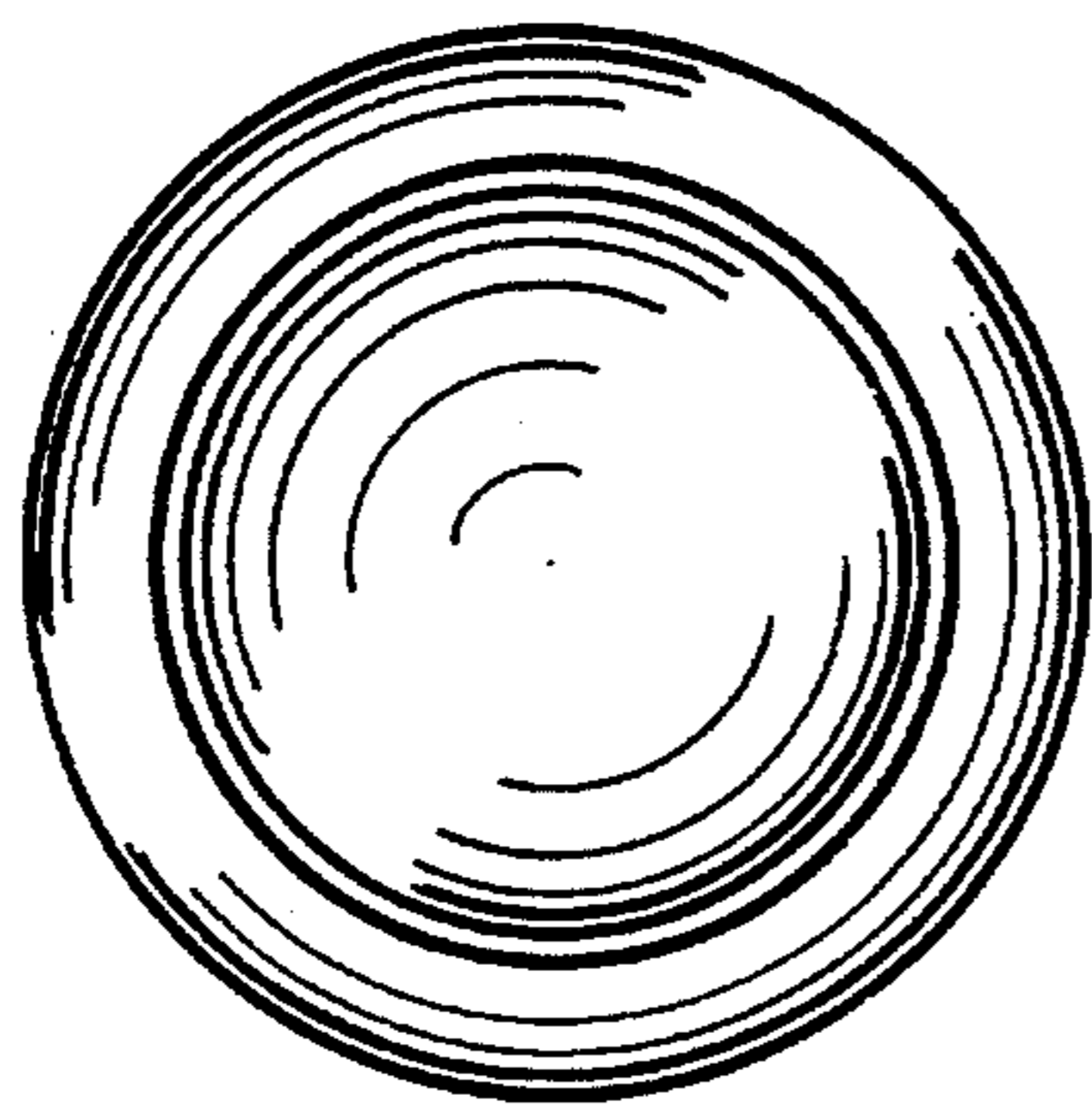

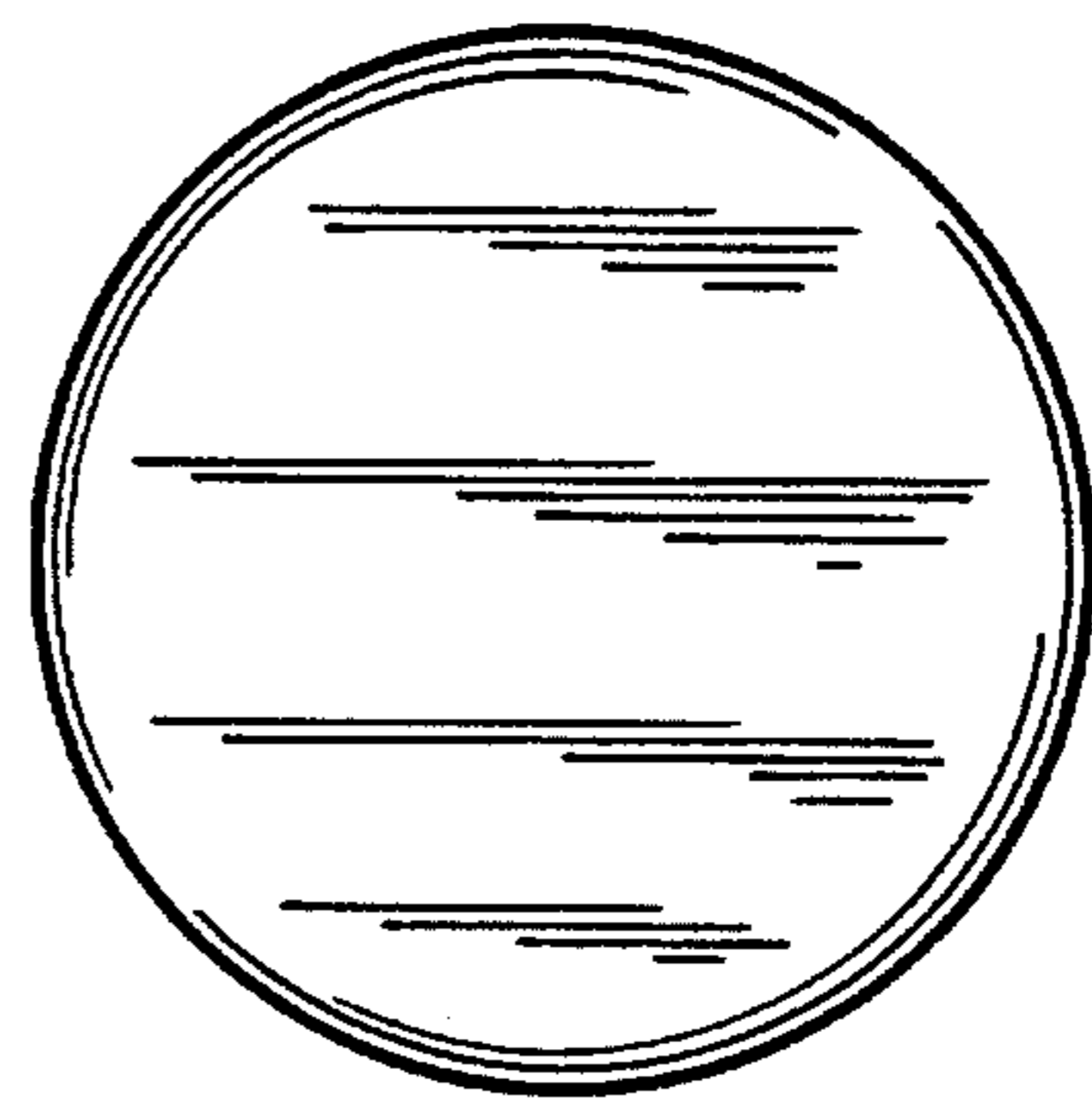
