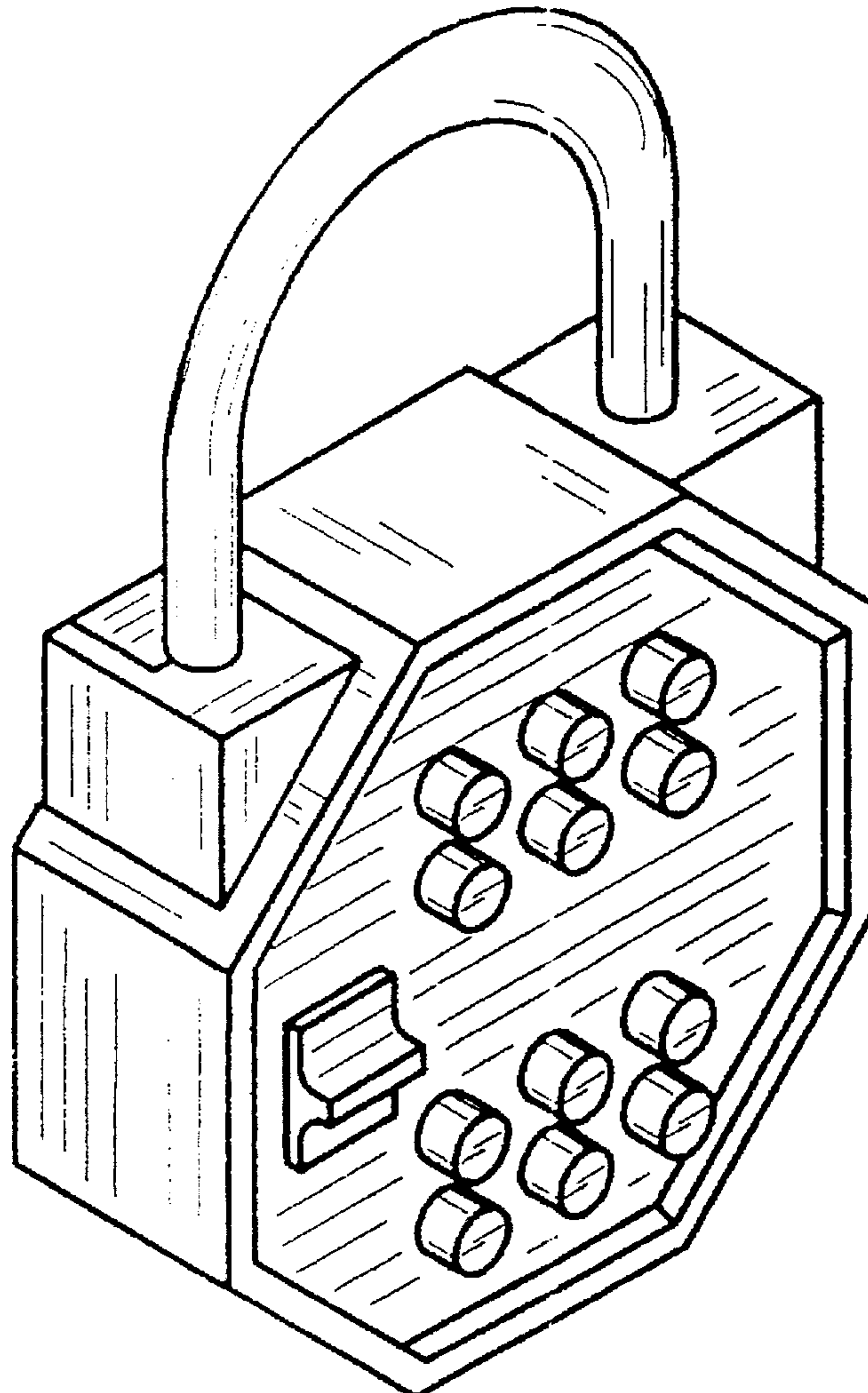
FIG. 1 is a top, front, and left side perspective view of a padlock showing my new design;

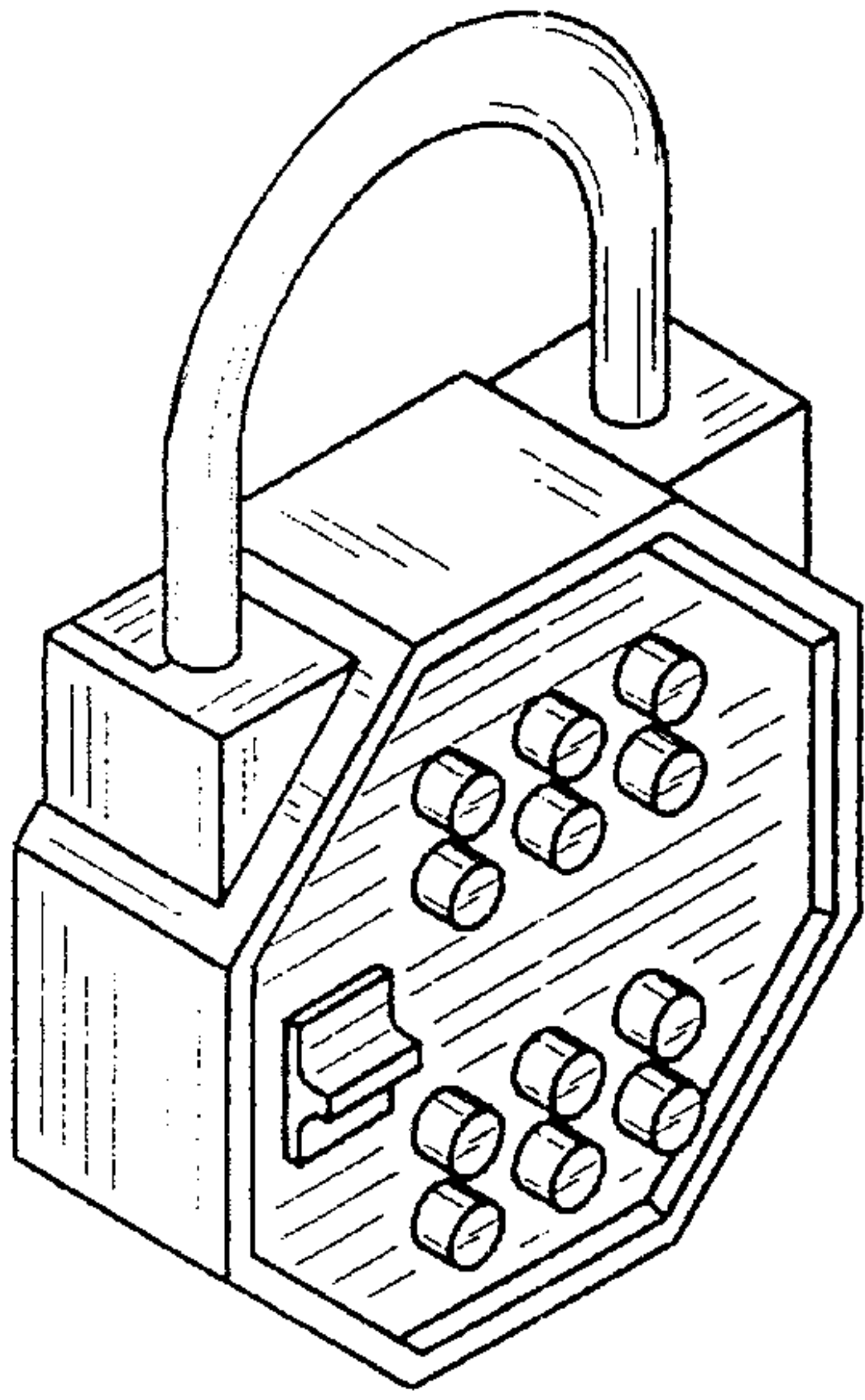

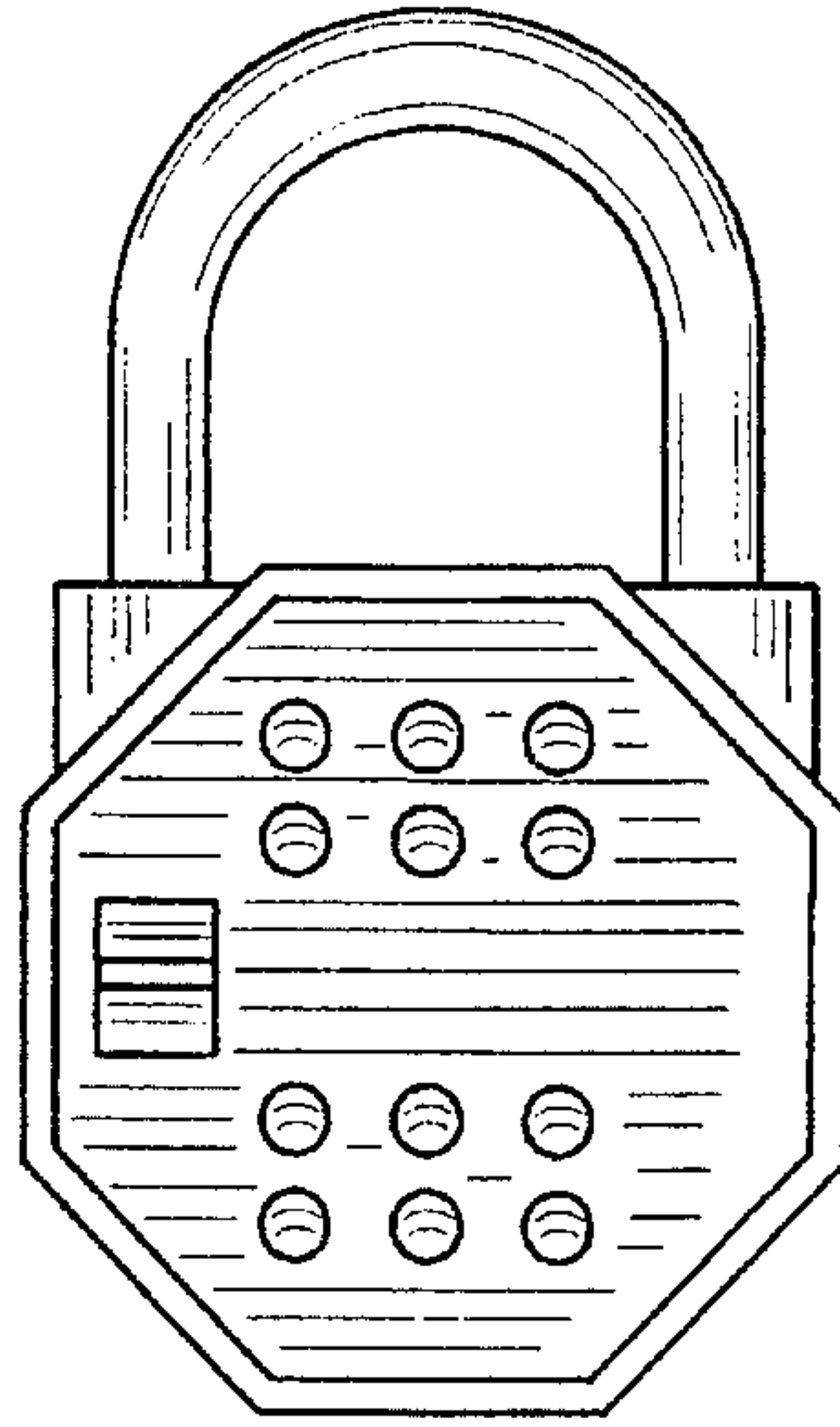

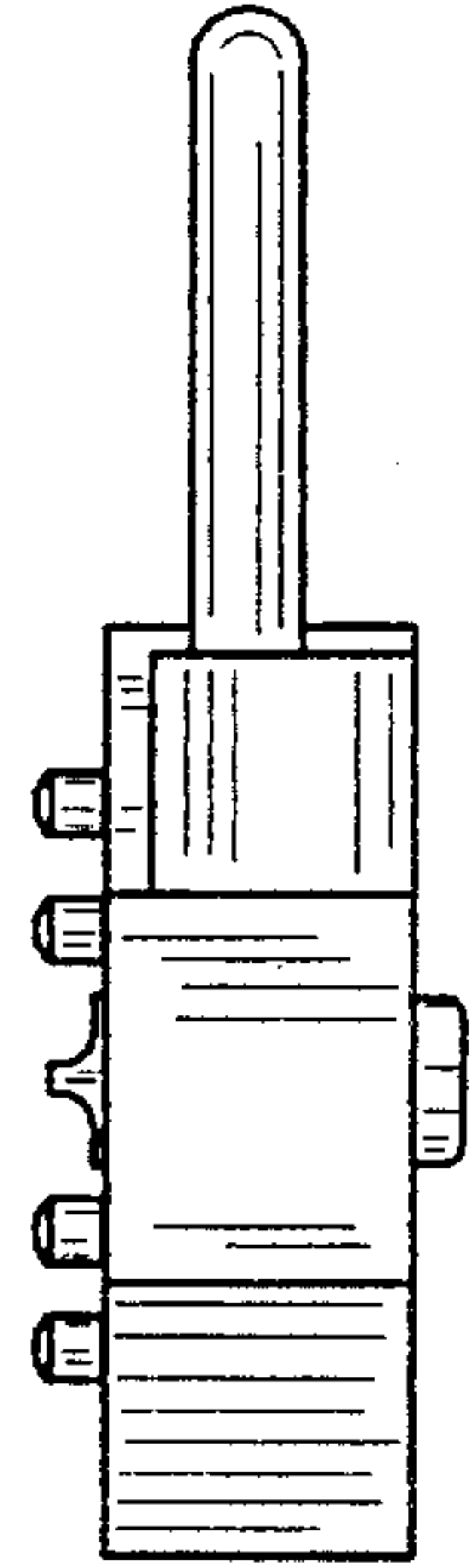

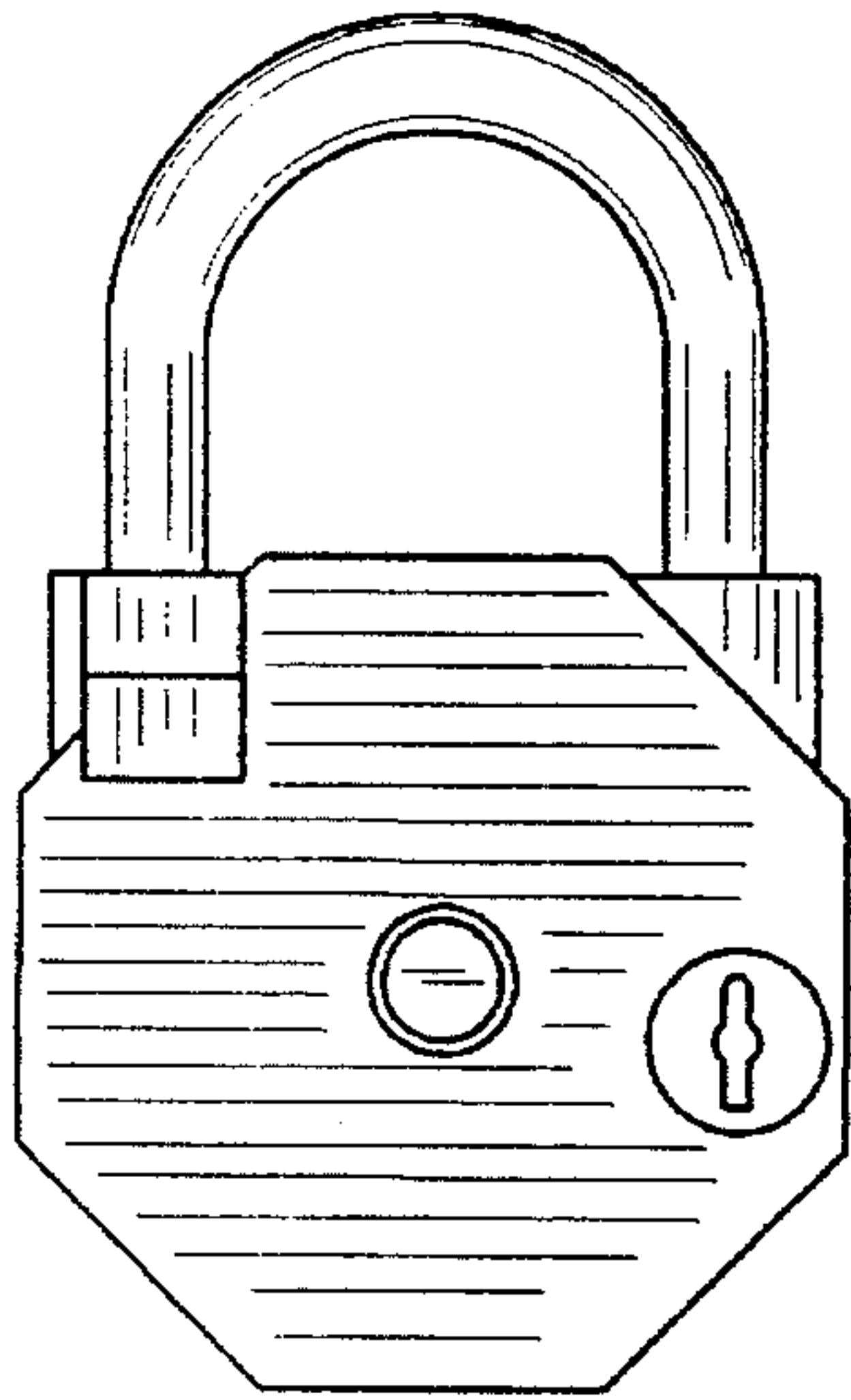

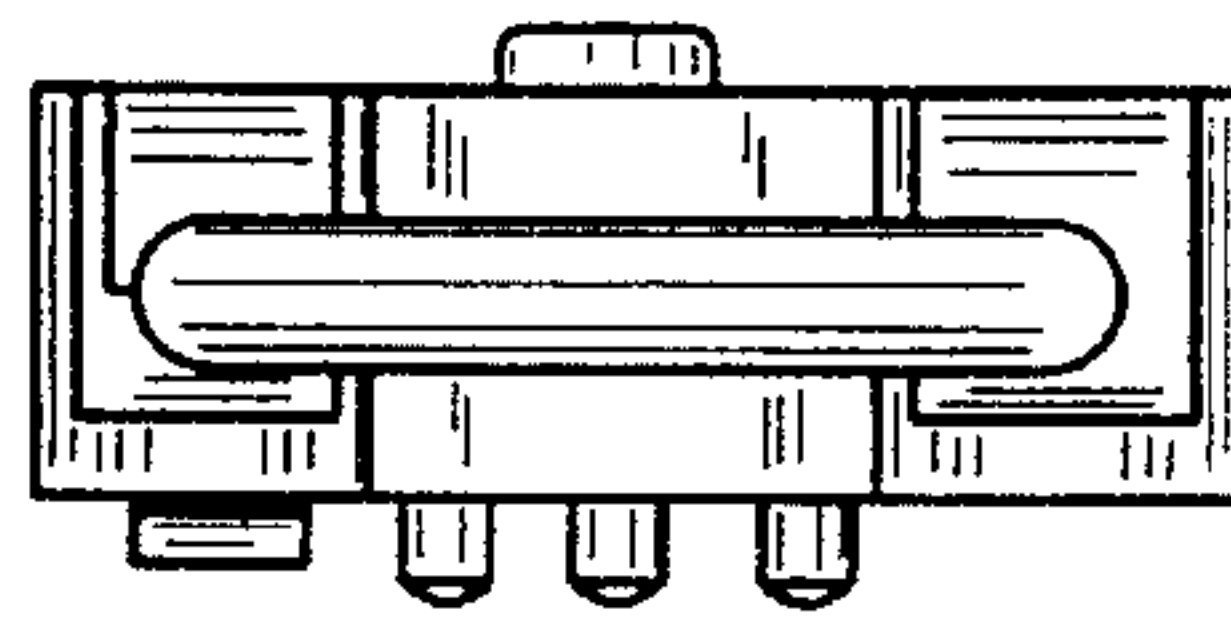

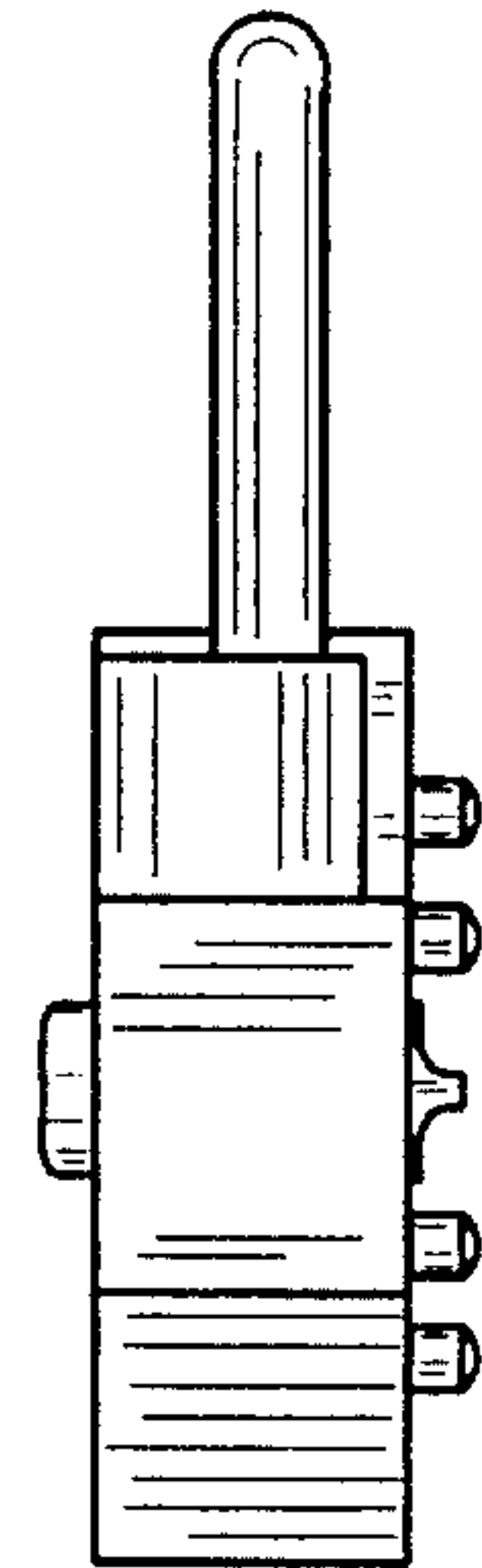

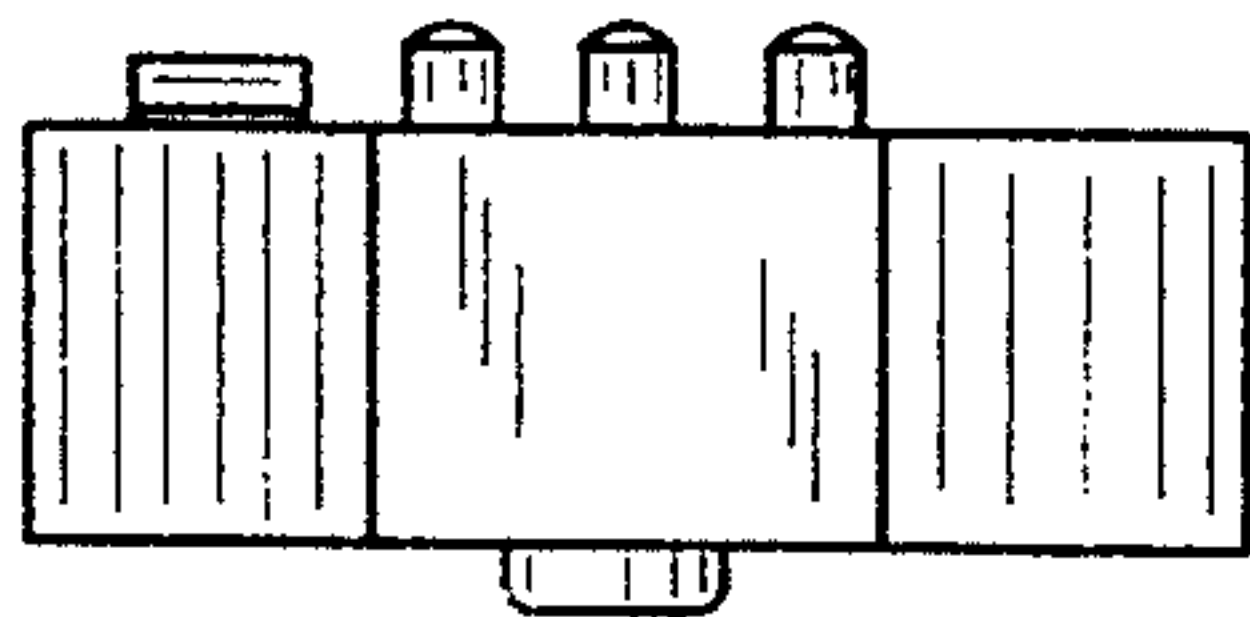
