The ornamental design for the body for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the body for a bottle;
 FIG. 2 is a front elevation view thereof, the opposite side being identical;
 FIG. 3 is a right side elevation view thereof, the opposite side being identical;
 FIG. 4 is a top plan view thereof; and,
 FIG. 5 is a bottom plan view thereof.

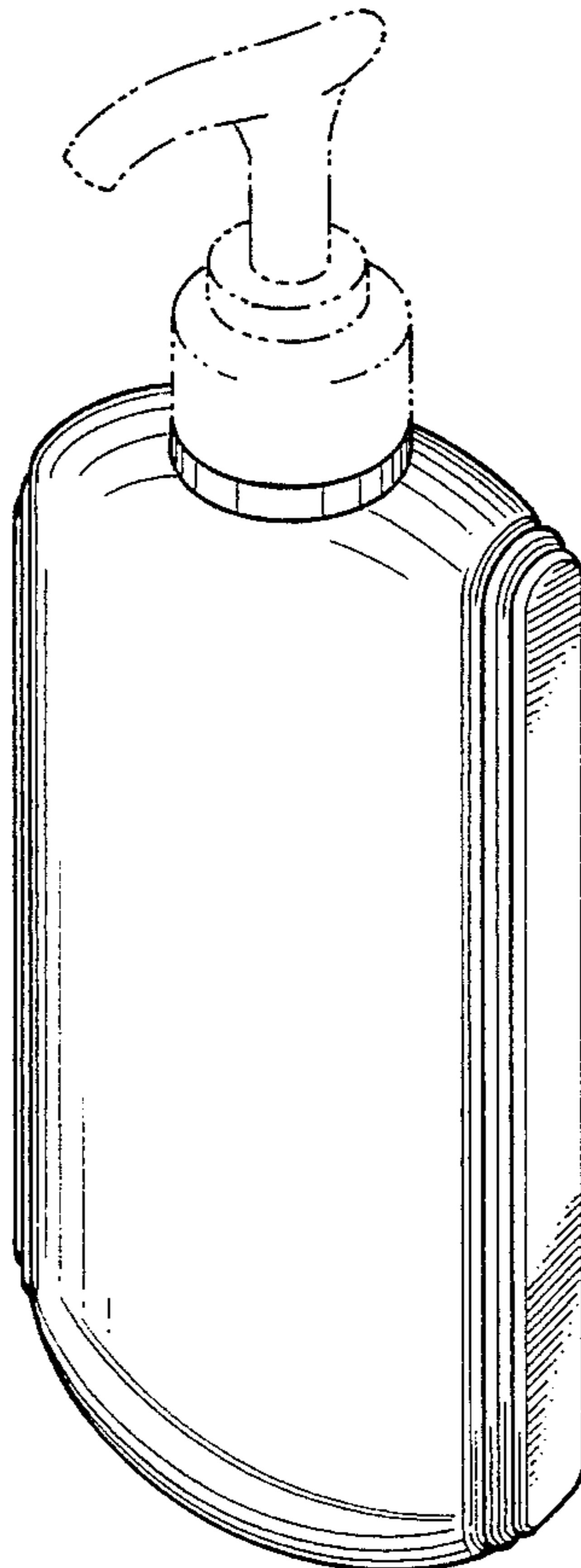

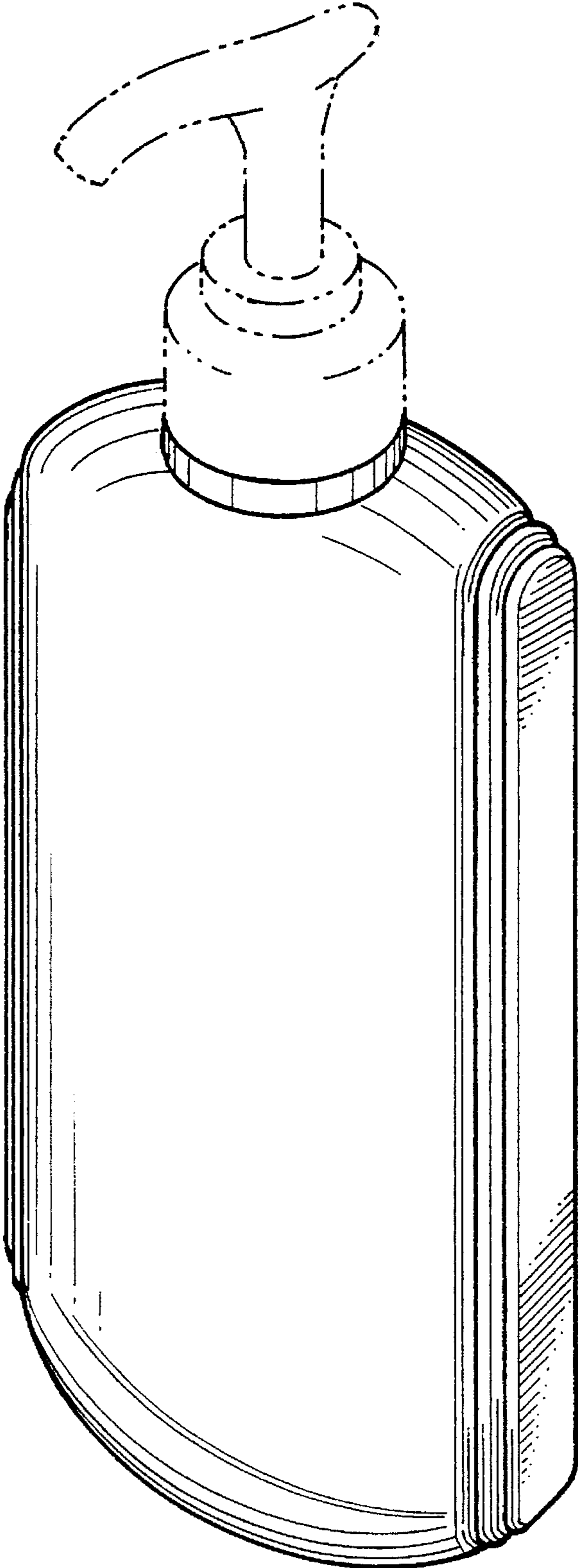

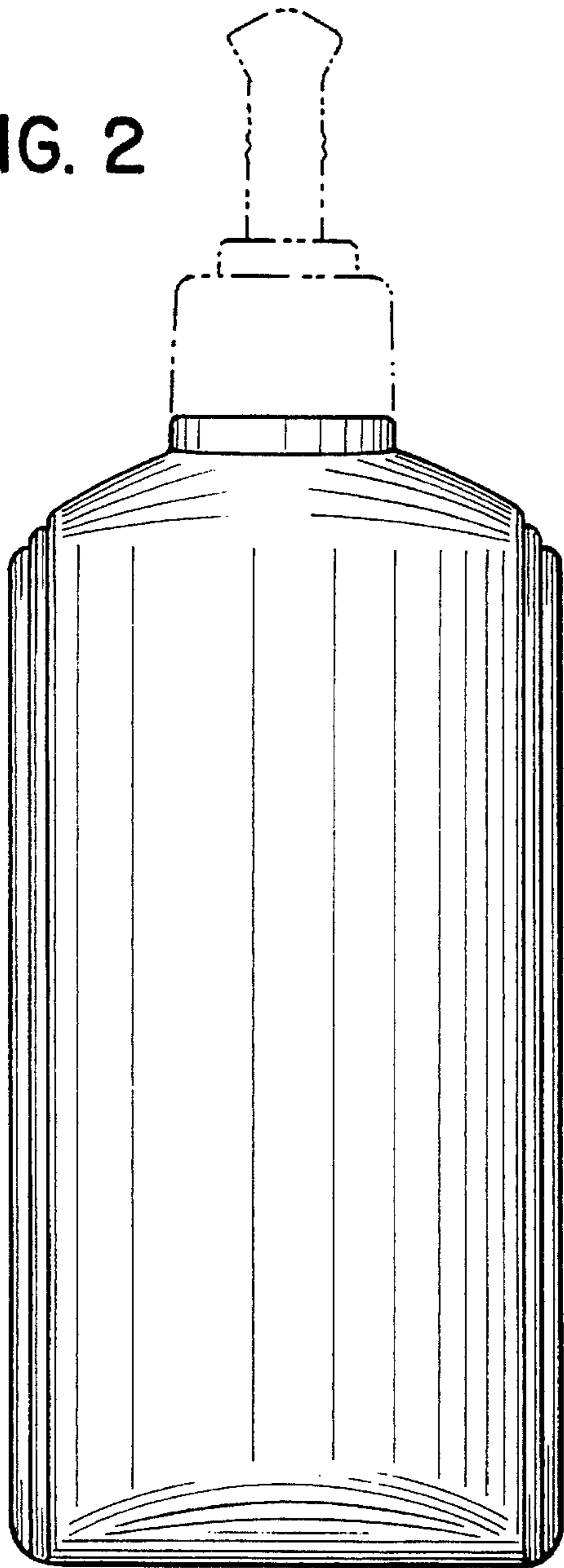

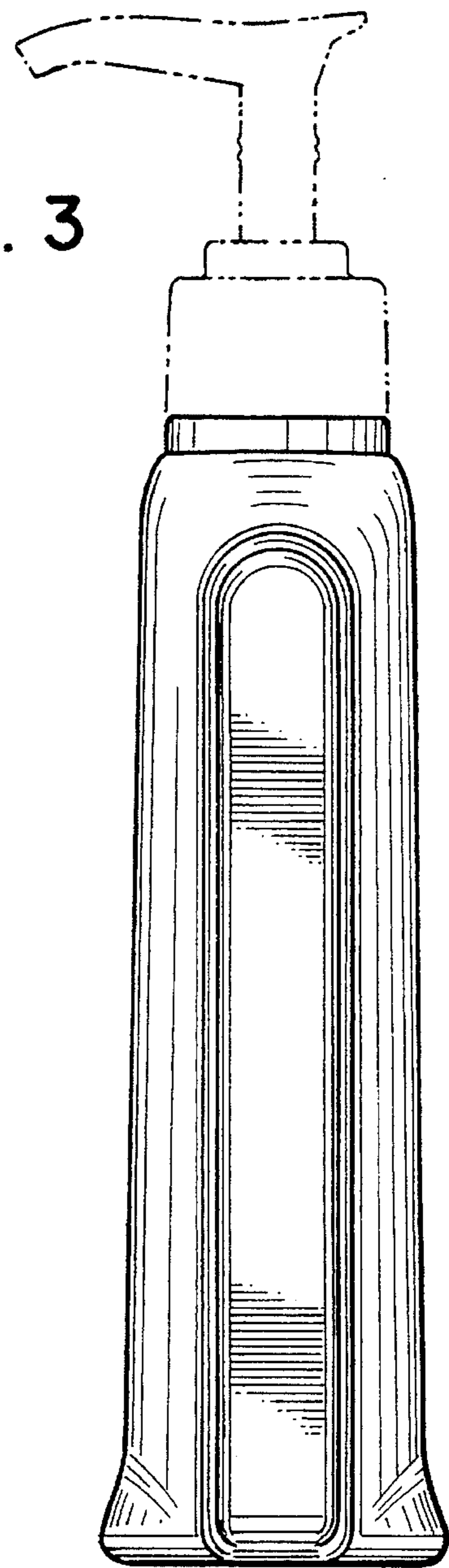

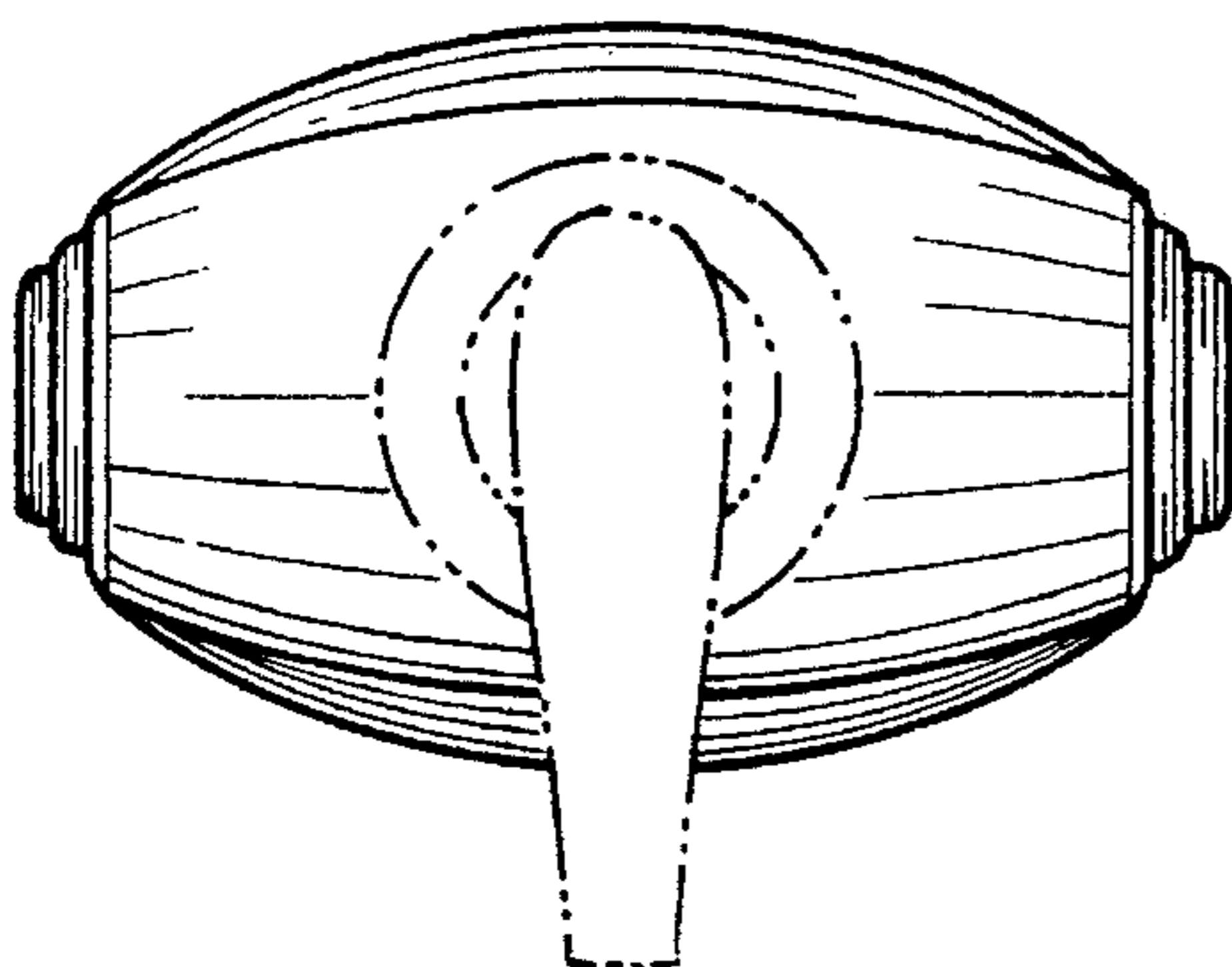
