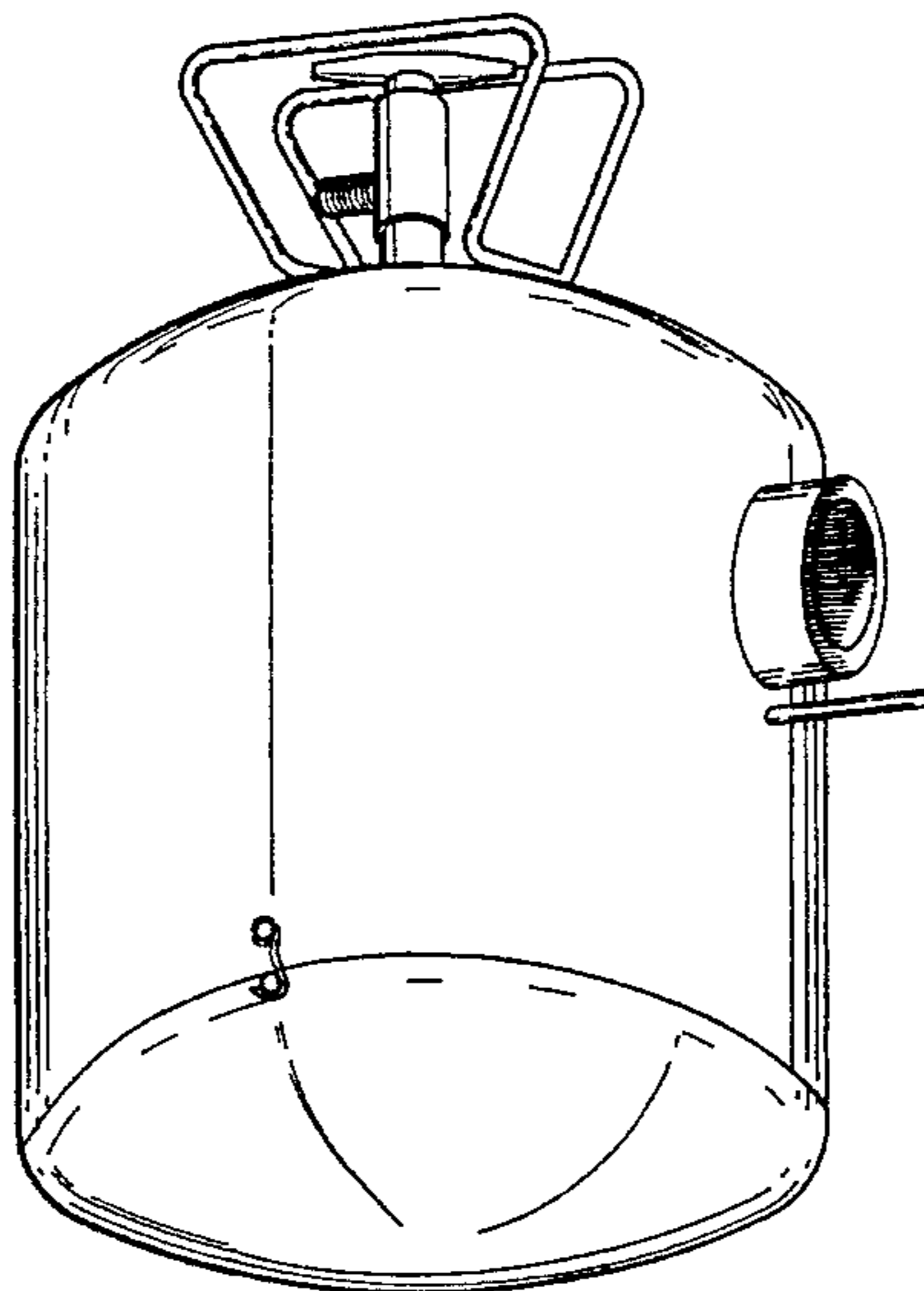
[57] CLAIM

DESCRIPTION

FIG. 1 is a perspective view showing the new design;

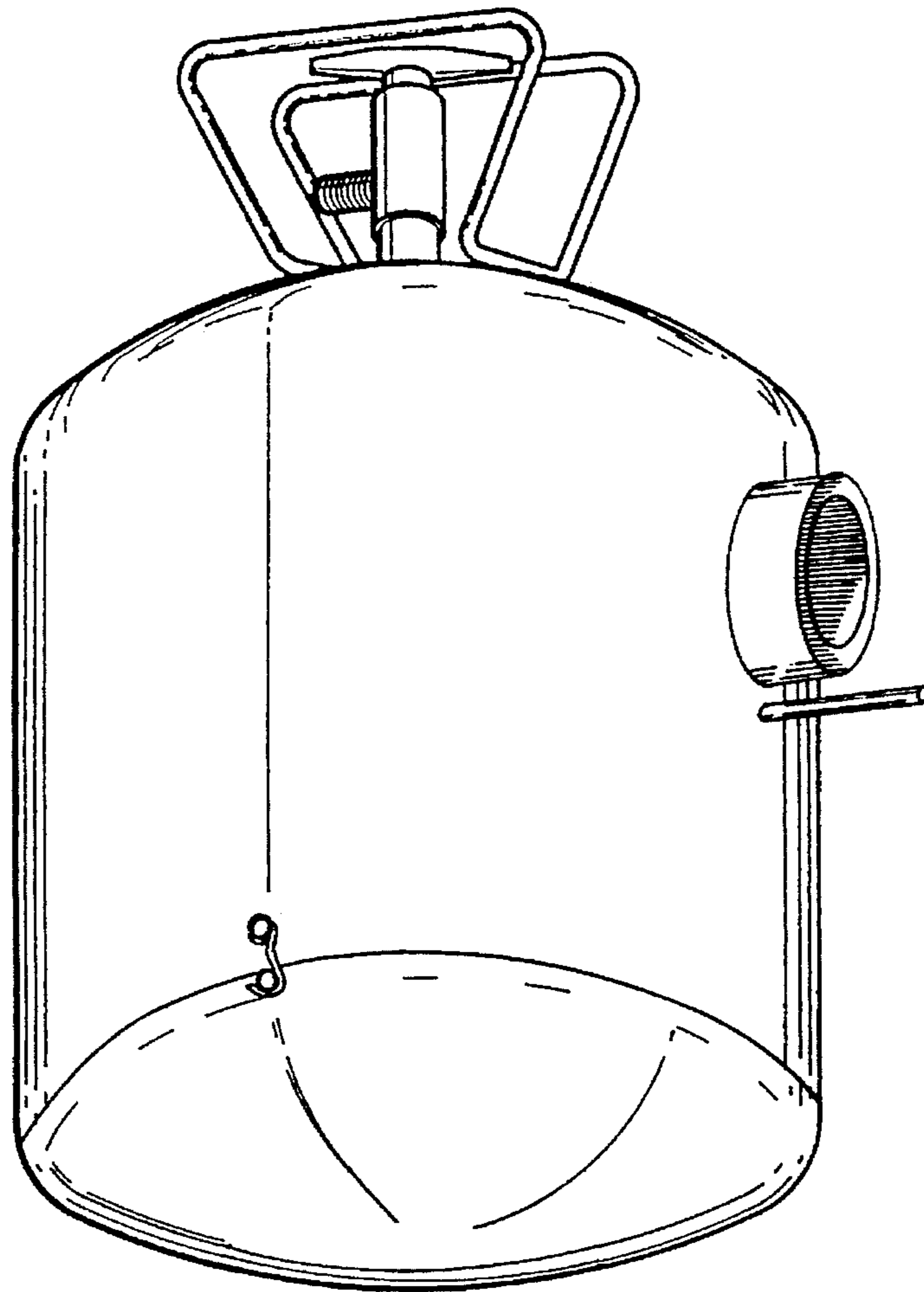

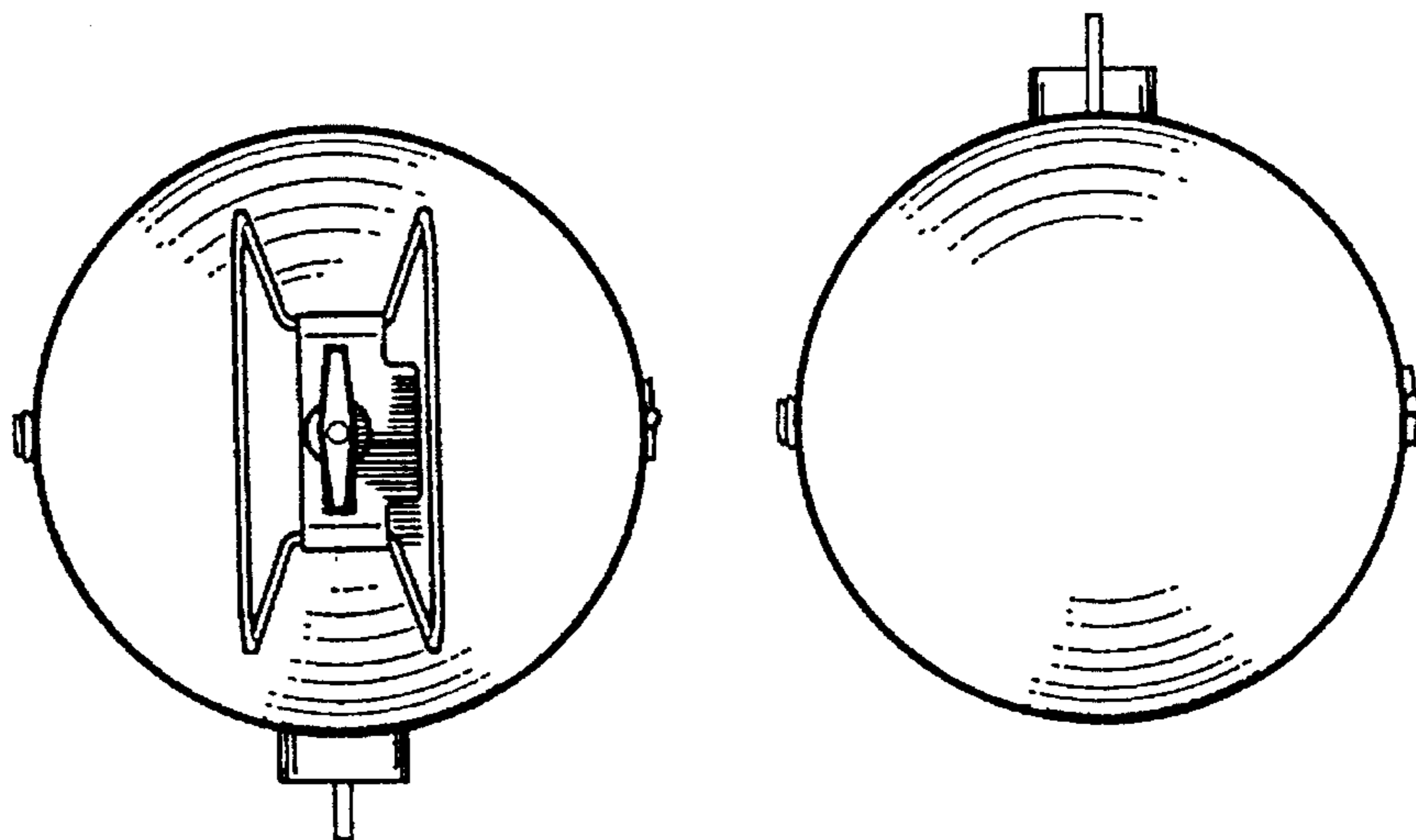

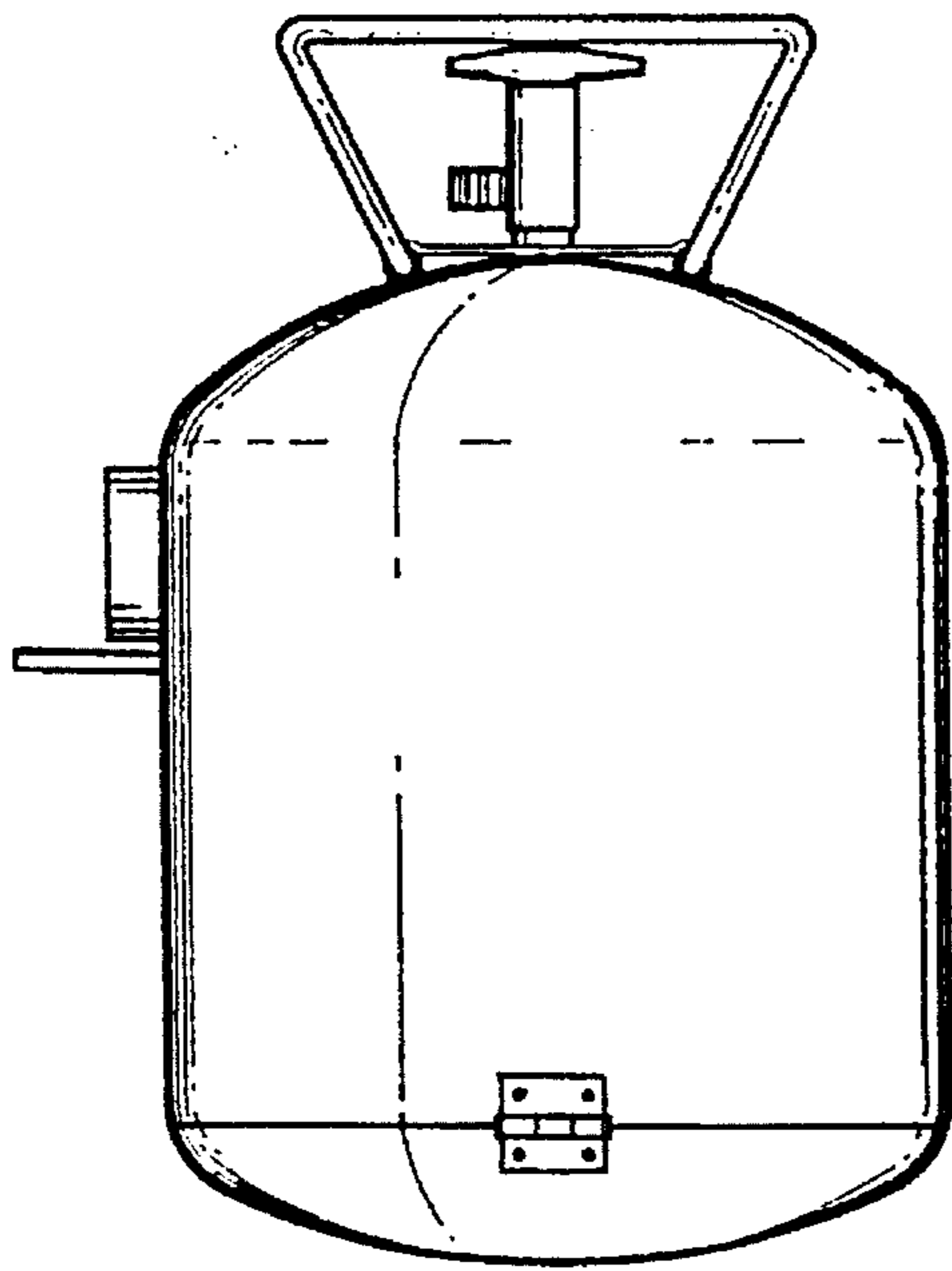

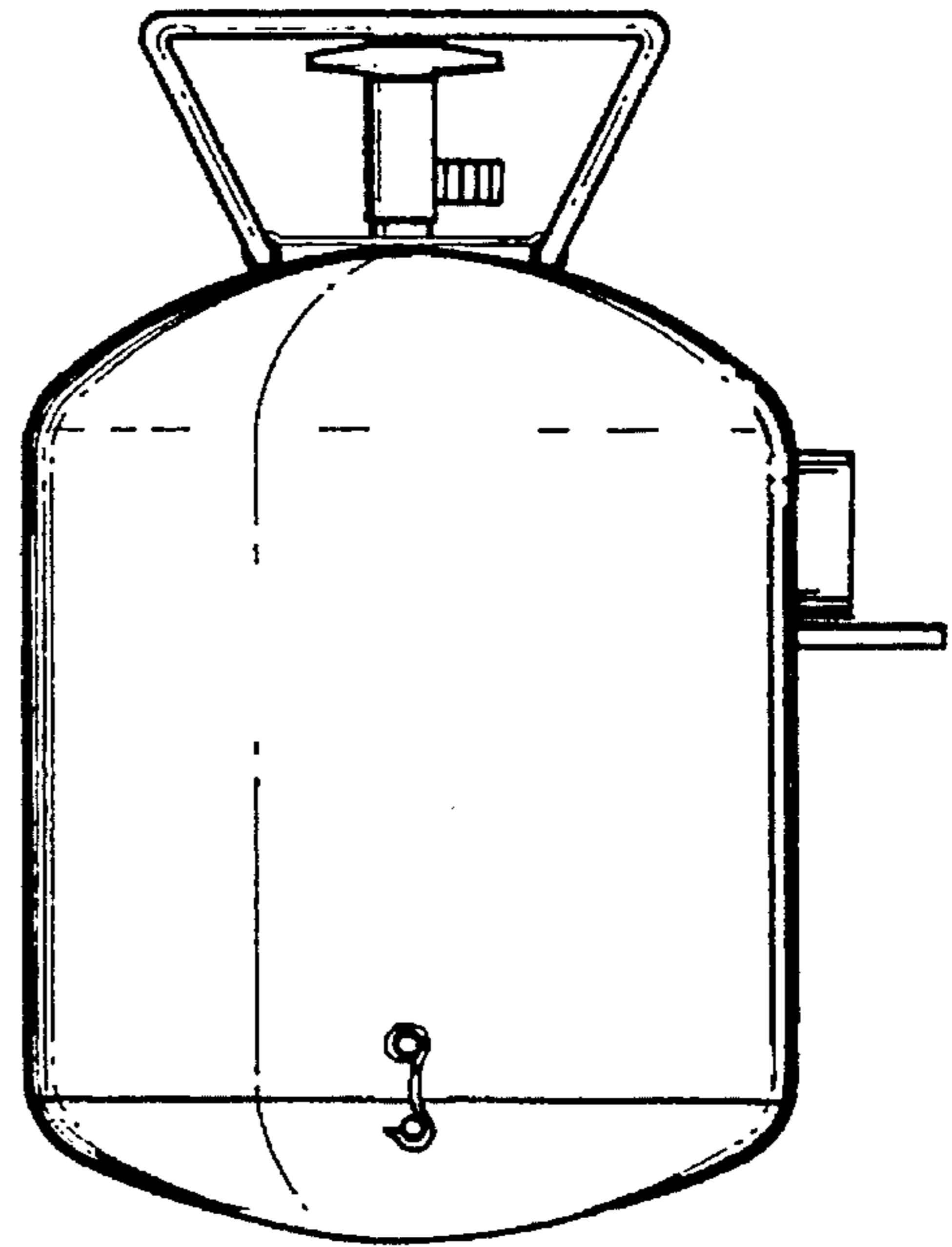

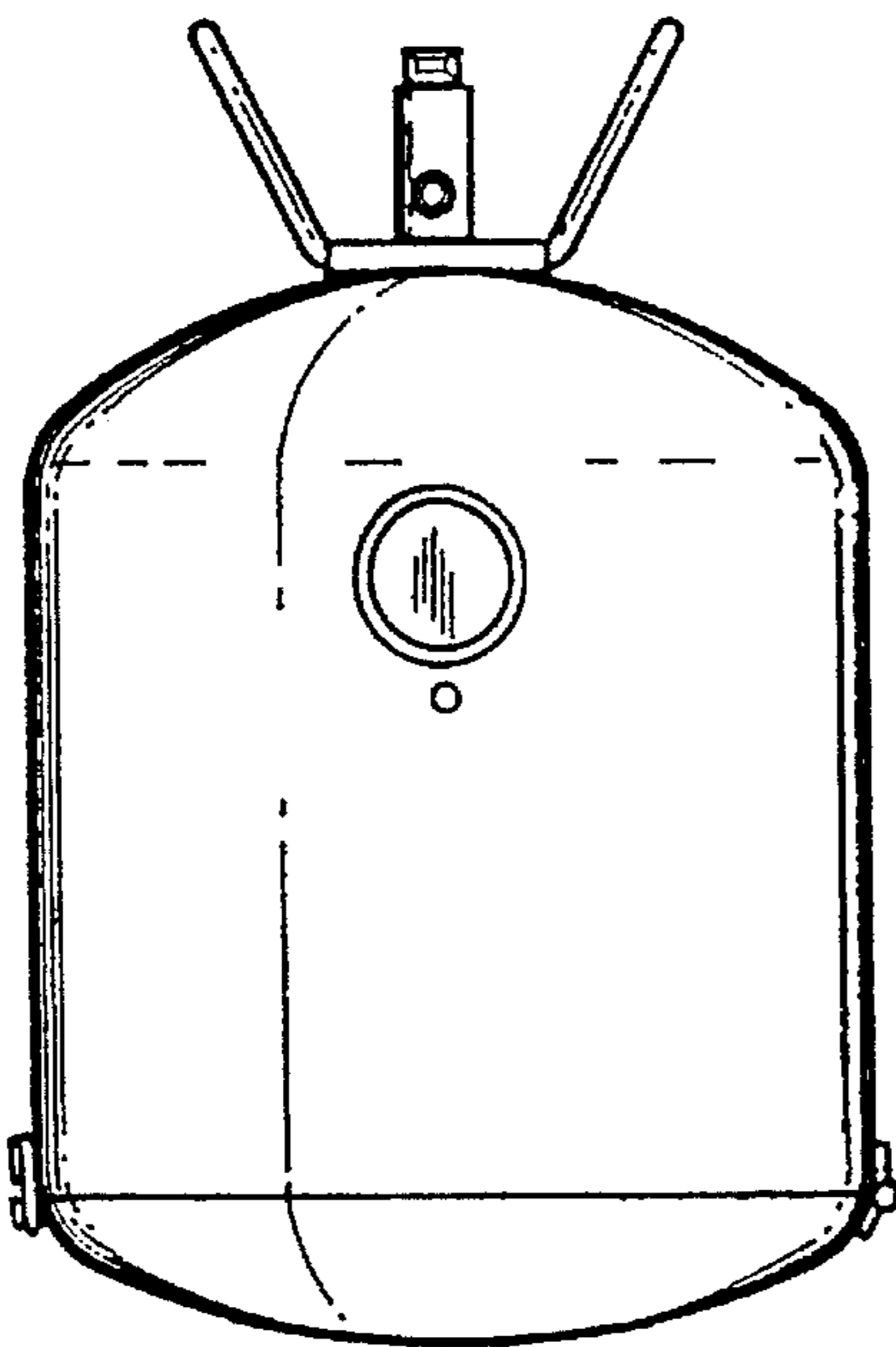

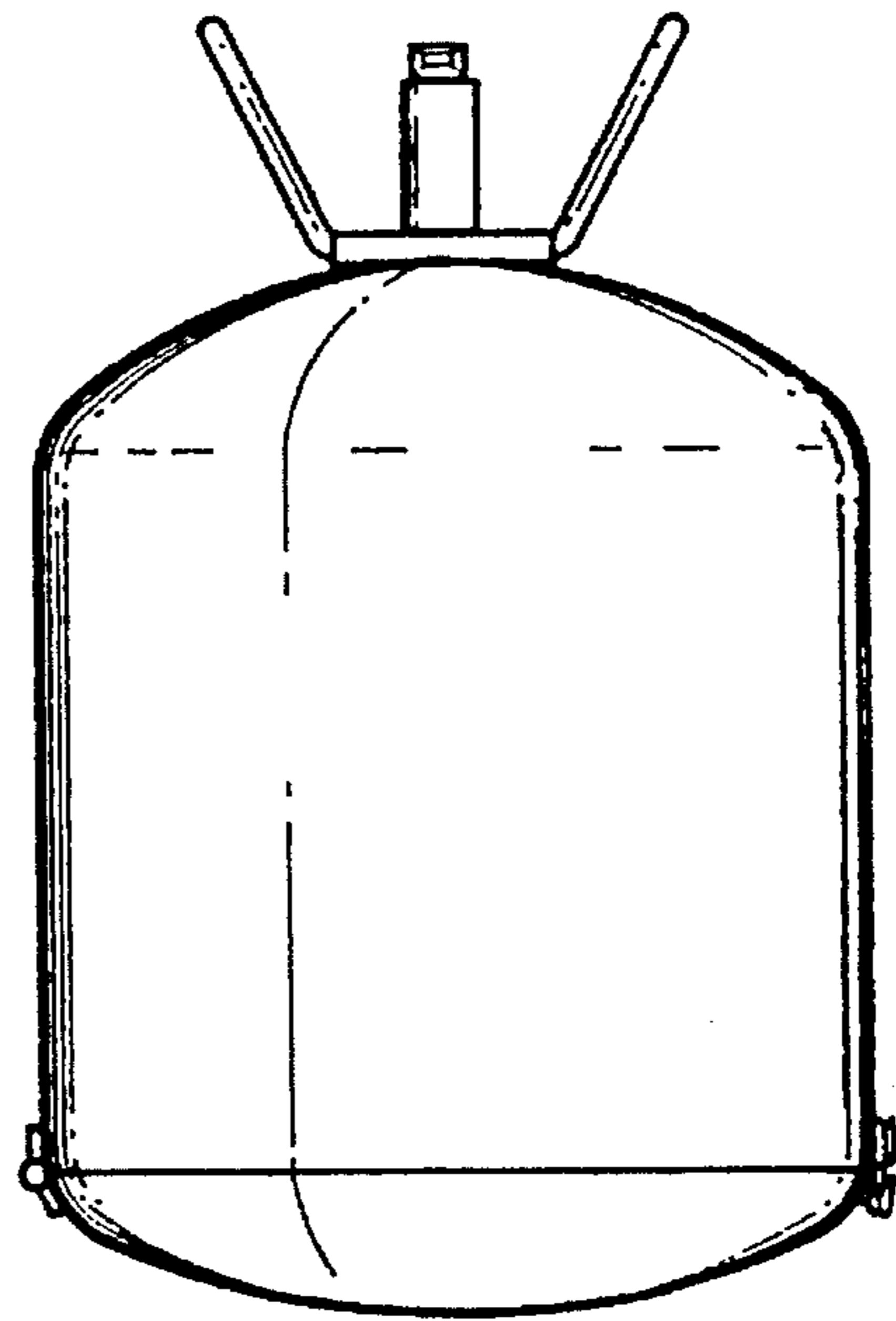
