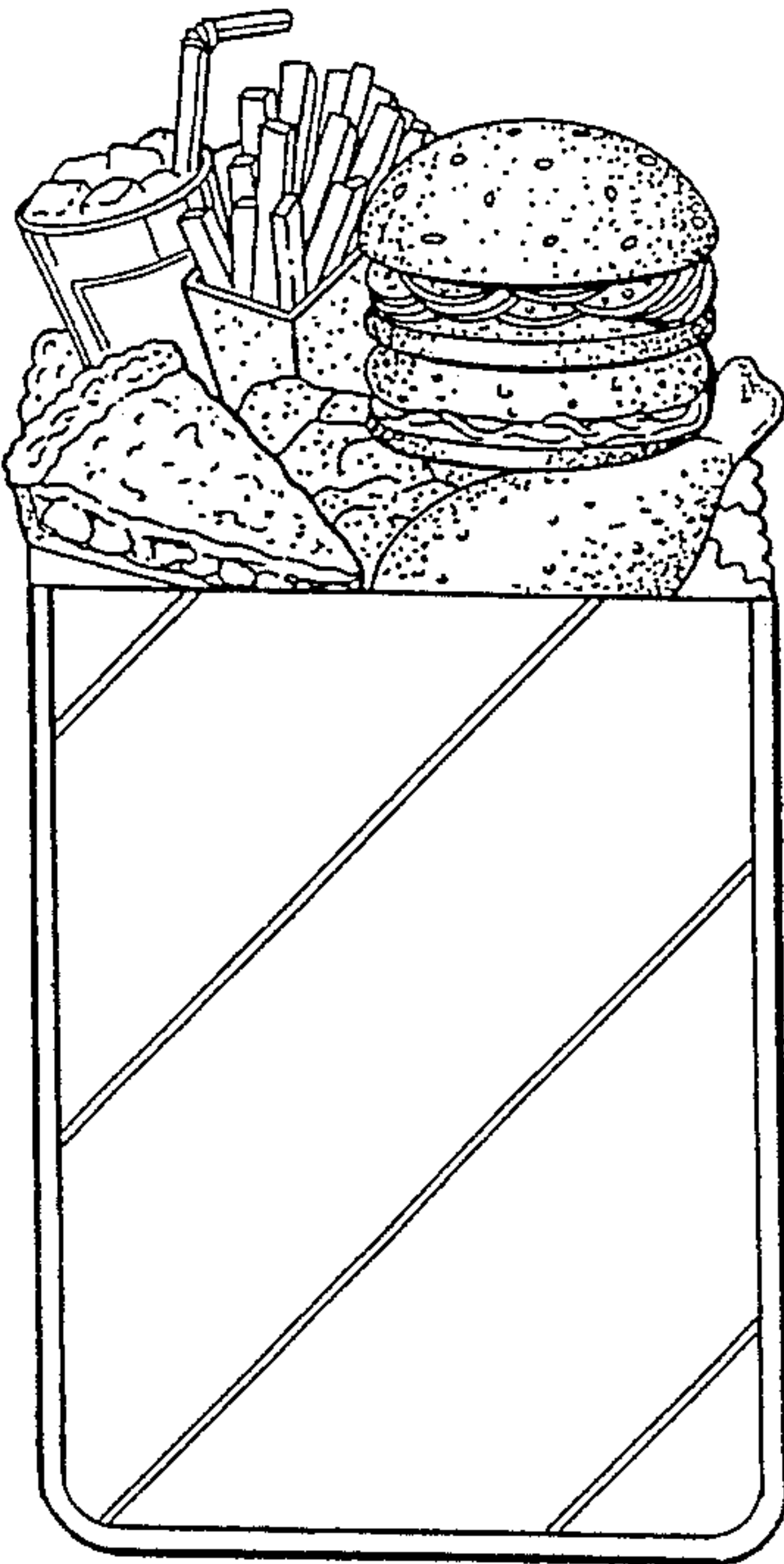
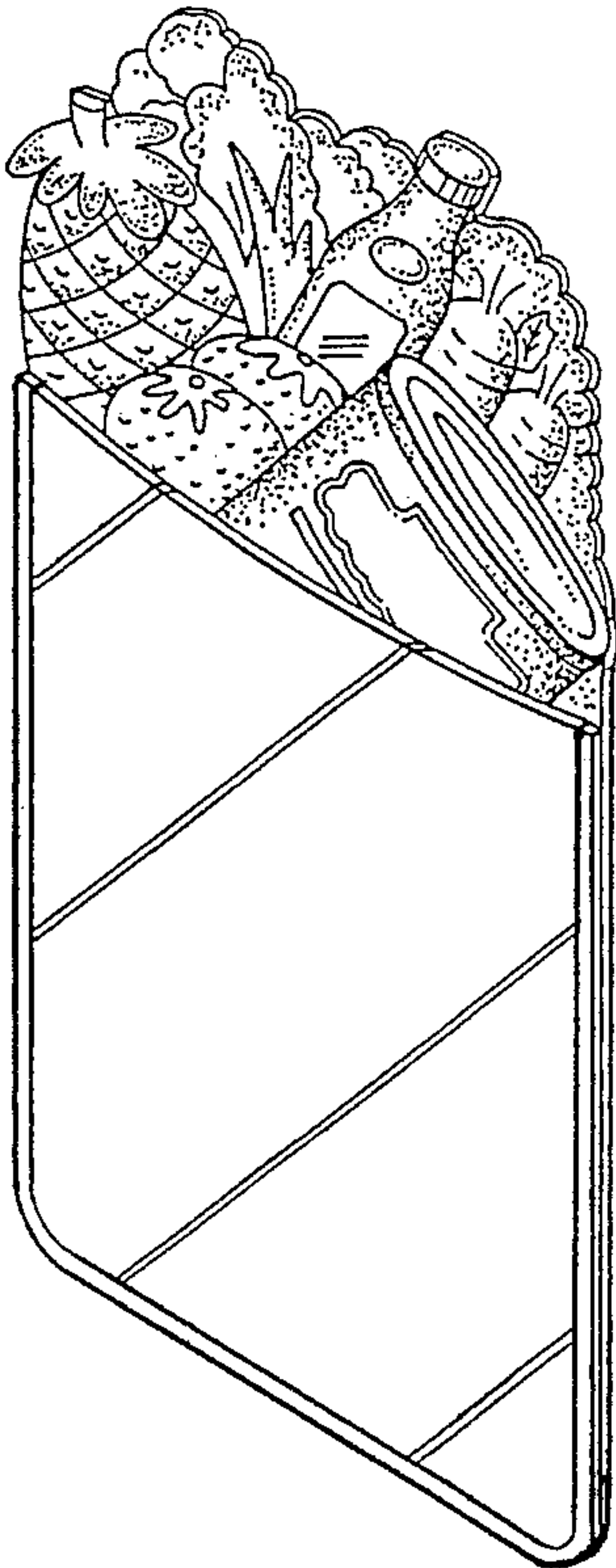
The ornamental design for a coupon holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a coupon holder showing my

new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a rear elevational view thereof;  
FIG. 7 is a left side elevational view thereof;  
FIG. 8 is a front elevational view of an alternate embodiment of the design shown in FIG. 1, the rear being planar and unadorned, the top bottom and sides being identical to FIGS. 2, 4, 5 and 7 except for the contour of the upper figurative portion of the embodiment;  
FIG. 9 is a front elevational view of a third embodiment of the design shown in FIG. 1, the rear being planar and unadorned, the top bottom and sides being identical to FIGS. 2, 4, 5 and 7 except for the contour of the upper figurative portion of the embodiment;  
FIG. 10 is a front elevational view of a fourth embodiment of the design shown in FIG. 1, the rear being planar and unadorned, the top bottom and sides being identical to FIGS. 2, 4, 5 and 7 except for the contour of the upper figurative portion of the embodiment;  
FIG. 11 is a front elevational view of a fifth embodiment of the design shown in FIG. 1, the rear being planar and unadorned, the top bottom and sides being identical to FIGS. 2, 4, 5 and 7 except for the contour of the upper figurative portion of the embodiment; and,  
FIG. 12 is a front elevational view of a sixth embodiment of the design shown in FIG. 1, the rear being planar and unadorned, the top bottom and sides being identical to FIGS. 2, 4, 5 and 7 except for the contour of the upper figurative portion of the embodiment.

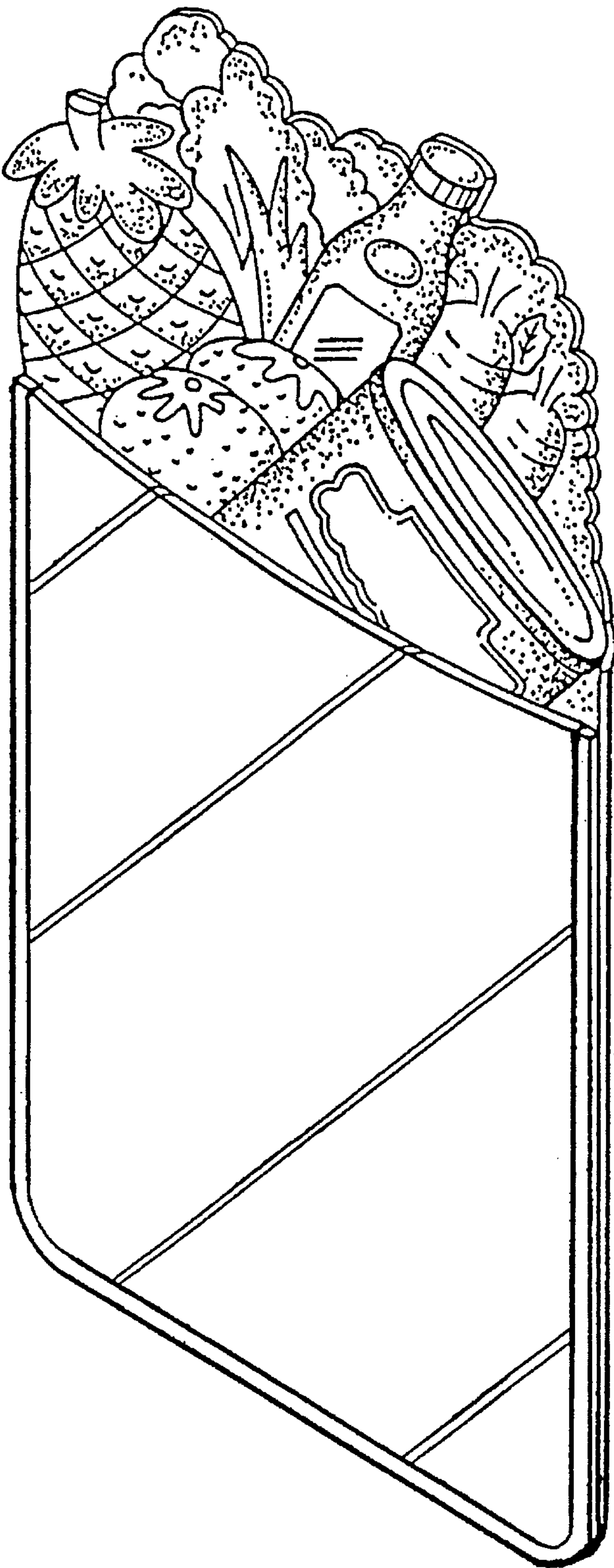

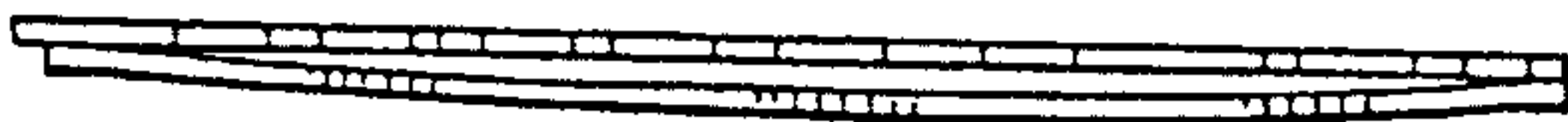

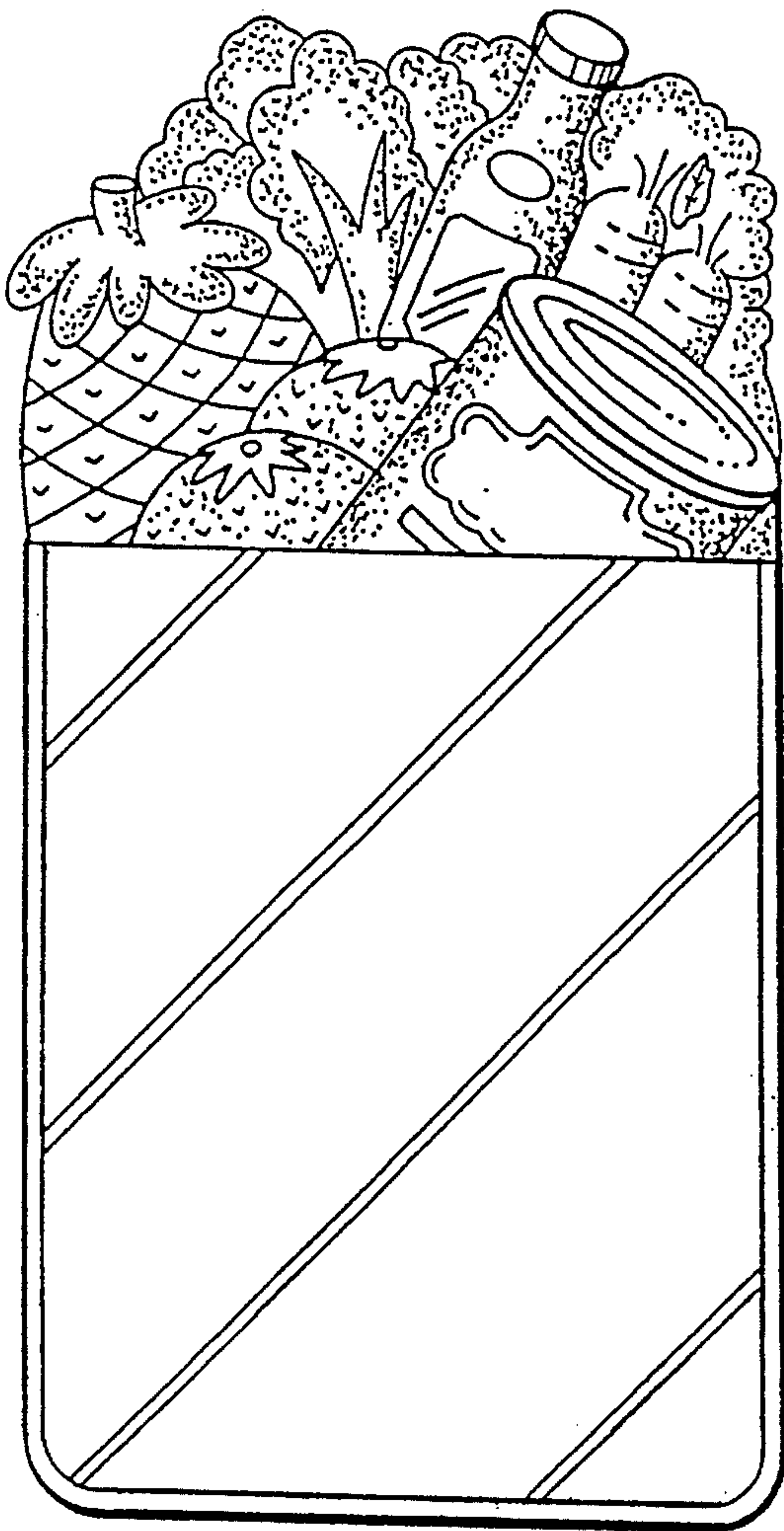

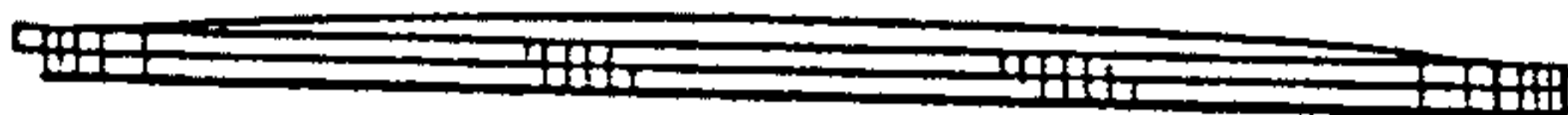

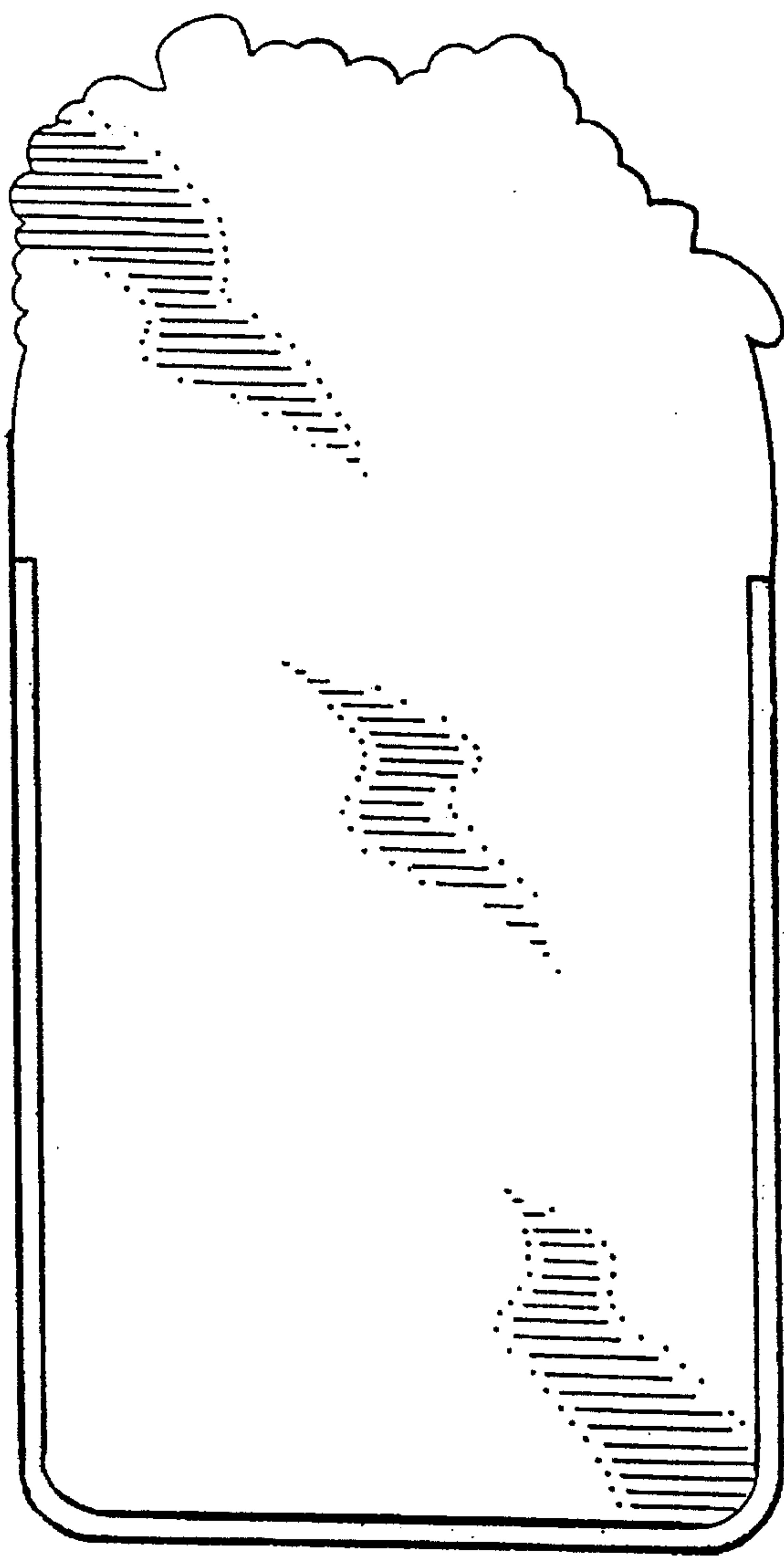

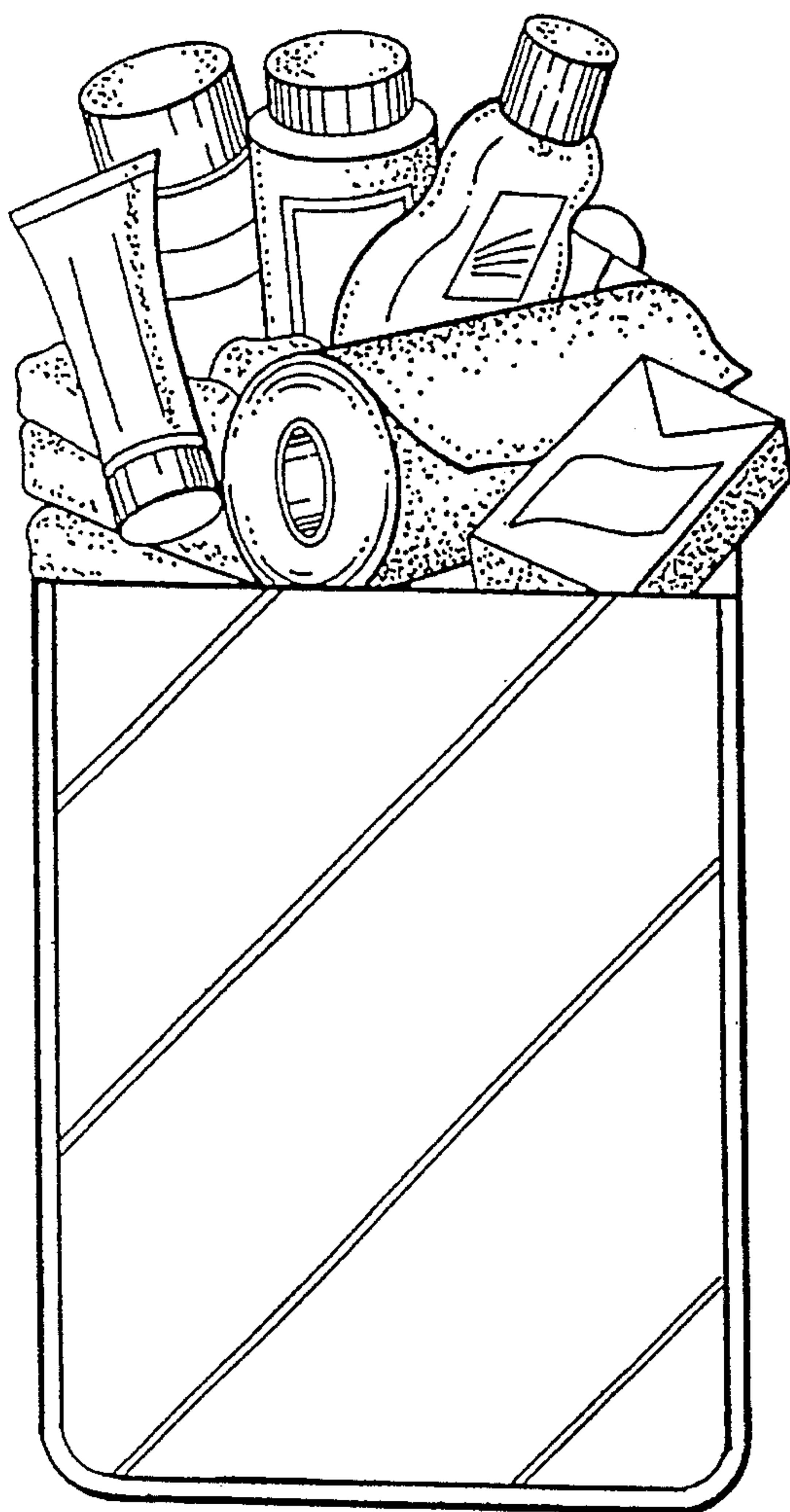

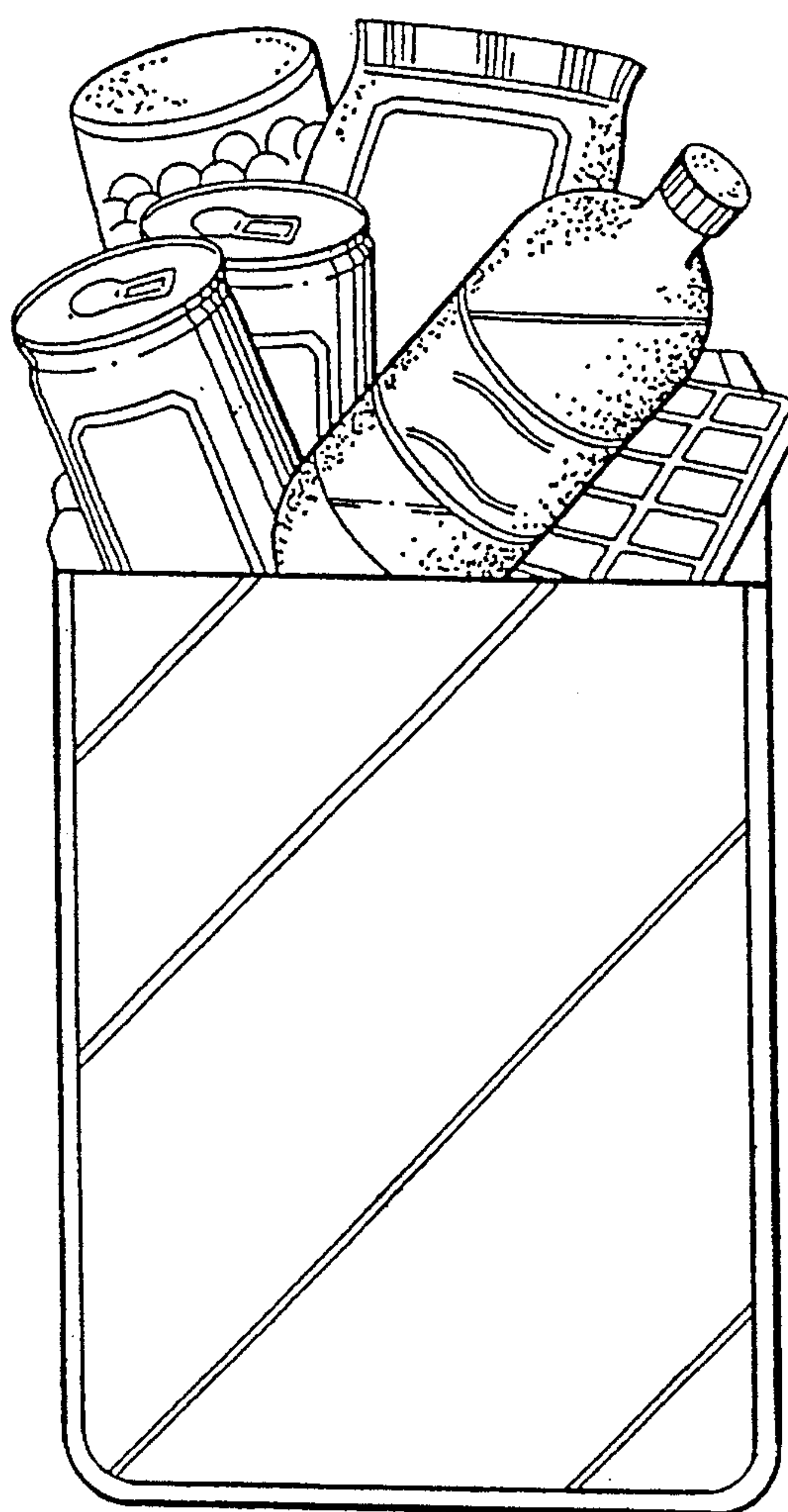

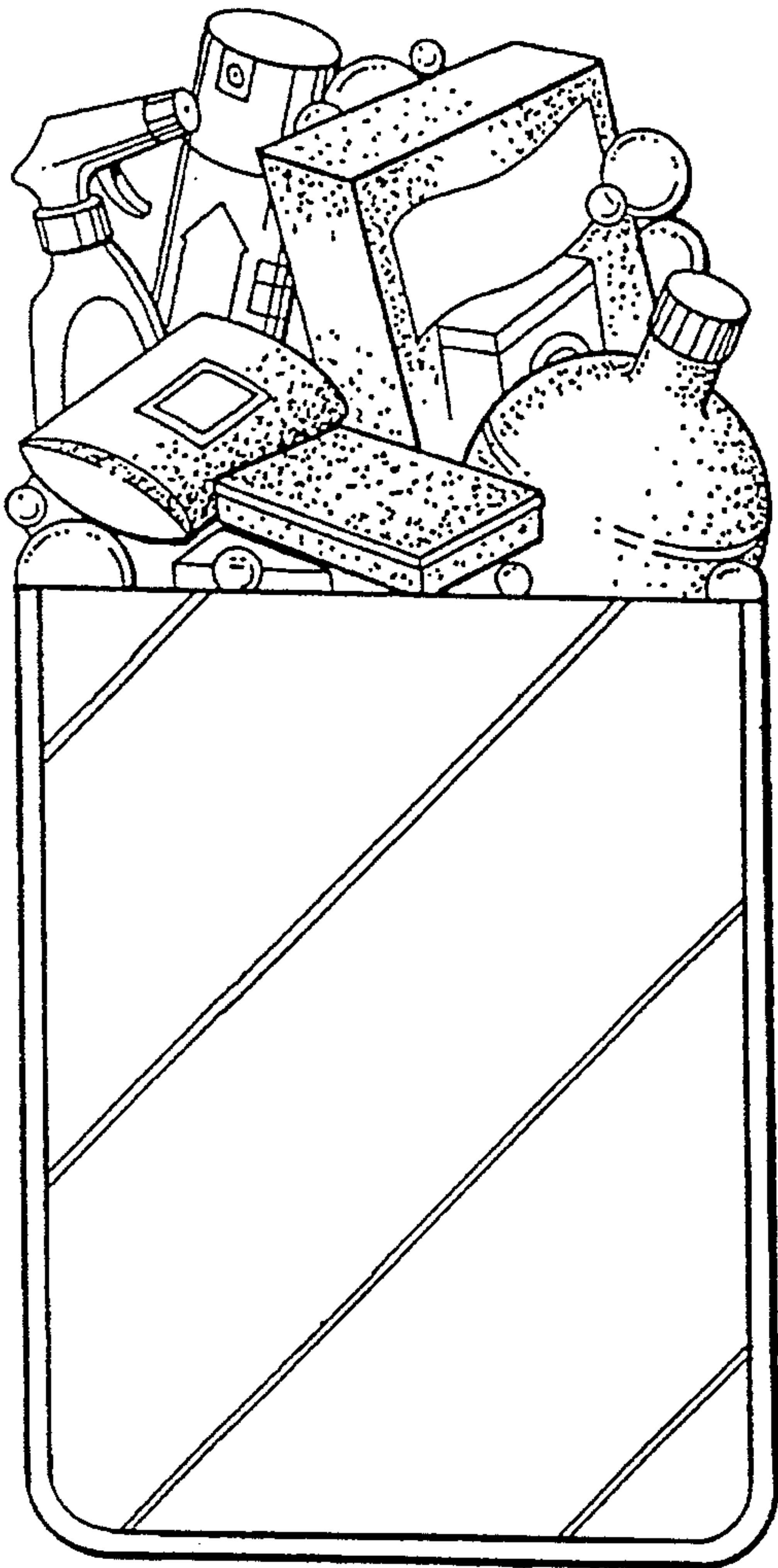

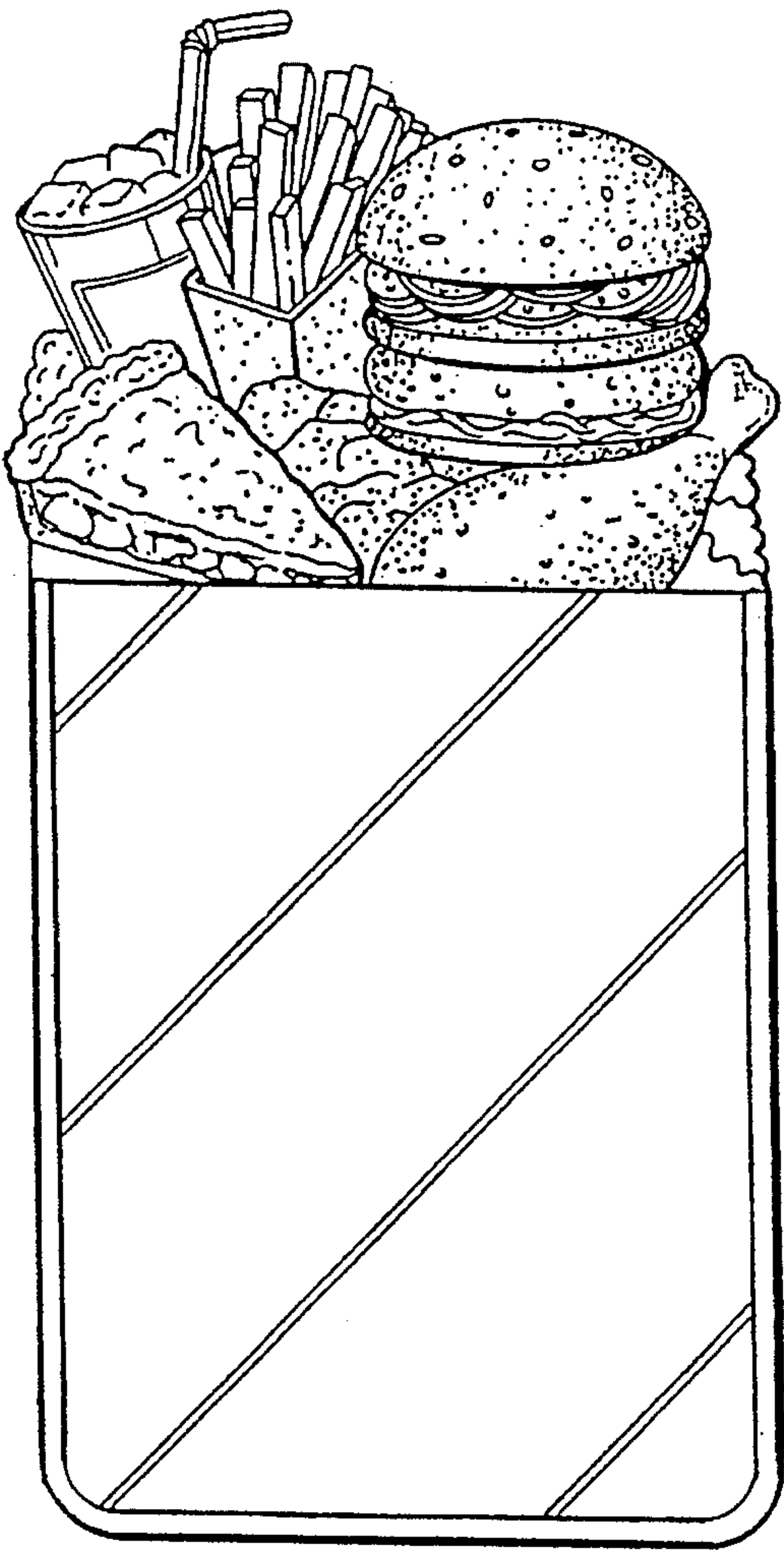

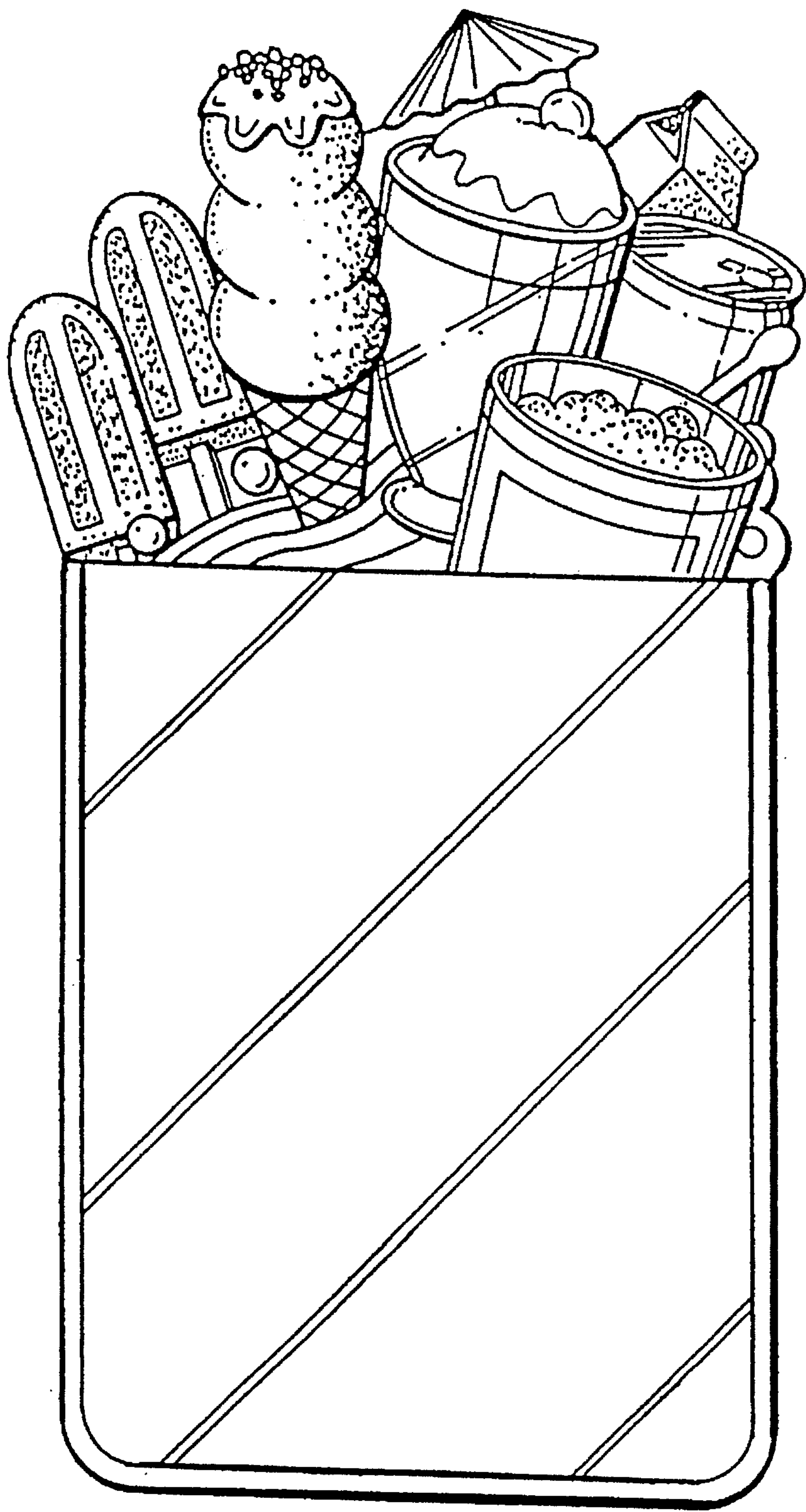
