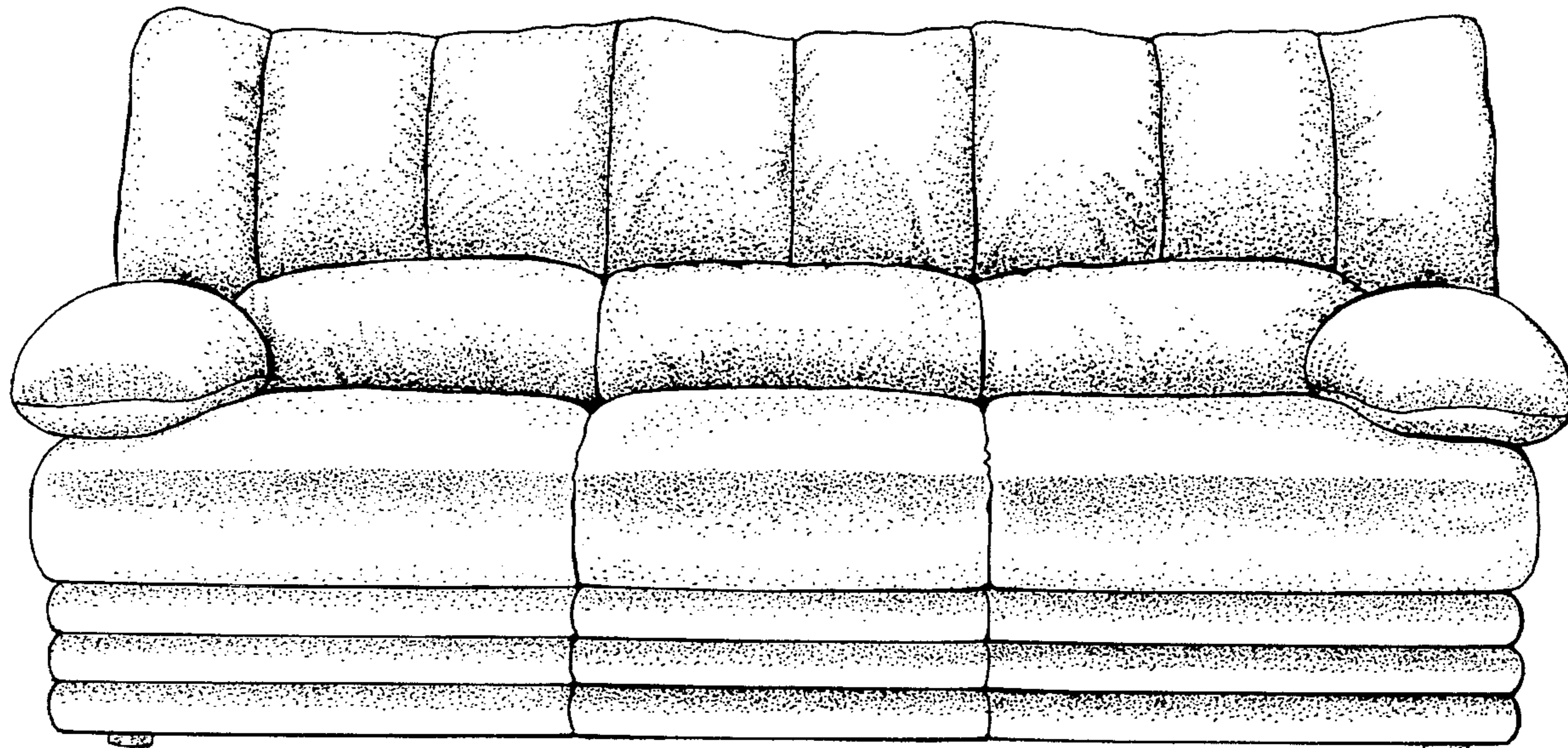
[57] CLAIM

The ornamental design for a seat of furniture, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a seat of furniture showing our new design in the form of a sofa;
FIG. 2 is a front elevational view;
FIG. 3 is a top plan view;
FIG. 4 is a right side elevational view, and the left side elevational view being a mirror image thereof; and,
FIG. 5 is a rear elevational view.

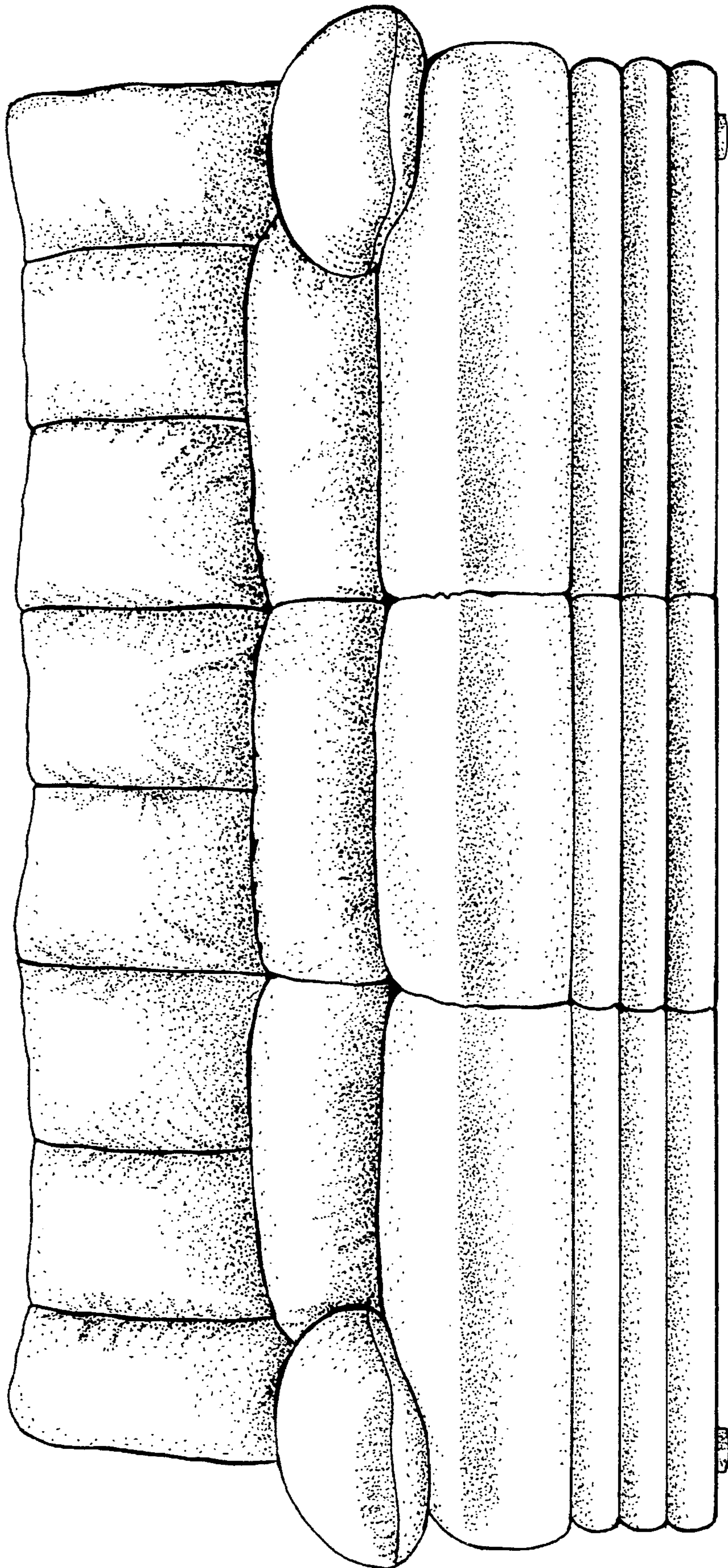

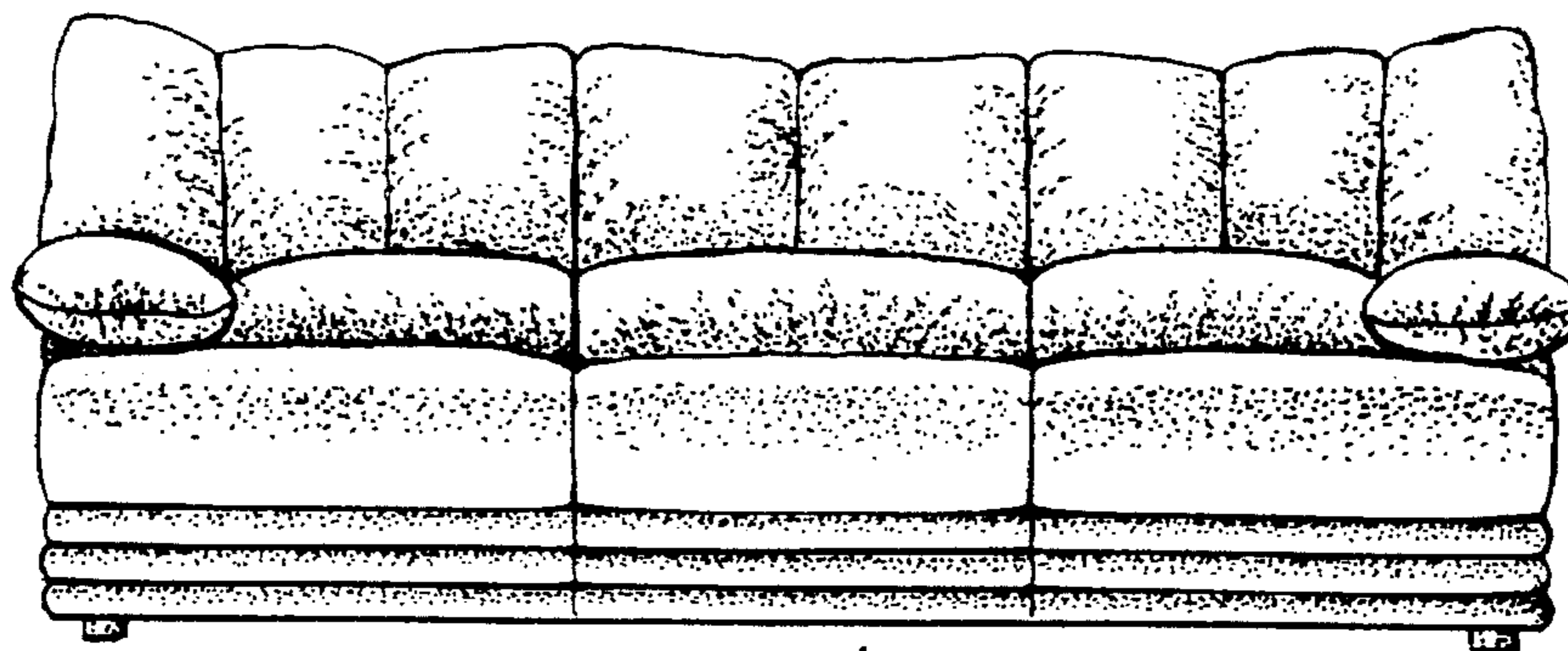

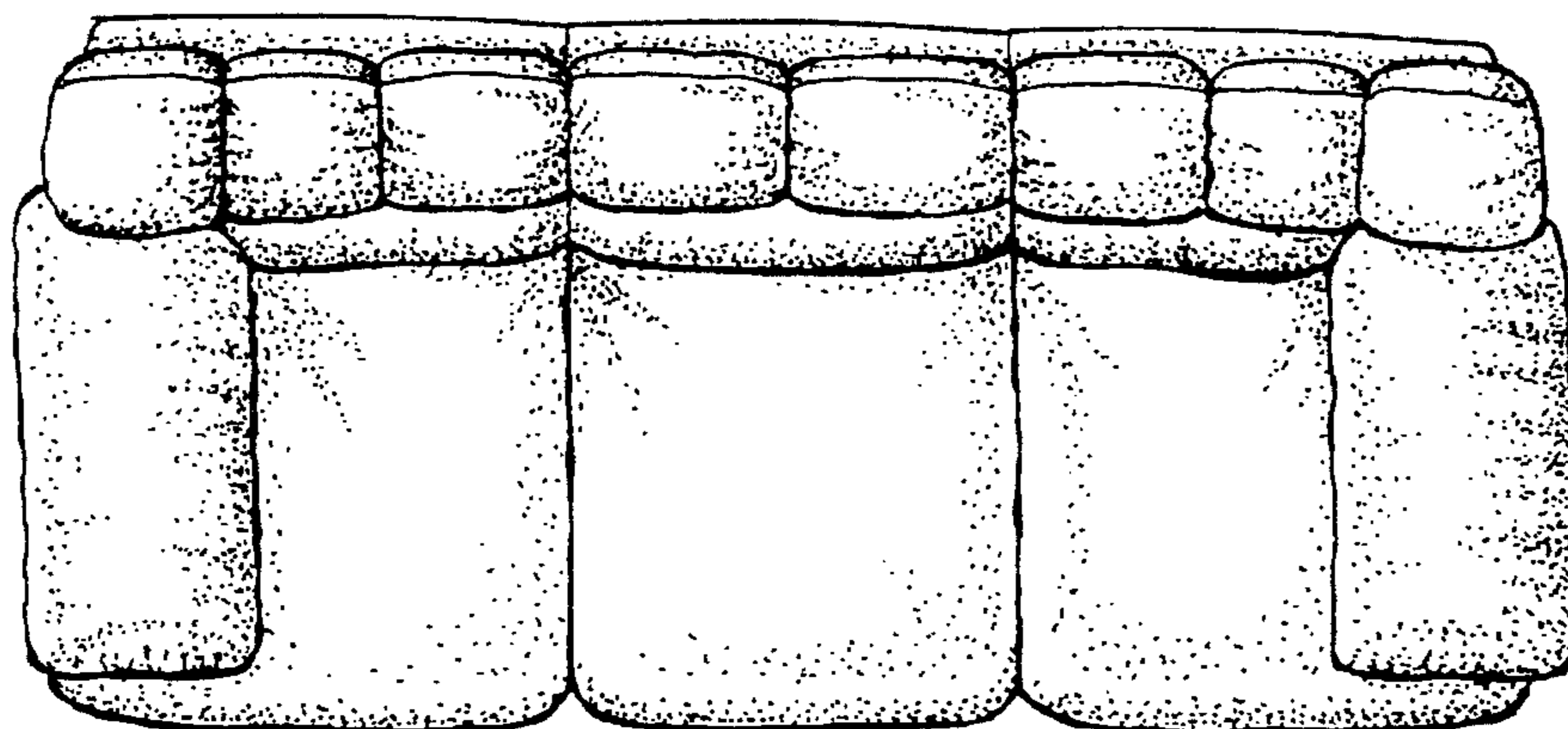

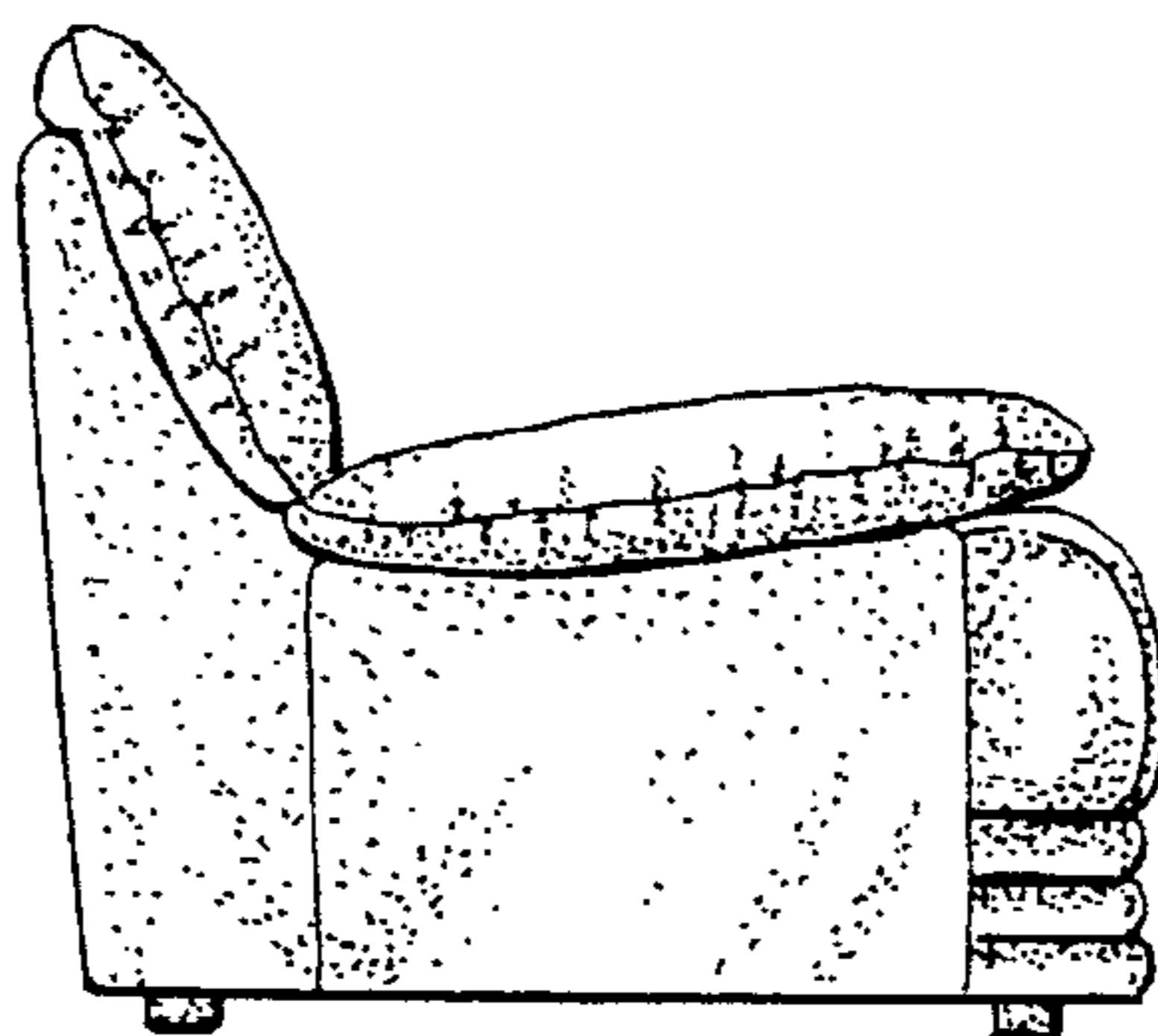

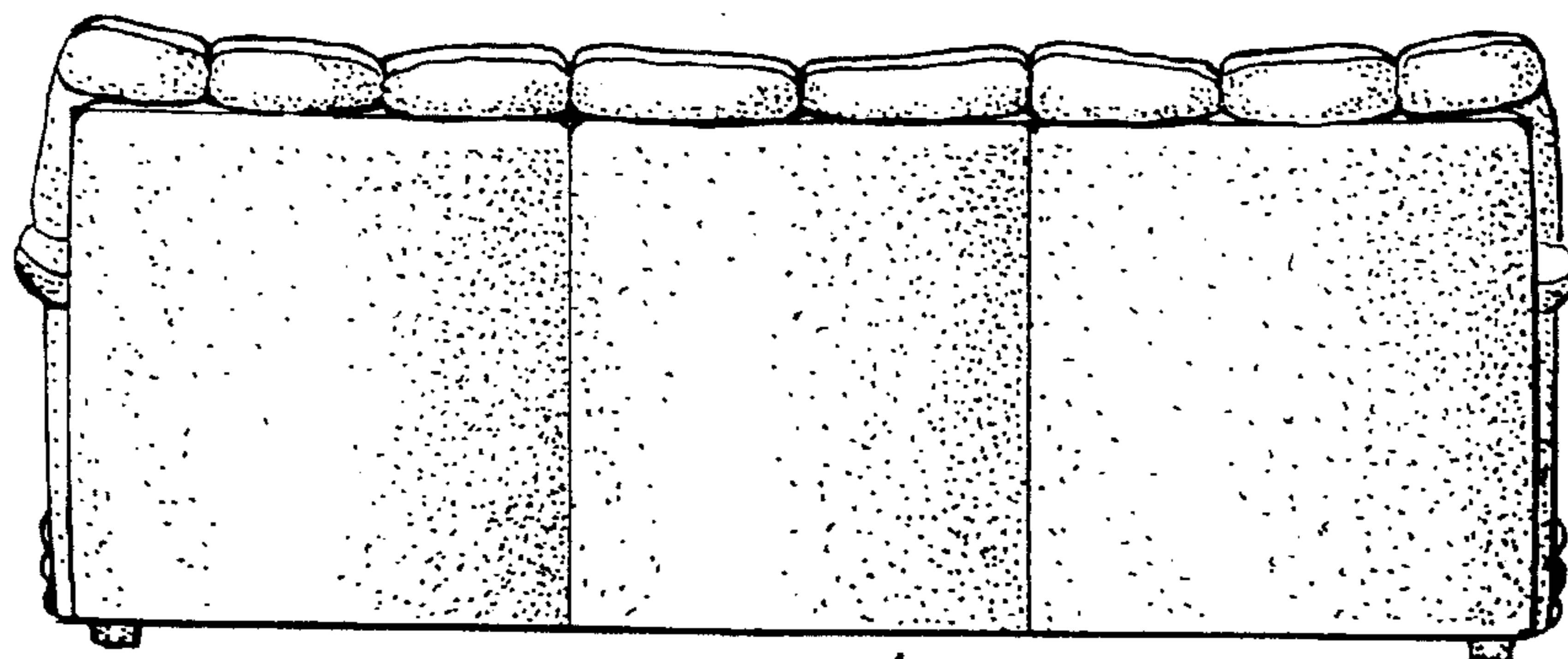
