FIG. 1 is a perspective view of an amusement gas truck showing my new design;

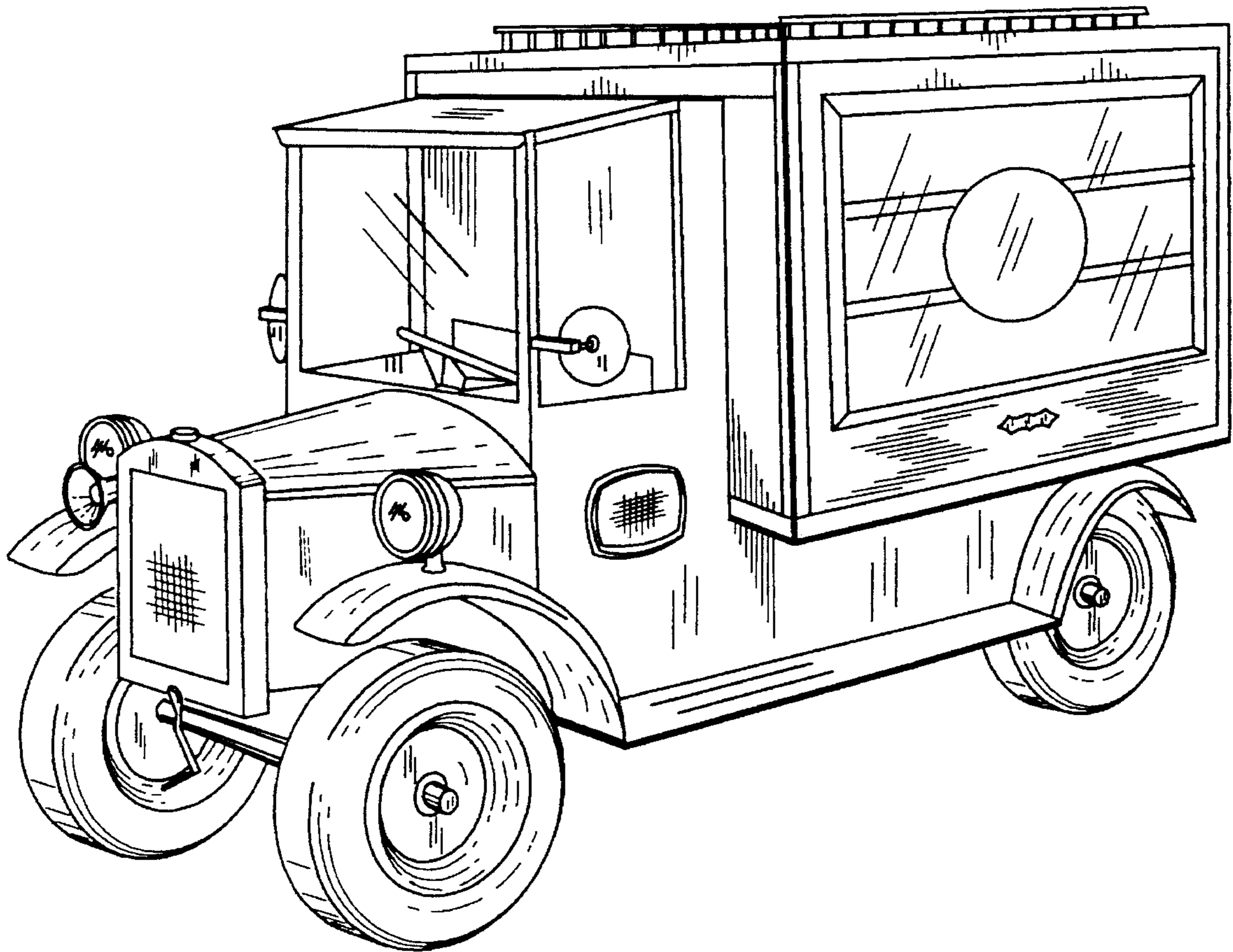
FIG. 2 is a second perspective view thereof;

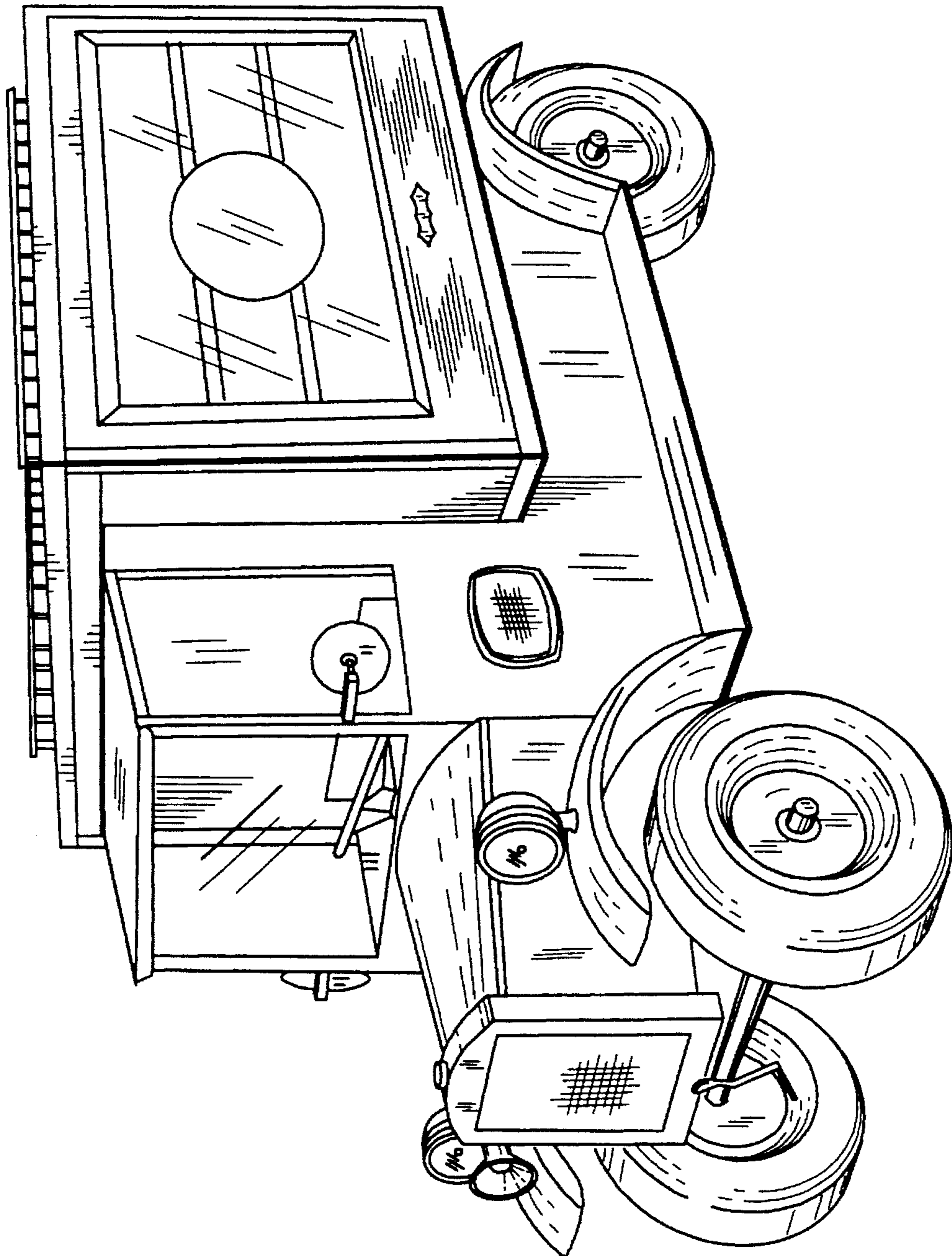

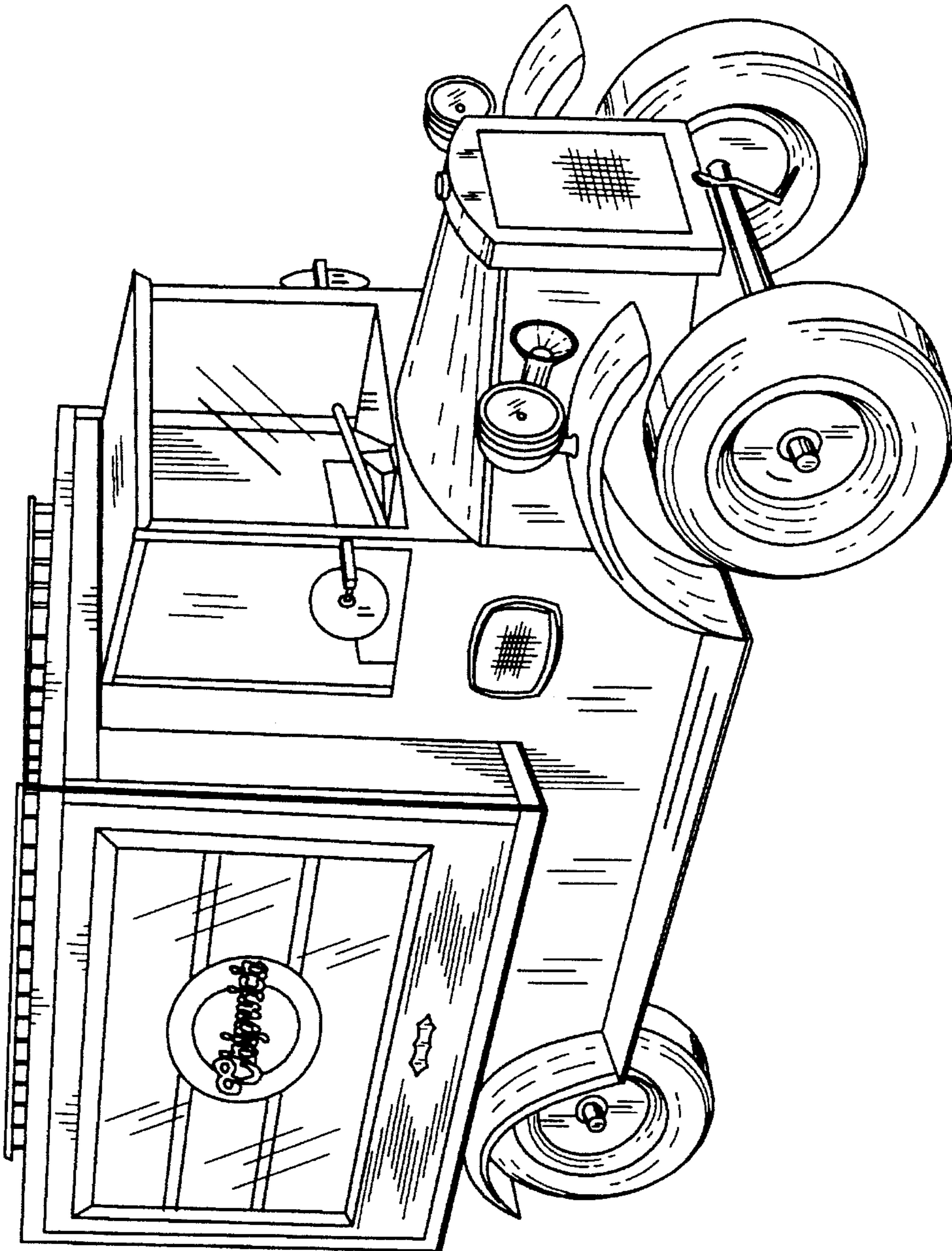

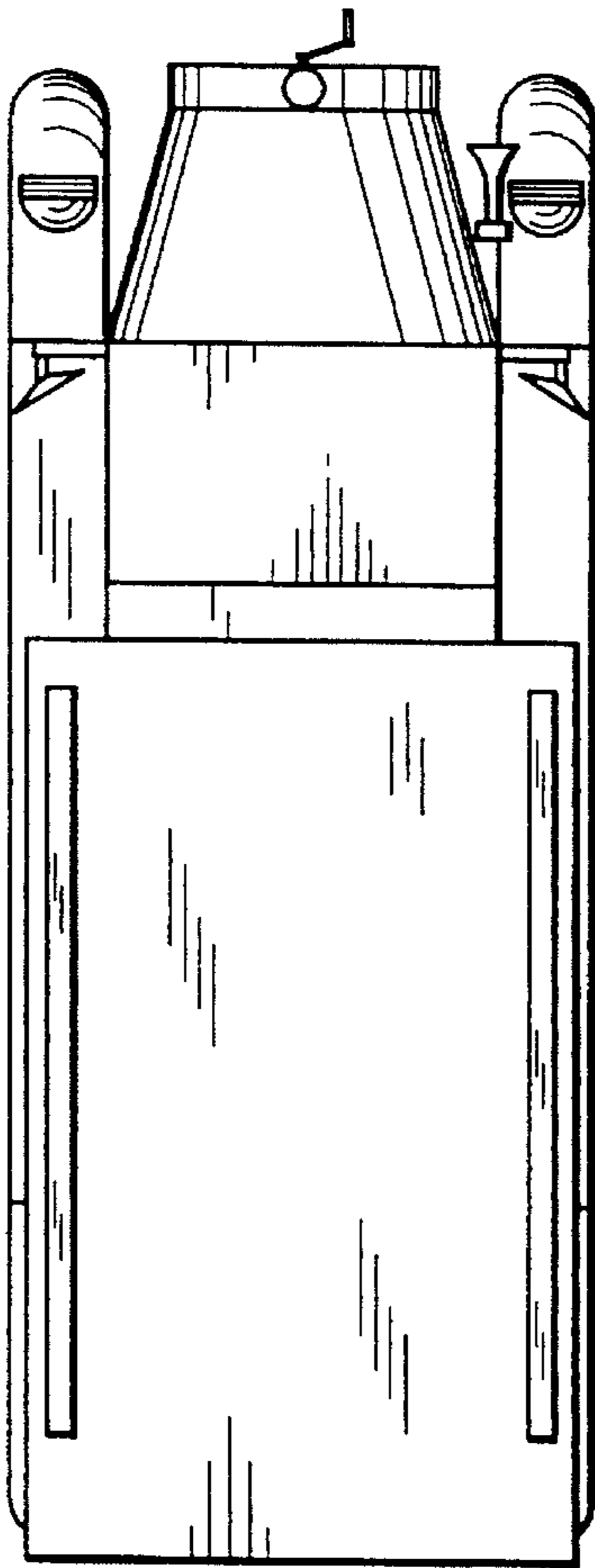

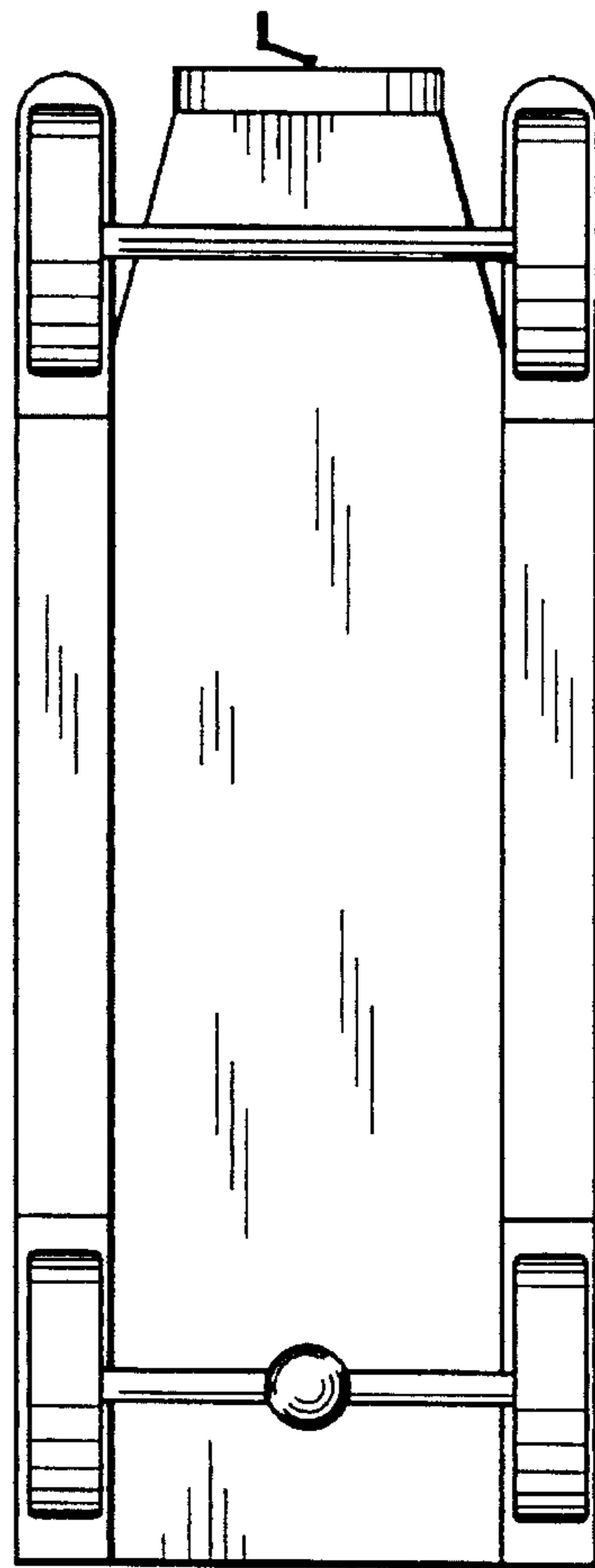

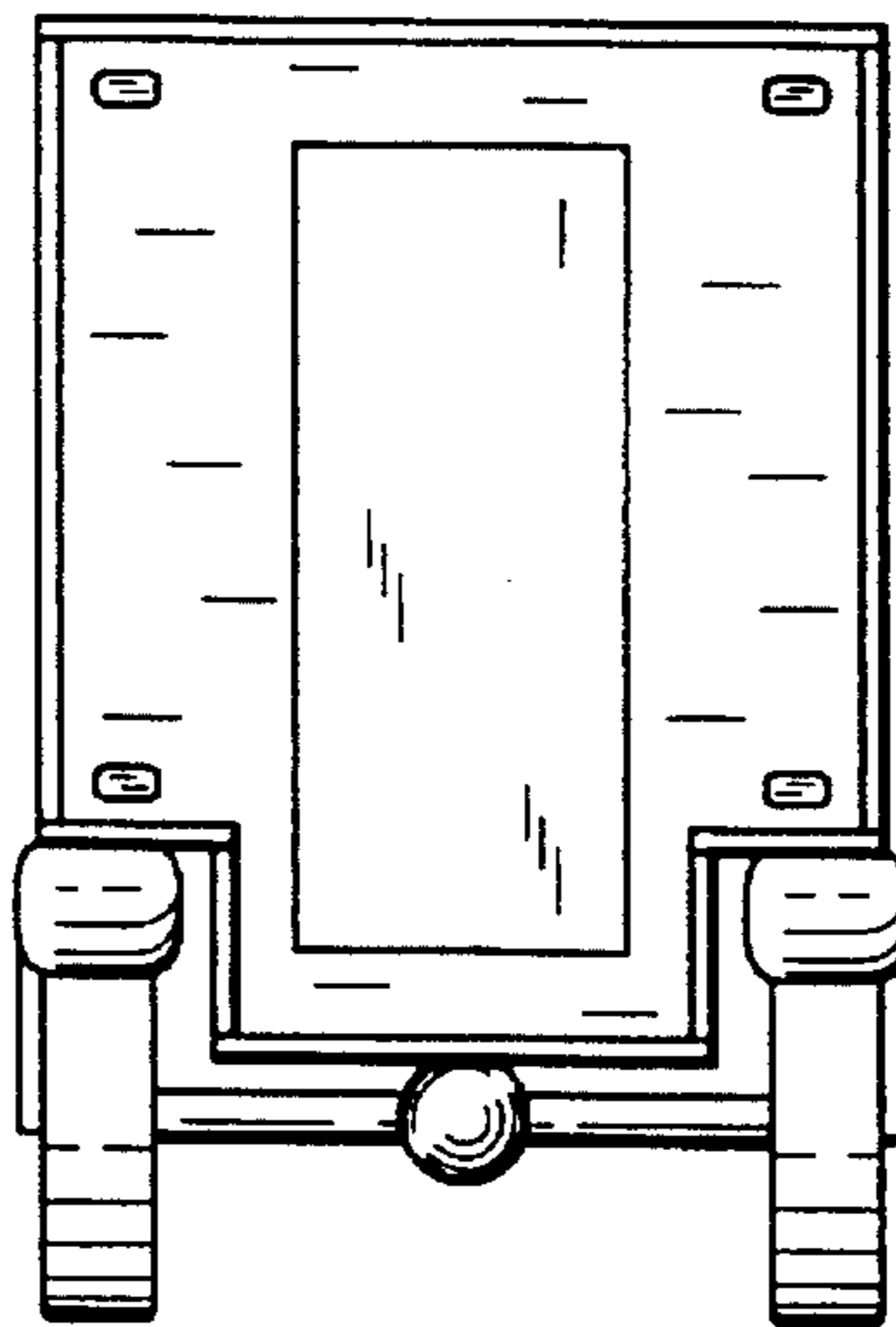

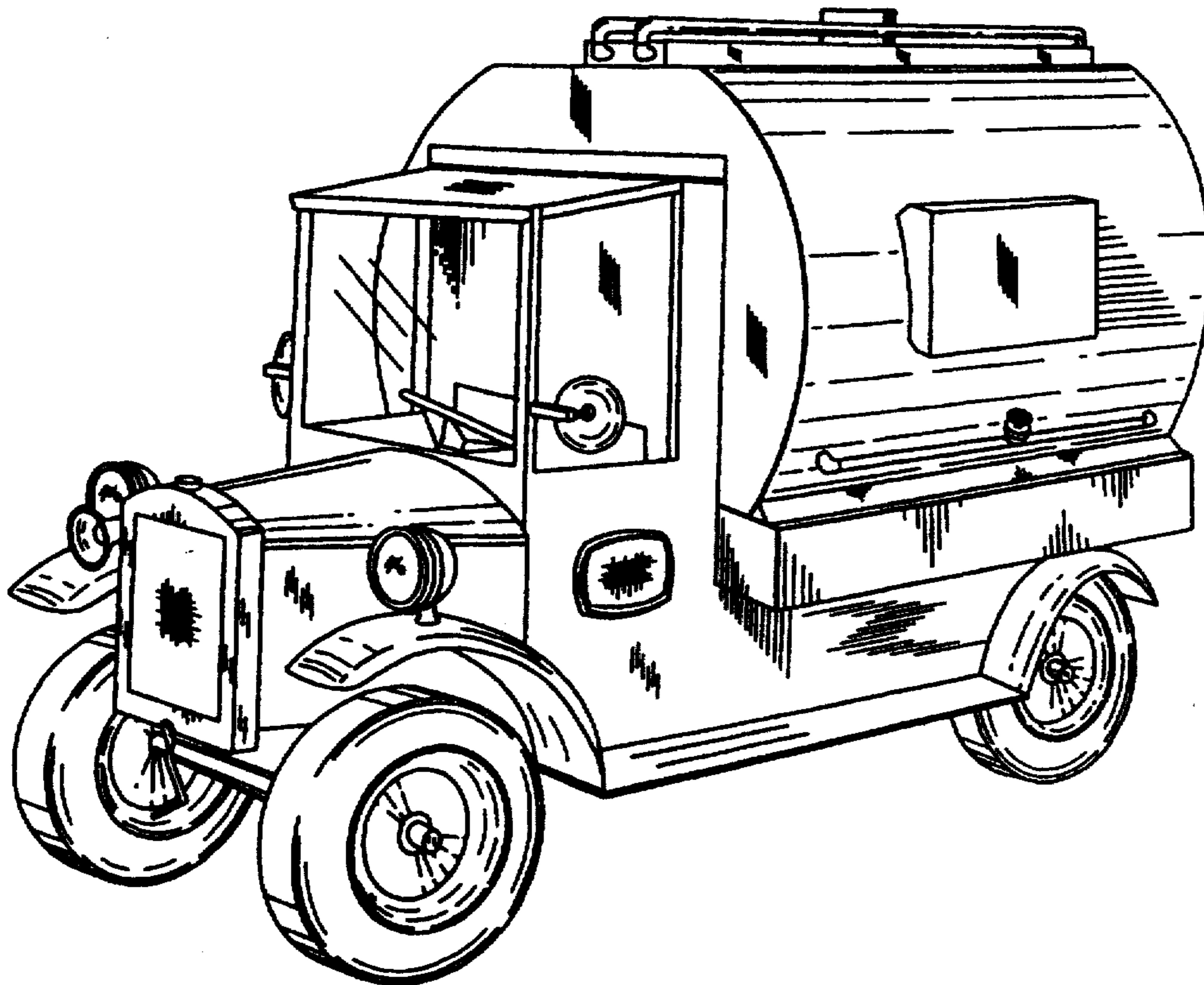

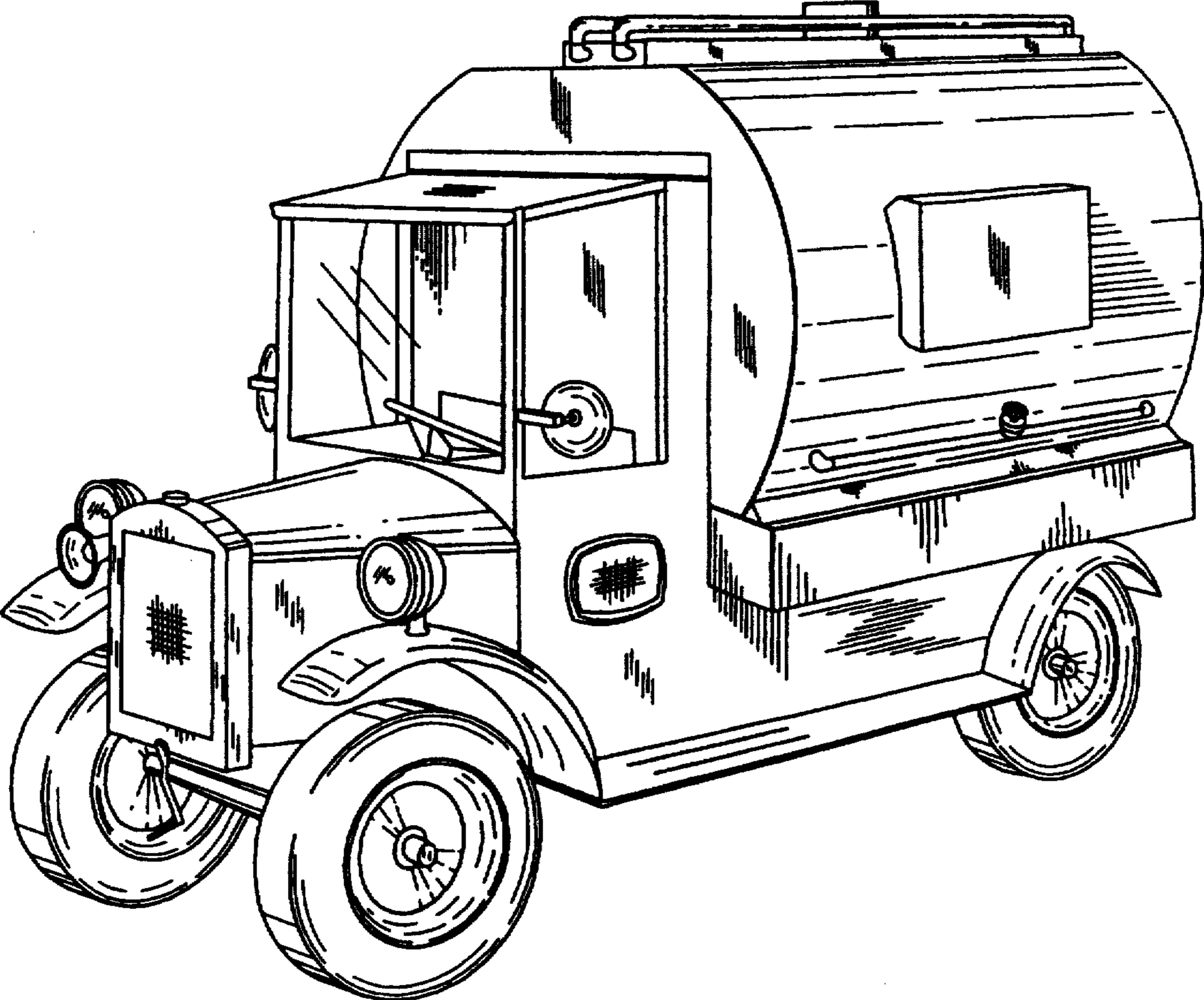

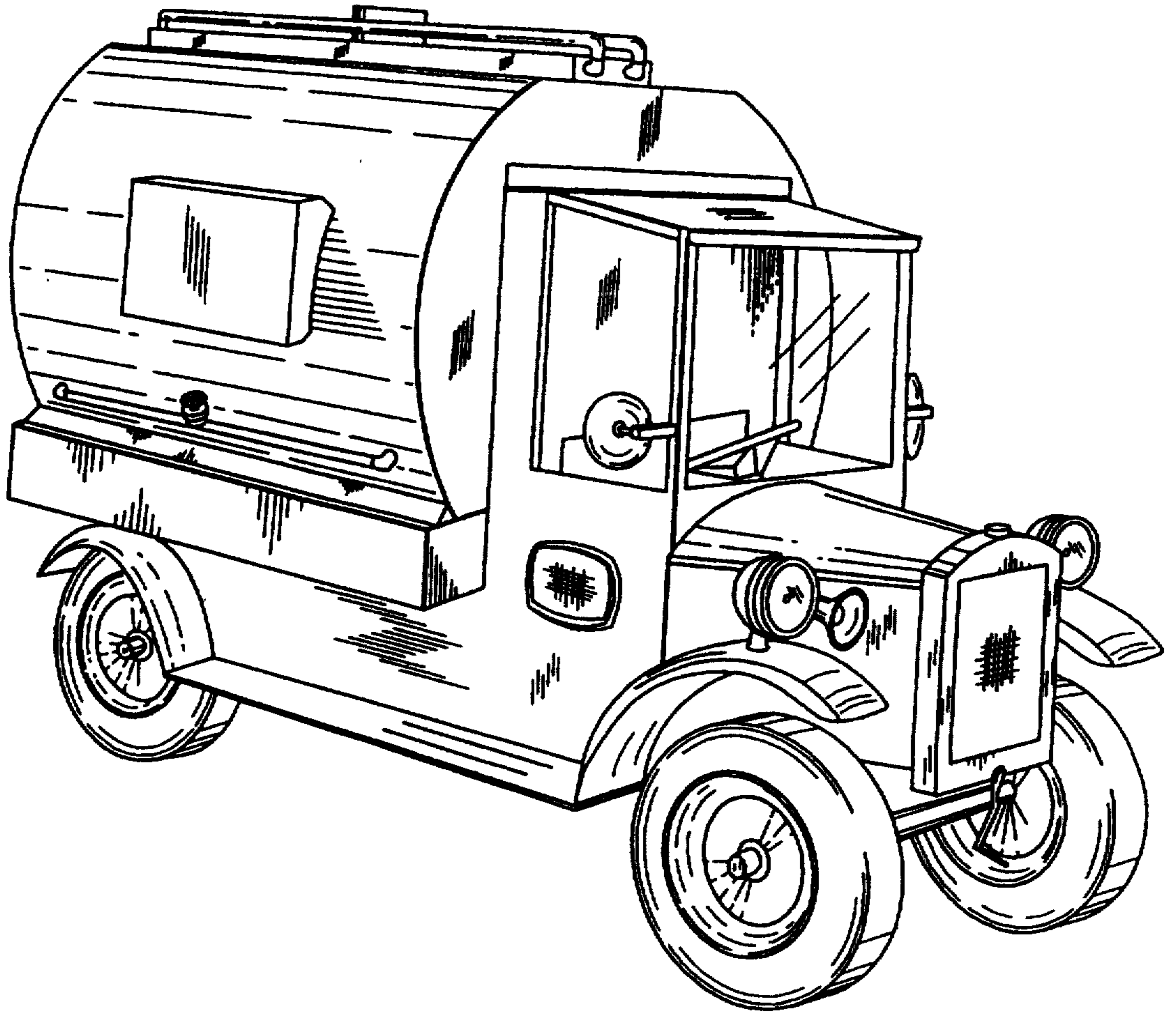

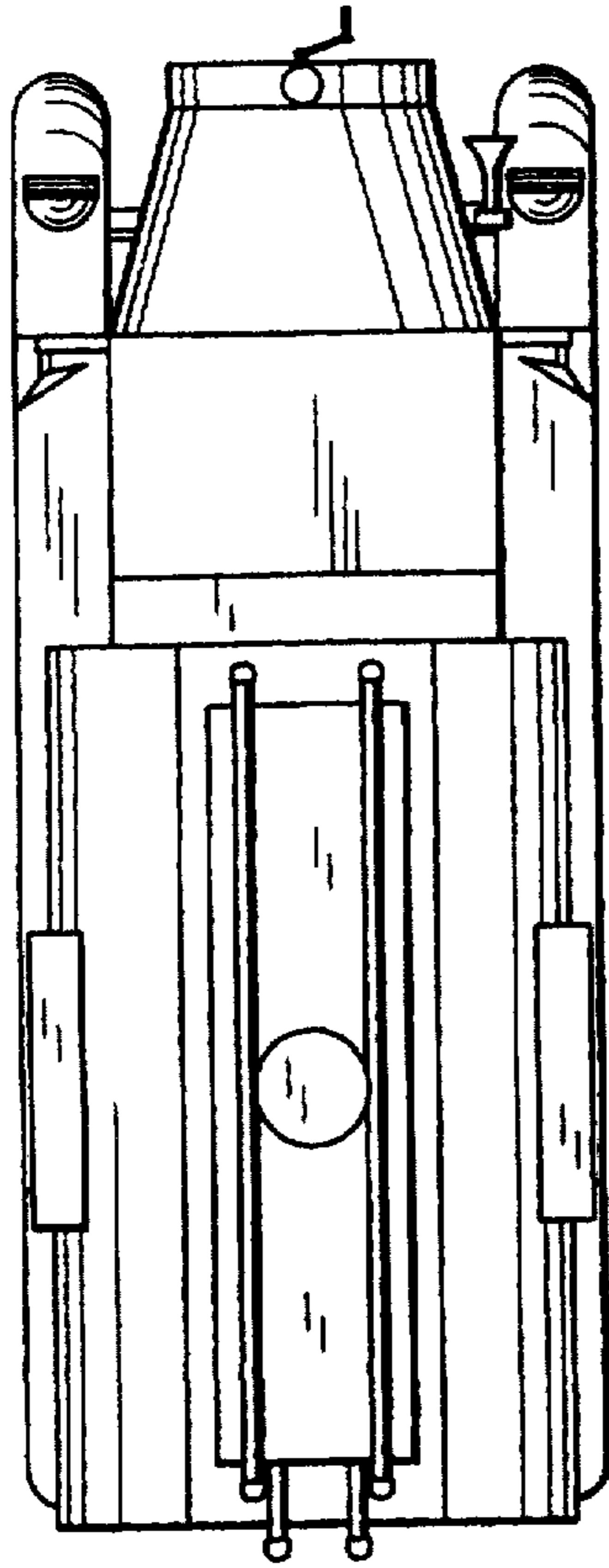

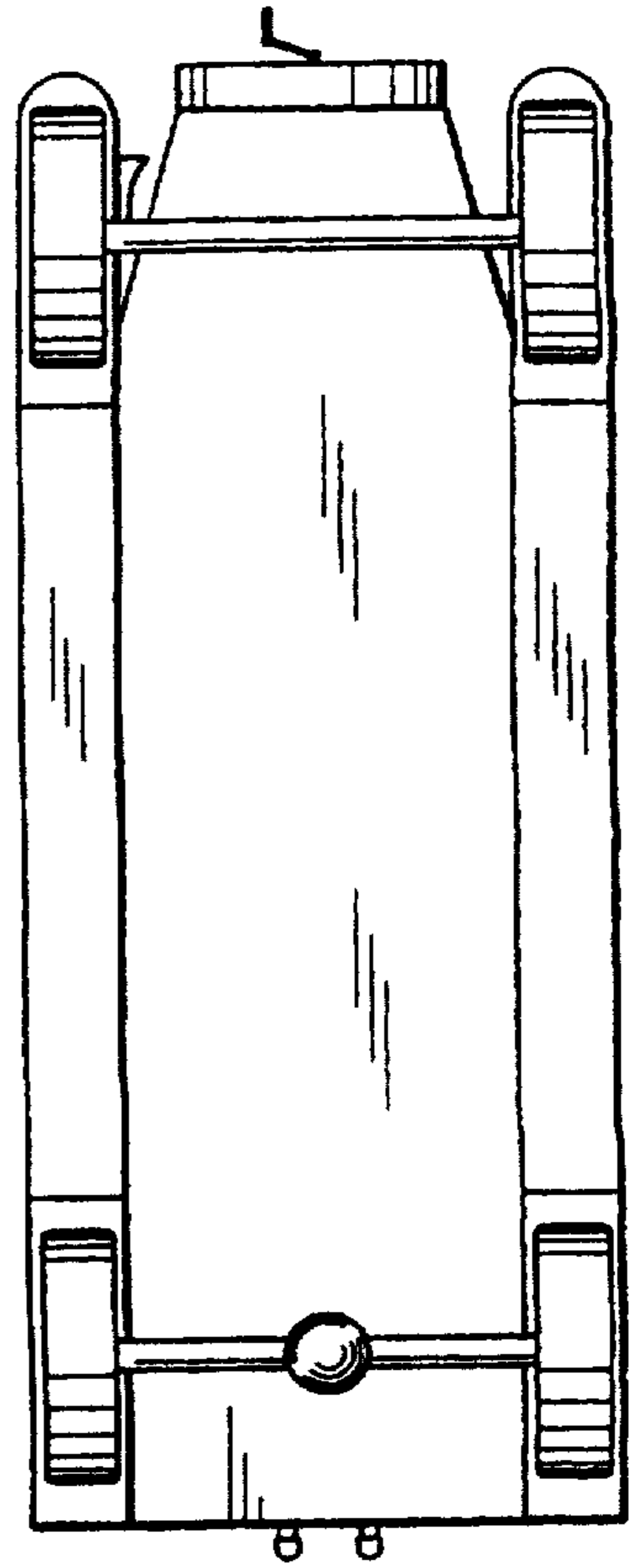

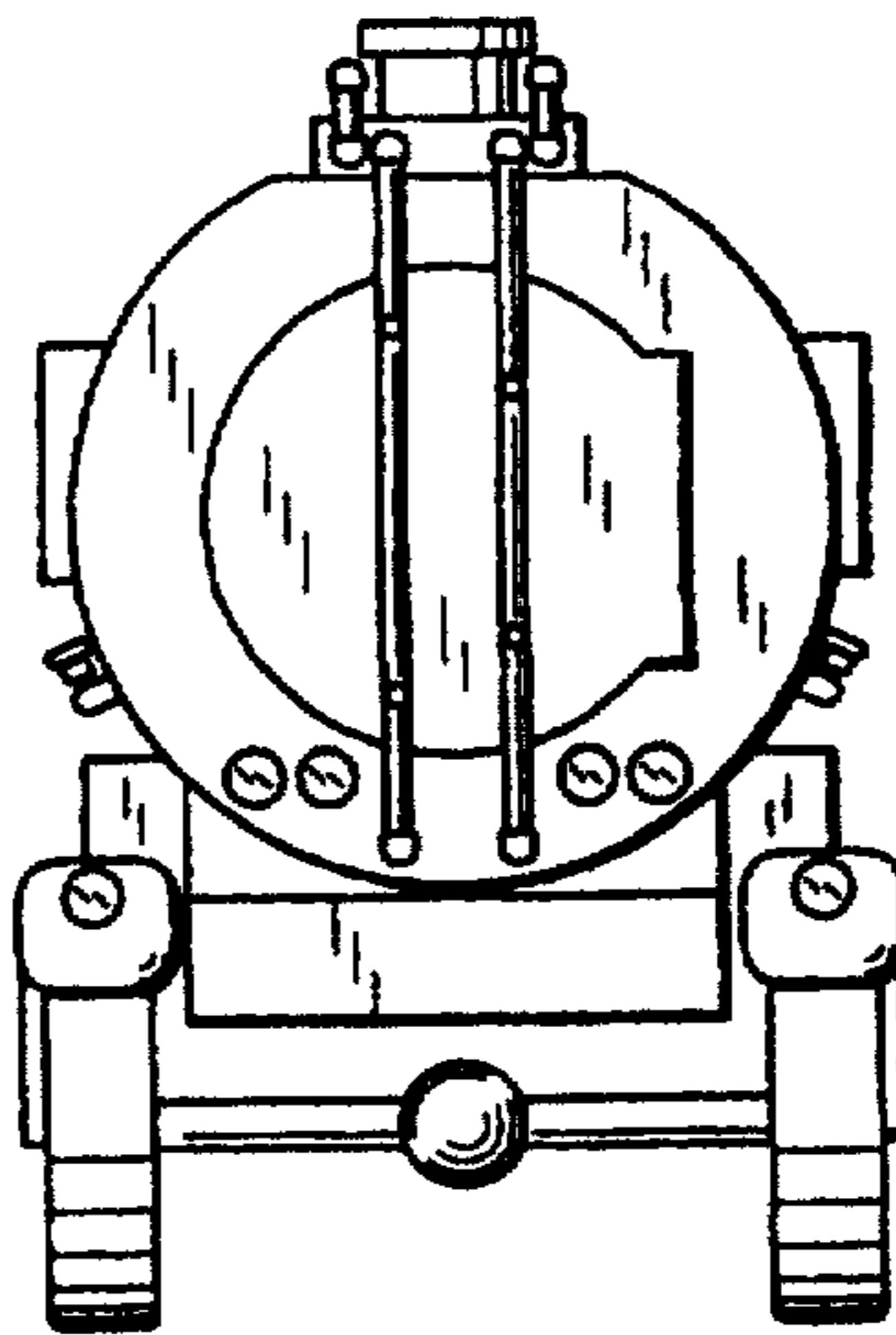
