**DESCRIPTION**

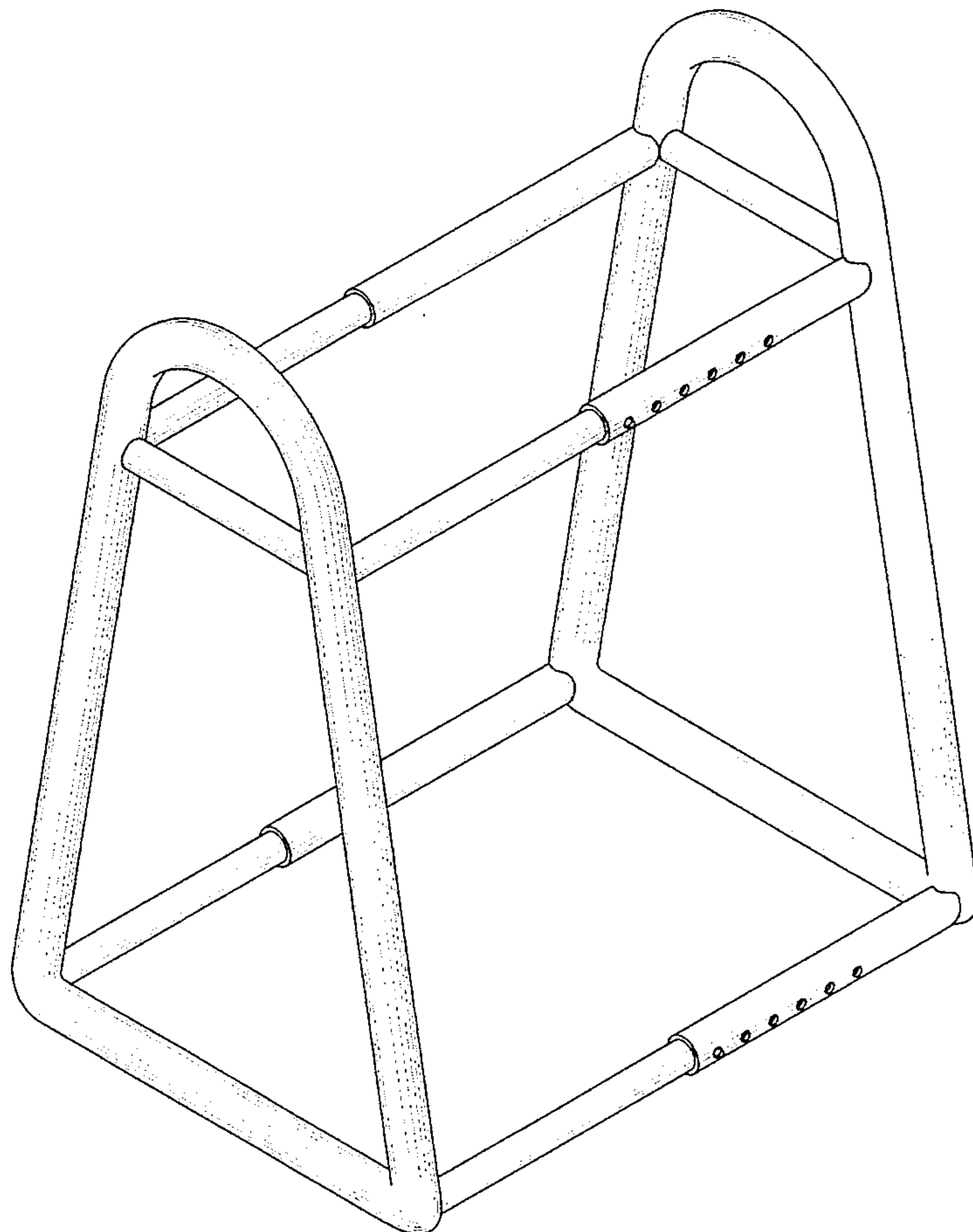
FIG. 1 is a front elevational view of the plastic grocery bag holder showing my new design;

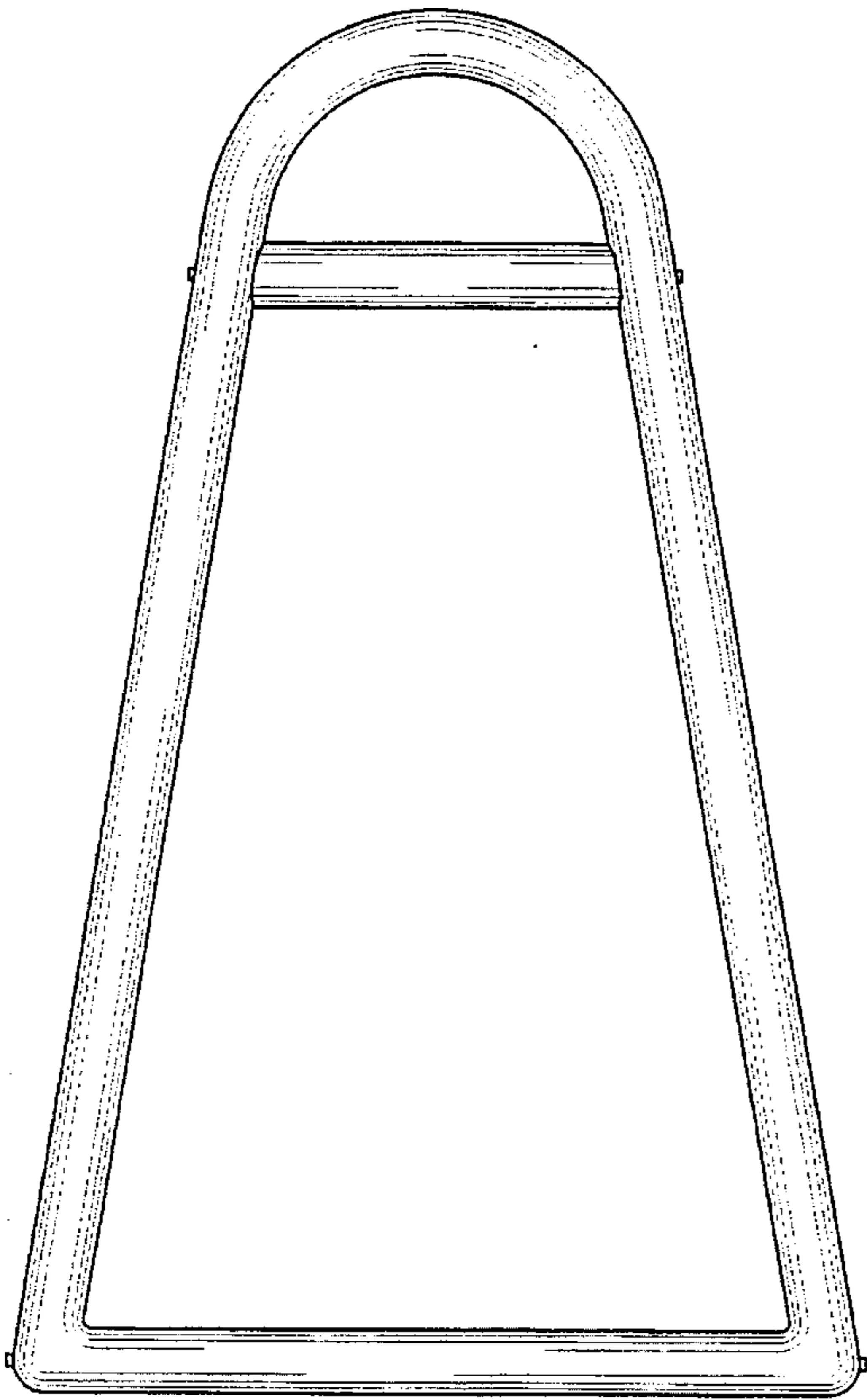

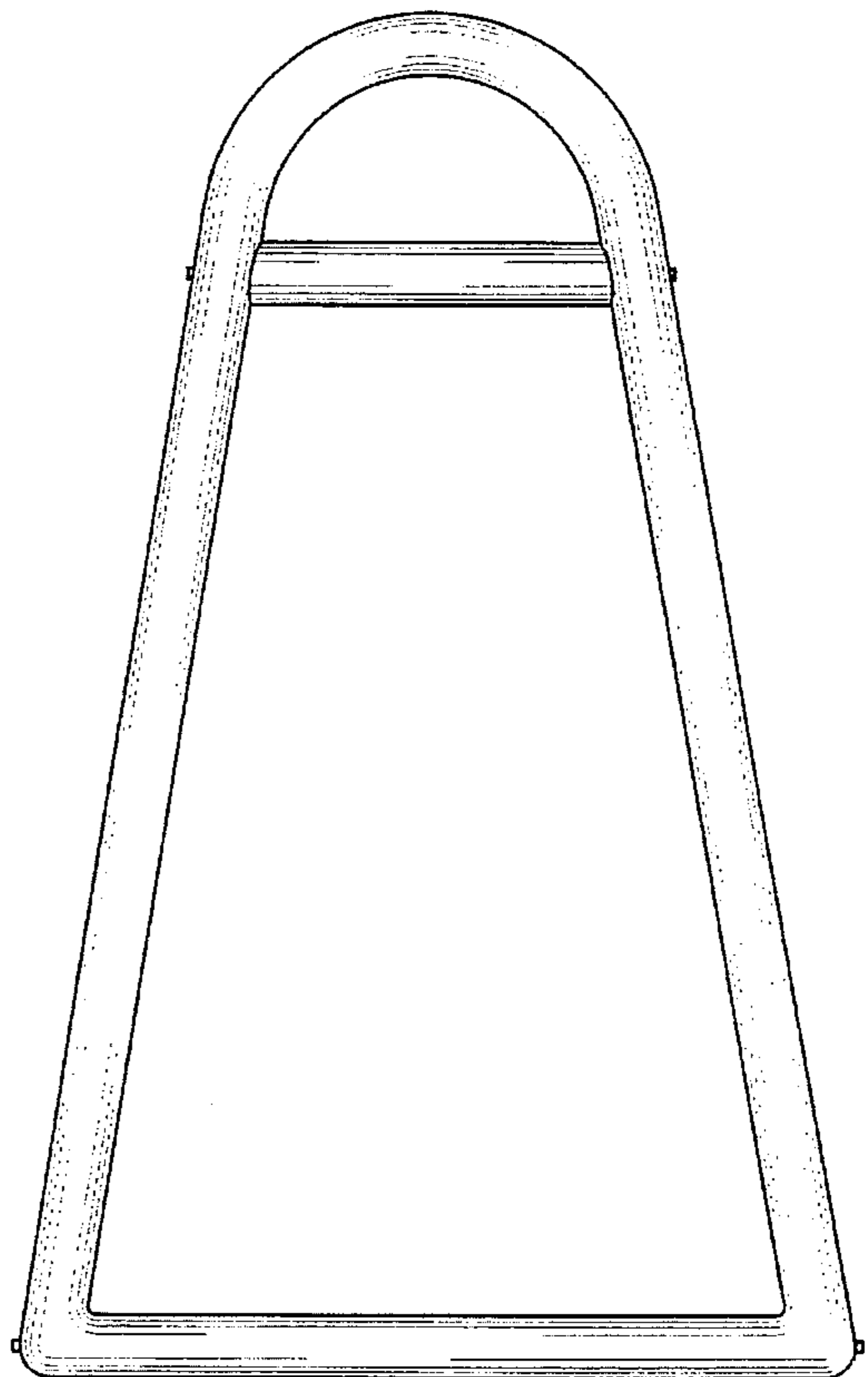

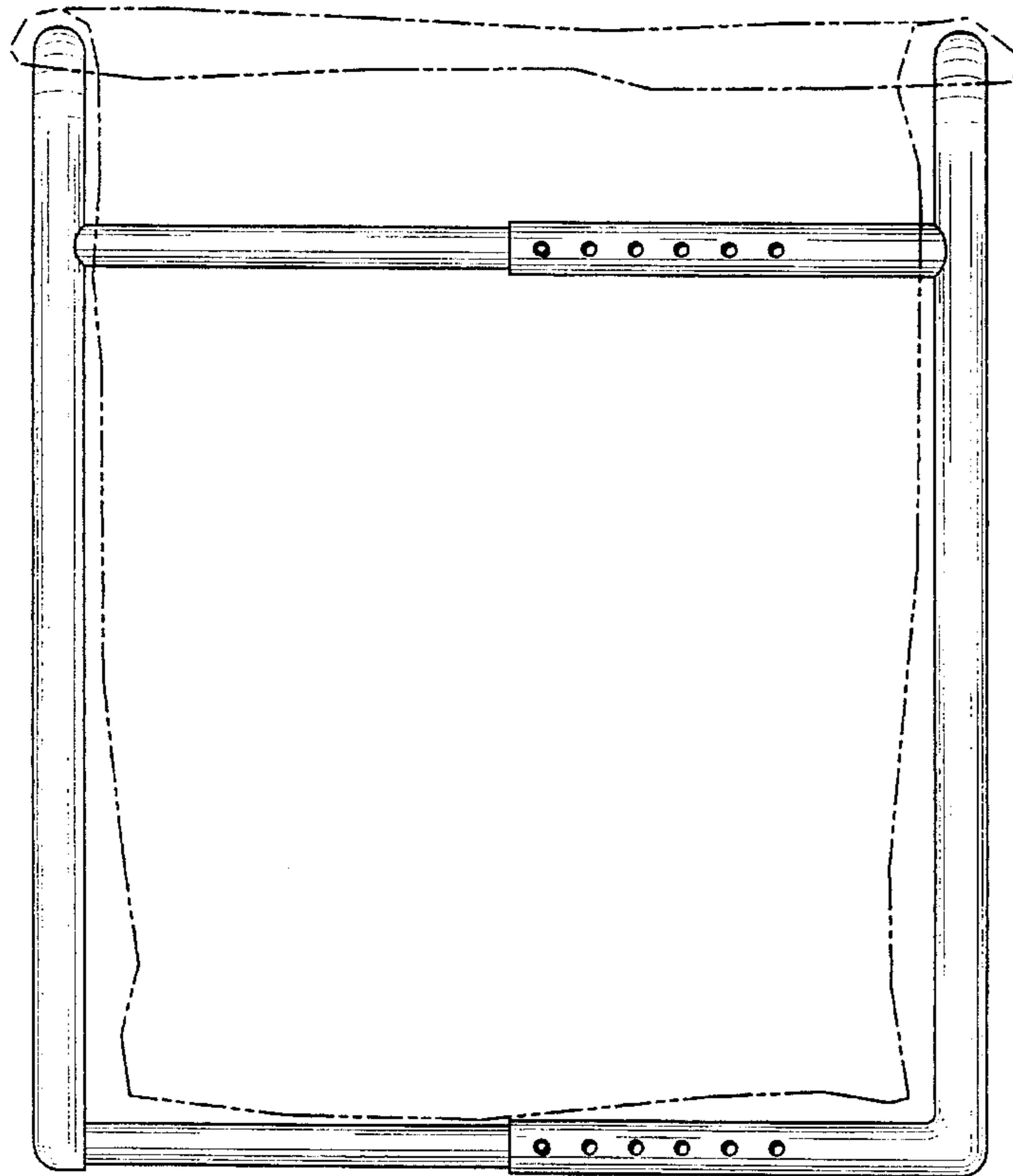

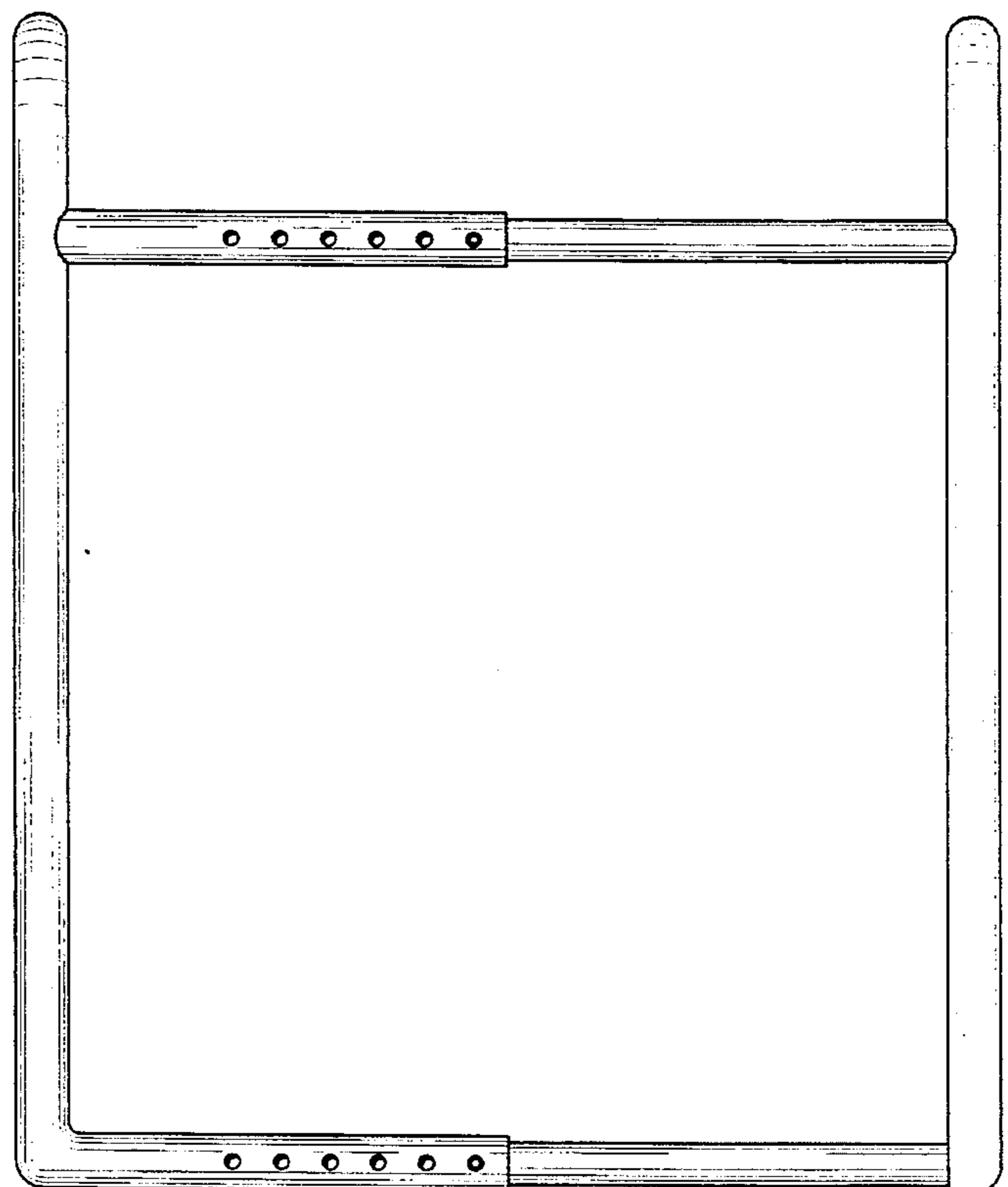

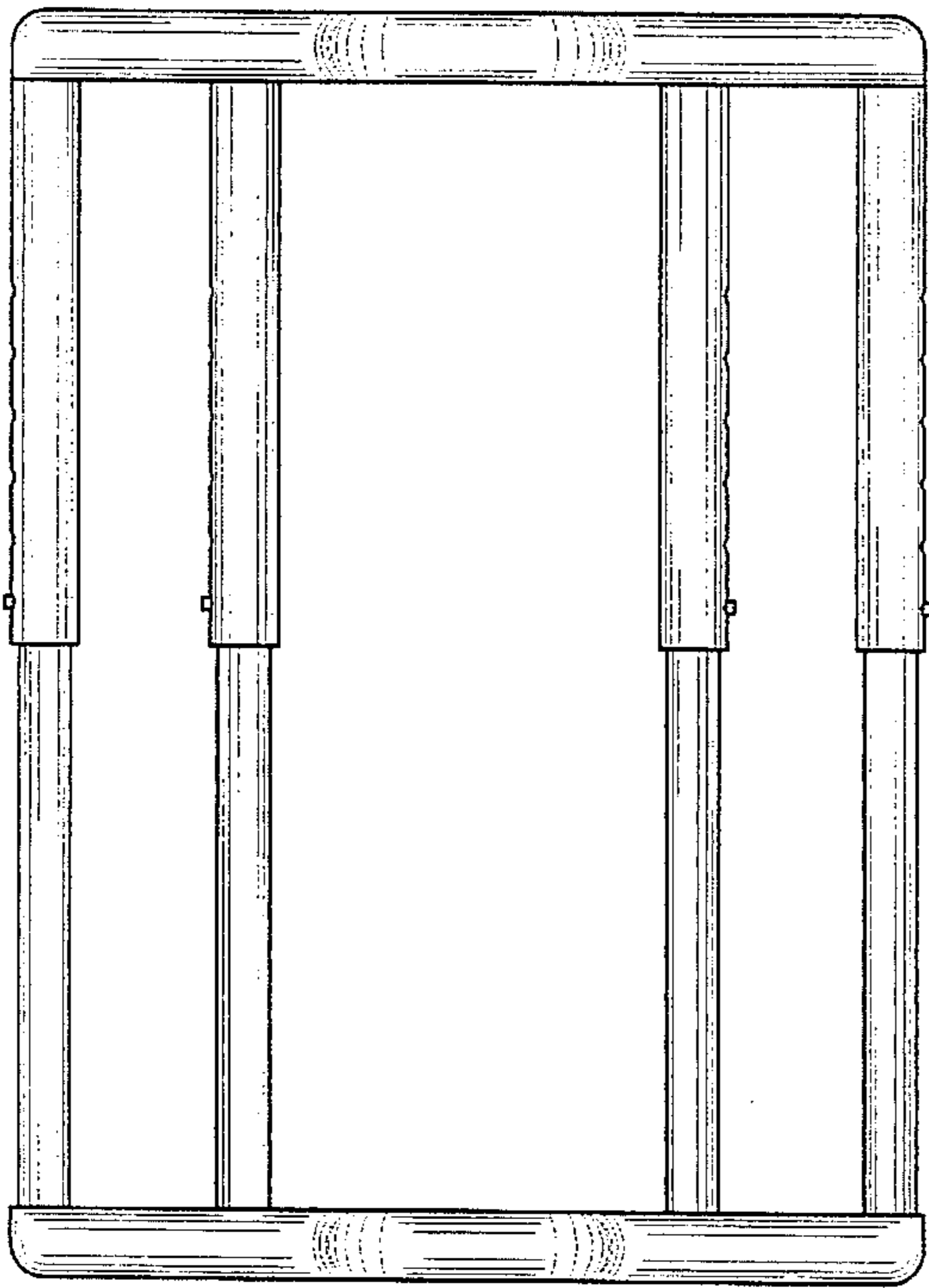

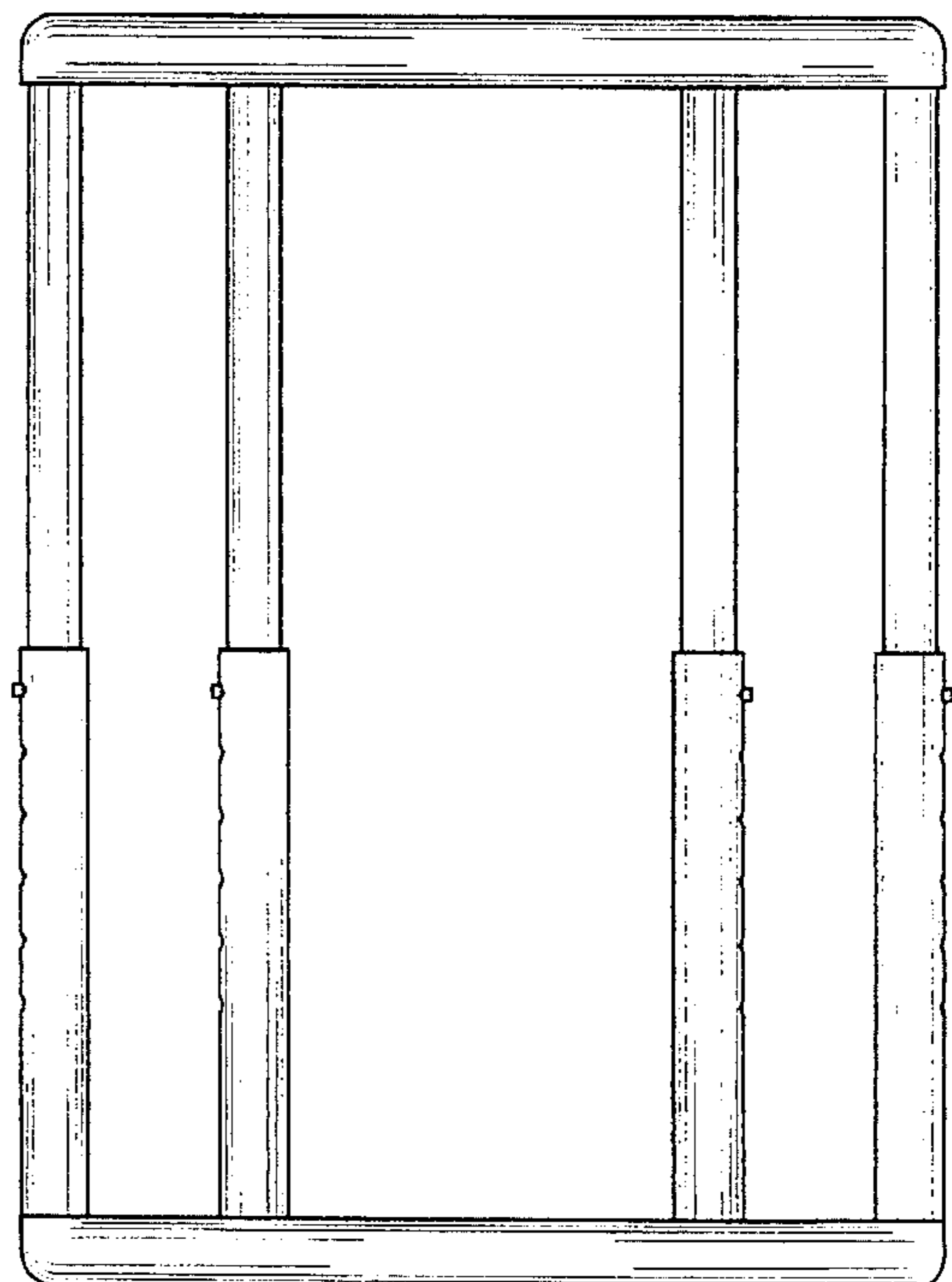
