[57] **CLAIM**

The ornamental design for a self standing shelving unit, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the preferred embodiment of

the self standing shelving unit according to the present invention;

FIG. 2 is an elevational view of one side of the preferred embodiment of the self standing shelving unit according to the present invention, the other side being identical thereto;

FIG. 3 is a top plan view of the preferred embodiment of the self standing shelving unit of the present invention;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a front elevational view of the preferred embodiment of the self standing shelving unit according to the present invention;

FIG. 6 is rear elevational view thereof;

FIG. 7 is a perspective of an alternative embodiment of the self standing shelving unit according to the present invention;

FIG. 8 is an elevational view of one side of the alternative embodiment of the self standing shelving unit according to the present invention, the other side being identical thereto;

FIG. 9 is a top plan view of the alternative embodiment of the self standing shelving unit according to the present invention;

FIG. 10 is a front elevation view of the alternative embodiment of the invention, the opposite or rear view being substantially identical thereto; and,

FIG. 11 is a bottom plan view of the alternative embodiment of the self standing shelving unit according to the present invention.

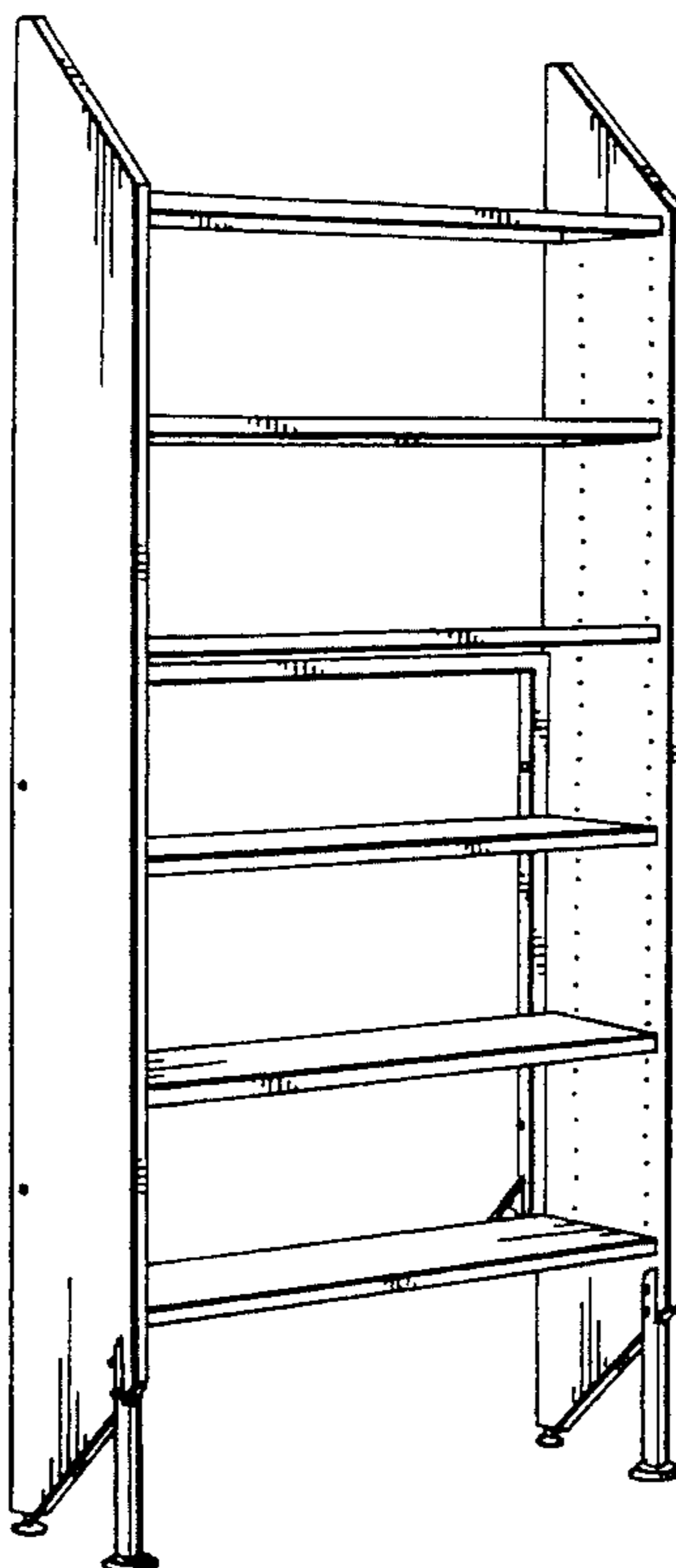

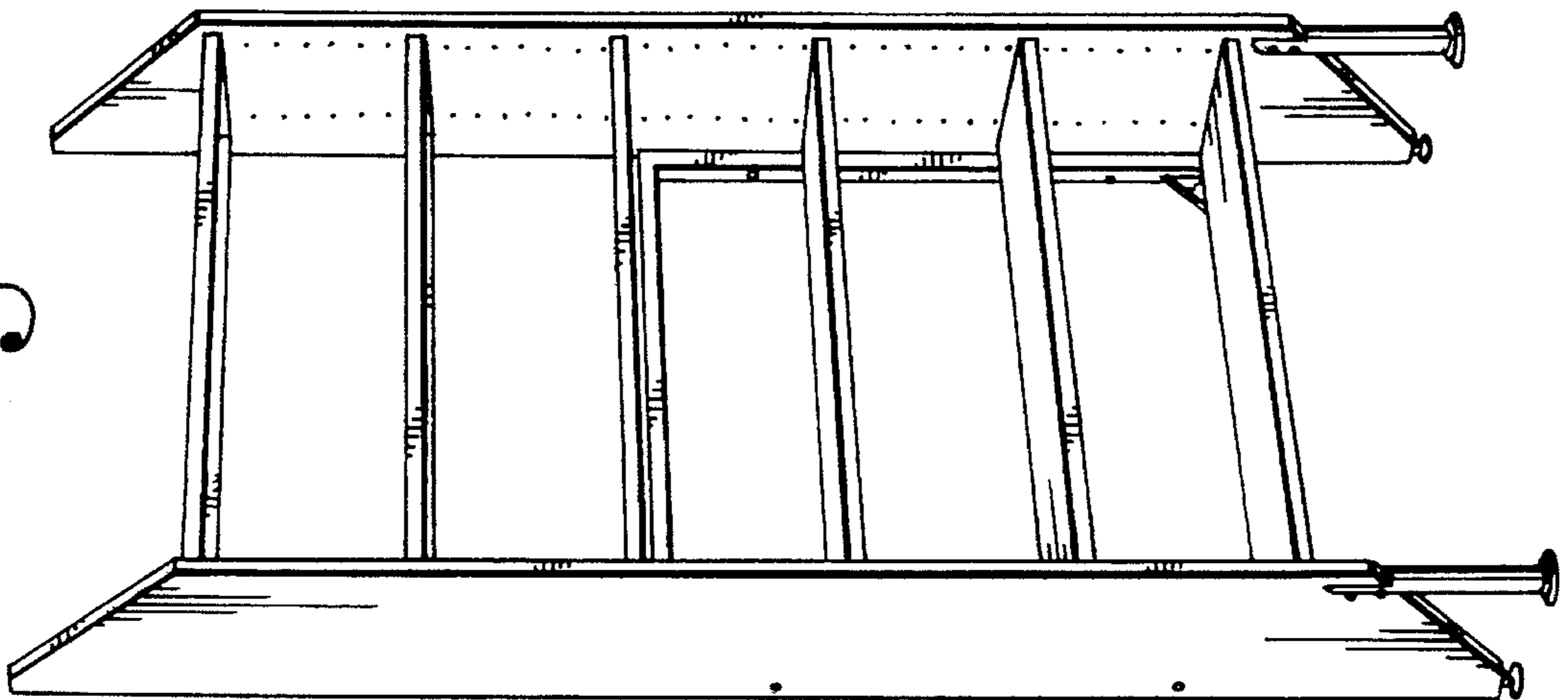

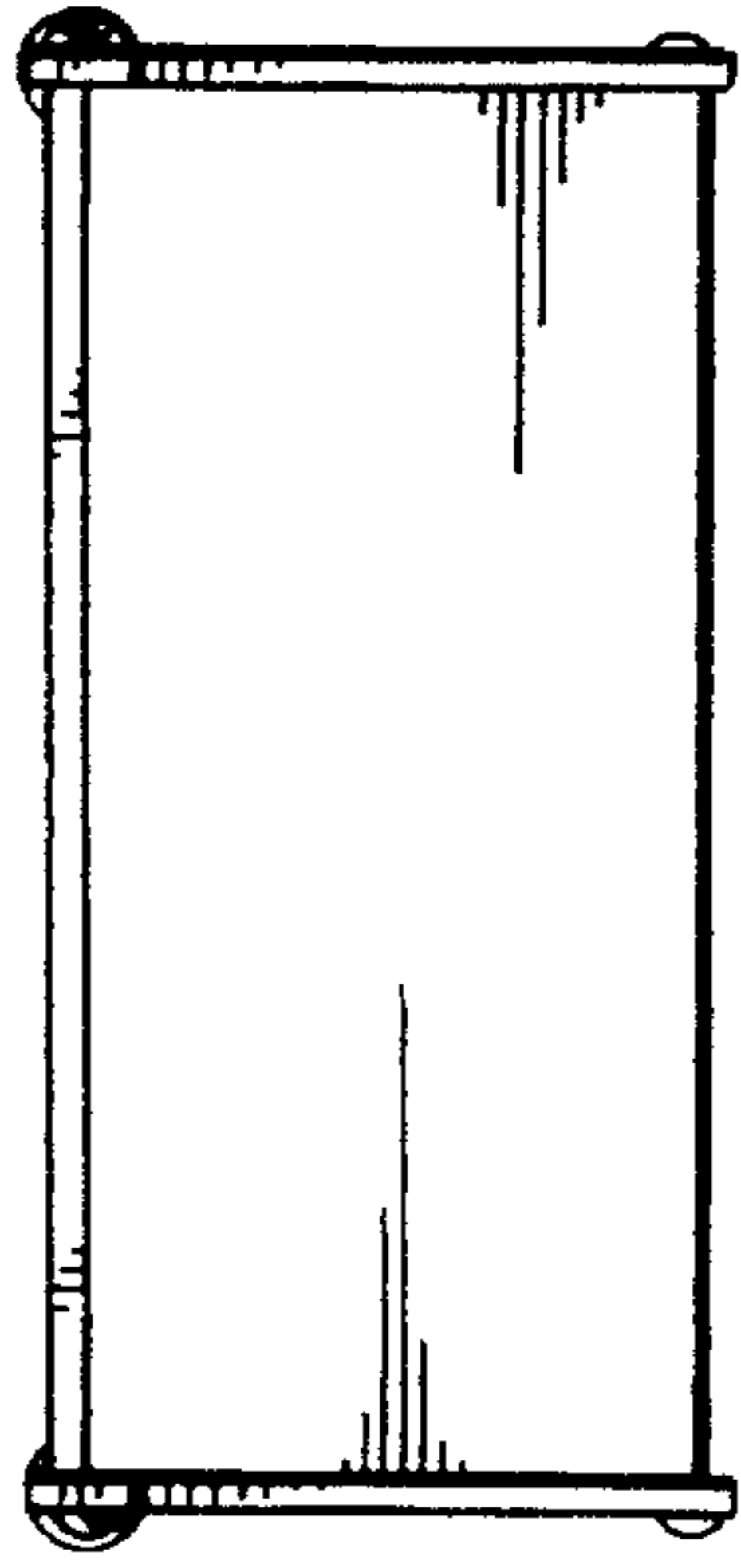

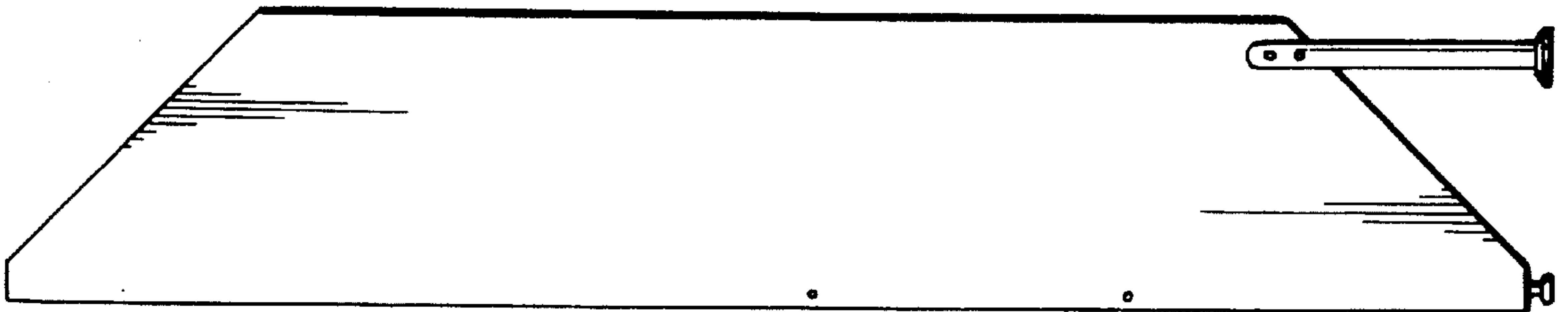
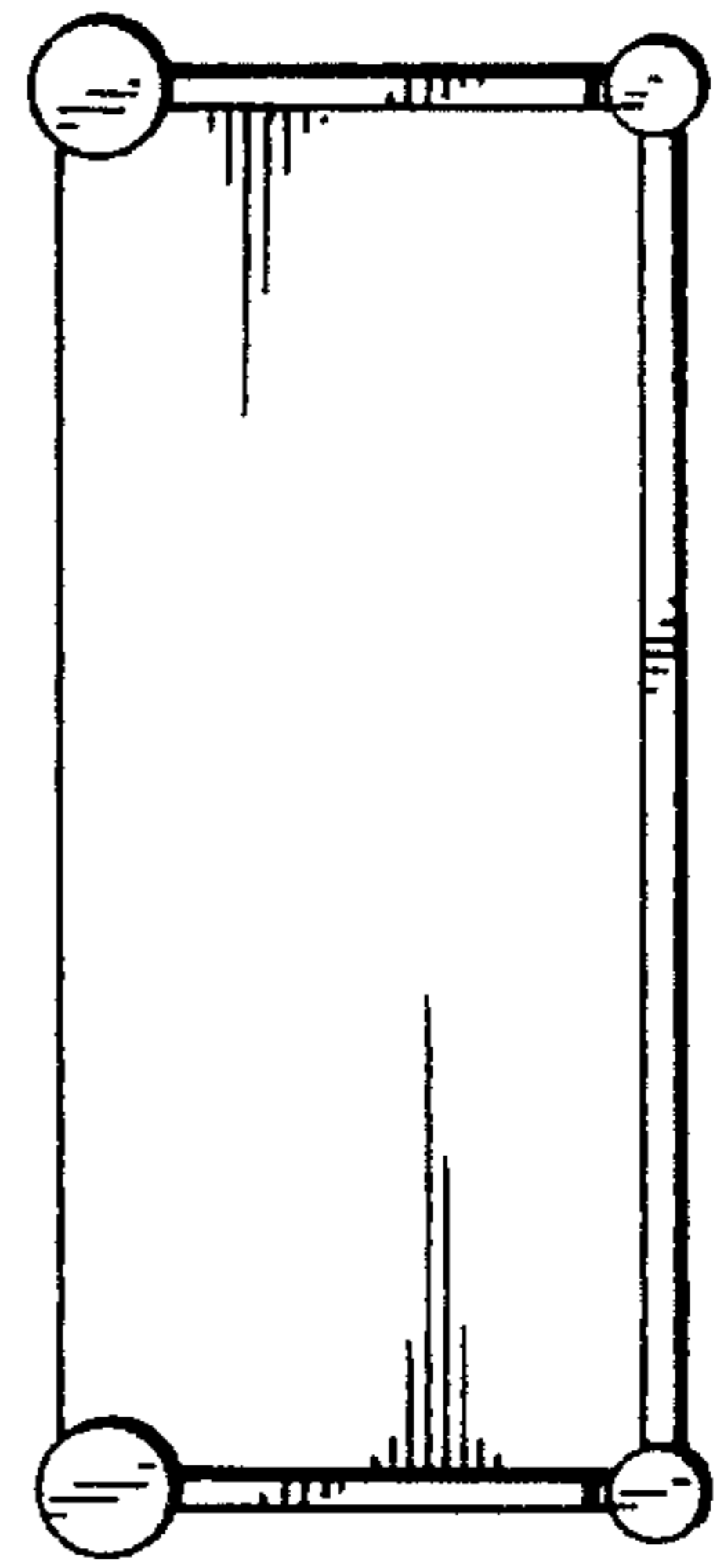

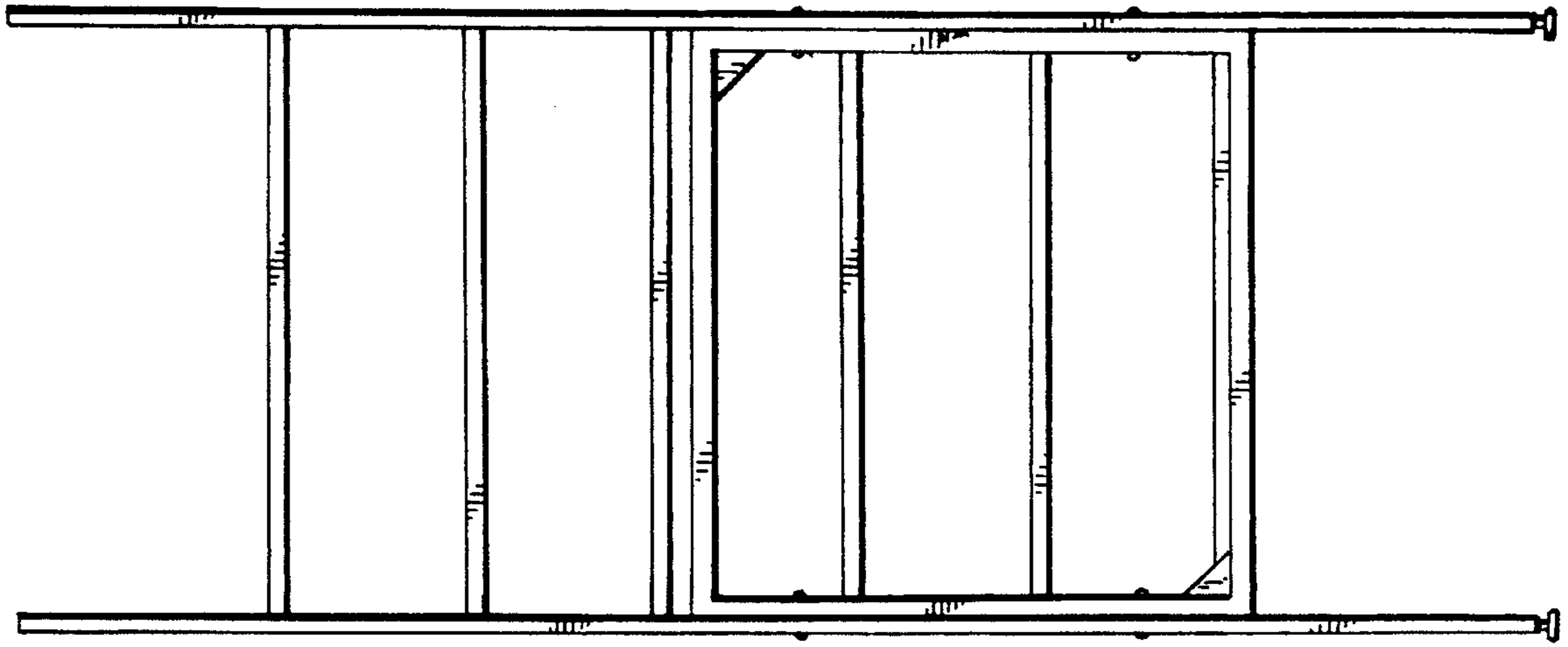

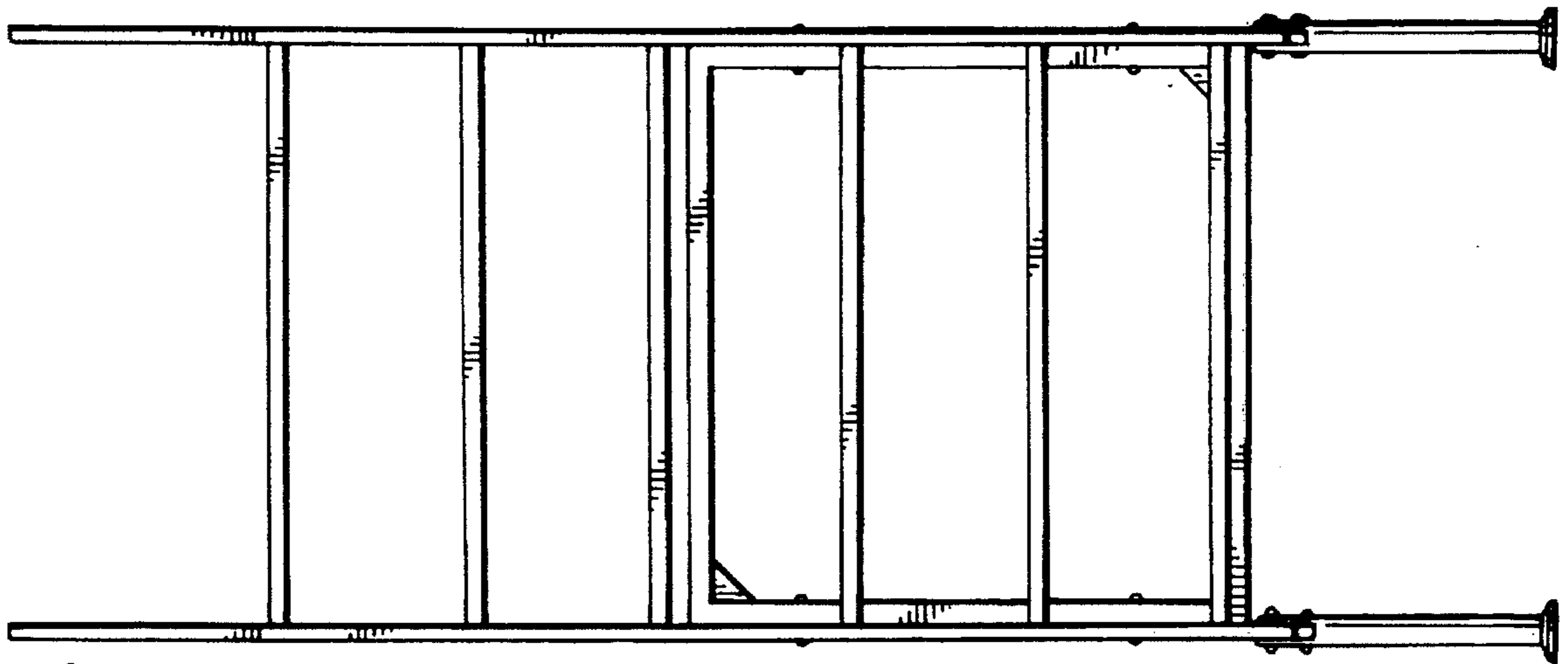

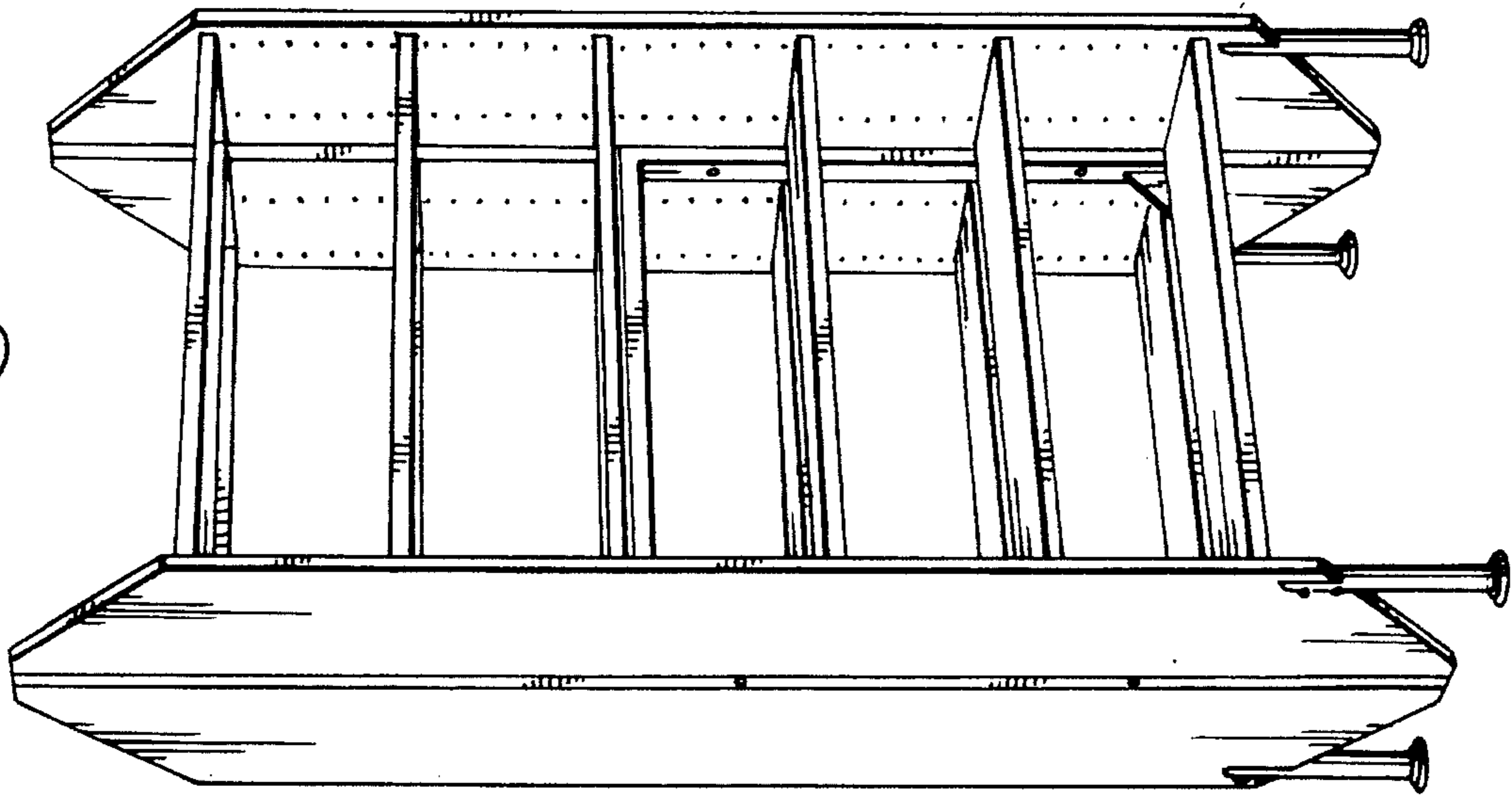

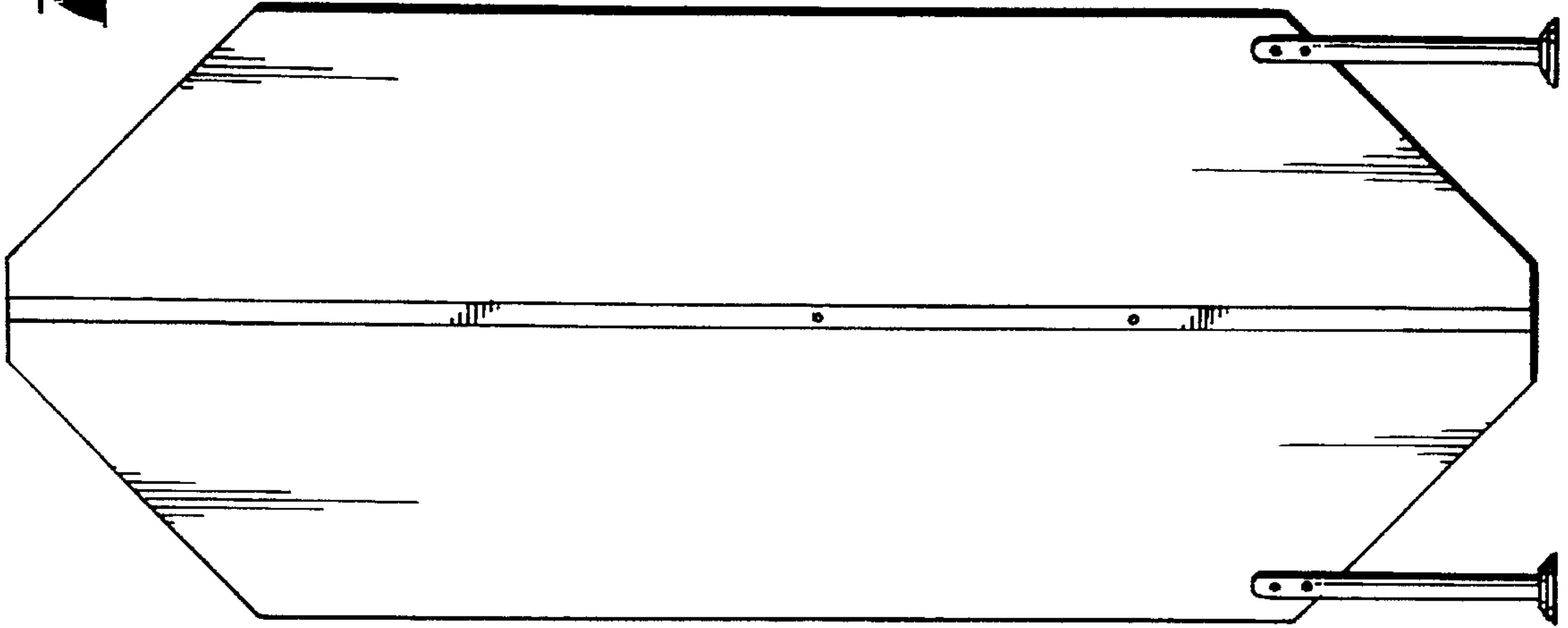

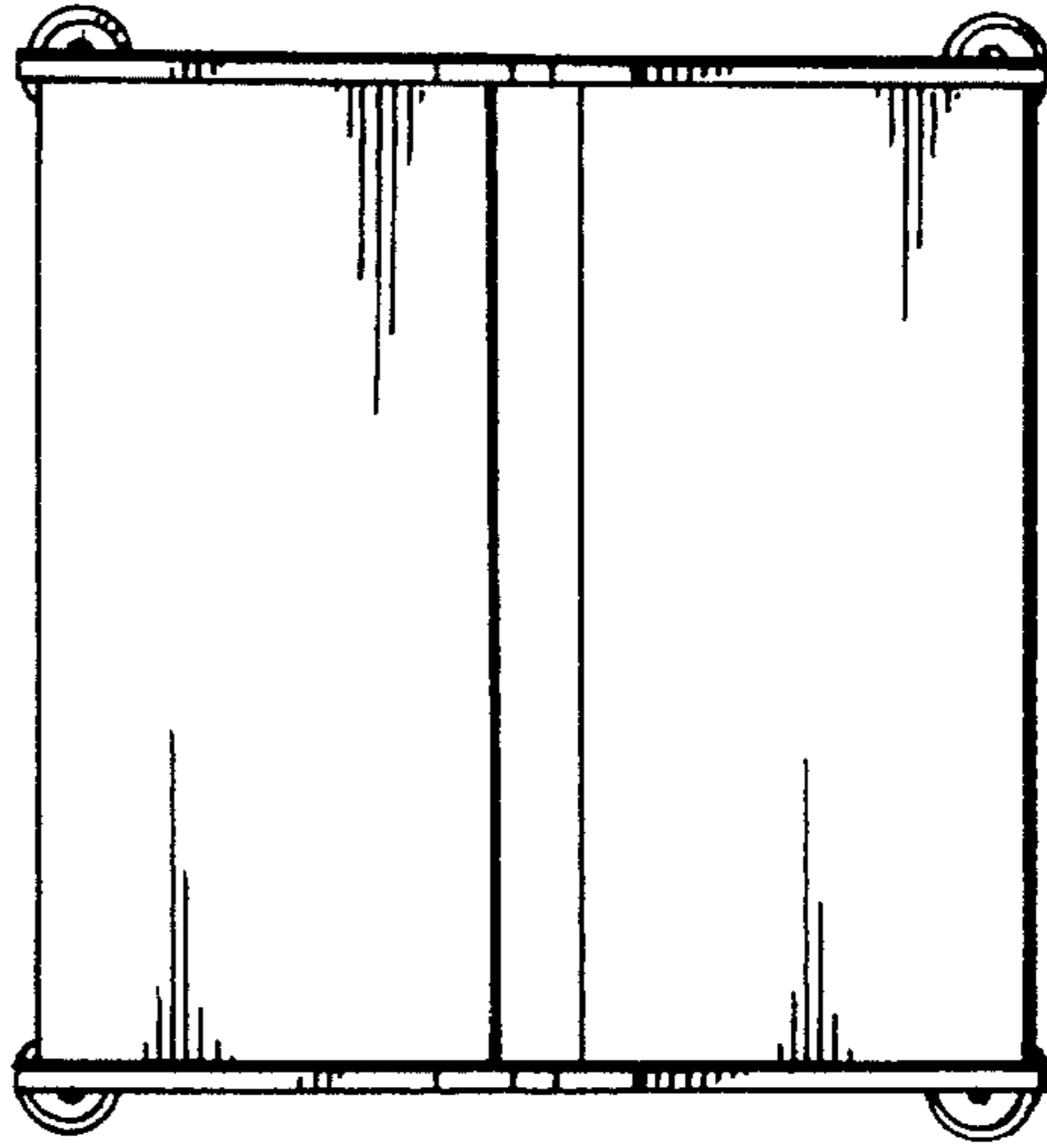

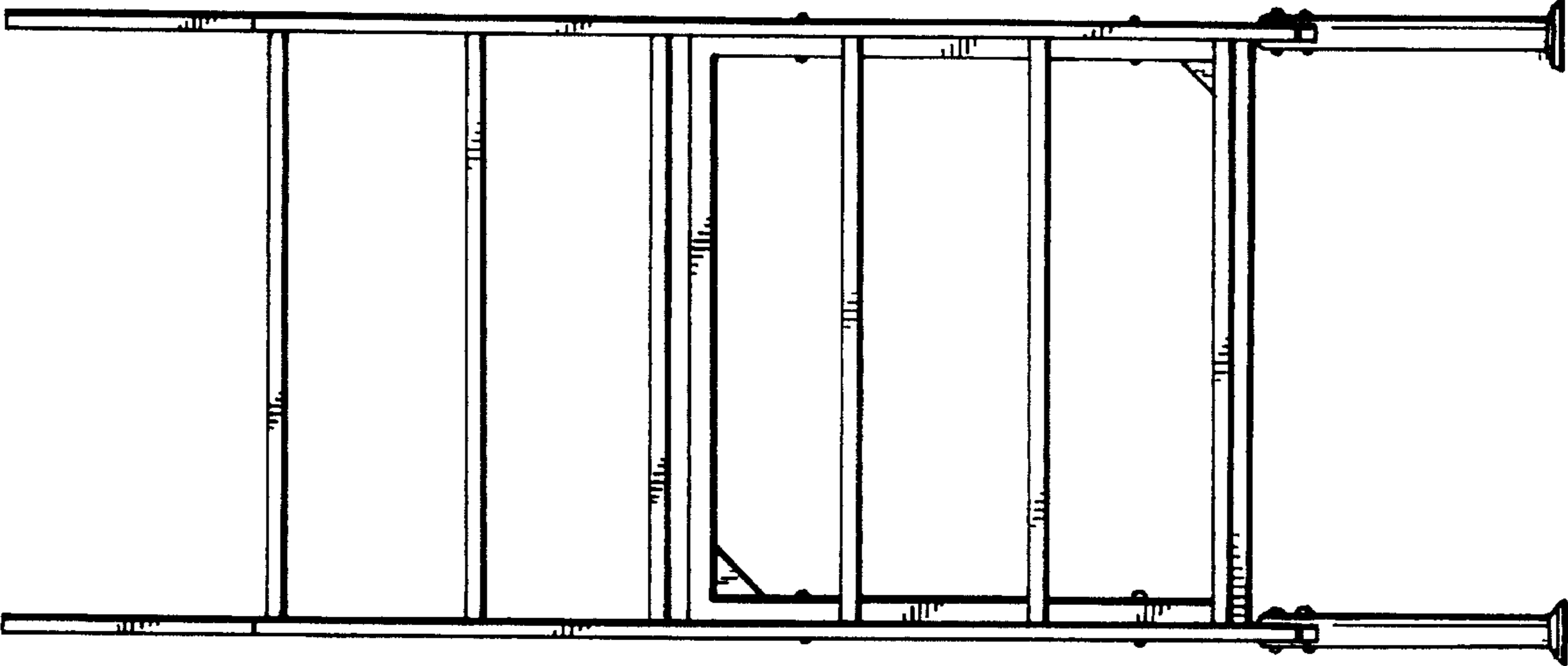
