The ornamental design for a closure, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a closure of the subject invention;  
FIG. 2 is a side plan view of the closure of the subject invention, the opposite side being identical;  
FIG. 3 is a top plan view of the closure of the subject invention; and,  
FIG. 4 is a bottom plan view of the closure of the subject invention.  
The broken line showing of a portion of a container in FIGS. 1 and 2 and of the threads of the cap in FIG. 4 is for illustrative purposes only and forms no part of the claimed design.

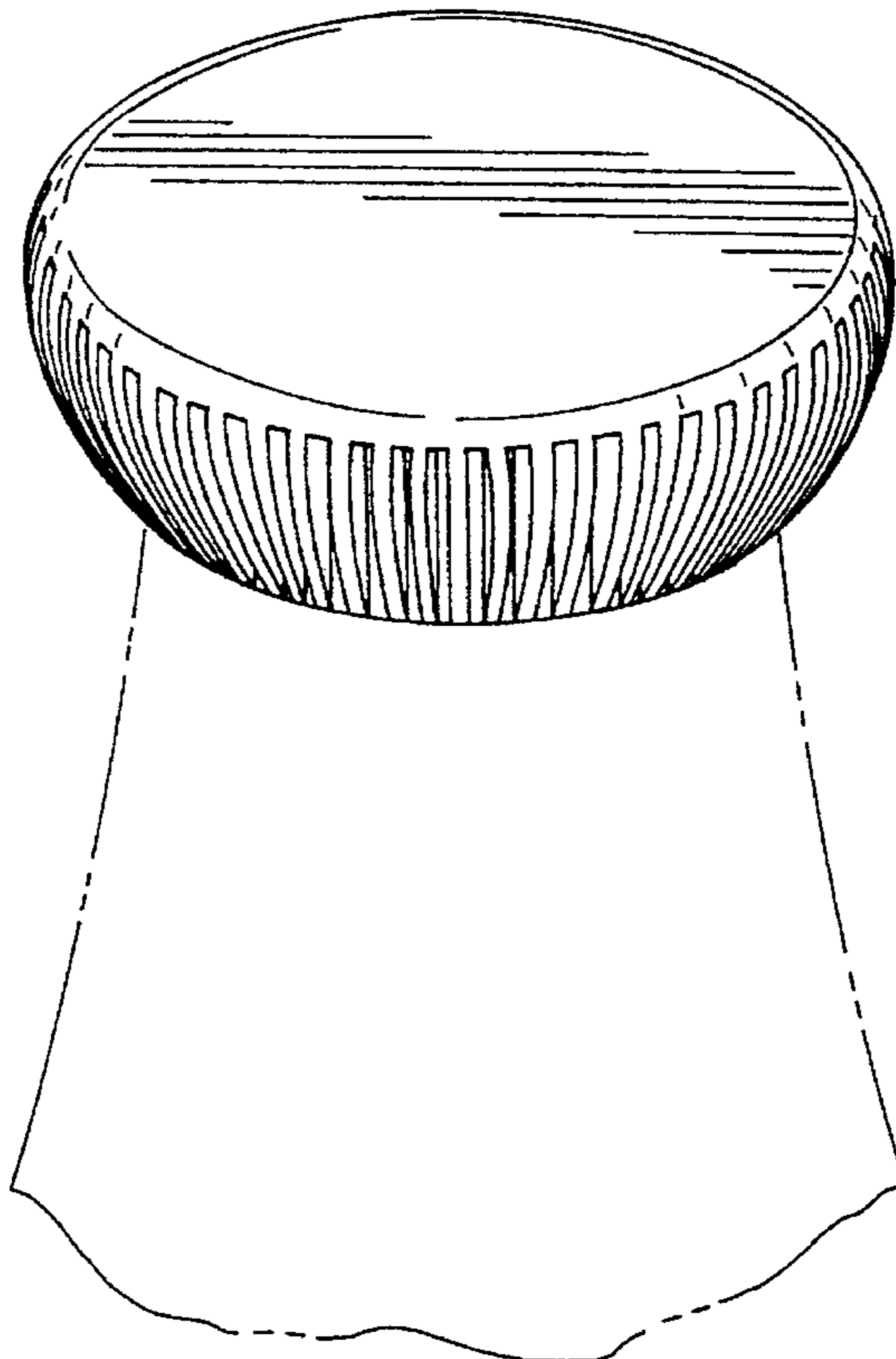

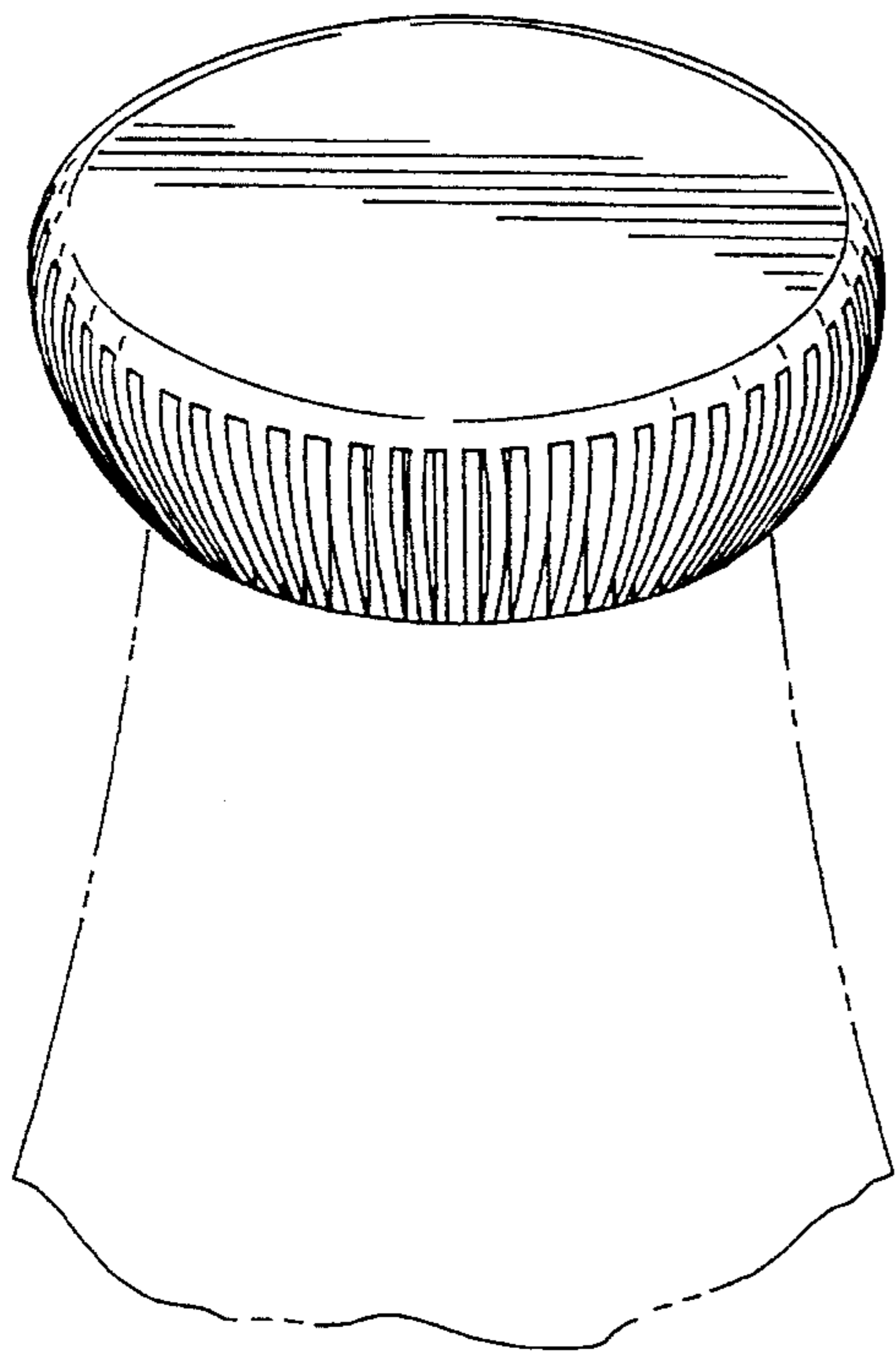

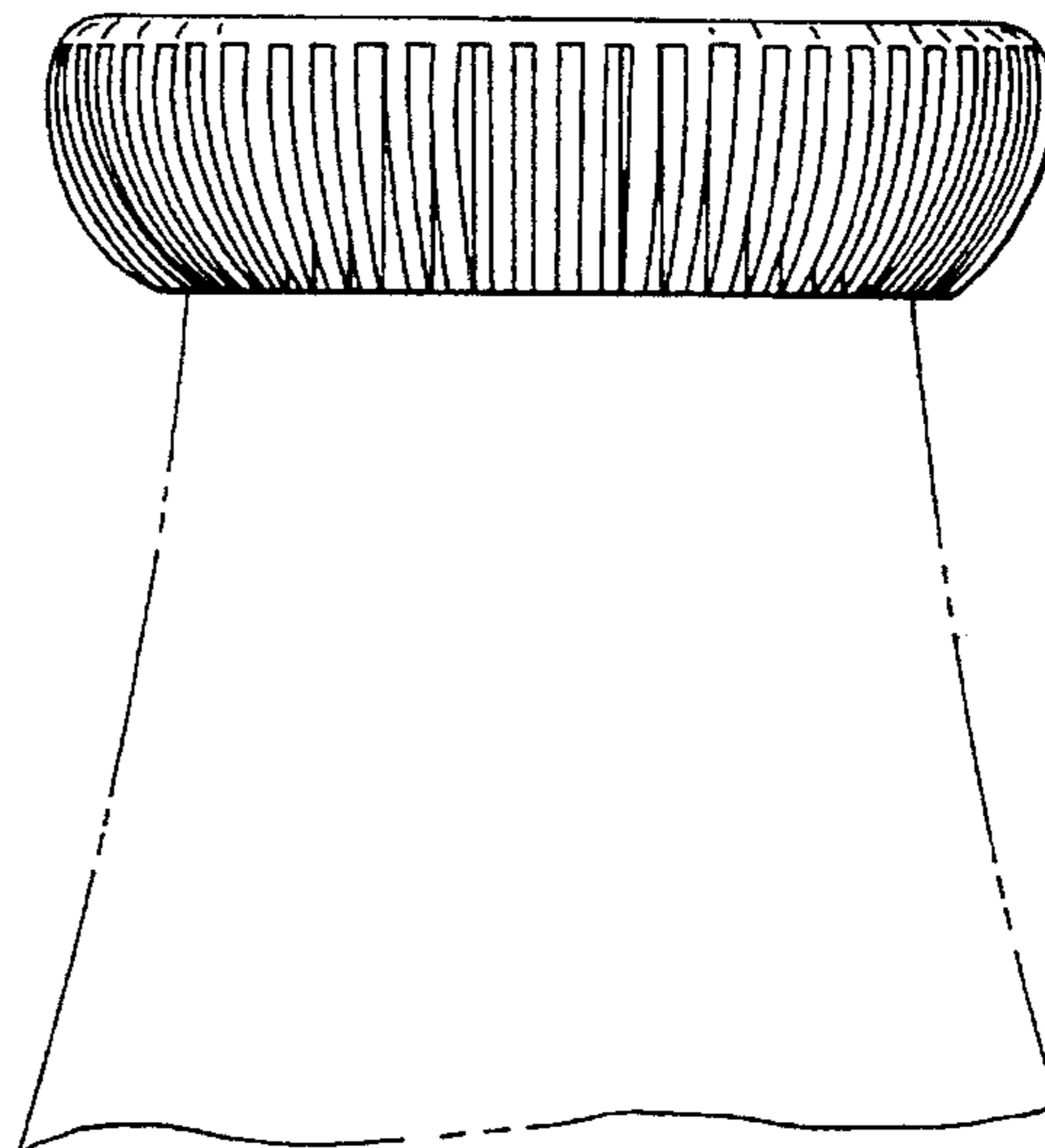

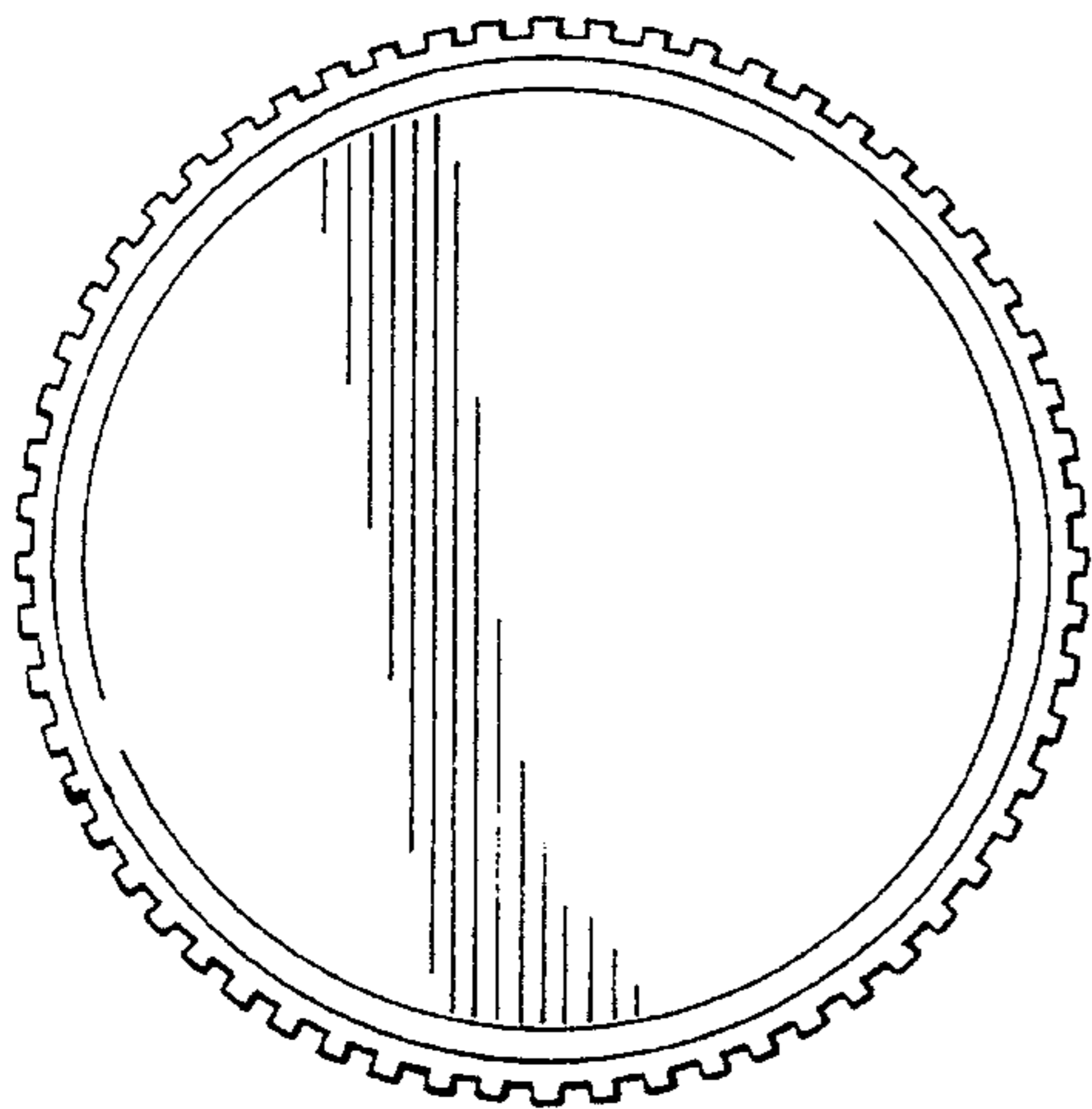
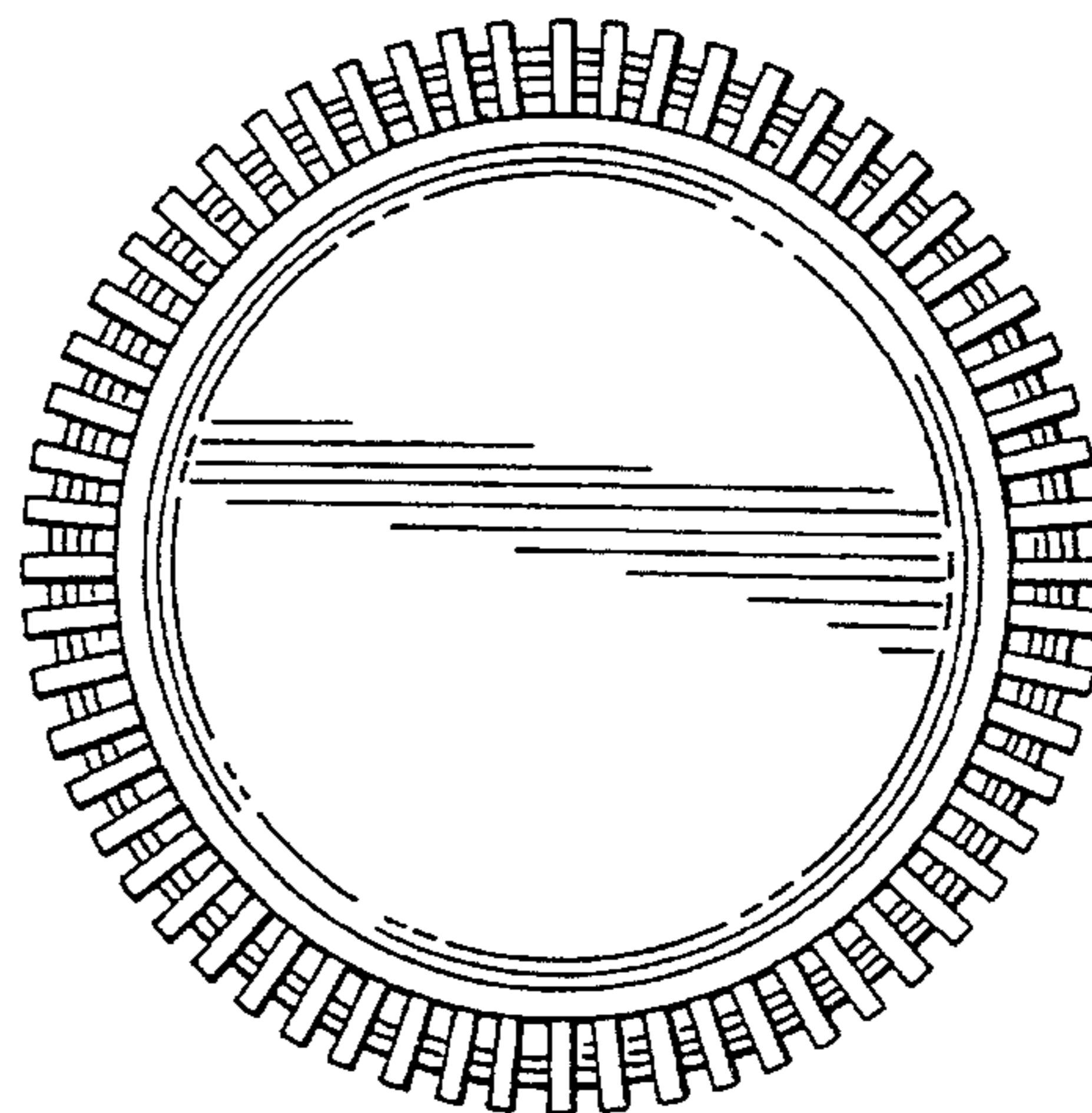
