The ornamental design for an combined eyeglasses strap and ear protectors, as shown and described.

DESCRIPTION

FIG. 1 is an environmental perspective view of the combined eyeglasses strap and ear protectors showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

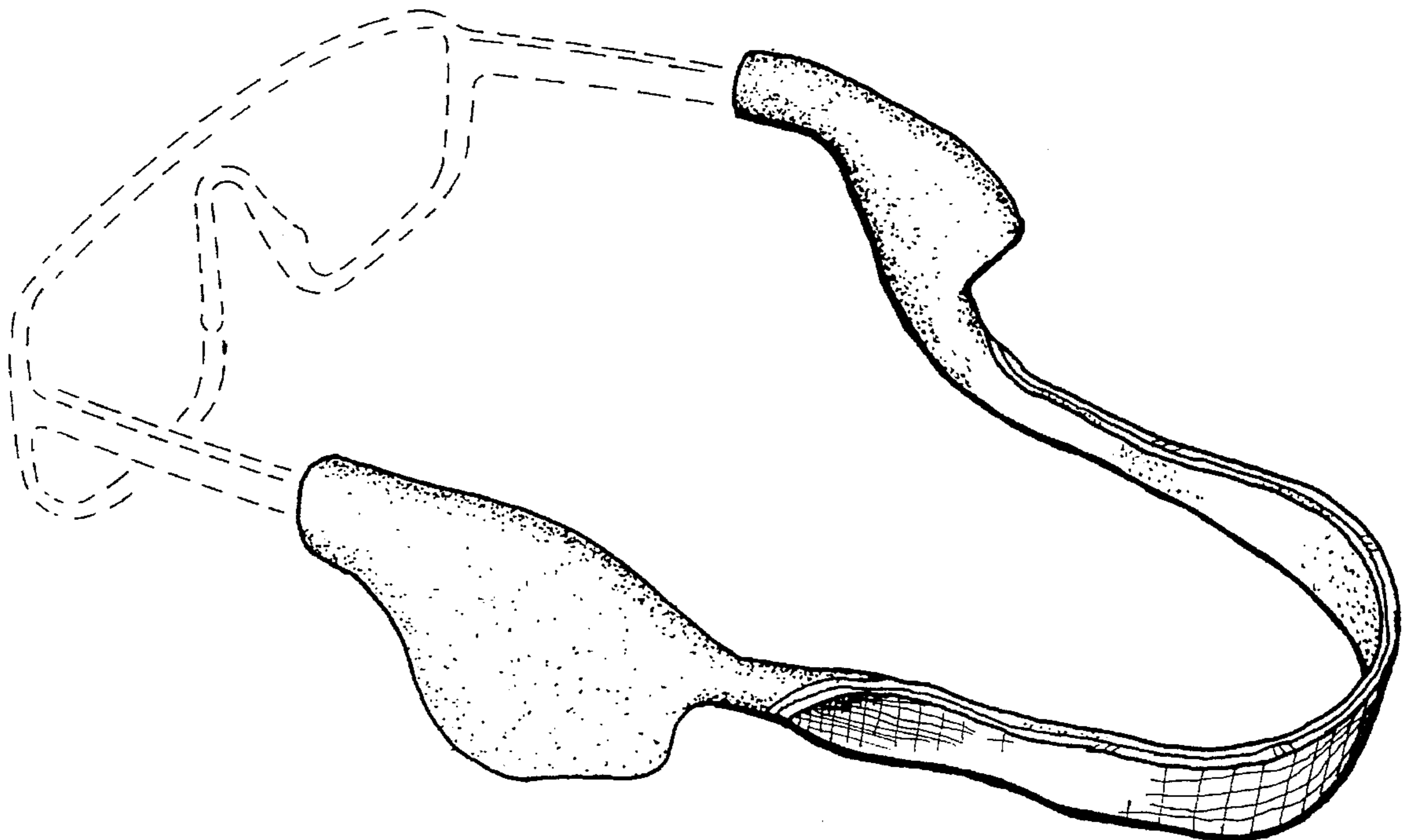
FIG. 4 is a top view thereof;

FIG. 5 is a right side elevational view with the left side being a mirror image thereof; and,

FIG. 6 is a bottom view thereof.

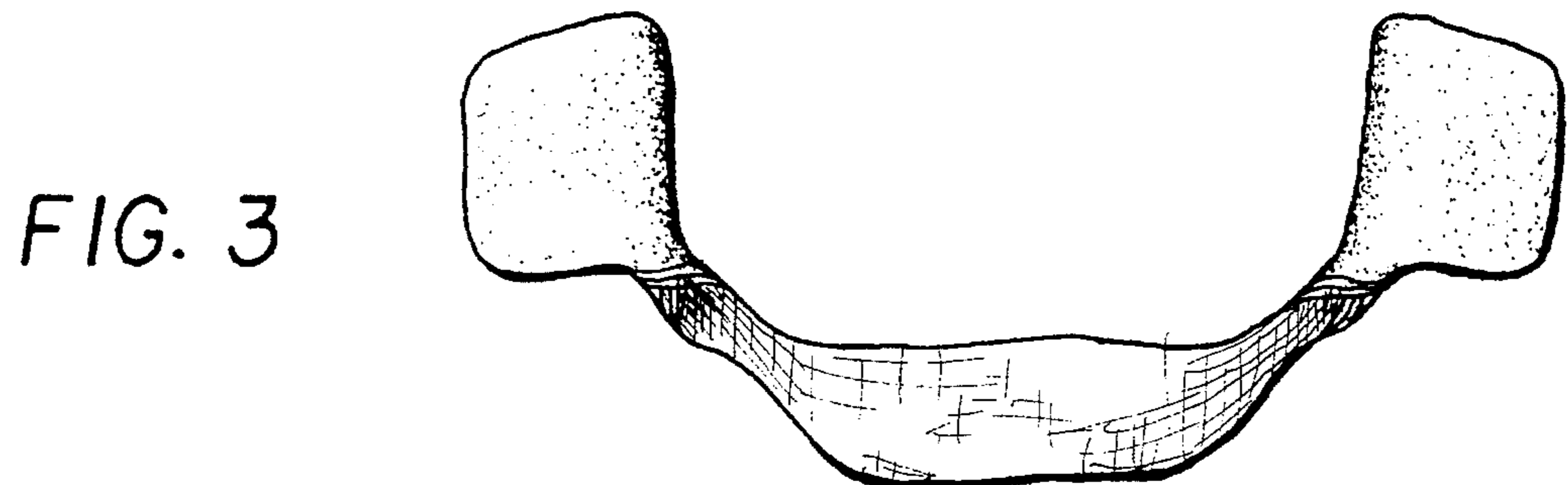
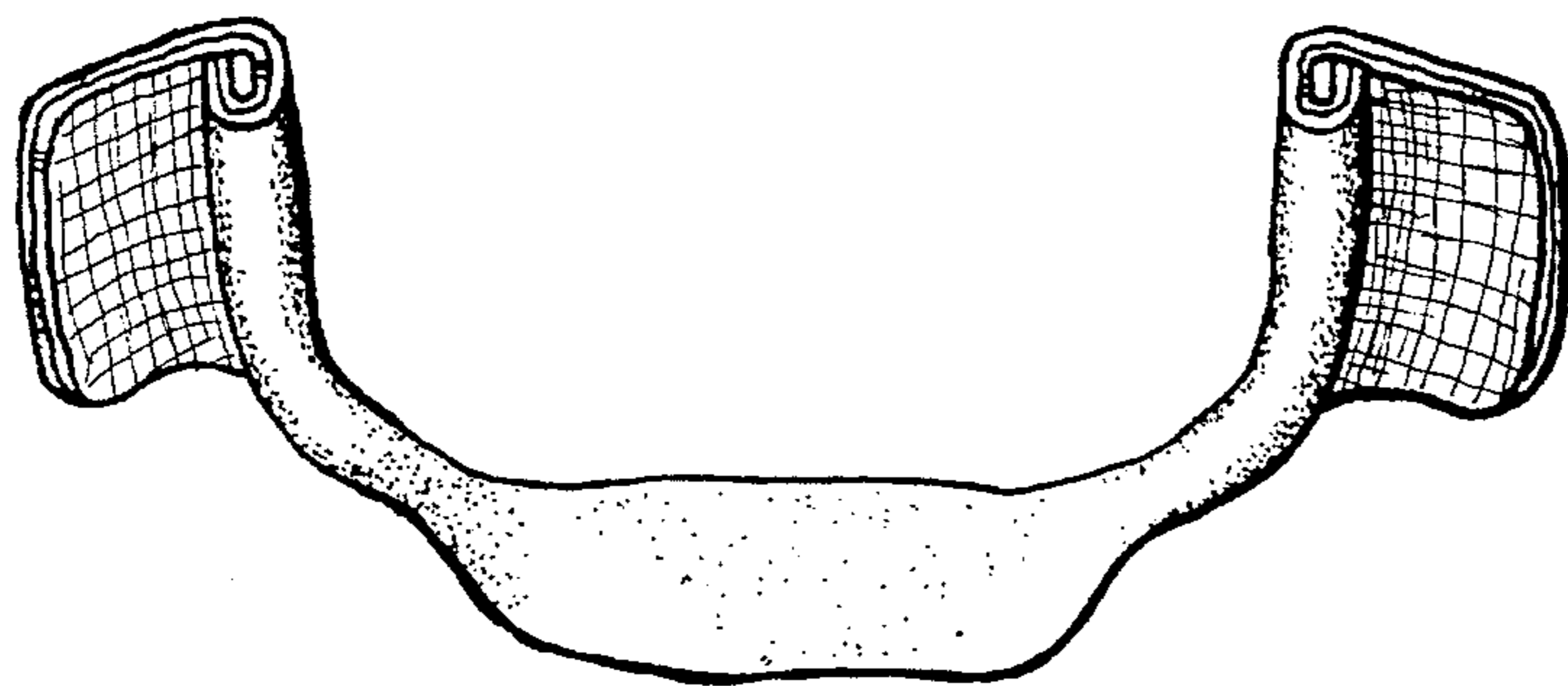
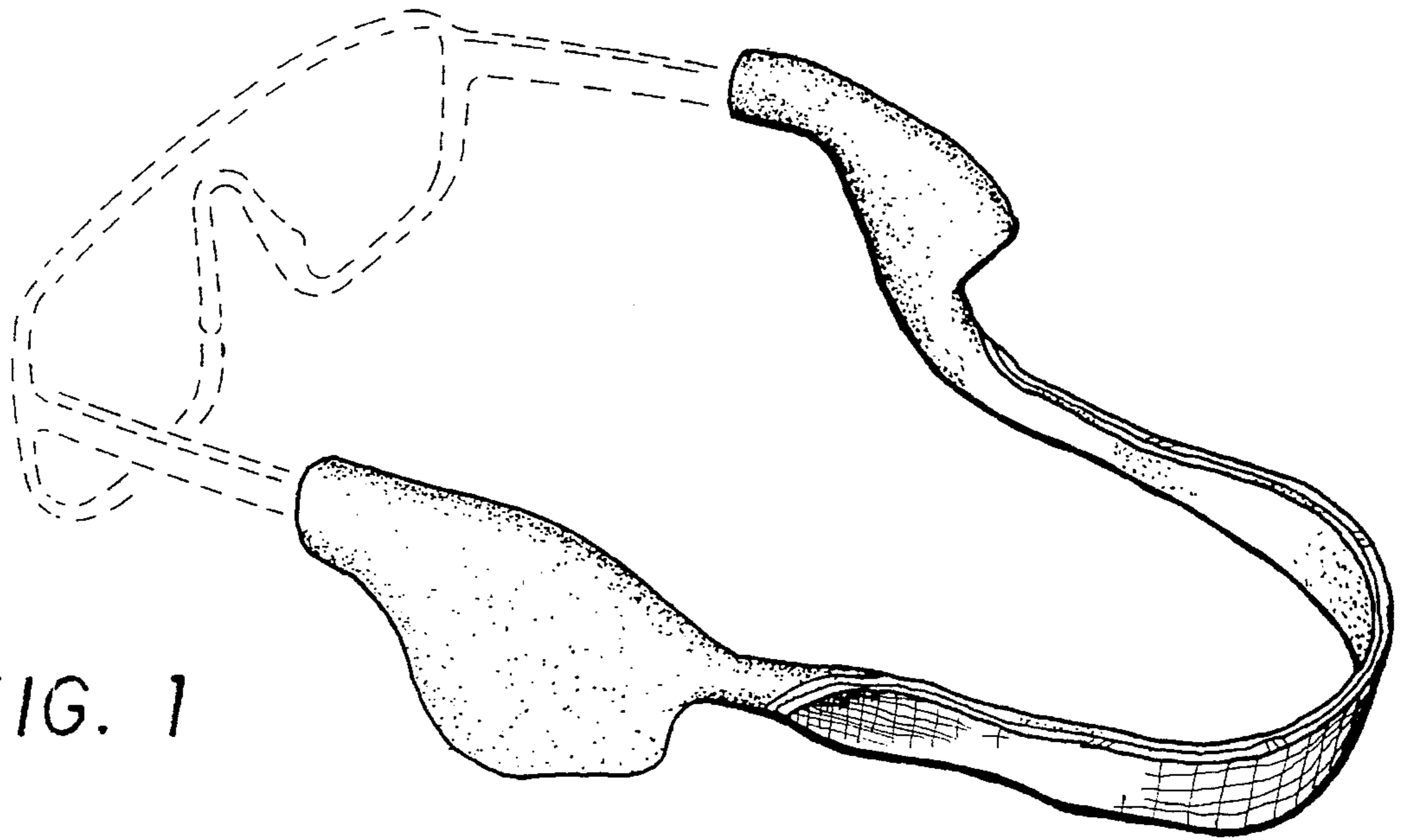

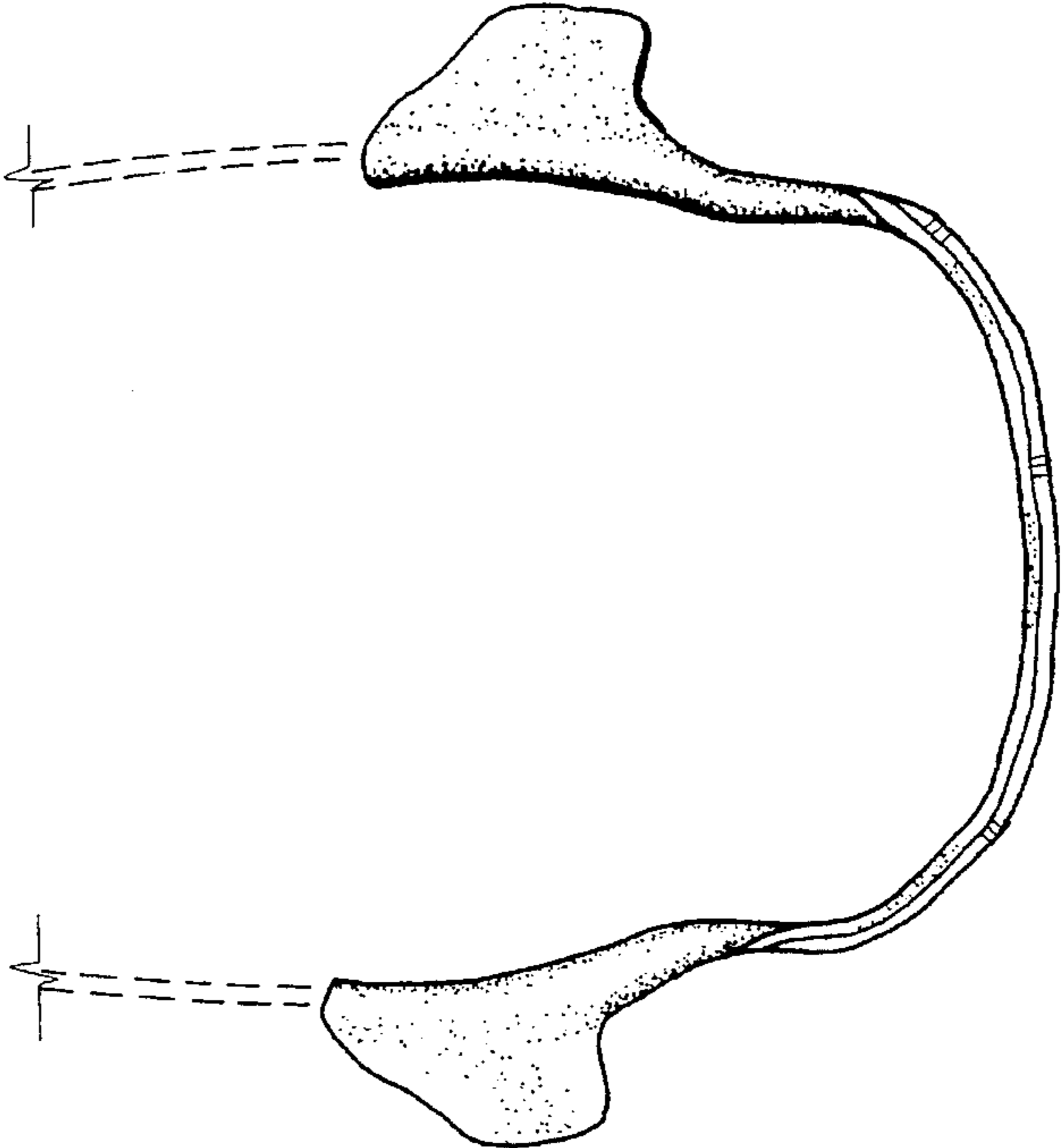

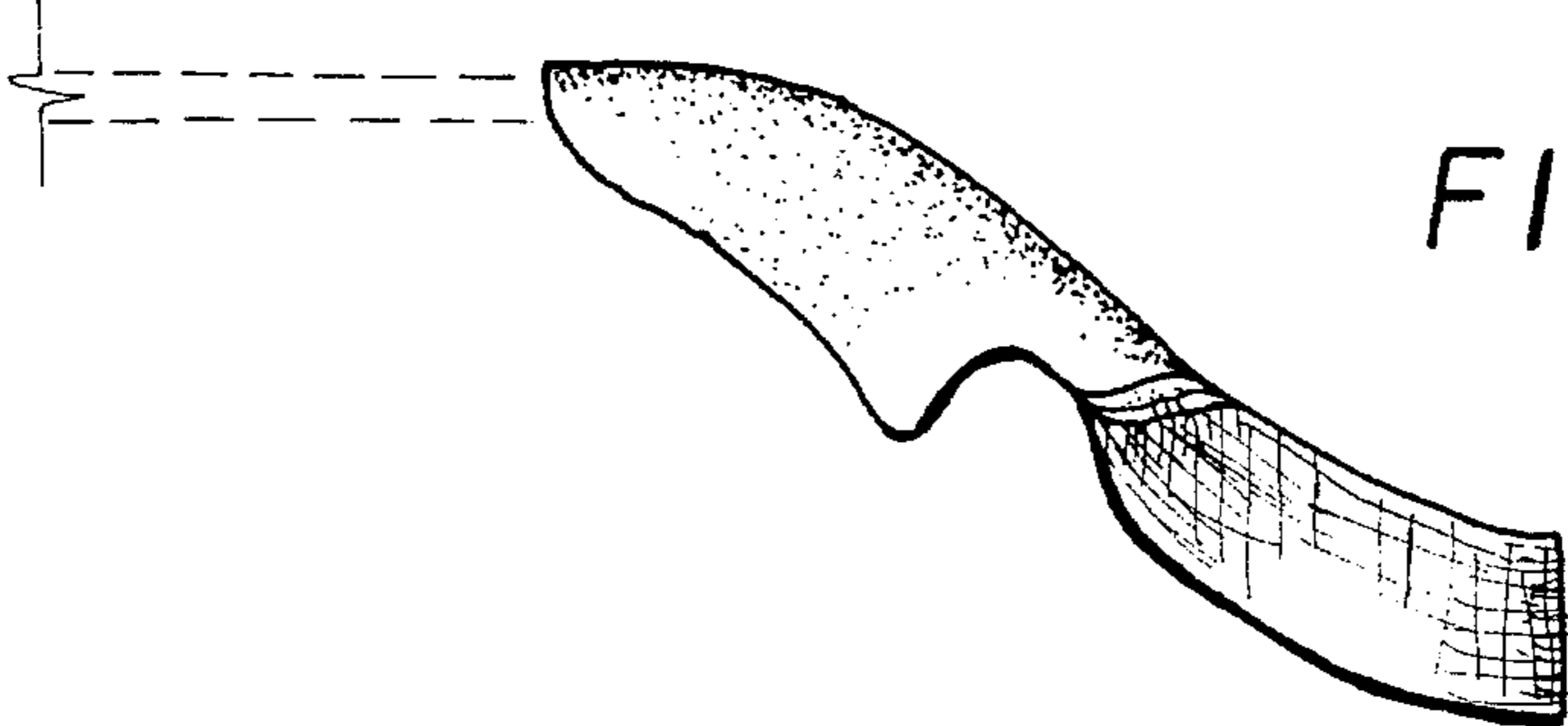
