### DESCRIPTION

FIG. 1 is perspective view taken from above of the front and side of my bait bucket stool;

FIG. 2 is a front elevational view of my bait bucket stool shown in FIG. 1;

FIG. 3 is a left side elevational view of my bait bucket stool shown in FIG. 1;

FIG. 4 is a rear elevational view of my bait bucket stool shown in FIG. 1;

FIG. 5 is a top plan view taken from above of my bait bucket stool shown in FIG. 1; and,

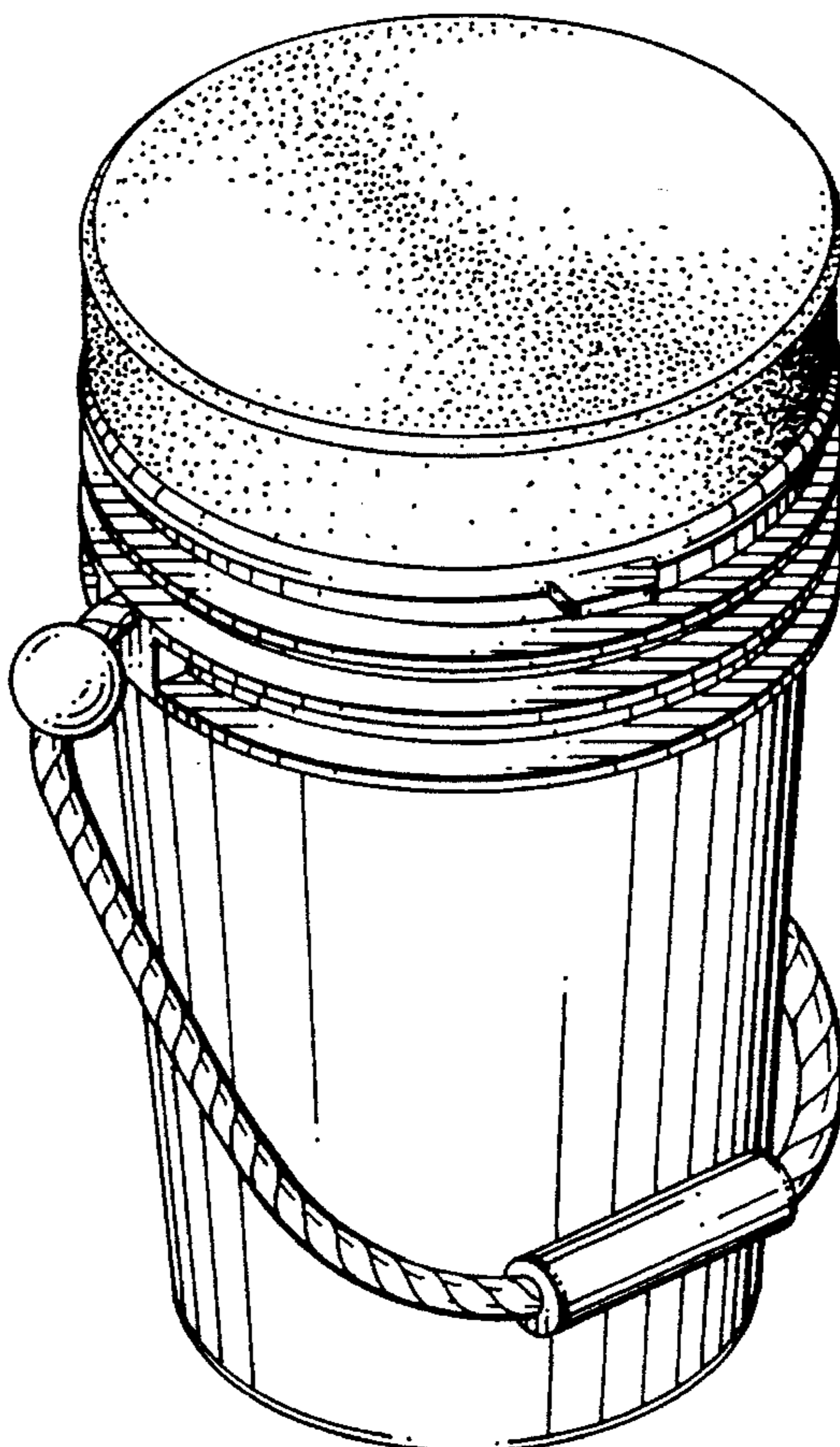
FIG. 6 is a bottom plan view taken from below of my bait bucket stool shown in FIG. 1.

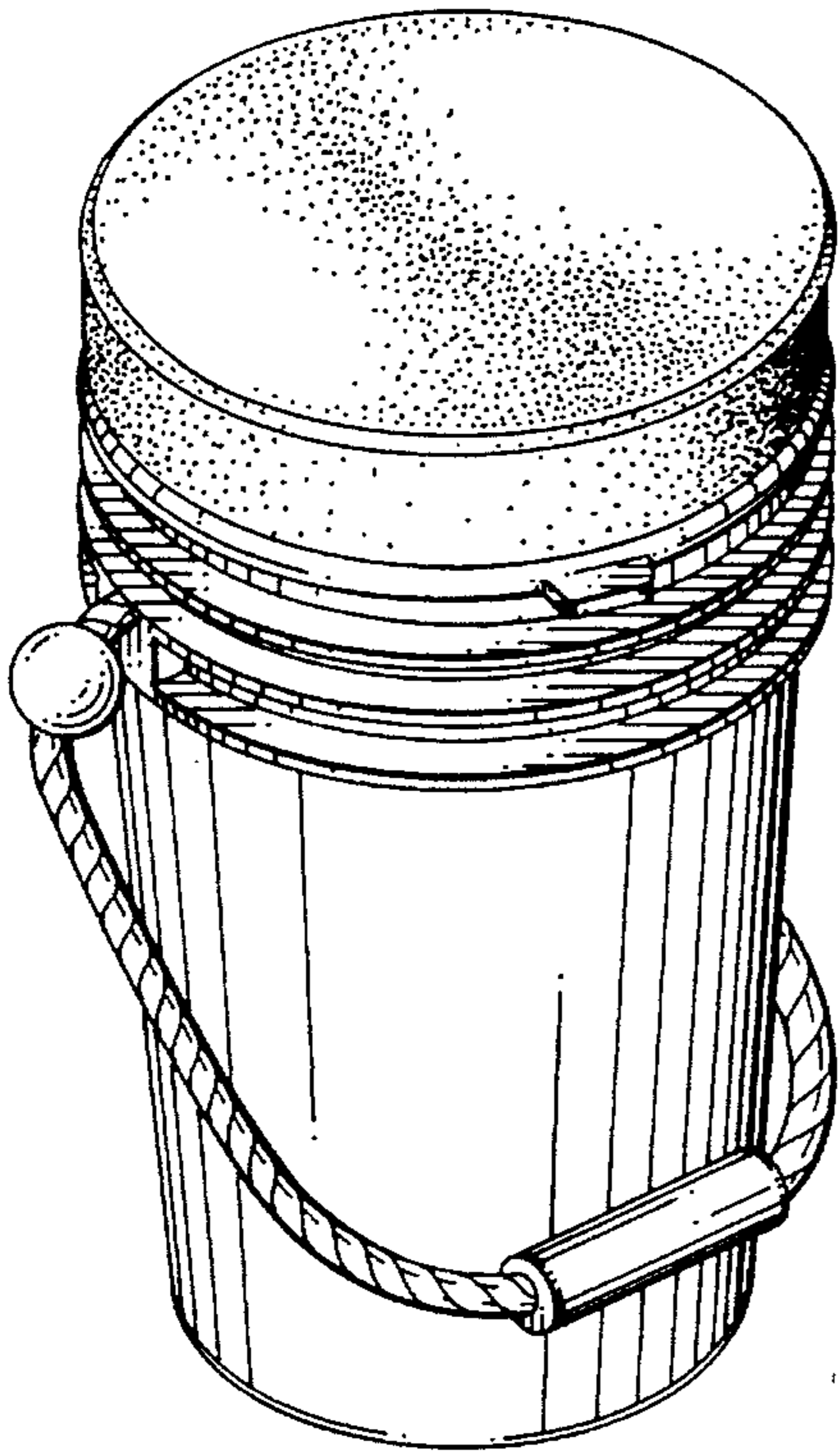

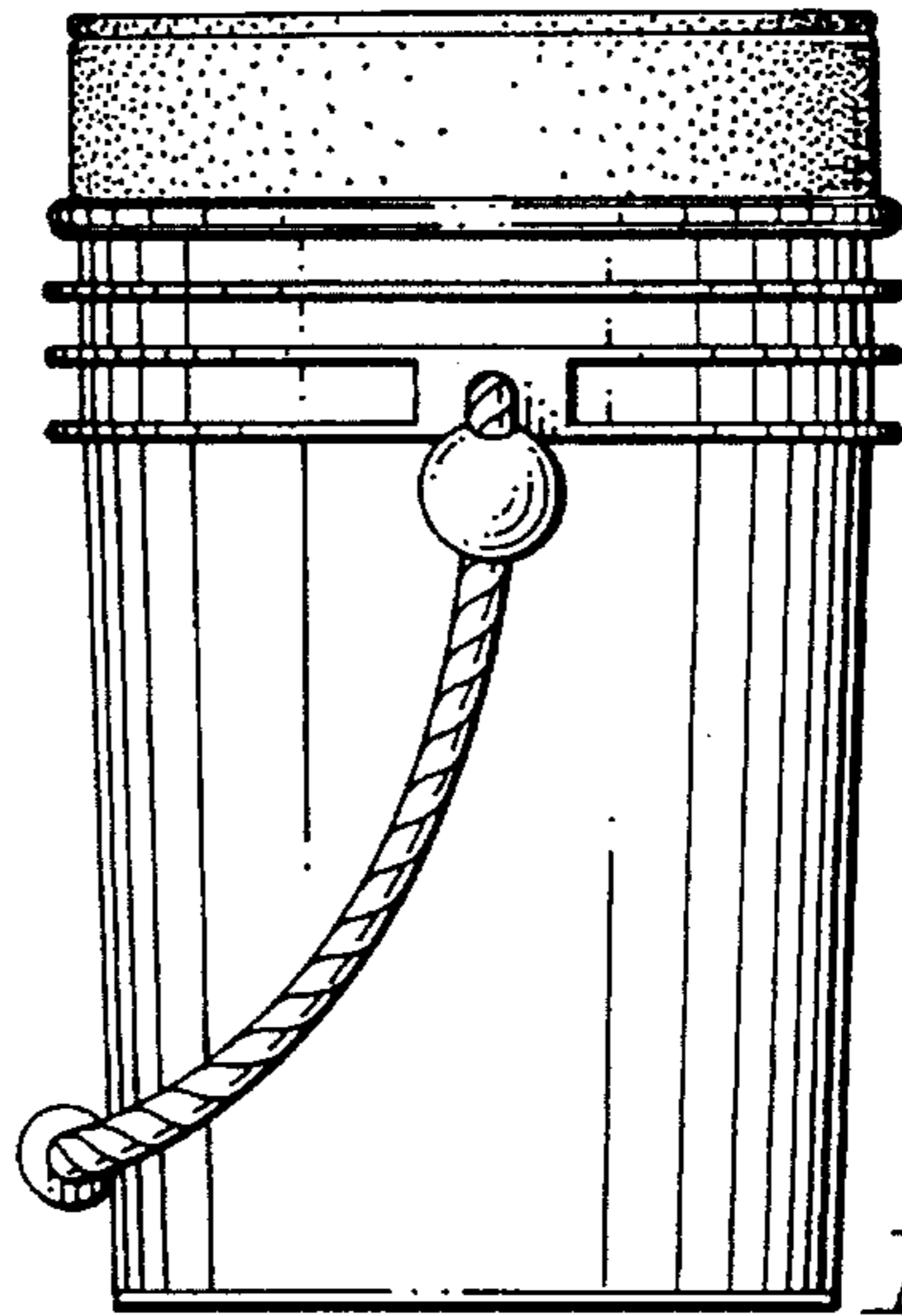

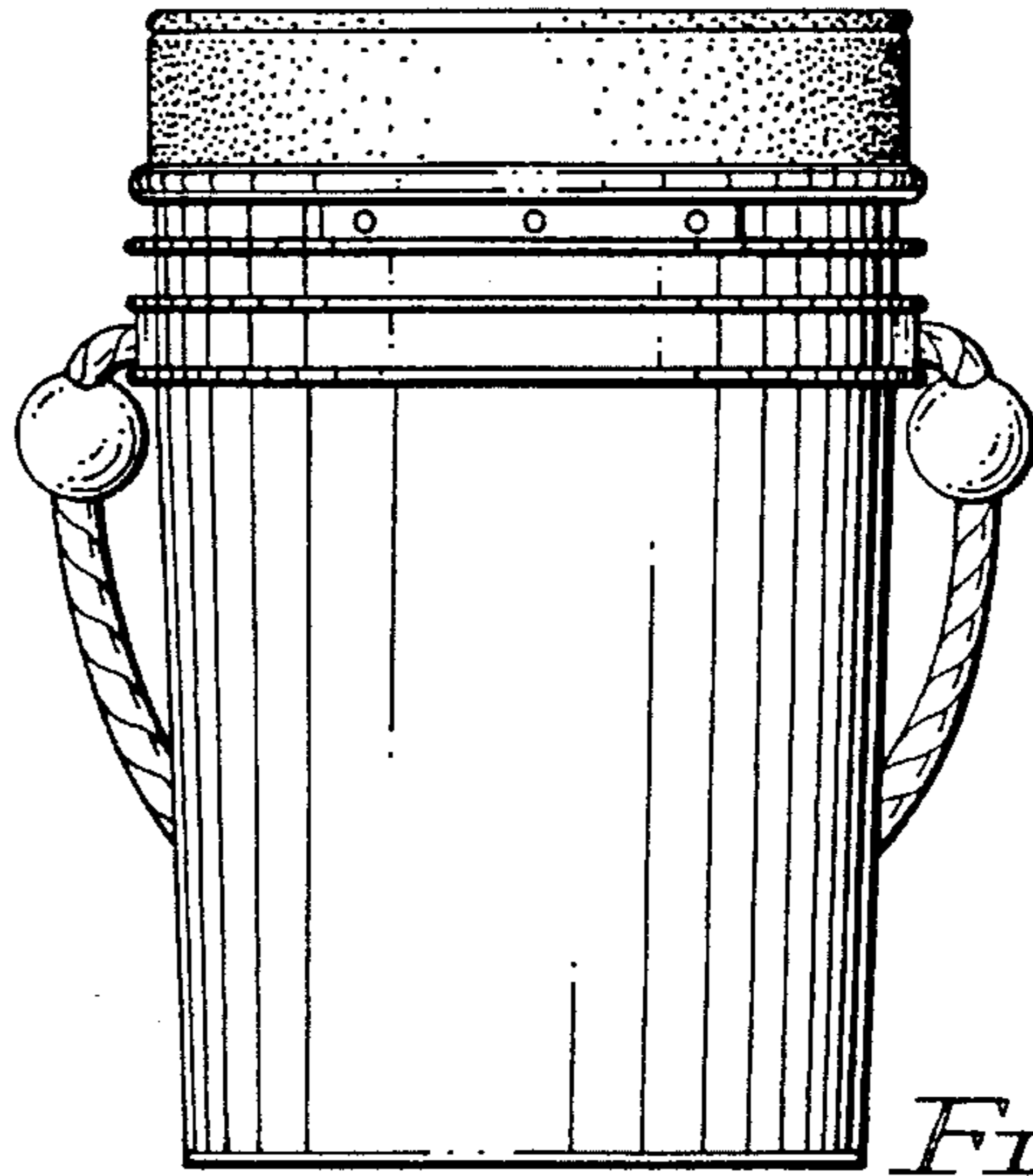

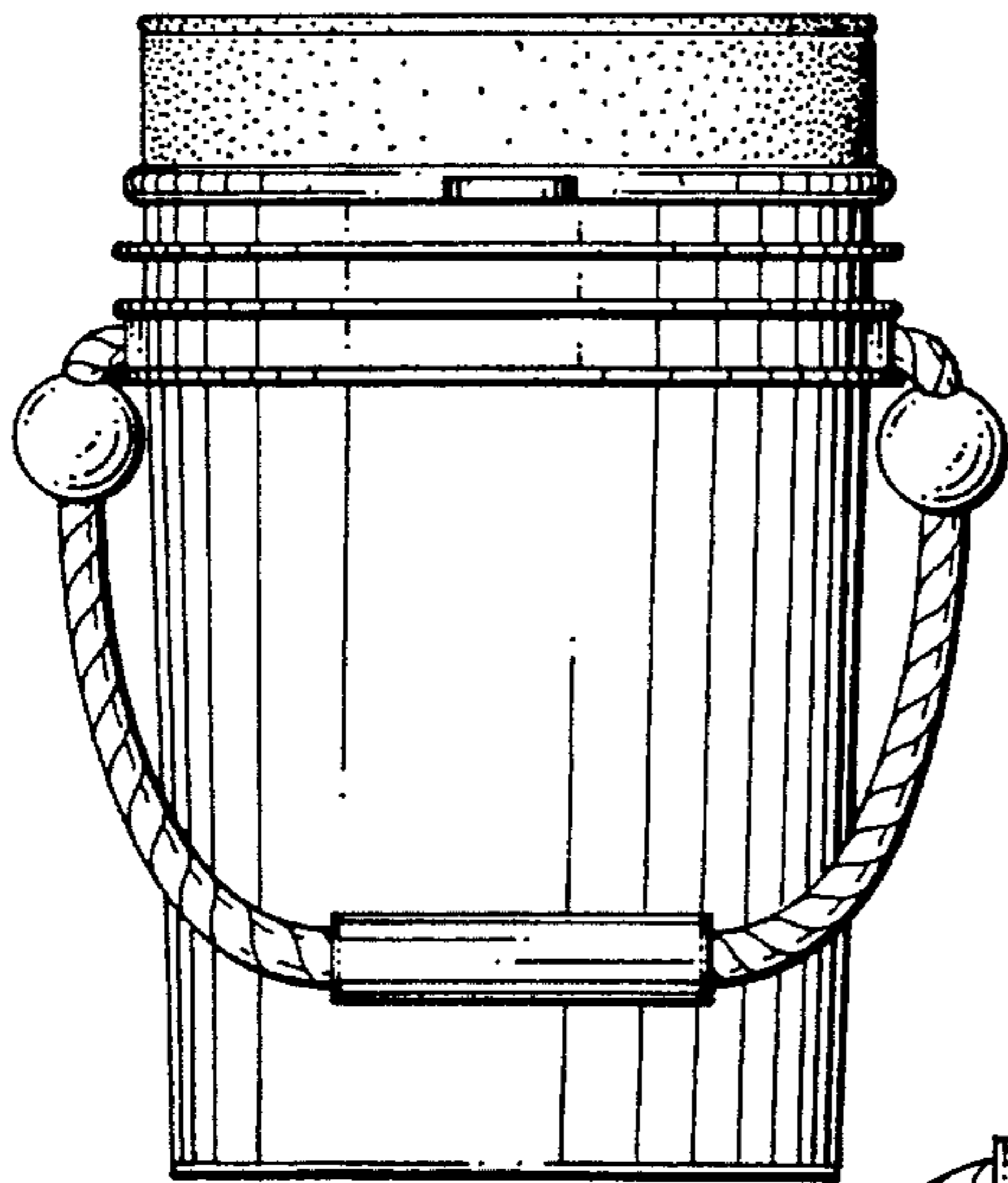

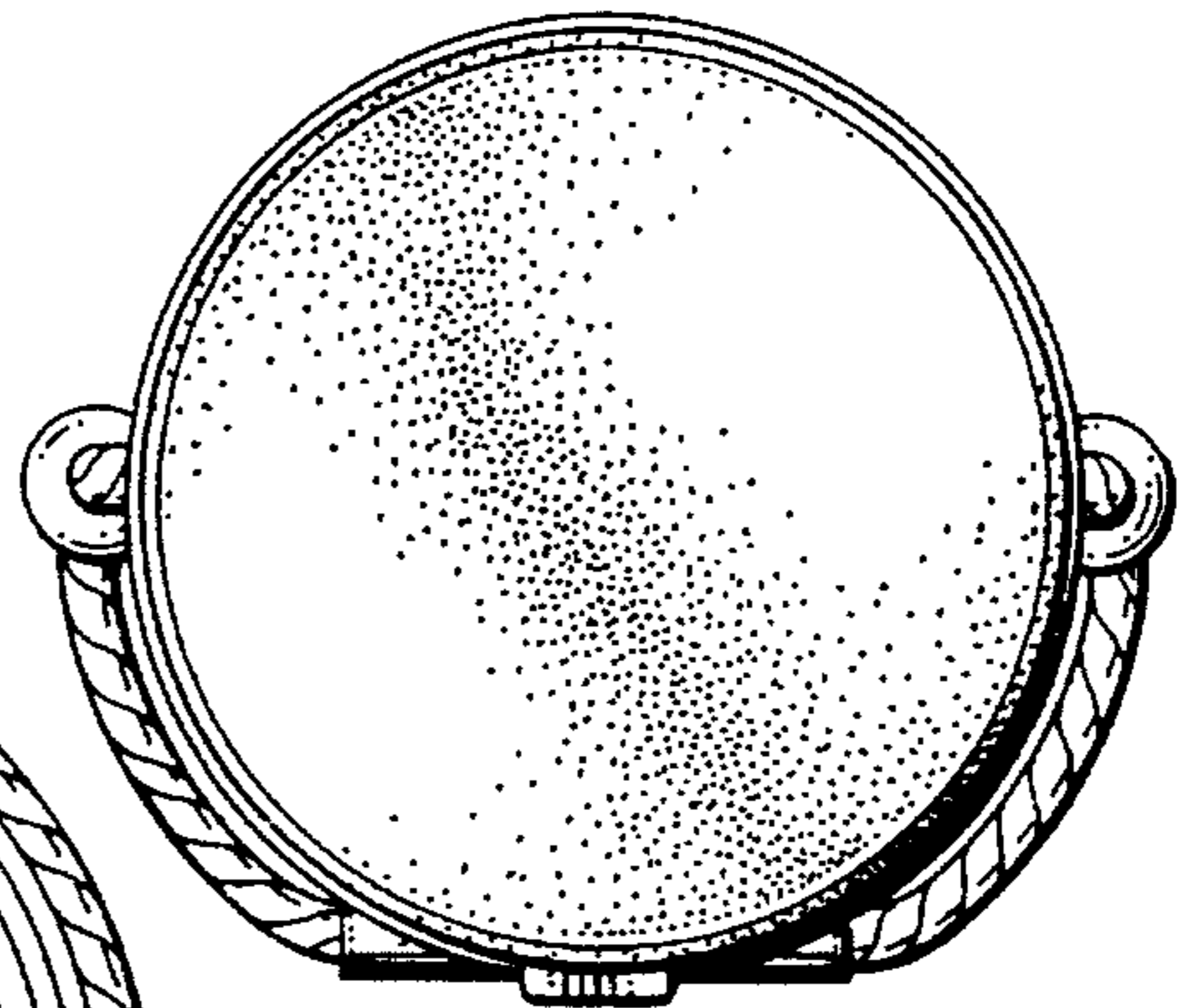

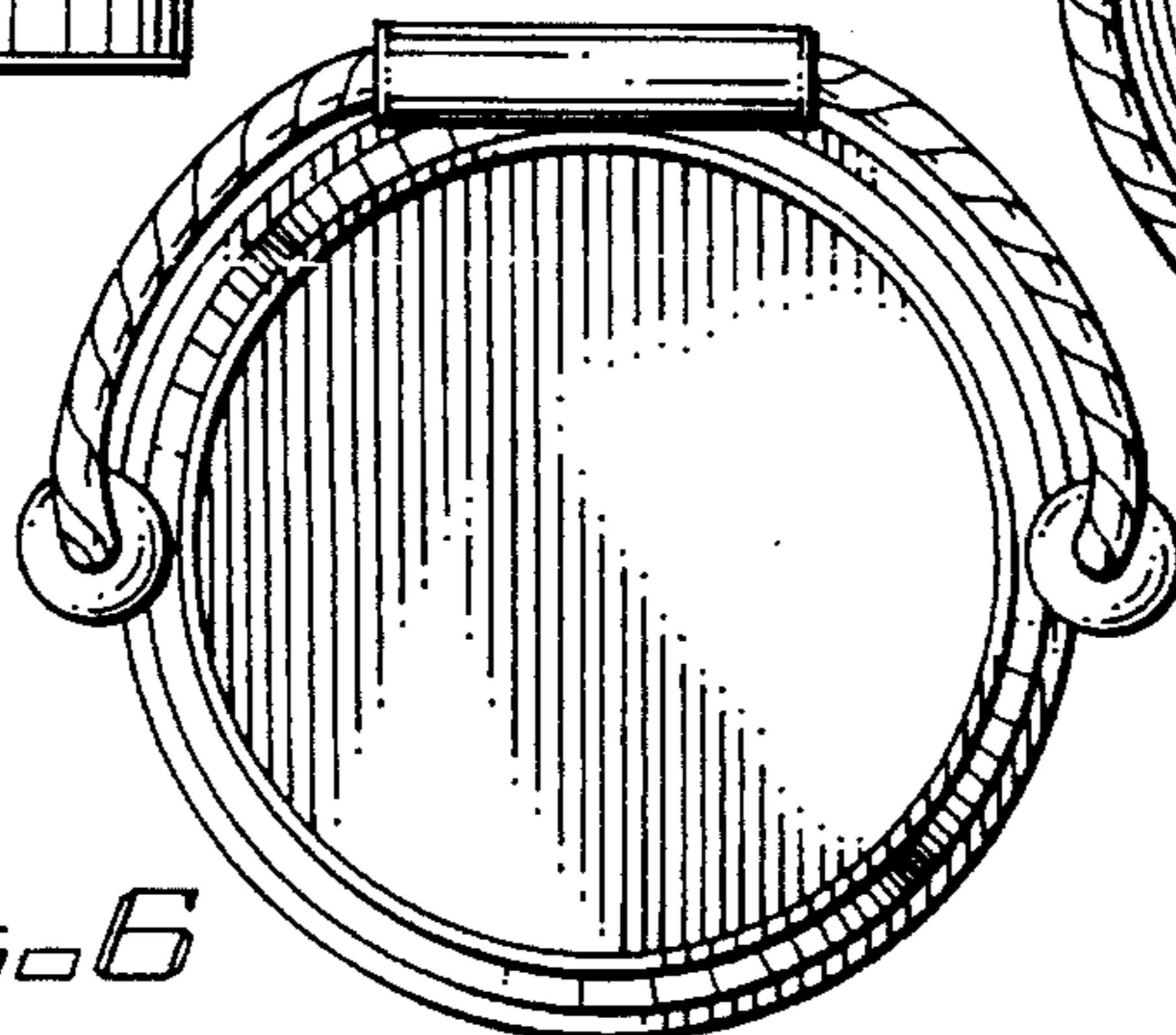
