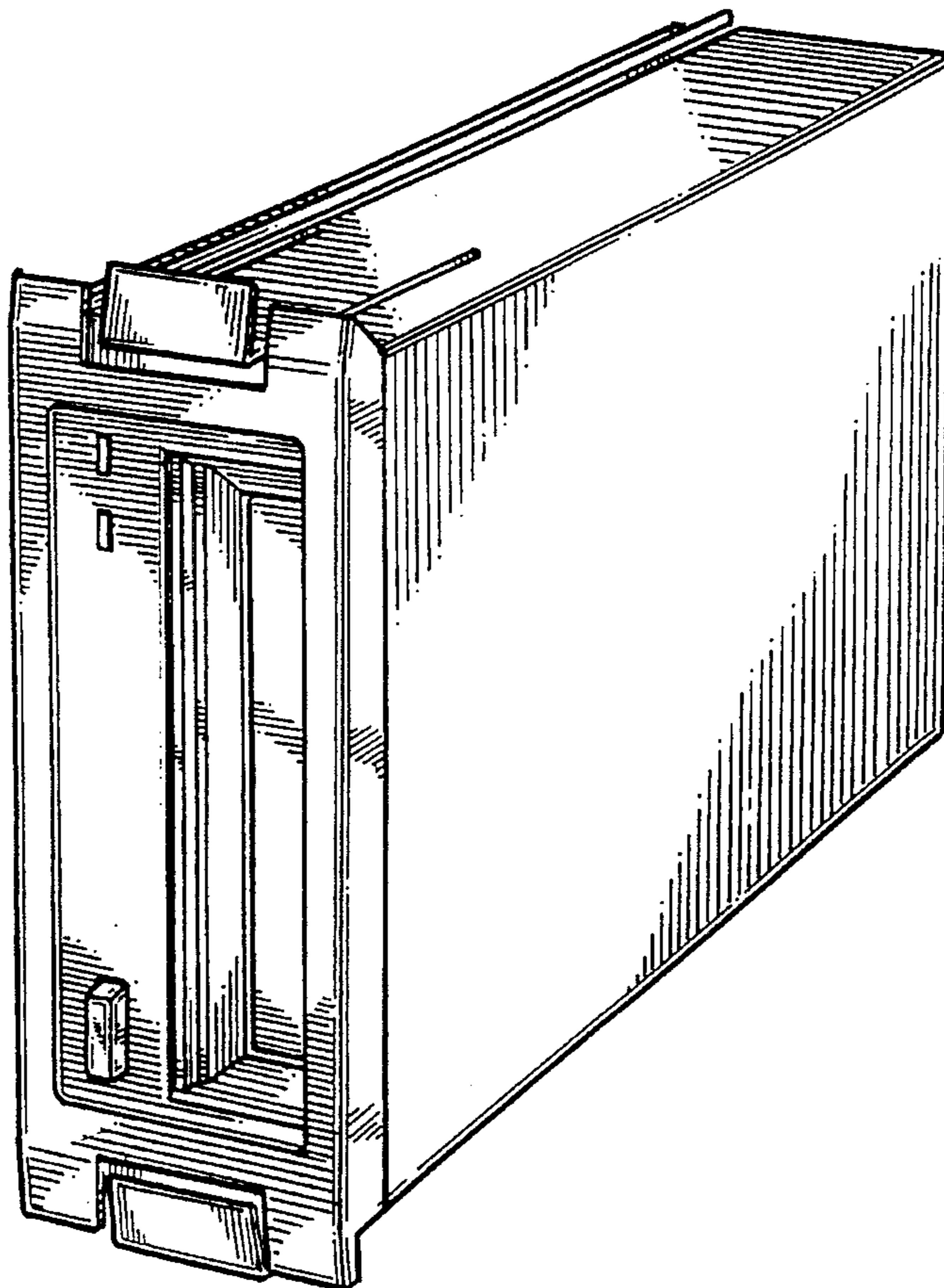
[57] **CLAIM**

The ornamental design for a removable housing for computers, as shown and described.

DESCRIPTION

FIG. 1 is a top front and right side perspective view of a removable housing for computers;
FIG. 2 is a bottom rear and right side perspective view thereof; and,
FIG. 3 is a left side elevational view thereof.
The undisclosed portion of the recessed area in FIG. 1 is identical to the portion which is shown.

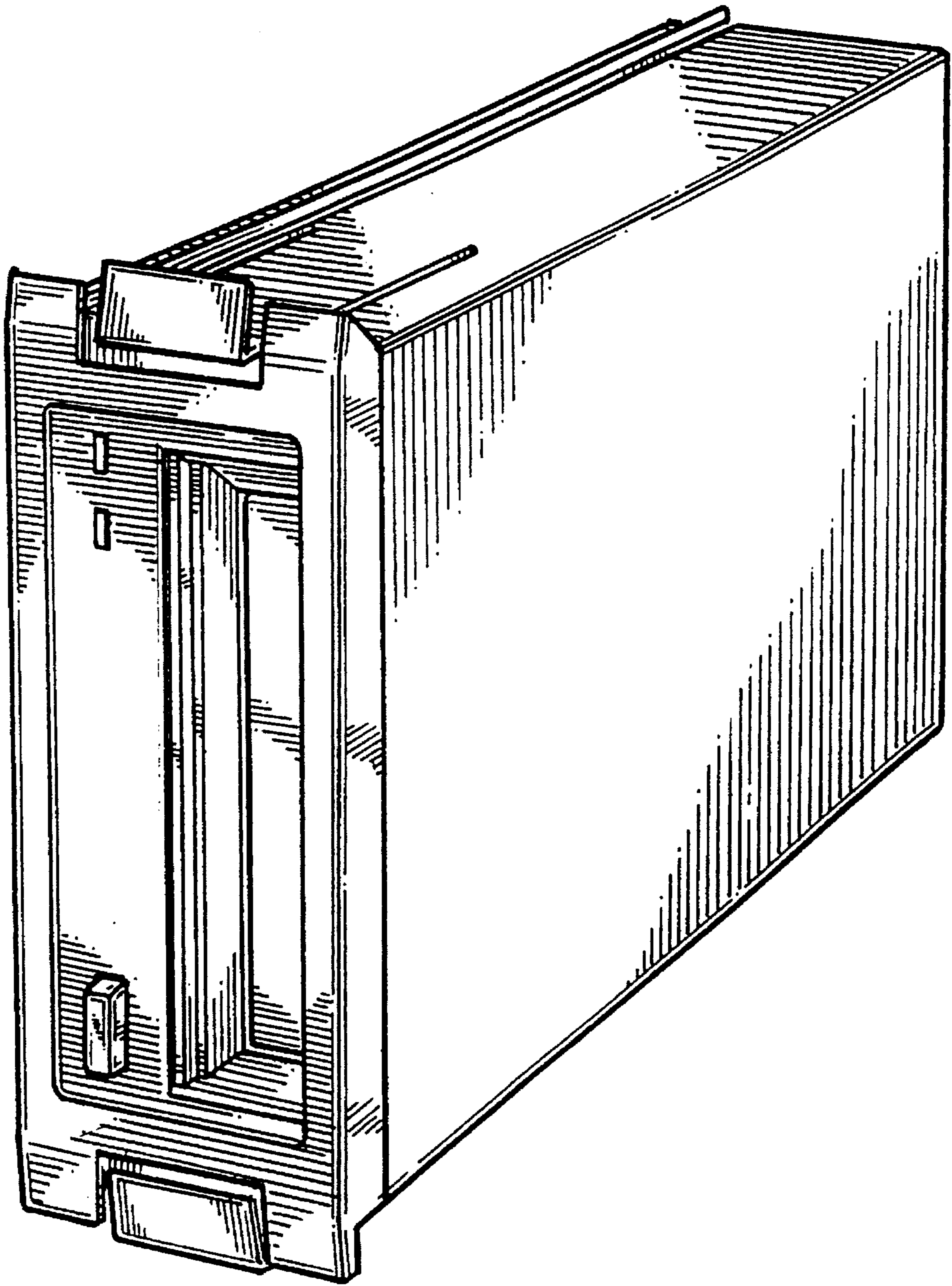

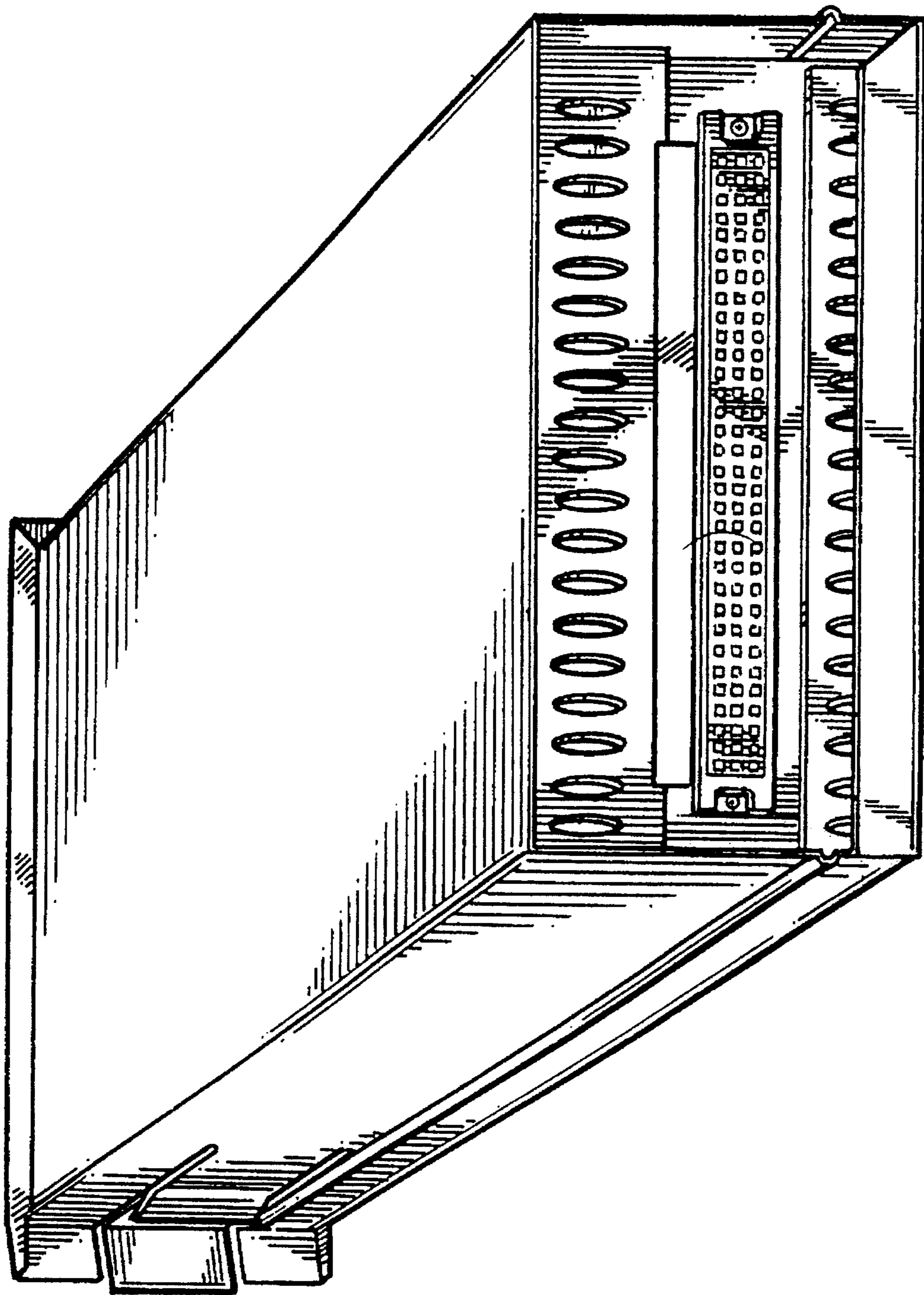

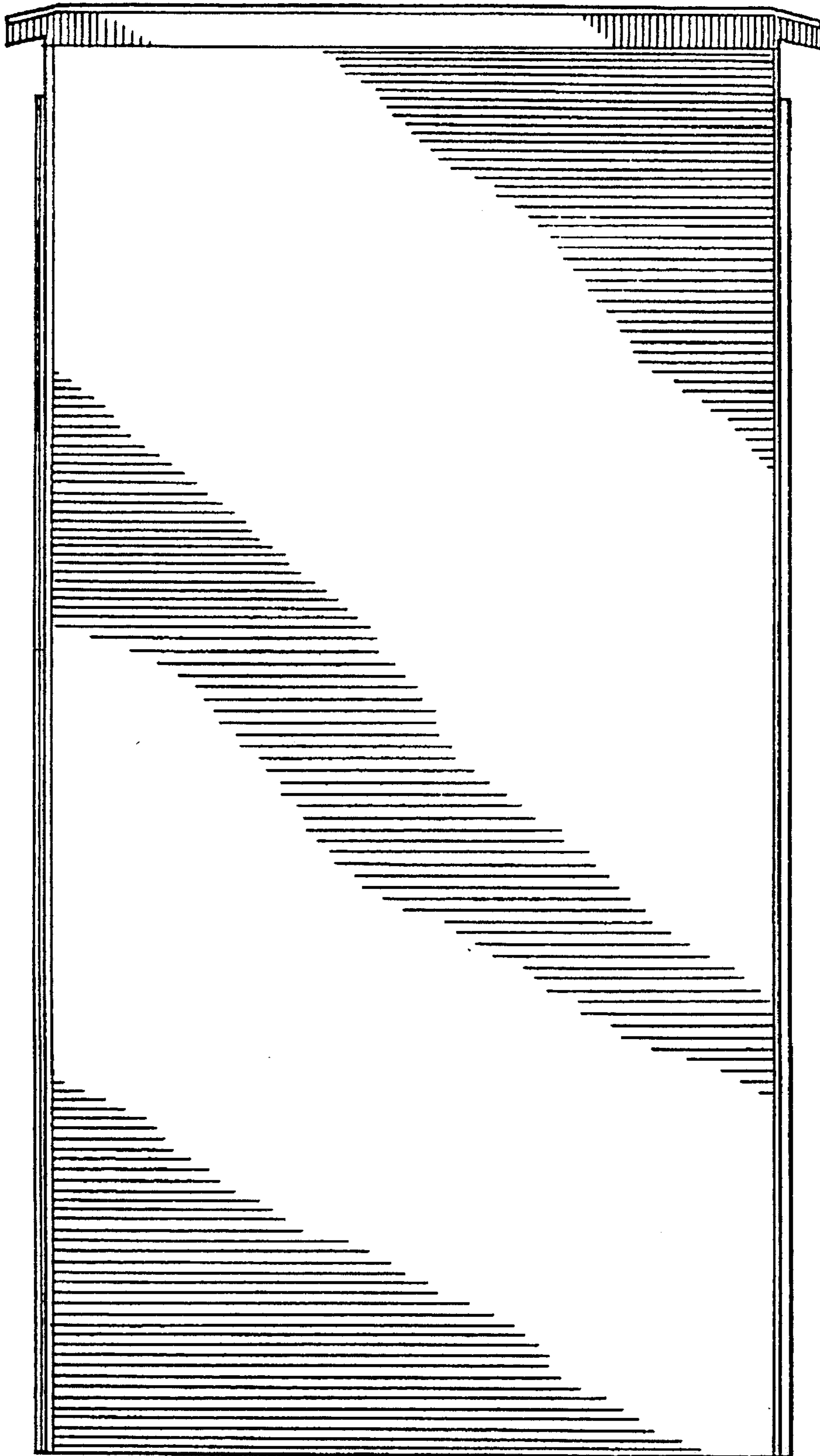
