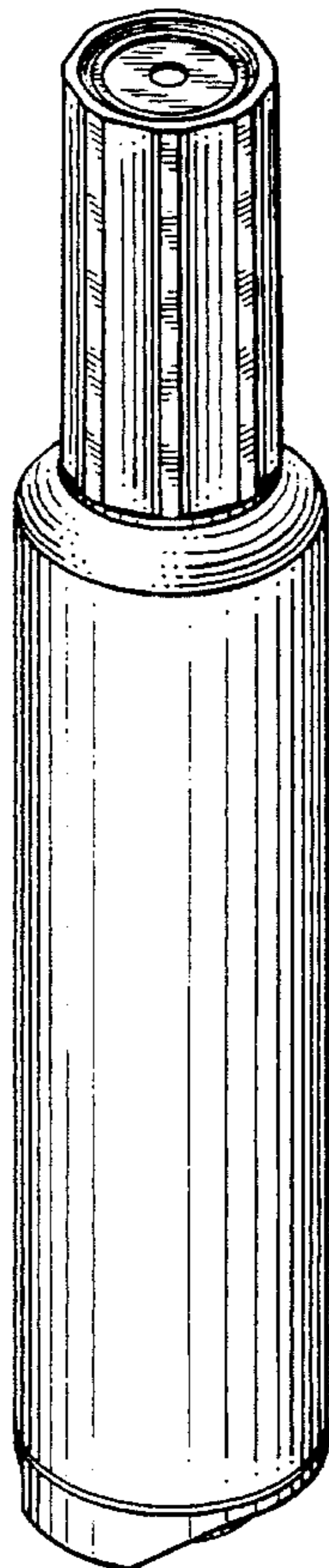
FIG. 1 is a perspective view of the inventive marker;

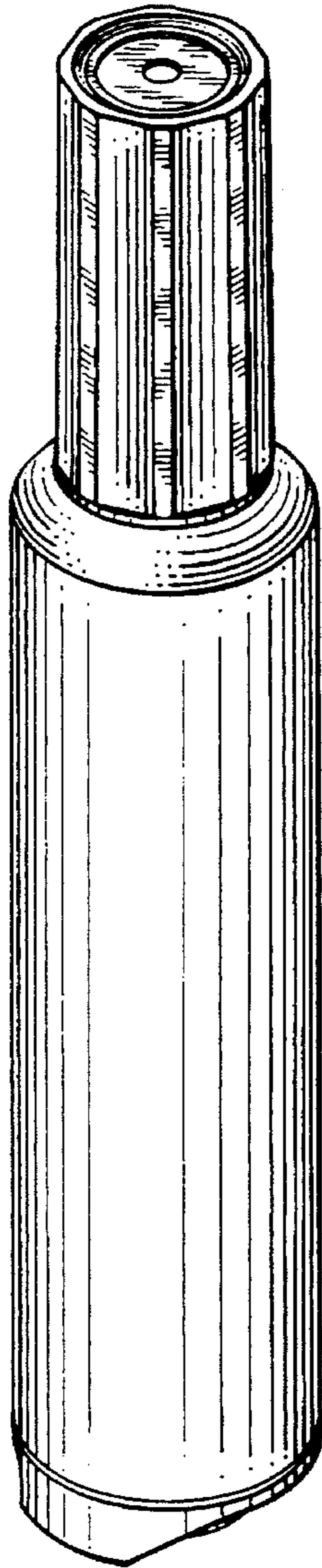

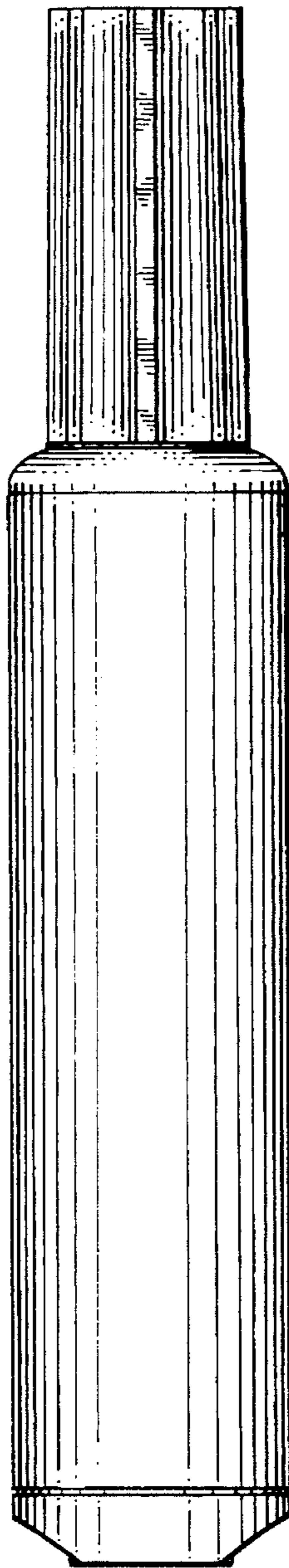

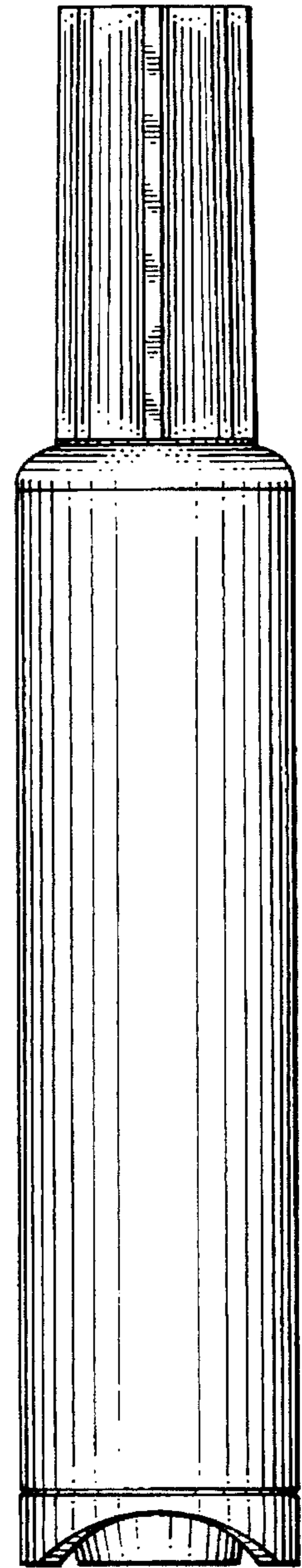

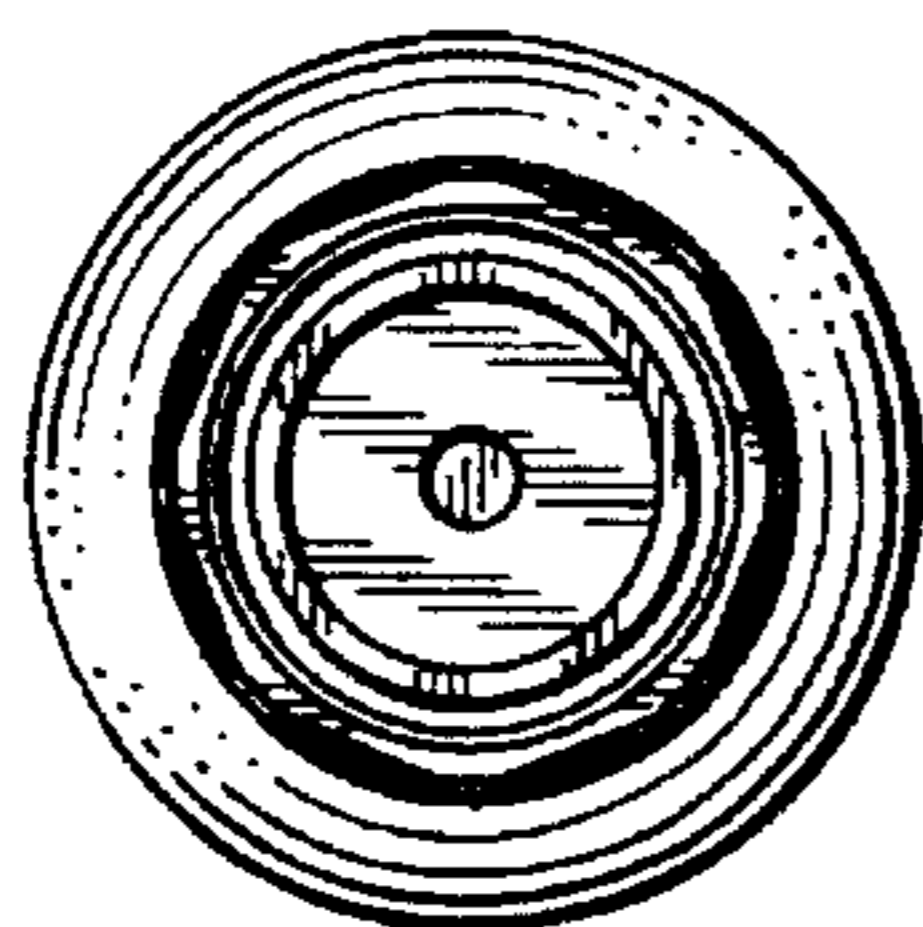

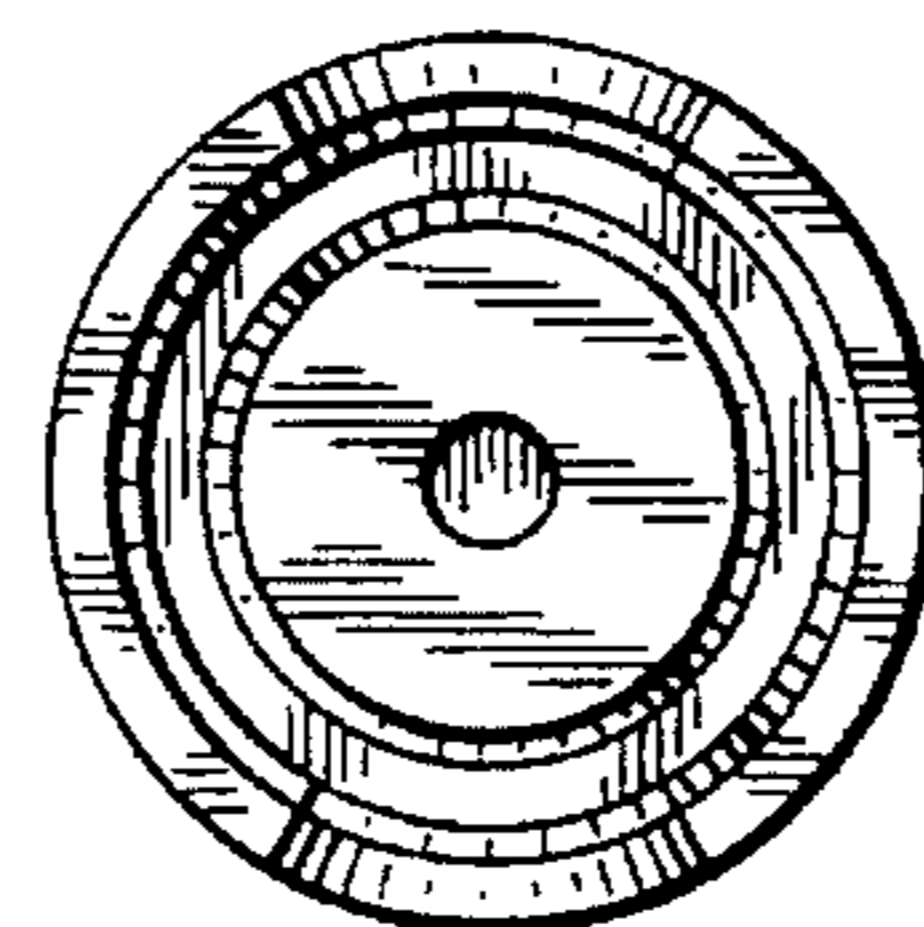

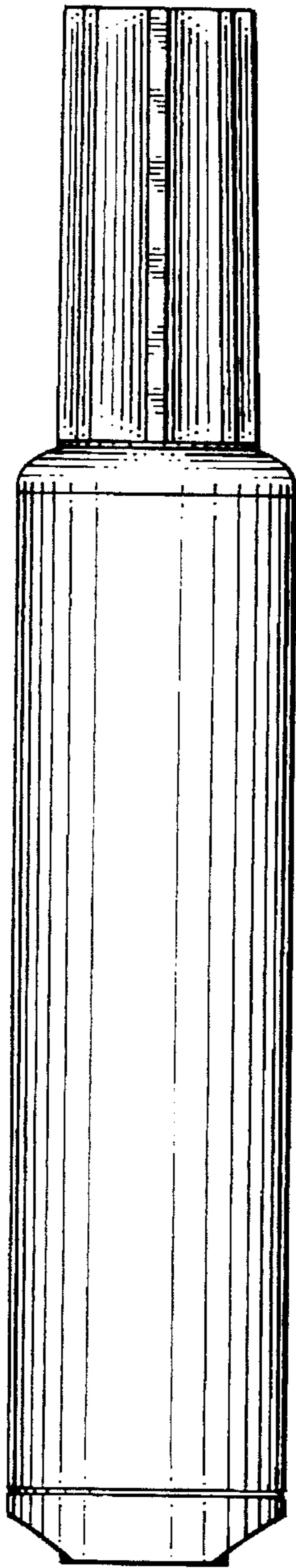

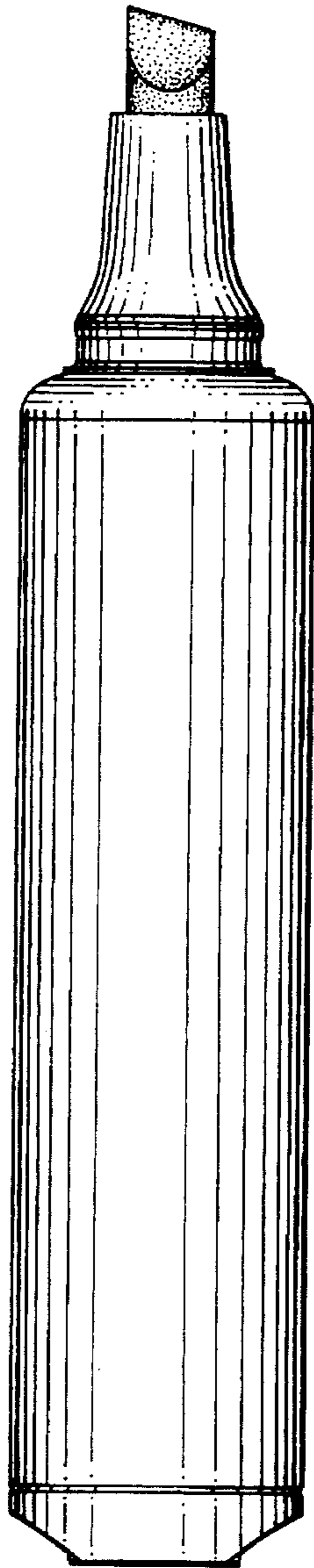

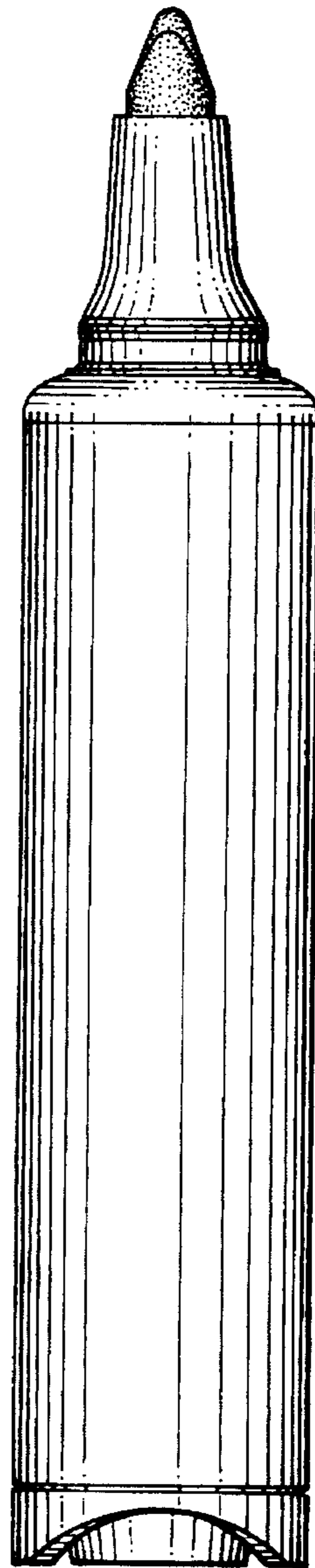

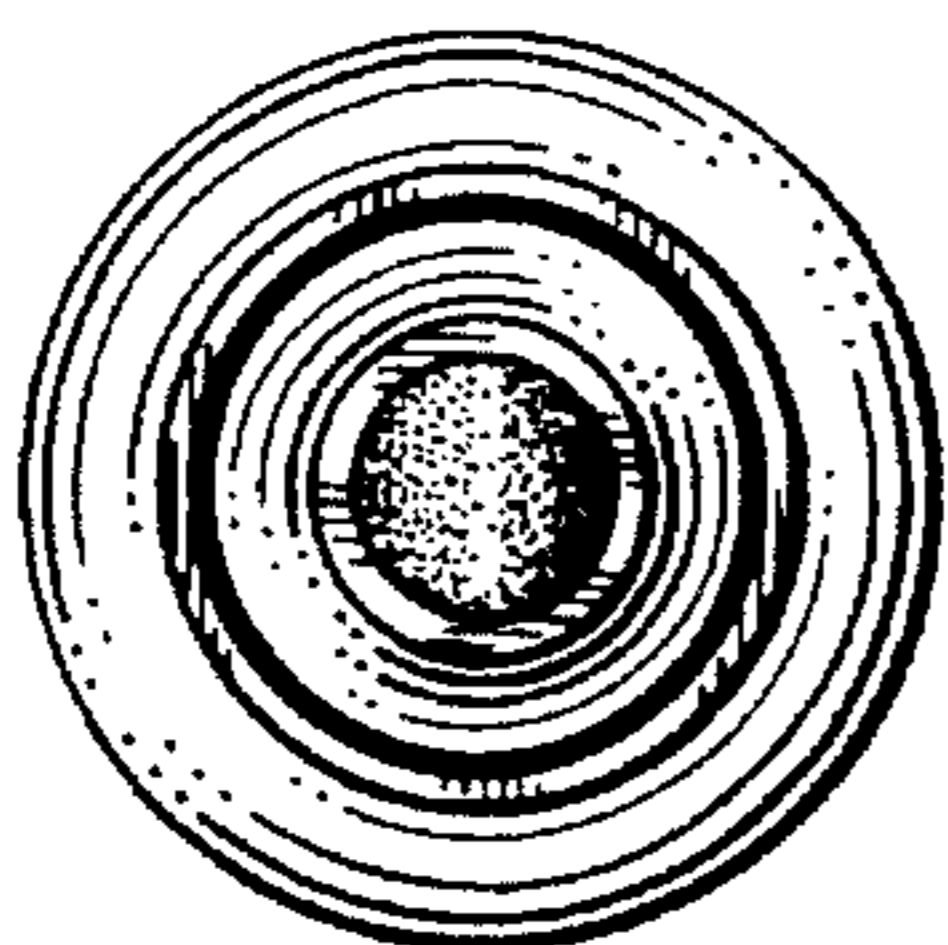

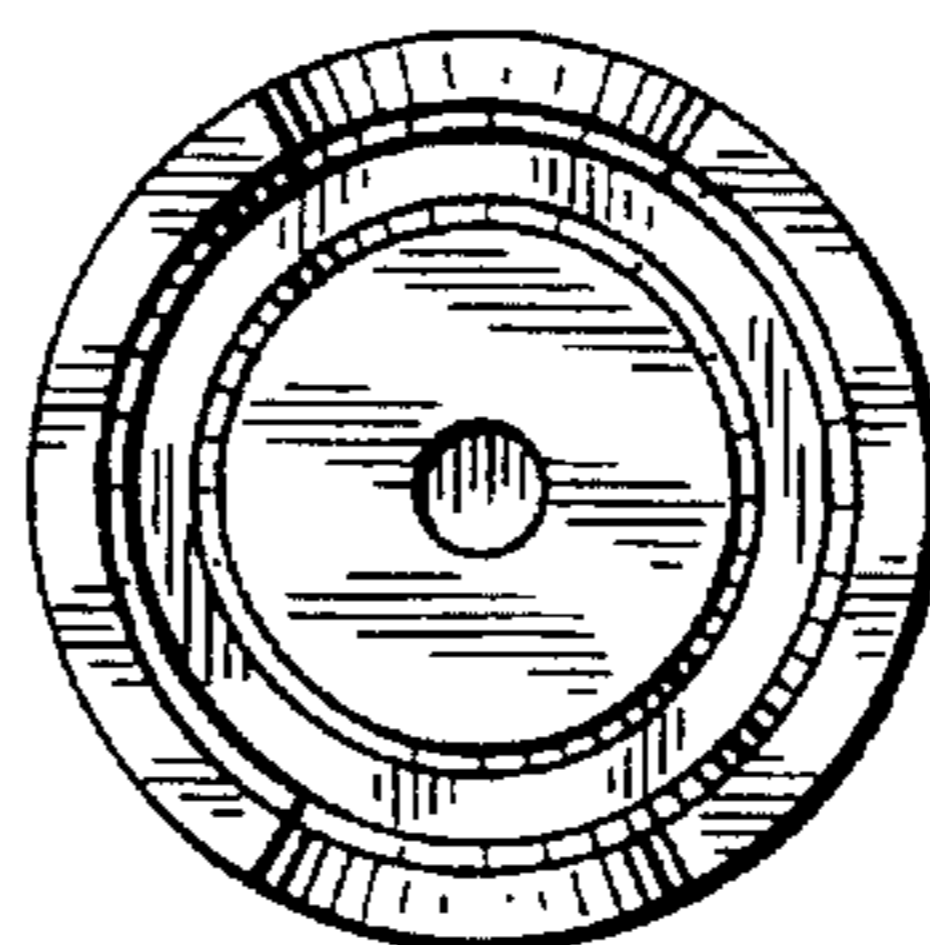

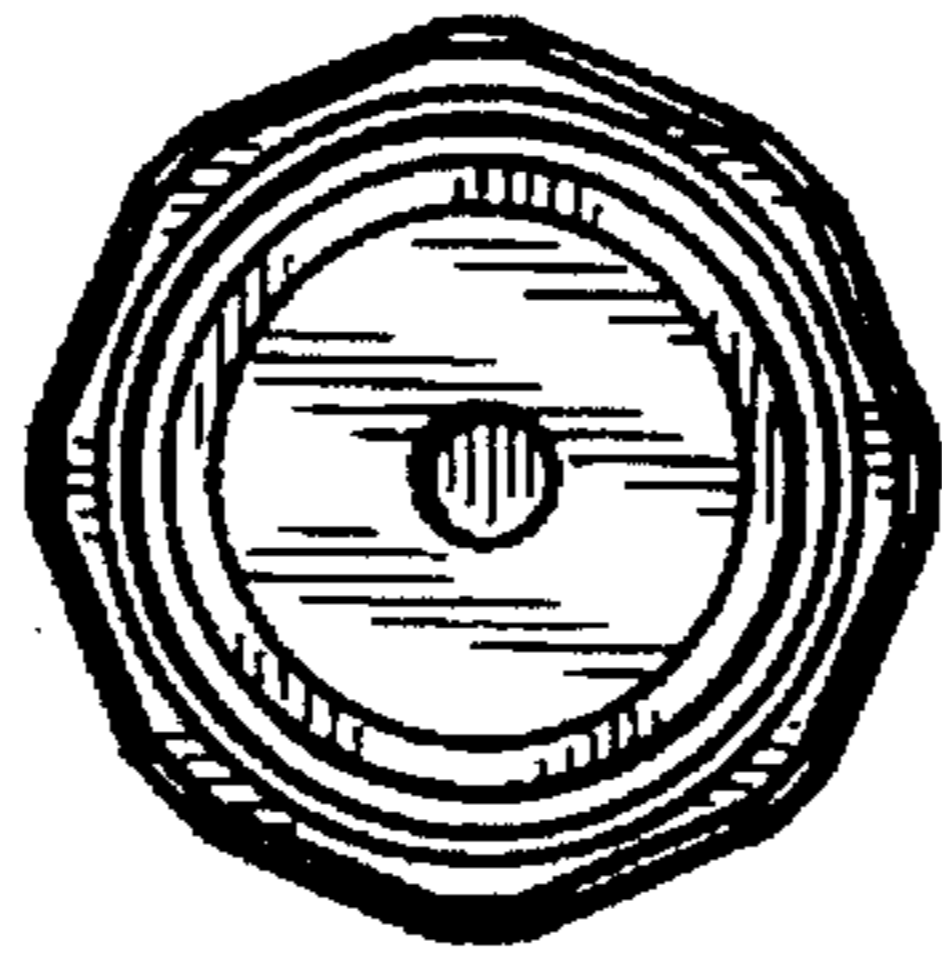

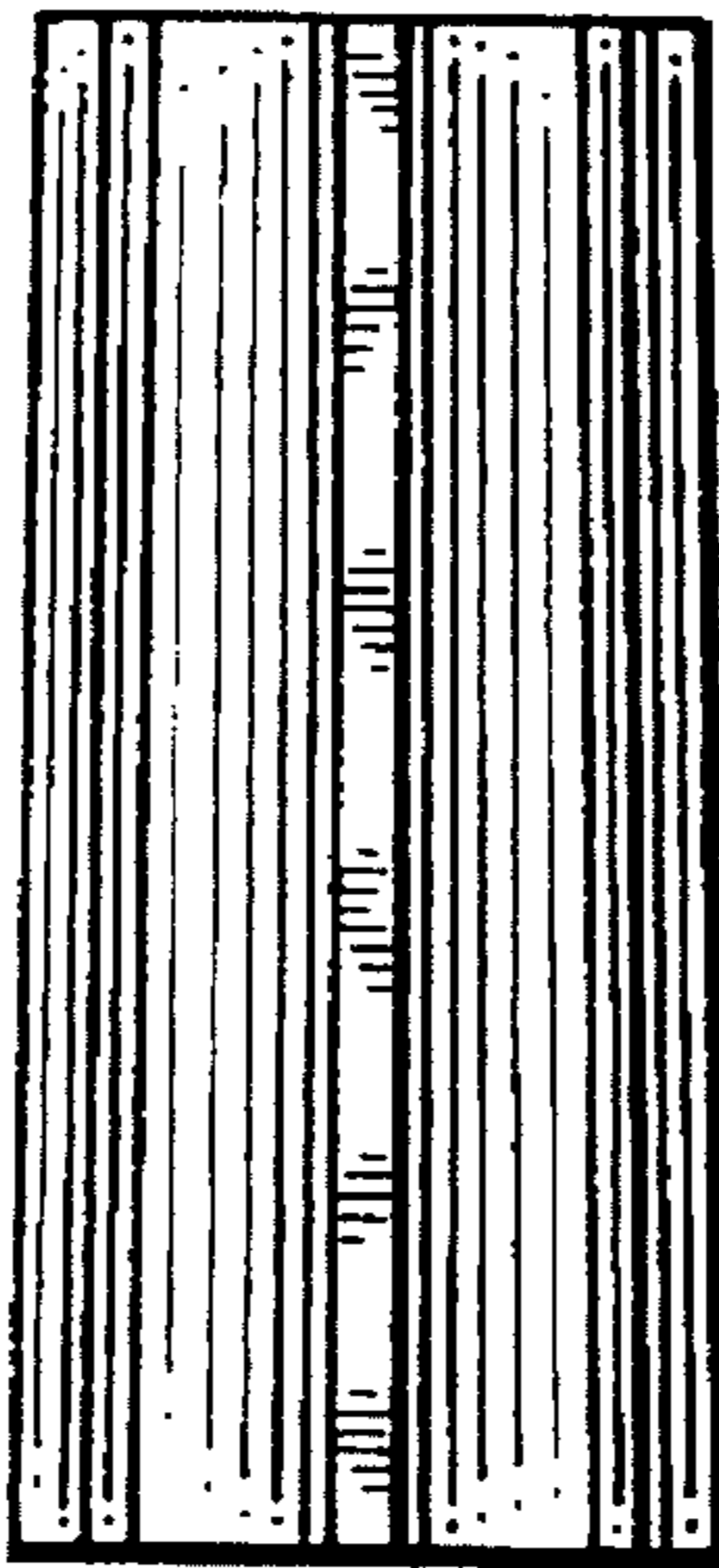
