[57] **CLAIM**

The ornamental design for the combined toy skeleton arm and detachable skull unit, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combined toy skeleton arm and detachable skull unit, the skull in an open position and the partial human arm shown in broken lines for illustrative purposes only;

FIG. 2 is a perspective view thereof, with the skull unit removed for clarity of illustration;

FIG. 3 is a top plan view of FIG. 1;

FIG. 4 is a right side elevational view of FIG. 1;

FIG. 5 is a bottom pan view of FIG. 1;

FIG. 6 is a left side elevational view of FIG. 1, the skull in a closed position;

FIG. 7 is a front elevational view of FIG. 6;

FIG. 8 is a rear elevational view of FIG. 6;

FIG. 9 is a top plan view of FIG. 2;

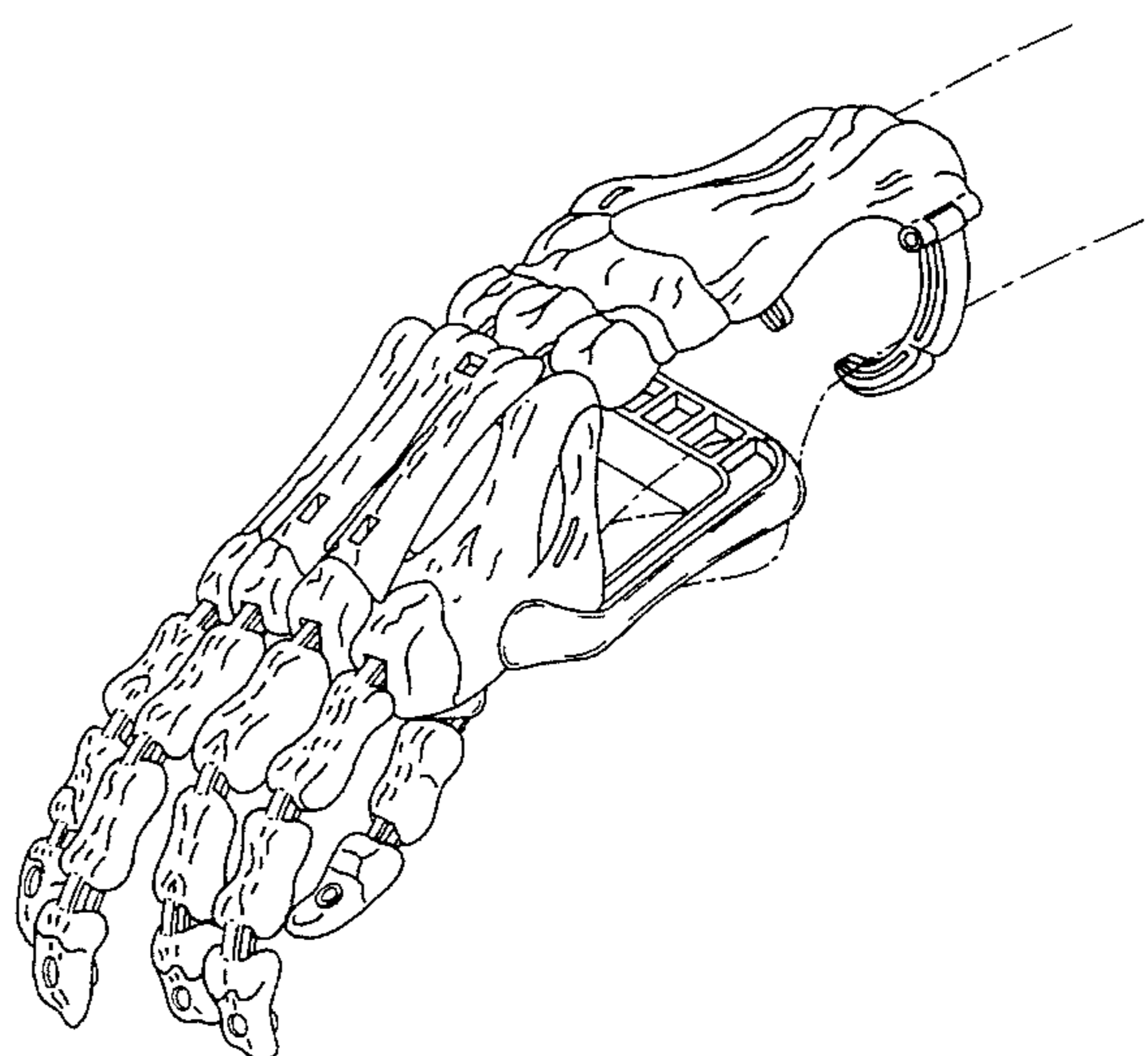
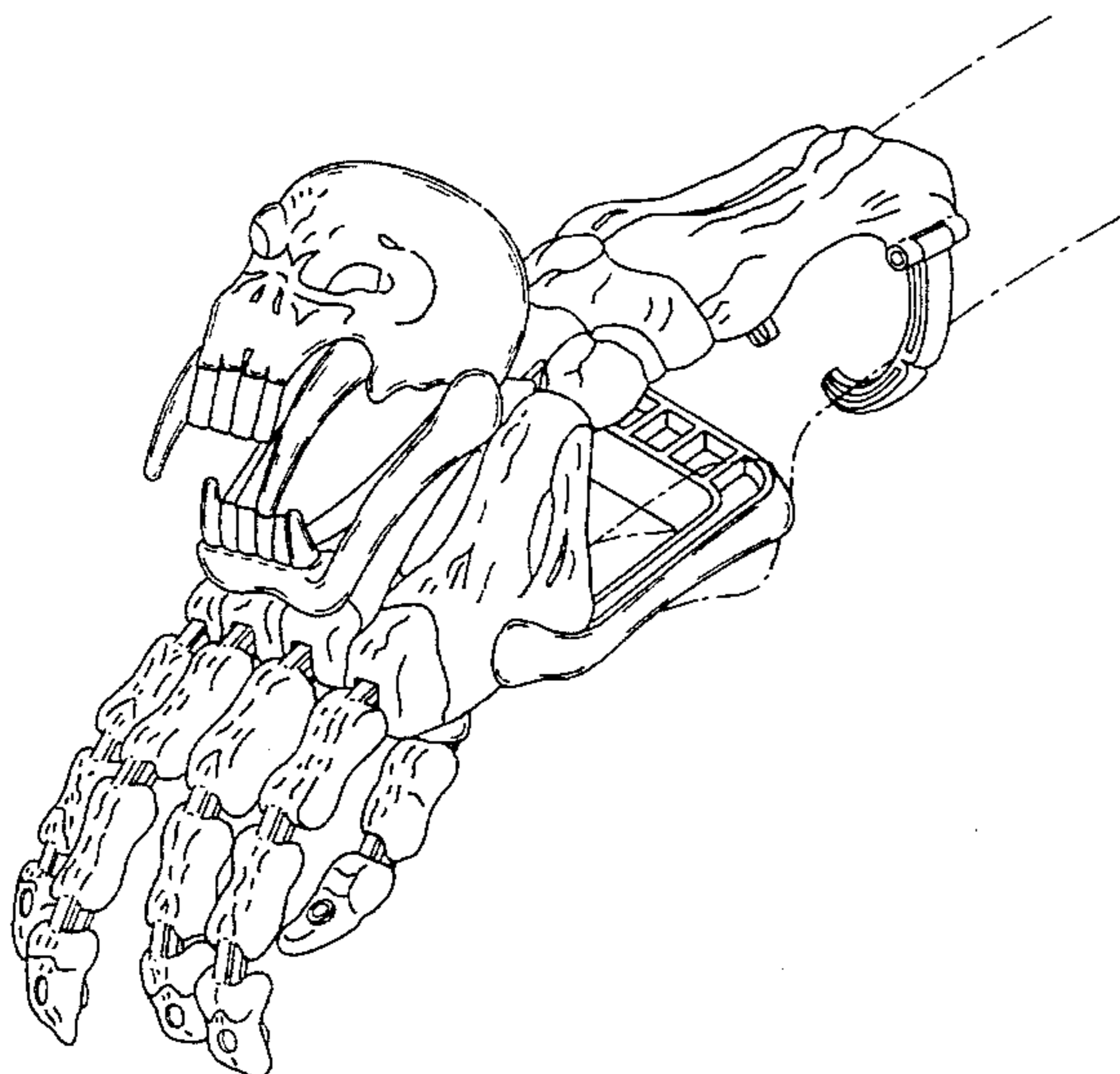
FIG. 10 is a front elevational view of the detachable skull unit thereof shown in the closed position and shown separately for clarity of illustration;

FIG. 11 is a left side elevational view of FIG. 10;

FIG. 12 is a front elevational view of the detachable skull unit of FIG. 11 shown in an open position; and,

FIG. 13 is a left side elevational view of FIG. 12.

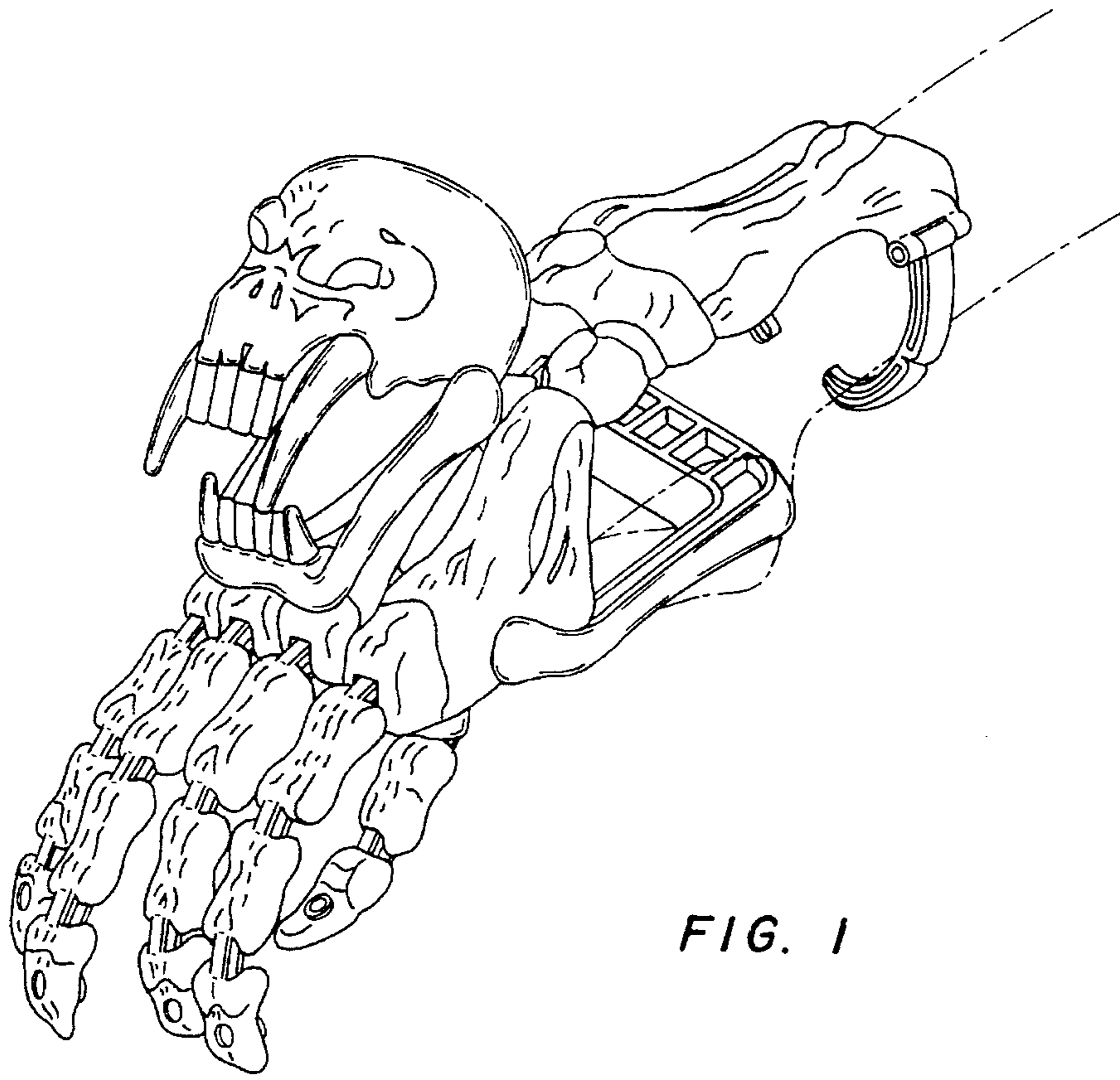

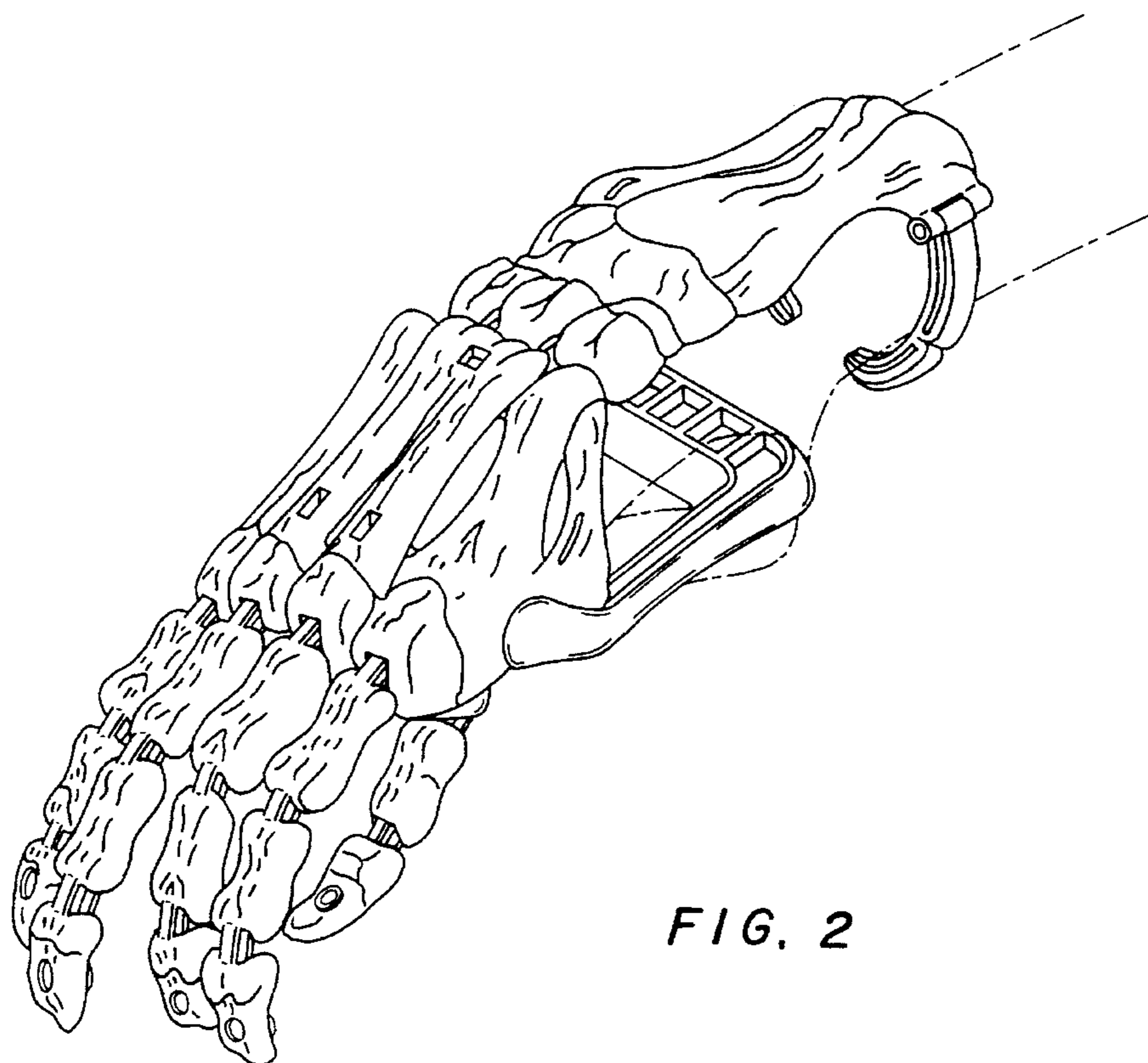

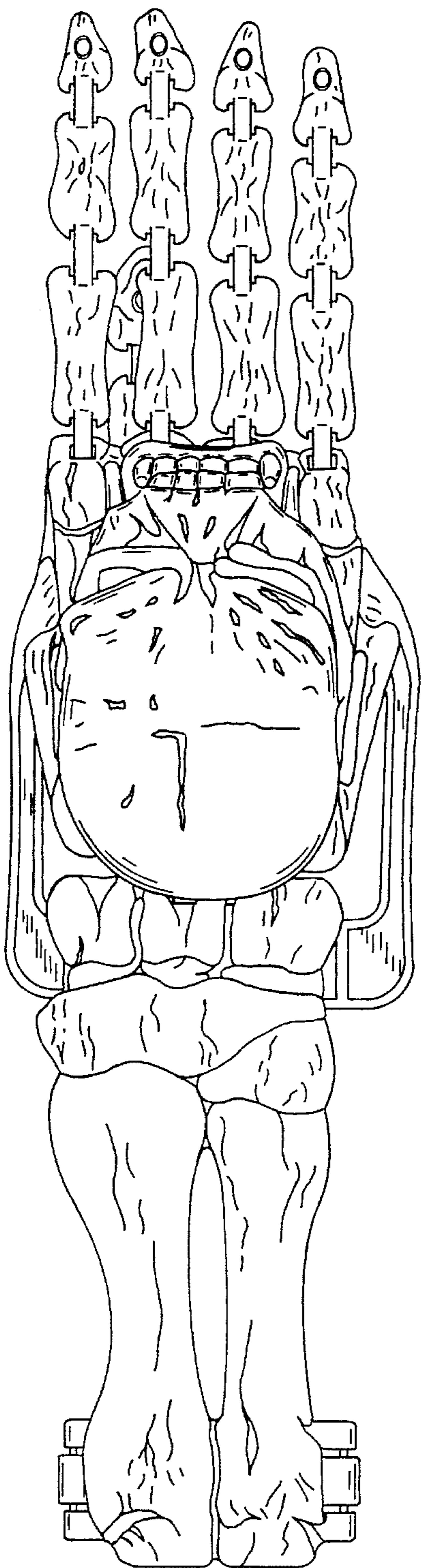

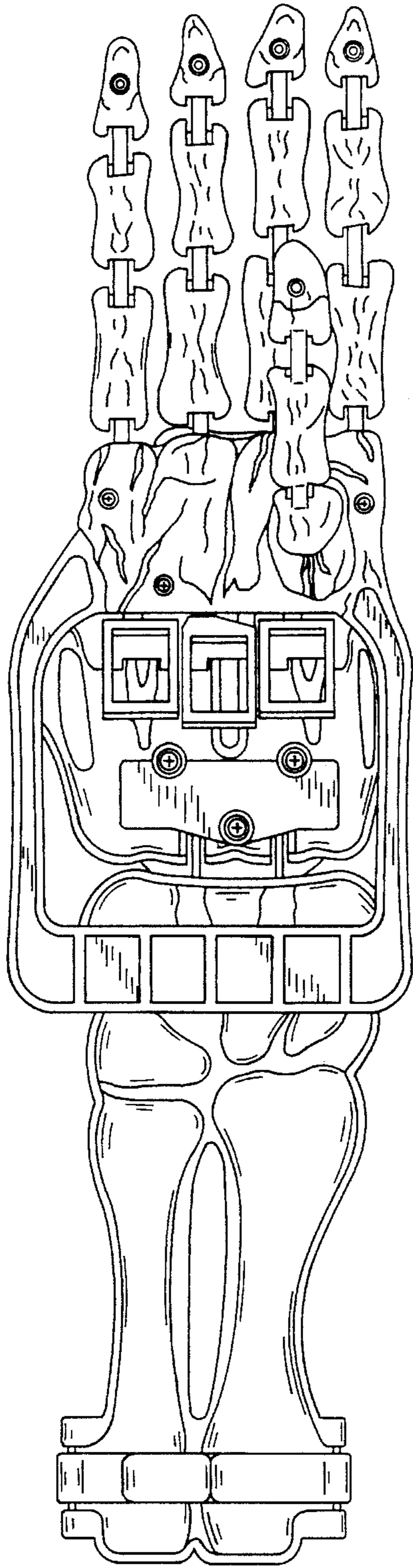

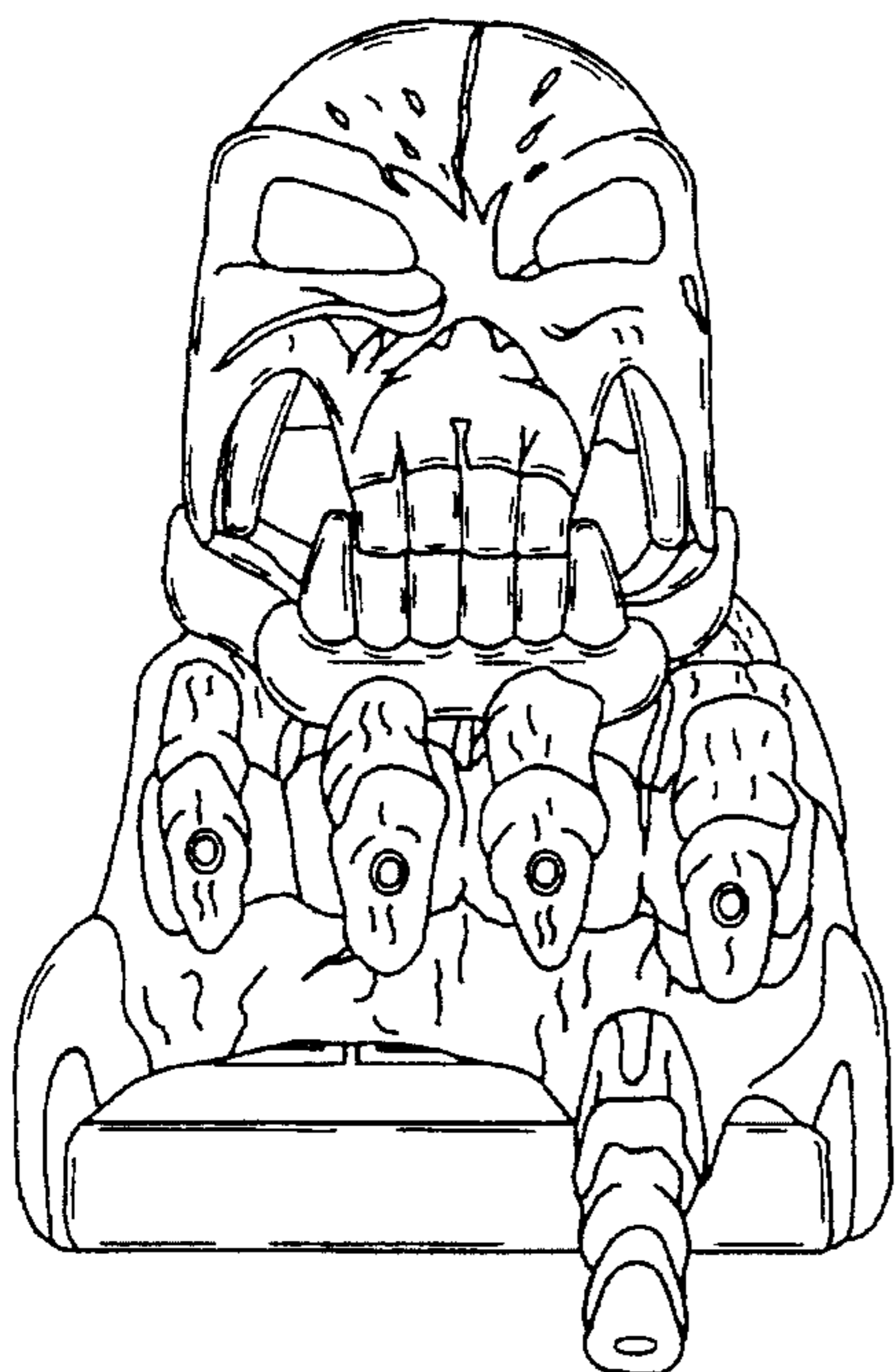

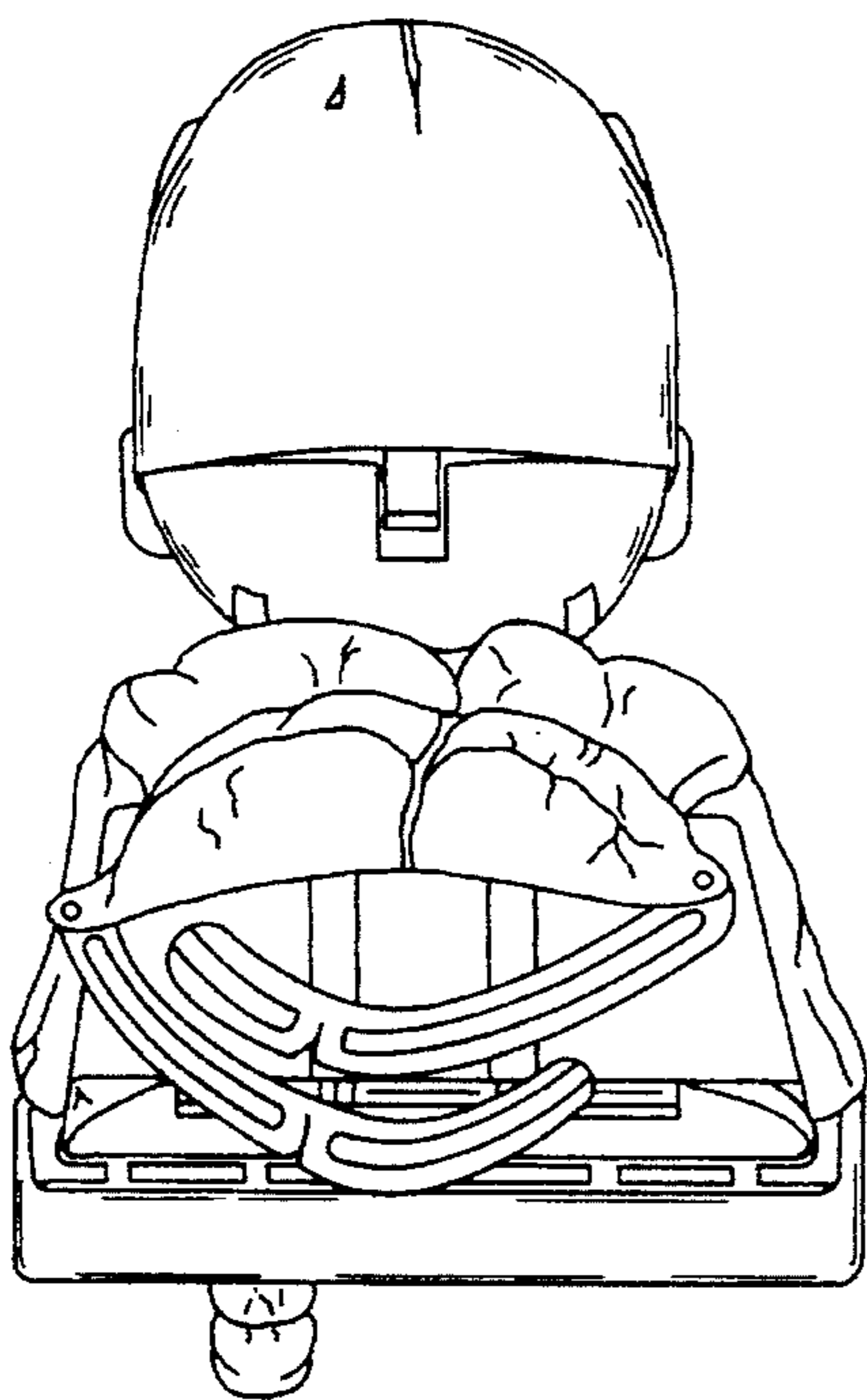

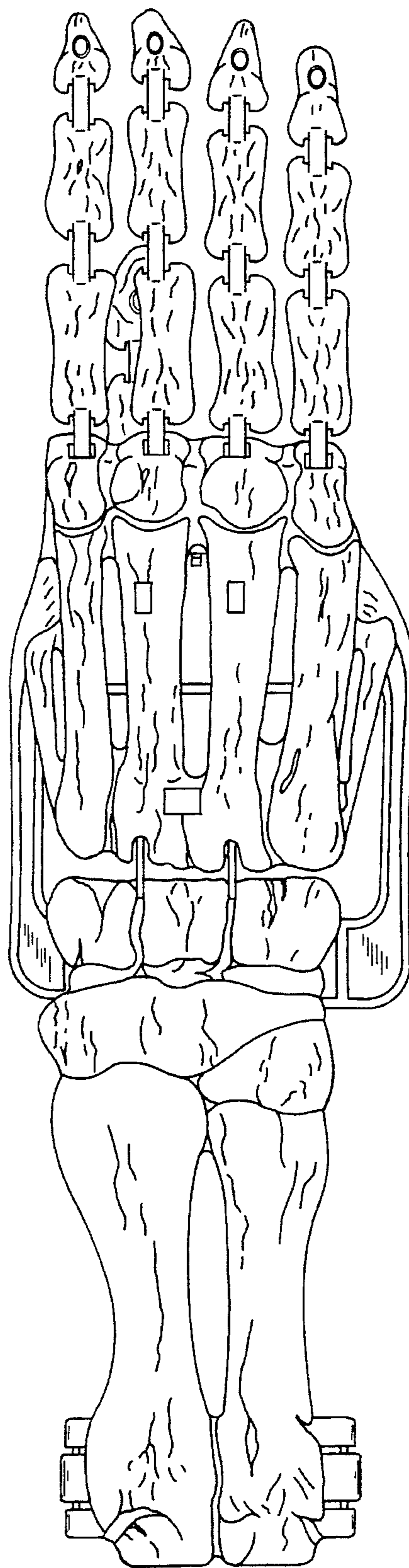

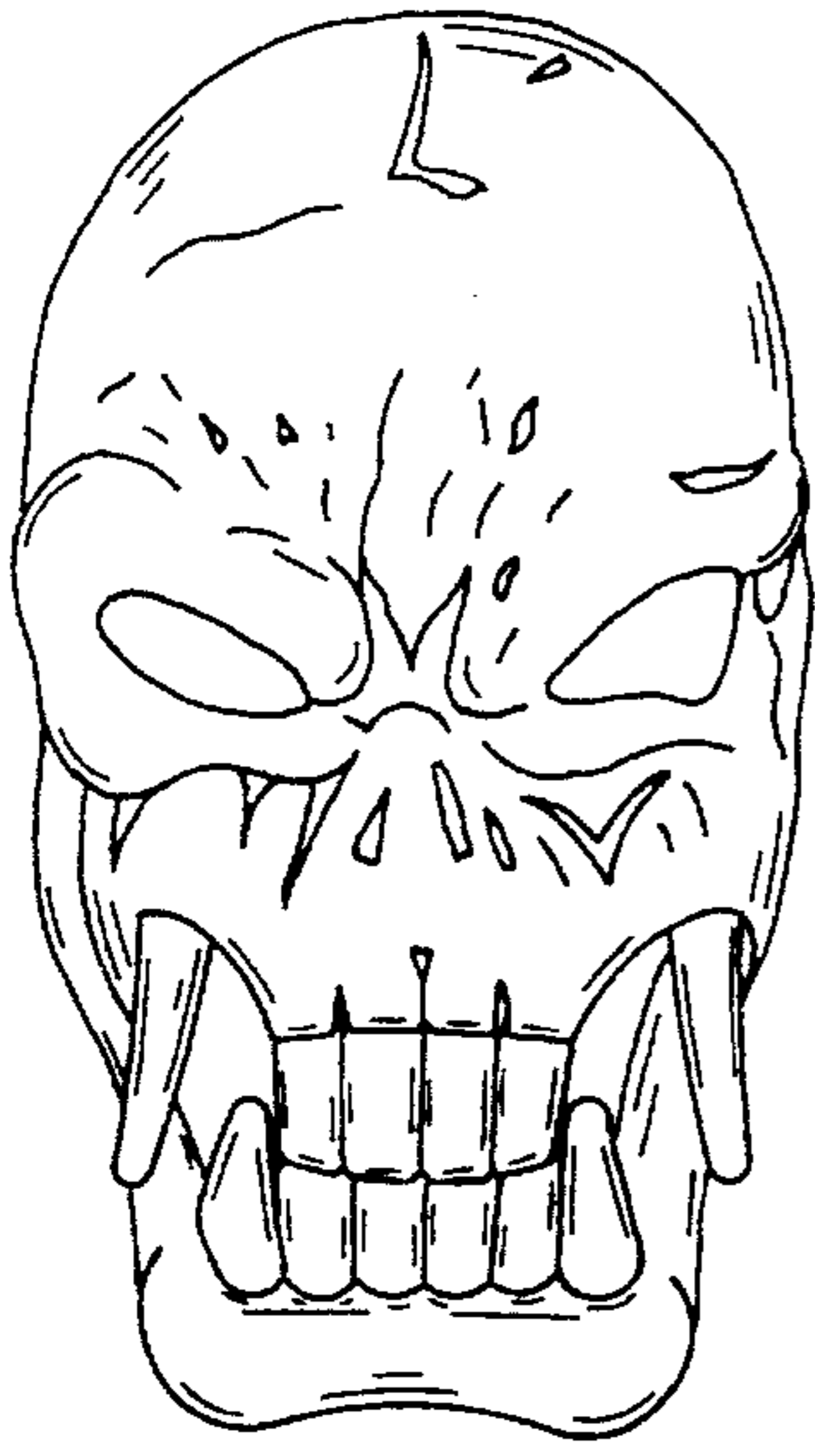

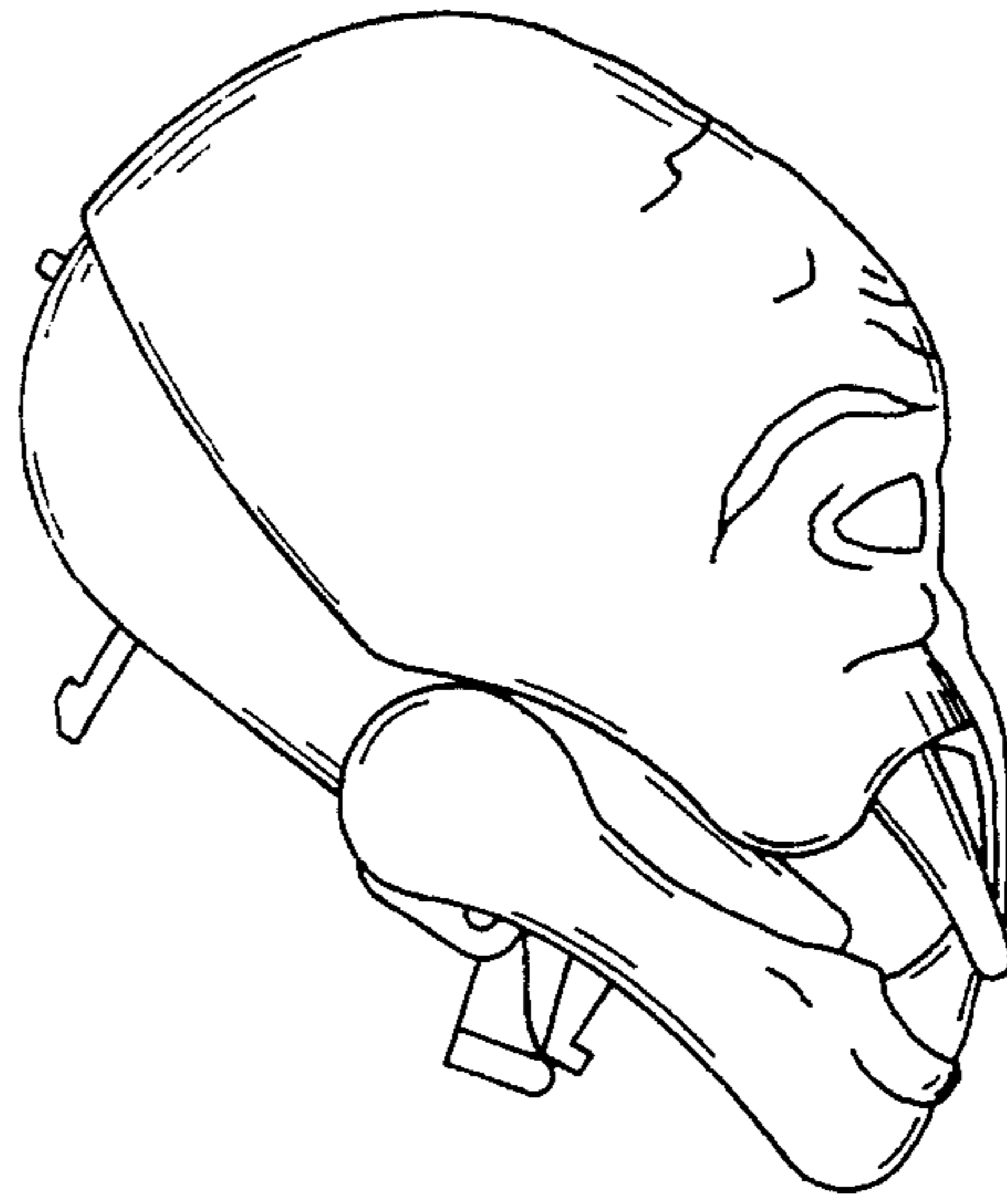

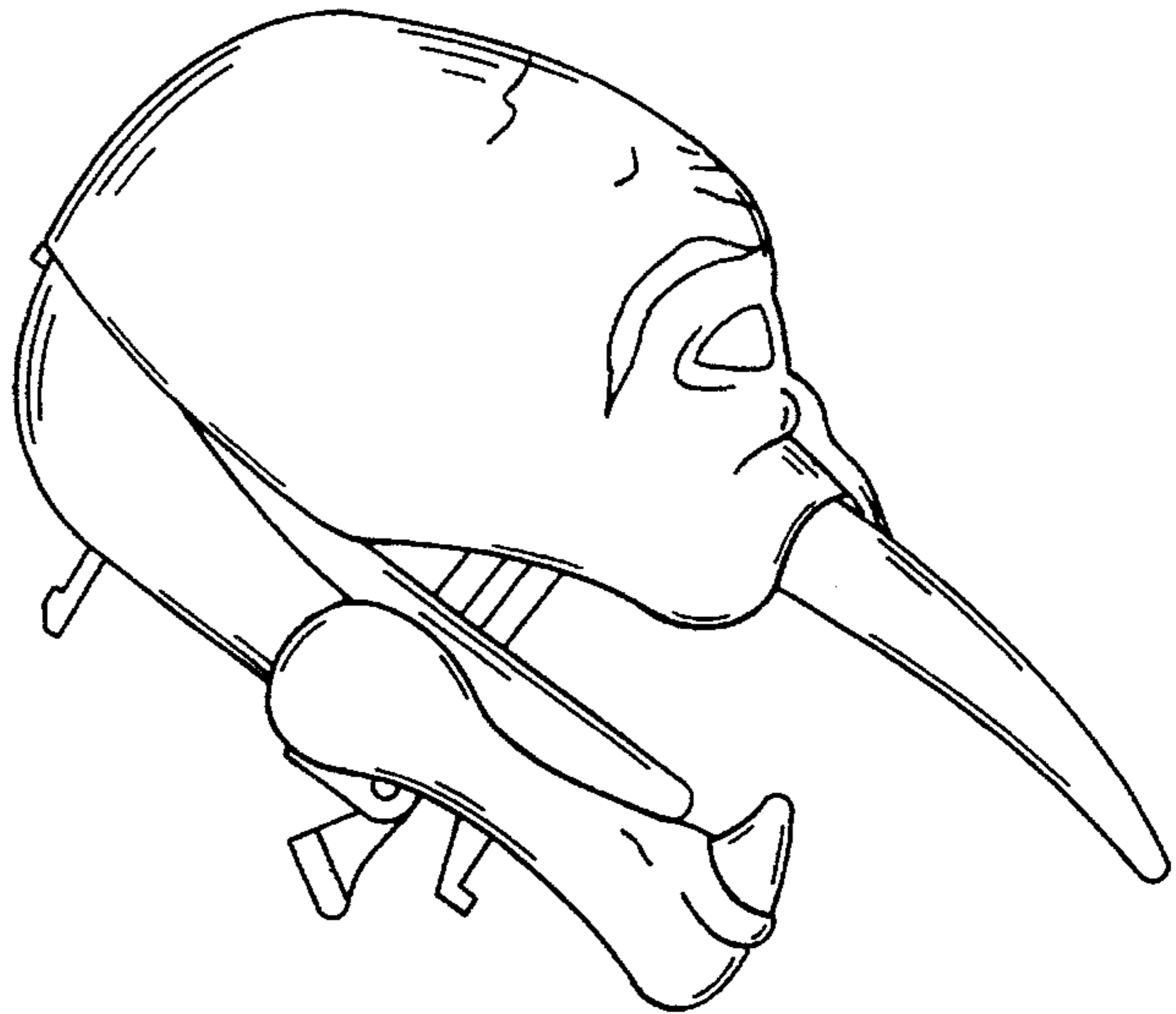
