[57] **CLAIM**

The ornamental design for a shoulder strap bag, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a shoulder strap bag as worn on one shoulder, showing my new design;

FIG. 2 is a perspective thereof;

FIG. 3 is an elevational view thereof;

FIG. 4 is an elevational view thereof, looking from the left of FIG. 3;

FIG. 5 is an elevational view thereof, looking from the right of FIG. 3;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is an elevational view, showing the components of my new design in a longitudinal array;

FIG. 9 is an elevational view of the side opposite that of FIG. 8;

FIG. 10 is a perspective view of a second embodiment;

FIG. 11 is an elevational view of the modification of FIG. 10;

FIG. 12 is an elevational view from the left of FIG. 11;

FIG. 13 is an elevational view from the right of FIG. 11;

FIG. 14 is a top plan view of the embodiment of FIG. 10;

FIG. 15 is a bottom plan view of the embodiment of FIG. 10;

FIG. 16 is an elevational view, showing the components of the modification of my new design in a longitudinal array; and,

FIG. 17 is an elevational view of the side opposite that of FIG. 16.

The broken-line illustration of the drawings is not part of the design sought to be patented. The invention is characterized by a wide, tapered shoulder strap for support of a plurality of containers.



































