### [57] CLAIM

The ornamental design for an LCD projector, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of the top, front and right side of an LCD projector showing our new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a right side elevational view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a rear elevational view thereof;  
FIG. 6 is a bottom plan view thereof;  
FIG. 7 is a top plan view thereof; and,  
FIG. 8 is a top plan view thereof, the controller shown separately for clarity of illustration.

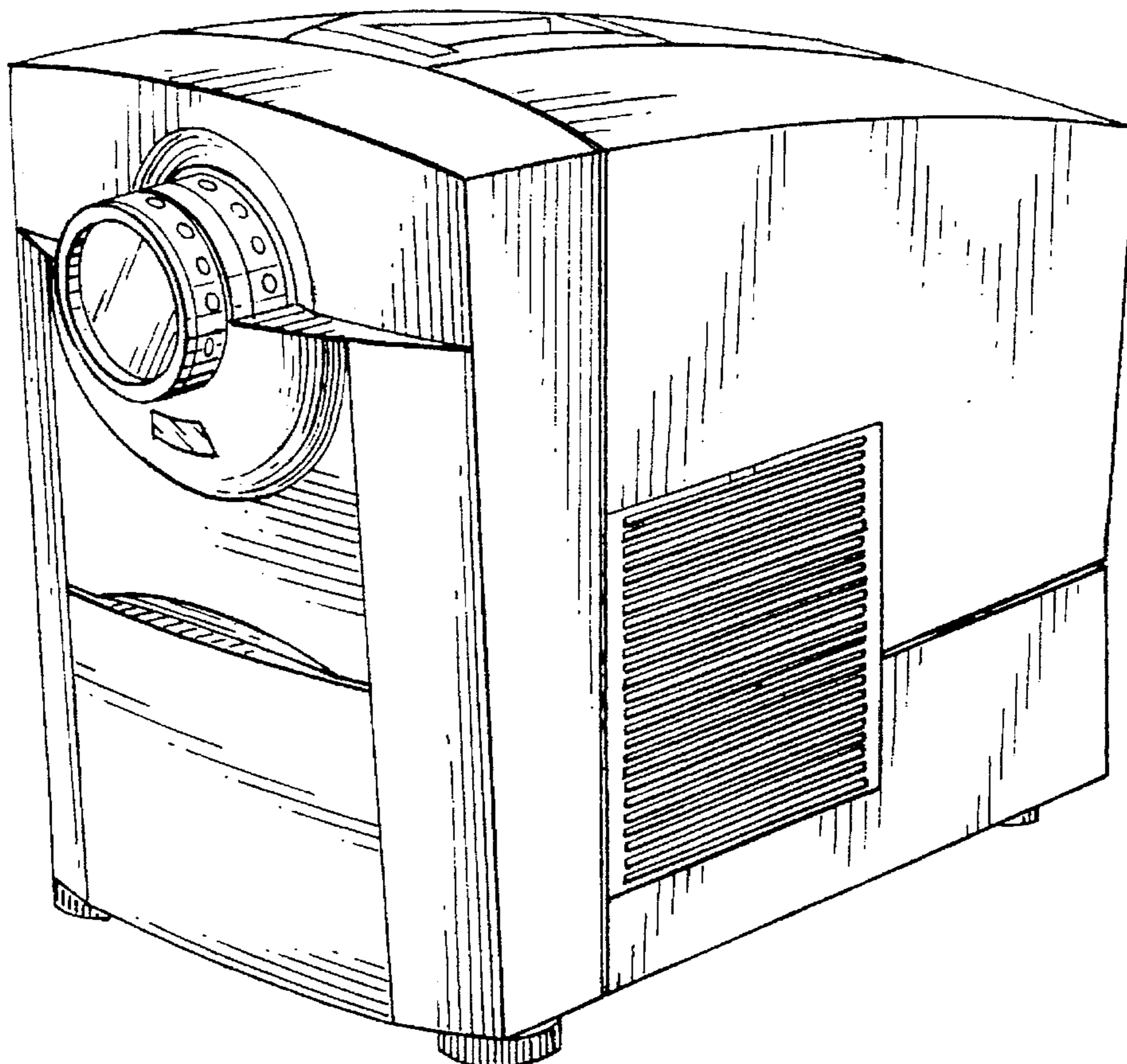

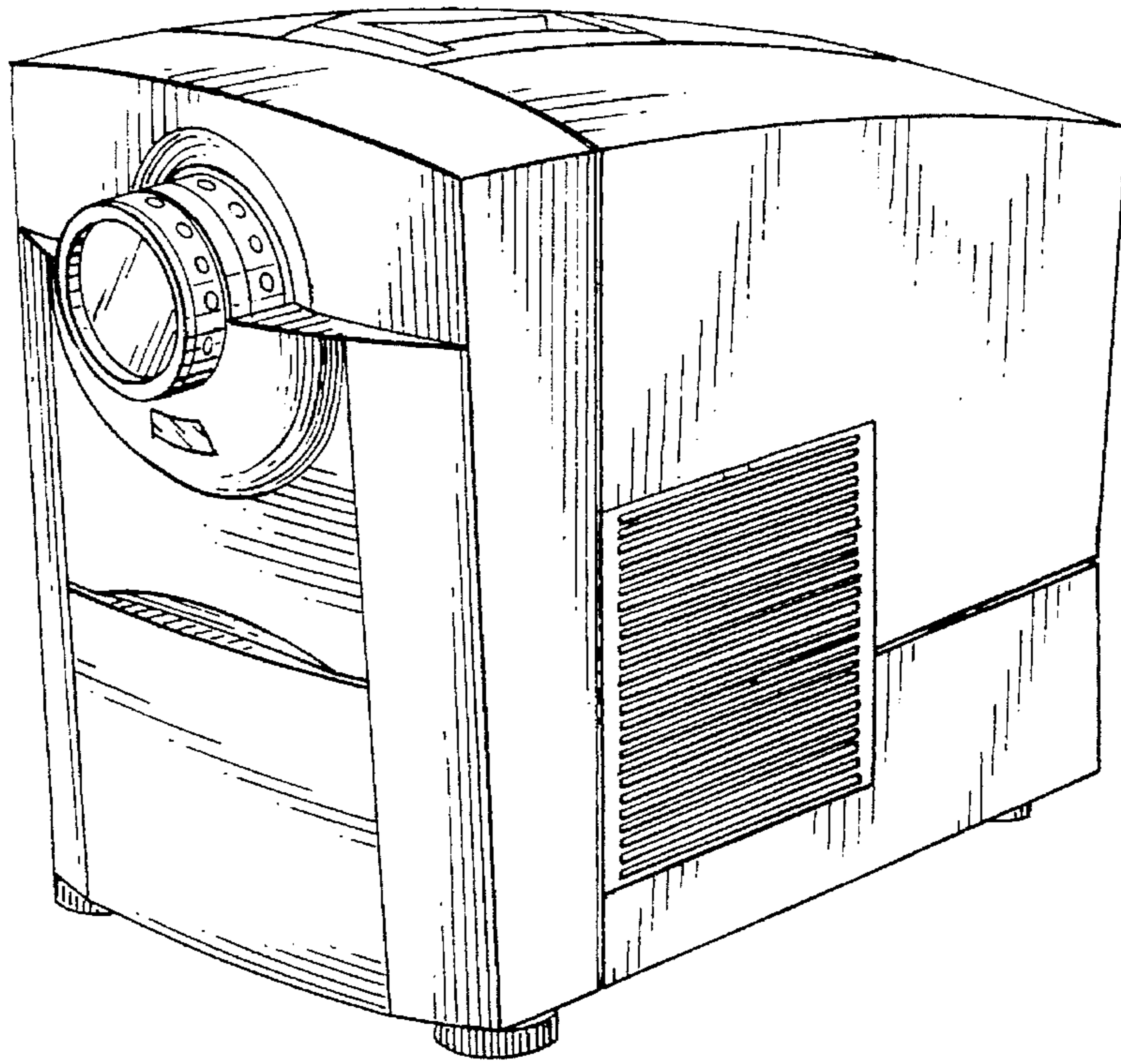

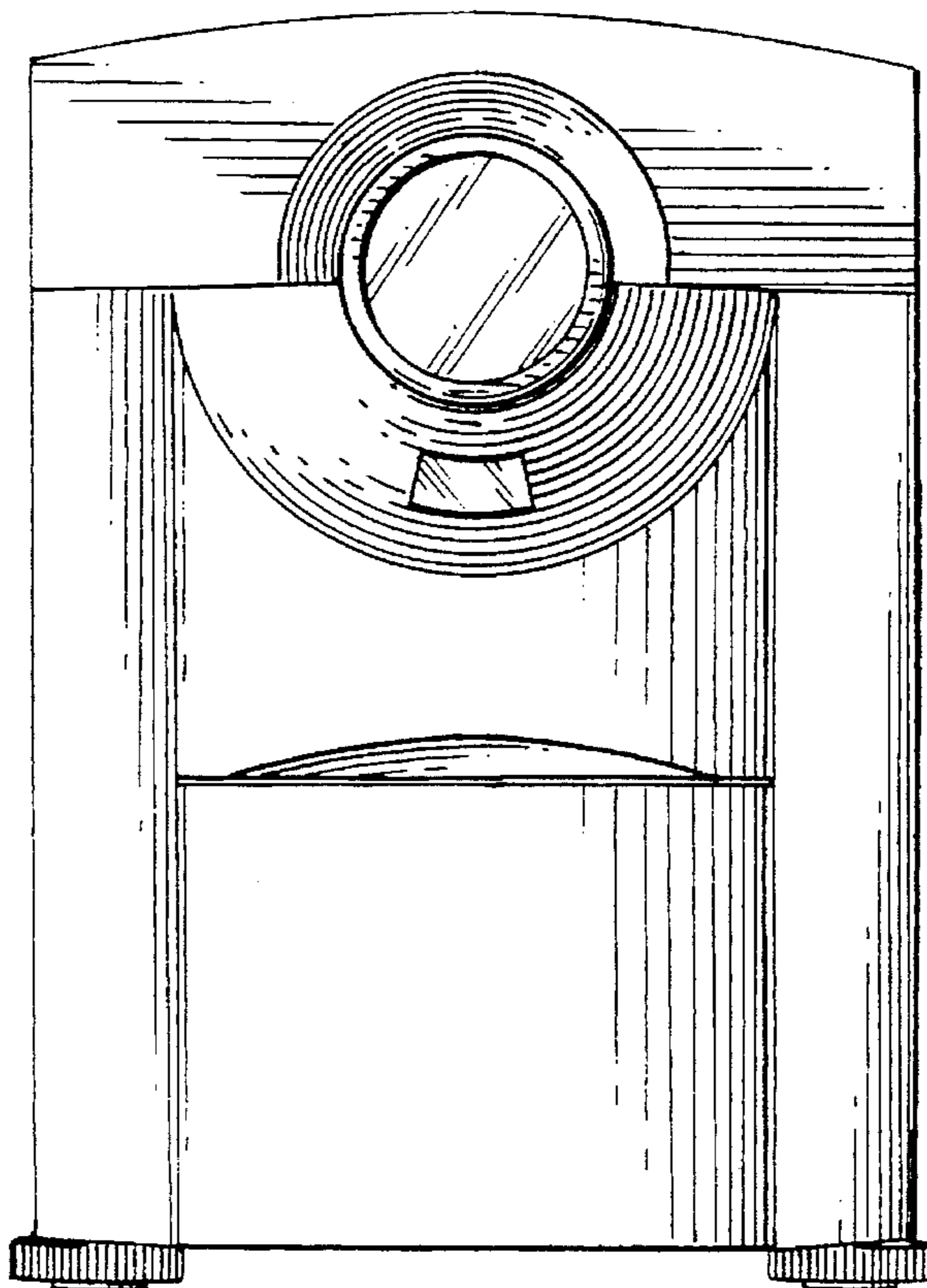

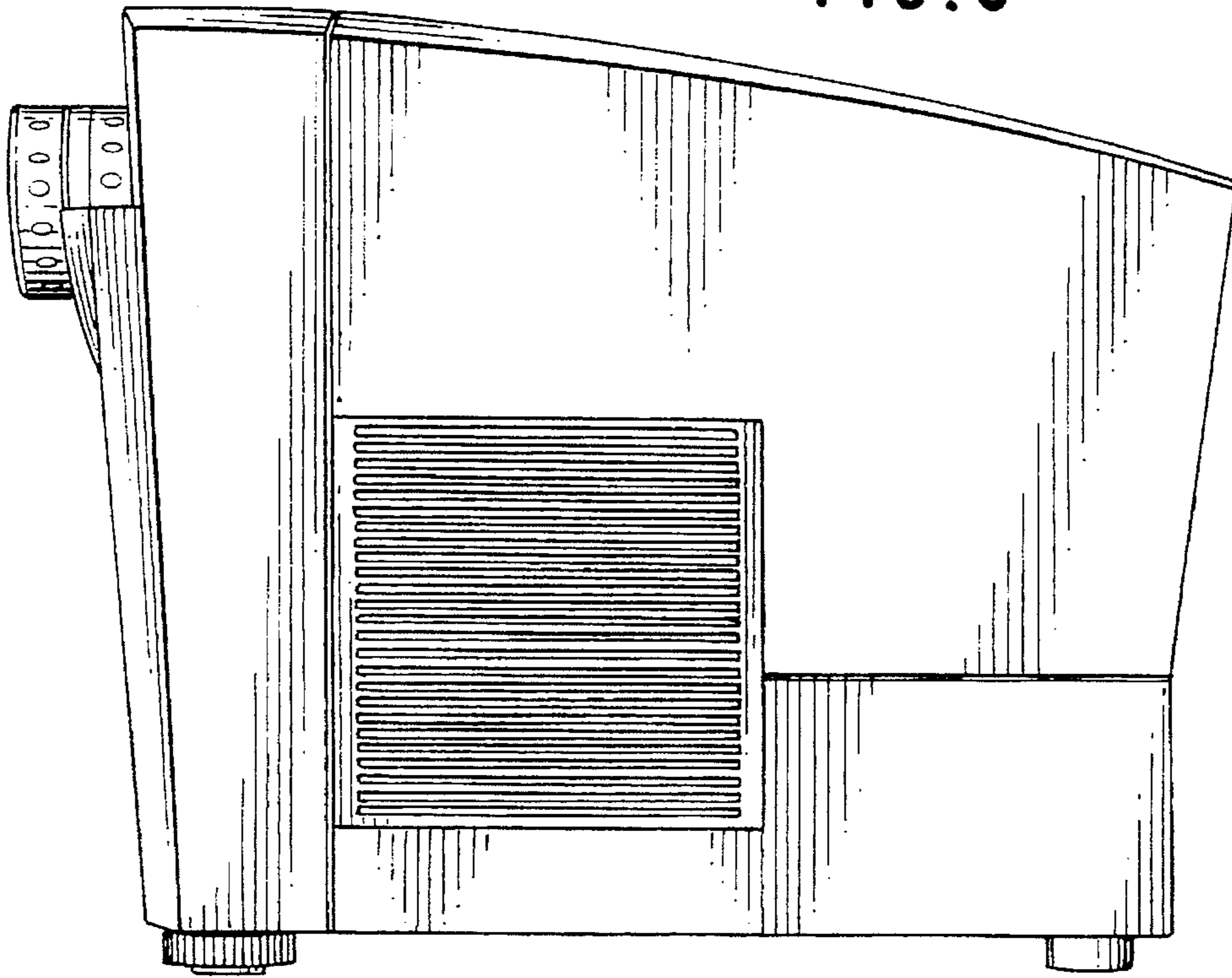

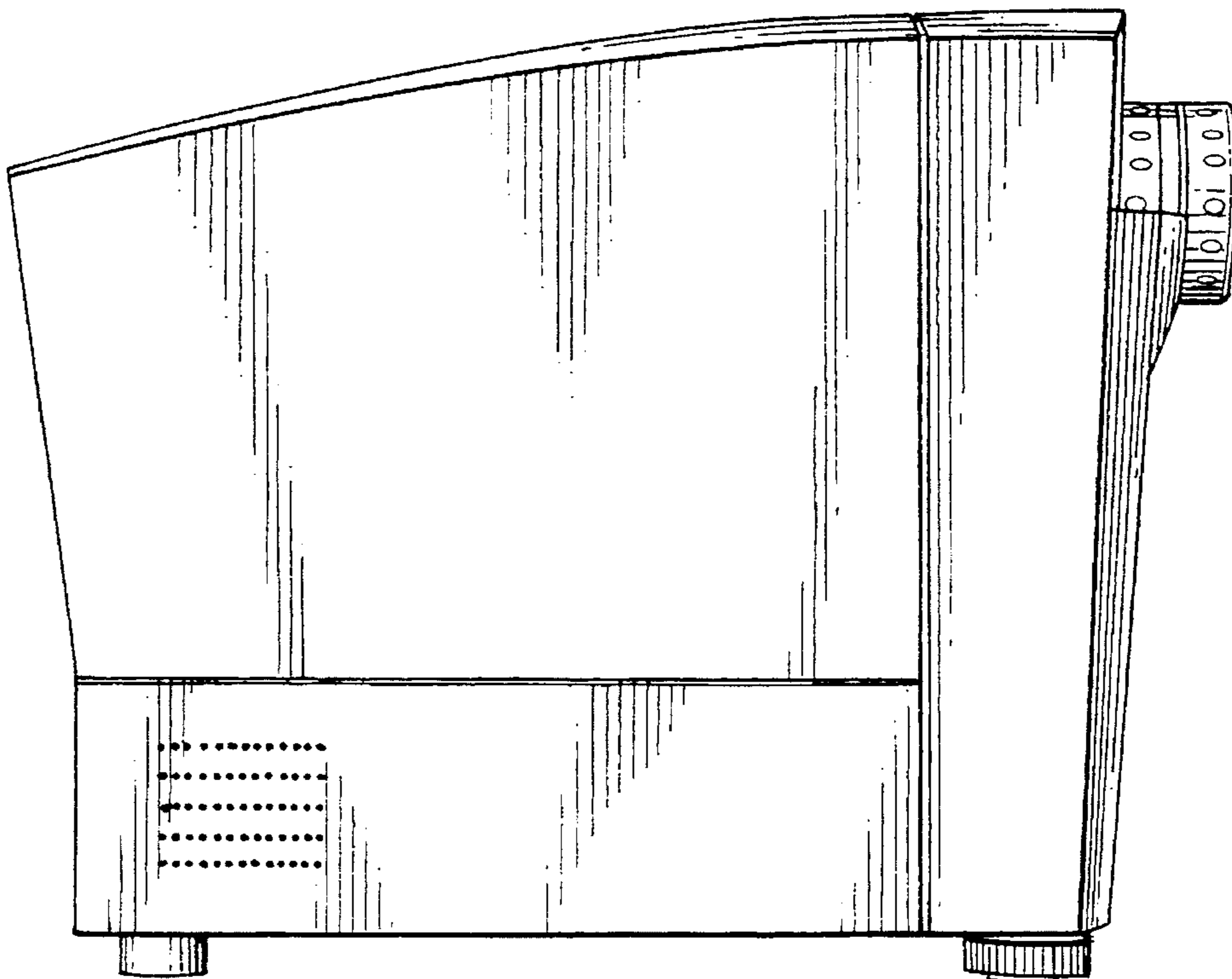

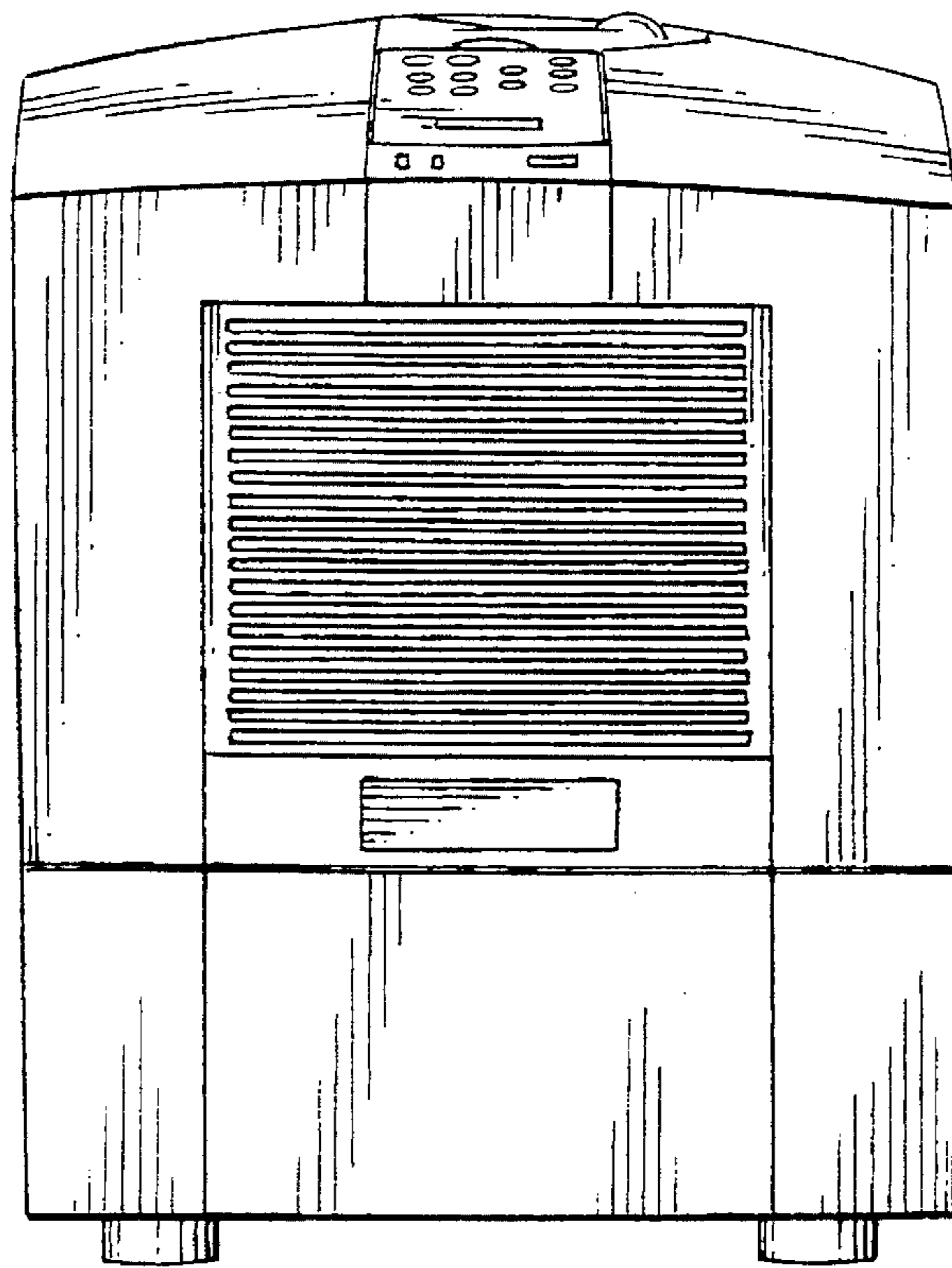
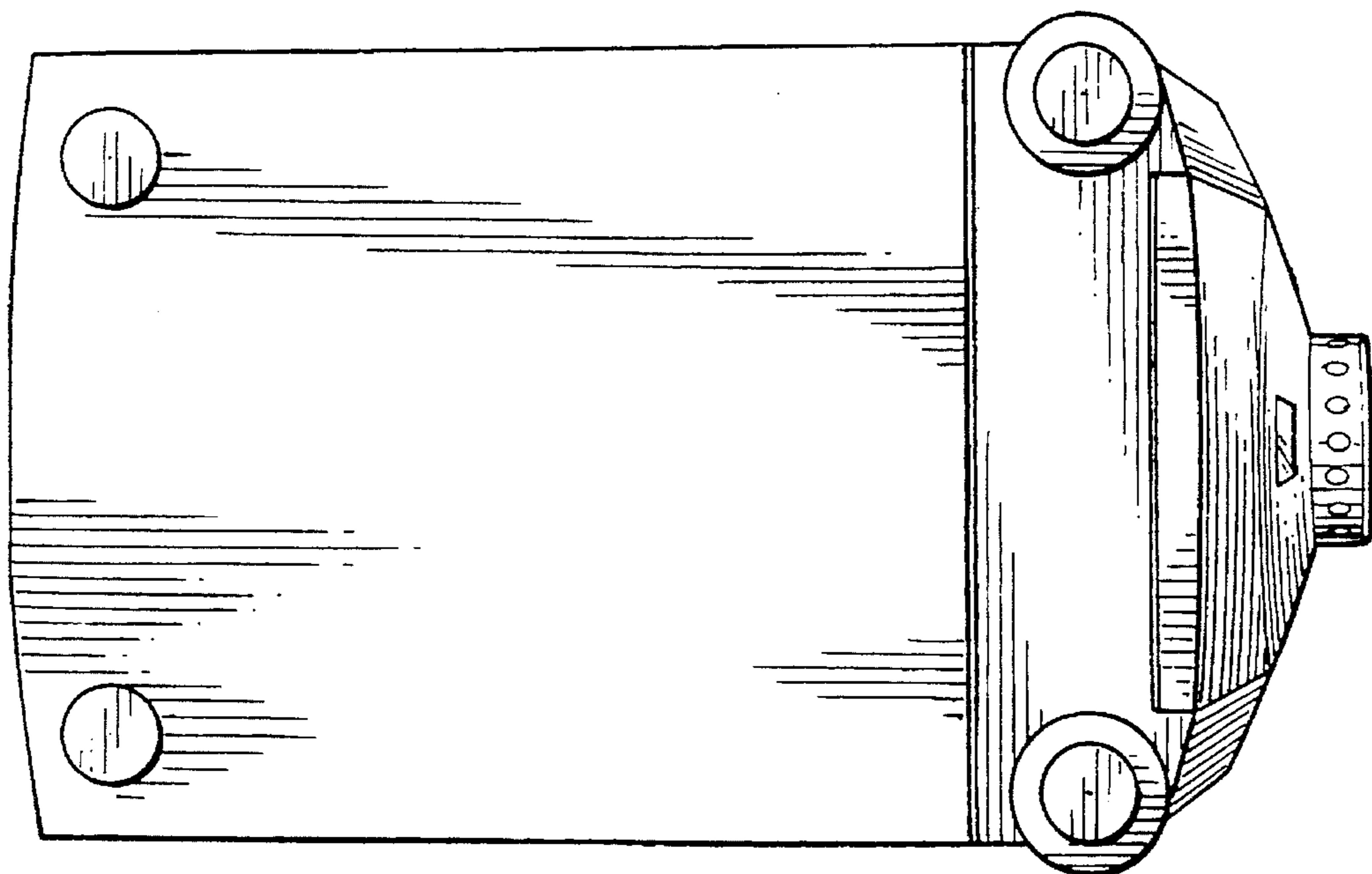

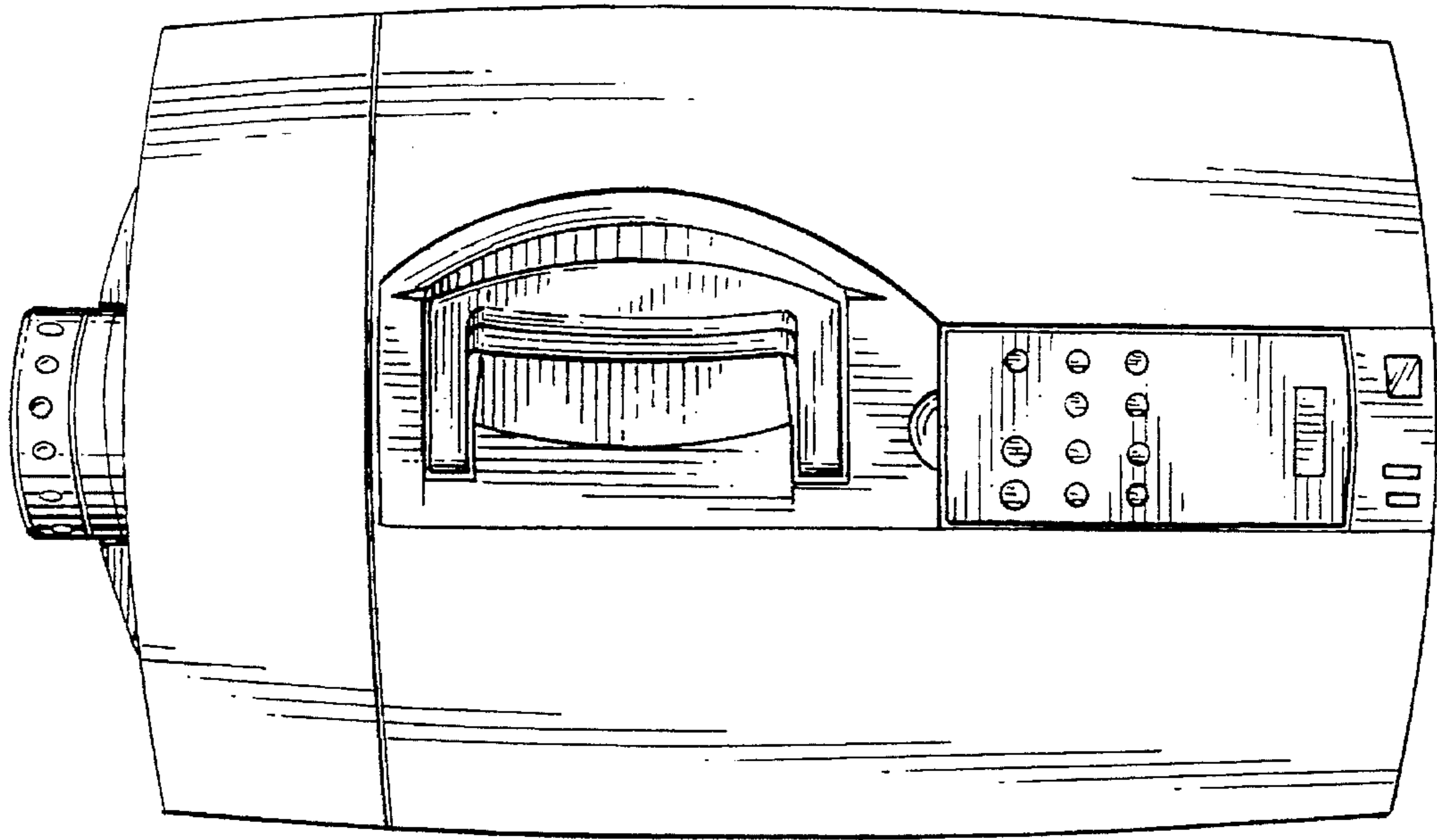

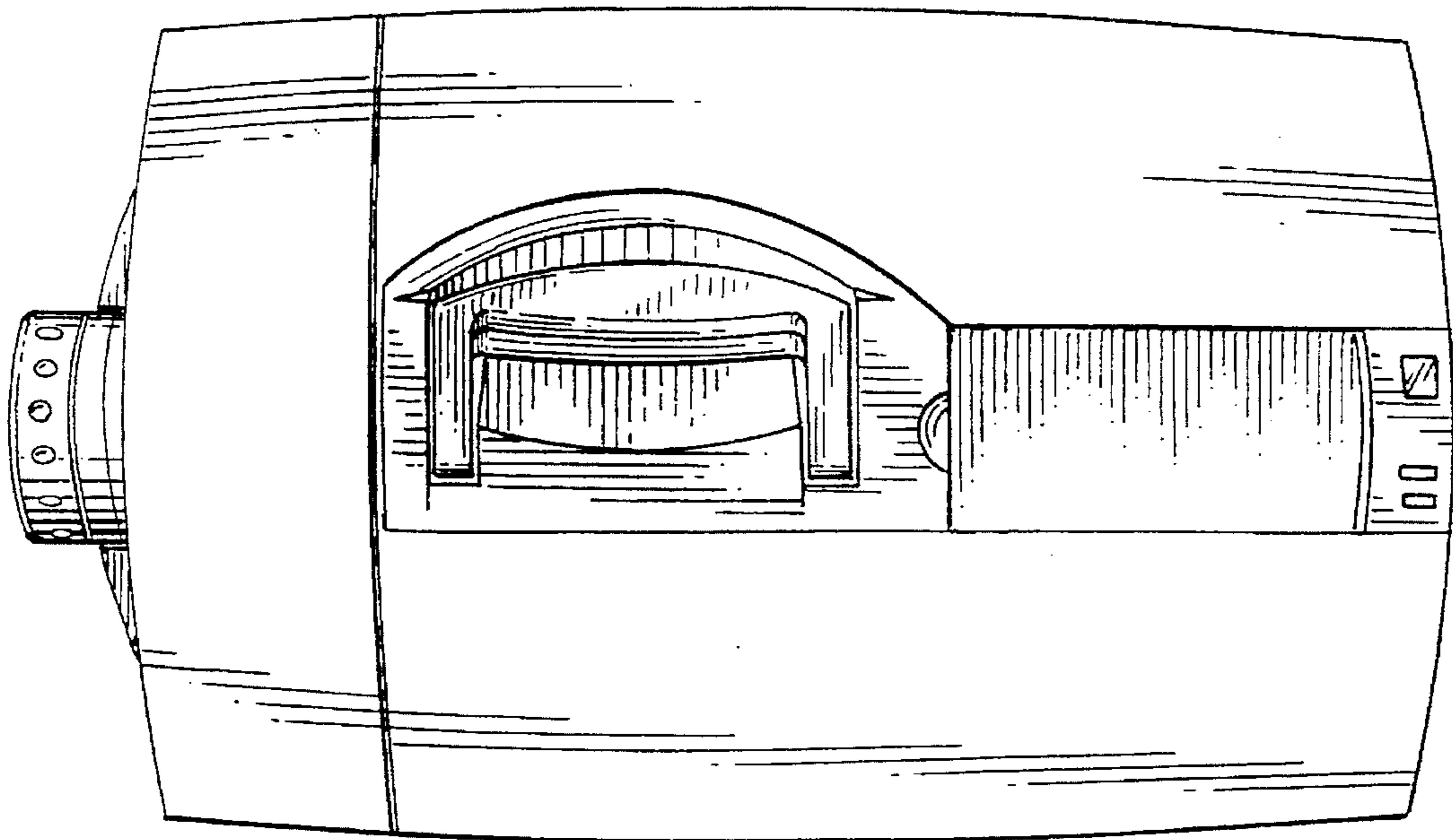
