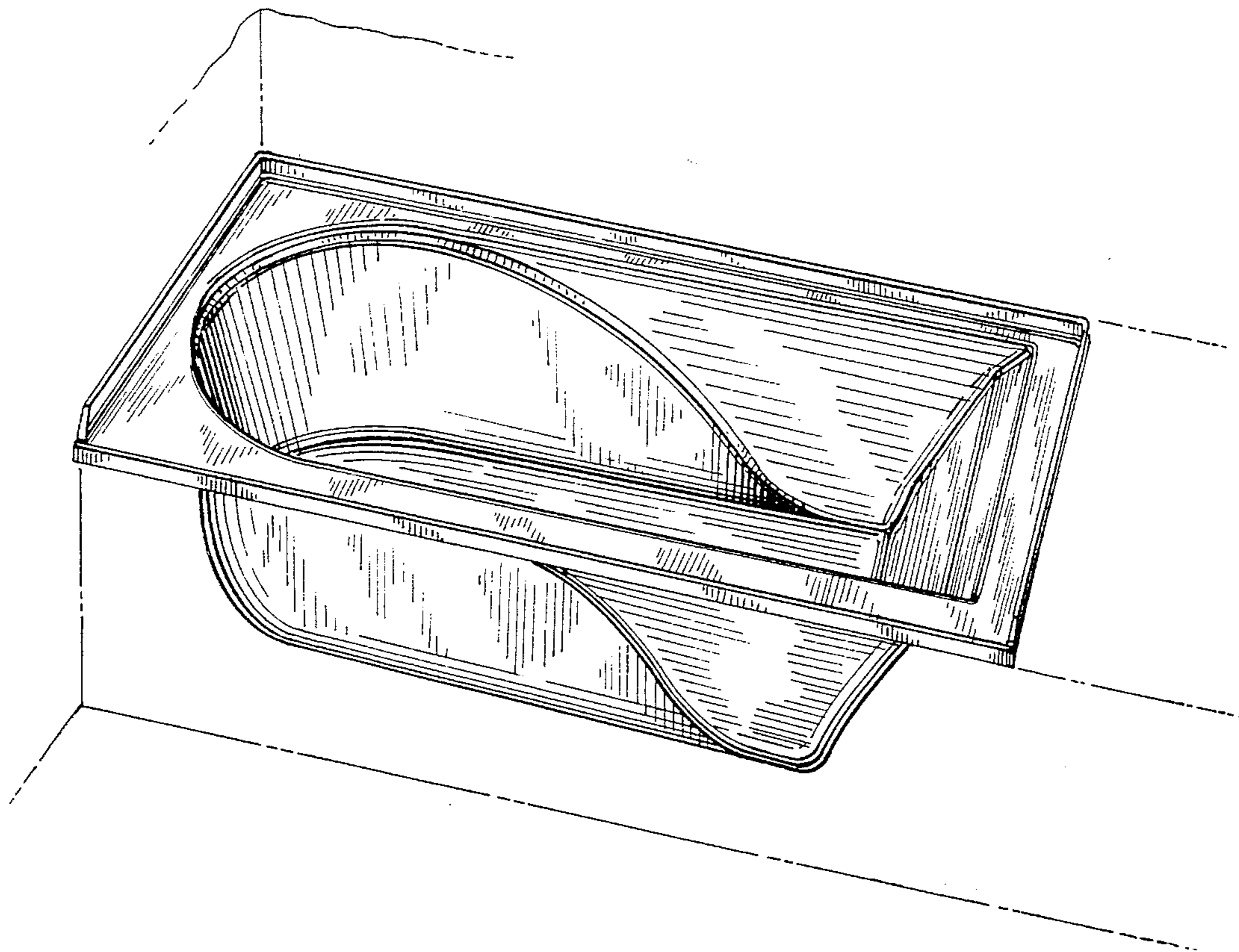
[57] **CLAIM**

The ornamental design for a tub for bathing, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from the top, front and right side of a tub for bathing showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a cross-sectional view taken on line 7—7 of FIG. 2; FIG. 8 is a cross-sectional view taken on line 8—8 of FIG. 2; and, FIG. 9 is a top plan view of a second embodiment, which is a mirror image of the first, the front elevational view being the mirror image of FIG. 3, the left side elevational view being the mirror image of FIG. 4, and the right side elevational view being the mirror image of FIG. 5; The fragmentary broken line representations of walls in FIG. 1 are for the purpose of illustration only and form no part of the claimed design.

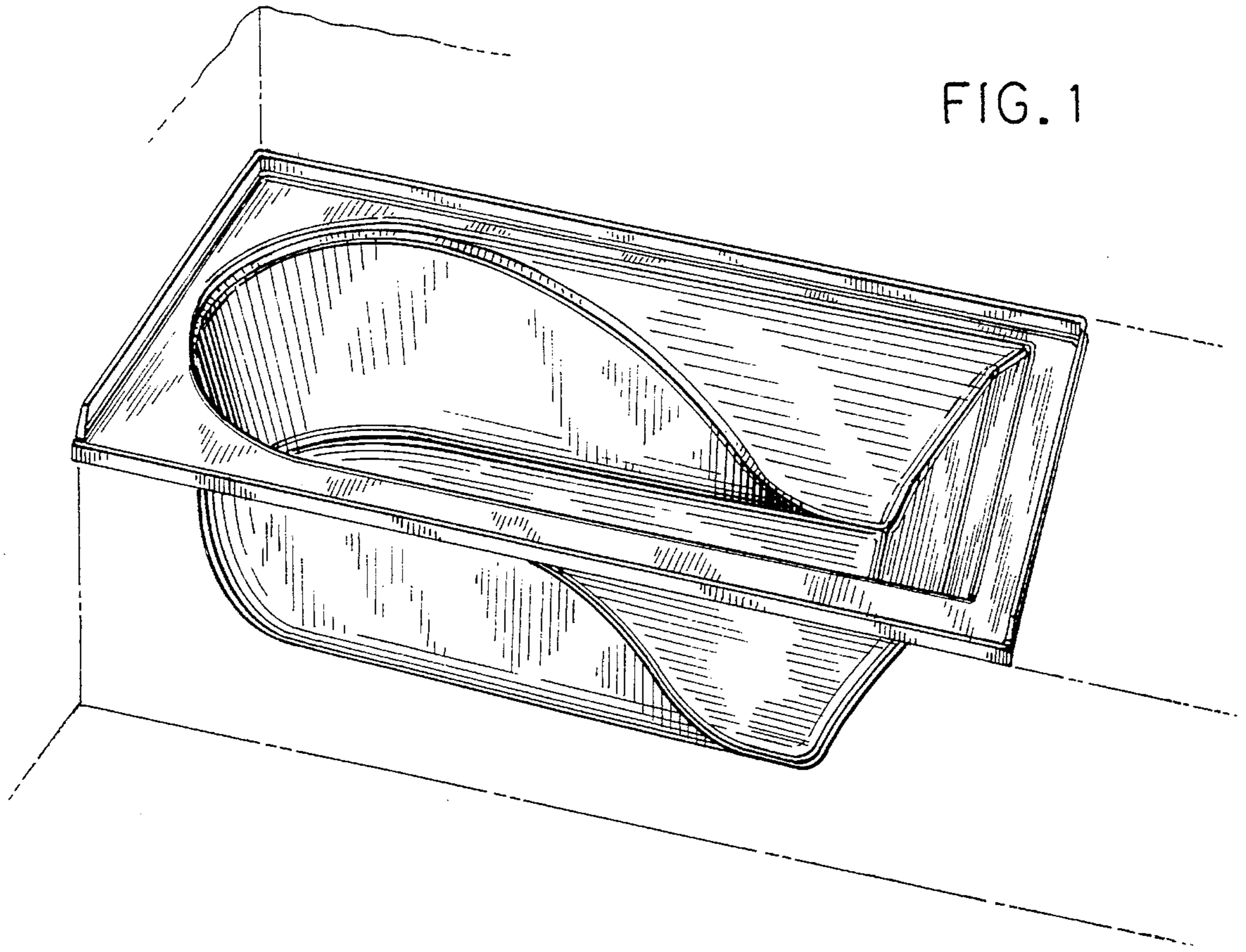

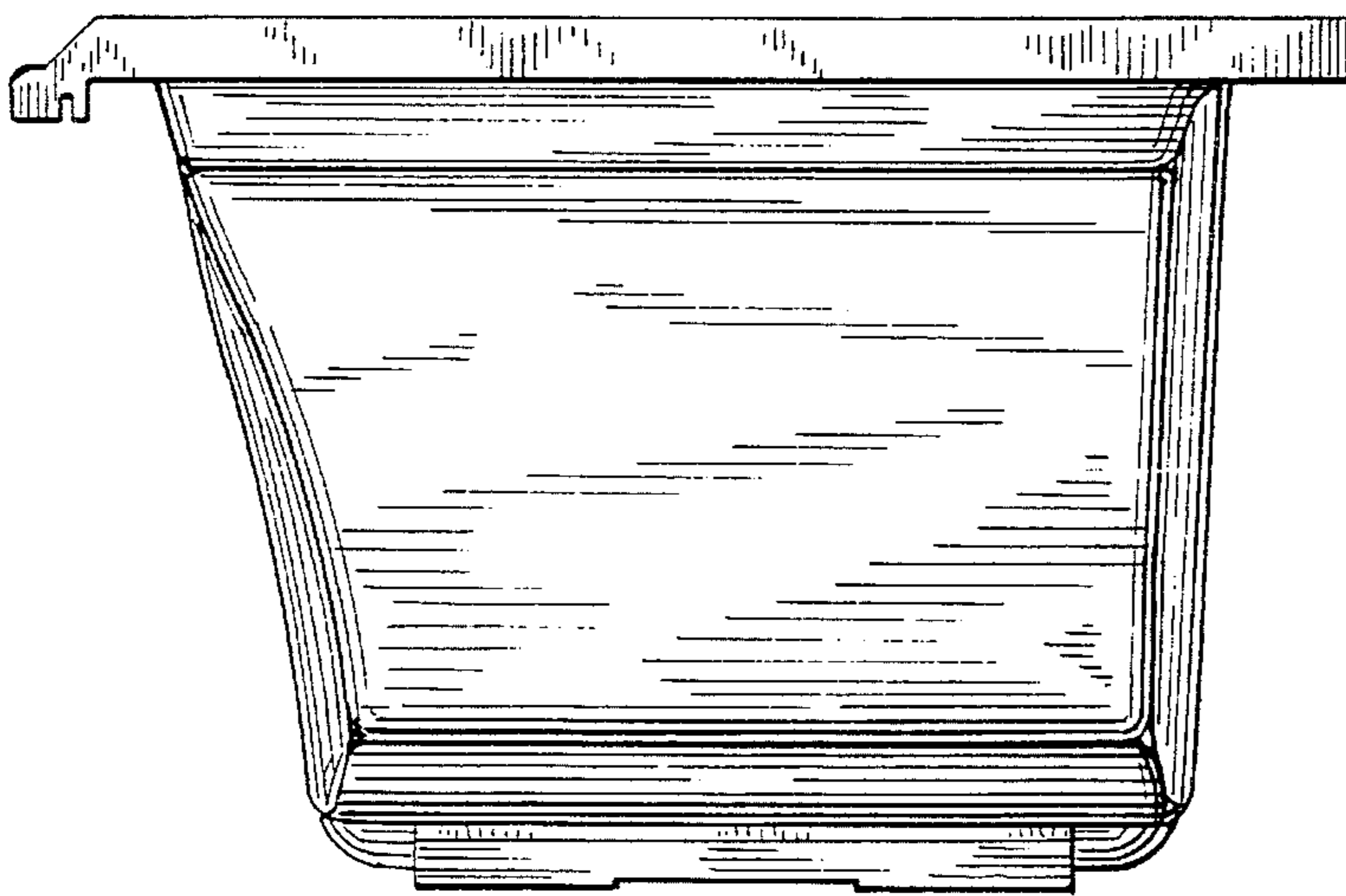

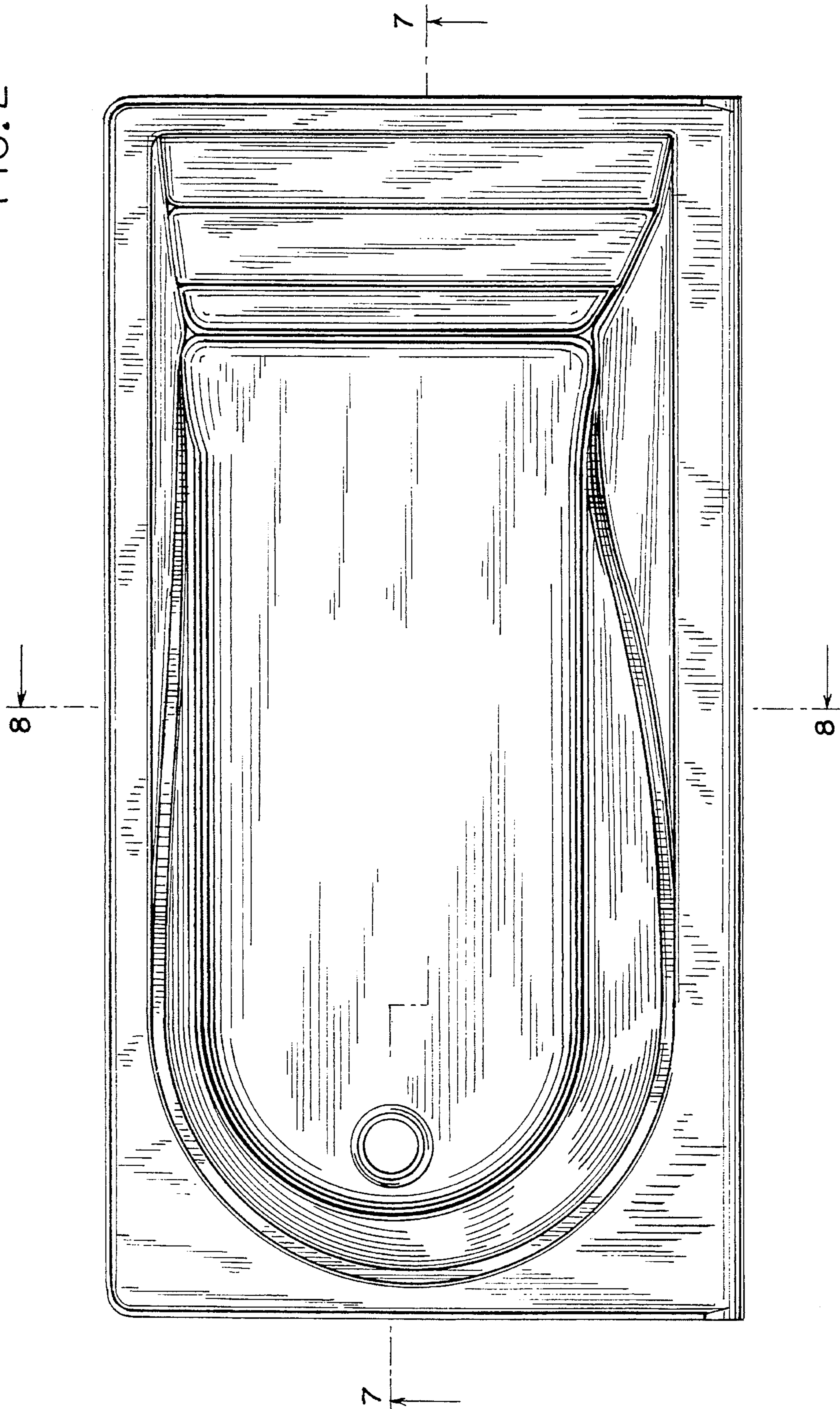

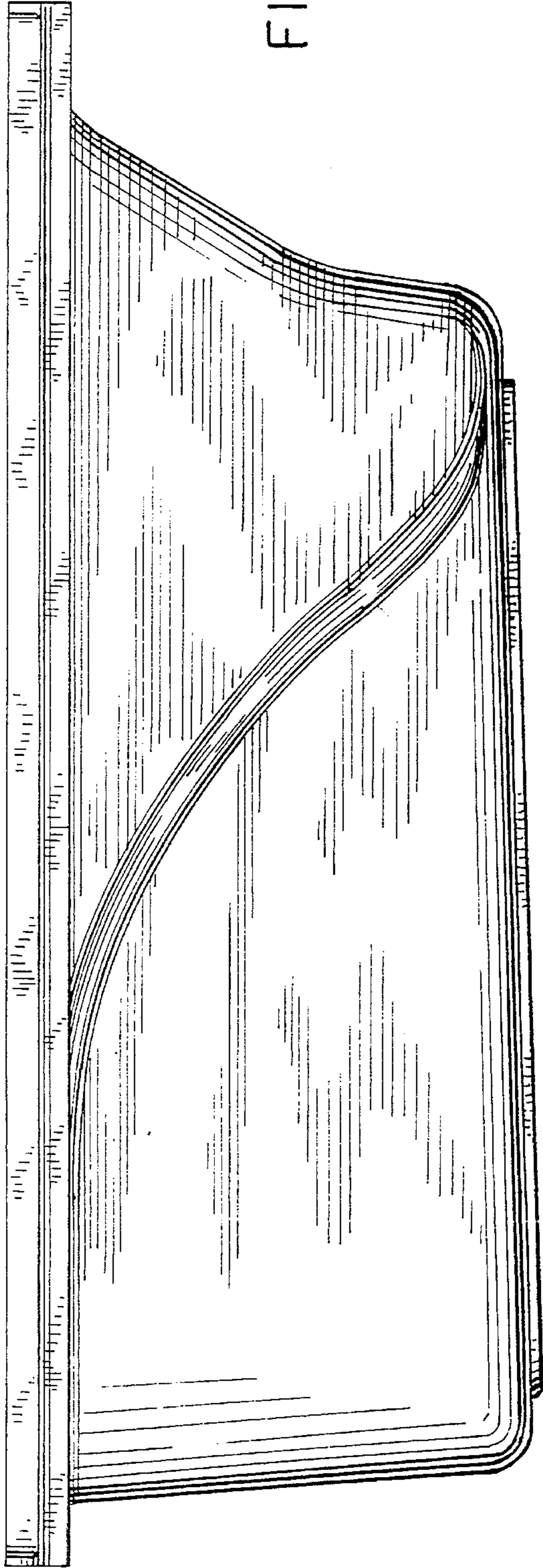
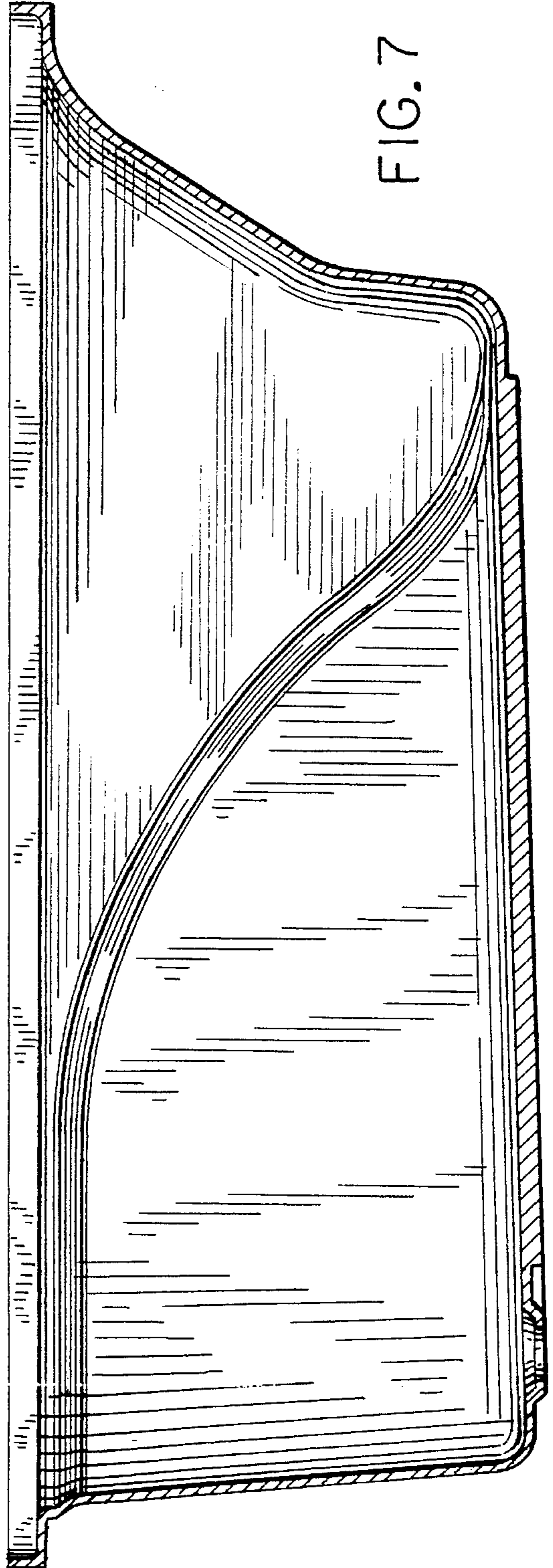

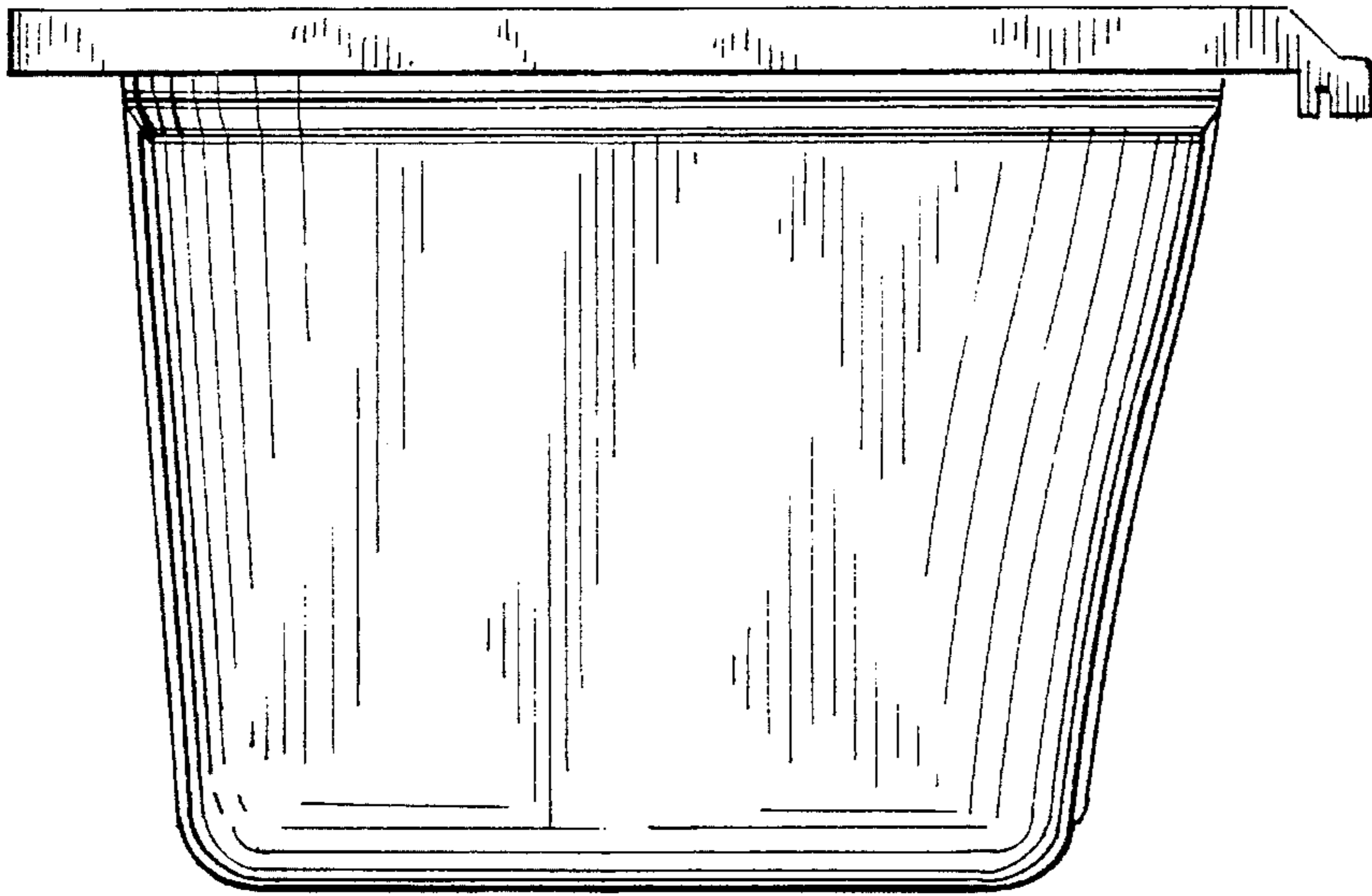

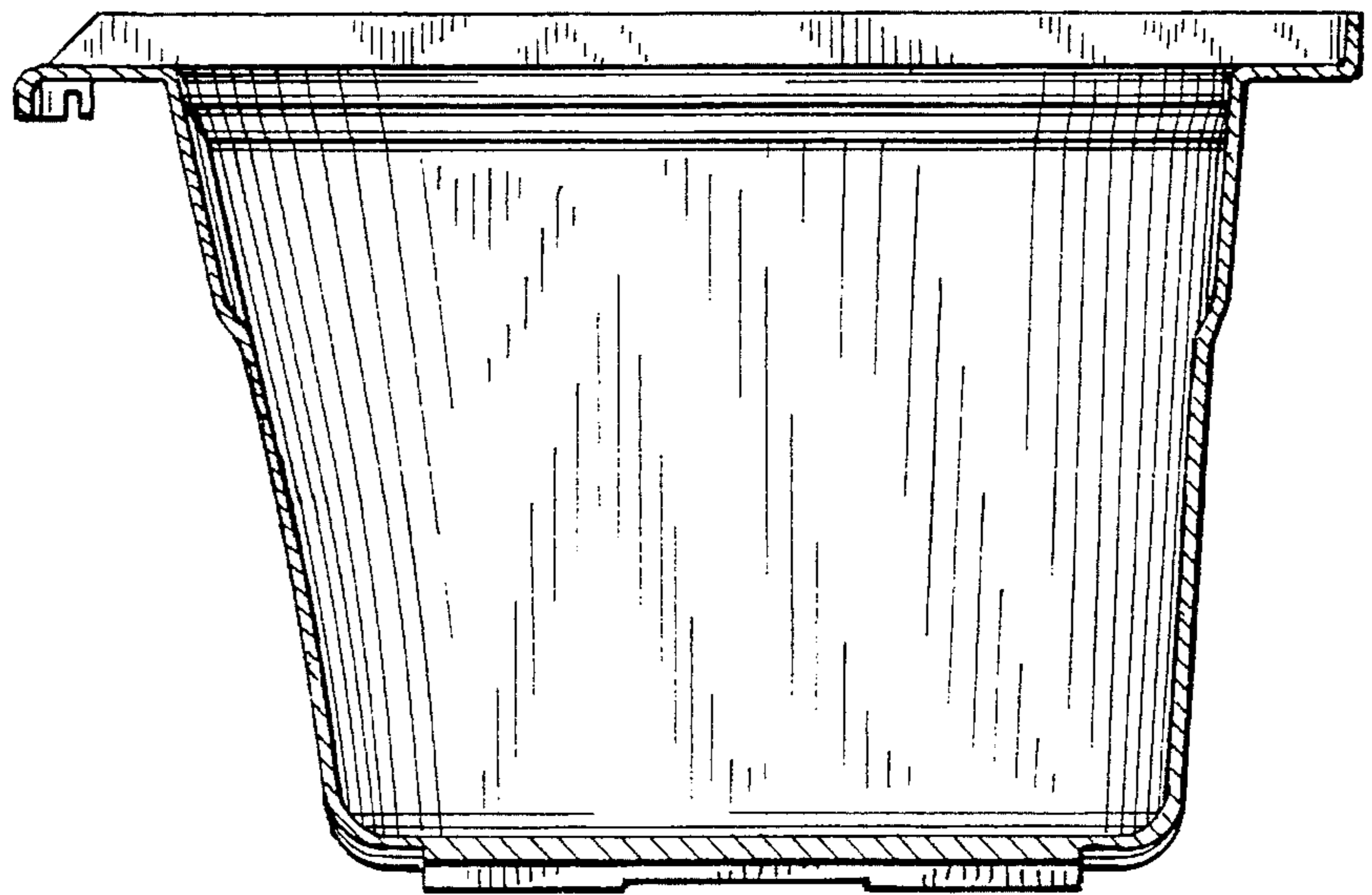

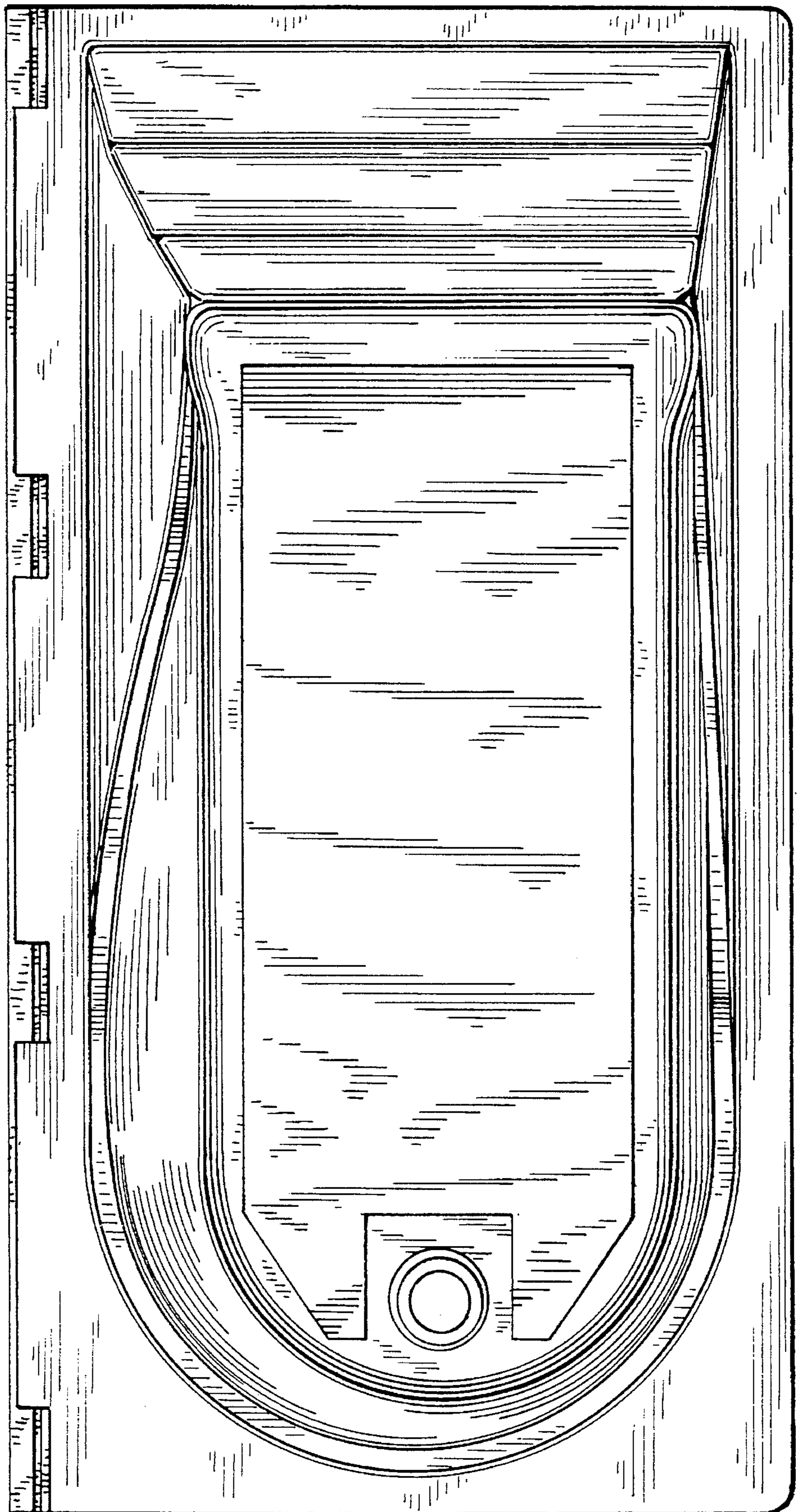
