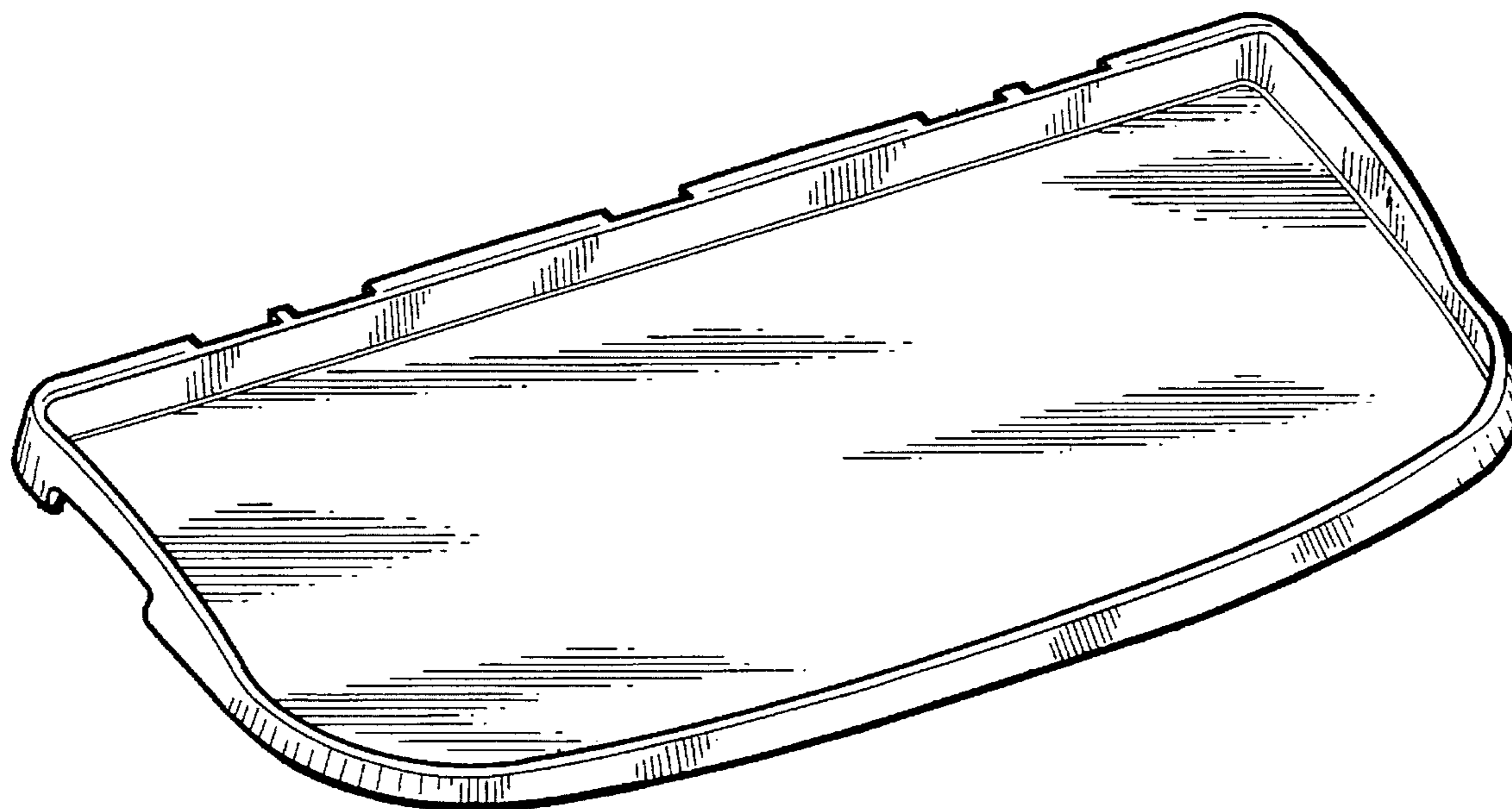
FIG. 1 is a top, front and end perspective view of a pet feeder tray showing our new design;

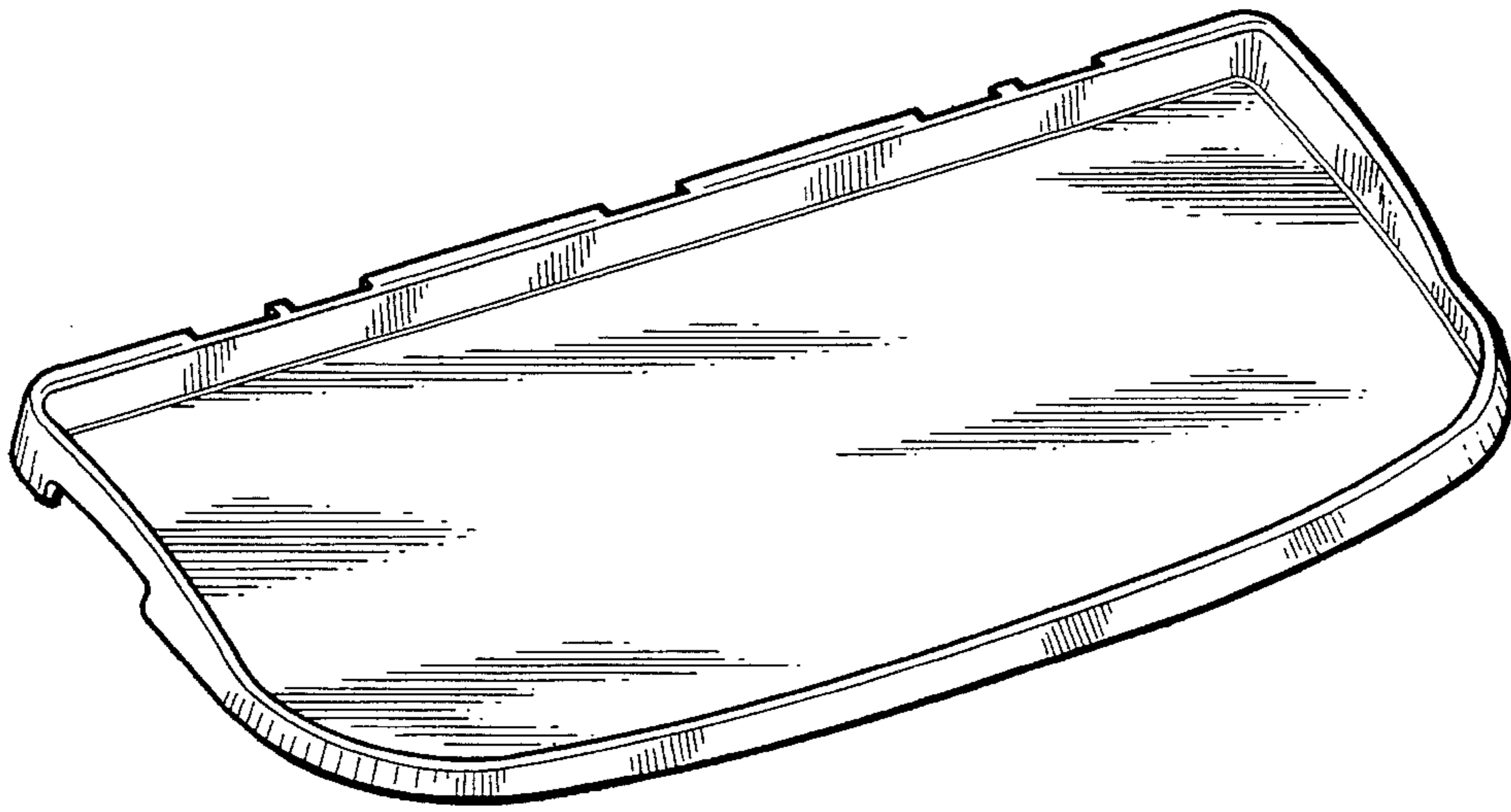

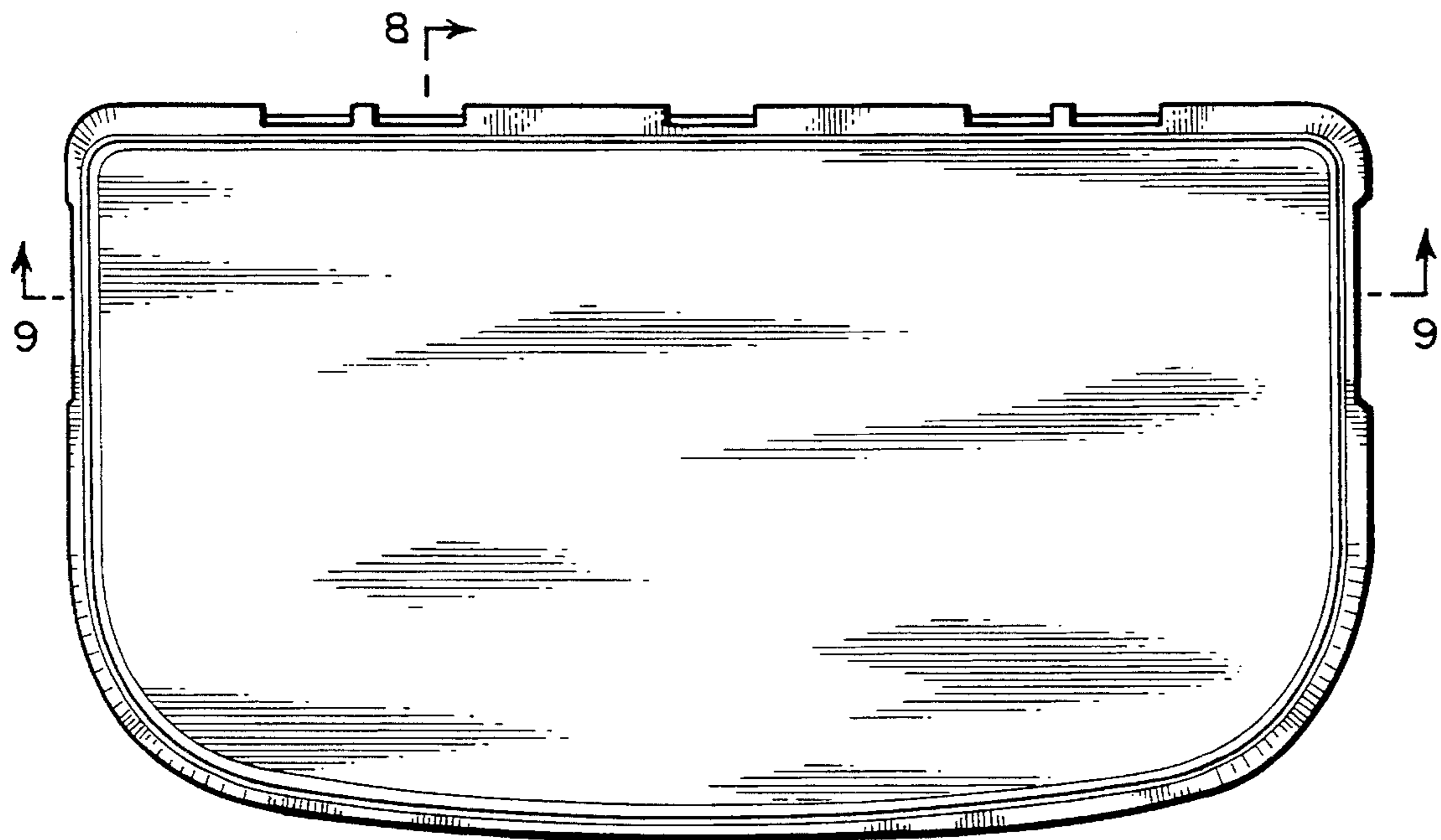

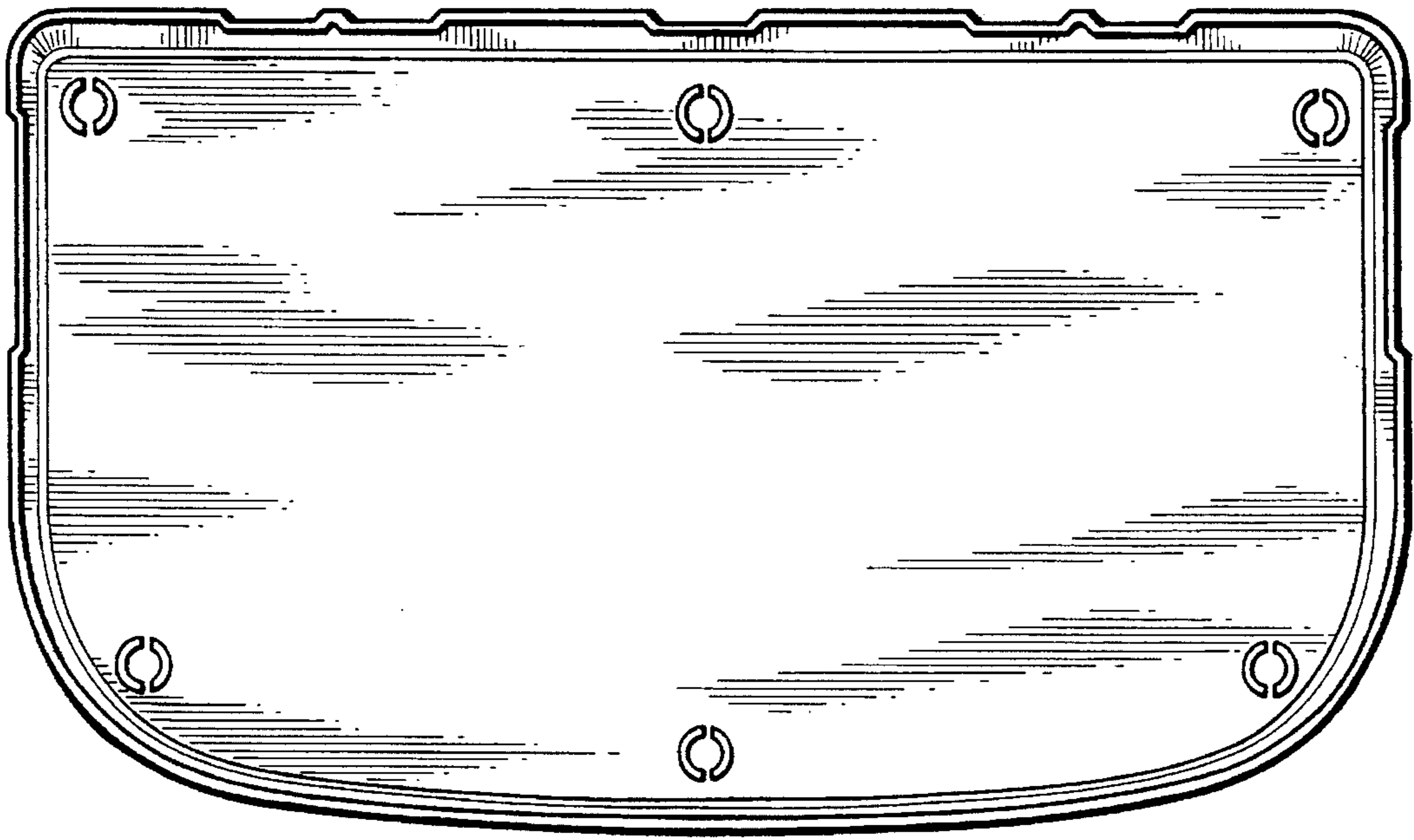

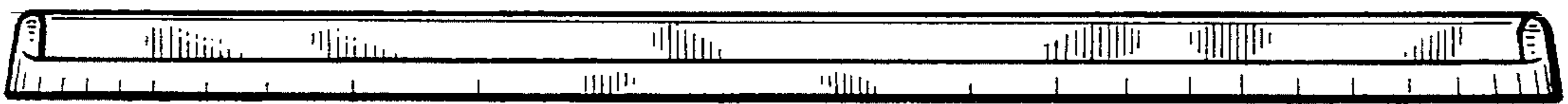

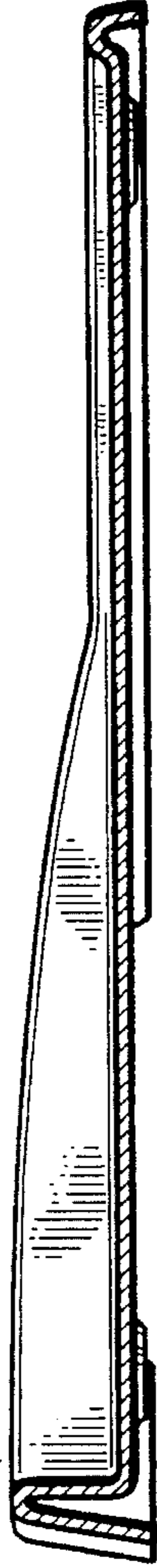

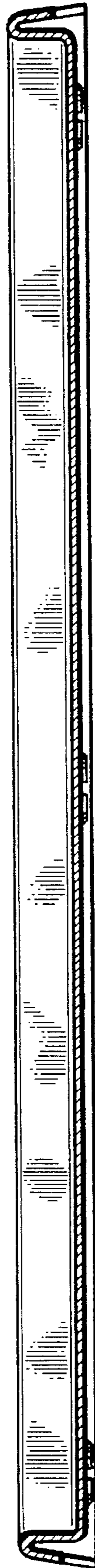
