[57] **CLAIM**

The ornamental design for a combined lid and package for contact lenses, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a combined lid and package for contact lenses showing our new design, the lid being removed;
FIG. 2 is a bottom perspective view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a left side elevational view thereof;
FIG. 7 is a front elevational view thereof;
FIG. 8 is a rear elevational view thereof;
FIG. 9 is a top perspective view thereof, the lid shown partially opened;
FIG. 10 is a top perspective view of FIG. 9, the lid shown in a fully closed position;
FIG. 11 is a sectional view taken along line XI—XI of FIG. 4; and,
FIG. 12 is a section view taken on line XII—XII of FIG. 4.

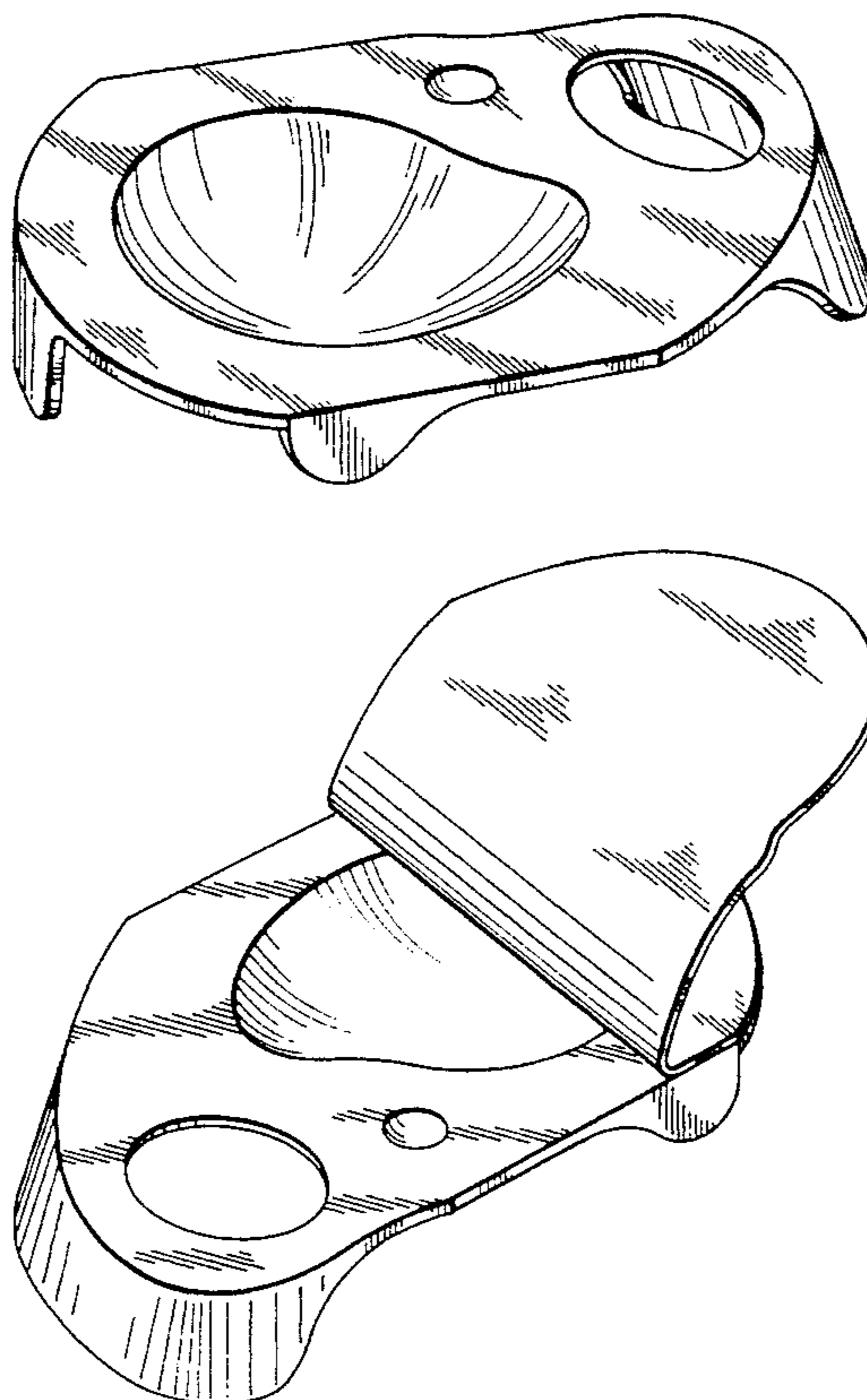

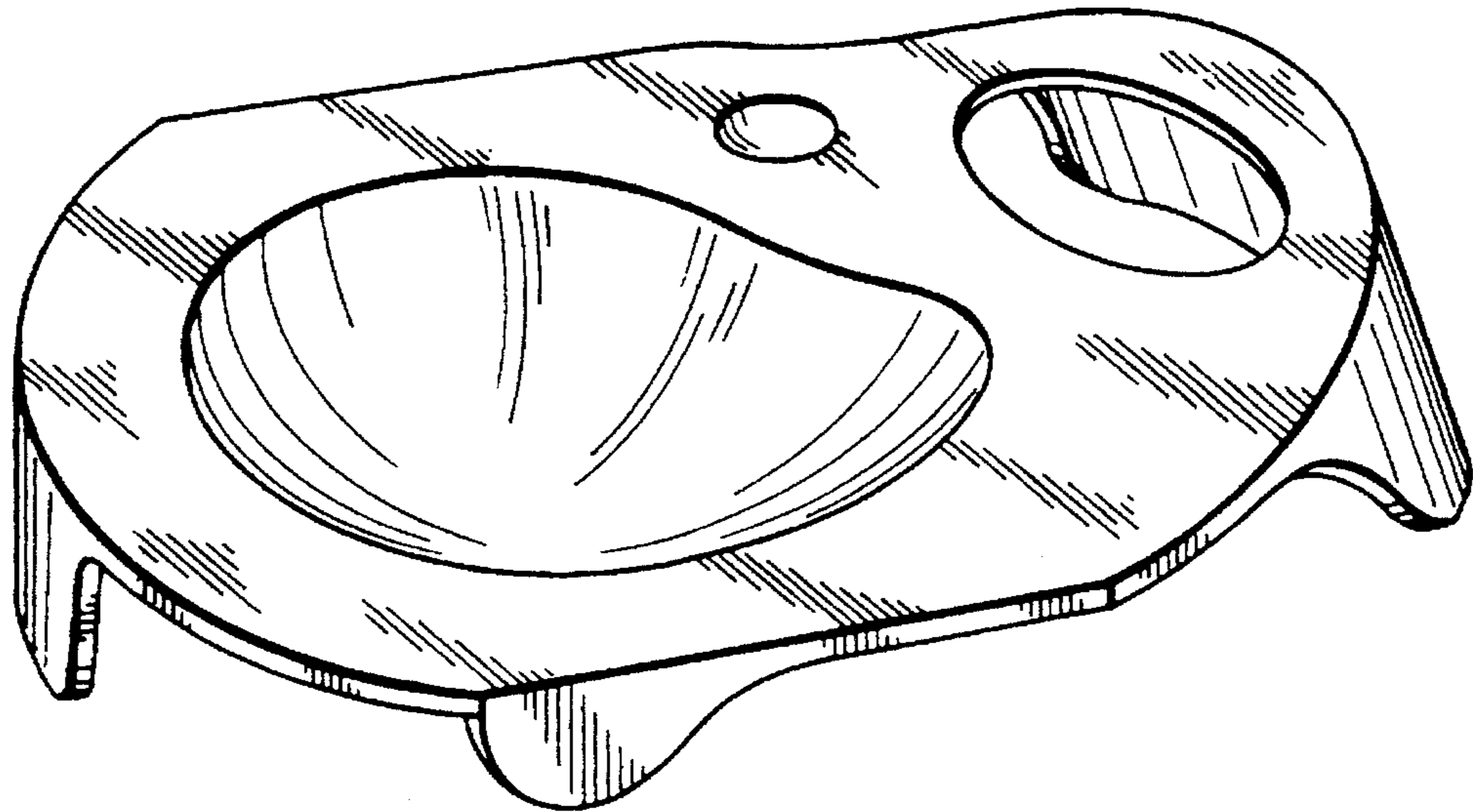

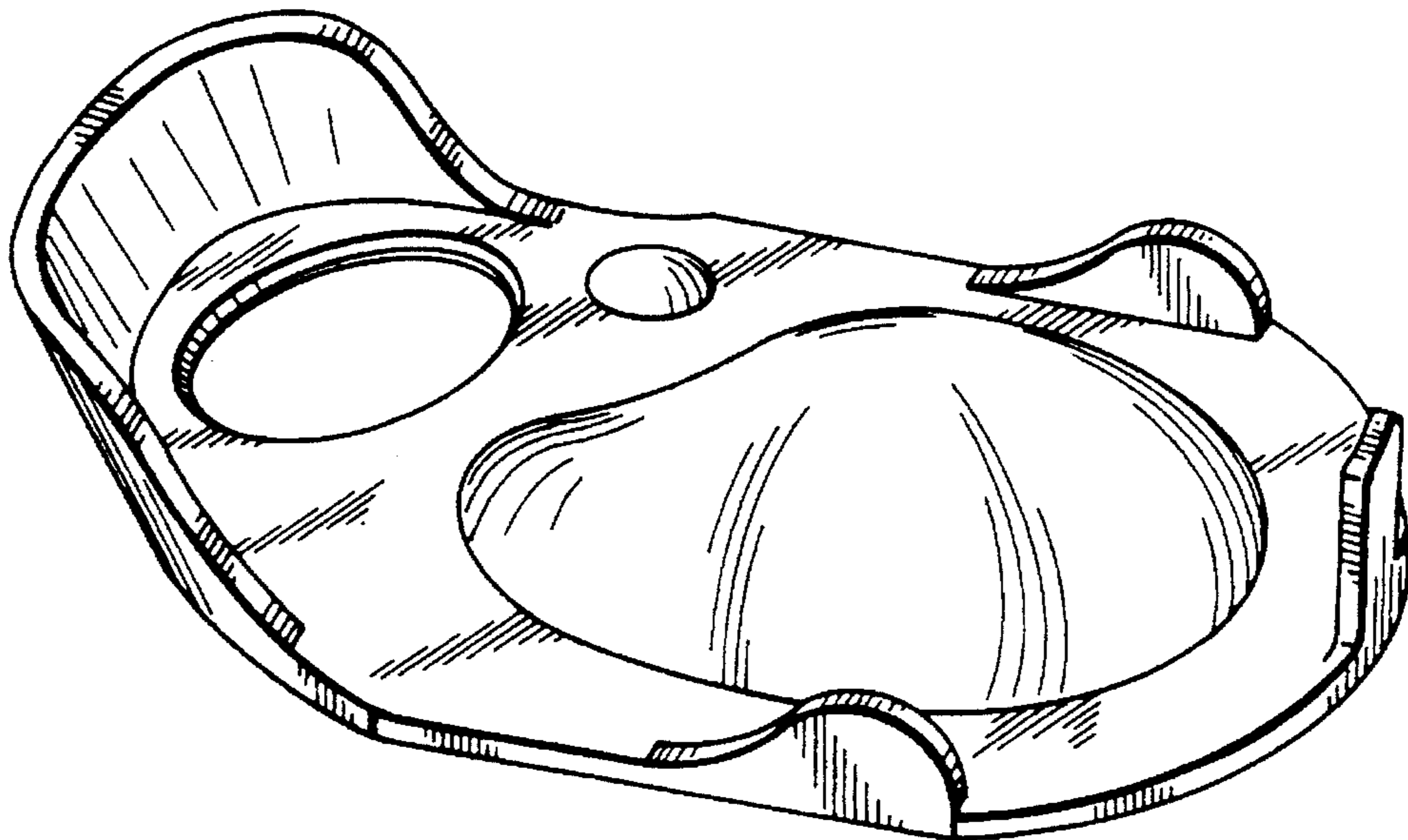

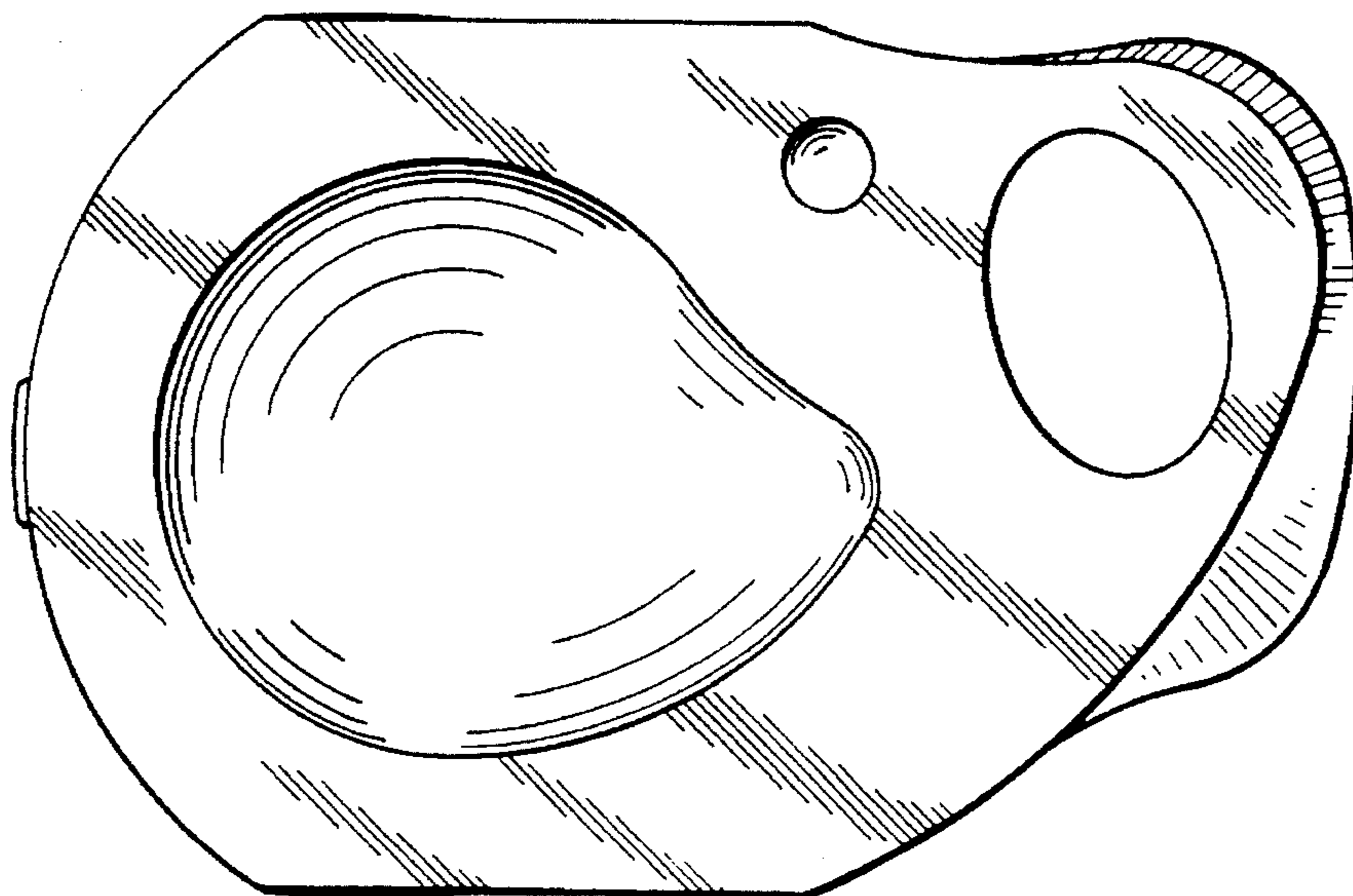

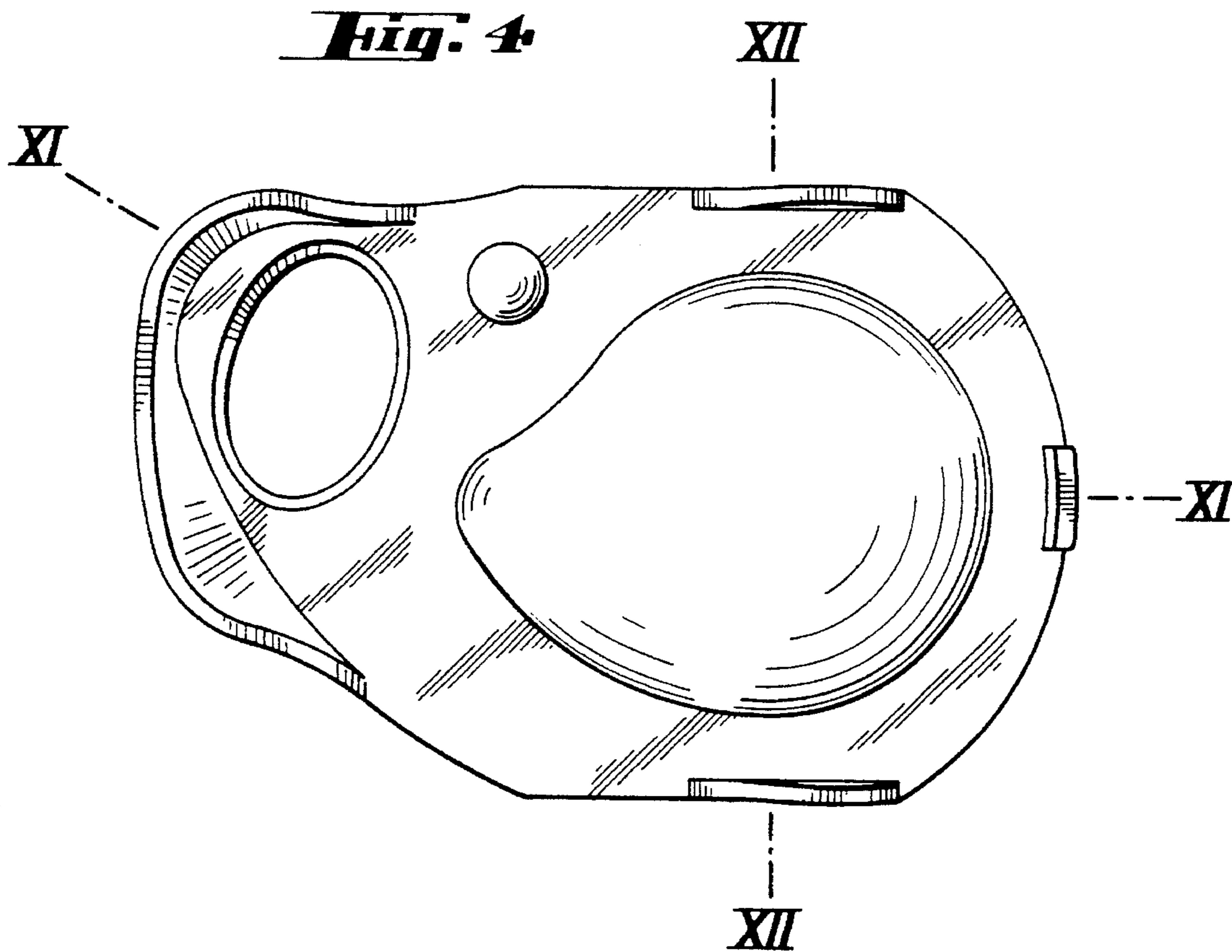

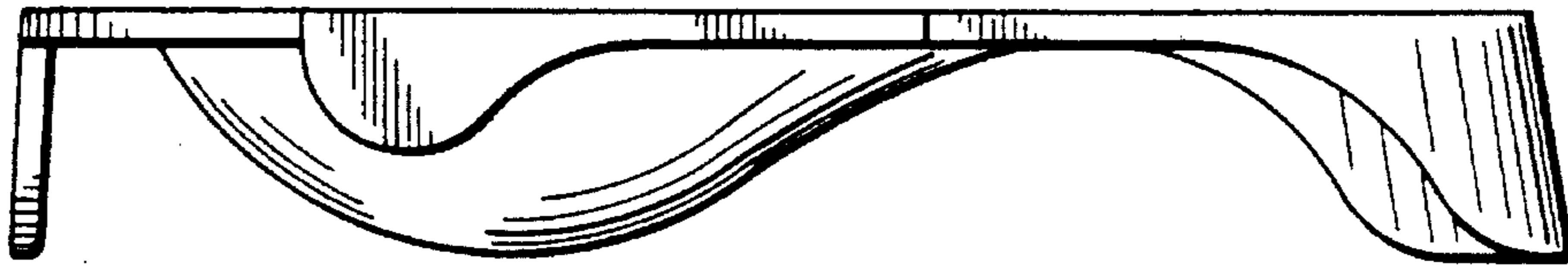

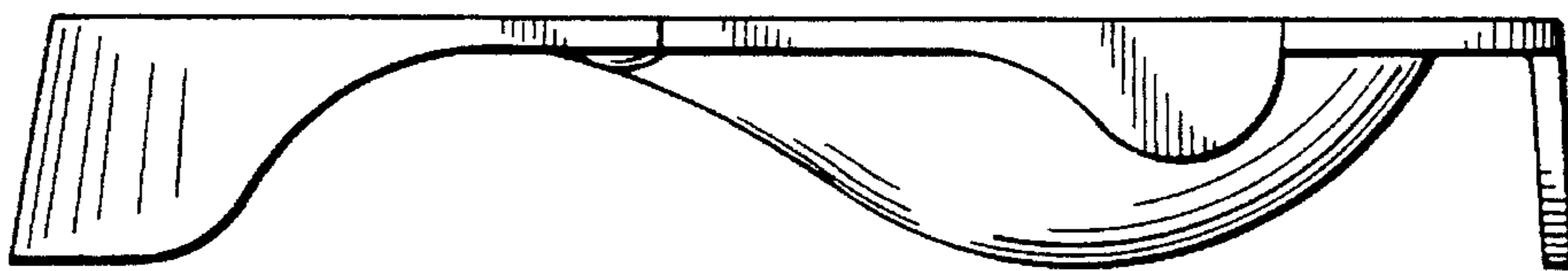

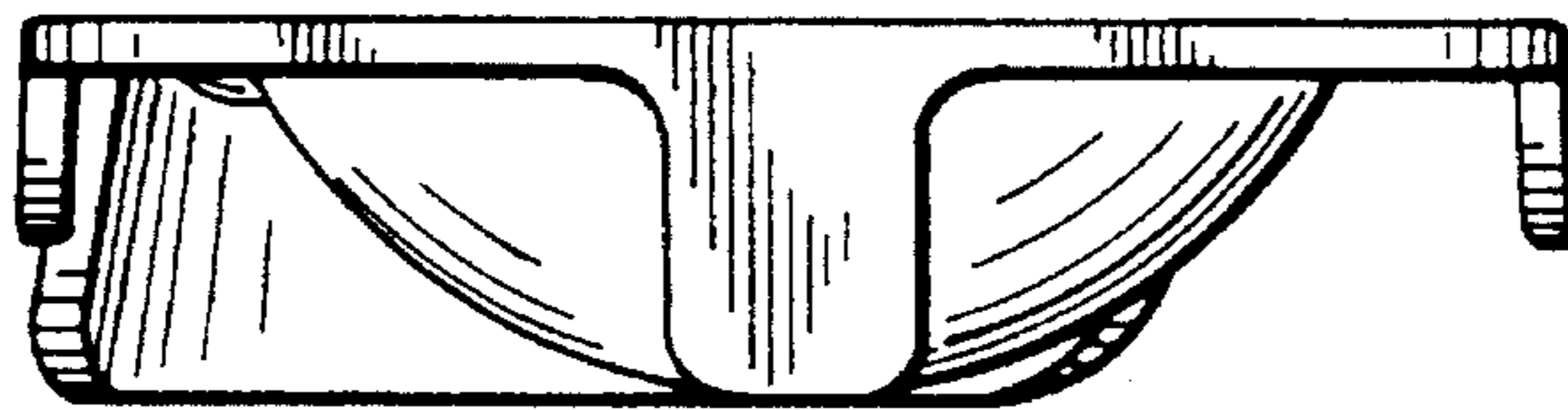
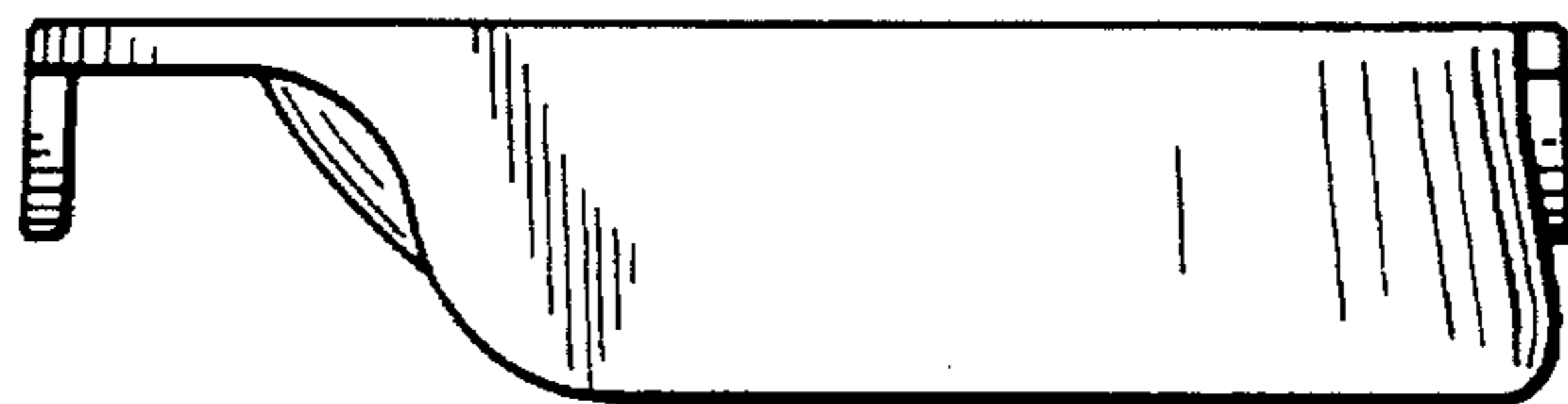

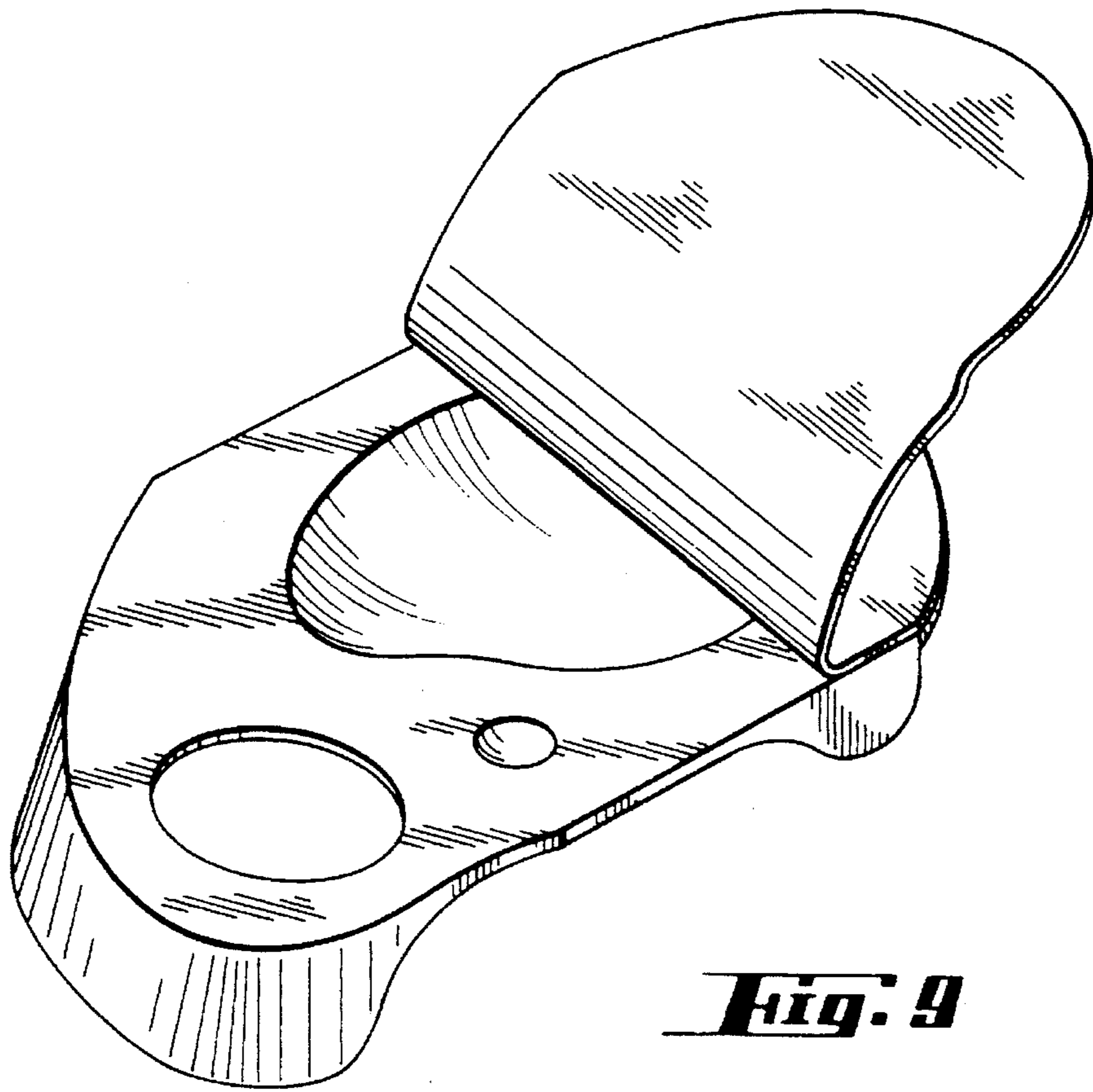

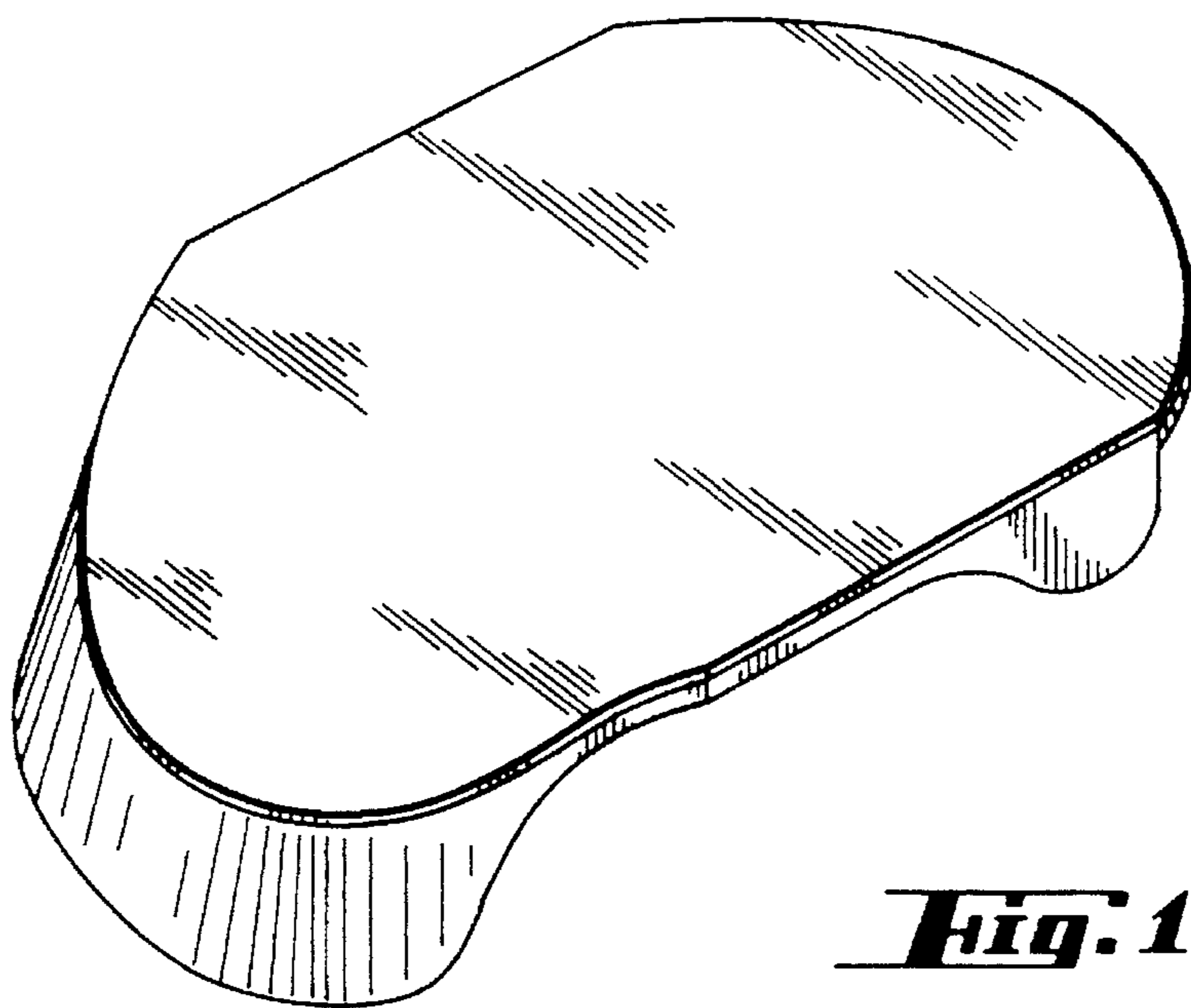

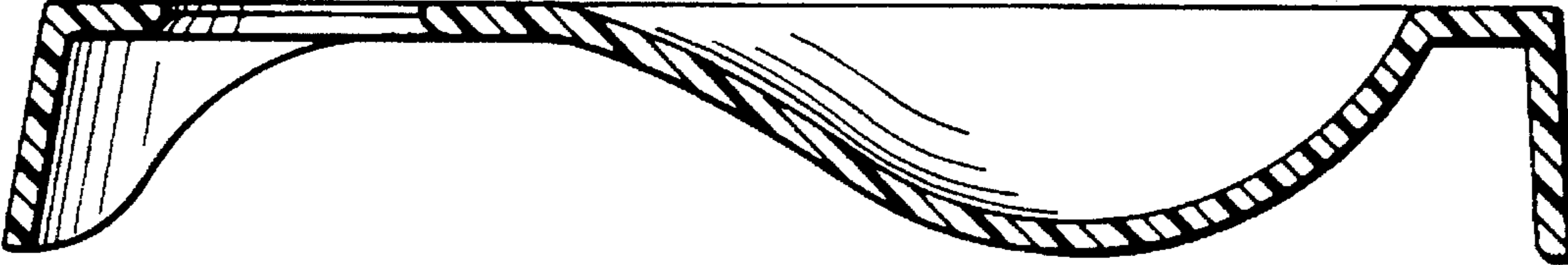
