the left side being identical thereto; and,

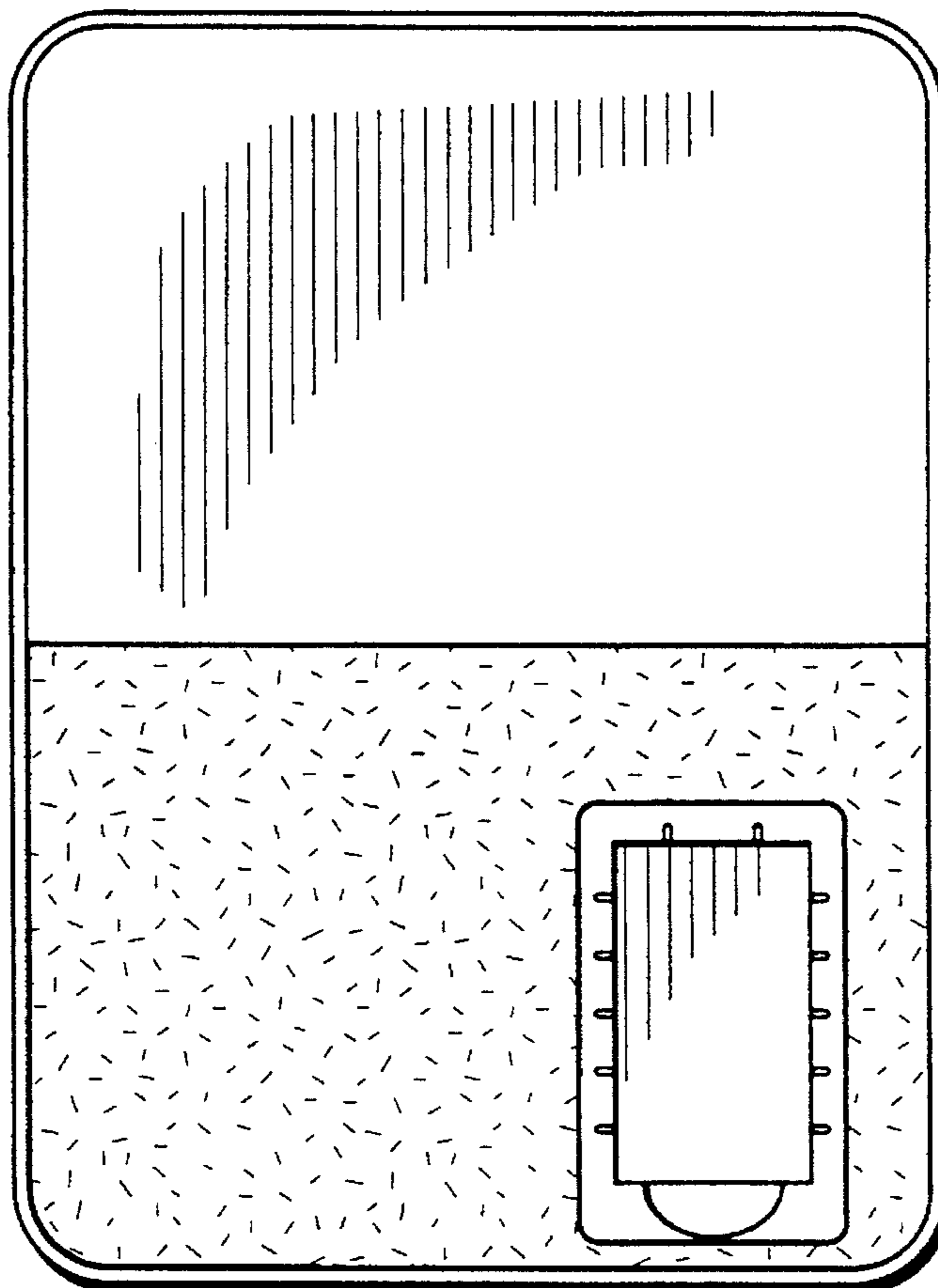
FIG. 6 is a top plan view of FIGS. 1, 2 and 3, the bottom

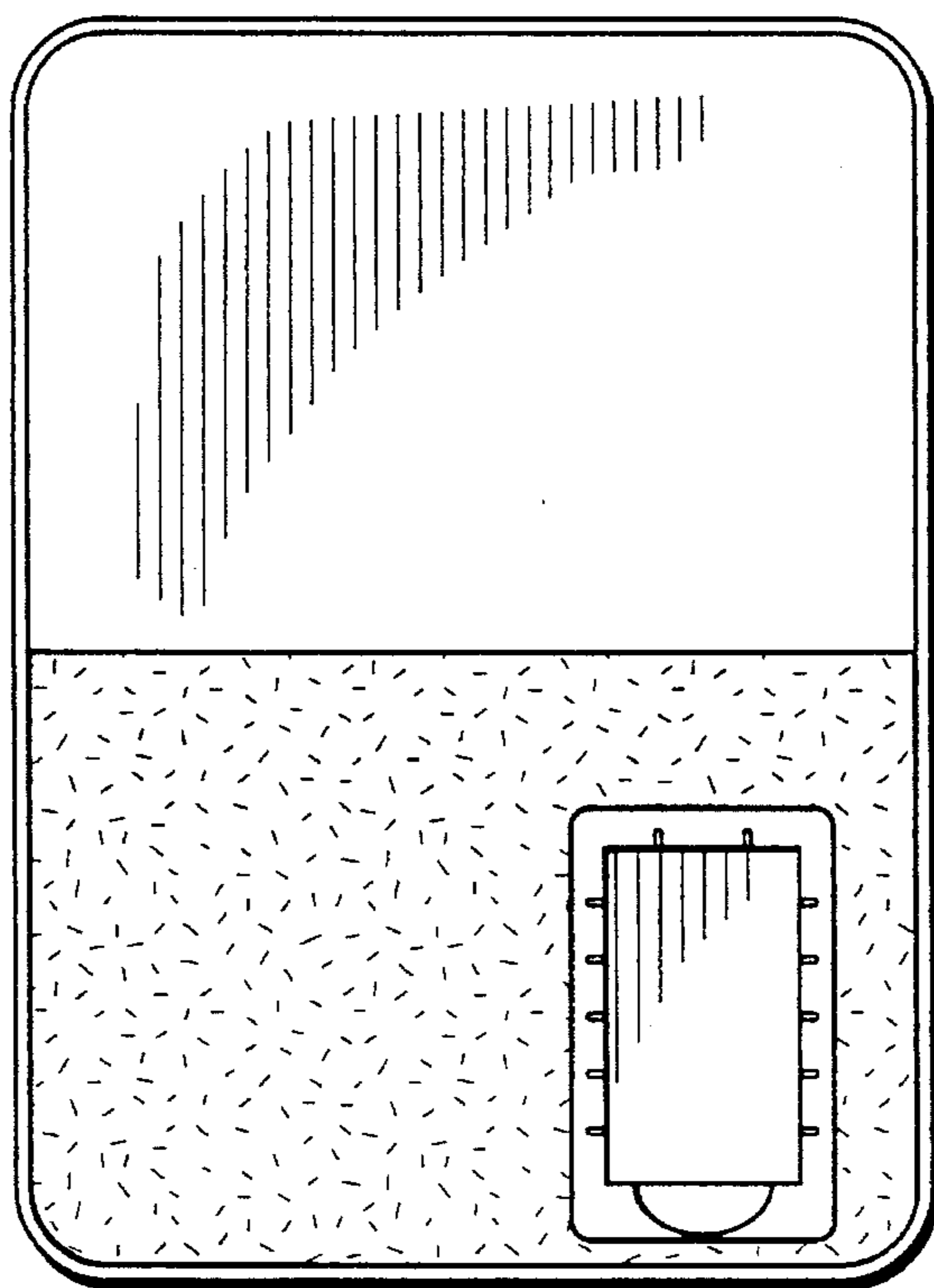

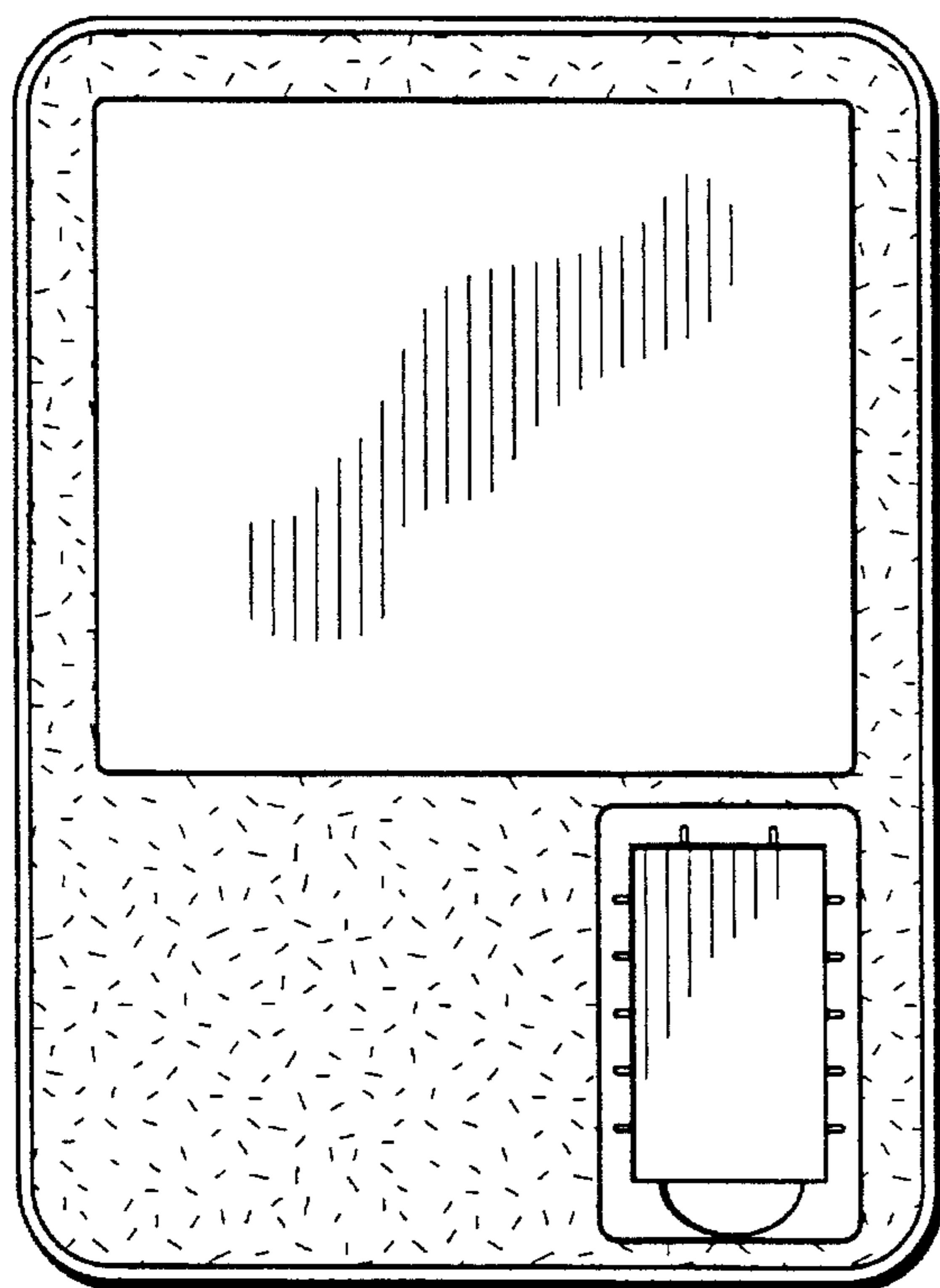

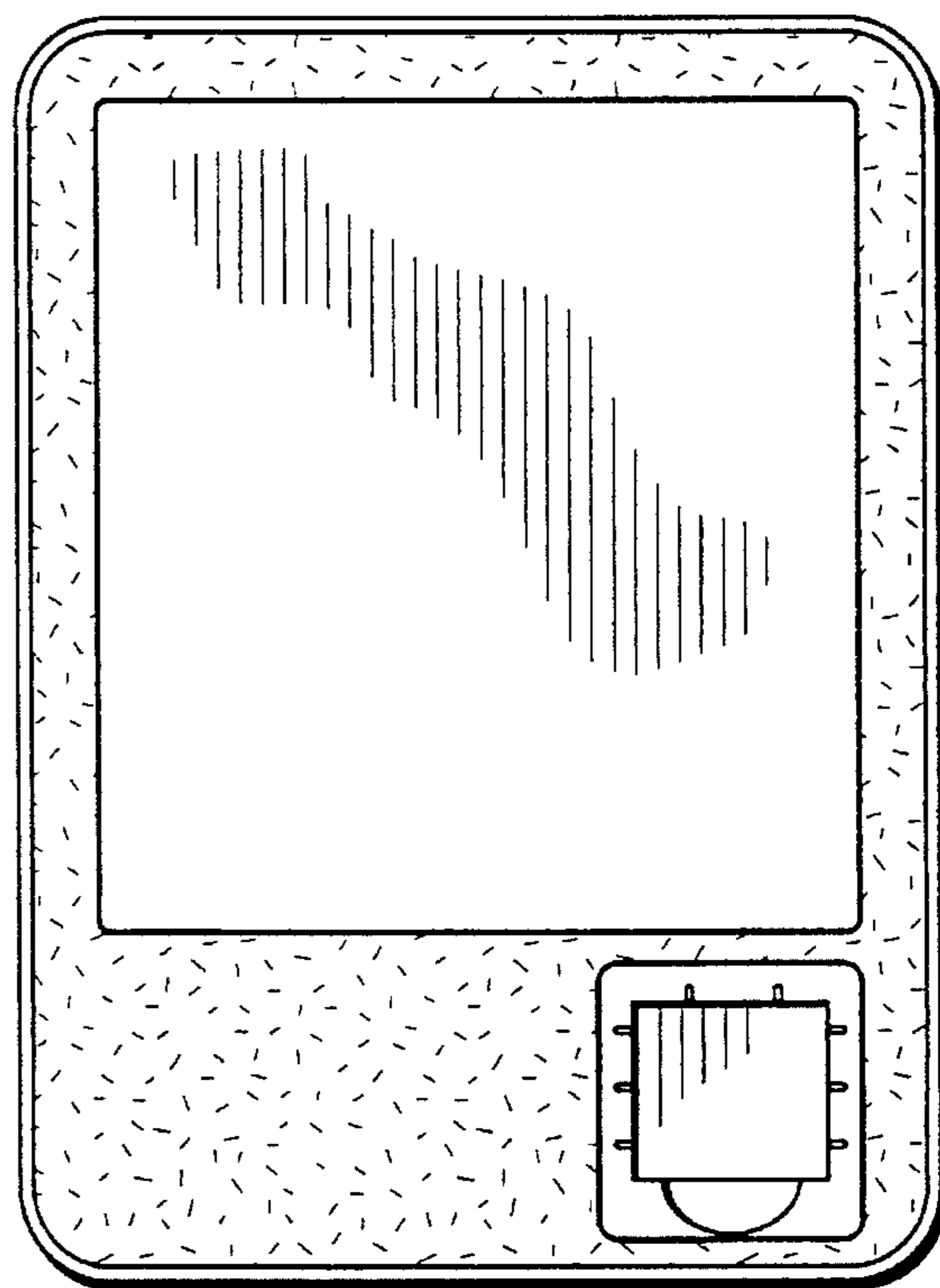

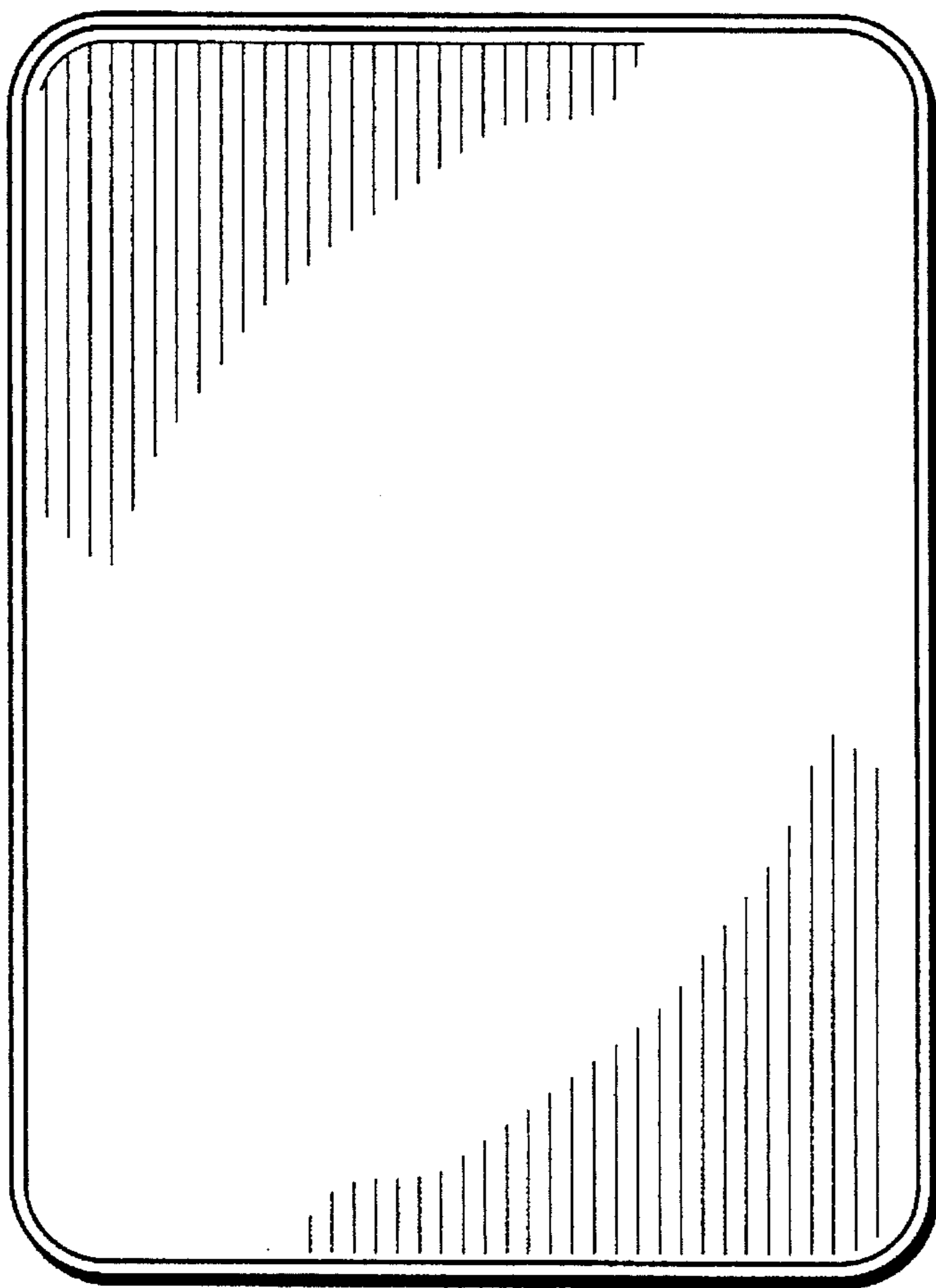

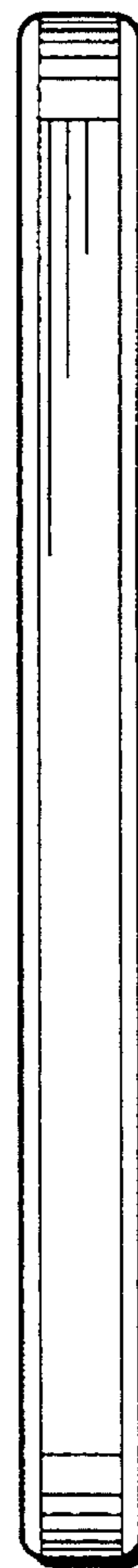

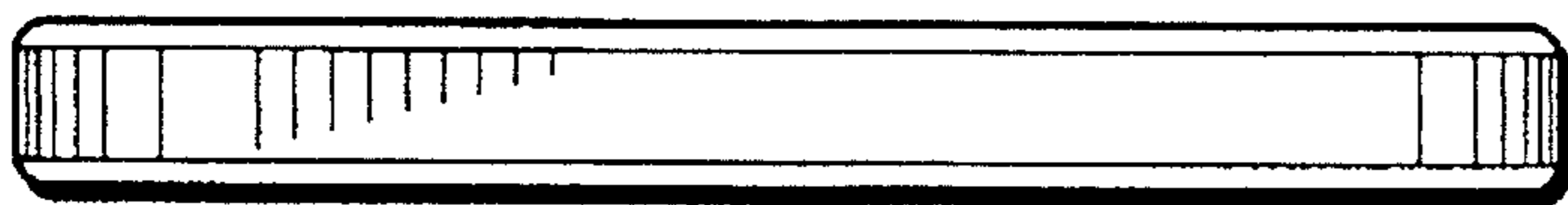
