
[57] CLAIM

The ornamental design for women's insole, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of women's insole showing our new design for use with a right foot;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a bottom plan view thereof;
 FIG. 4 is a left side view thereof;
 FIG. 5 is a right side view thereof;
 FIG. 6 is a front view thereof;
 FIG. 7 is a rear view thereof; and,
 FIG. 8 is a top plan view of women's insole, showing our new design for use with a left foot, the other views all being mirror images of those of the first embodiment.






