DESCRIPTION

FIG. 1 is an exploded perspective view of a football container showing my new design;
FIG. 2 is a rear elevational view thereof with the cover on;
FIG. 3 is a front elevational view thereof with the cover on;
FIG. 4 is a left side elevational view thereof with the cover on;
FIG. 5 is a right side elevational view thereof with the cover on;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

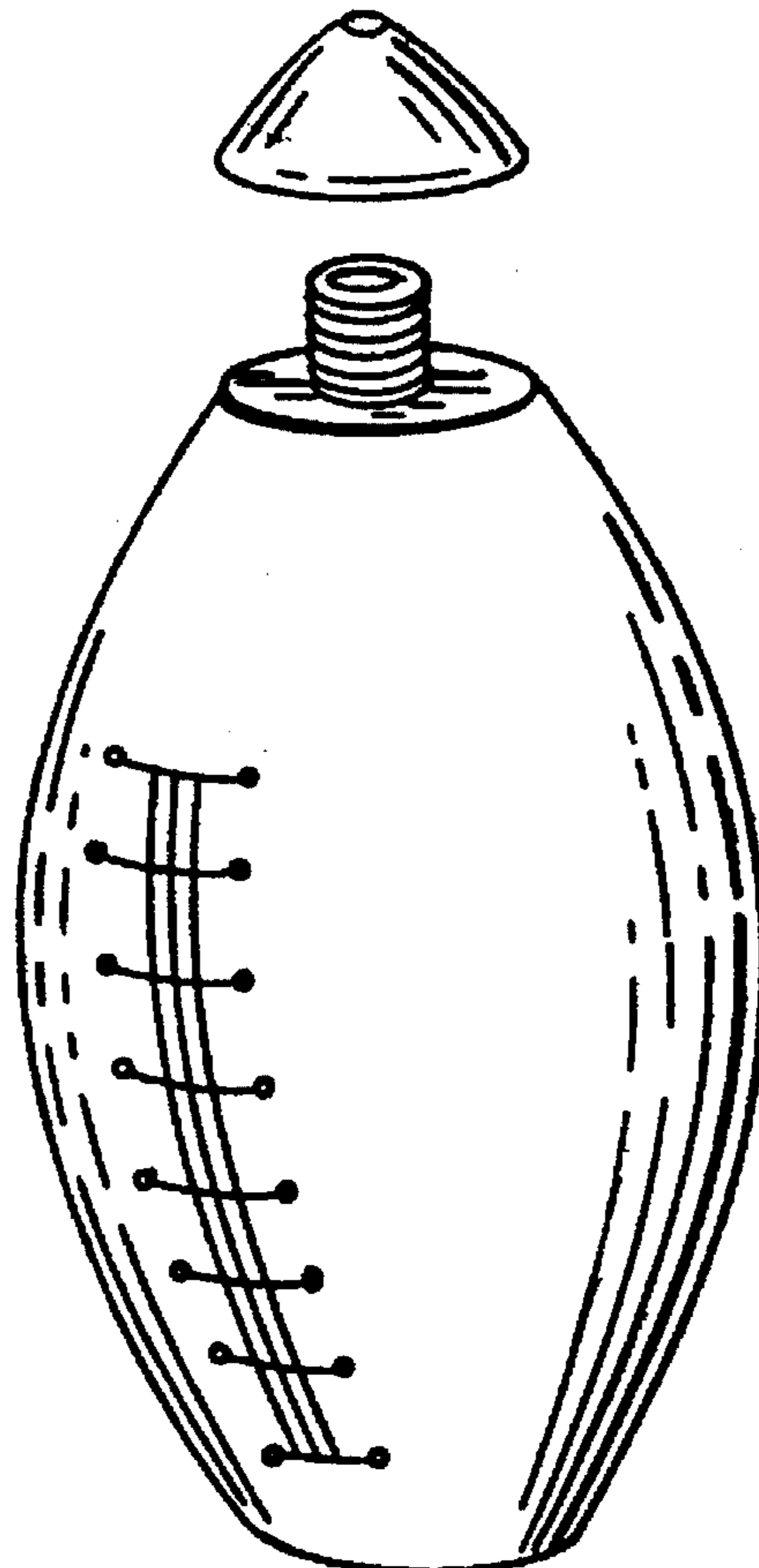

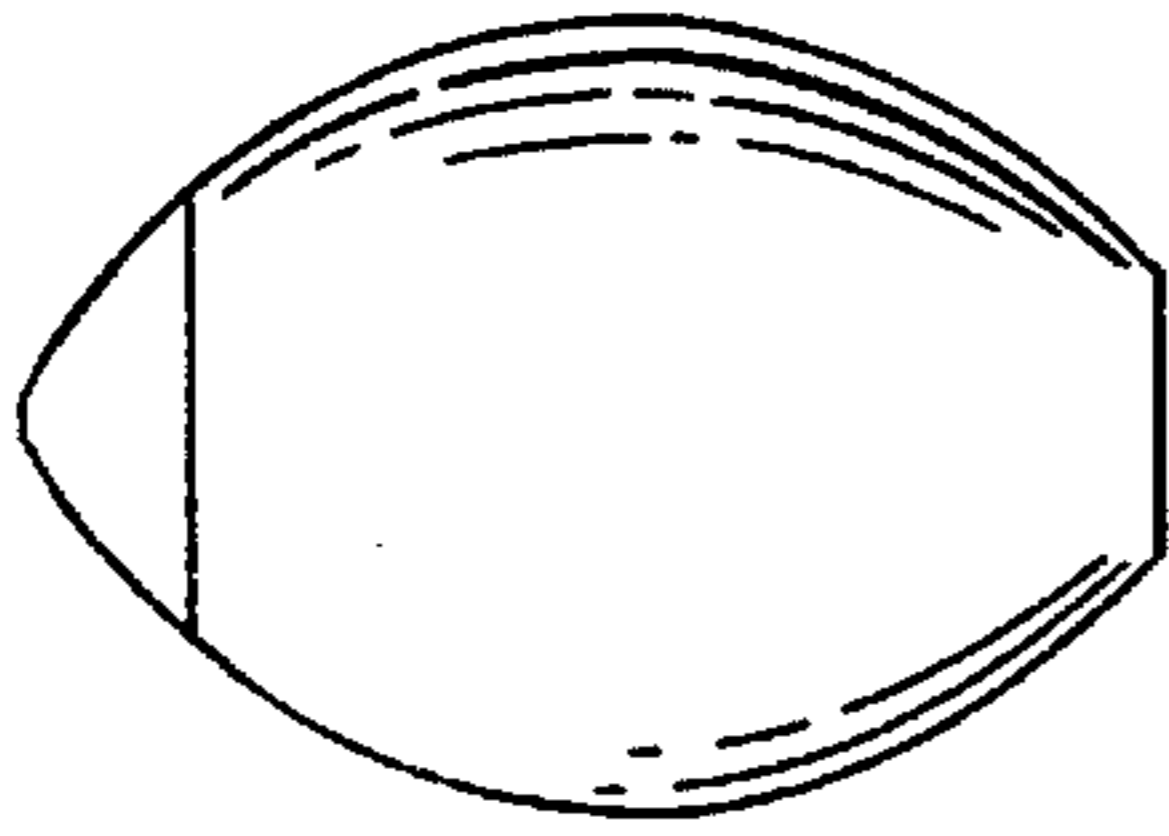

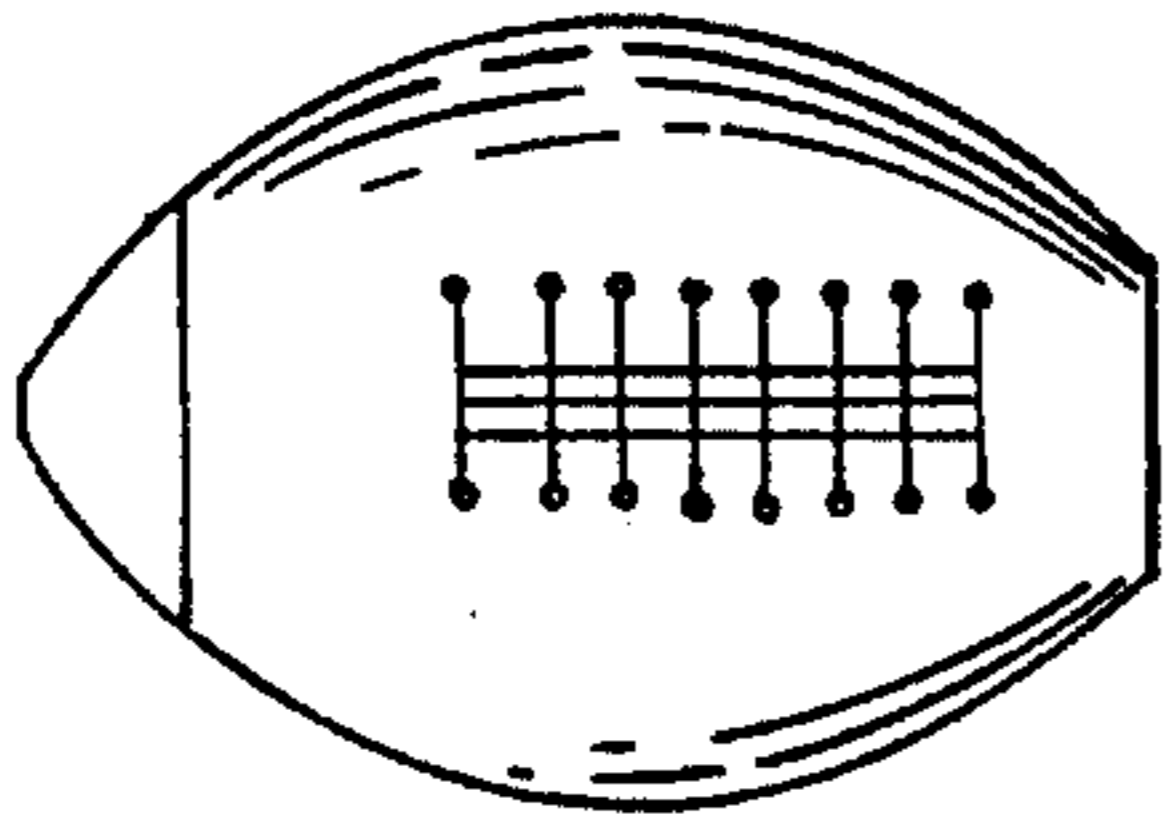

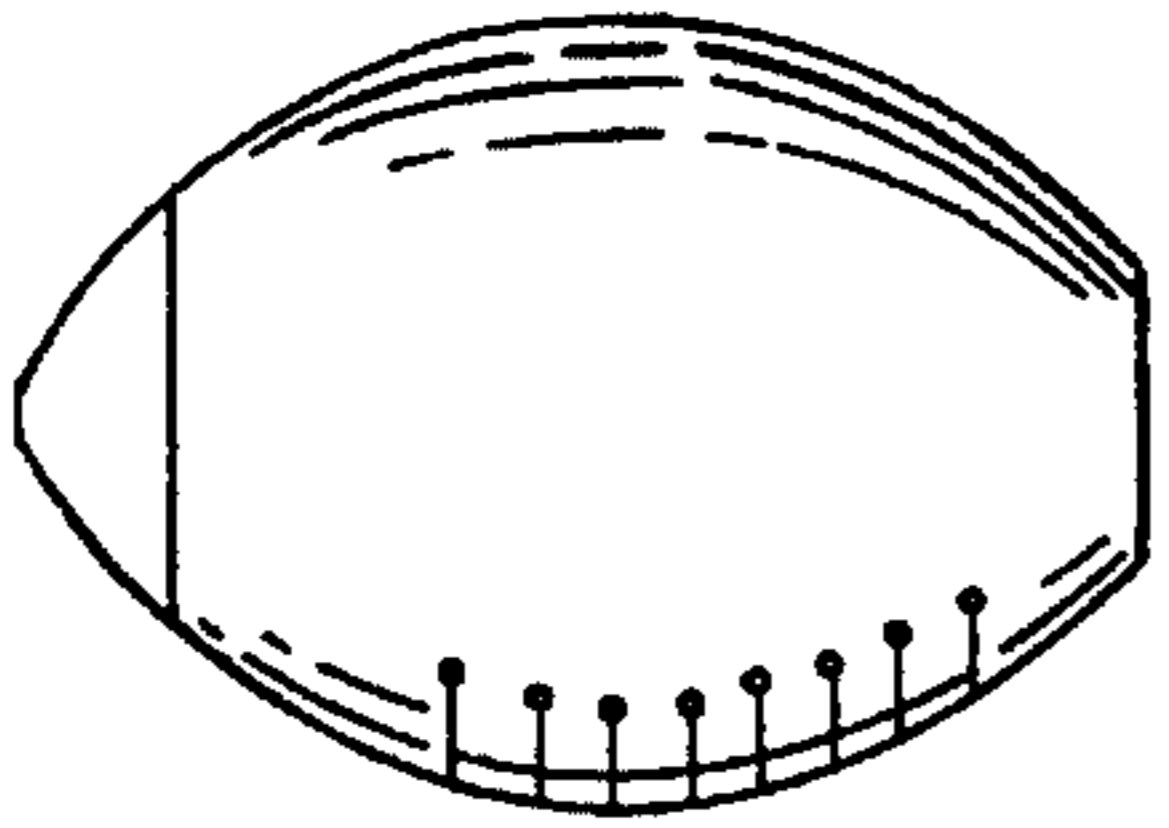

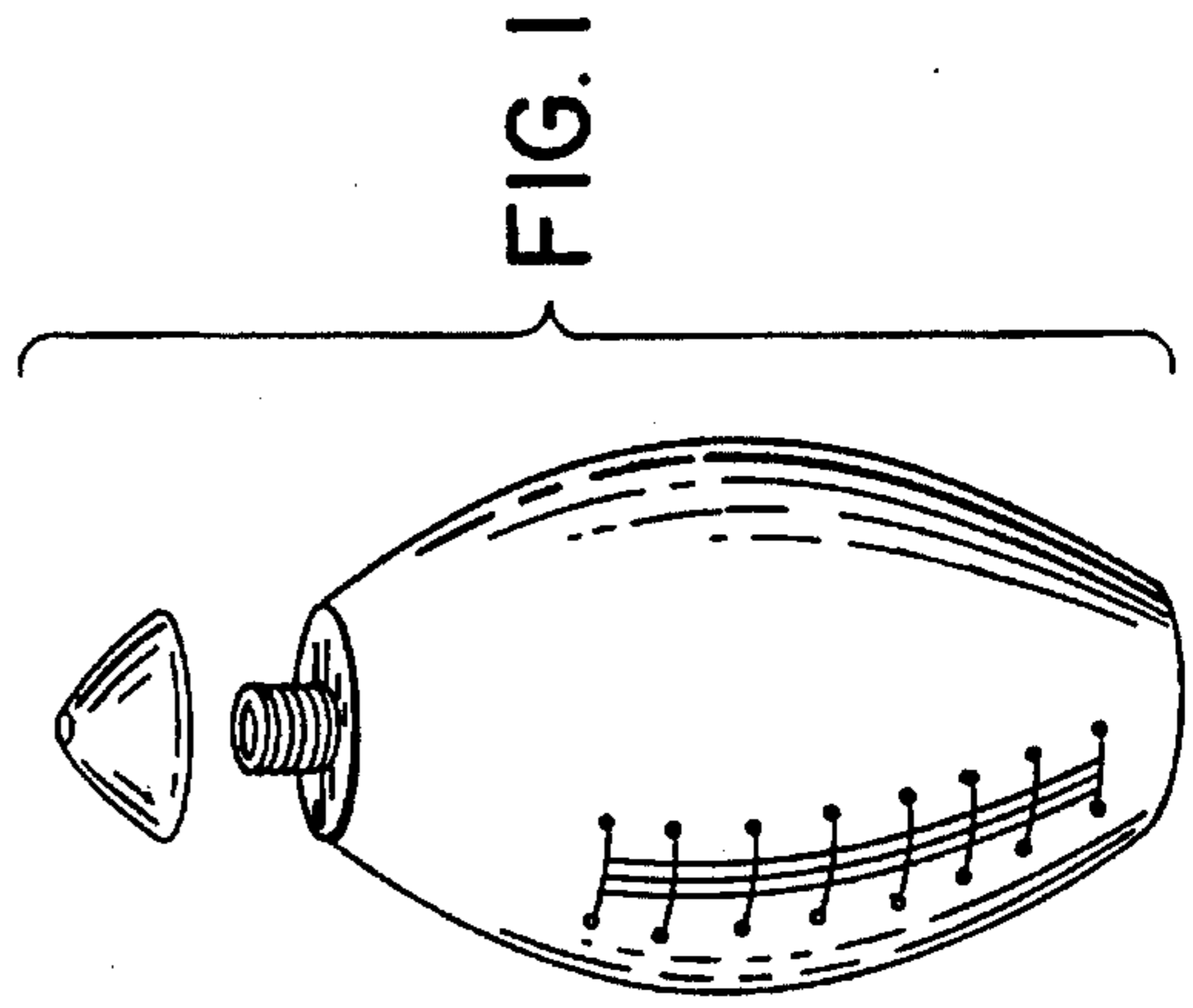
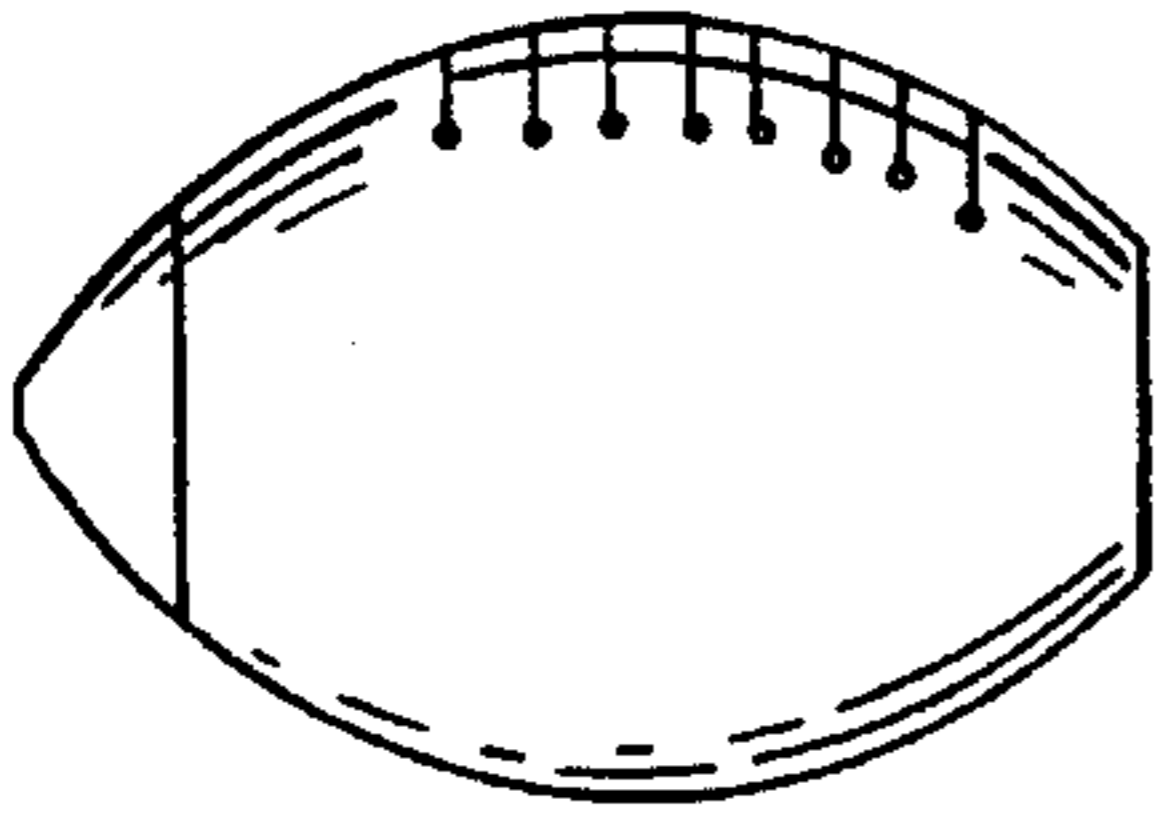

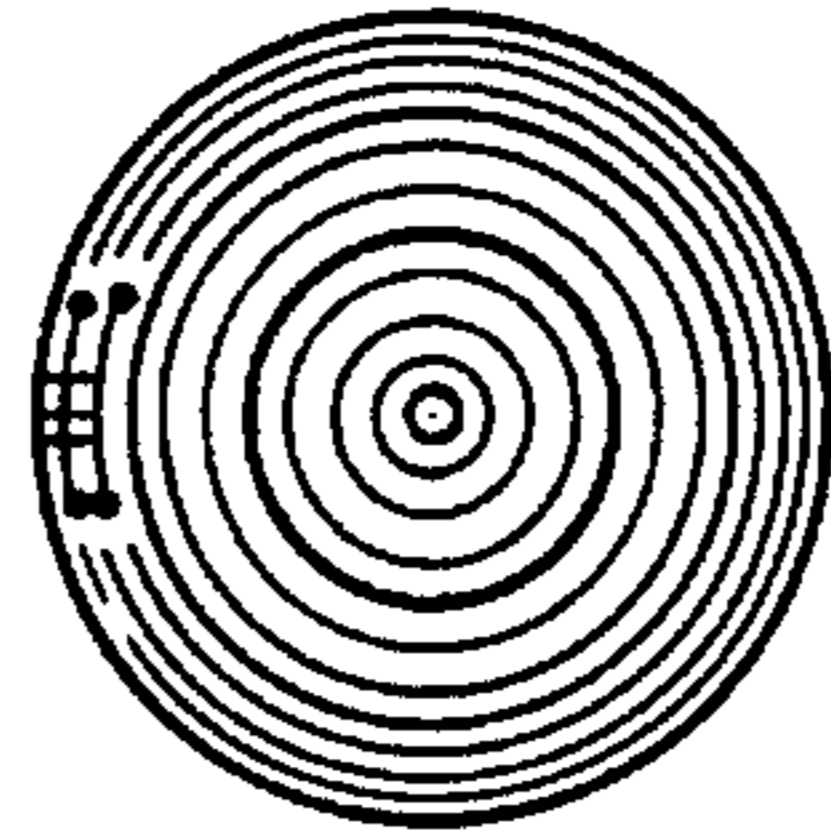
