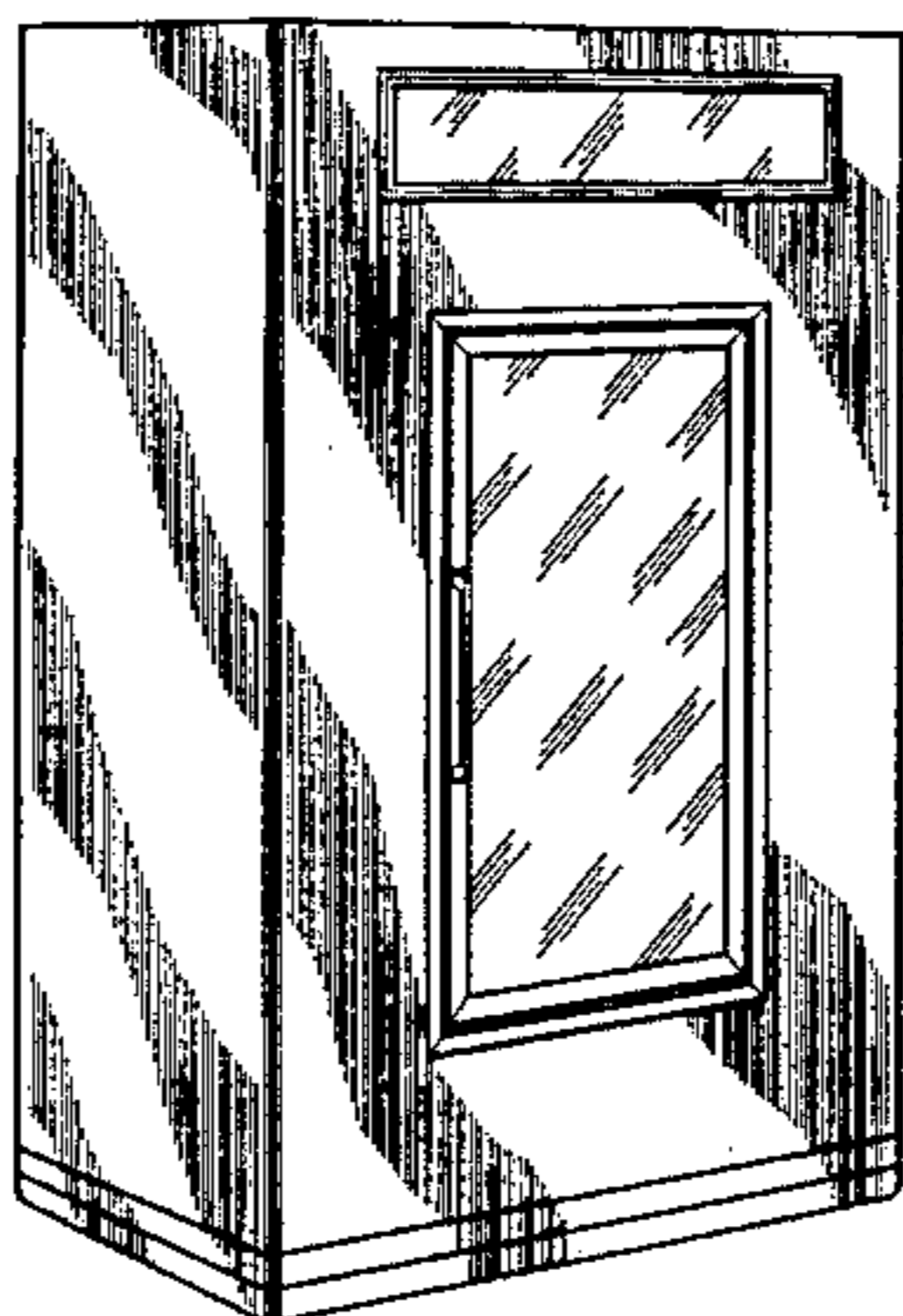
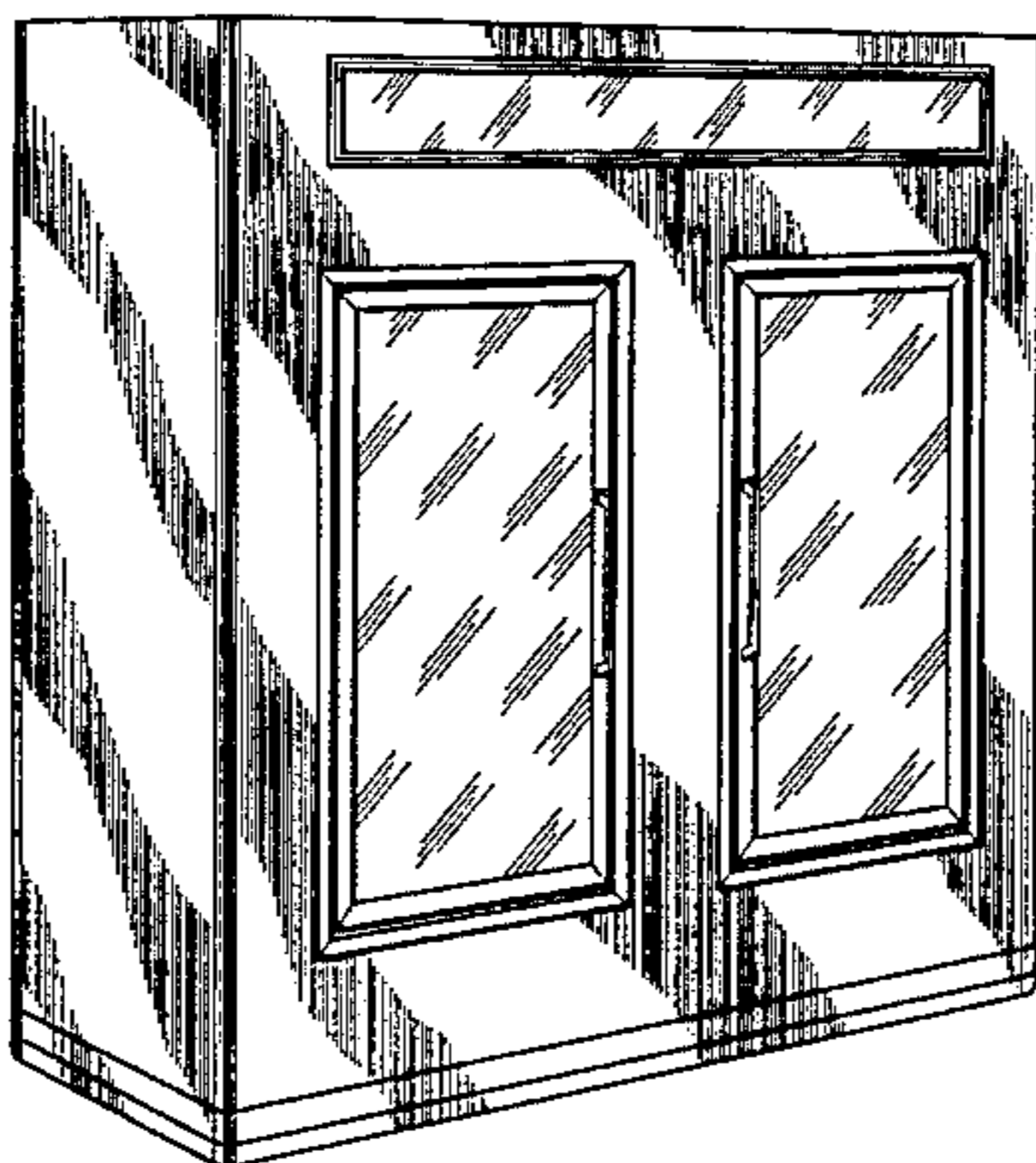
### [57] CLAIM

The ornamental design for an ice merchandiser with message board, as shown and described.

### DESCRIPTION

FIG. 1 is a front perspective view of the ice merchandiser with message board of this invention;  
FIG. 2 is a right side elevational view thereof, the side opposite being the mirror image thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a rear elevational view thereof;  
FIG. 7 is a front perspective view of an alternative embodiment ice merchandiser with message board of this invention;  
FIG. 8 is a right side elevational view thereof, the side opposite being the mirror image thereof;  
FIG. 9 is a front elevational view thereof;  
FIG. 10 is a bottom plan view thereof;  
FIG. 11 is a top plan view thereof; and,  
FIG. 12 is a rear elevational view thereof.

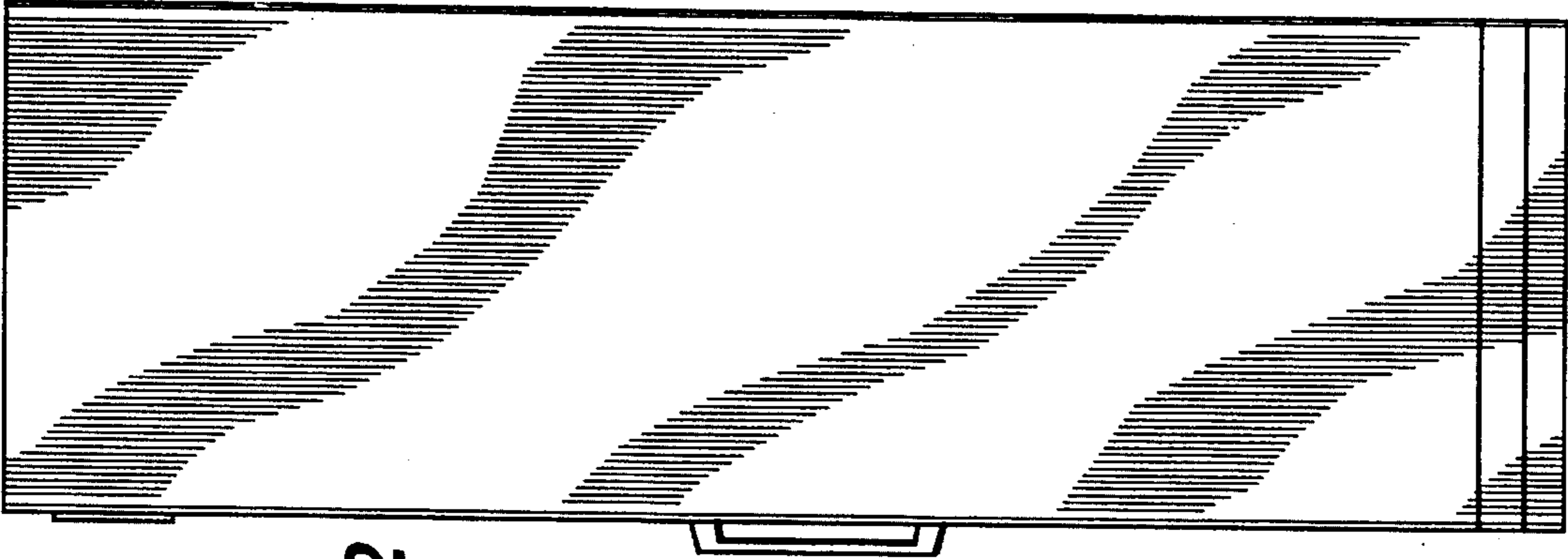

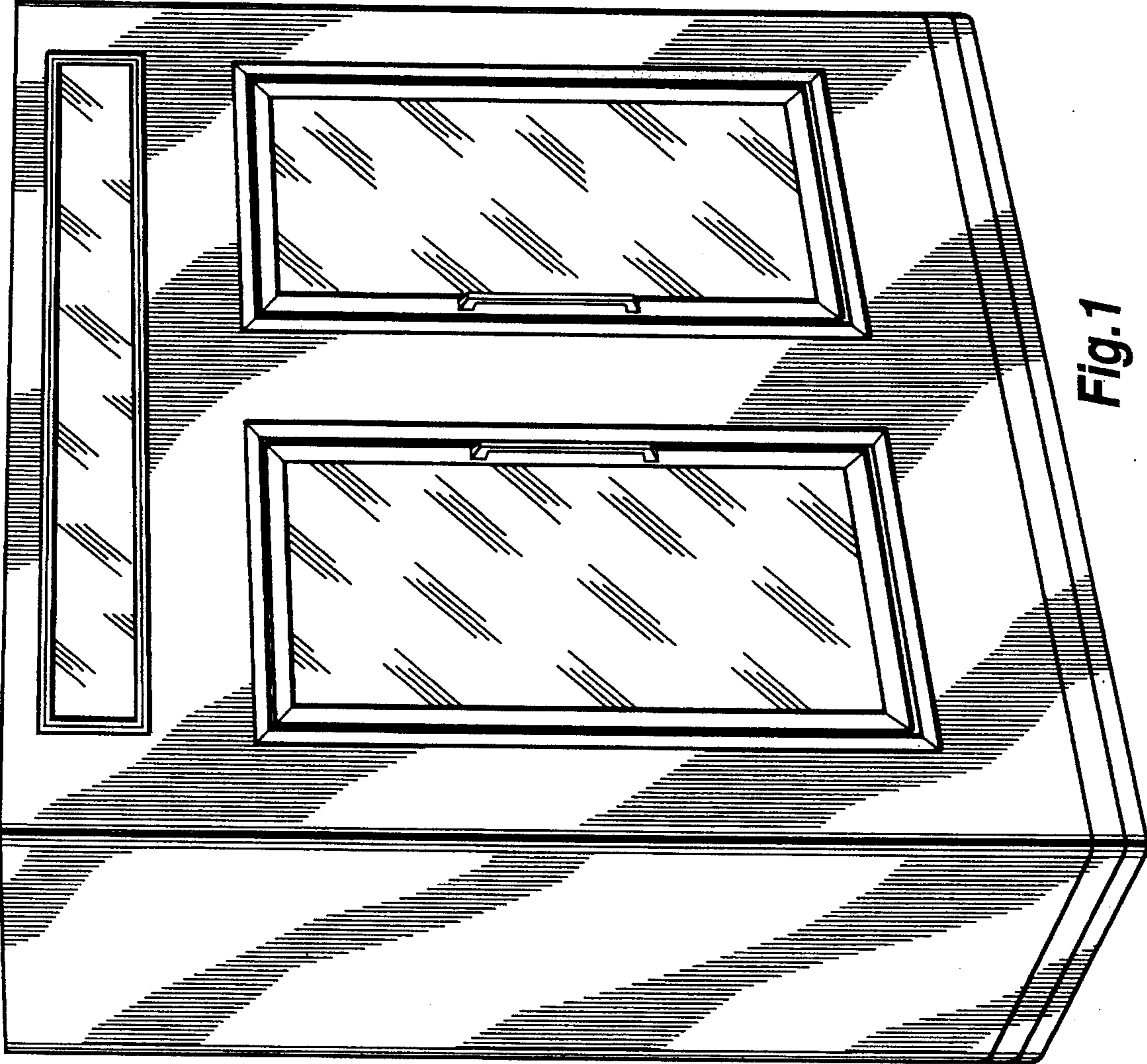
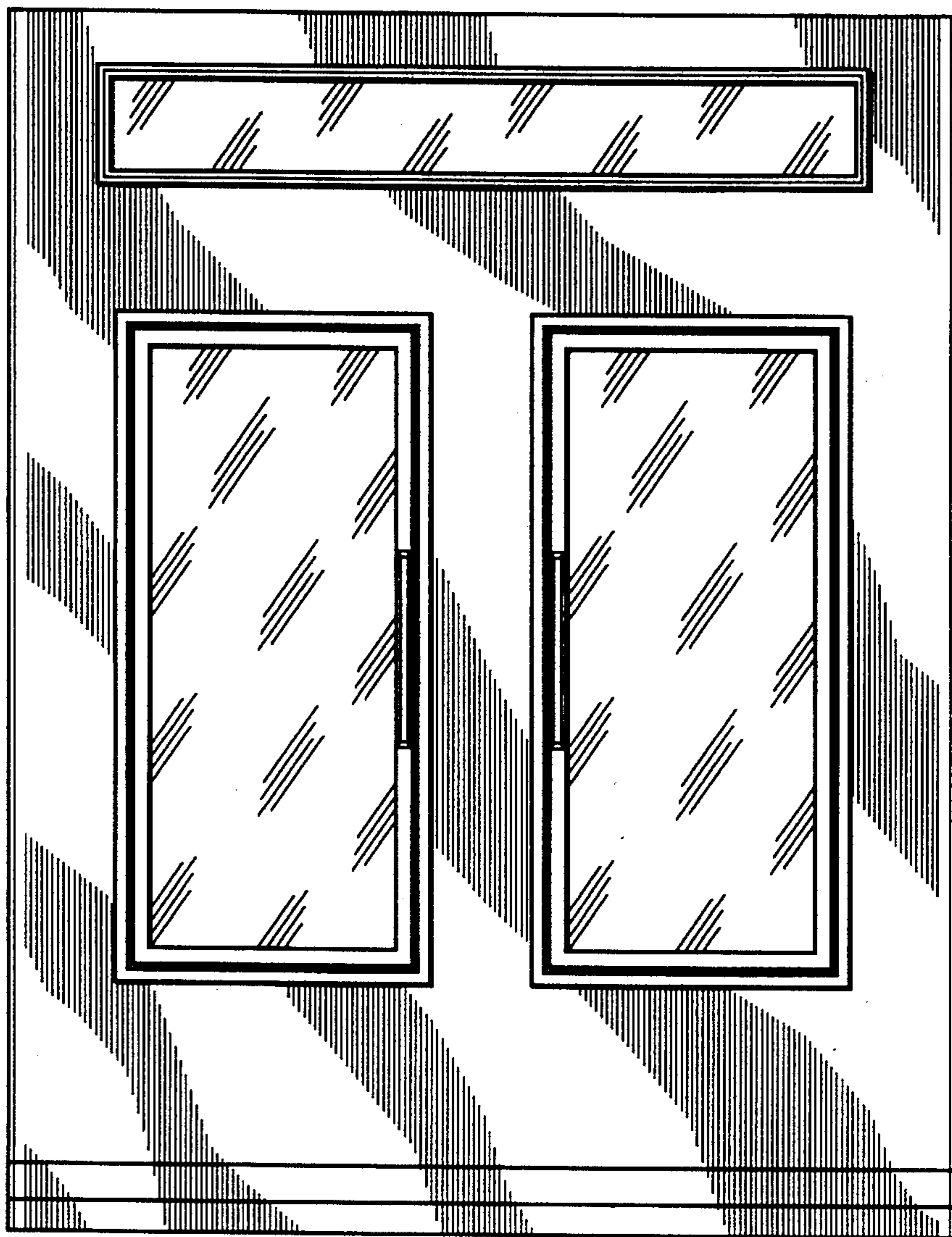
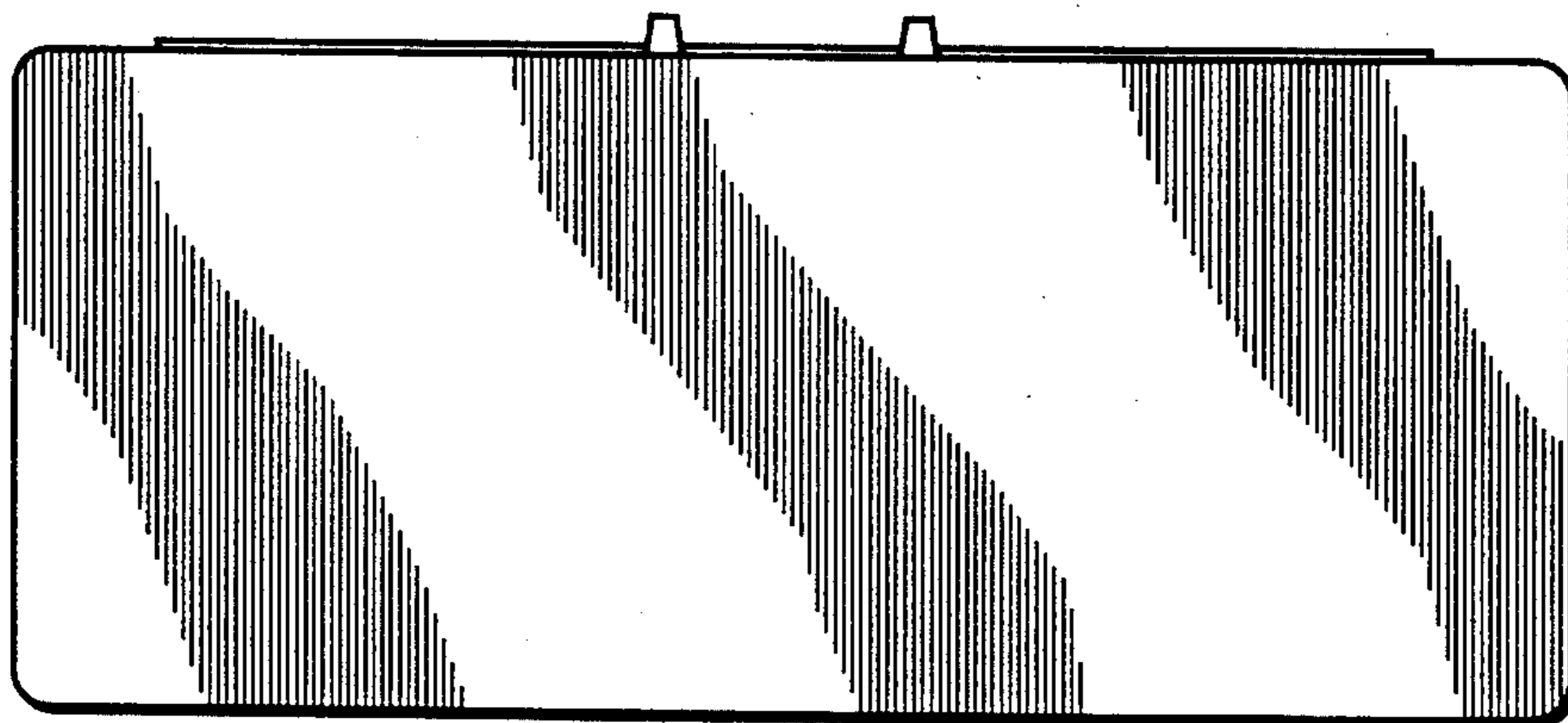

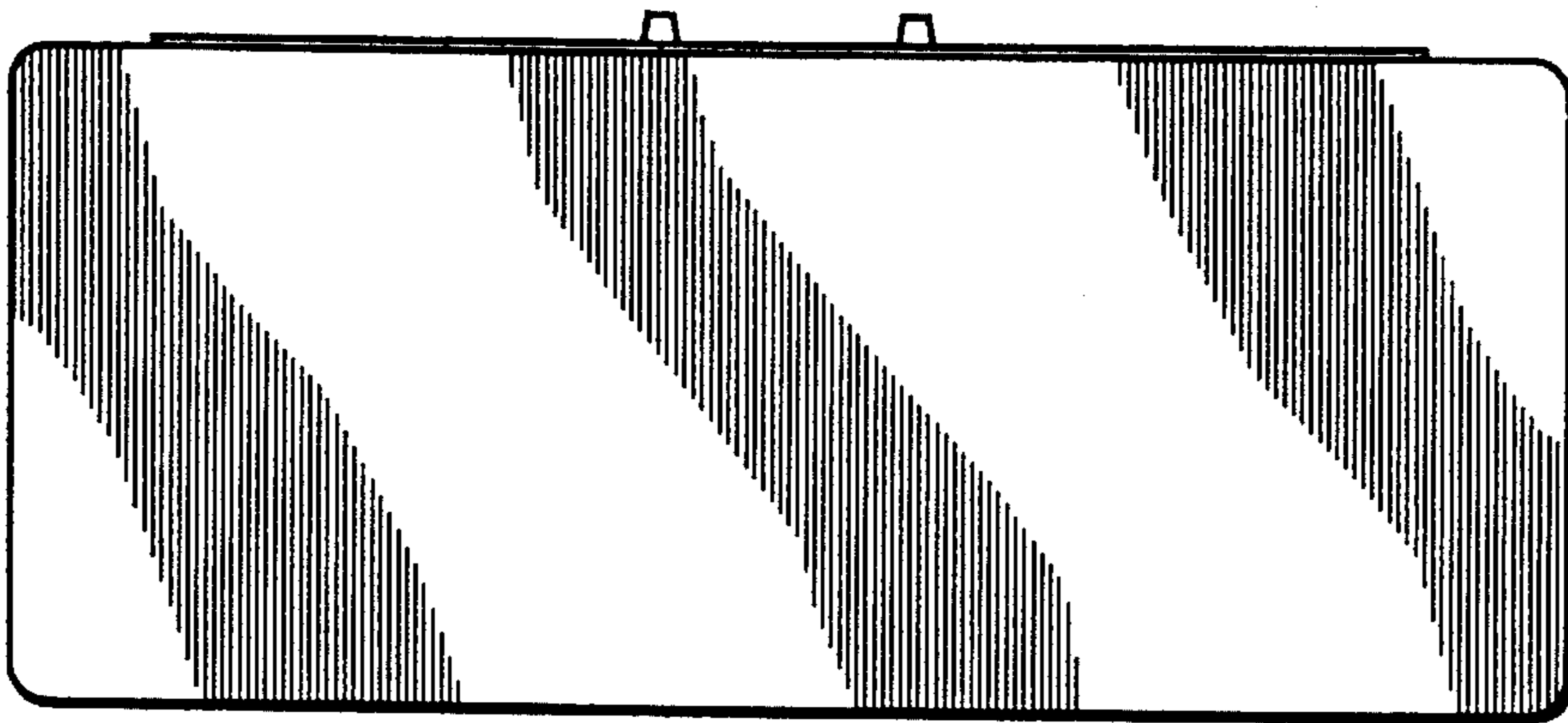




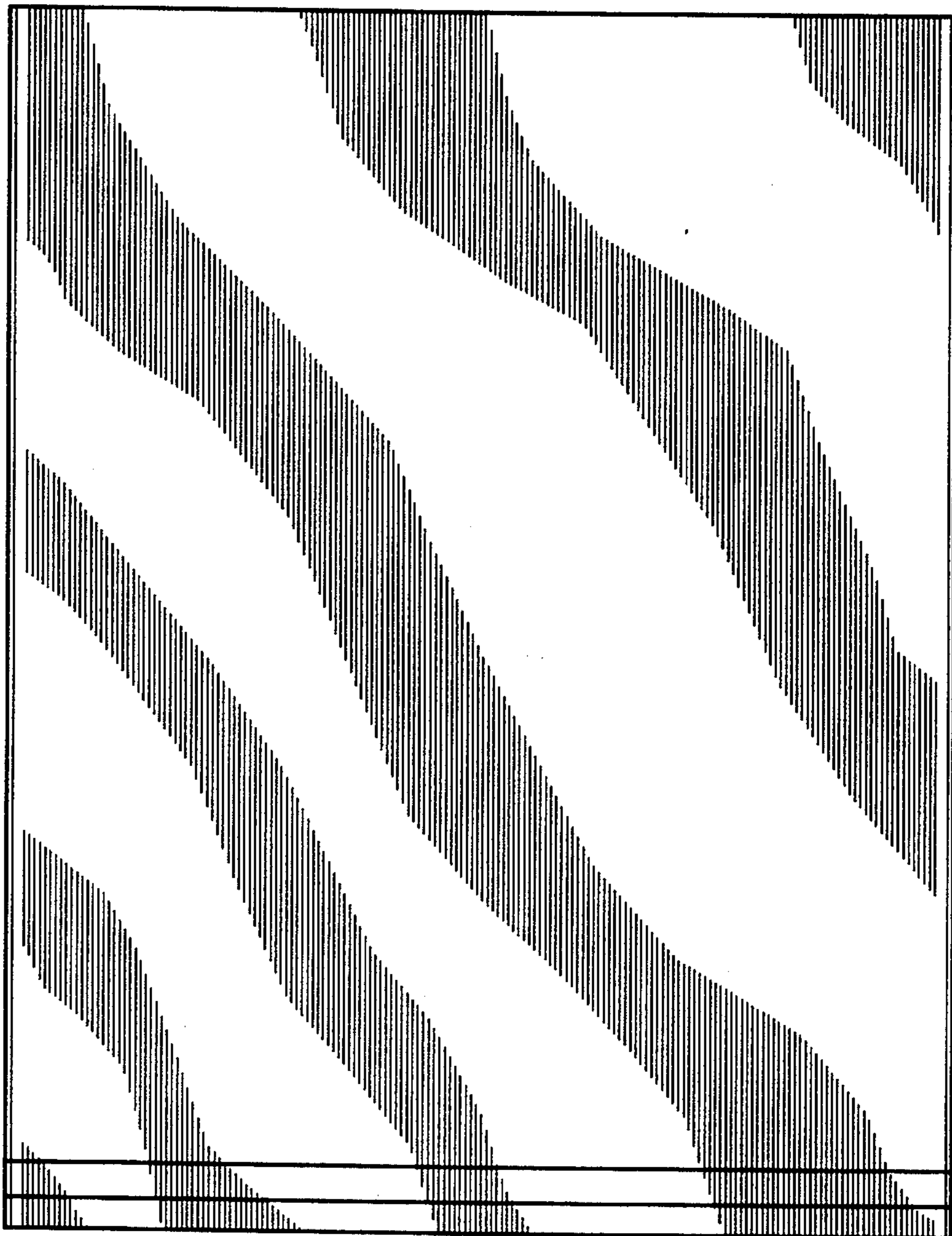

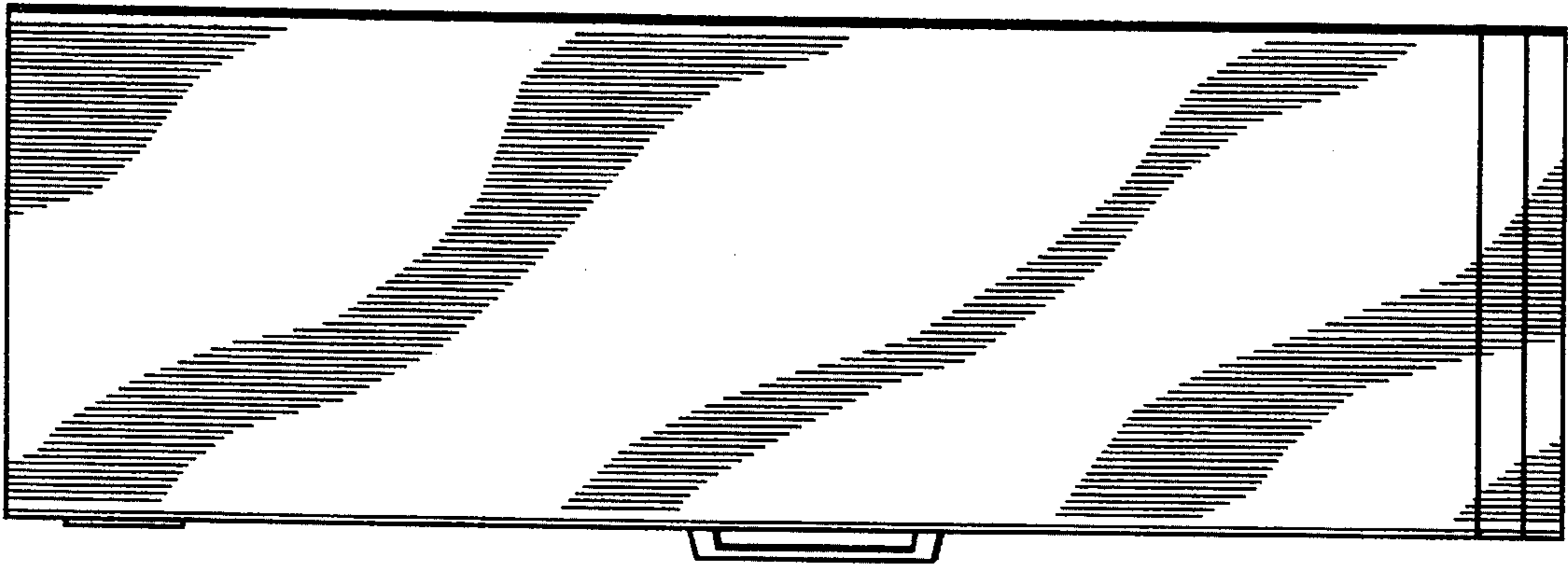

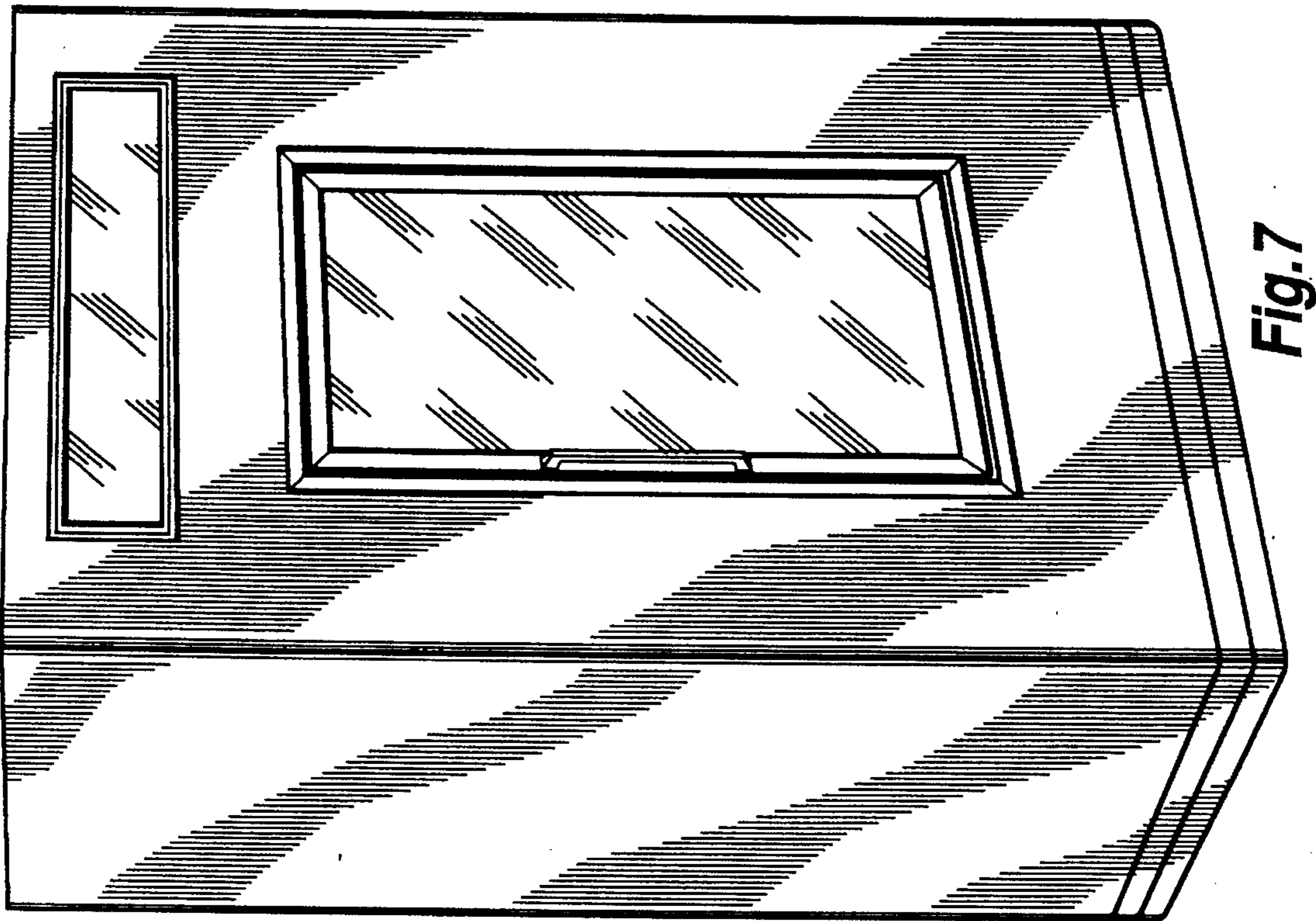
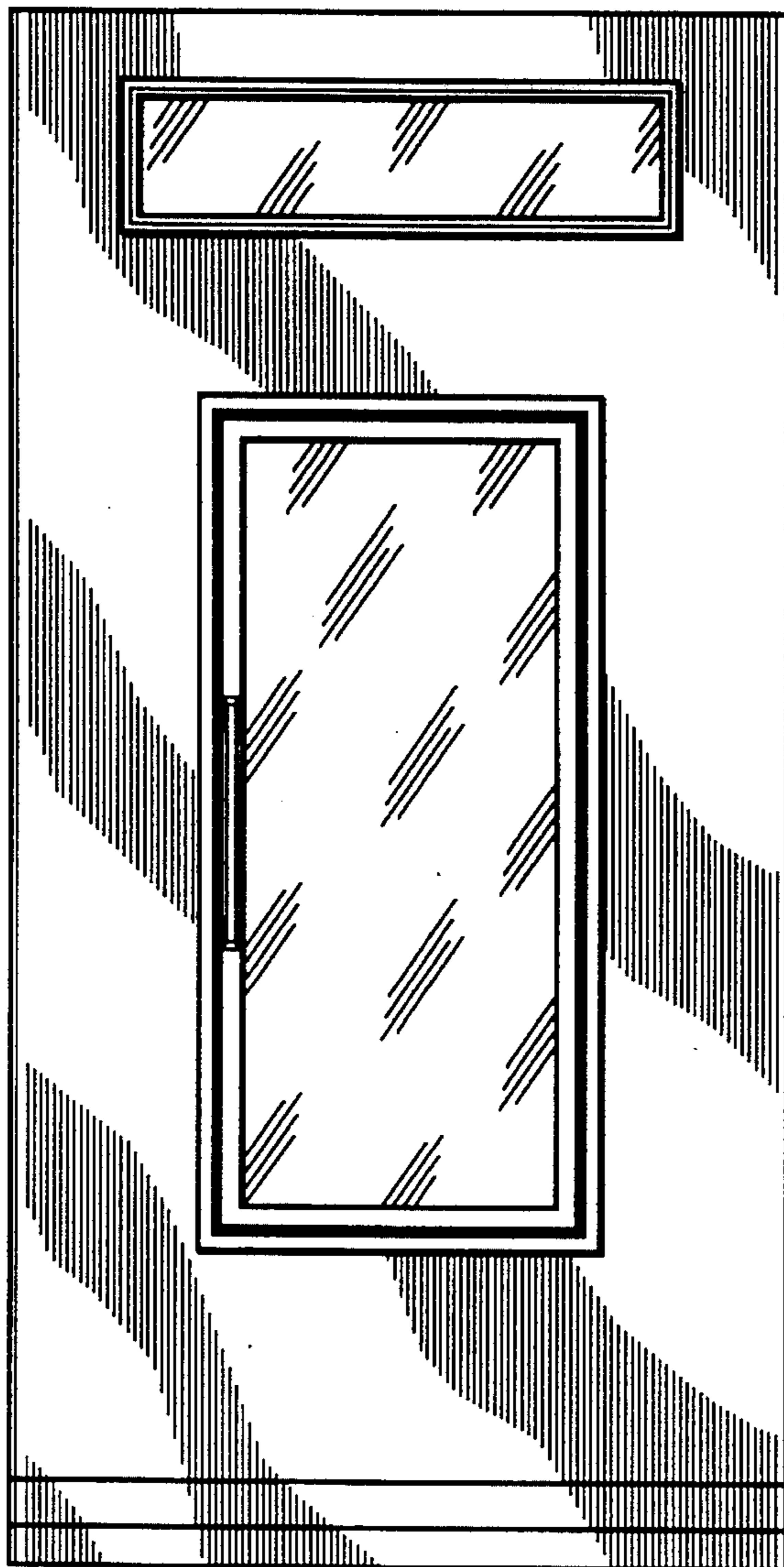
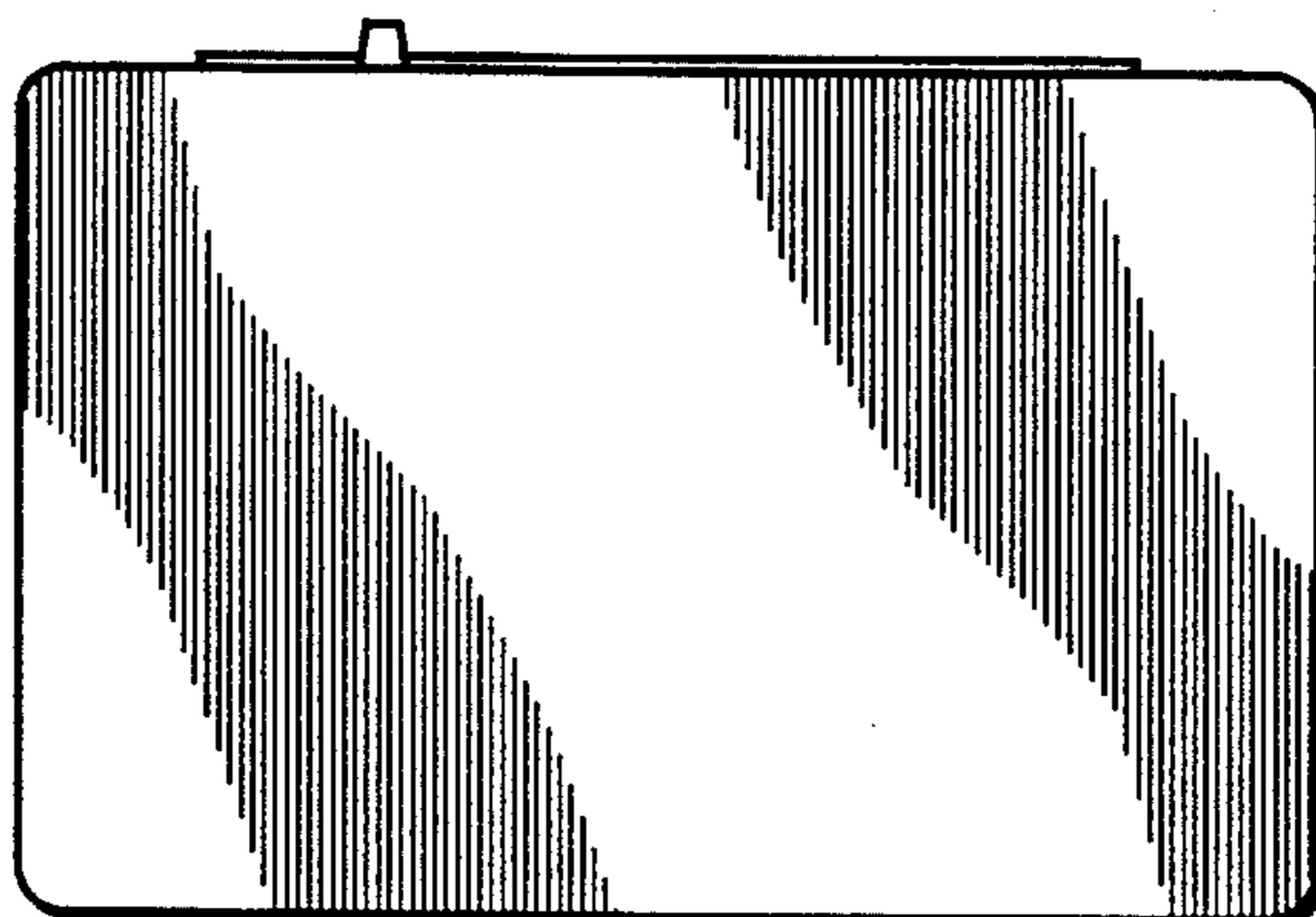

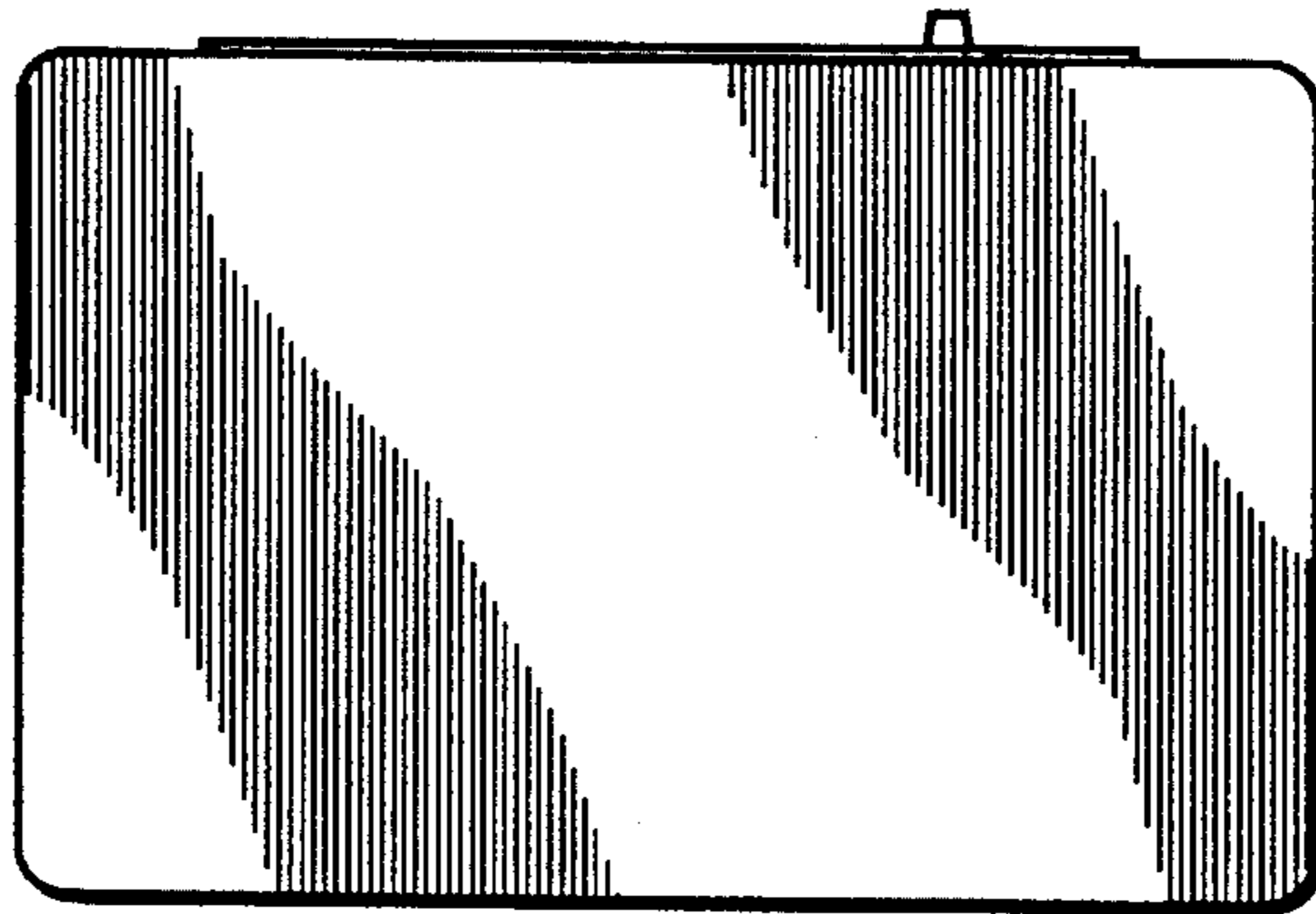

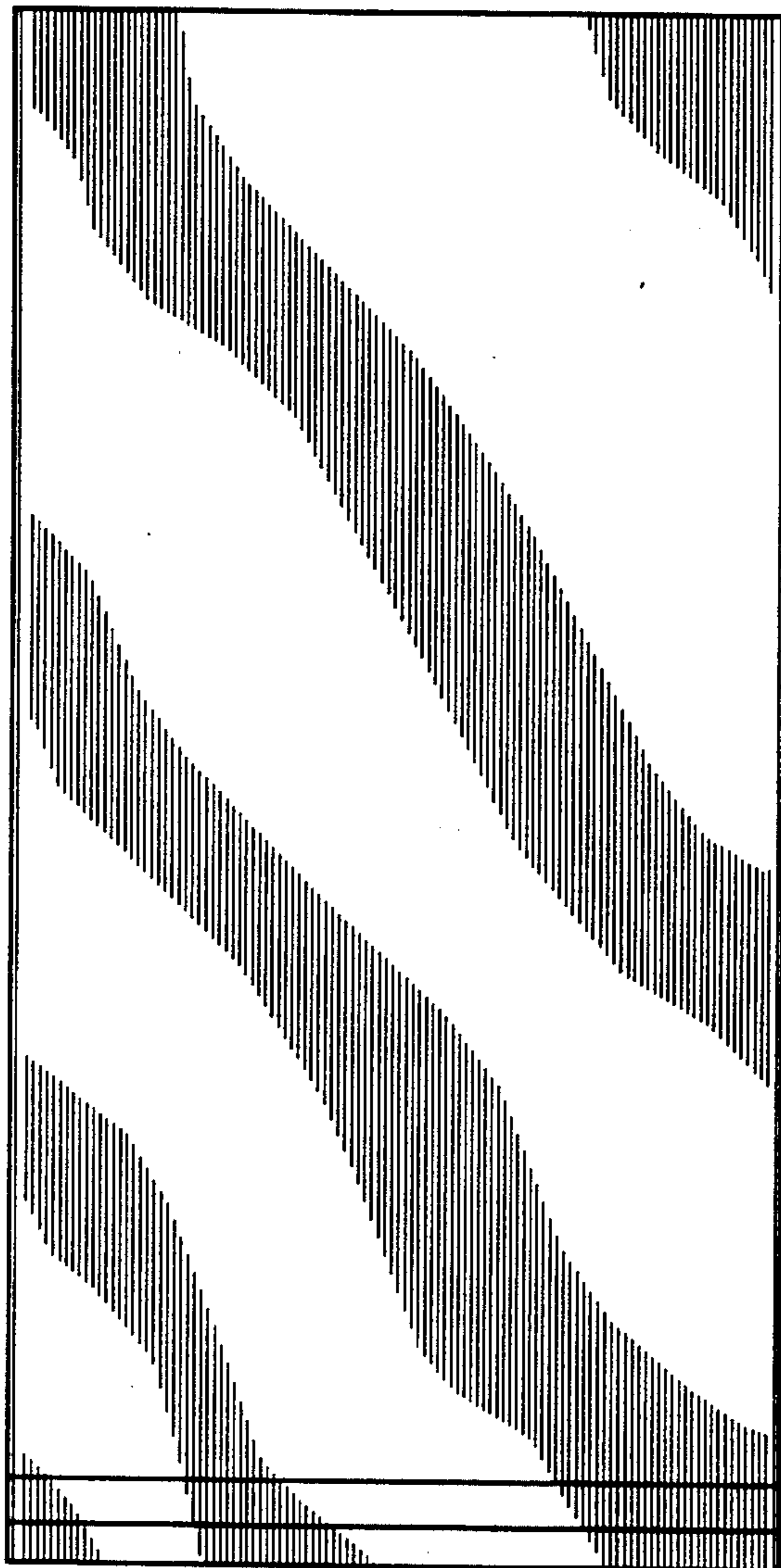
