DESCRIPTION

FIG. 1 is a top plan view of the left jaw of a pair of tool jaws to form salad dressing pouches showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is top plan view of the right jaw of the pair of jaws to form salad dressing pouches;
FIG. 7 is a front elevational view thereof;
FIG. 8 is a right side elevational view thereof;
FIG. 9 is a rear elevational view thereof;
FIG. 10 is a bottom plan view thereof; and,
FIG. 11 is a top, left side perspective view of the pair of jaws to form salad dressing pouches.
The tool jaws in FIGS. 1-10 are shown independently of the pair for clarity of illustration.

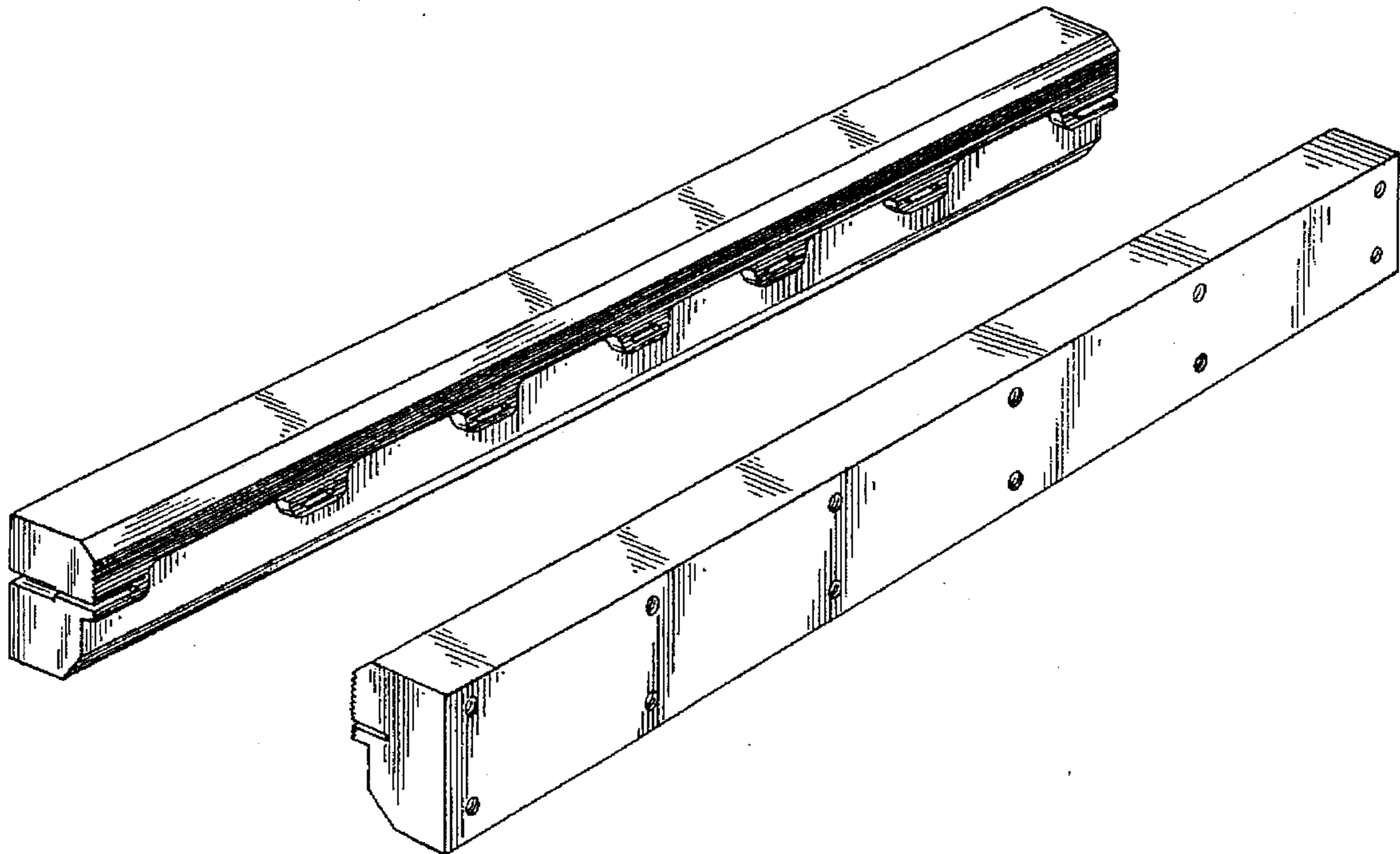

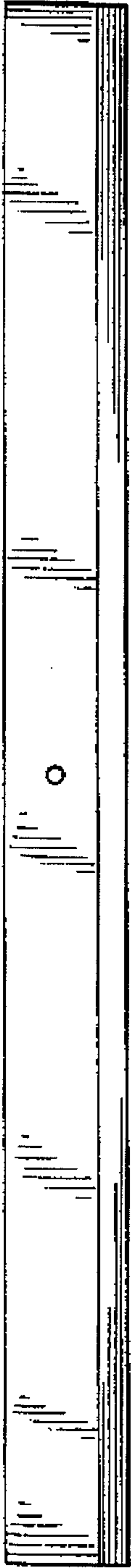

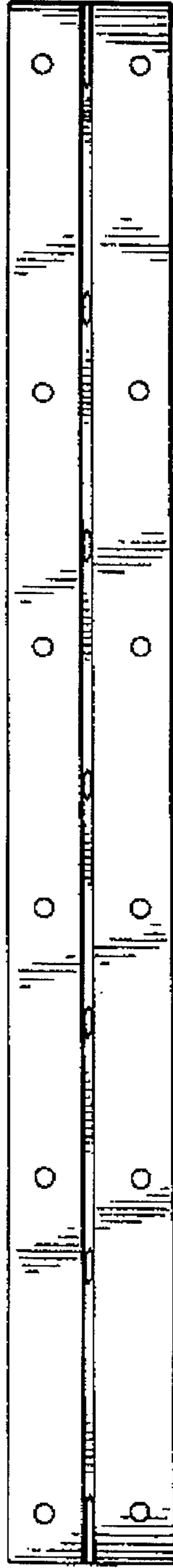

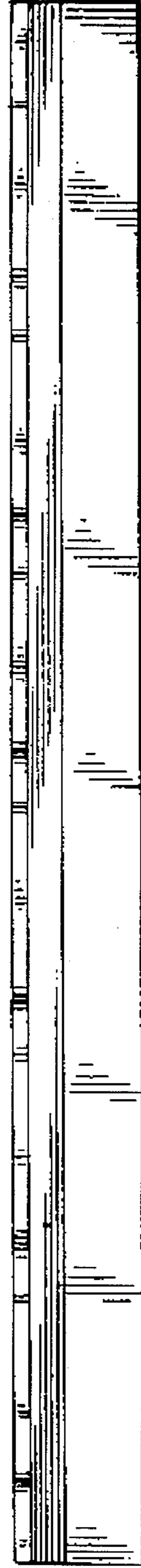

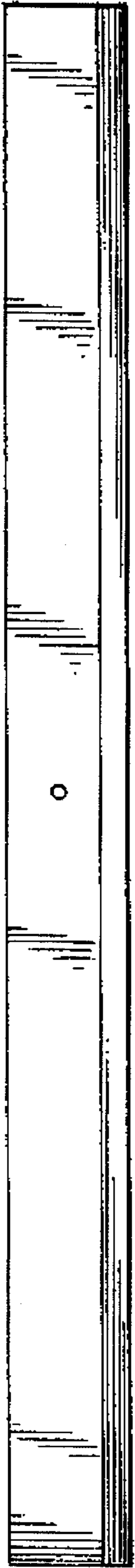

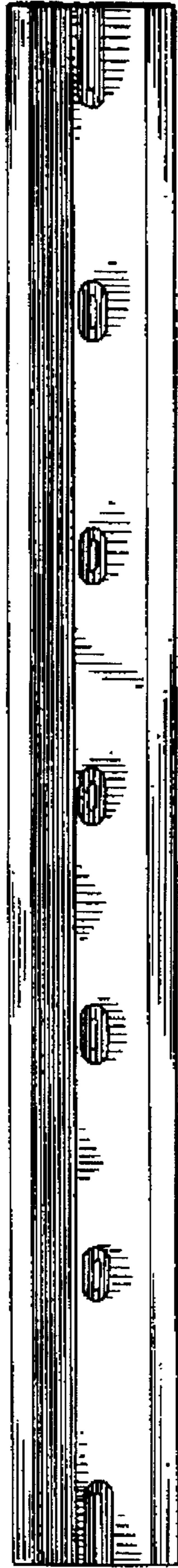

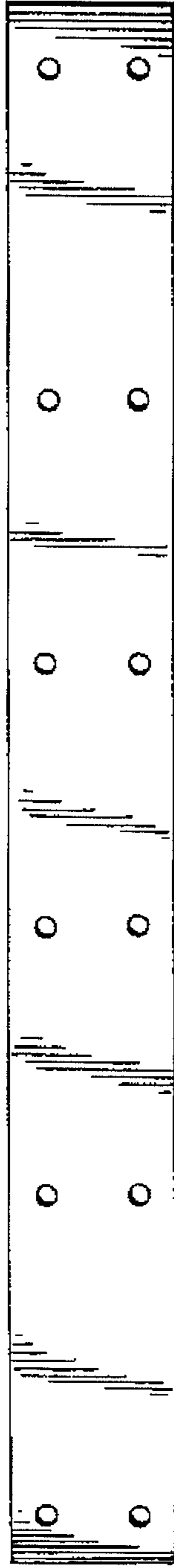
