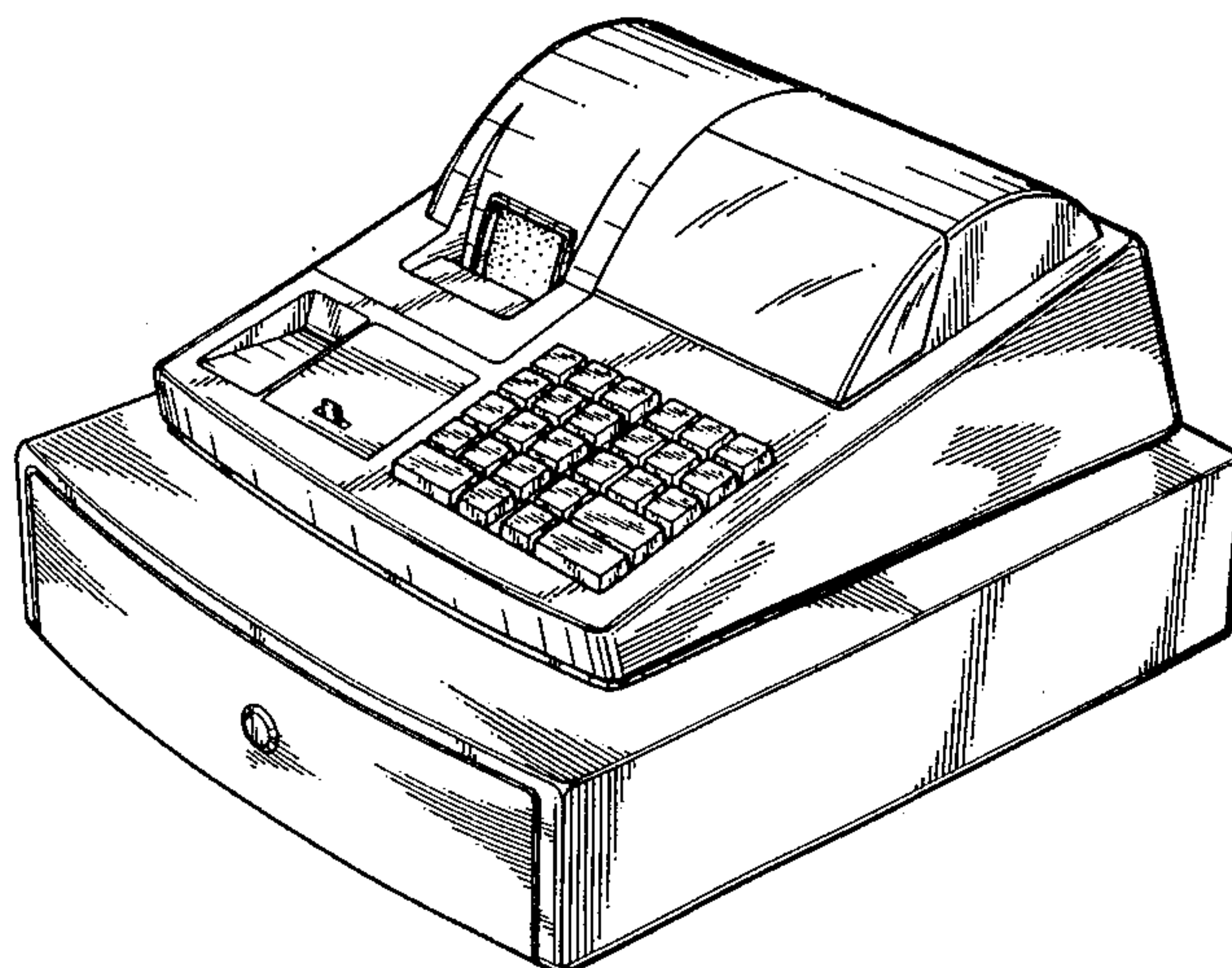
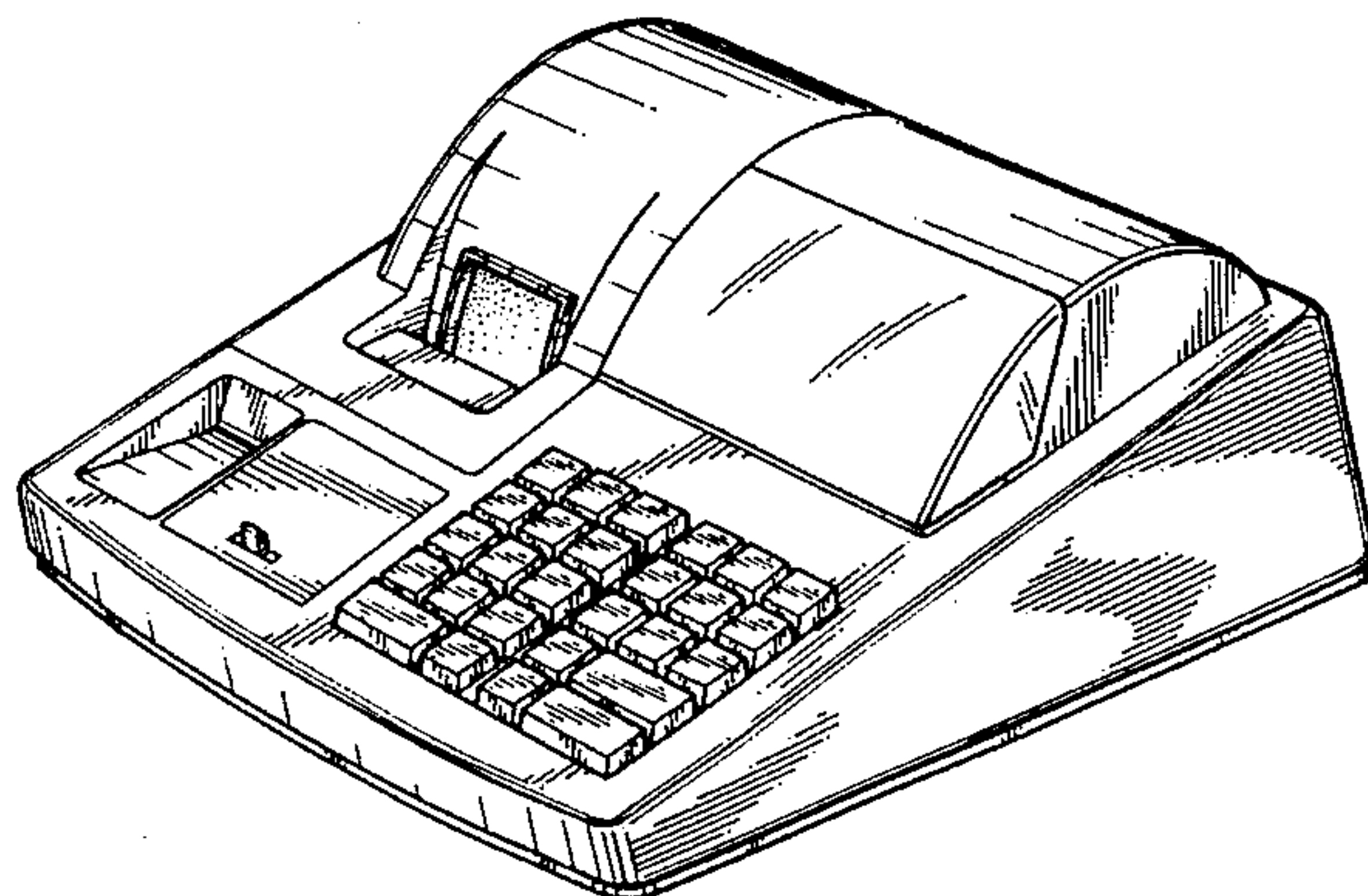
[57] **CLAIM**

The ornamental design for a cash register, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a cash register according to our design; FIG. 2 is a front elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a rear elevational view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a view similar to FIG. 1 illustrating a second embodiment of the cash register of FIGS. 1-7; FIG. 9 is a front elevational view thereof; FIG. 10 is a top plan view thereof; FIG. 11 is a right side elevational view thereof; FIG. 12 is a left side elevational view thereof; FIG. 13 is a rear elevational view thereof; and, FIG. 14 is a bottom plan view thereof.

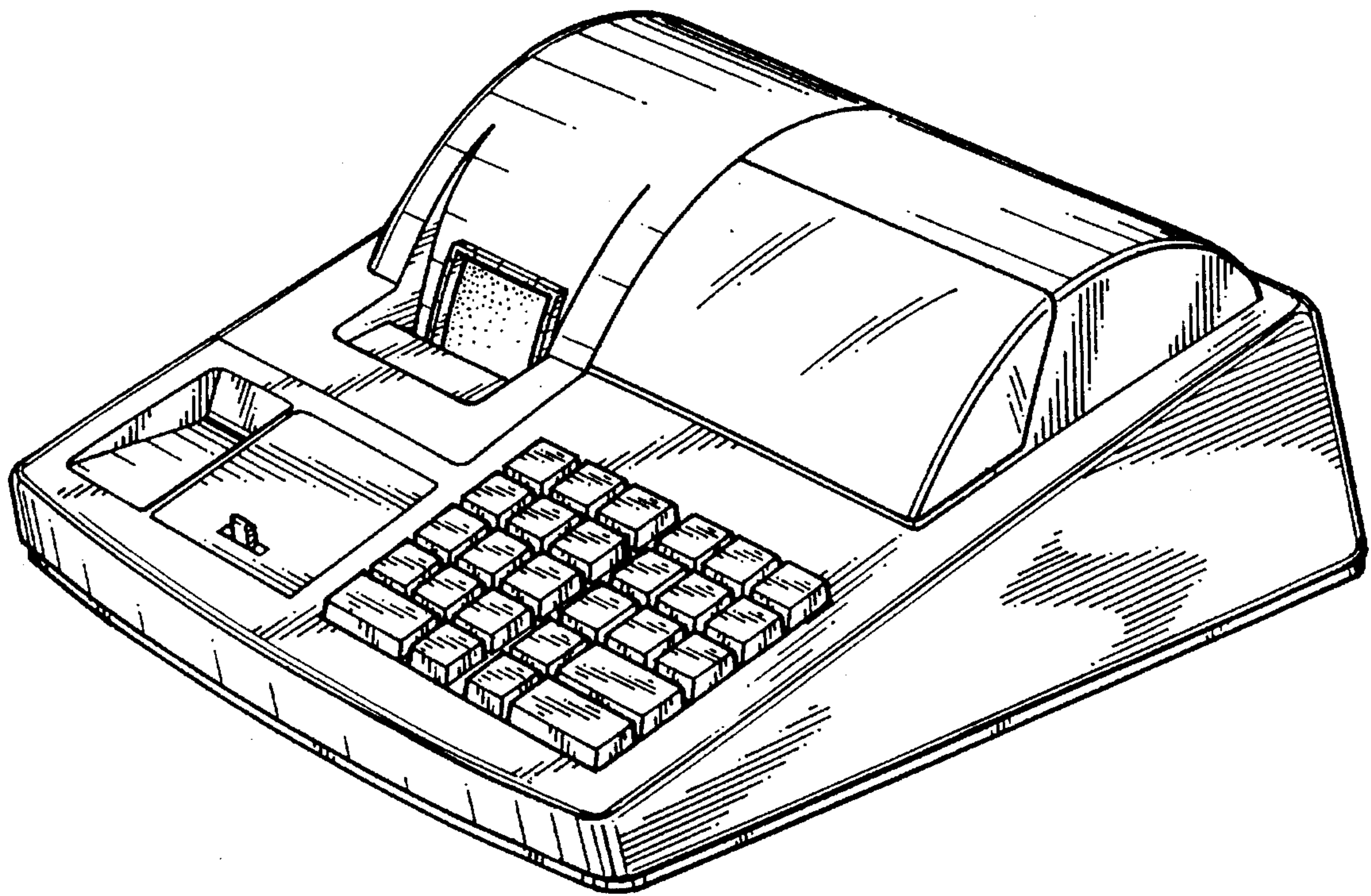

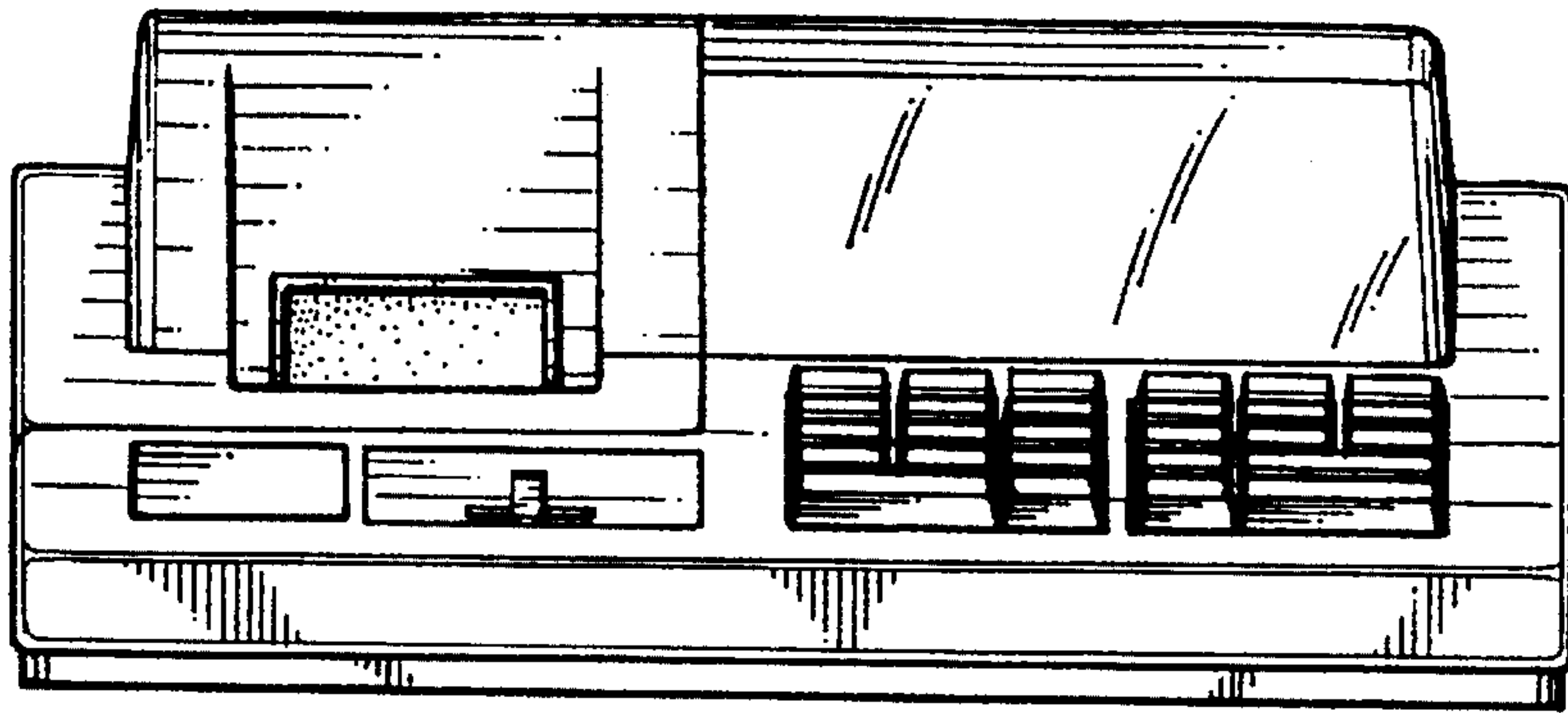

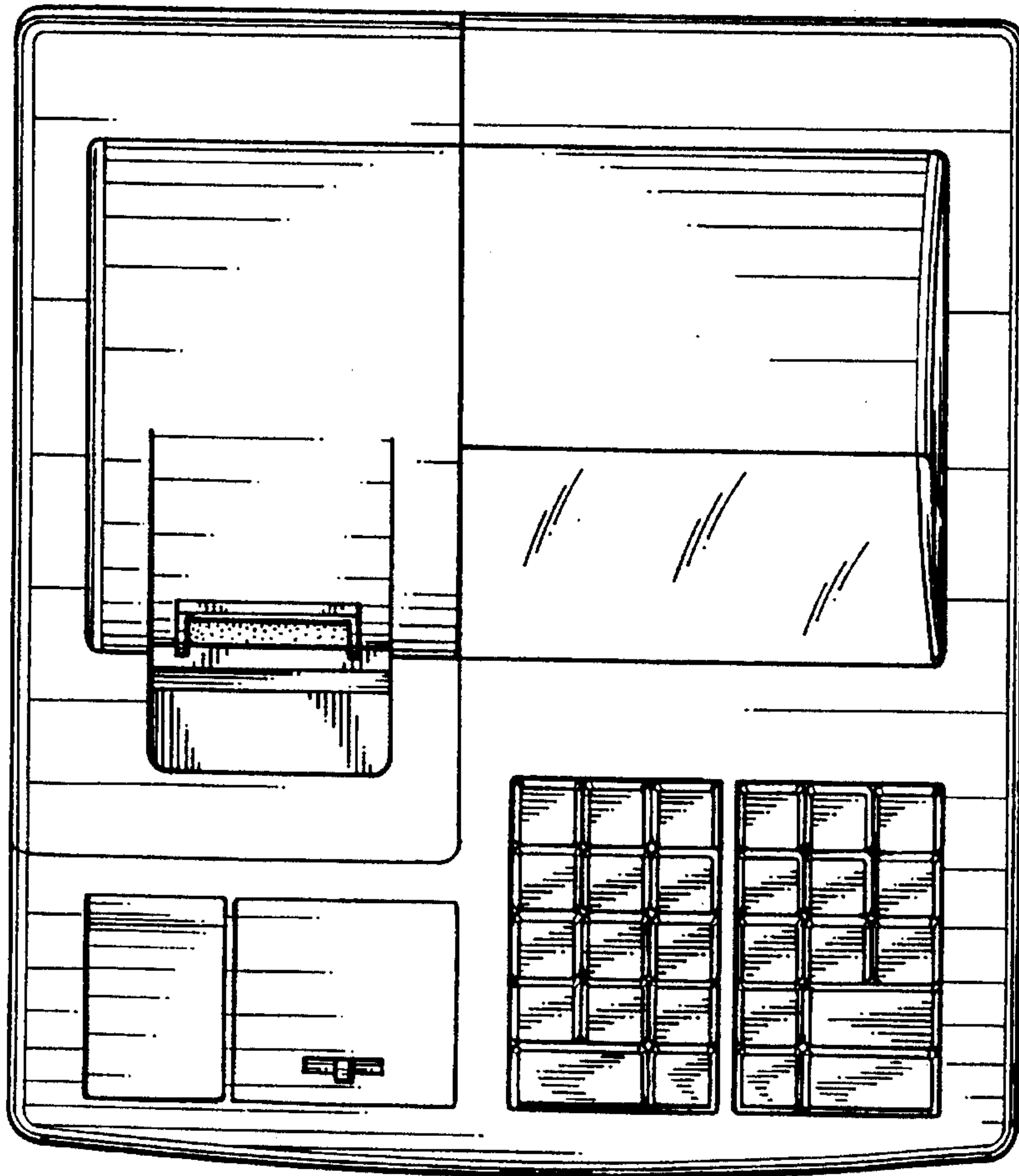

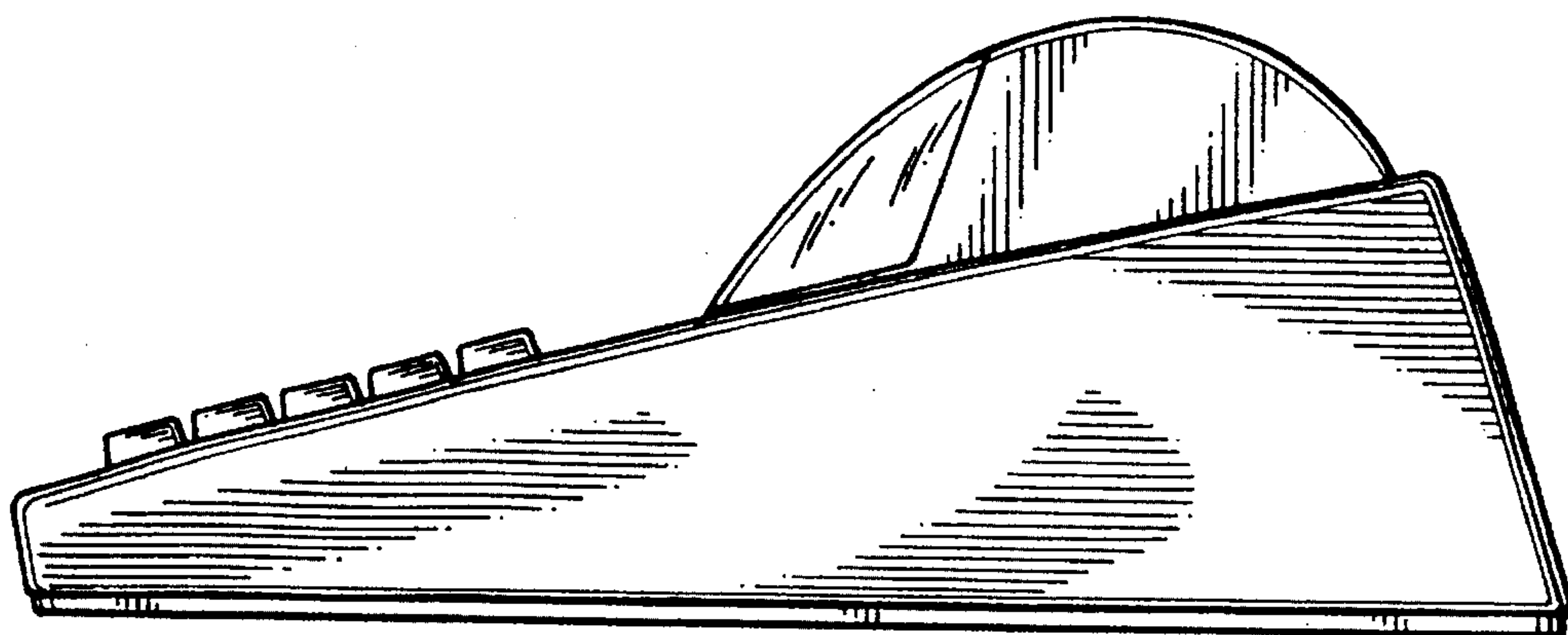

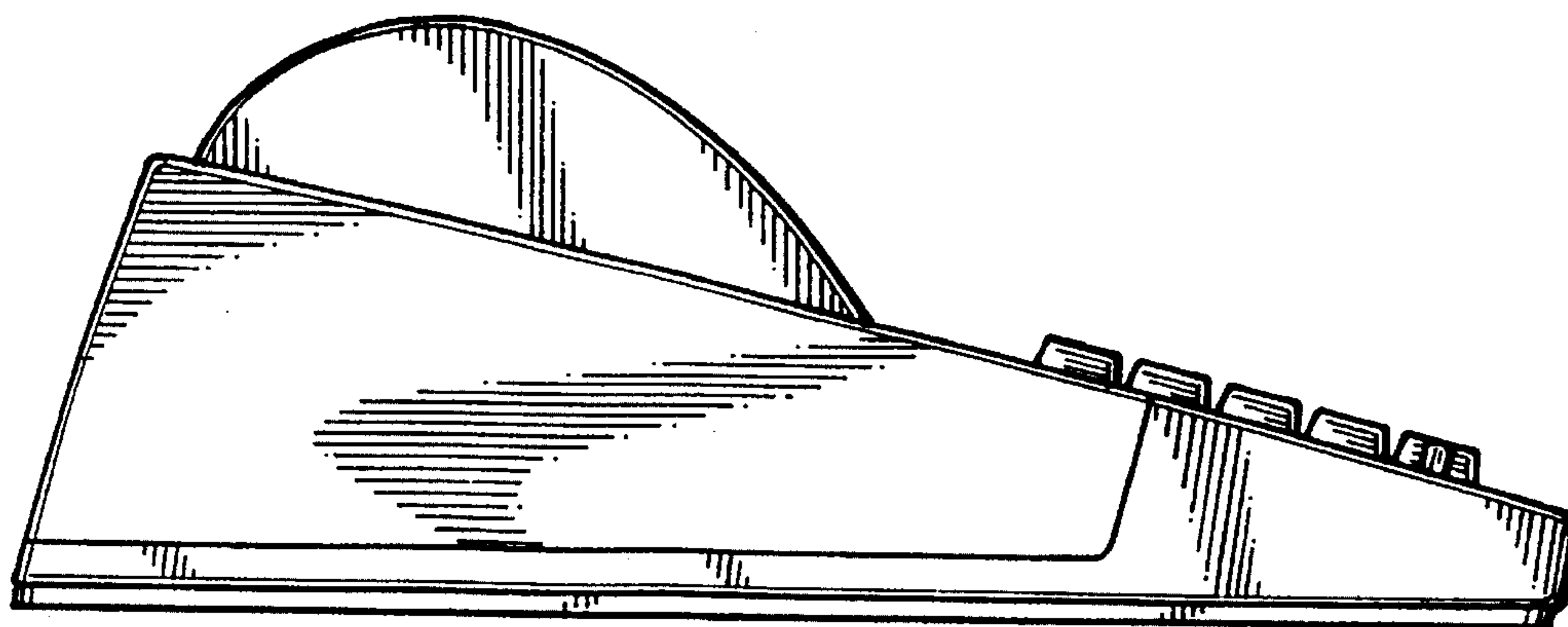

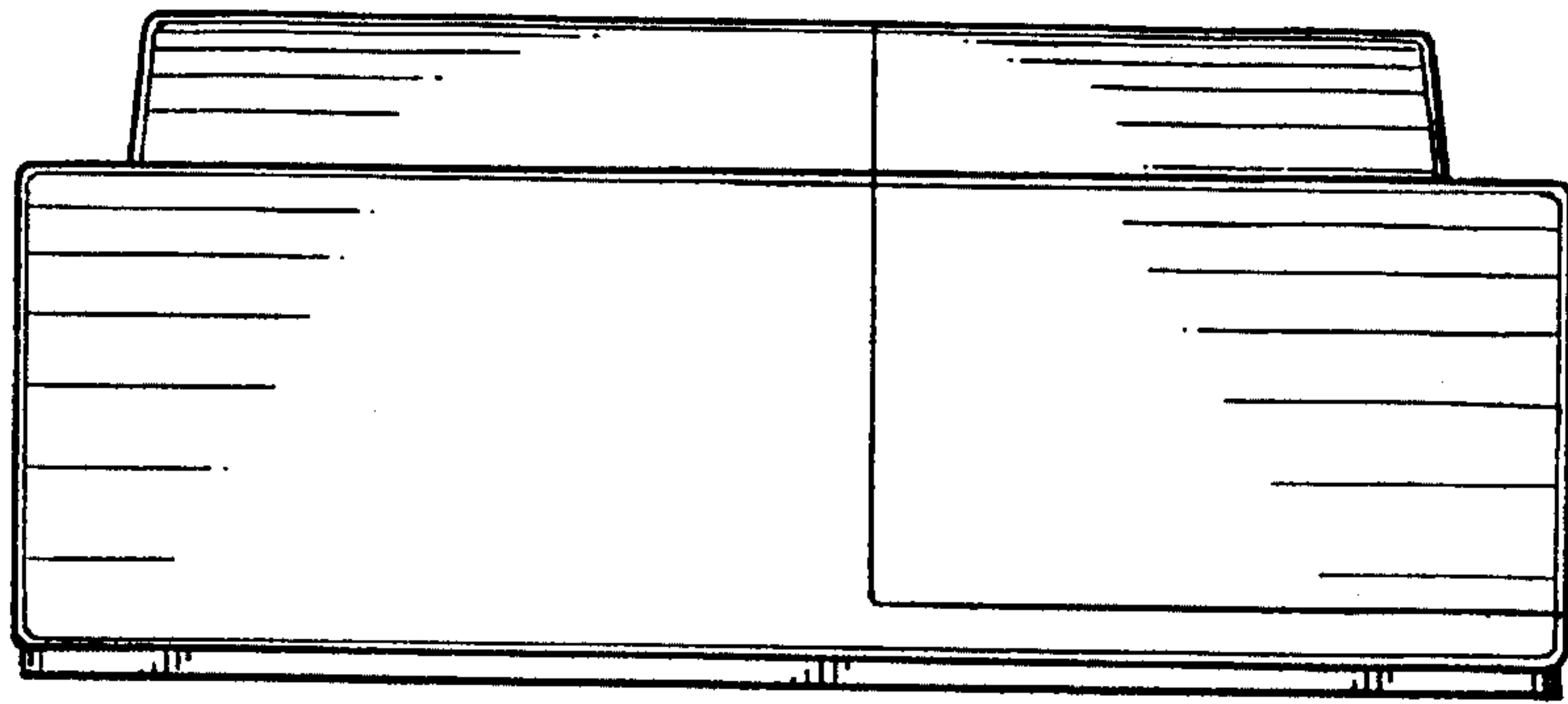

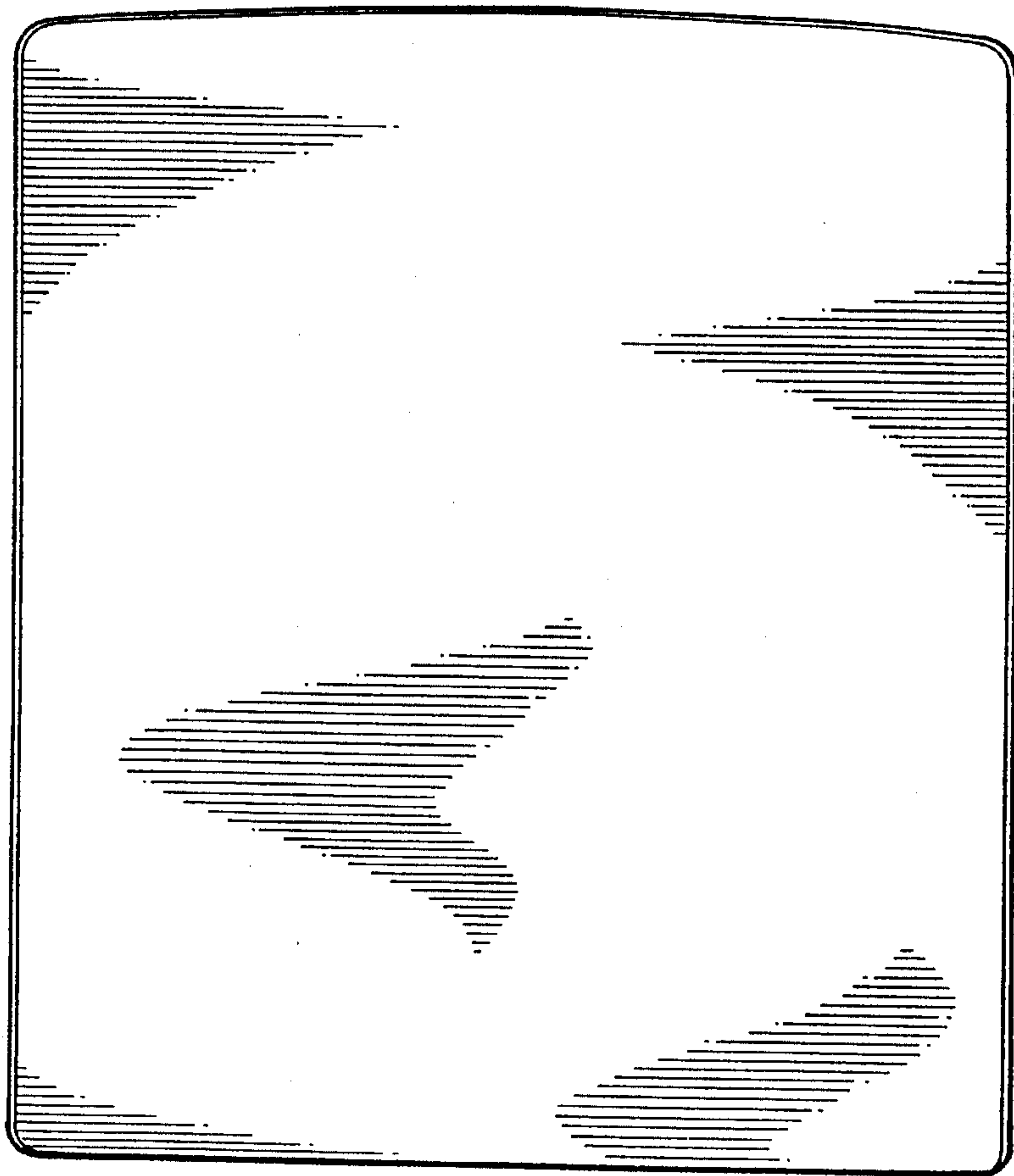

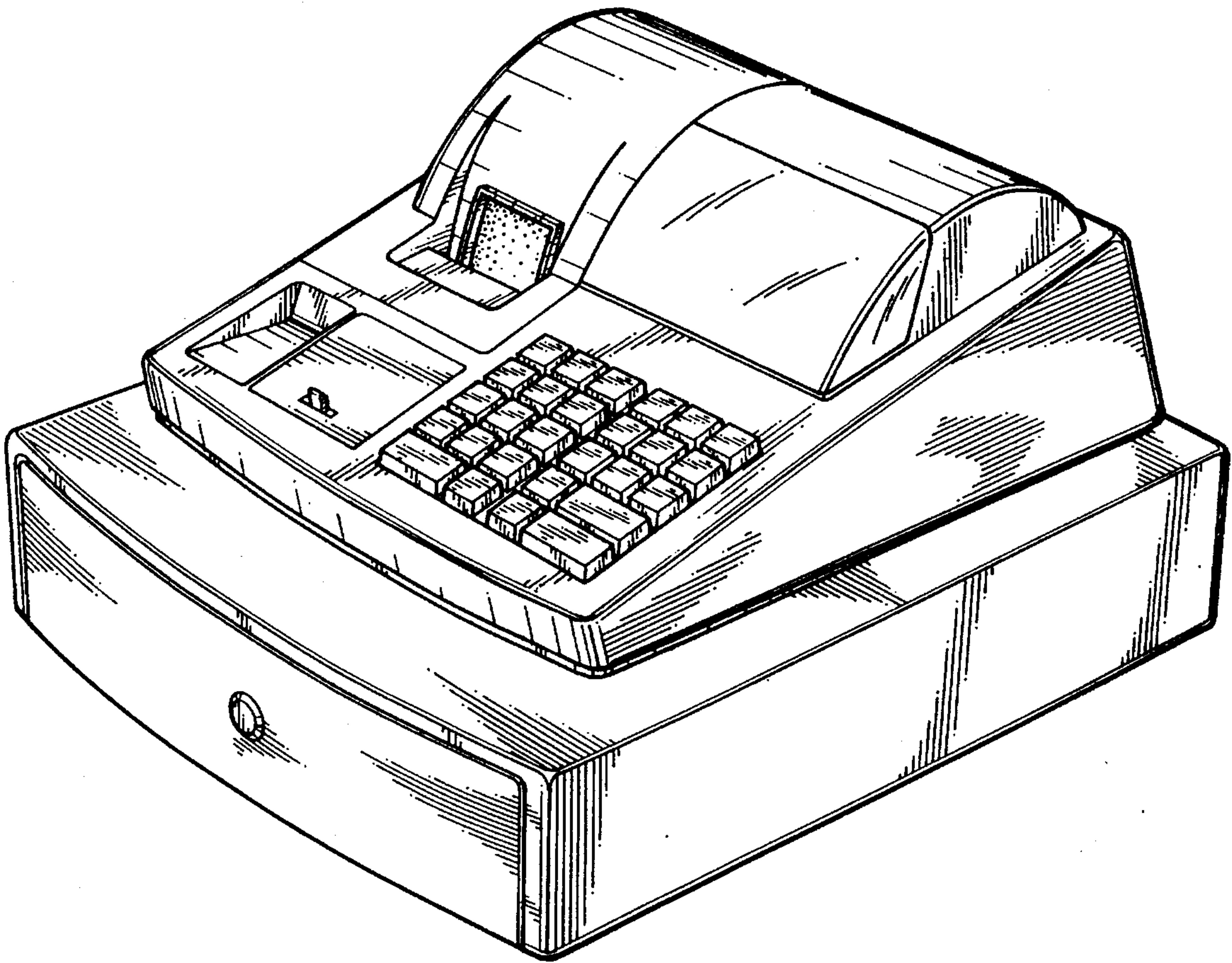

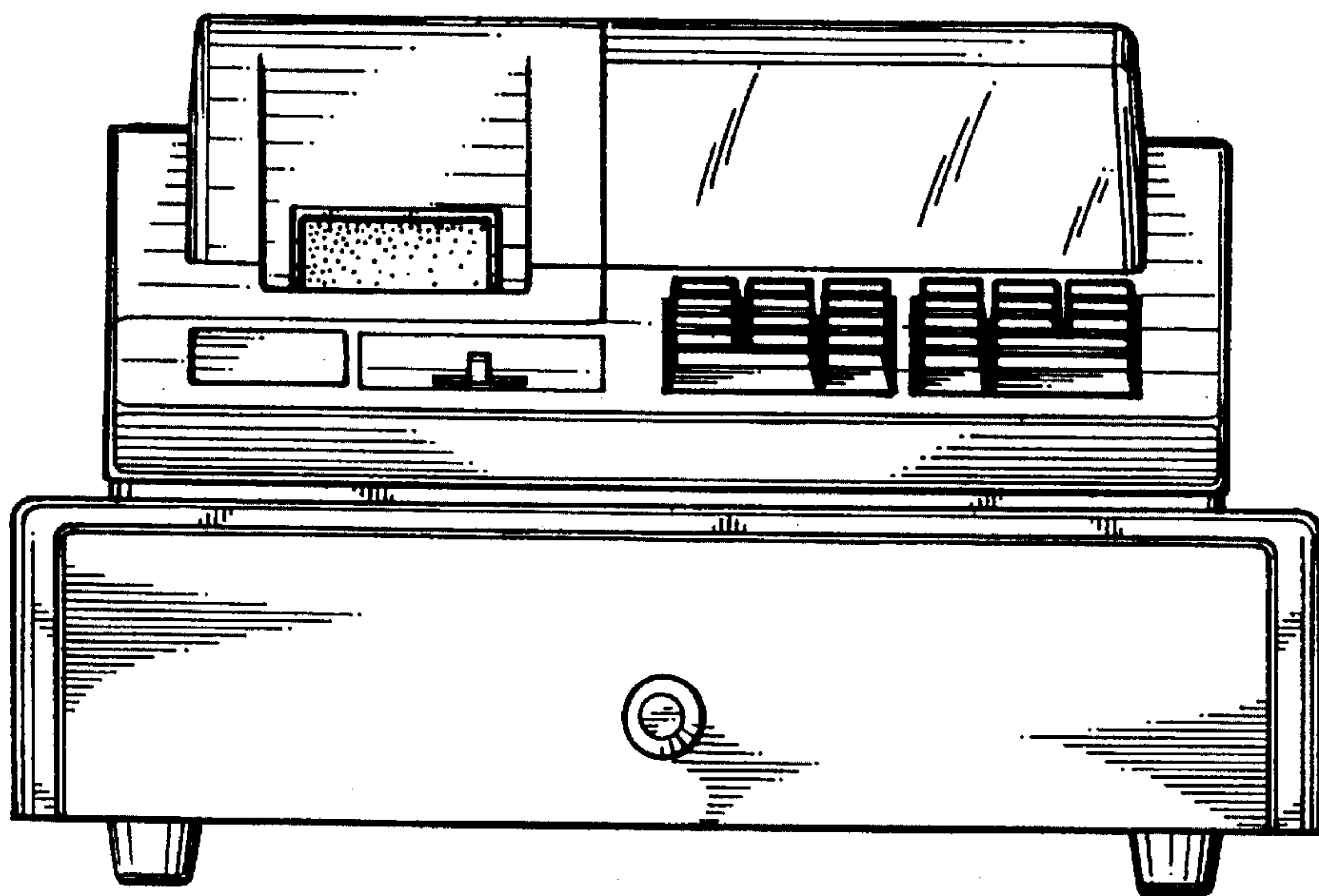
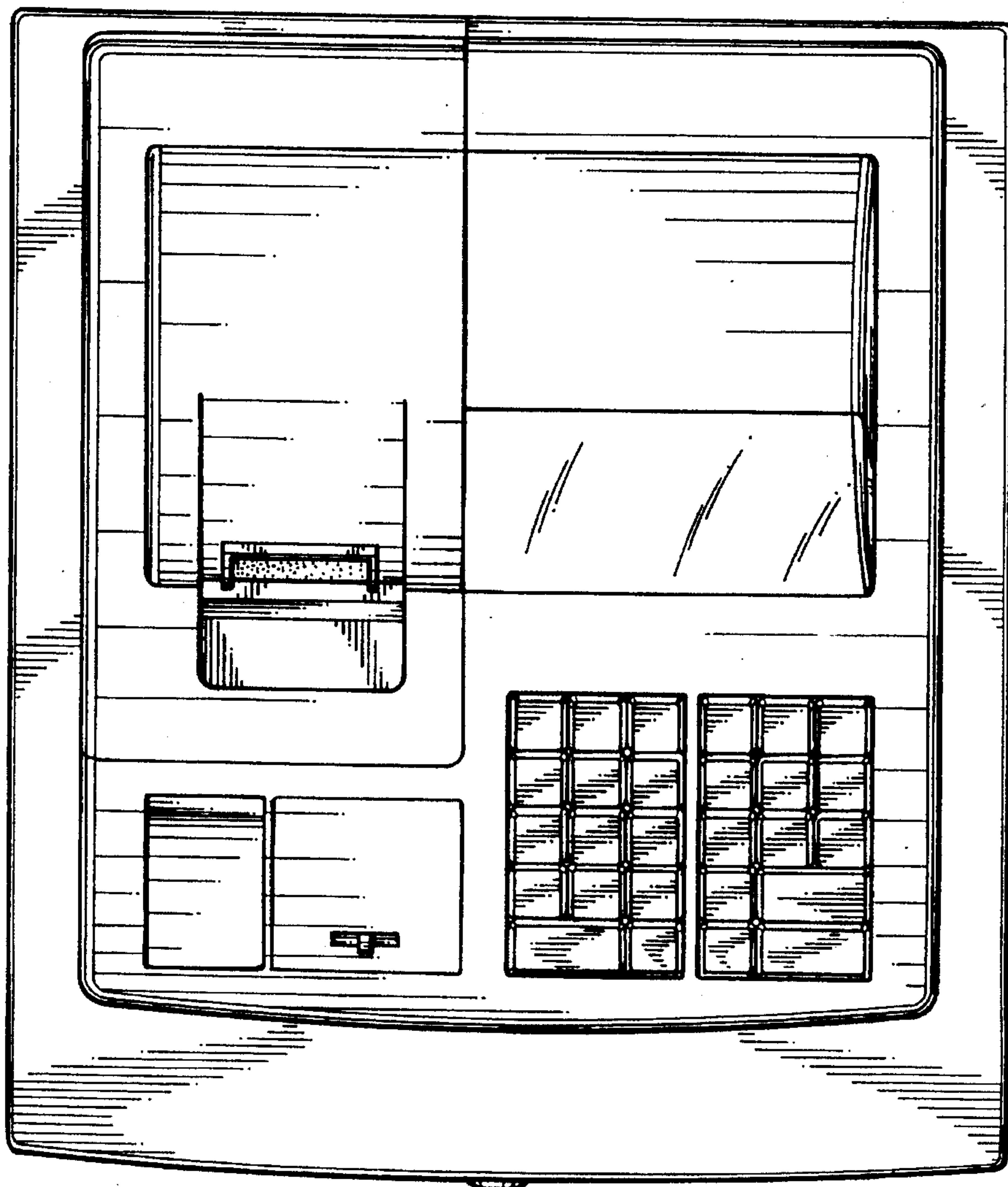

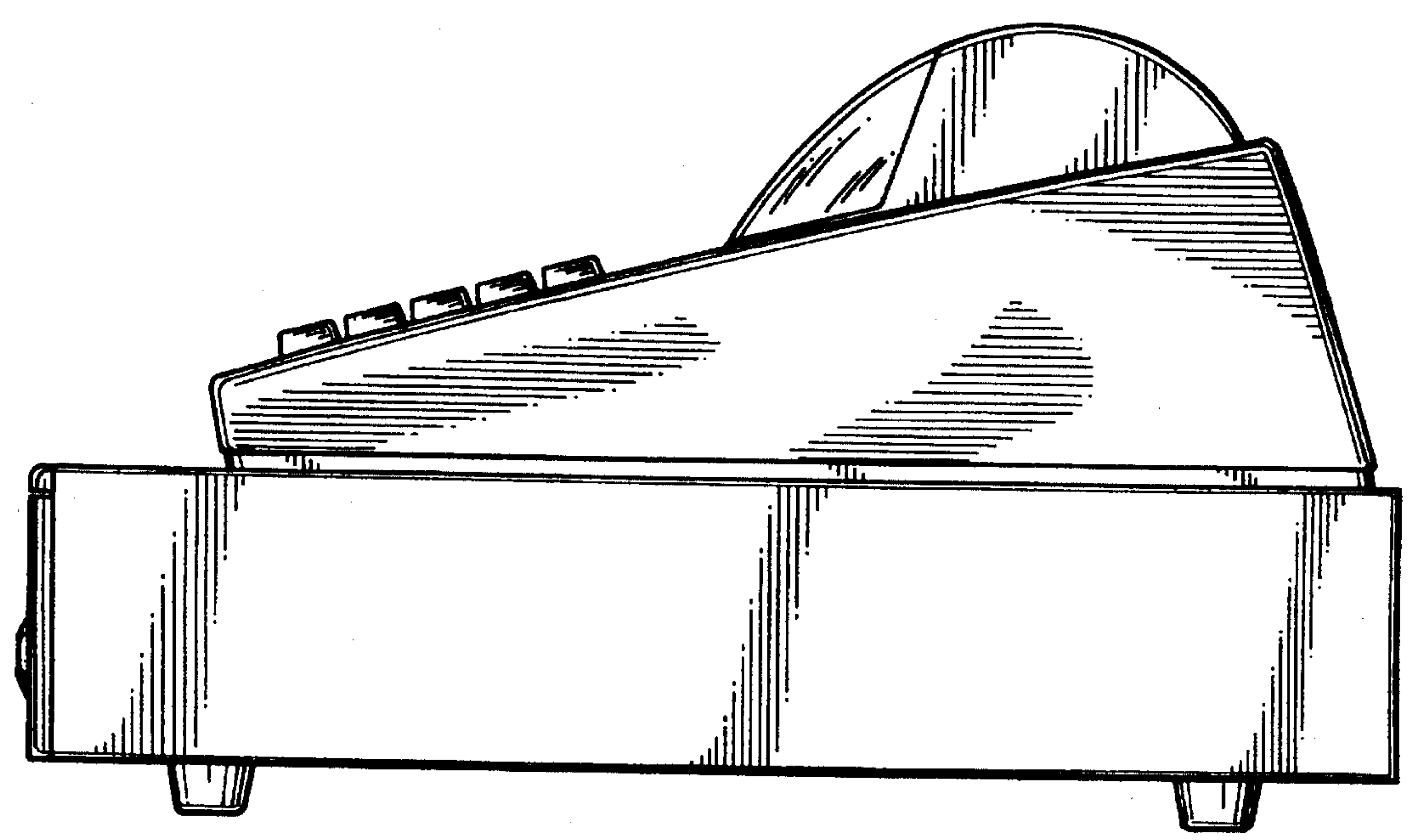

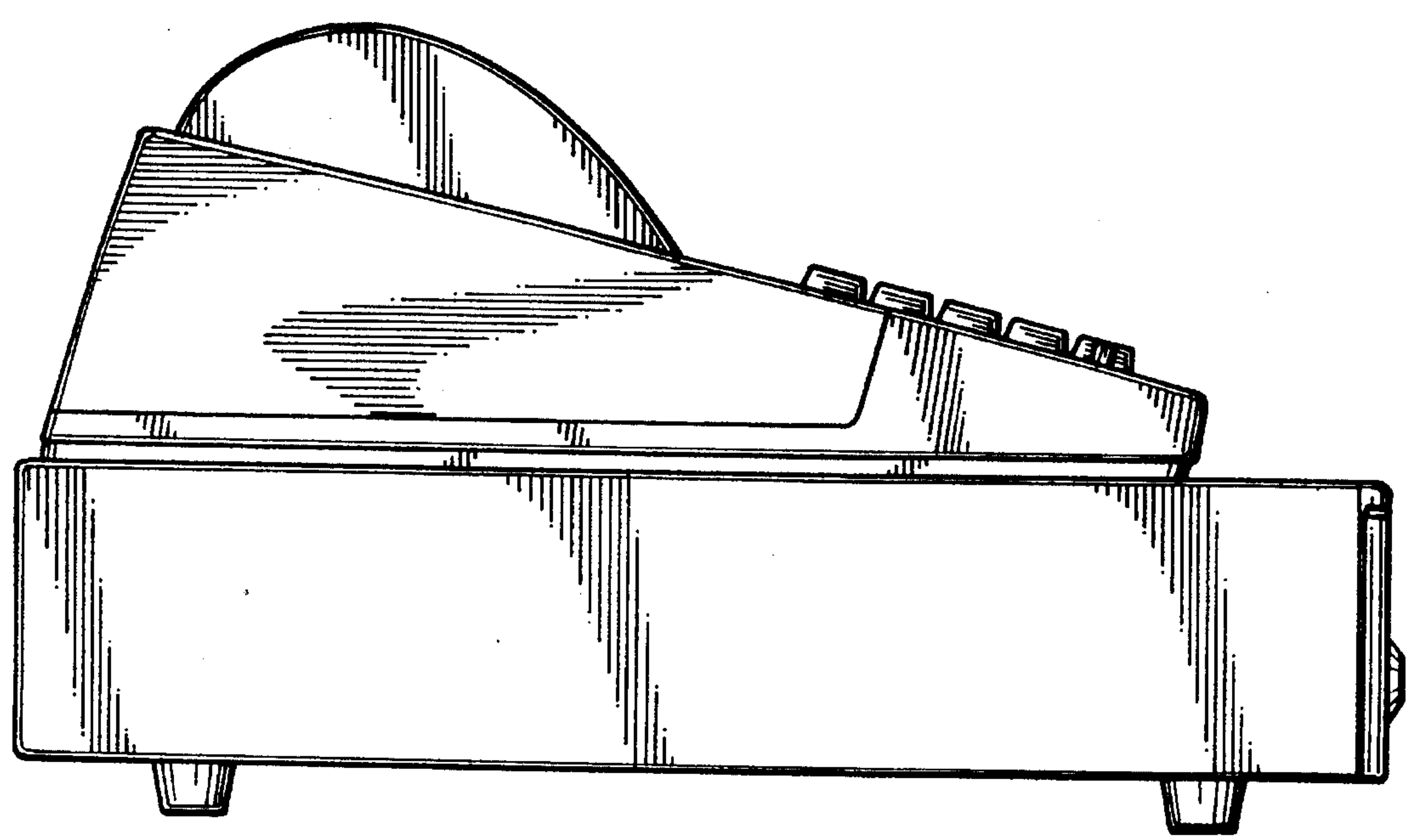

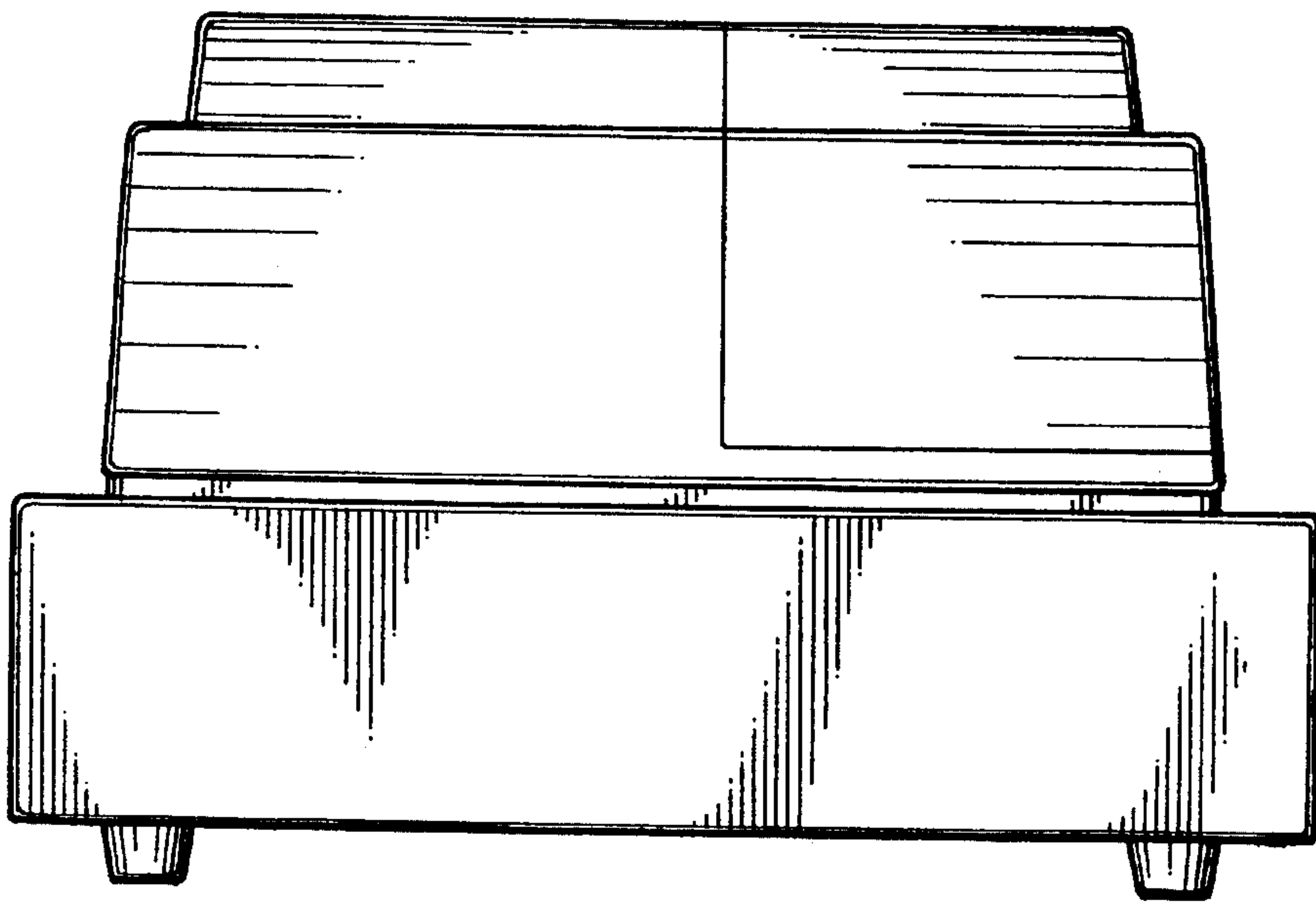

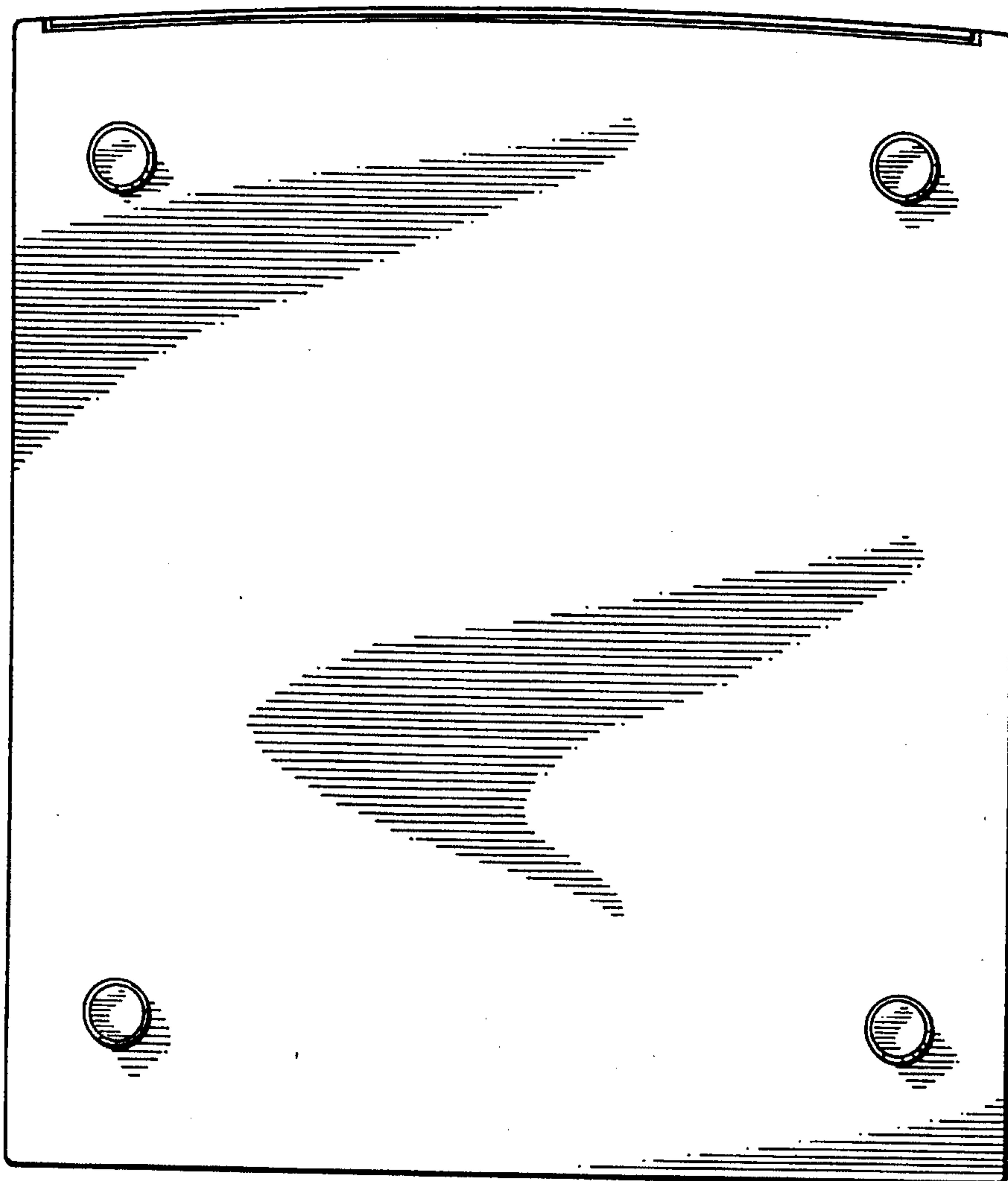
