[57] **CLAIM**

The ornamental design for a writing instrument, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of a writing instrument showing my new design;
 FIG. 2 is a side view with the cap removed thereof;
 FIG. 3 is a front elevational view;
 FIG. 4 is a rear elevational view;
 FIG. 5 is a right side elevational view thereof;
 FIG. 6 is a left side elevational view thereof;
 FIG. 7 is a bottom plan view thereof;
 FIG. 8 is a top plan view thereof;
 FIG. 9 is a front isometric view of an alternative embodiment of a writing instrument showing my new design;
 FIG. 10 is a side view of the writing instrument with the cap removed;
 FIG. 11 is a front elevational view thereof;
 FIG. 12 is a rear elevational view thereof;
 FIG. 13 is a right side elevational view thereof;
 FIG. 14 is a left side elevational view thereof;
 FIG. 15 is a bottom plan view thereof; and,
 FIG. 16 is a top plan view thereof.

The characteristic feature of the design resides in the particularly configured clip member in combination with the writing instrument body shown, as best illustrated in FIGS. 1 and 9.

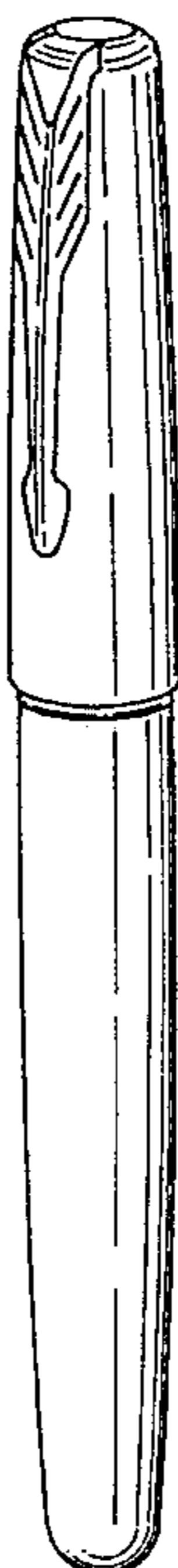

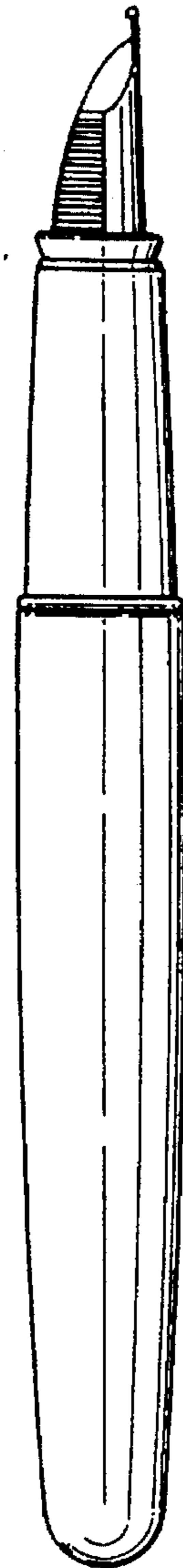
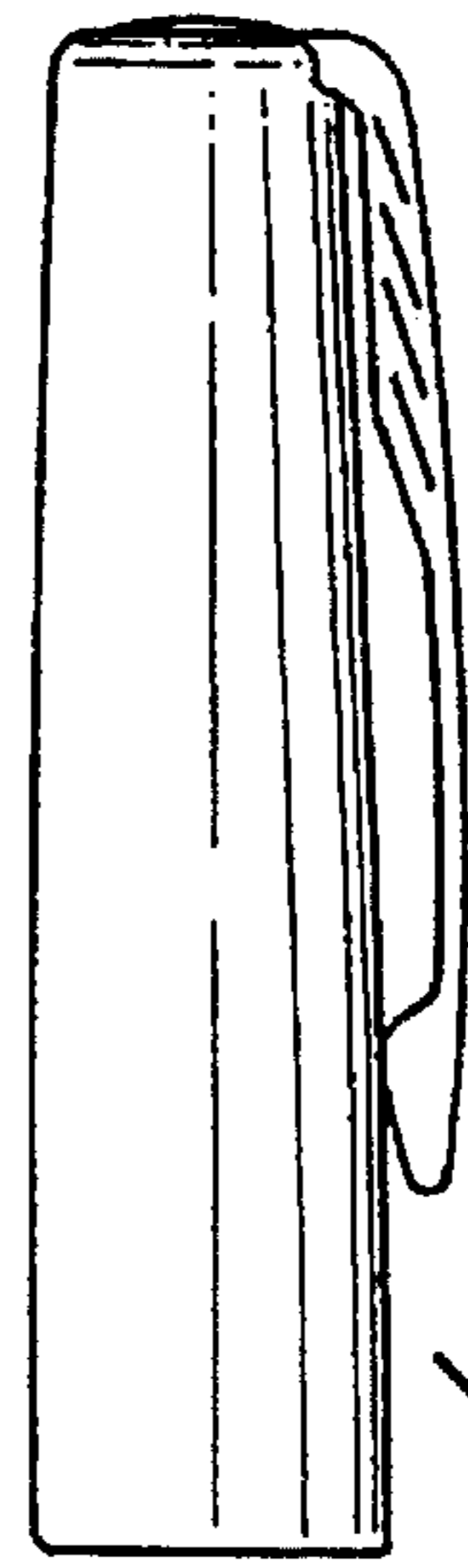
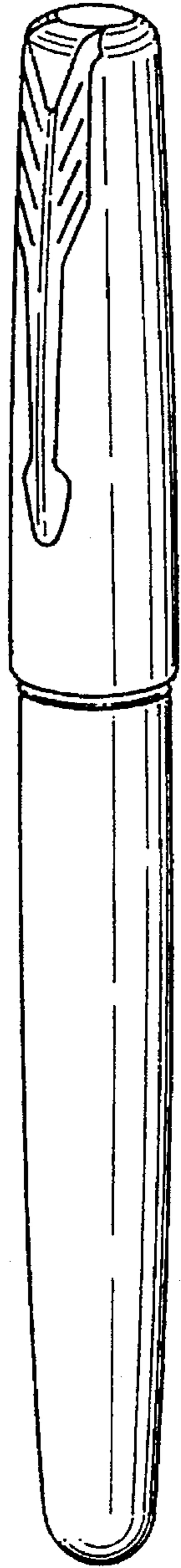

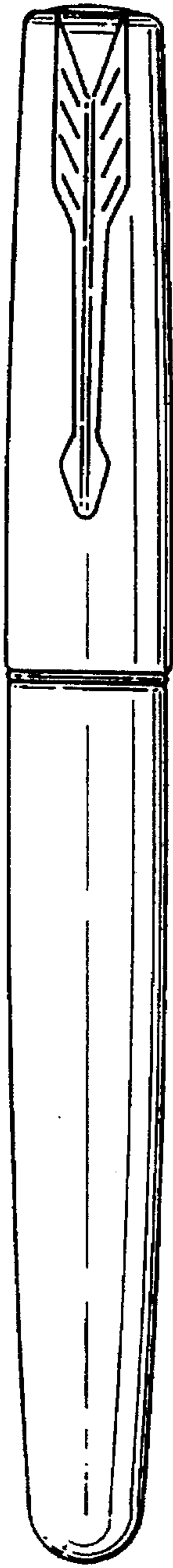

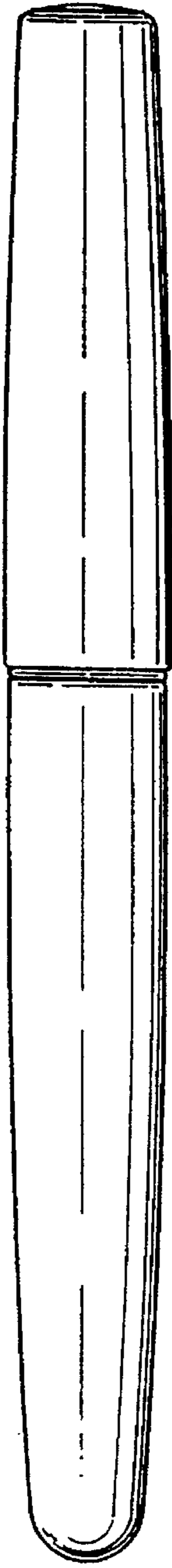

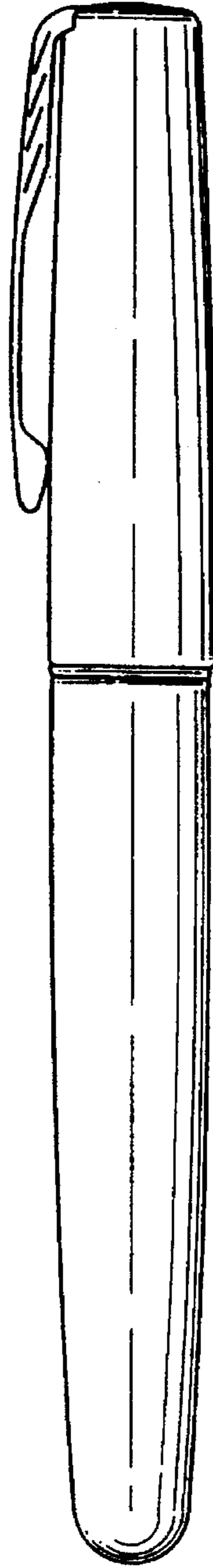

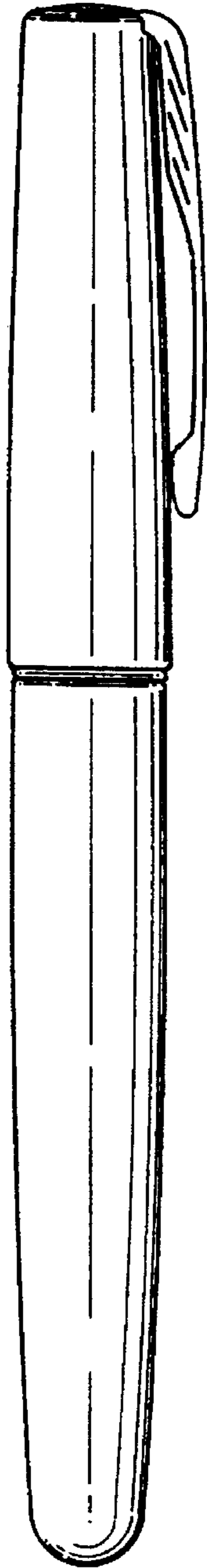

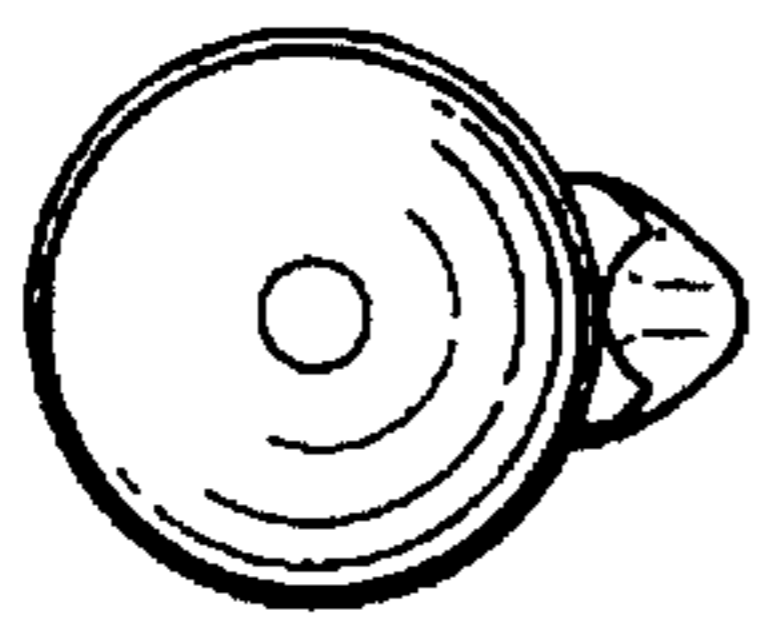

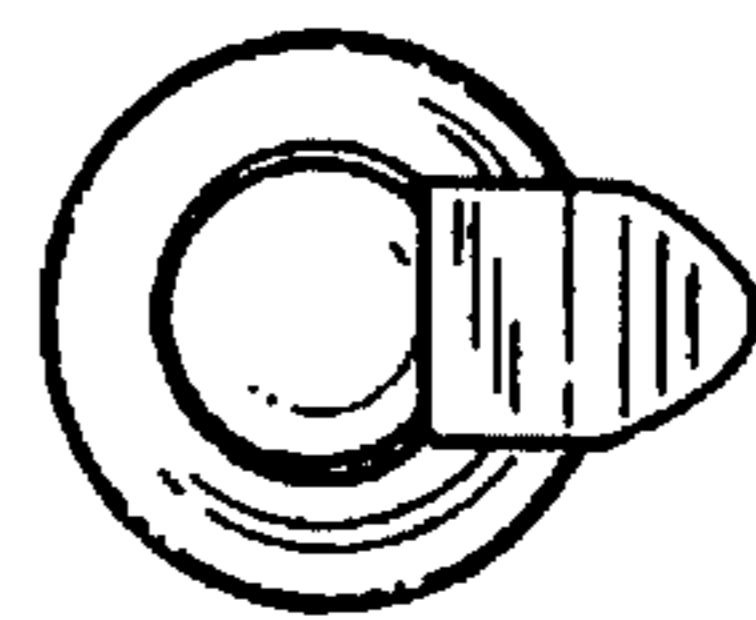

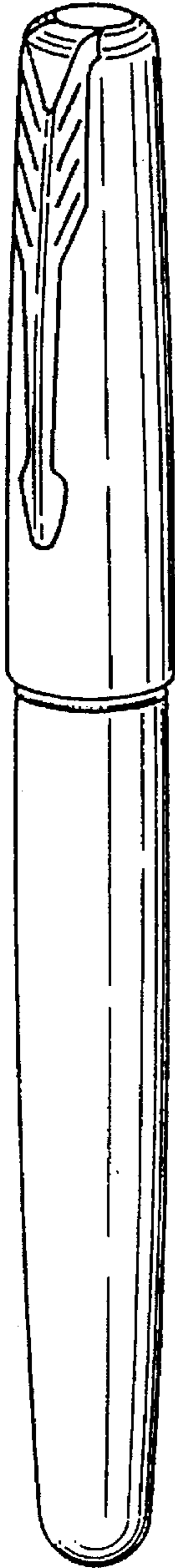
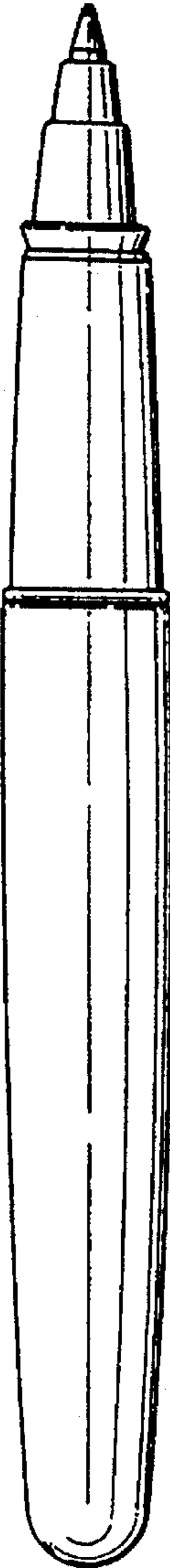

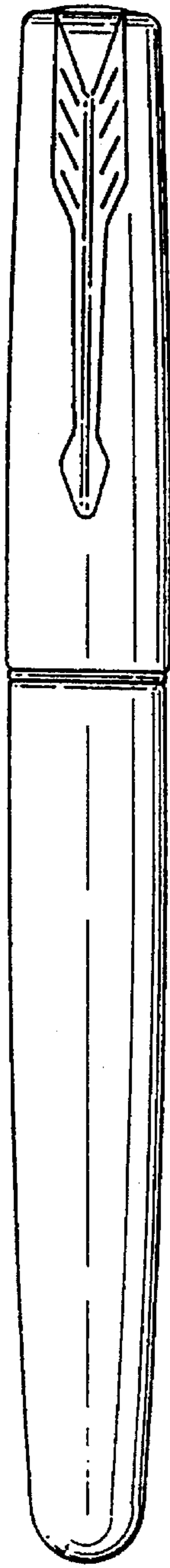

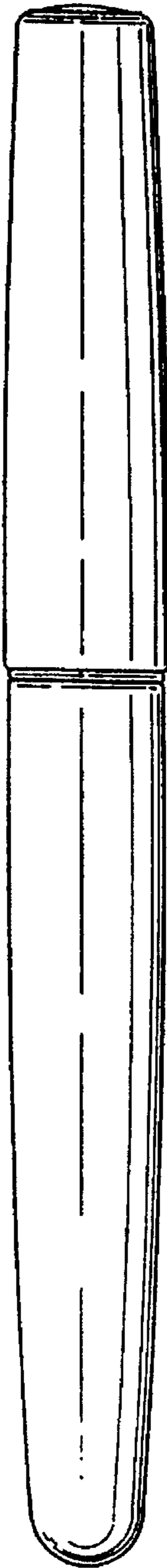

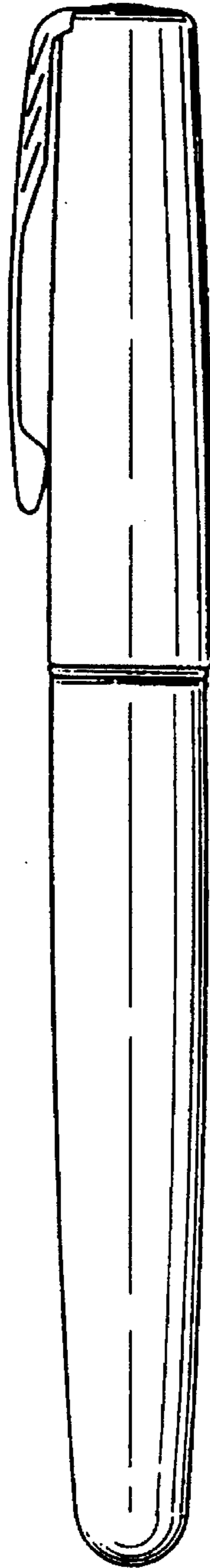

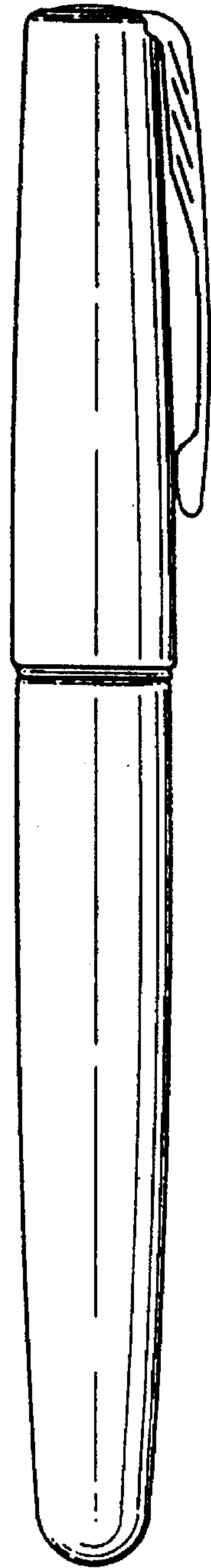

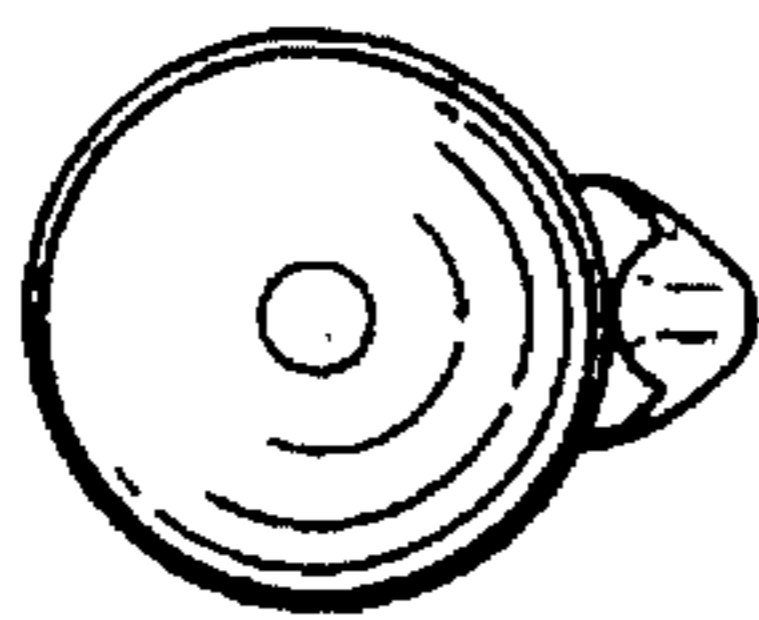

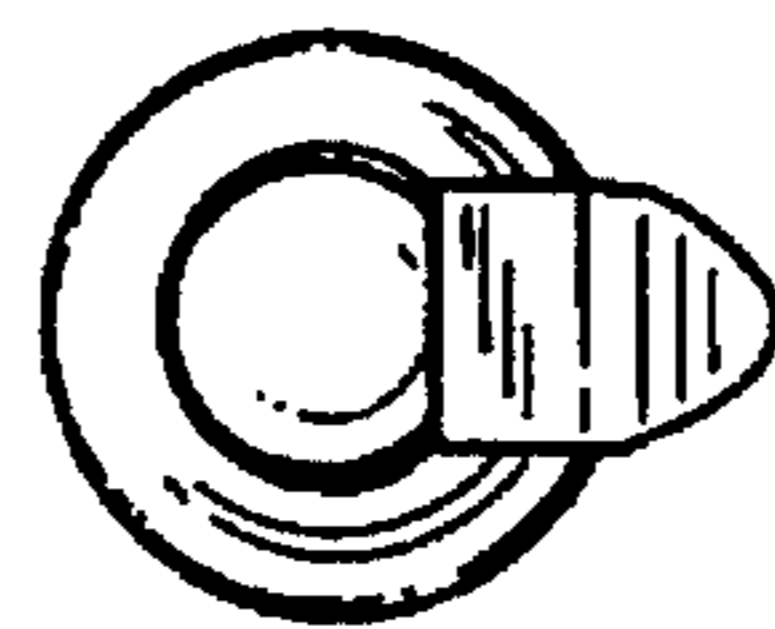
