The ornamental design for a two-partitions hand-bag, as shown.

DESCRIPTION

FIG. 1 is a perspective view of two-partitions hand-bag embodying my new design;
FIG. 2 is a perspective view in the open position;
FIG. 3 is a front elevational view;
FIG. 4 is a rear elevational view;
FIG. 5 is a side elevational view taken from the left in FIG. 3;
FIG. 6 is a side elevational view taken from the right in FIG. 3;
FIG. 7 is a top view; and,

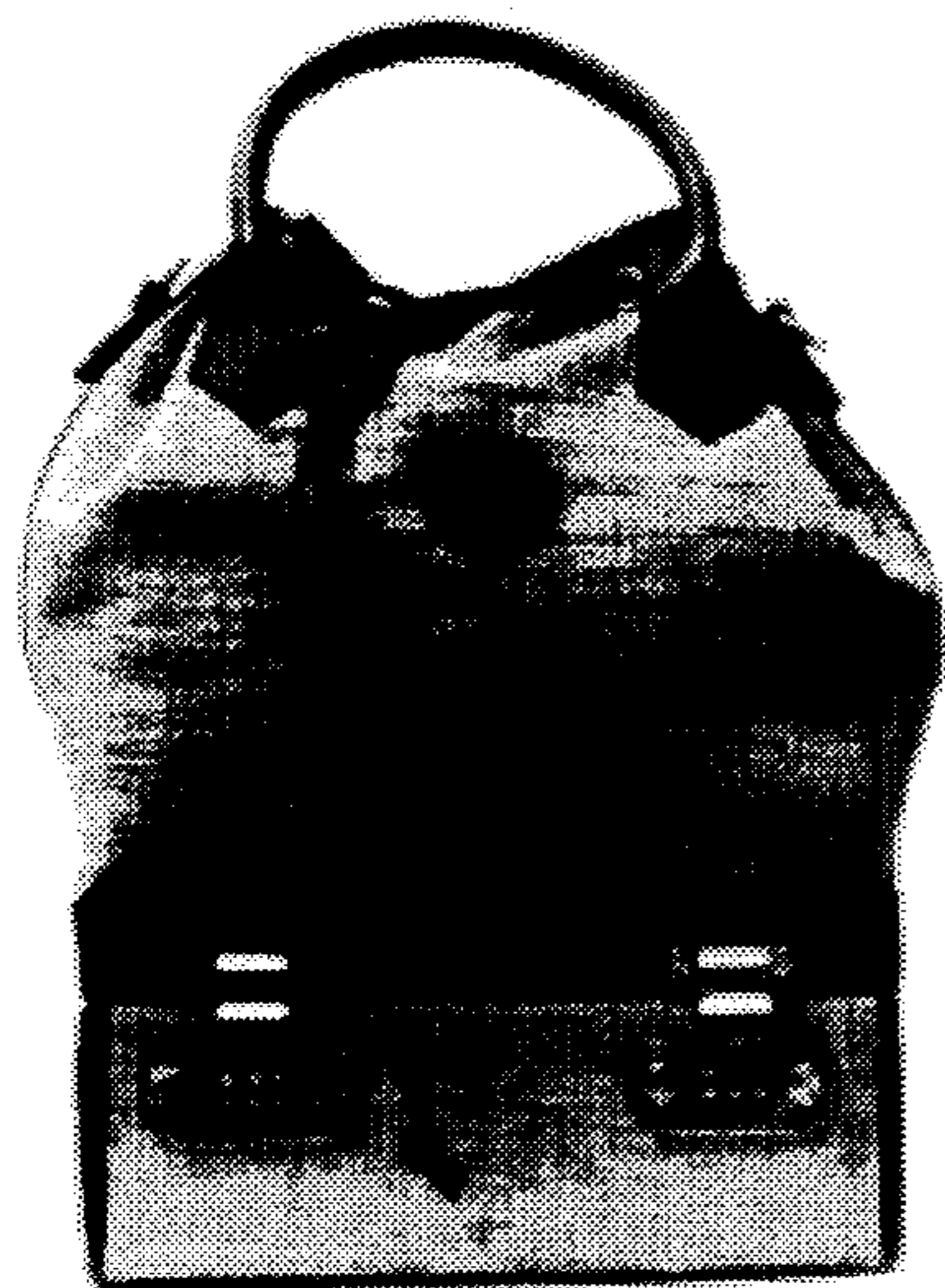

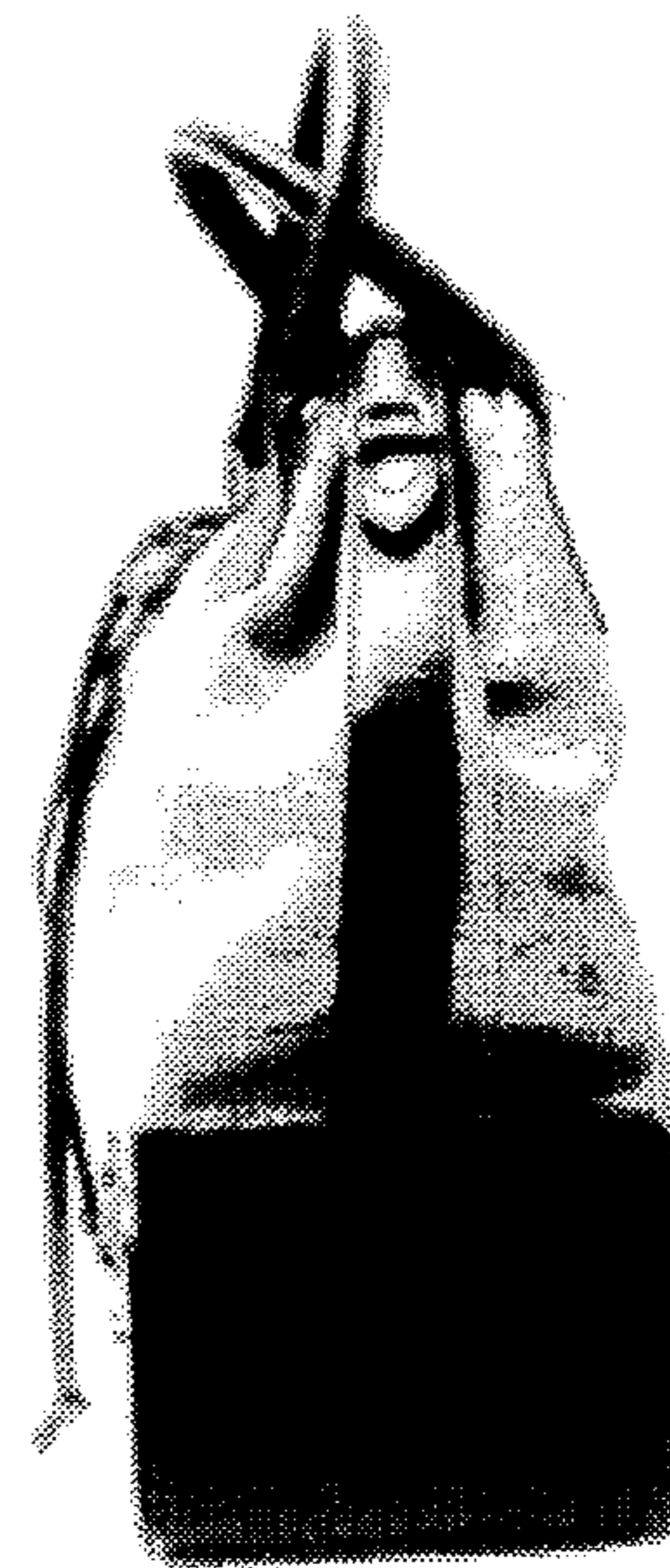

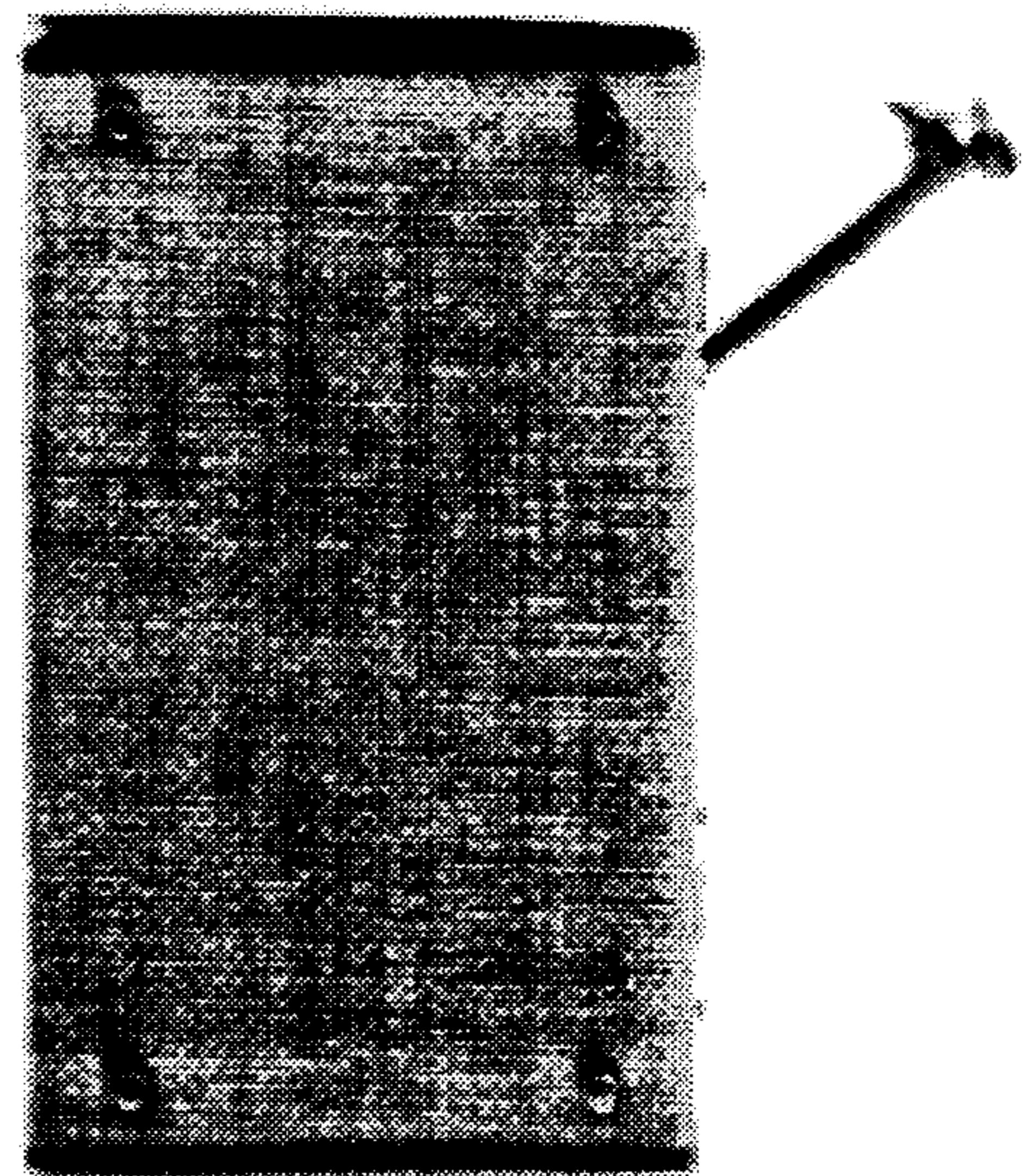
