### [57] CLAIM

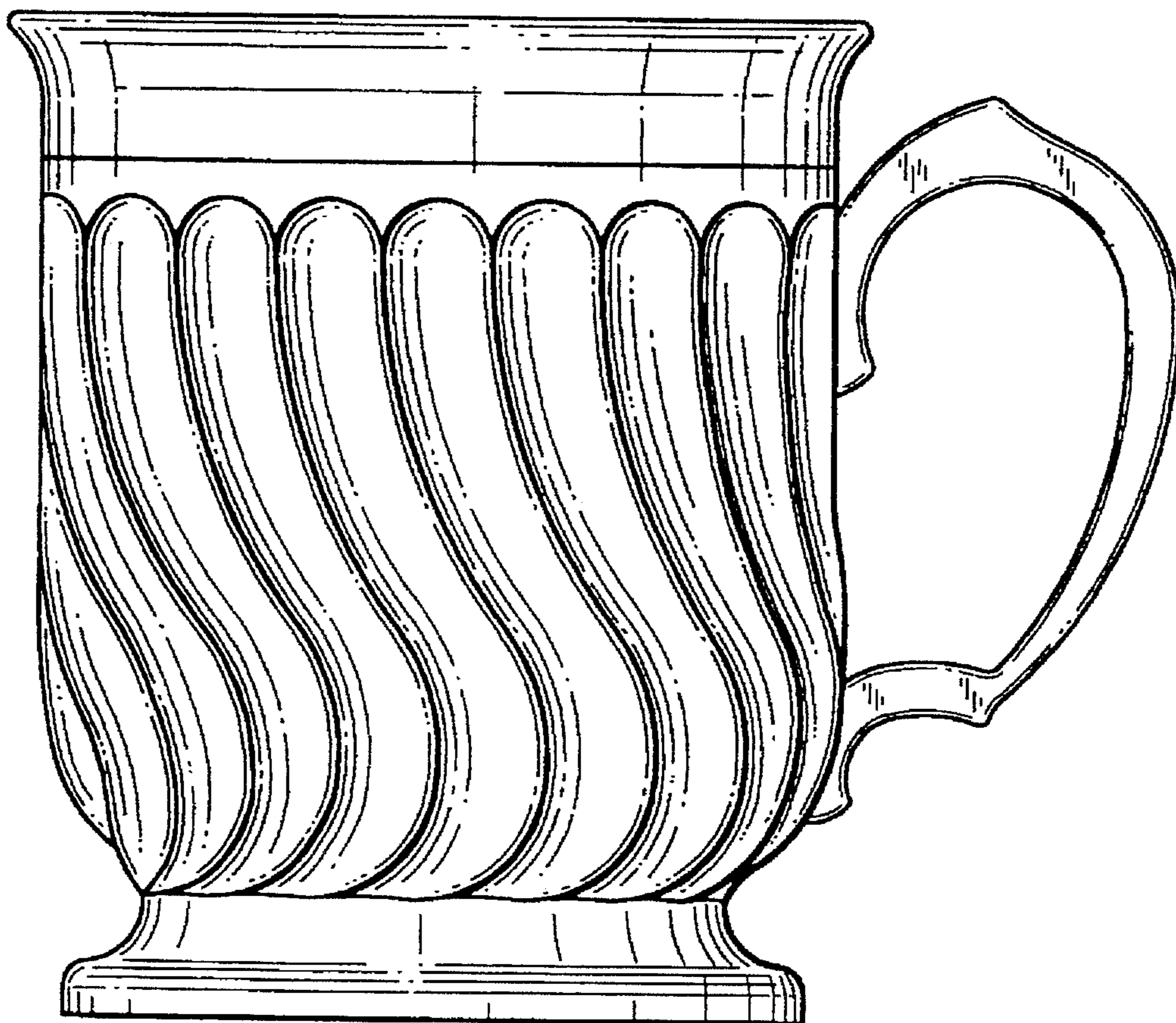
The ornamental design for an insulated drink cup, as shown and described.

### DESCRIPTION

FIG. 1 is a front elevational view of an insulated drink cup showing my new design;

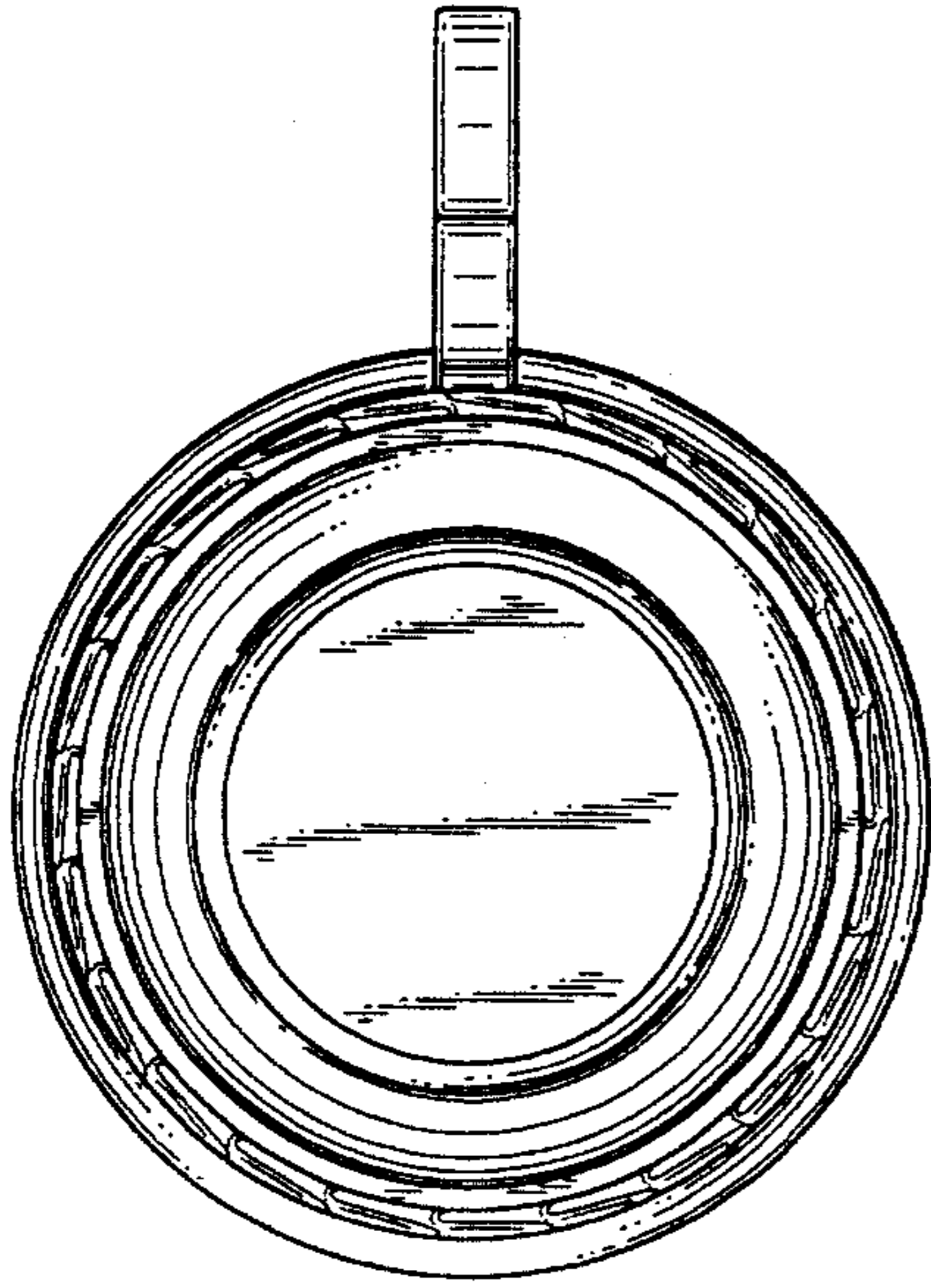

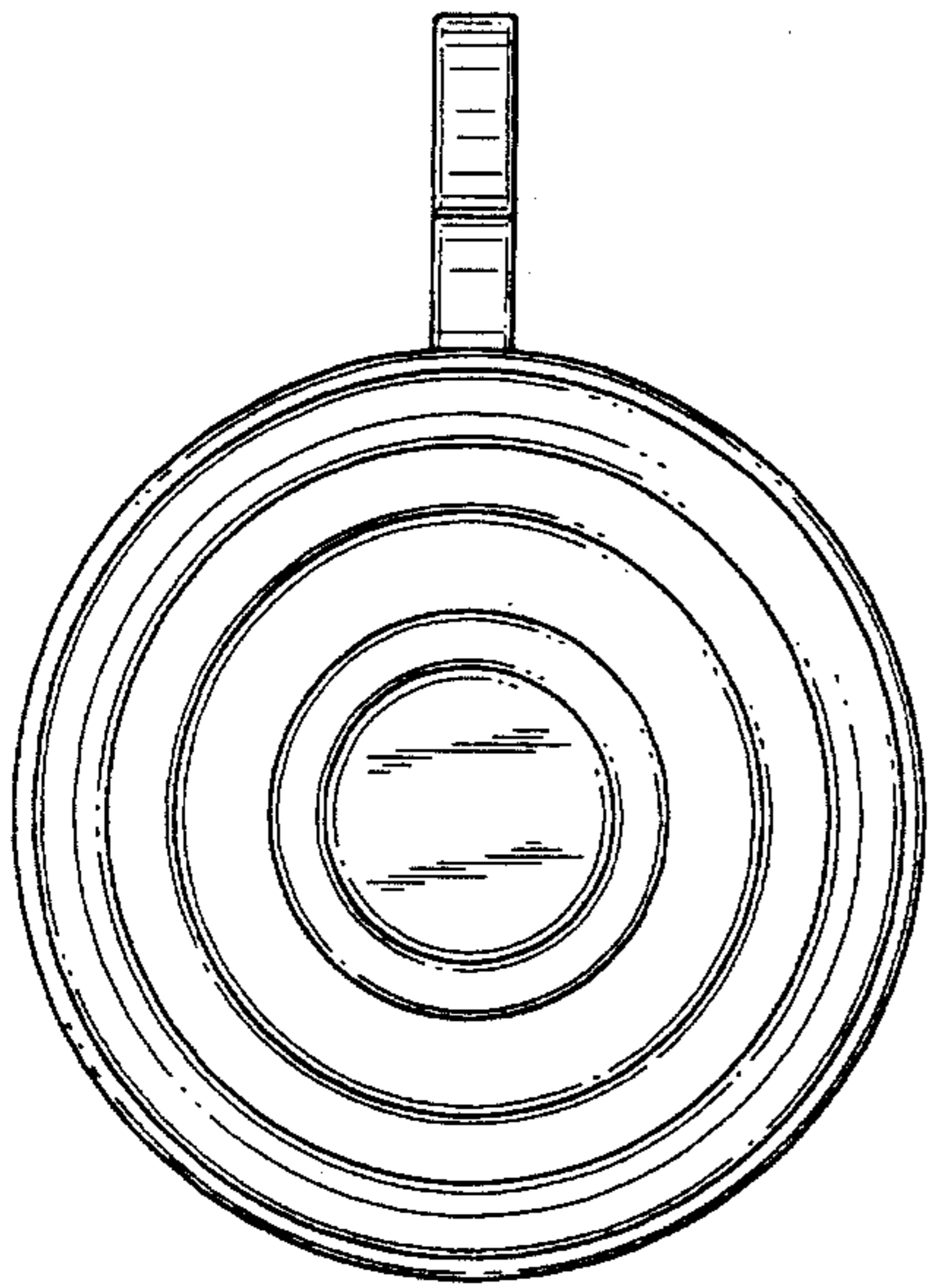

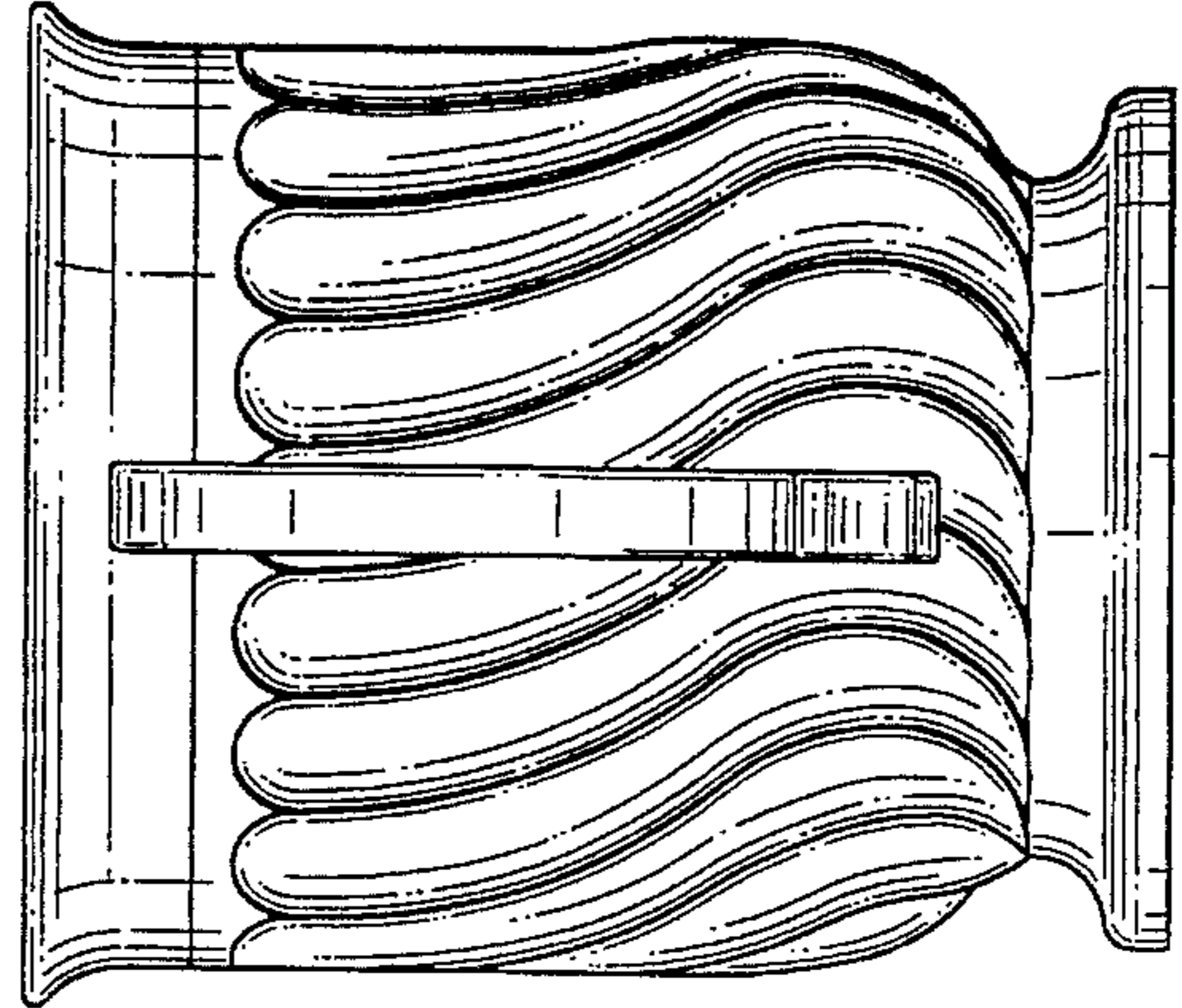

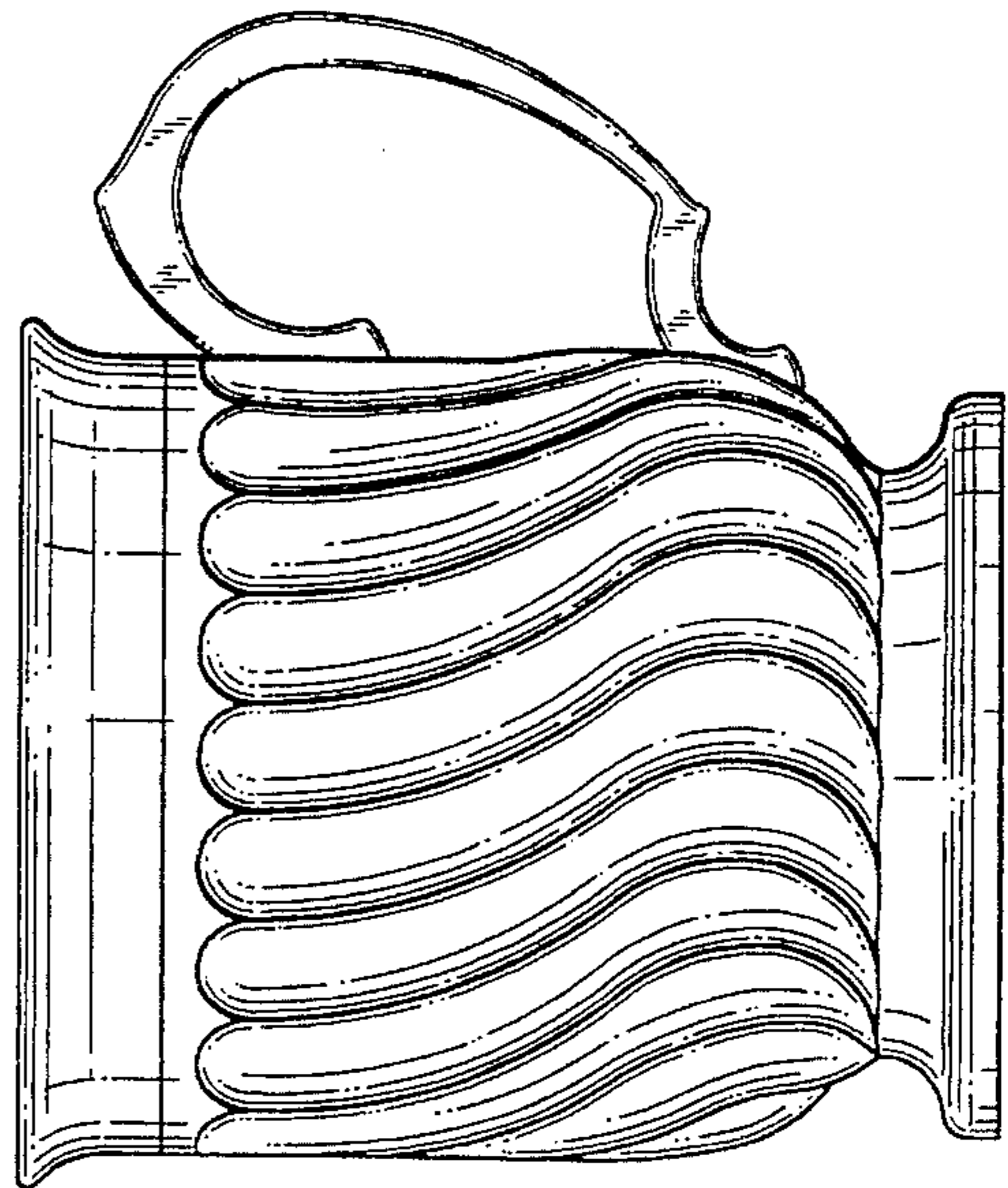

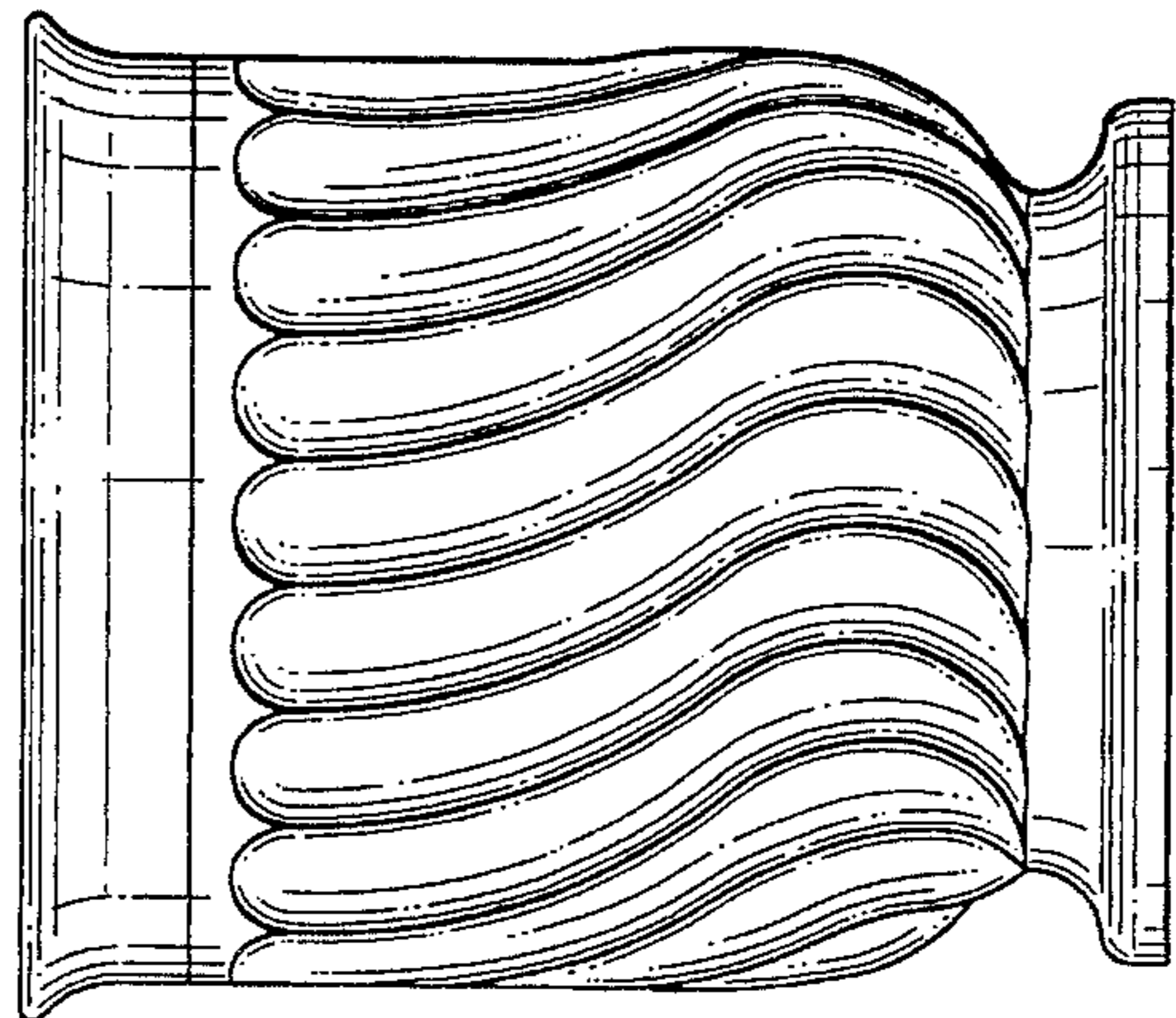
