The ornamental design for a combined bottle and closure, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bottle showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a side elevational view thereof the undisclosed opposite side is a mirror image;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a perspective view with the closure opened.

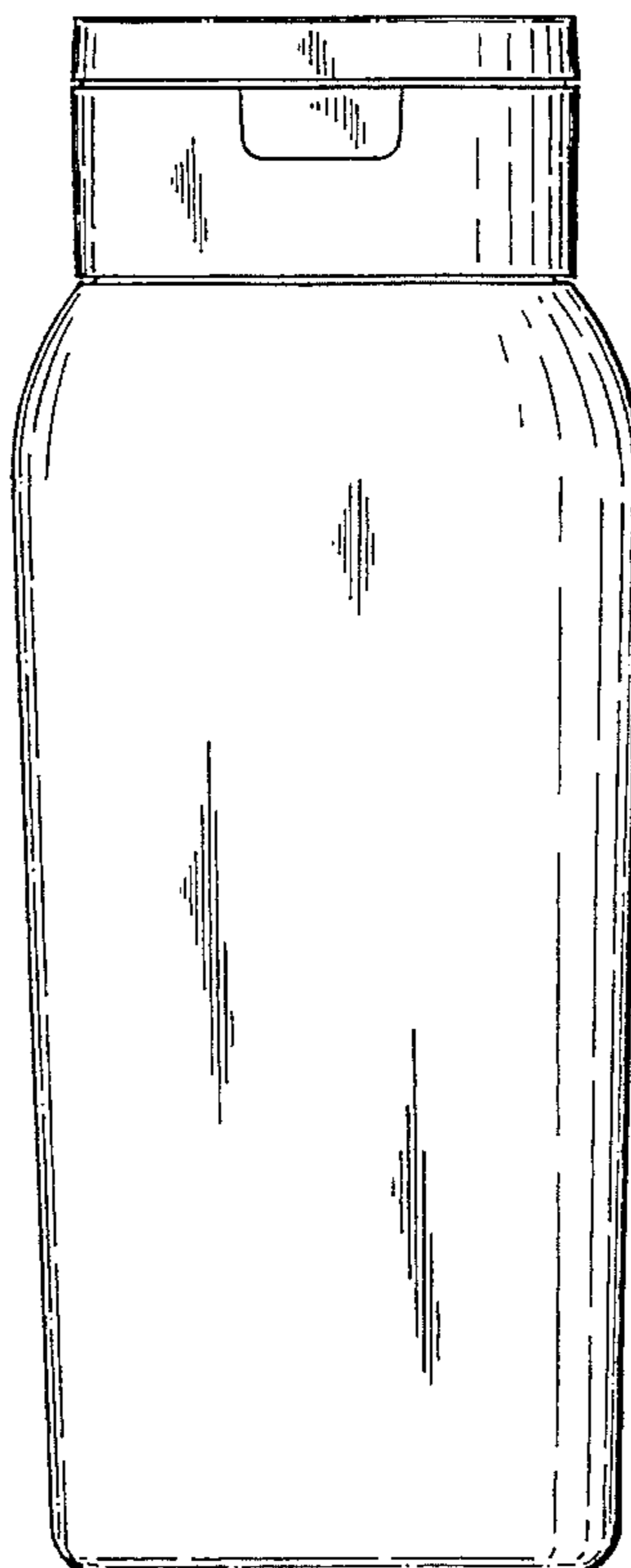

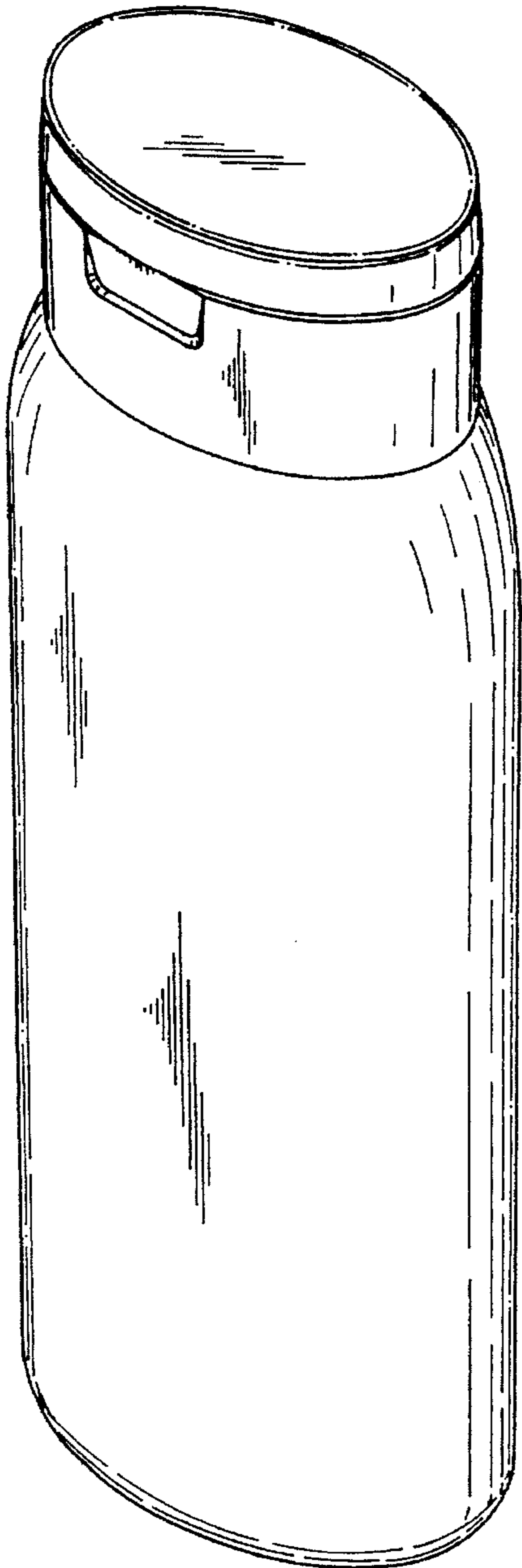

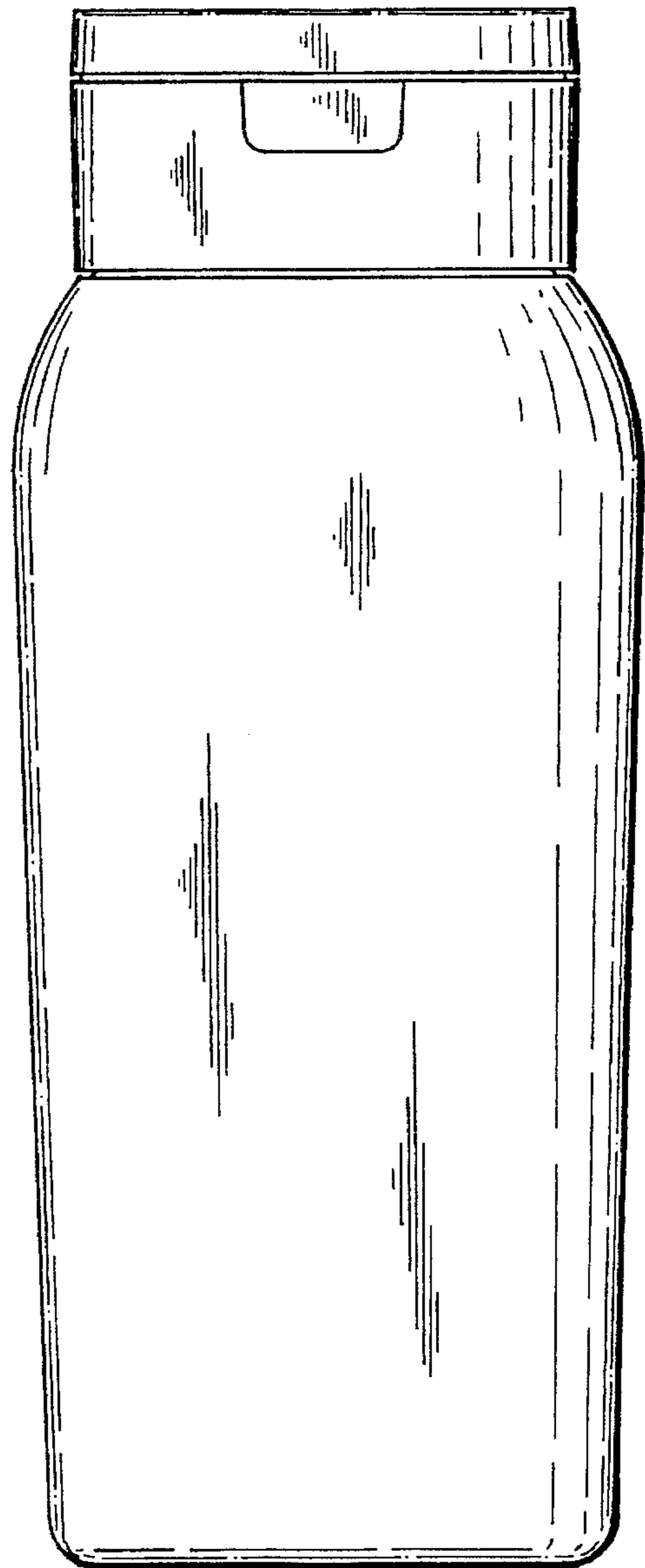

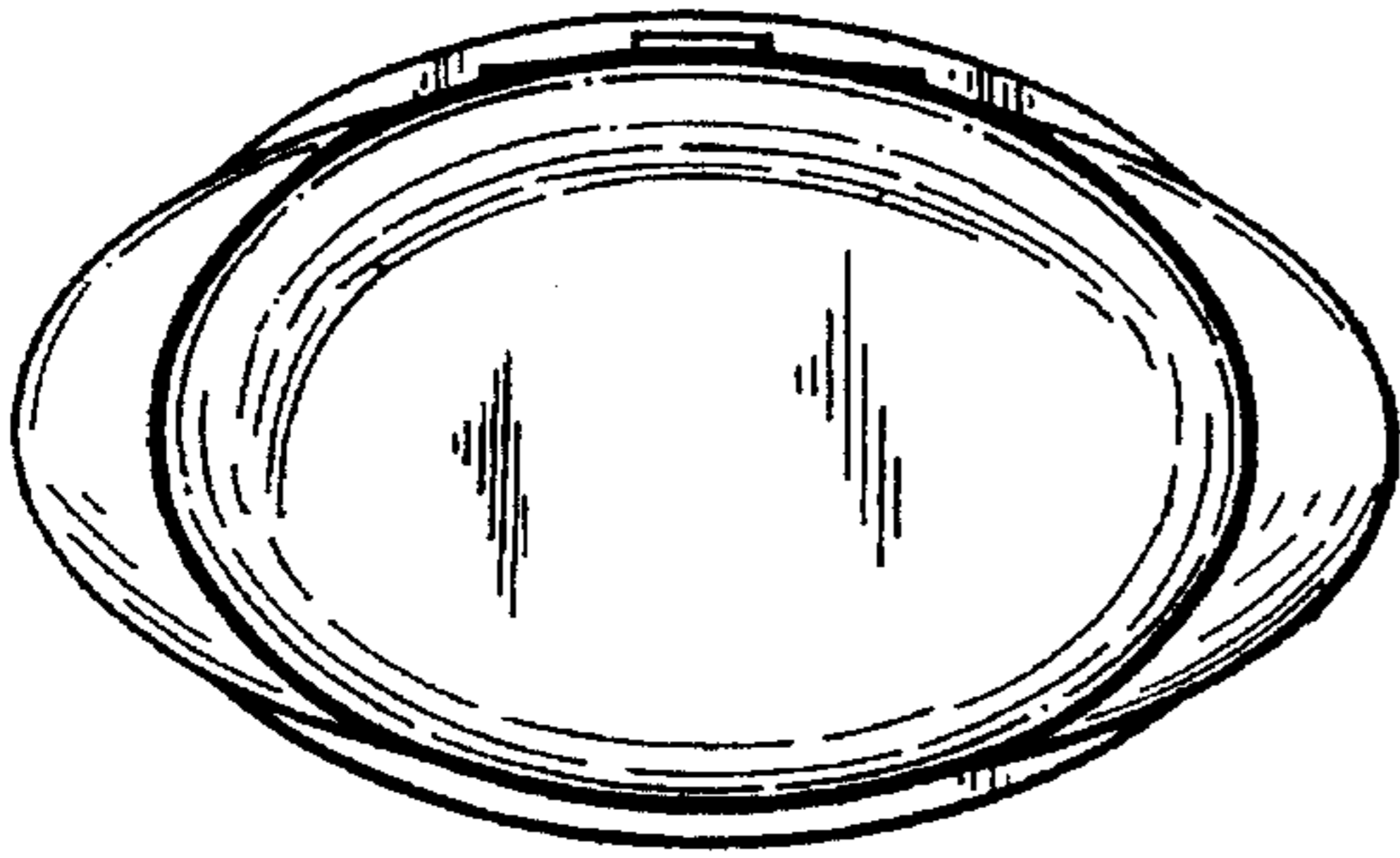

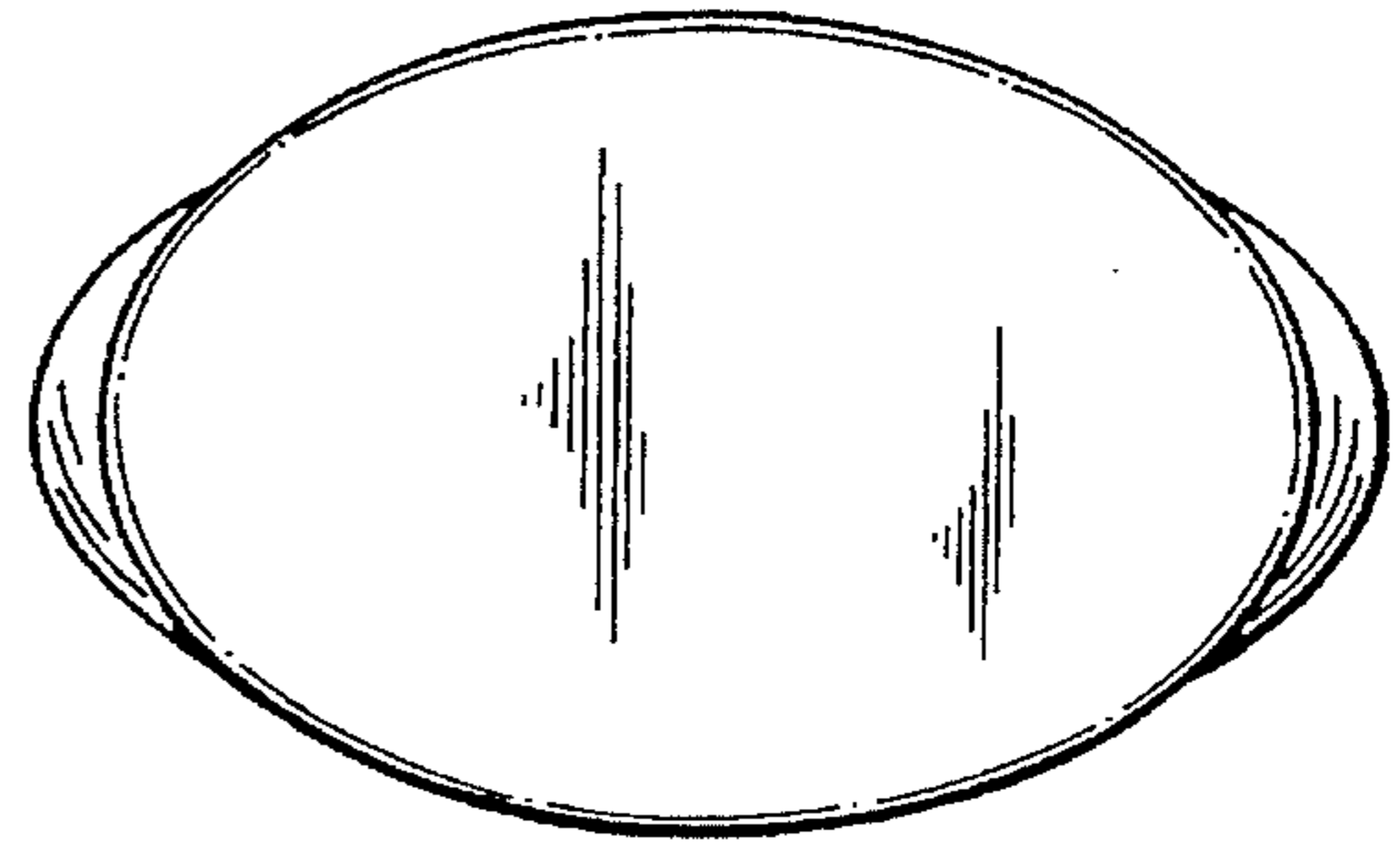

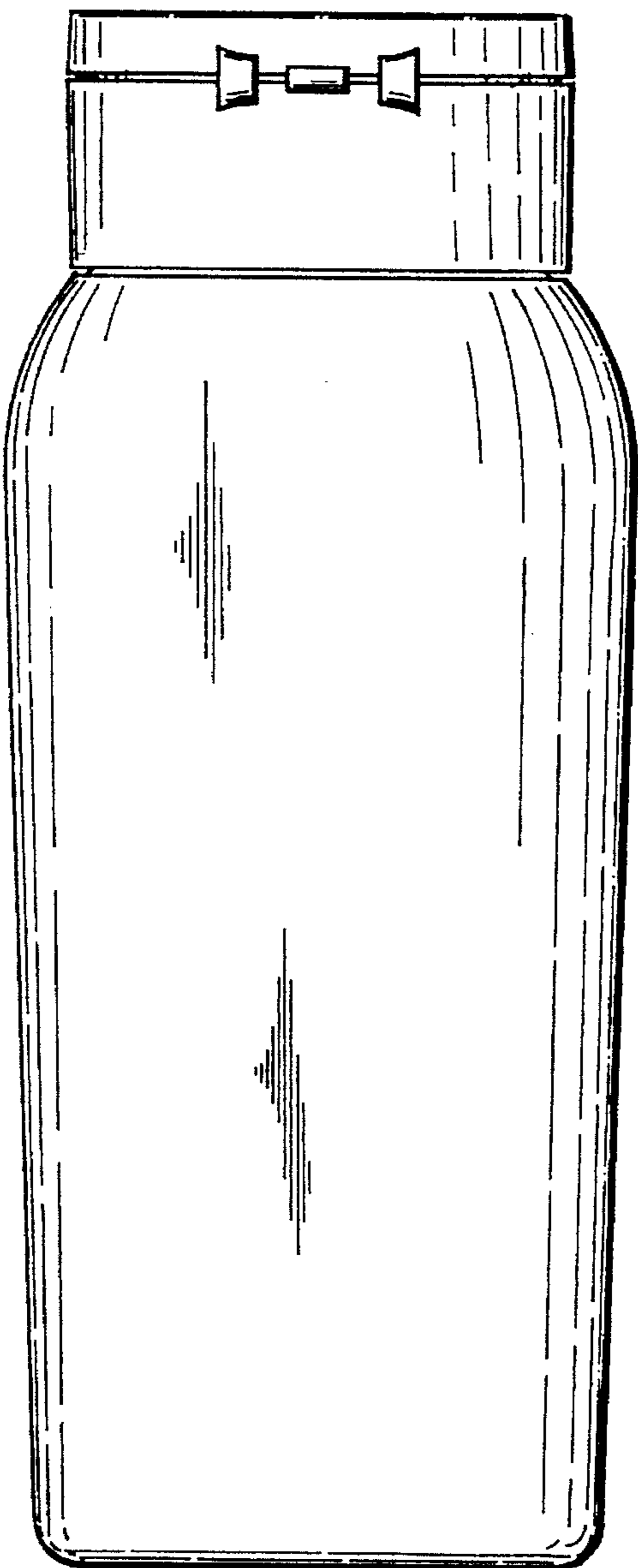

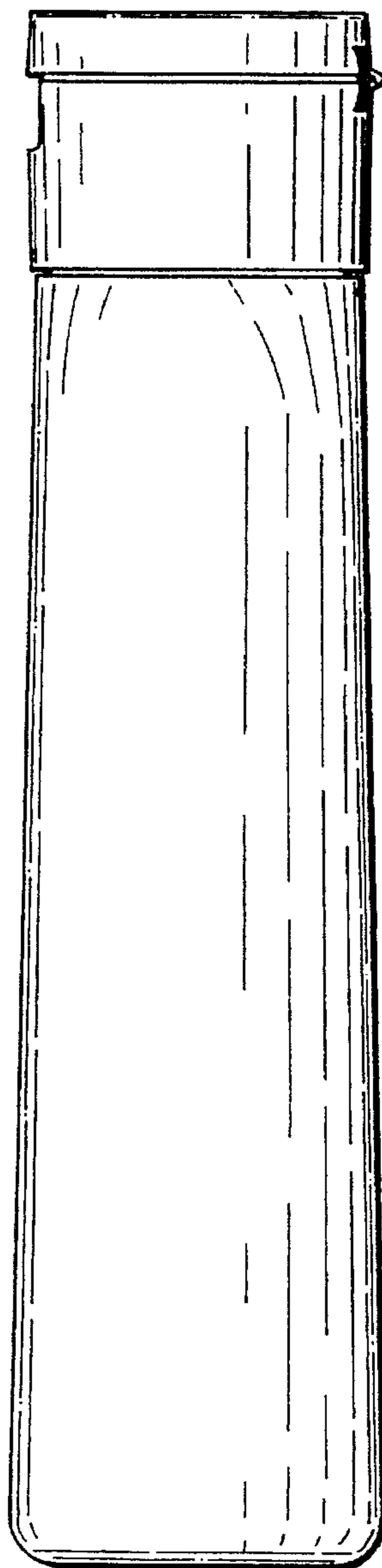
